FIG. 5 is a top plan view thereof;

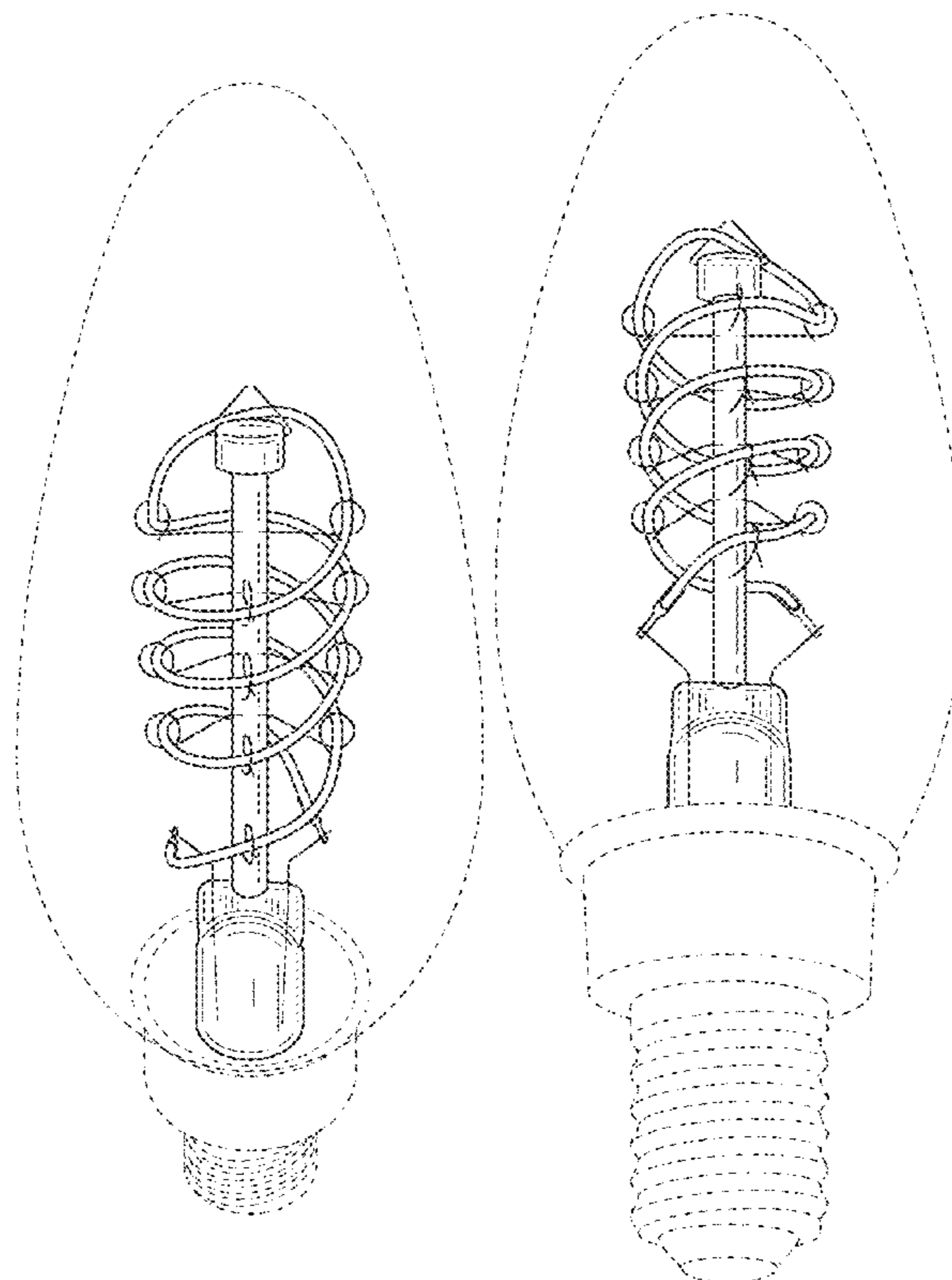
FIG. 6 is a top perspective view thereof; and,

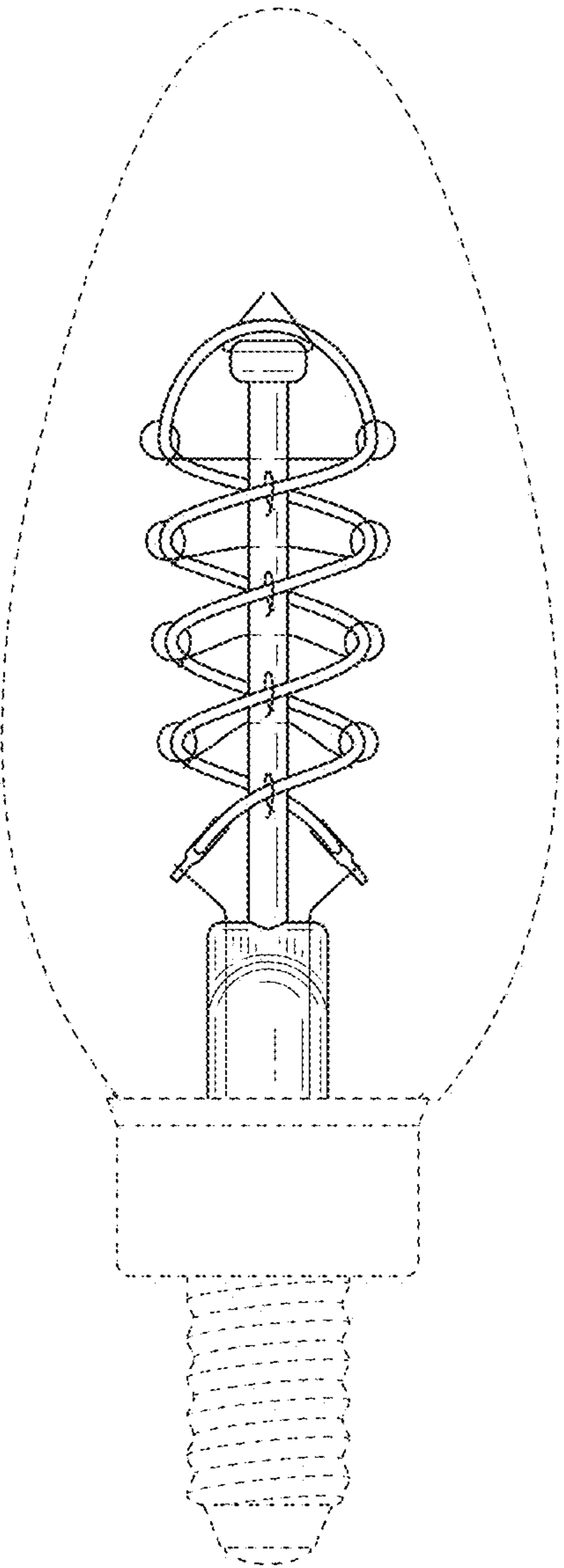

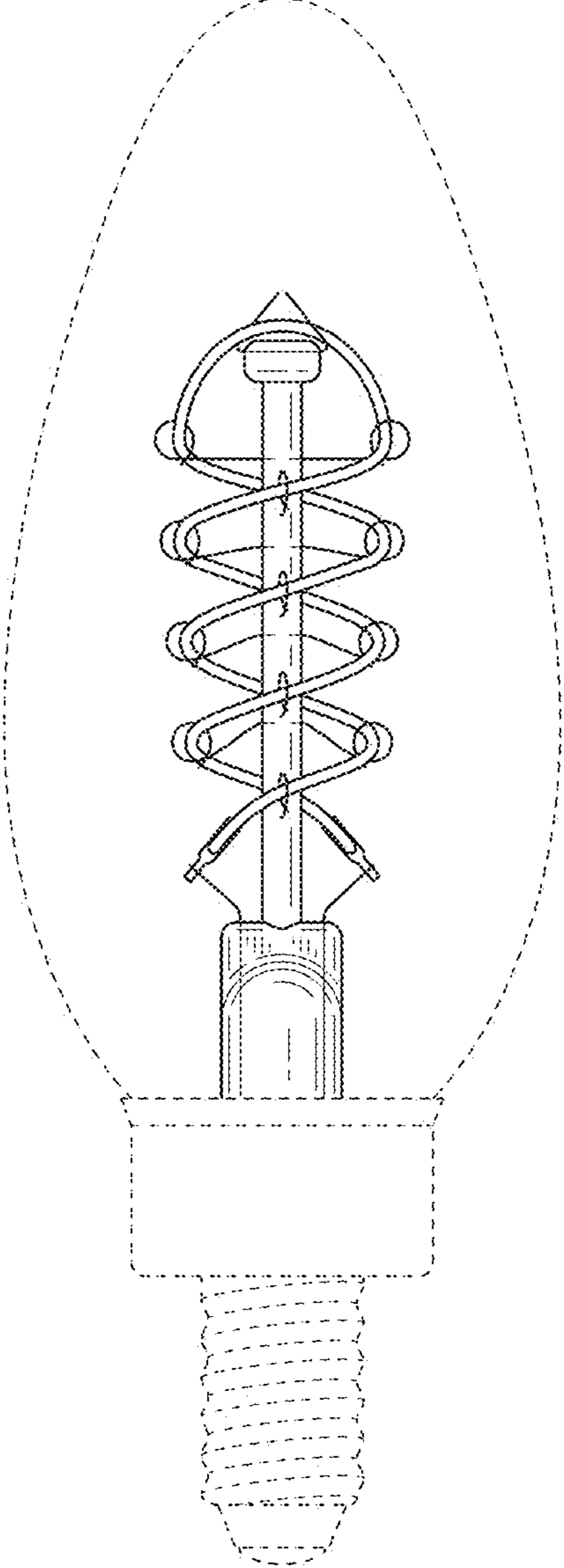

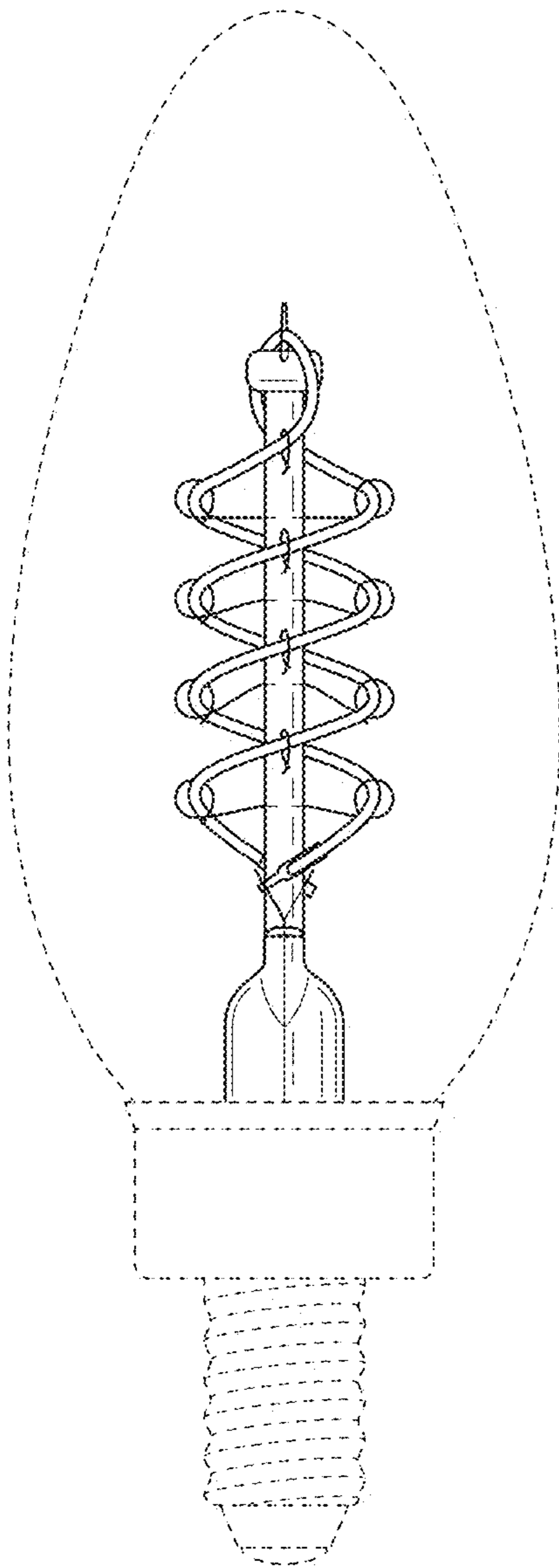

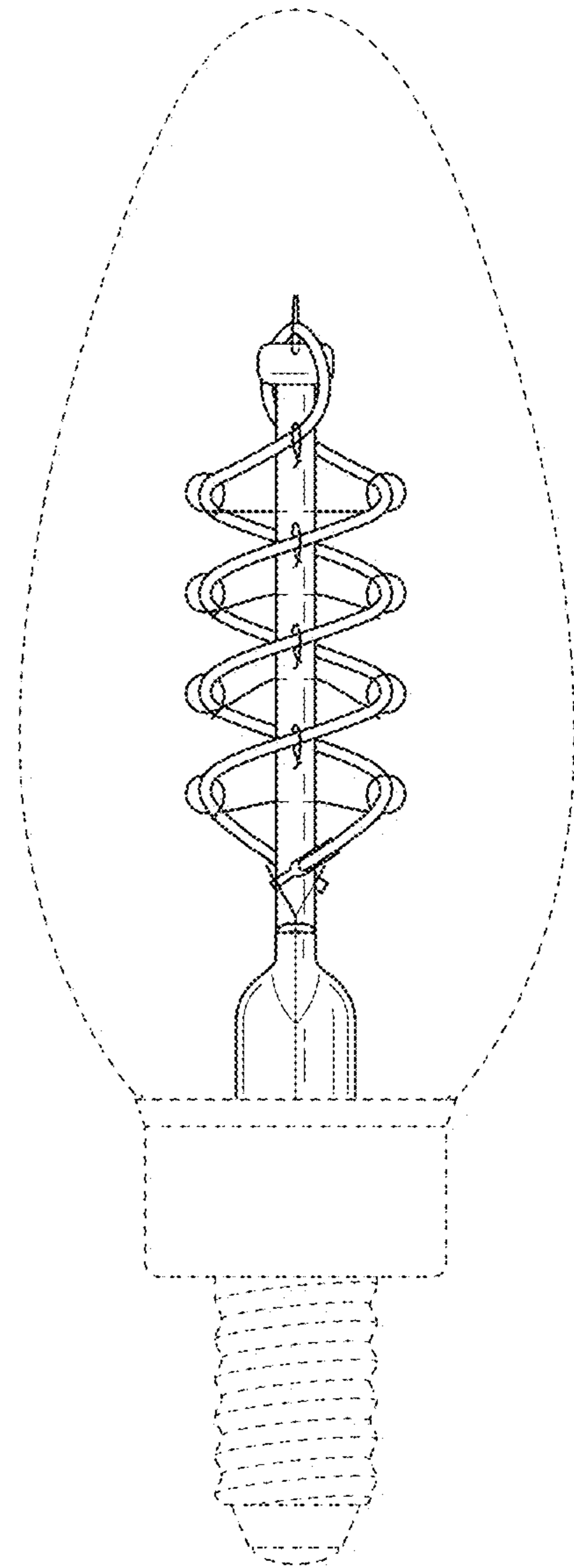

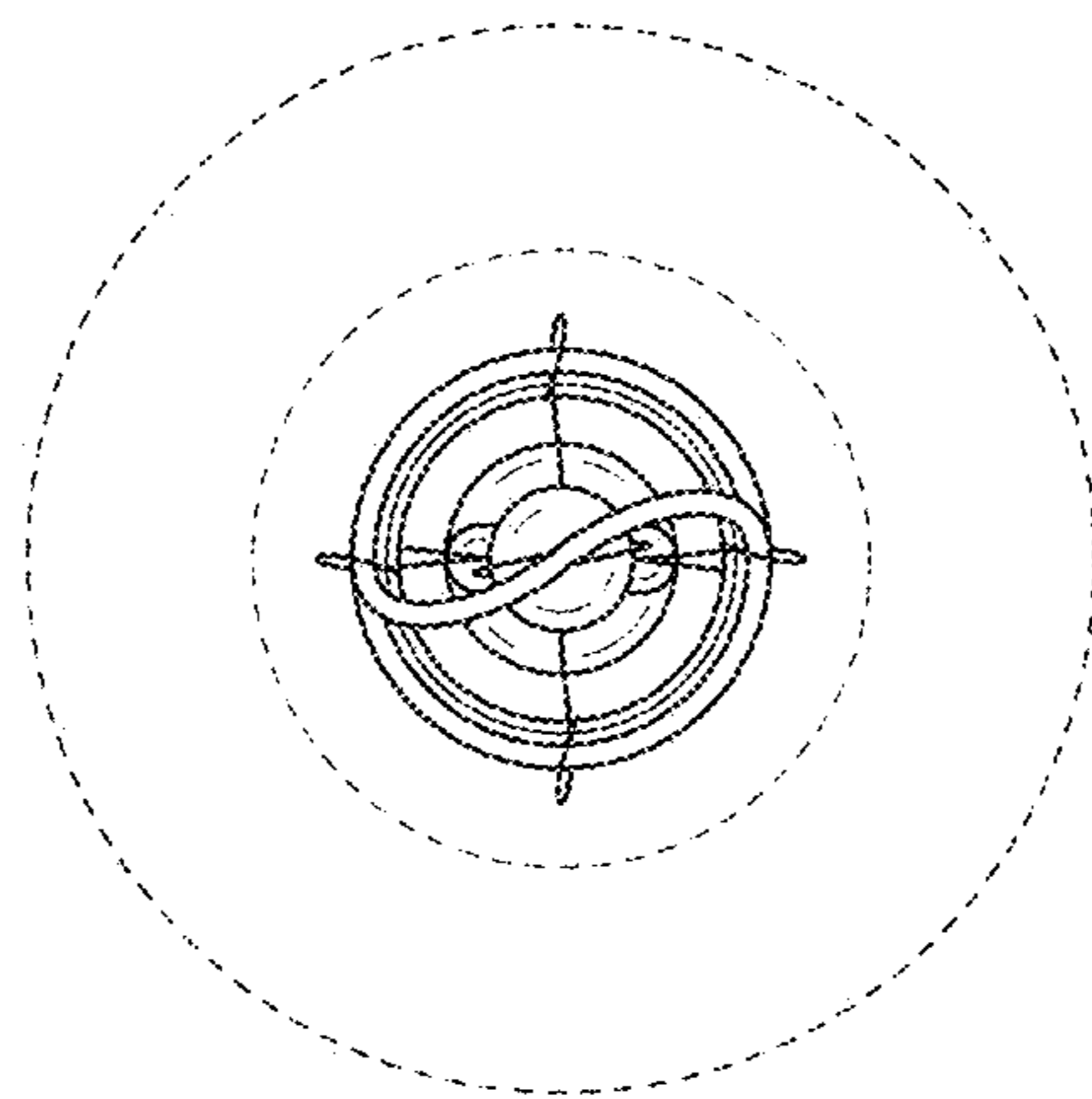

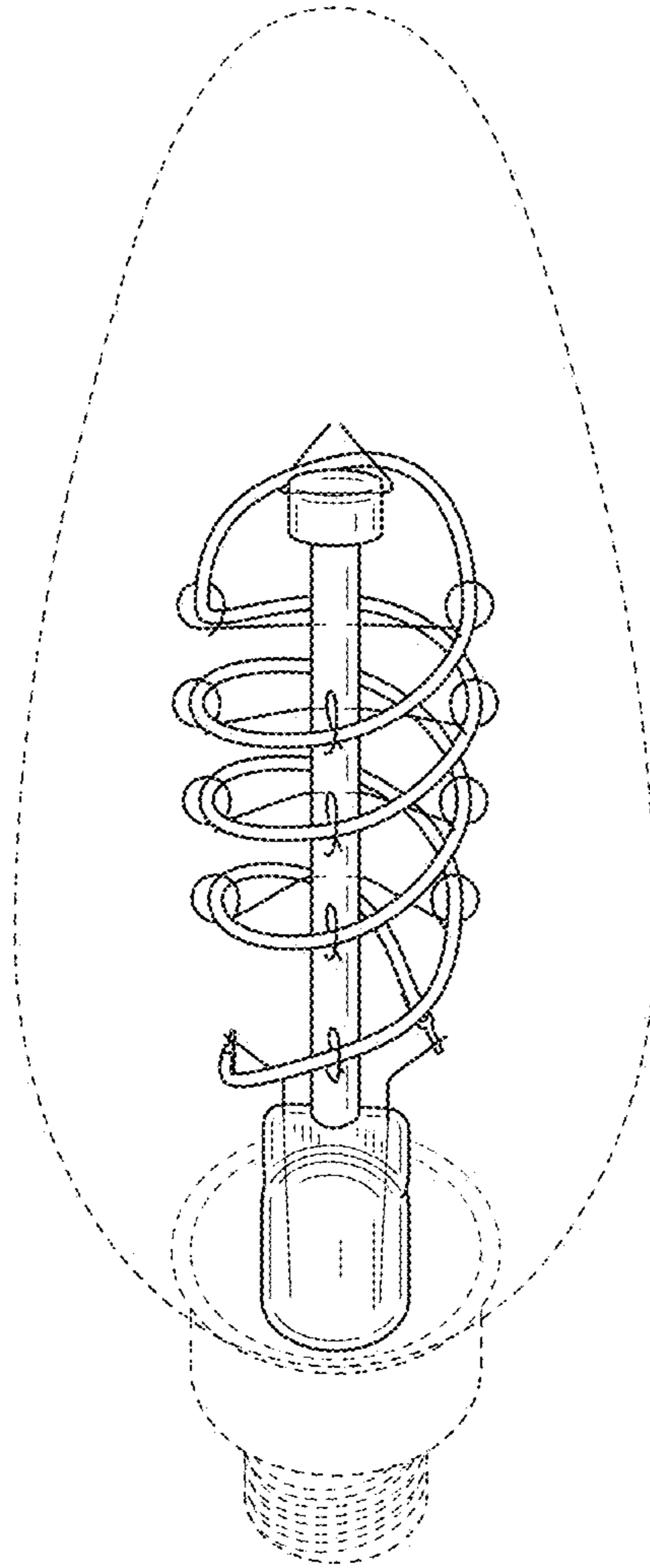

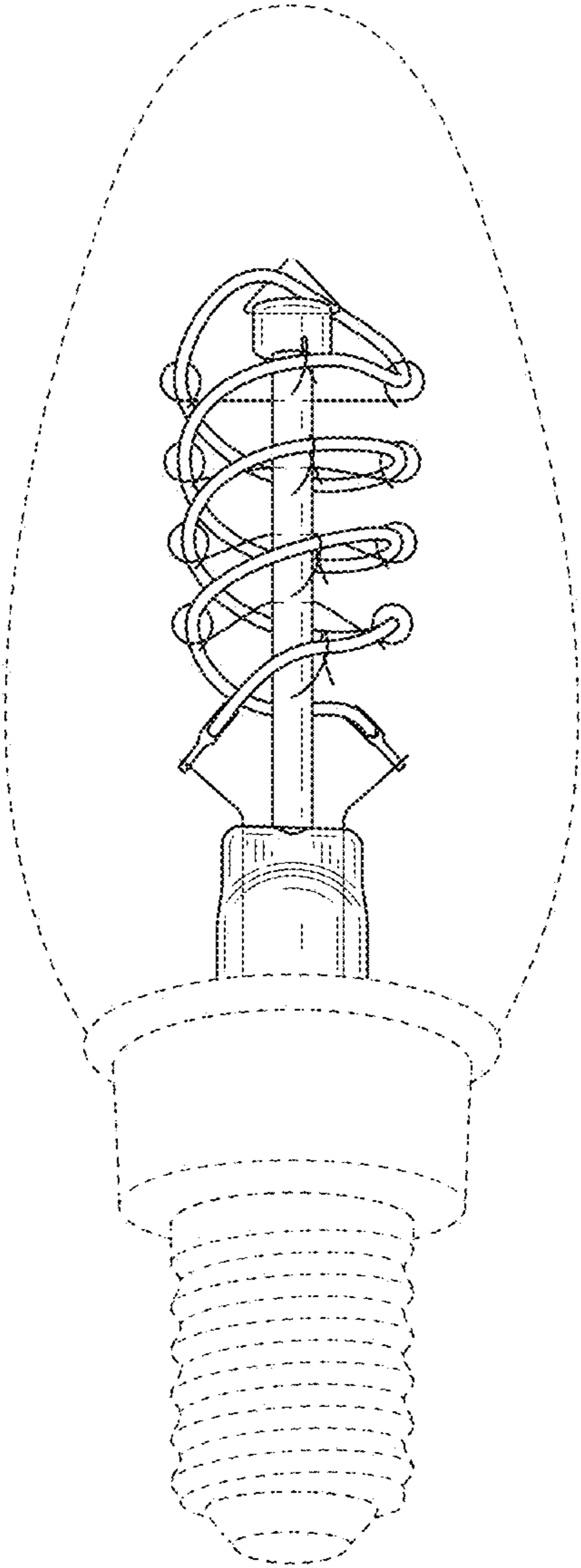
