What is claimed is the ornamental design for an athletic sleeve with vein features, as shown and described.

DESCRIPTION

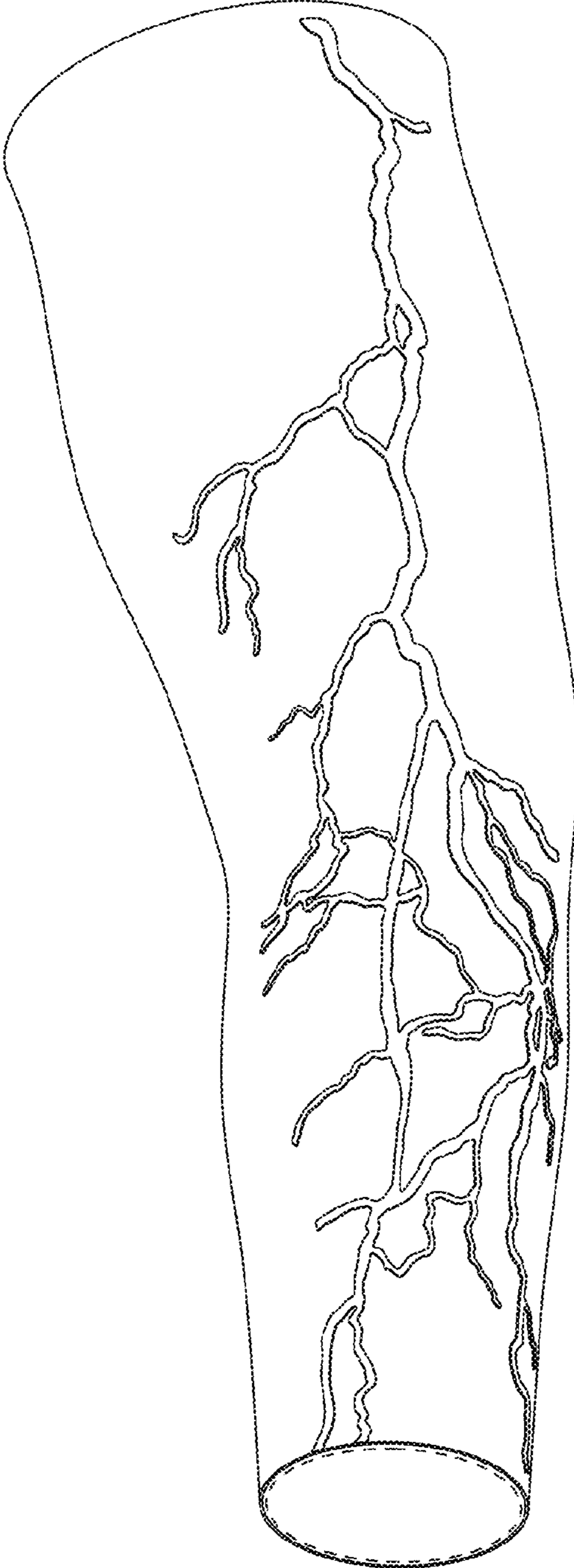

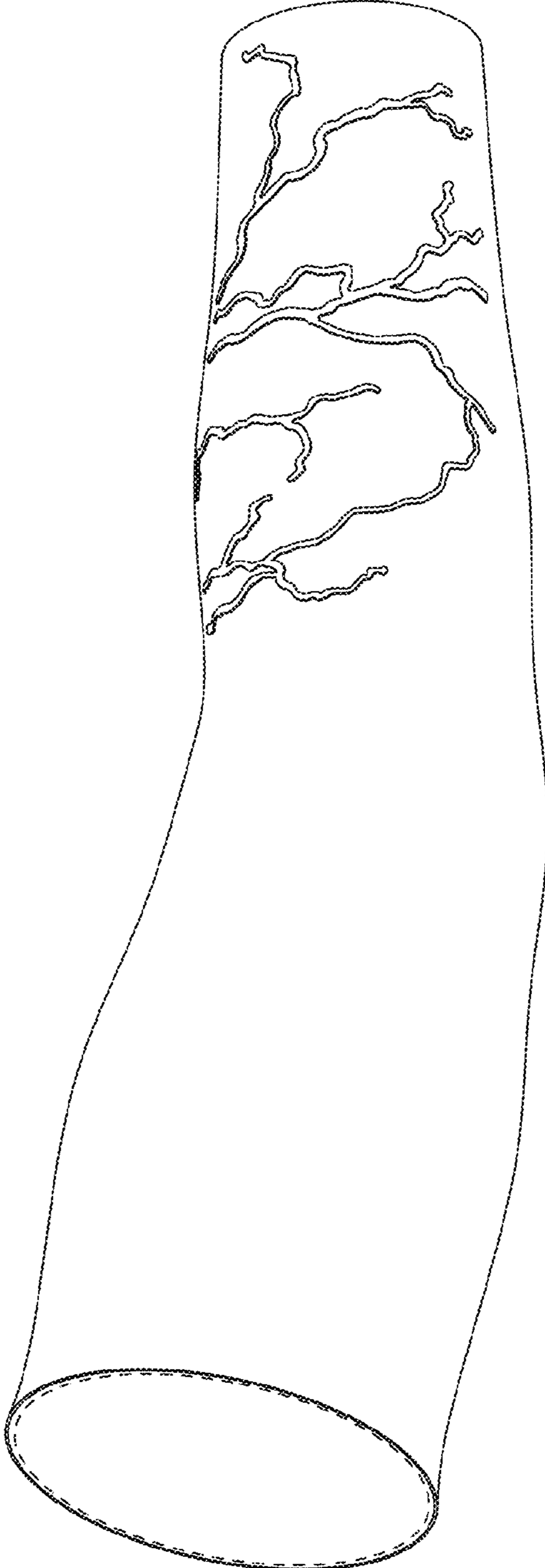

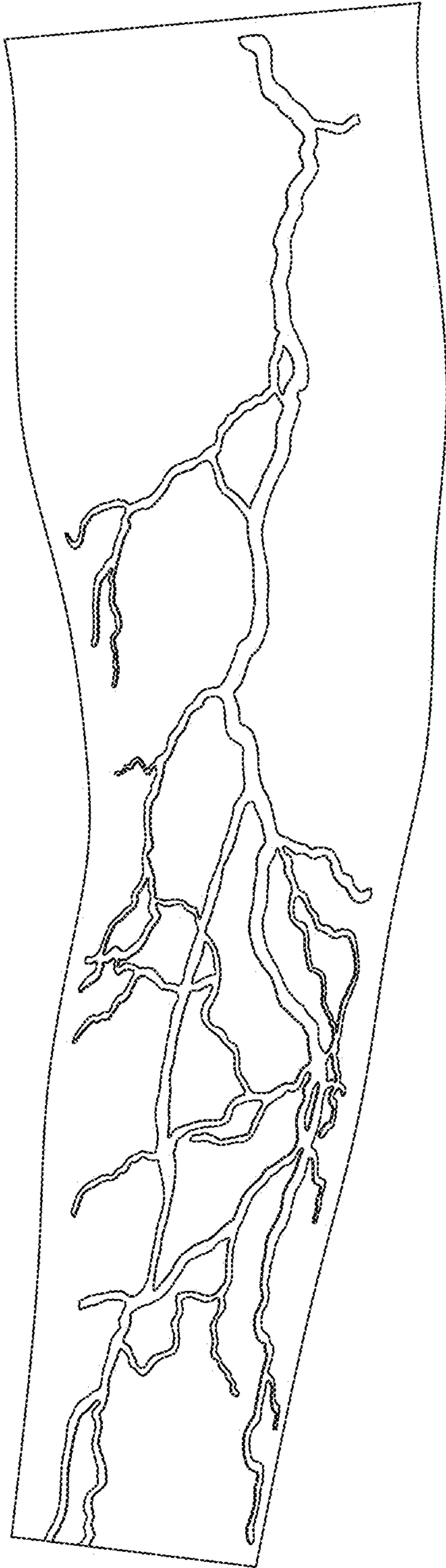

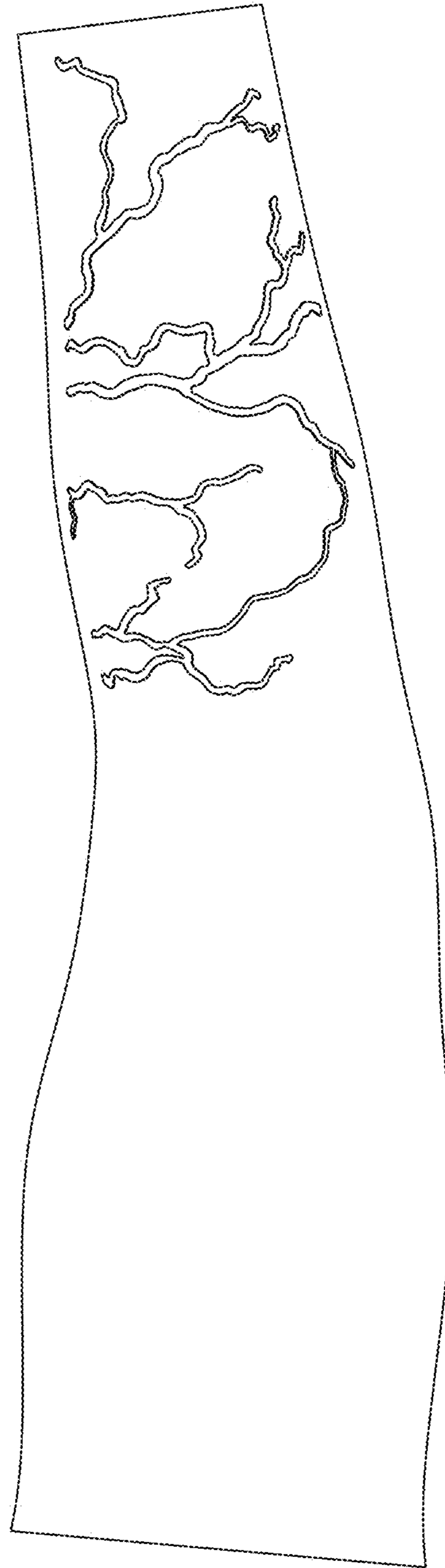

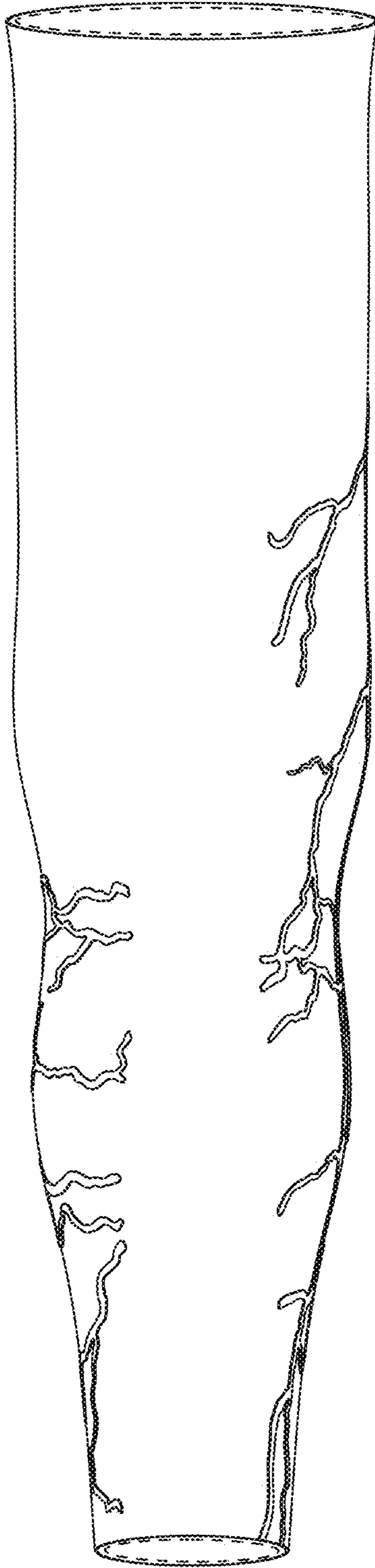

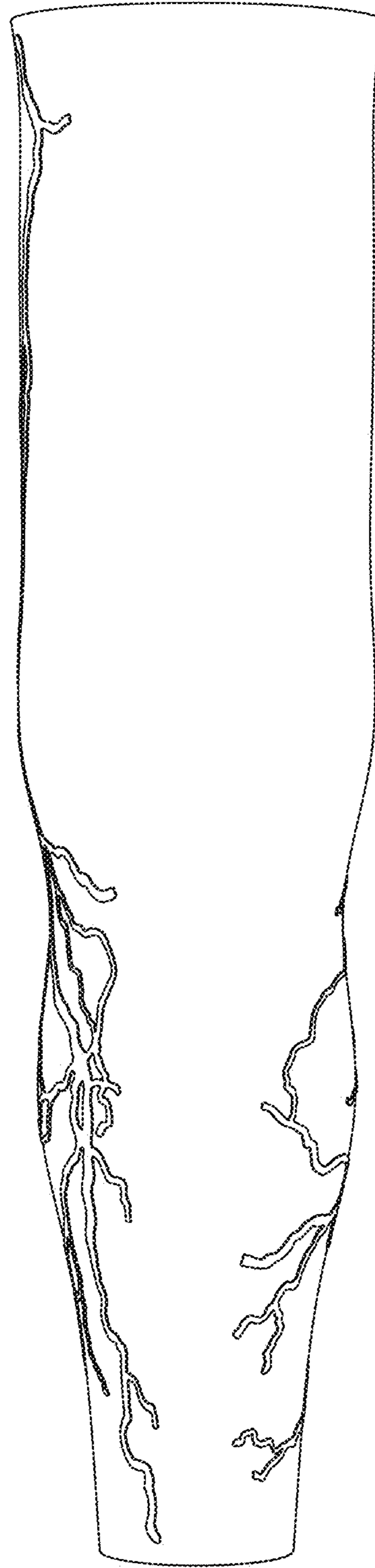

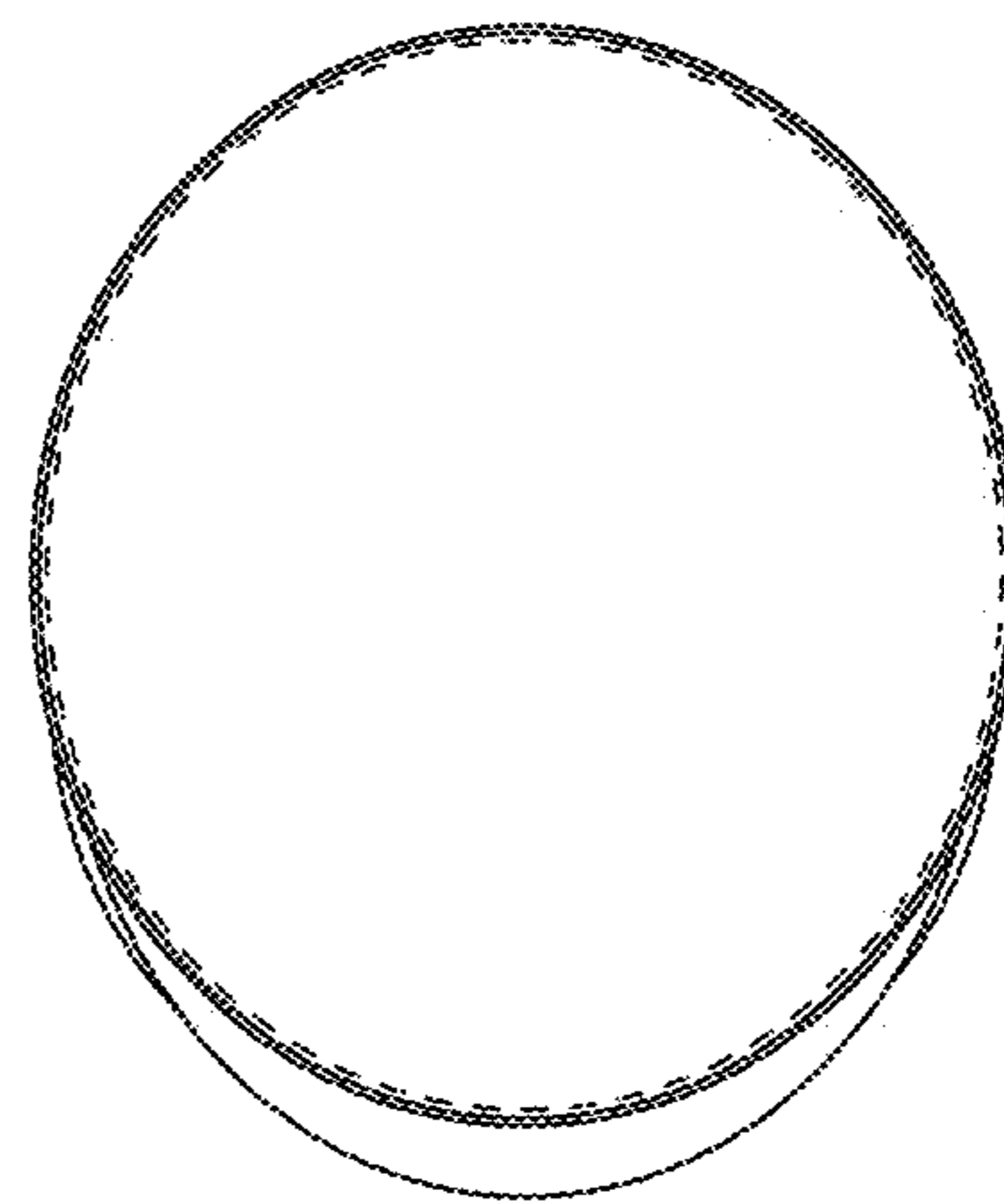

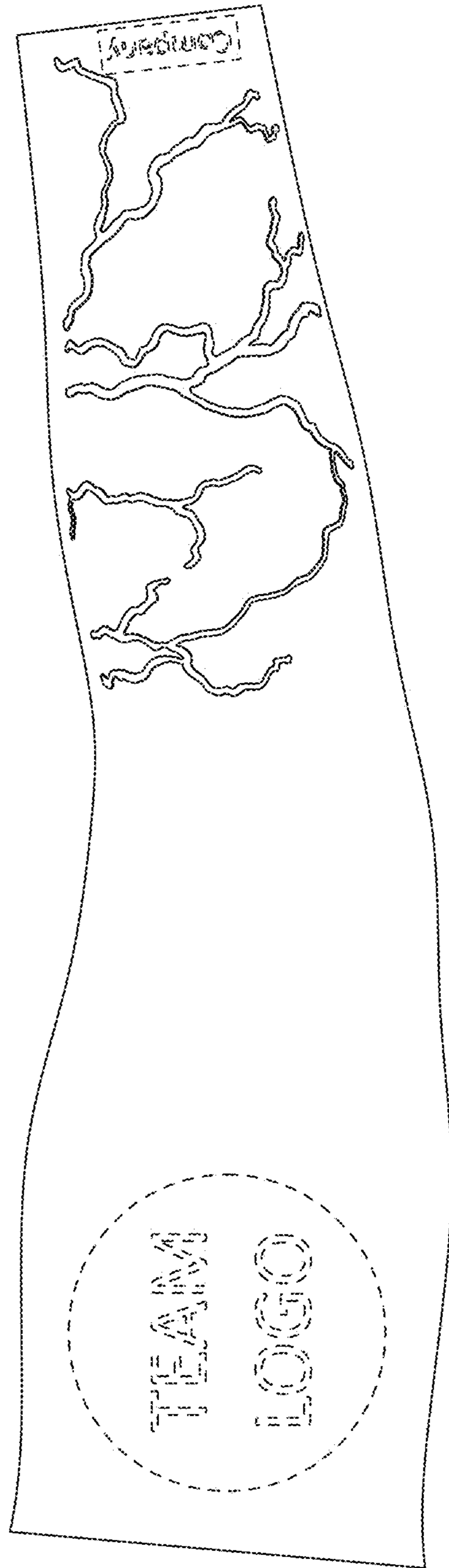
