FIG. 3 is a rear view thereof.

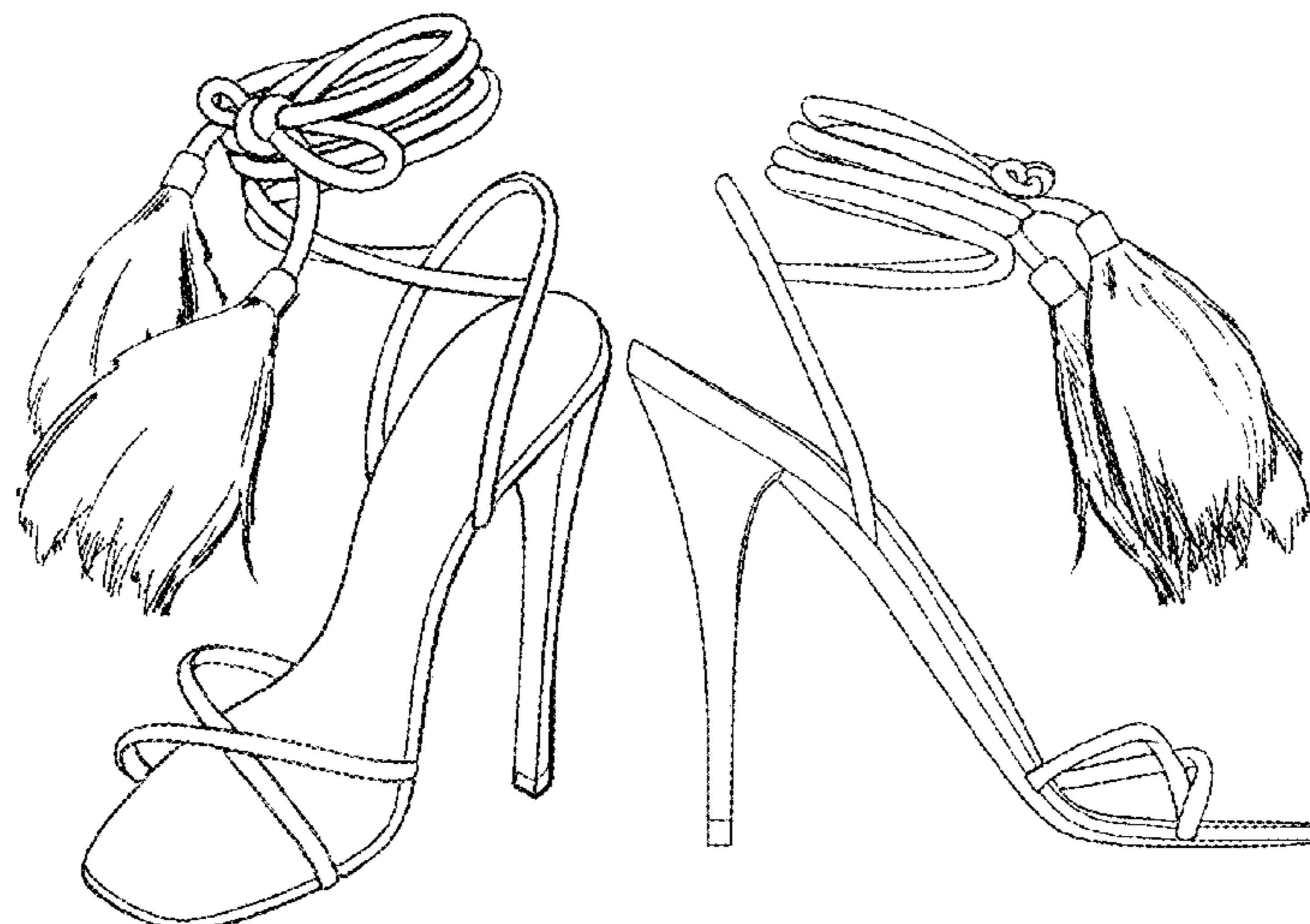
FIG. 4 is right side view thereof.

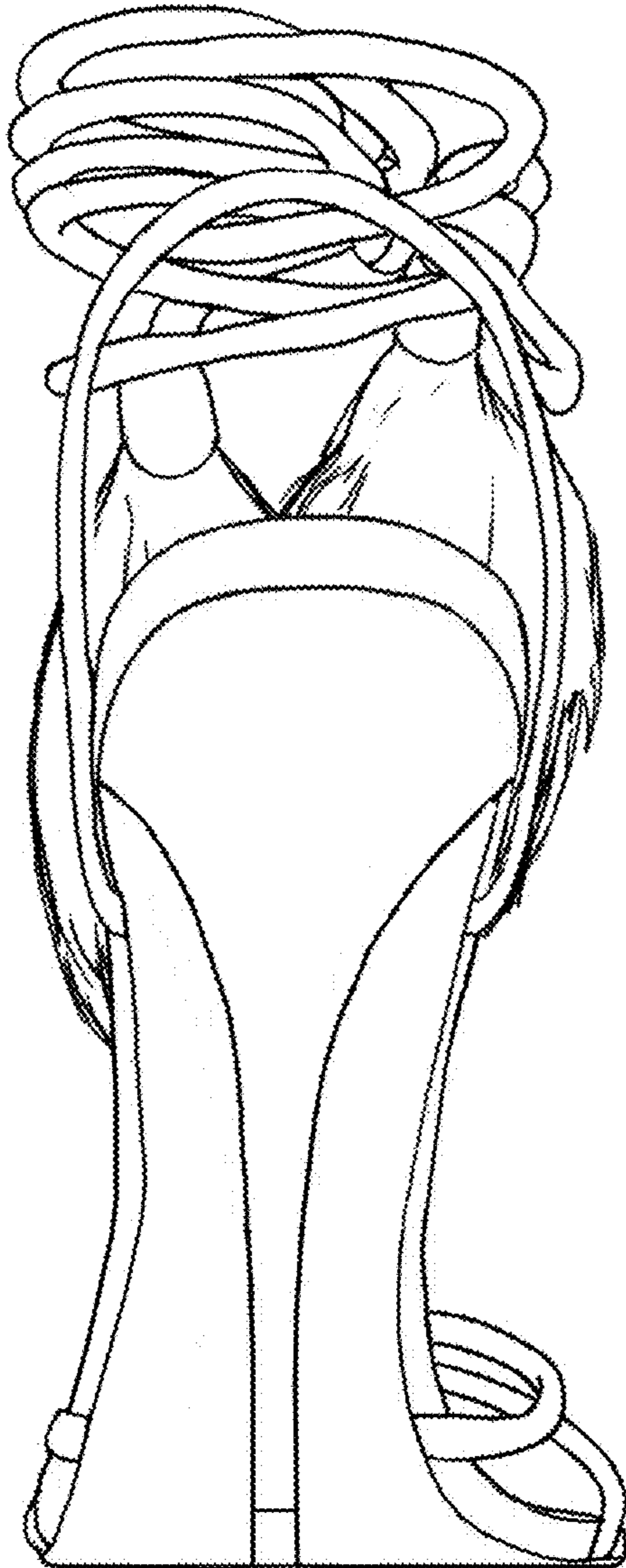

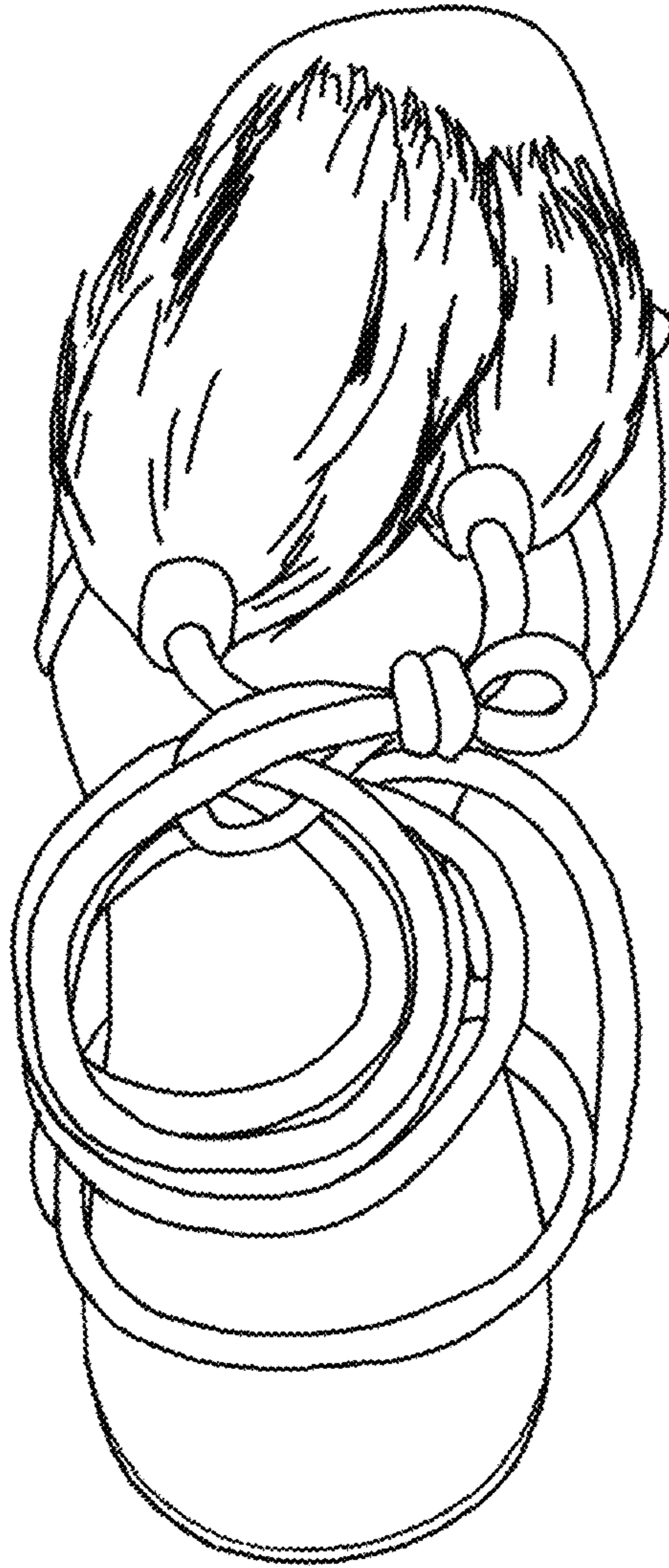

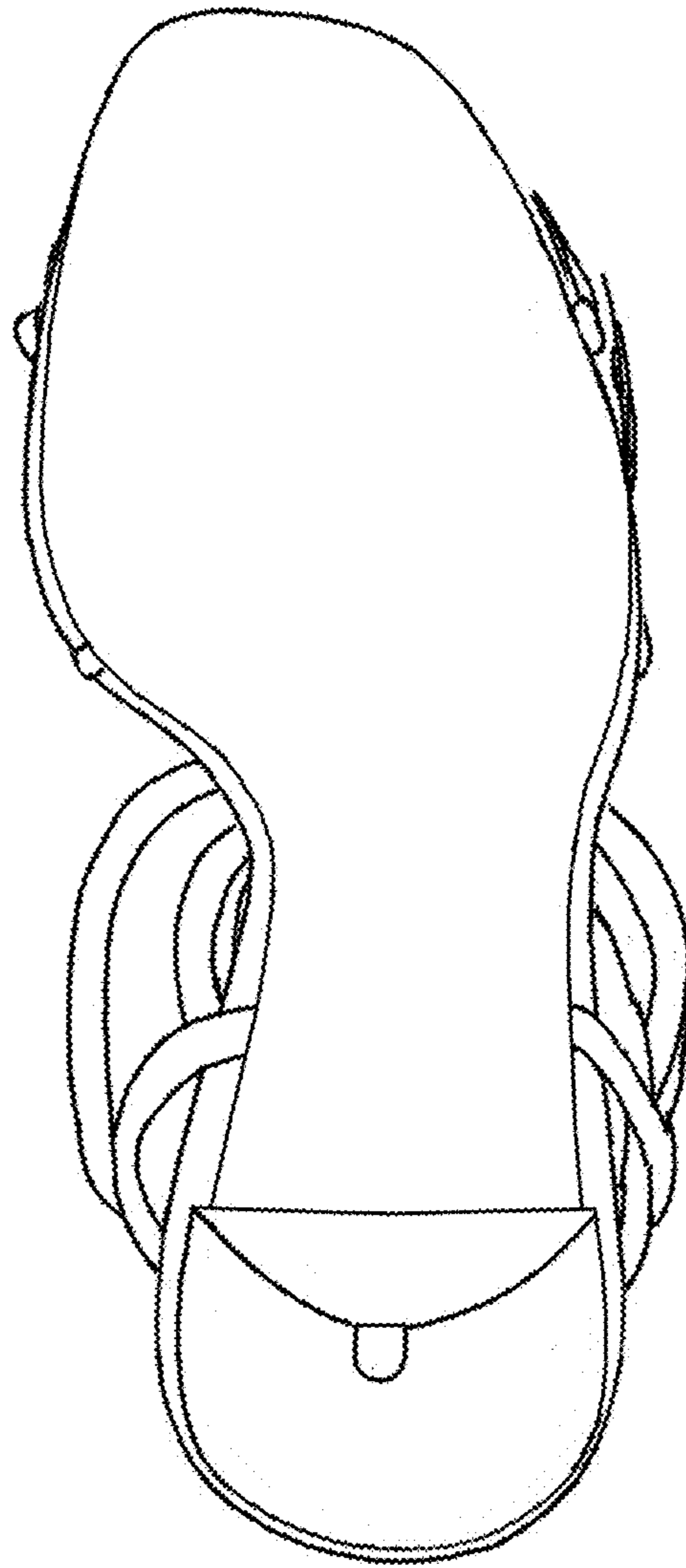
