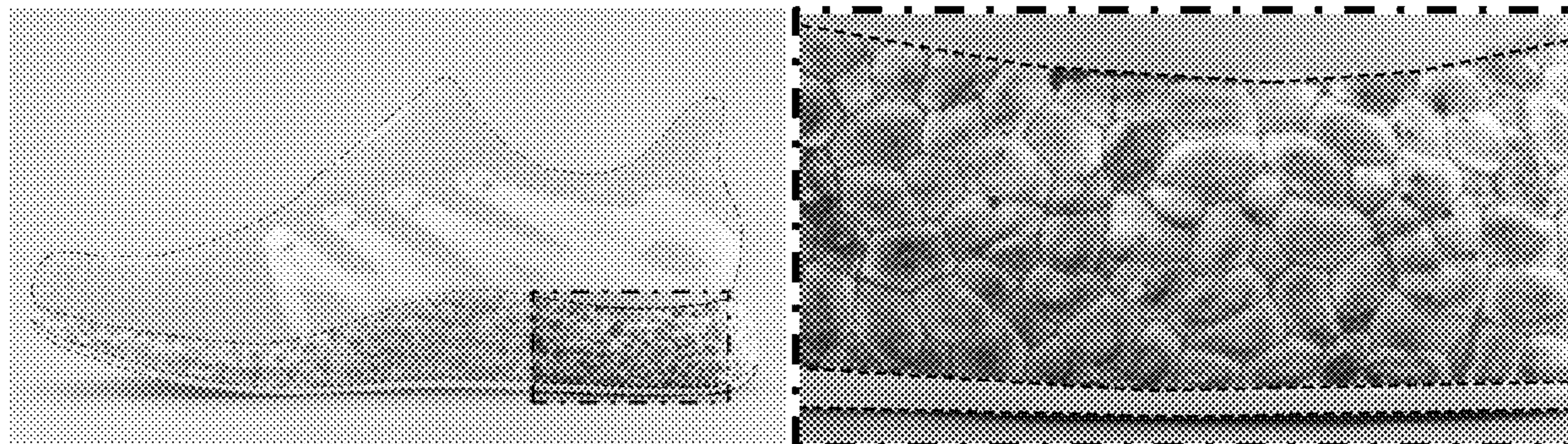
(57) **CLAIM**

The ornamental design of a shoe midsole, as shown and
described.

DESCRIPTION

FIG. 1 is a side view of a shoe midsole; and,
FIG. 2 is an enlarged view of the portion of the shoe midsole
of FIG. 1 surrounded by the dash-dot-dash broken line.
The dashed lines enclose portions of the shoe that form no
part of the claimed design. The dash-dot-dash lines show the
boundaries of the midsole that form the claimed design, and
the dash-dot-dash lines form no part of the claimed design.
Portions of the midsole outside the dash-dot-dash line form
no part of the claimed design.

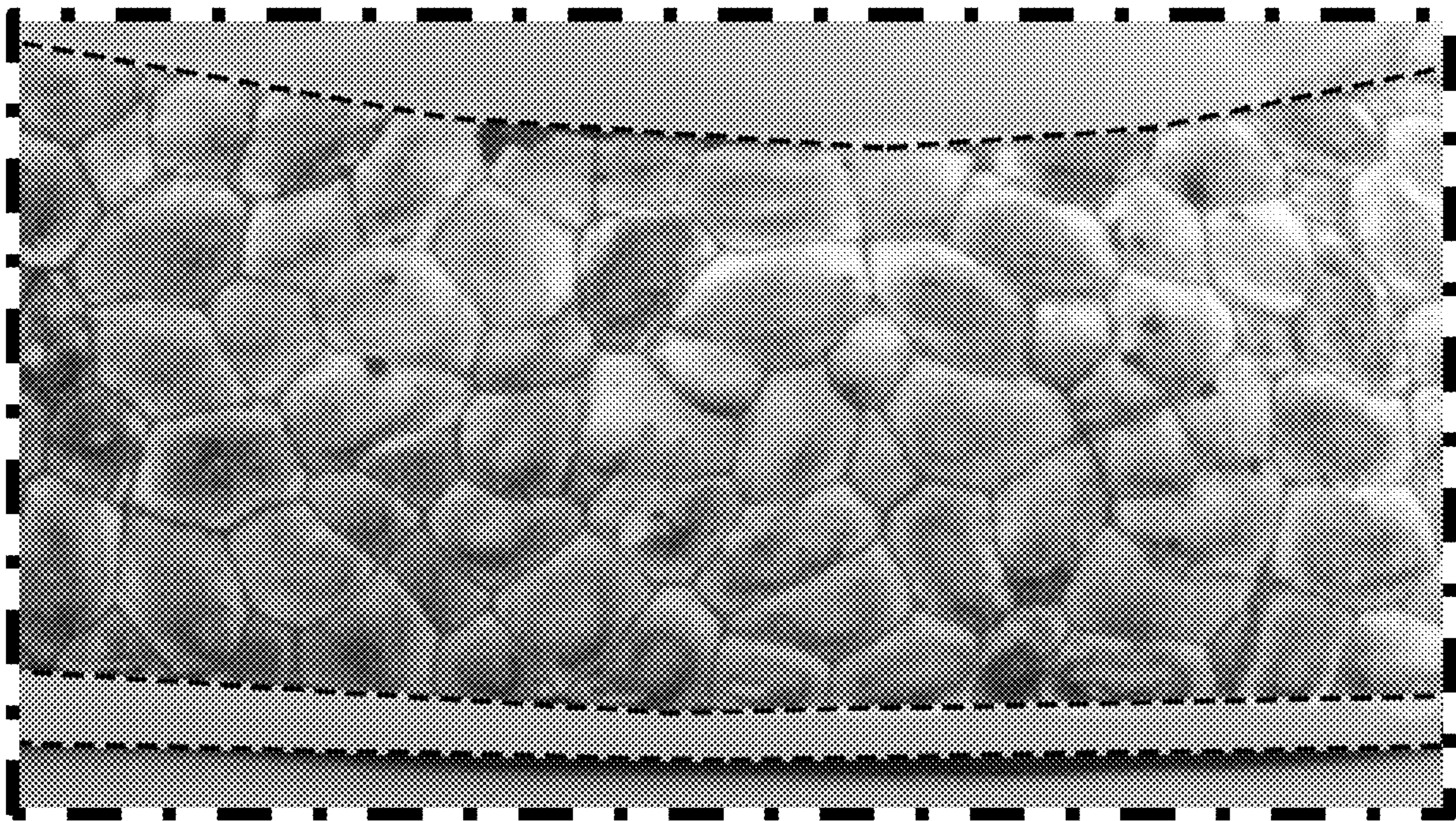
