**DESCRIPTION**

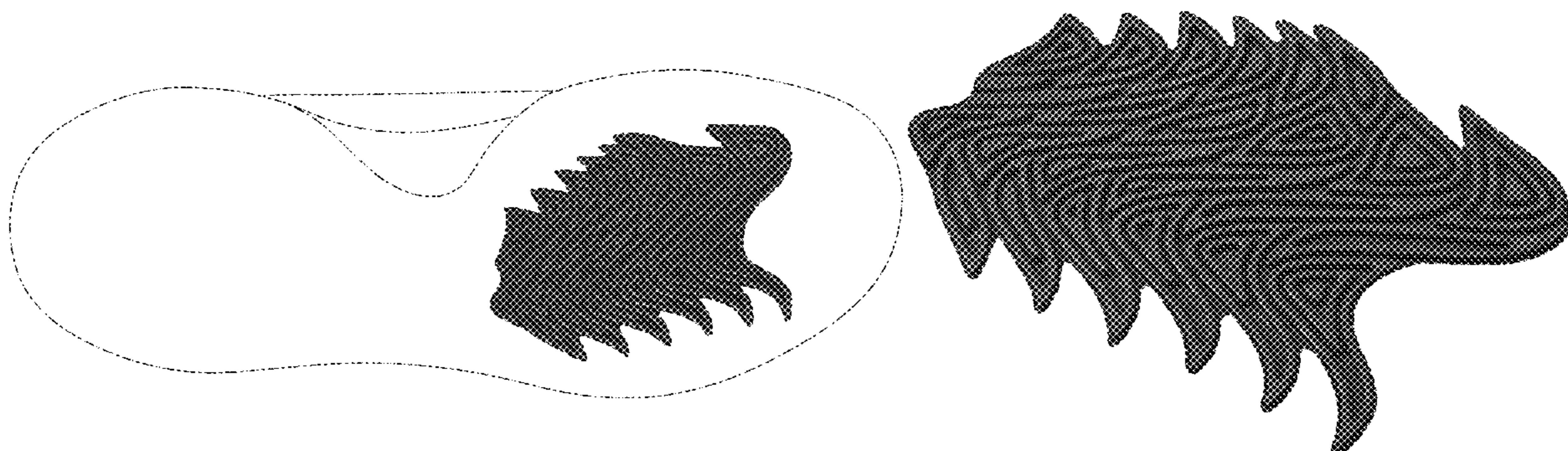
FIG. 1 is a front perspective view of a shoe showing my new design;

FIG. 2 is a bottom view thereof; and,

FIG. 3 is an enlarged view of the claim as shown in FIG. 1 with environment removed for clarity purpose.

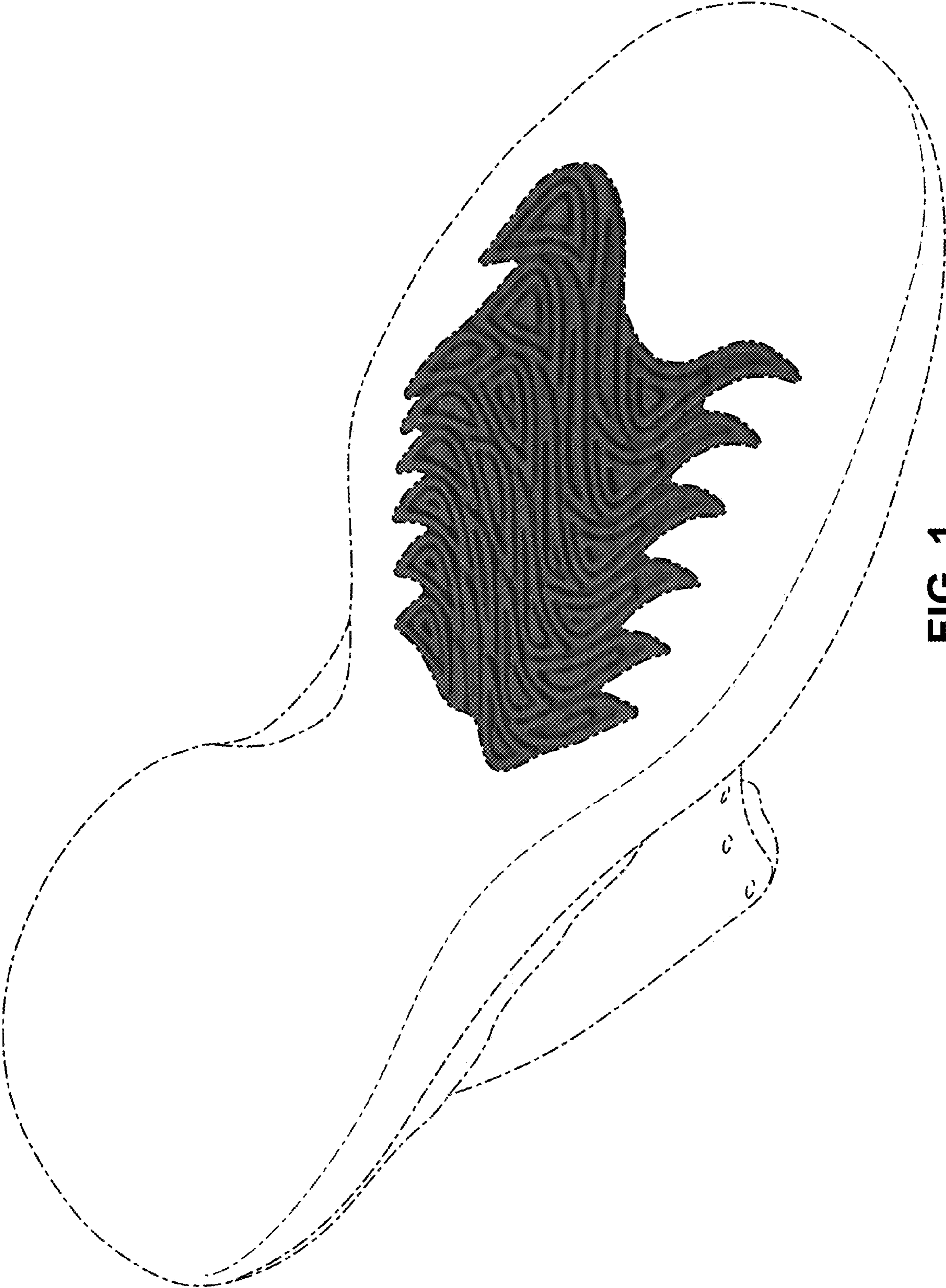

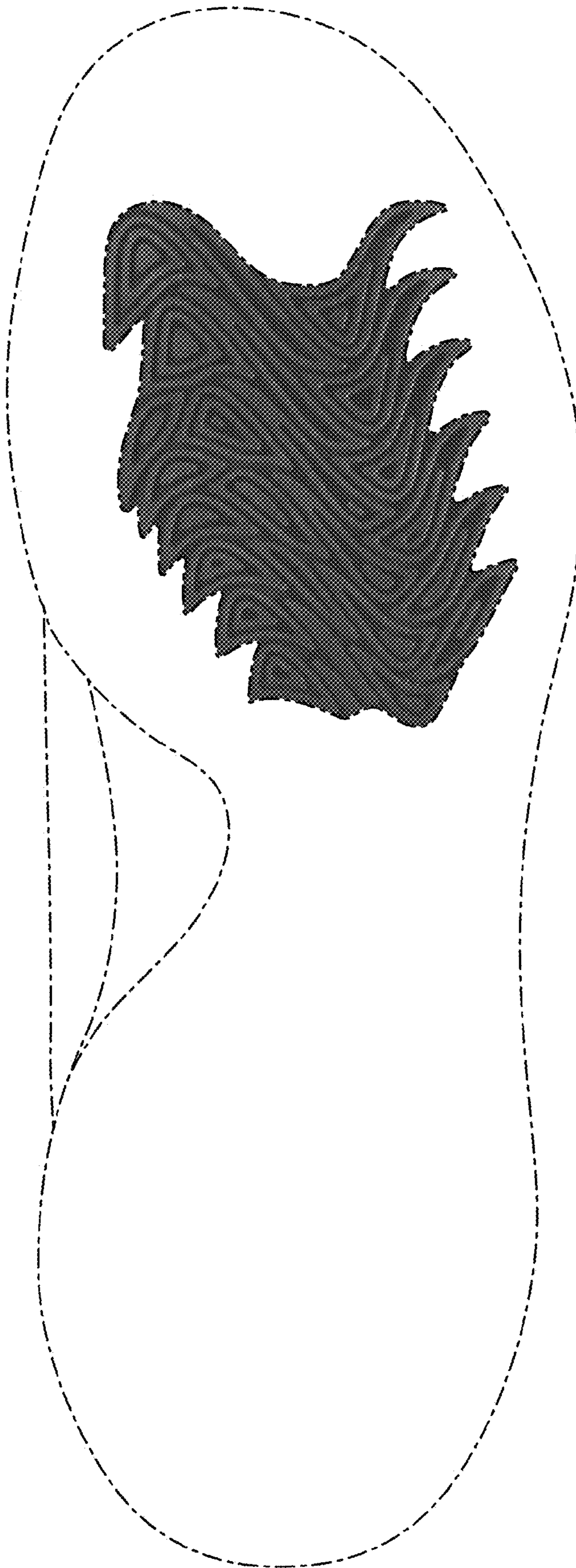

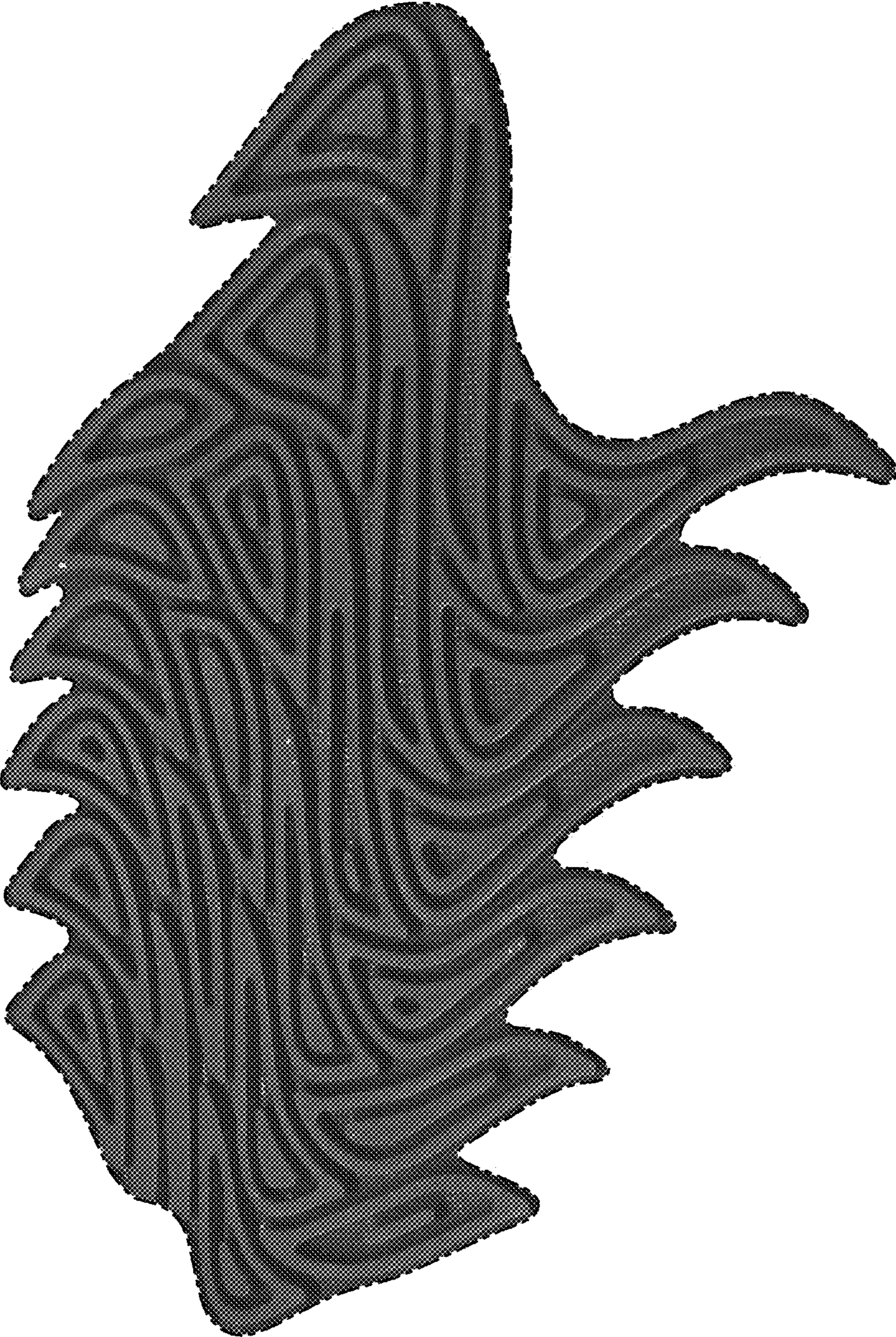
