(57) **CLAIM**

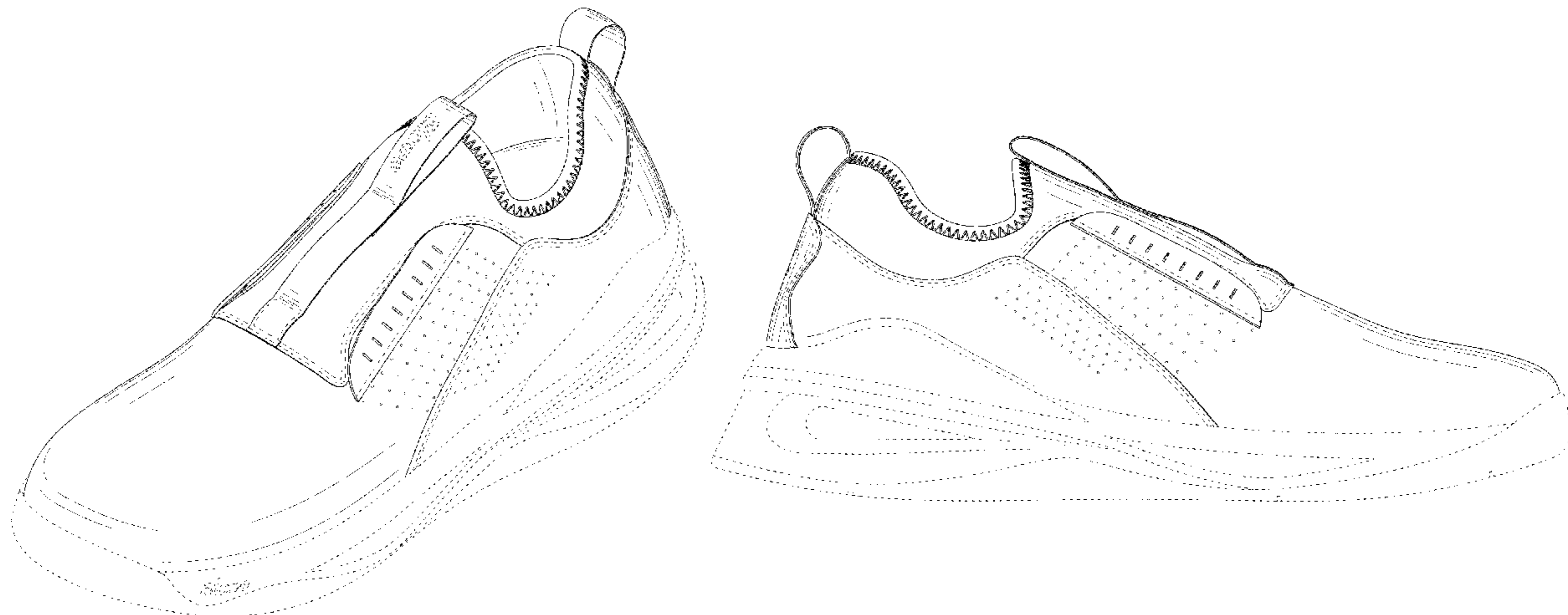
The ornamental design for a shoe upper, as shown and described.

DESCRIPTION

FIG. 1 is a top front perspective view of a shoe upper showing our new design;
FIG. 2 is a bottom rear perspective view thereof;
FIG. 3 is a front view thereof;
FIG. 4 is a rear view thereof;
FIG. 5 is a medial side view from the inside edge thereof;
FIG. 6 is a lateral side view from the outer edge thereof;
FIG. 7 is a top plan view thereof; and,
FIG. 8 is a bottom plan view thereof.

The broken lines in the drawings depict portions of the shoe that form no part of the claimed design. The even length broken lines within the shaded portions of the shoe upper depict stitching, which forms no part of the claimed design.

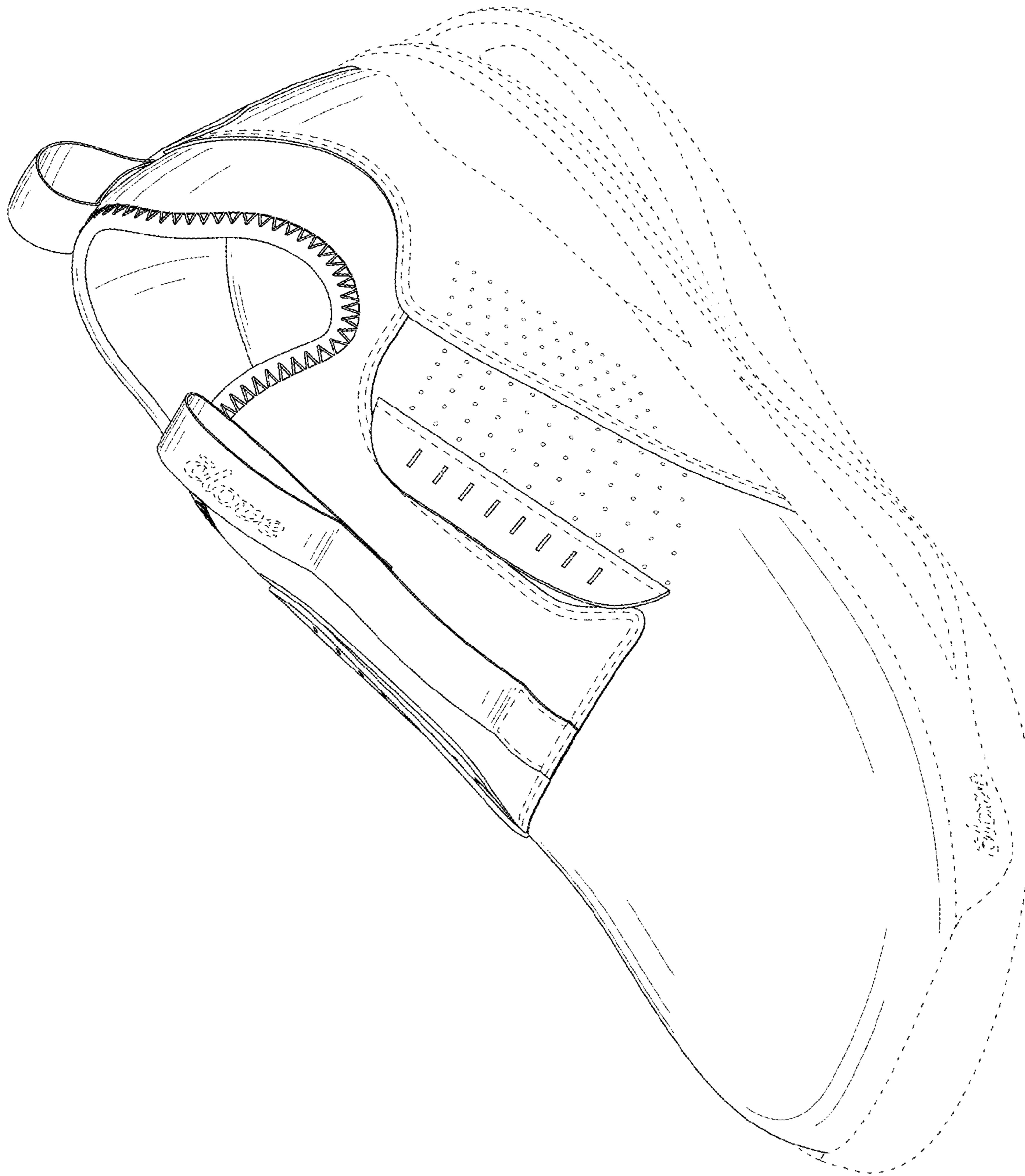

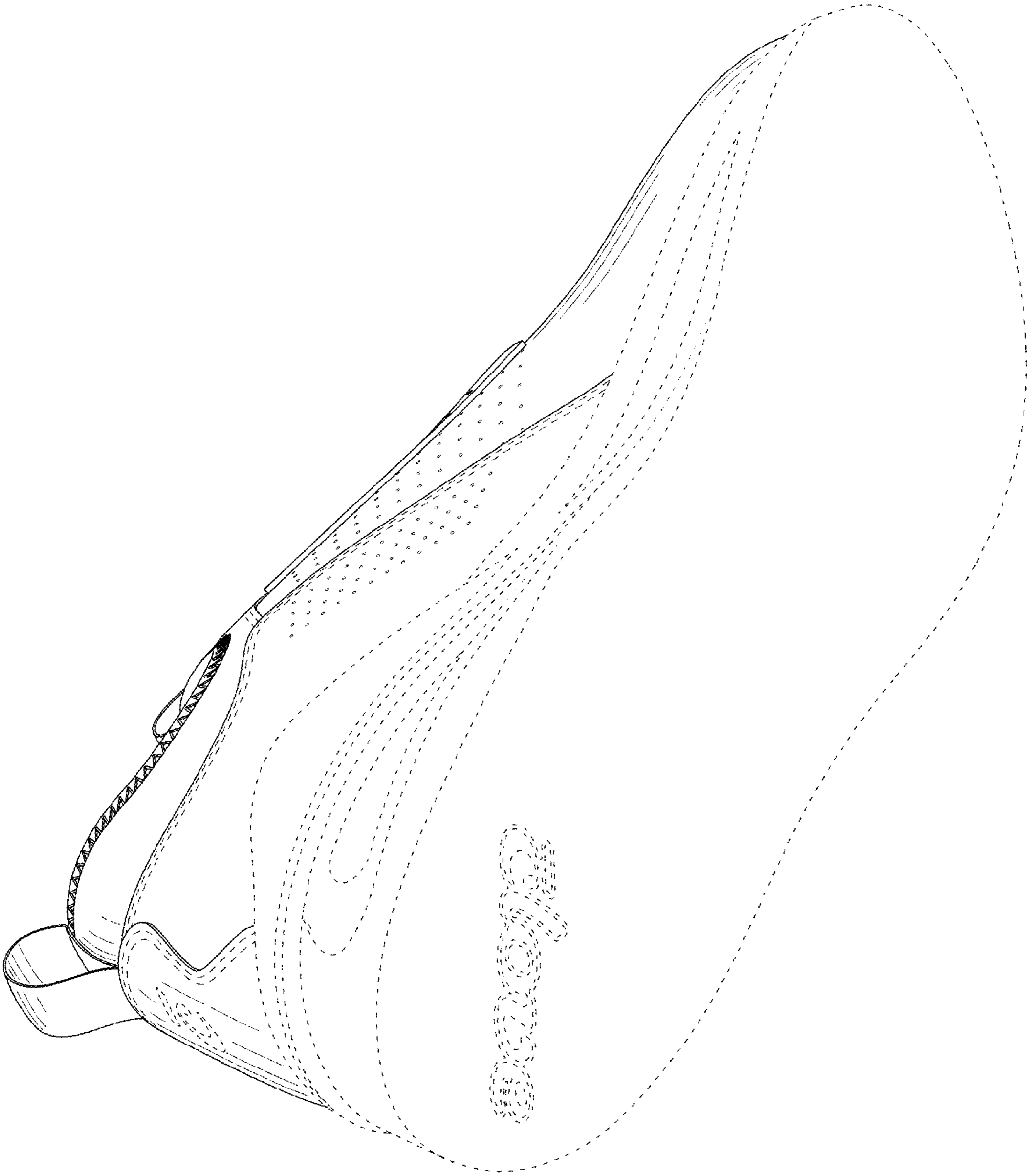

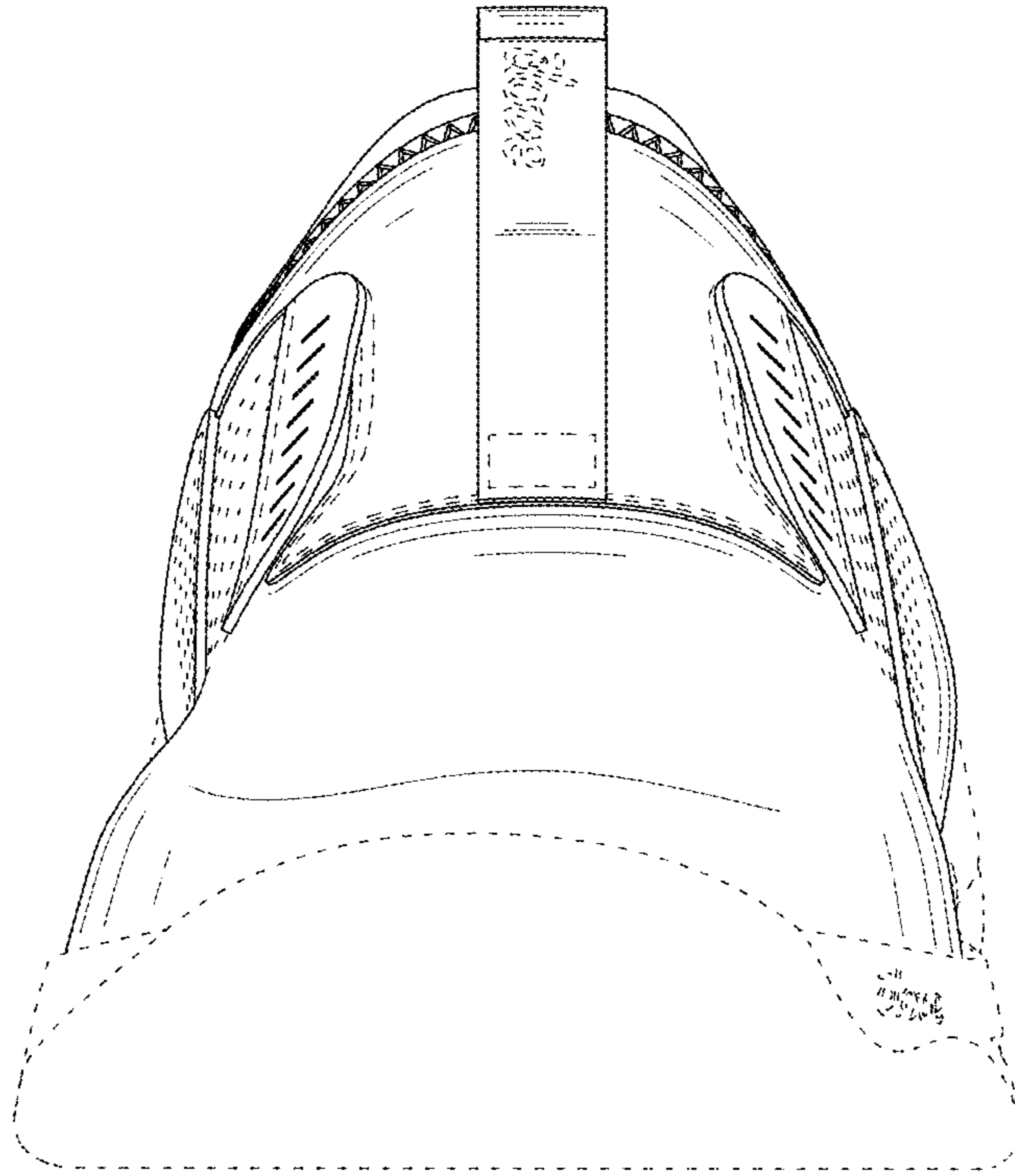

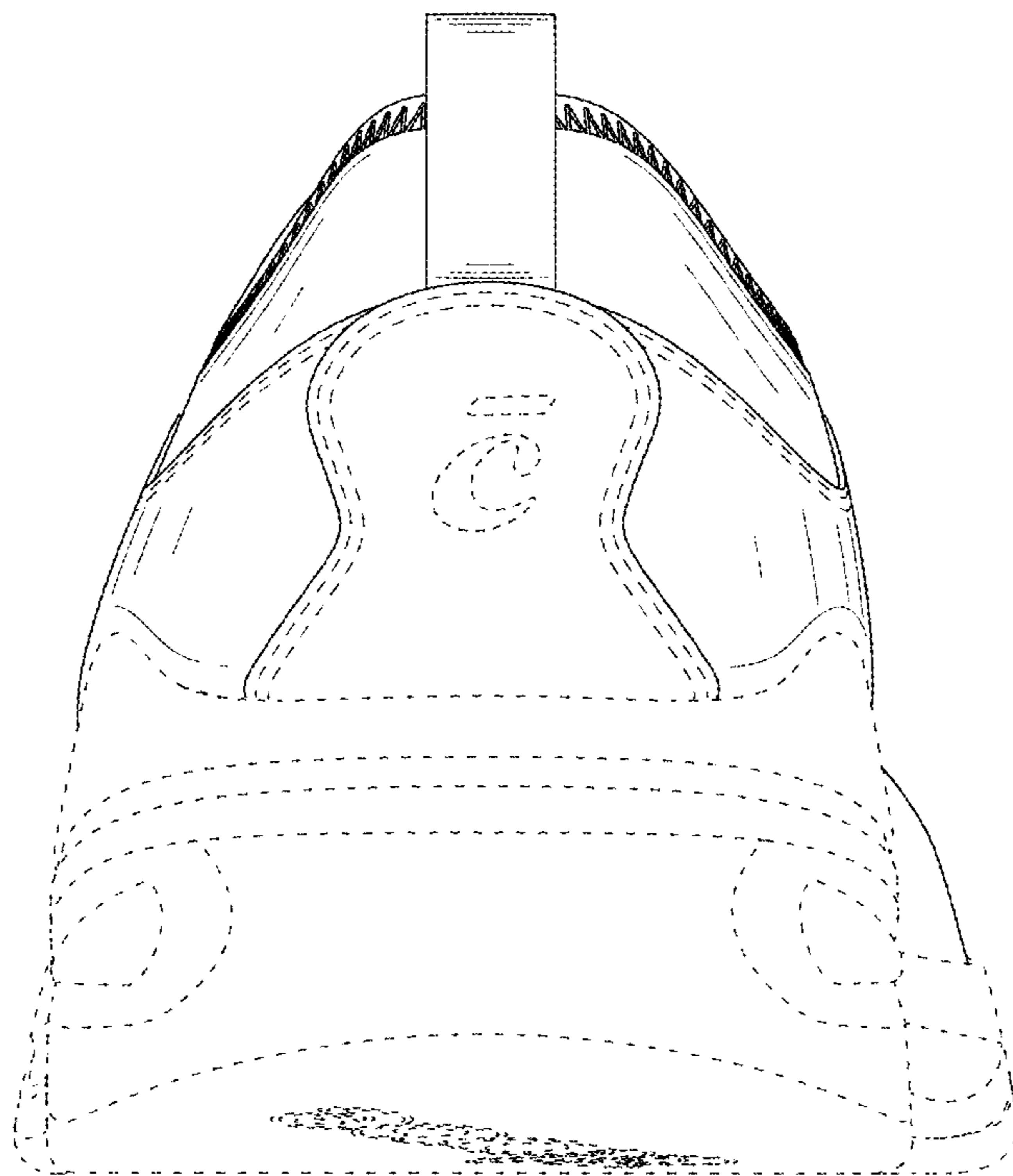

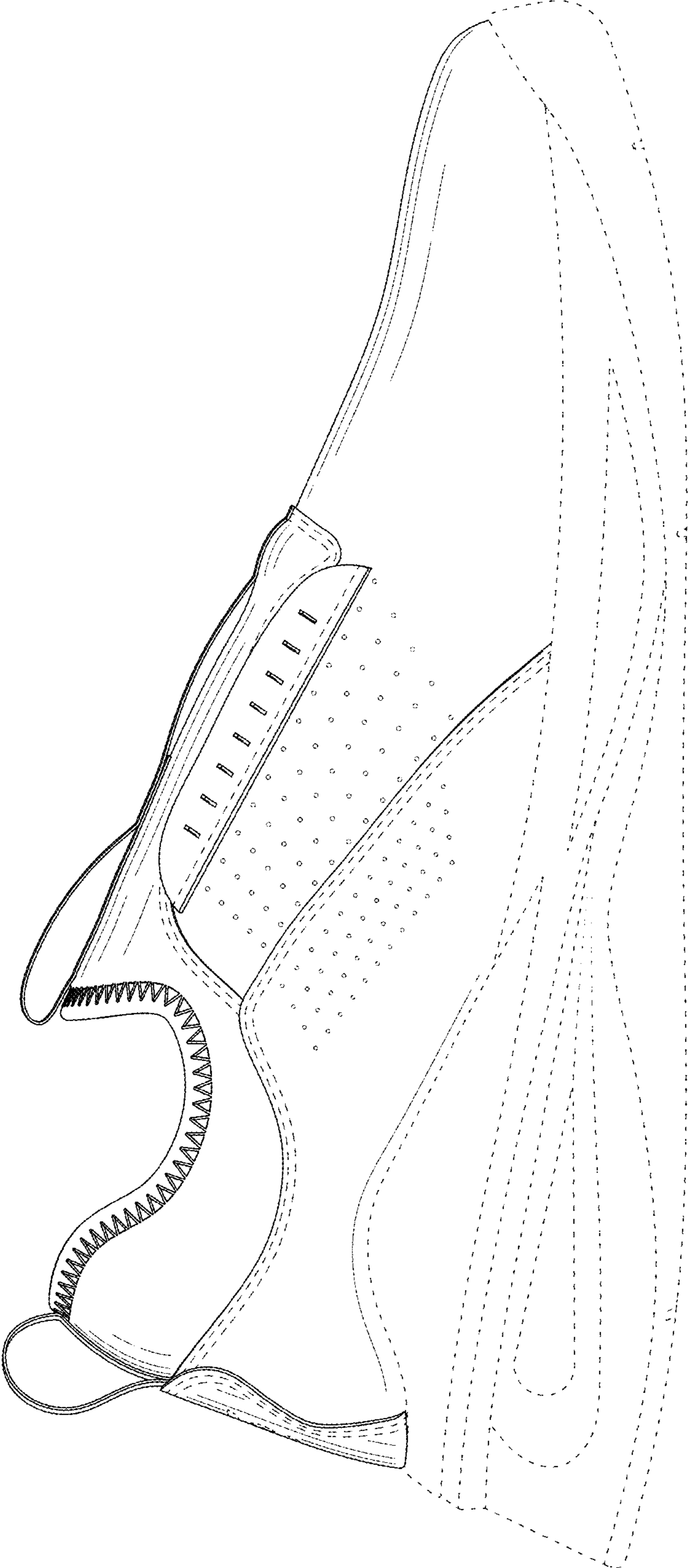

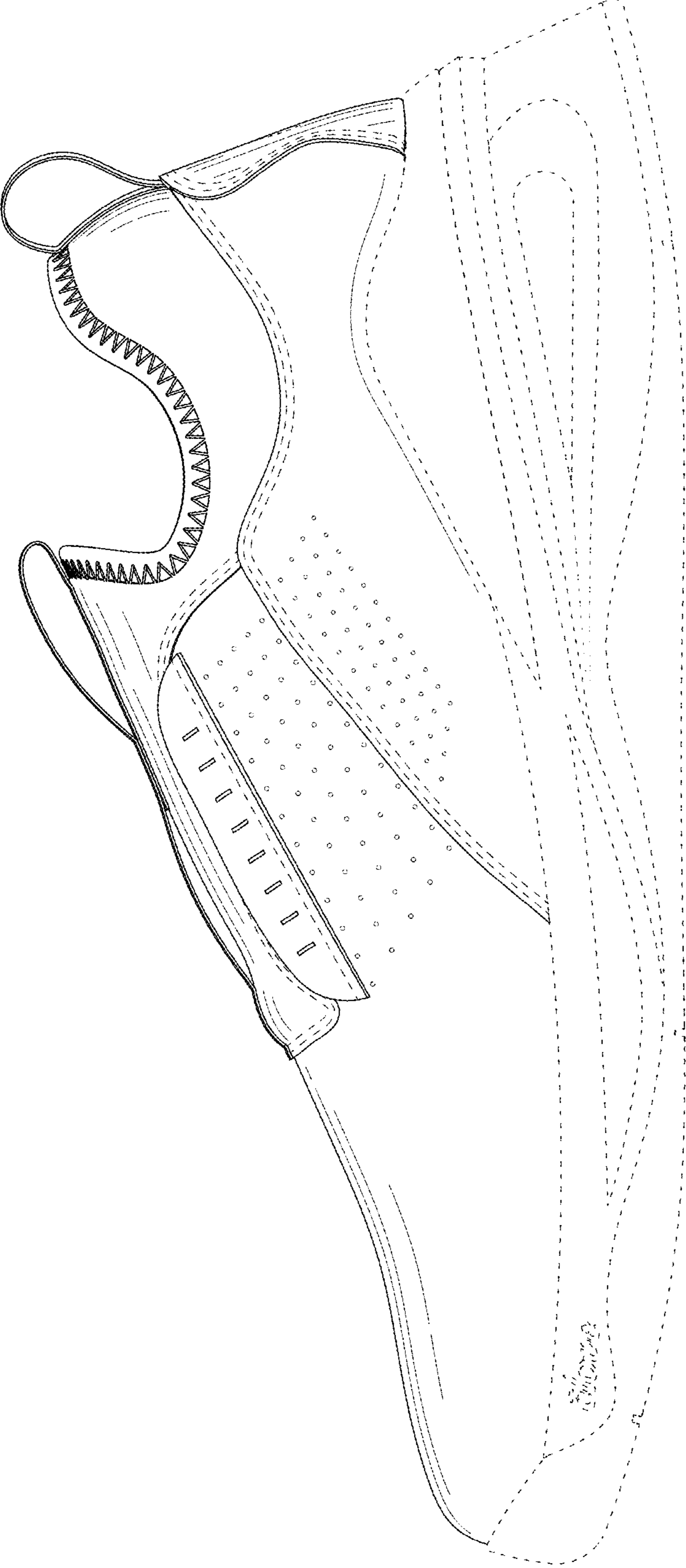

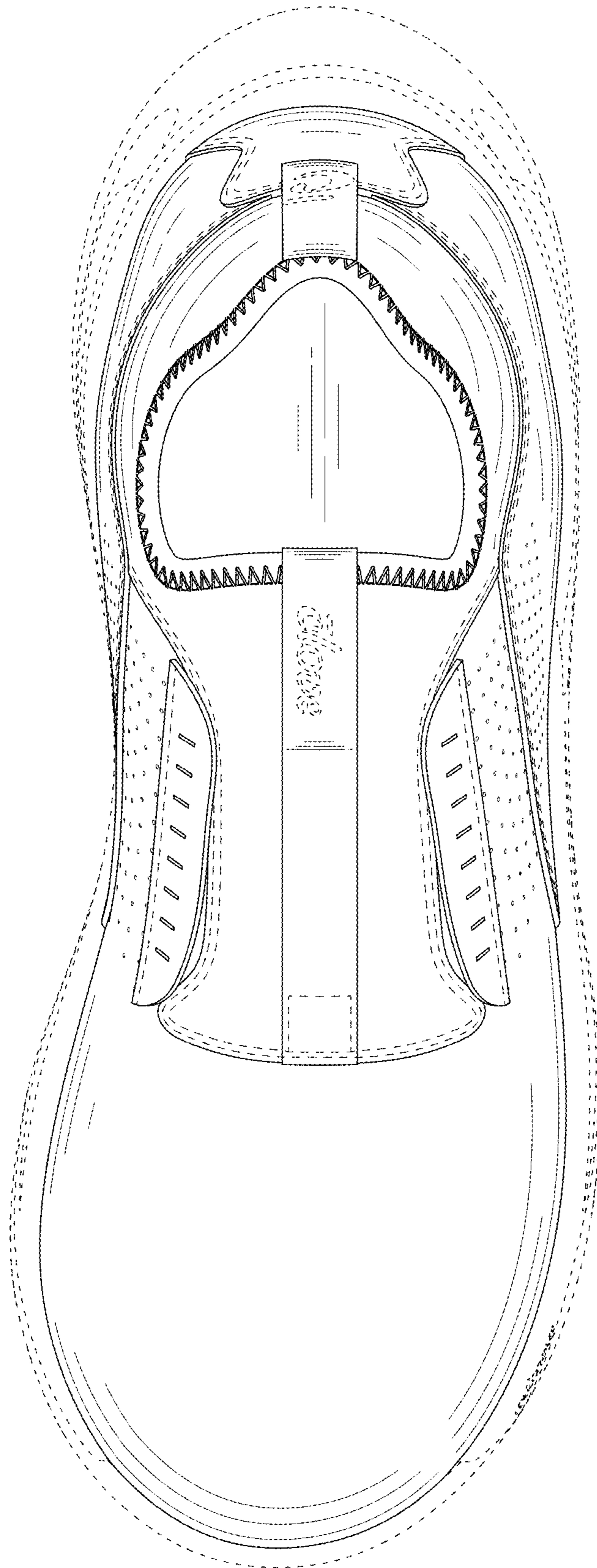

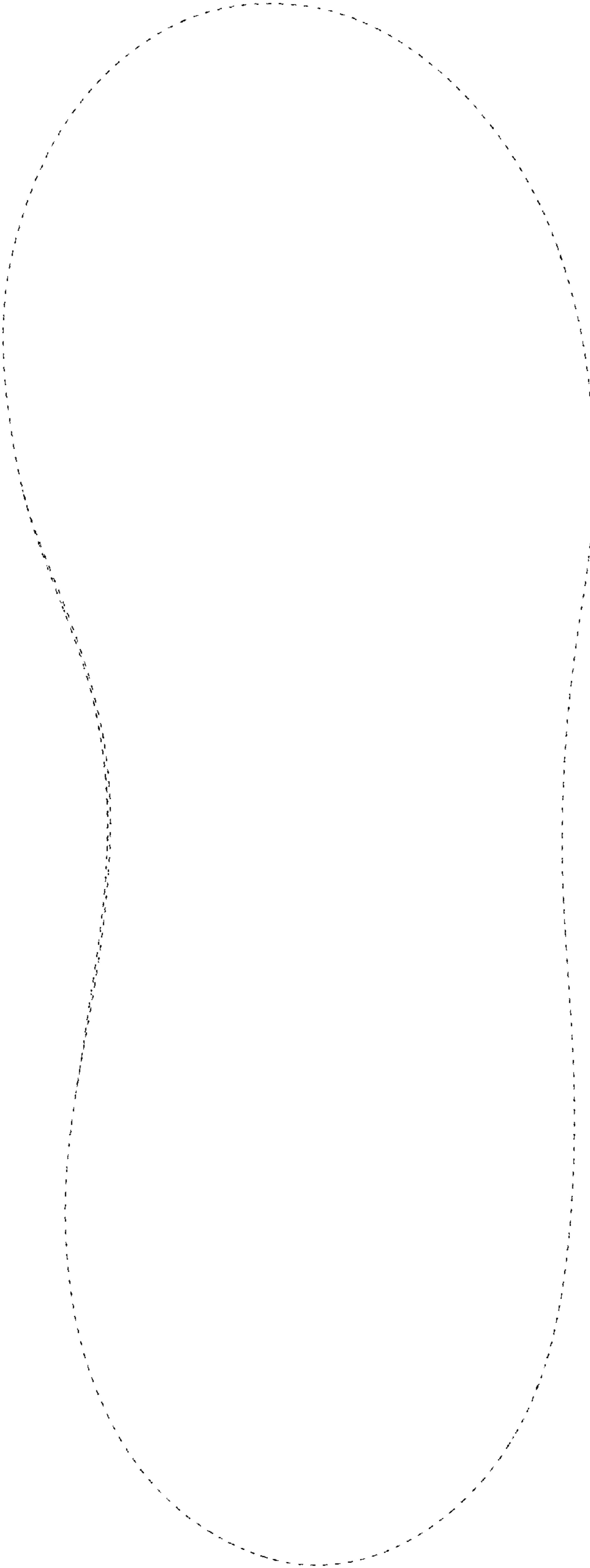
