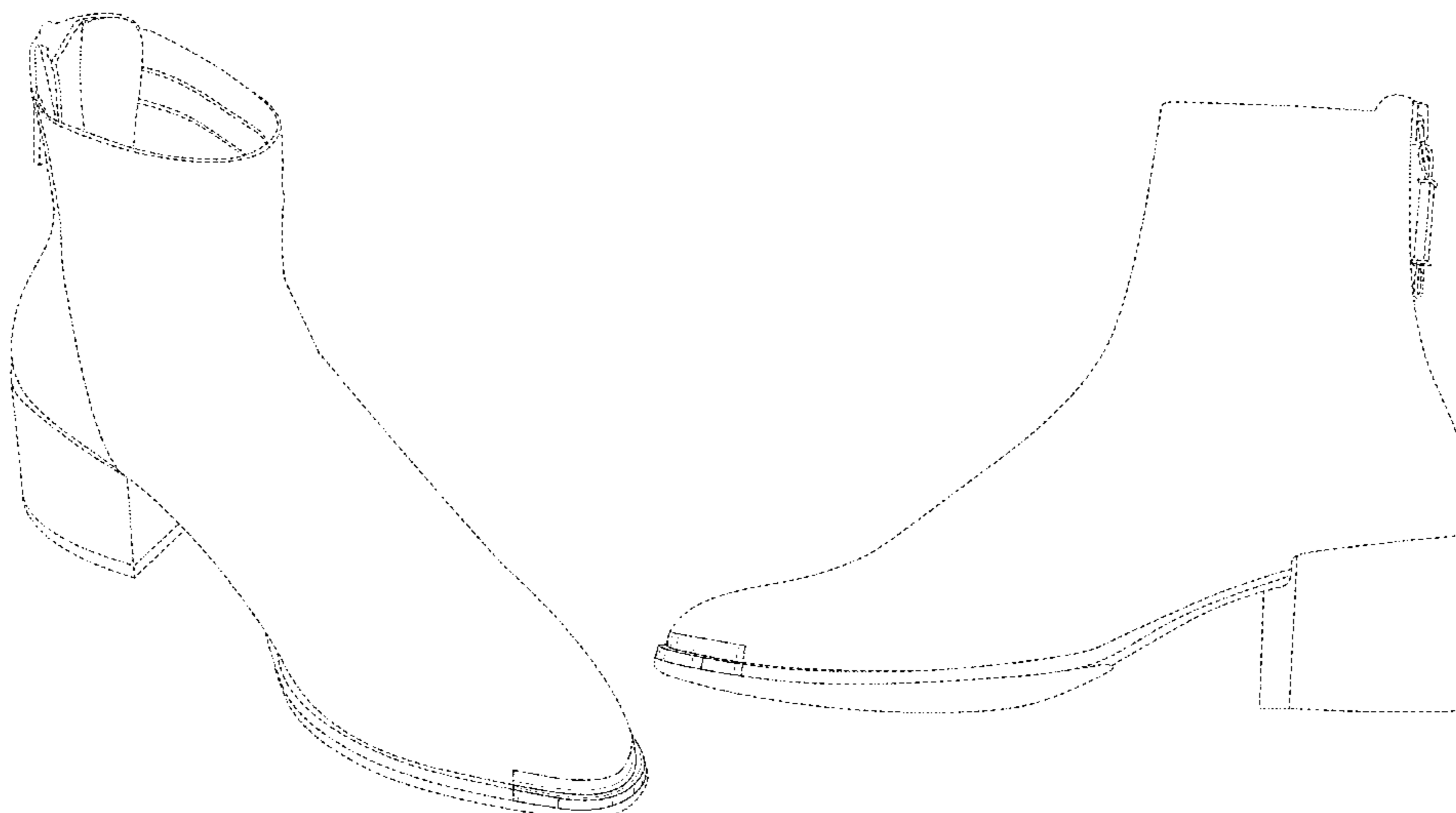
(57) **CLAIM**

The ornamental design for a toe portion of a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a toe portion of a shoe showing our new design;
FIG. 2 is a left side view thereof;
FIG. 3 is a right side view thereof; and,
FIG. 4 is a top view thereof.

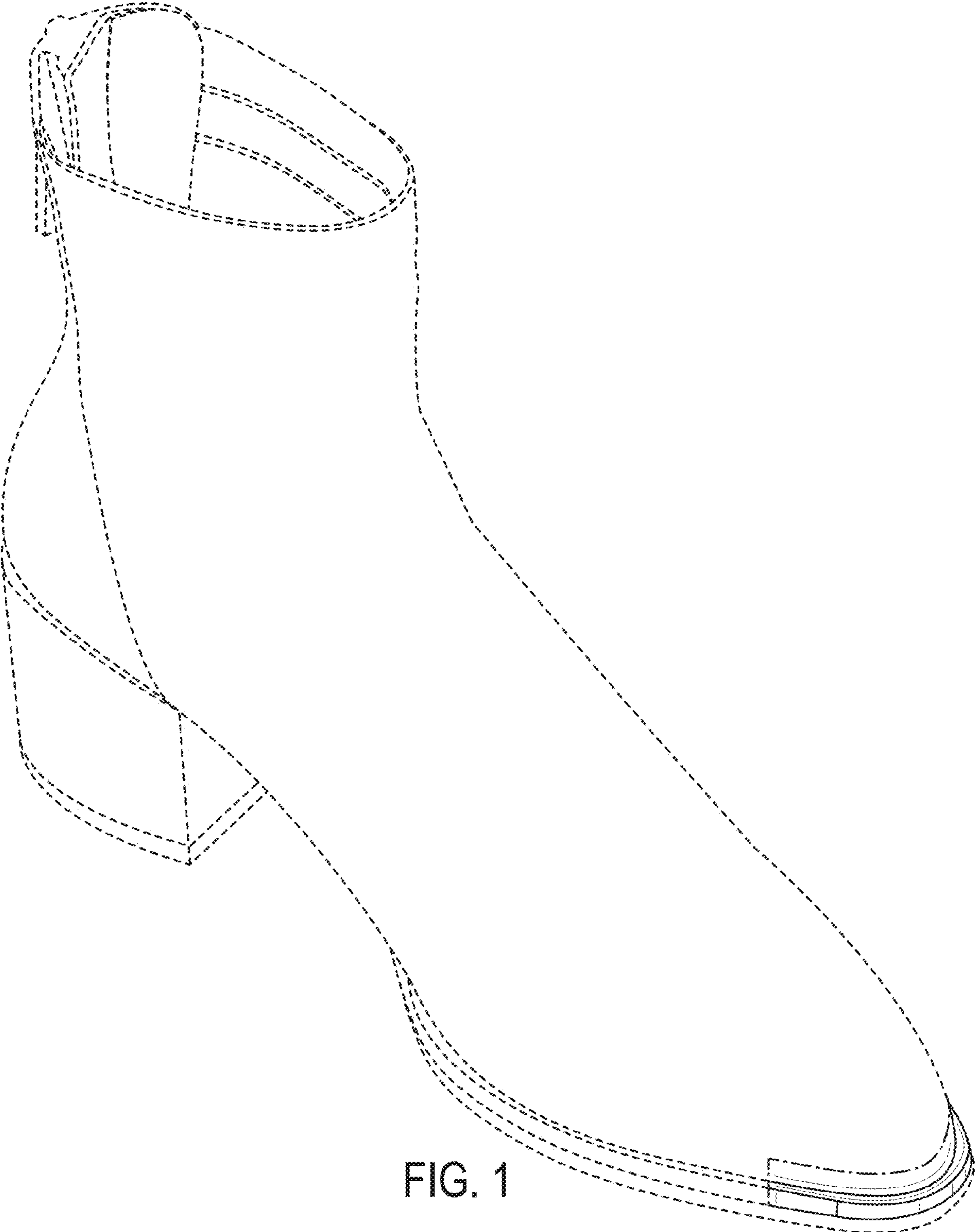

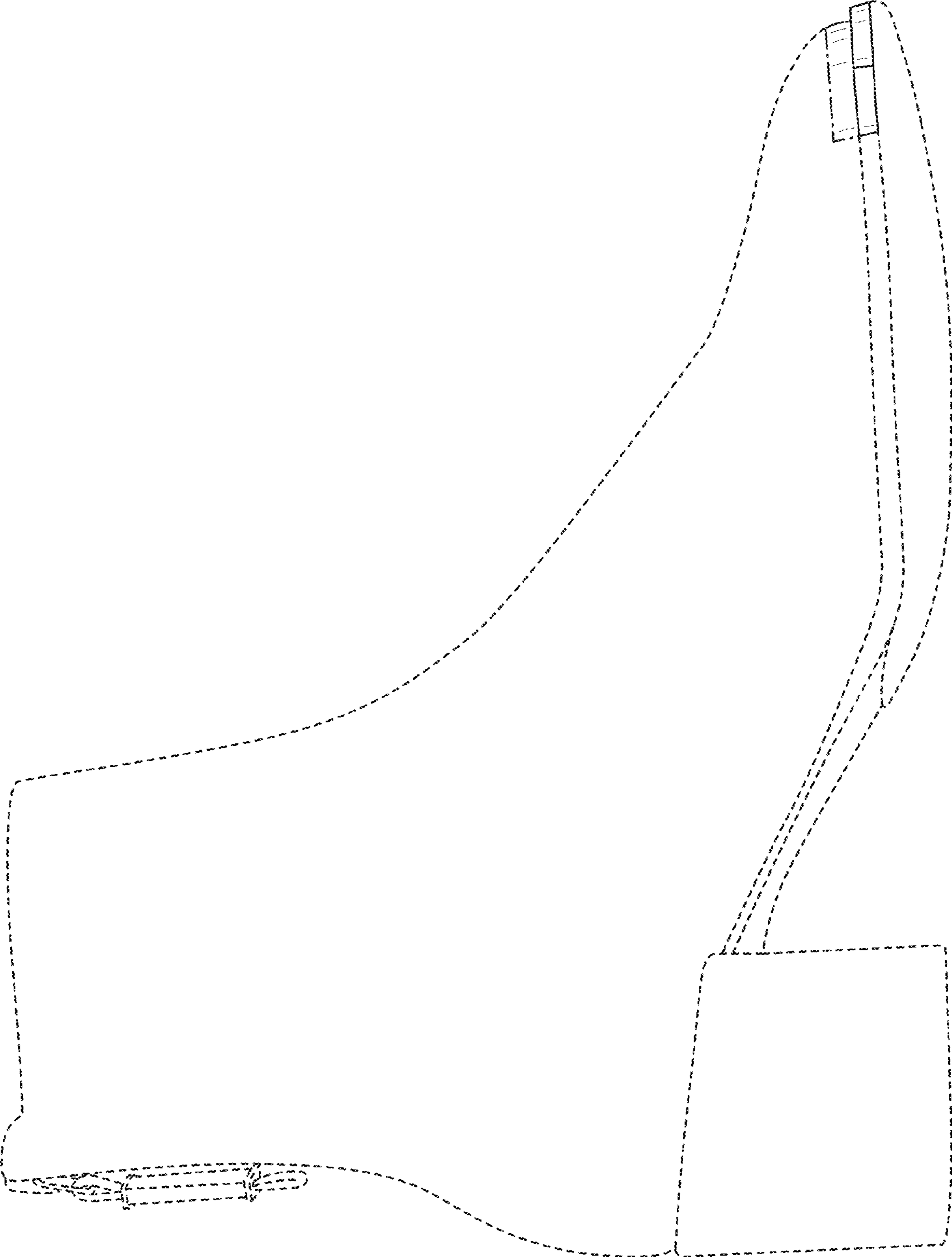

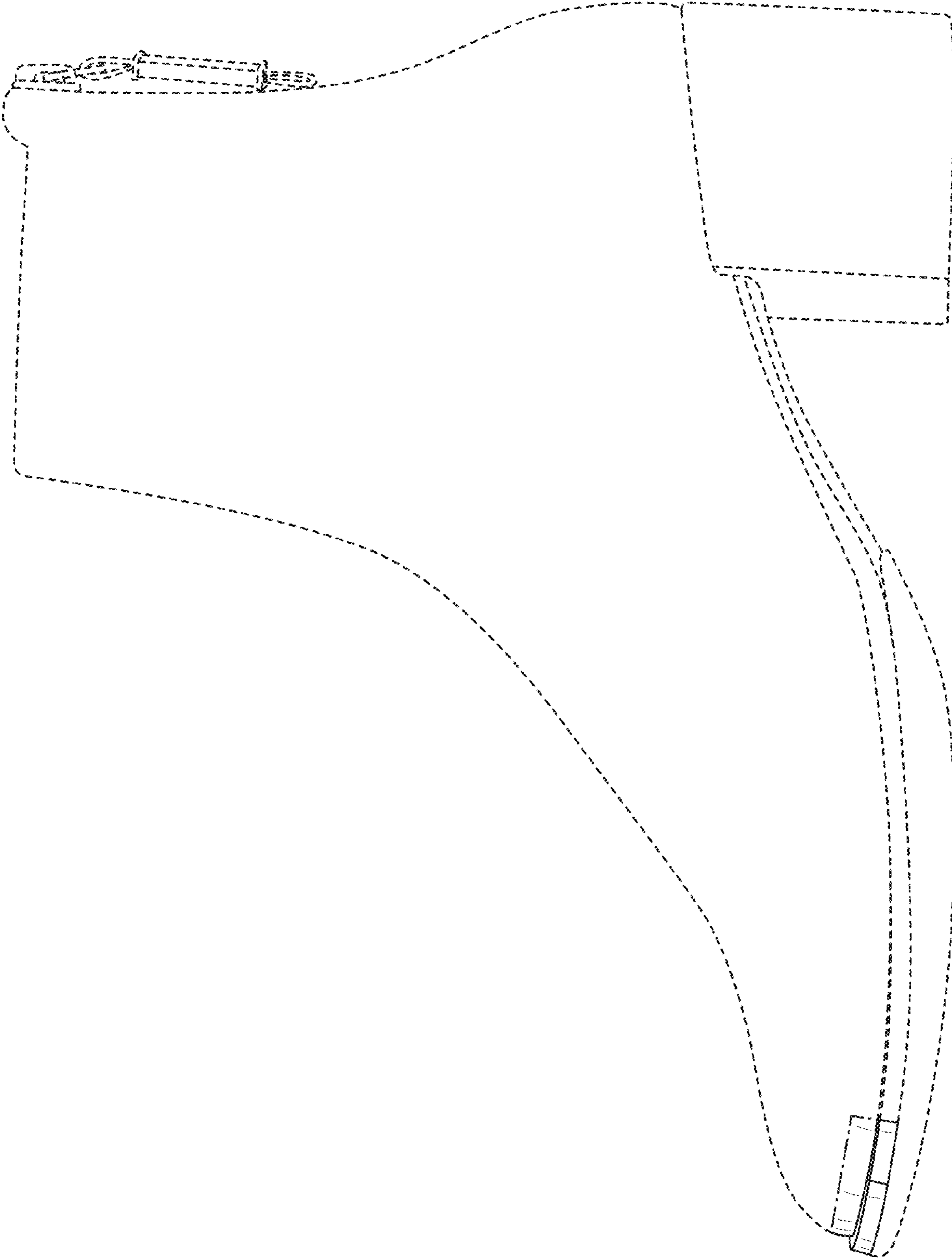

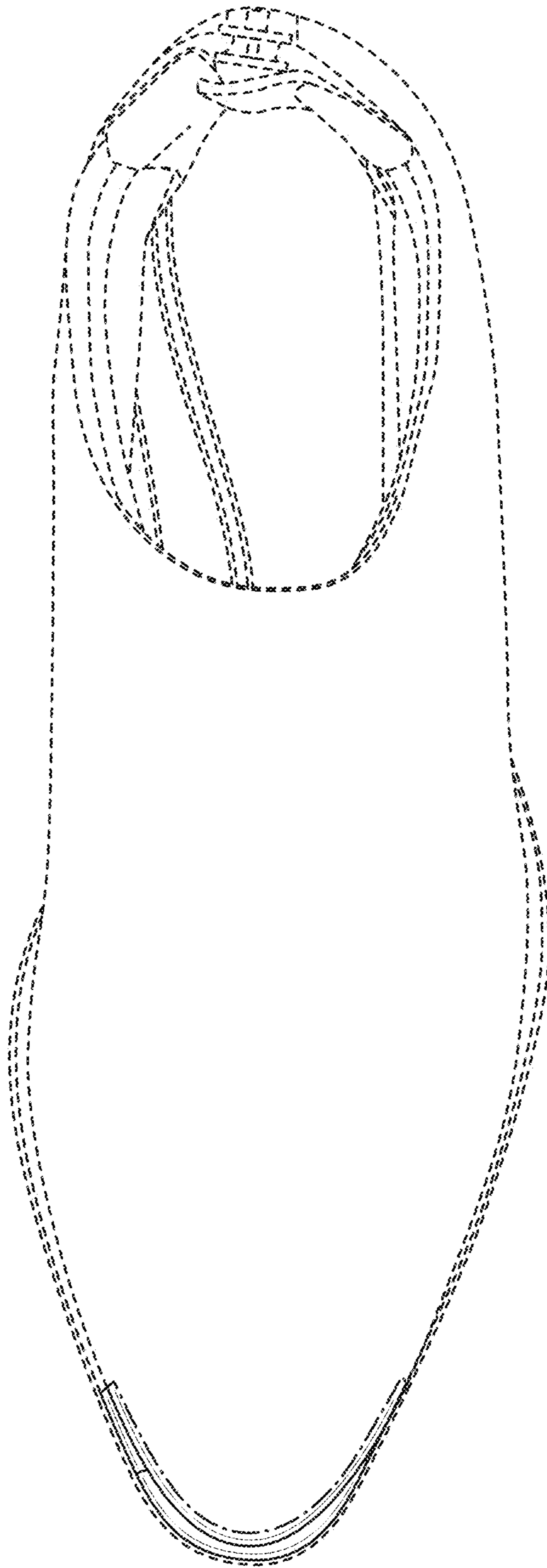
