(57) **CLAIM**

The ornamental design for a shoe with ornamentation, as shown and described.

**DESCRIPTION**

FIG. 1 is an elevated perspective view of the left side and rear of a right foot shoe with ornamentation showing our new design;

FIG. 2 is an elevated perspective view of the right side and front thereof;

FIG. 3 is a lower perspective view of the right side and underside thereof;

FIG. 4 is an elevated perspective view of the left side and front thereof;

FIG. 5 is an orthographic view of the right side thereof;

FIG. 6 is an orthographic view of the left side thereof;

FIG. 7 is an orthographic view of the front thereof;

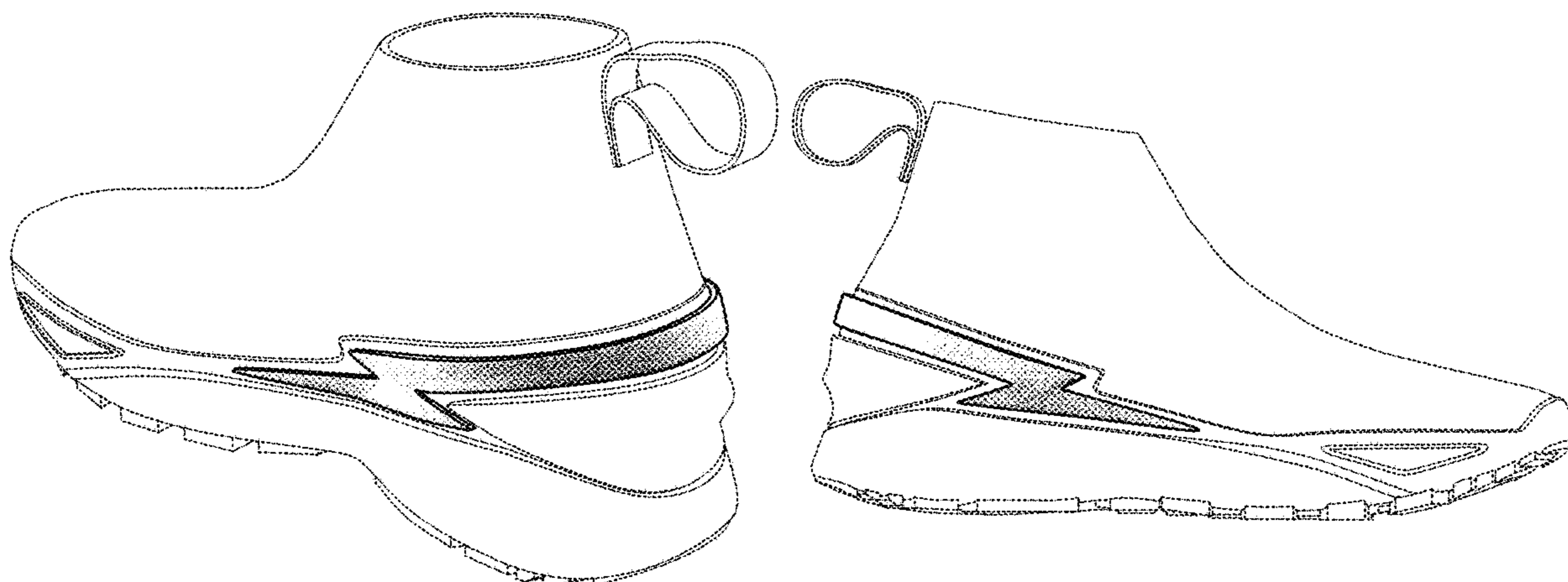
FIG. 8 is an orthographic view of the rear thereof;

FIG. 9 is an orthographic view of the top thereof; and,

FIG. 10 is an orthographic view of the bottom thereof.

The broken lines show portions of the shoe that form no part of the claimed design. A mirrored left foot shoe of the right foot shoe is not shown but is claimed as a second embodiment.

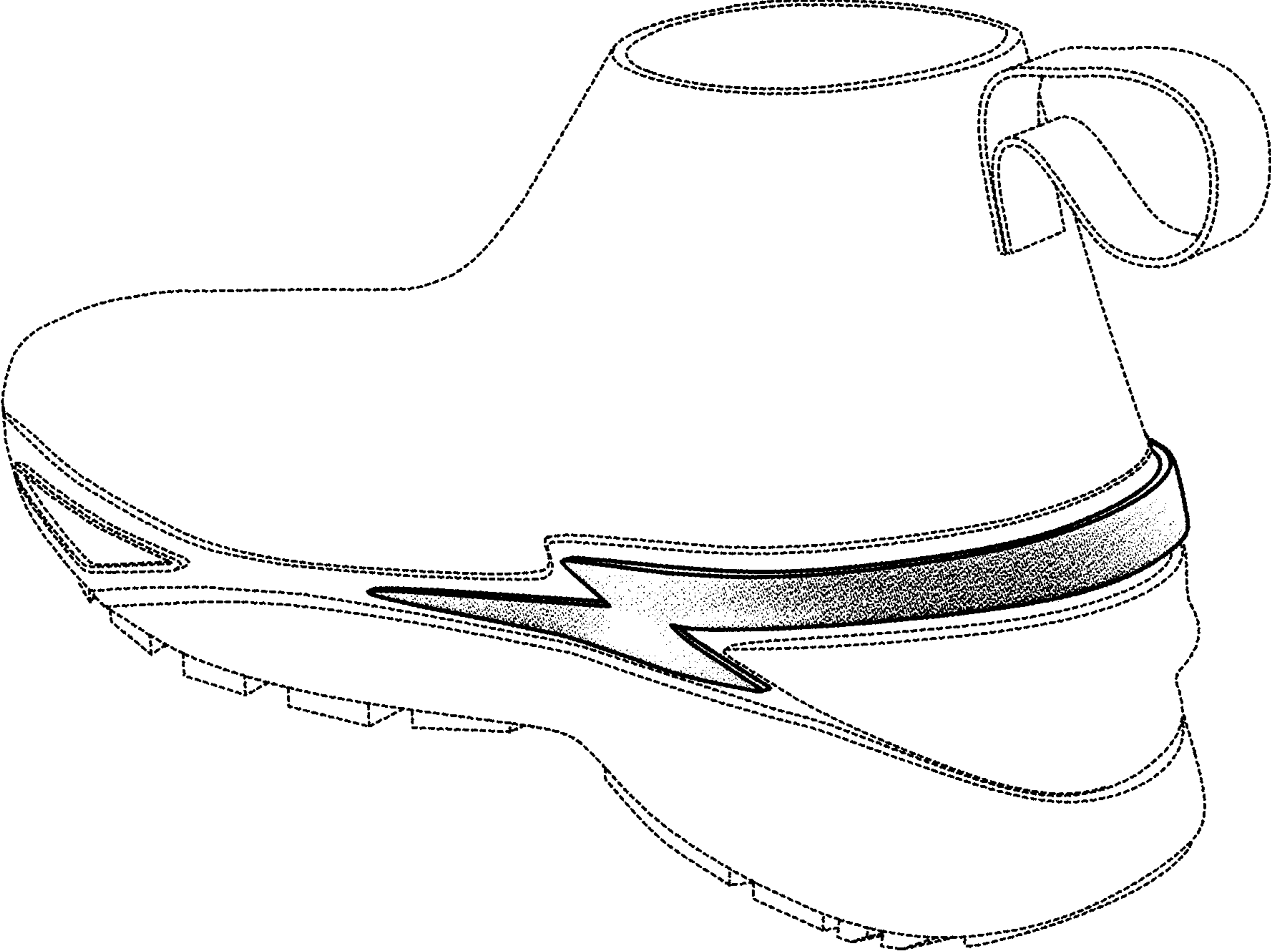

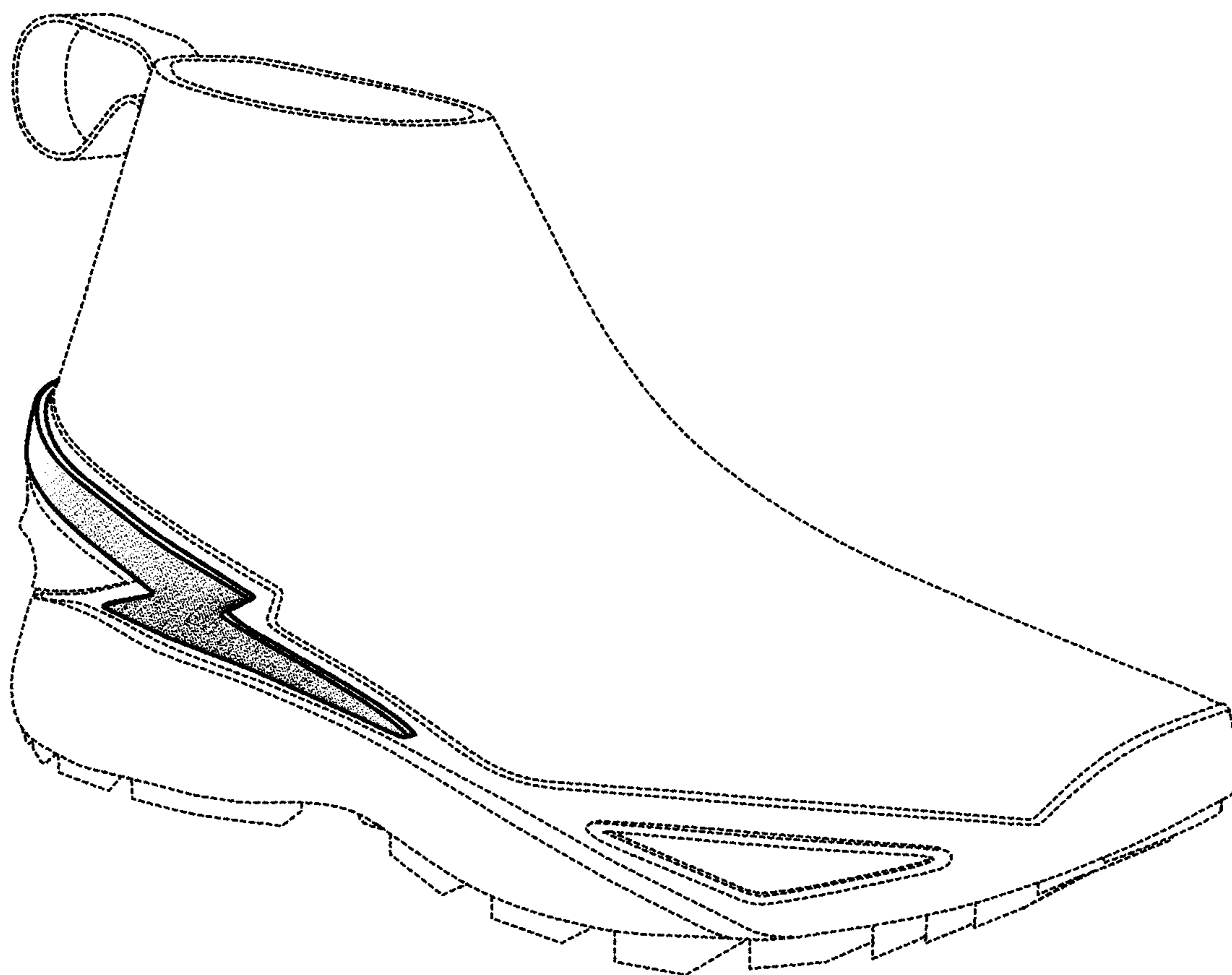

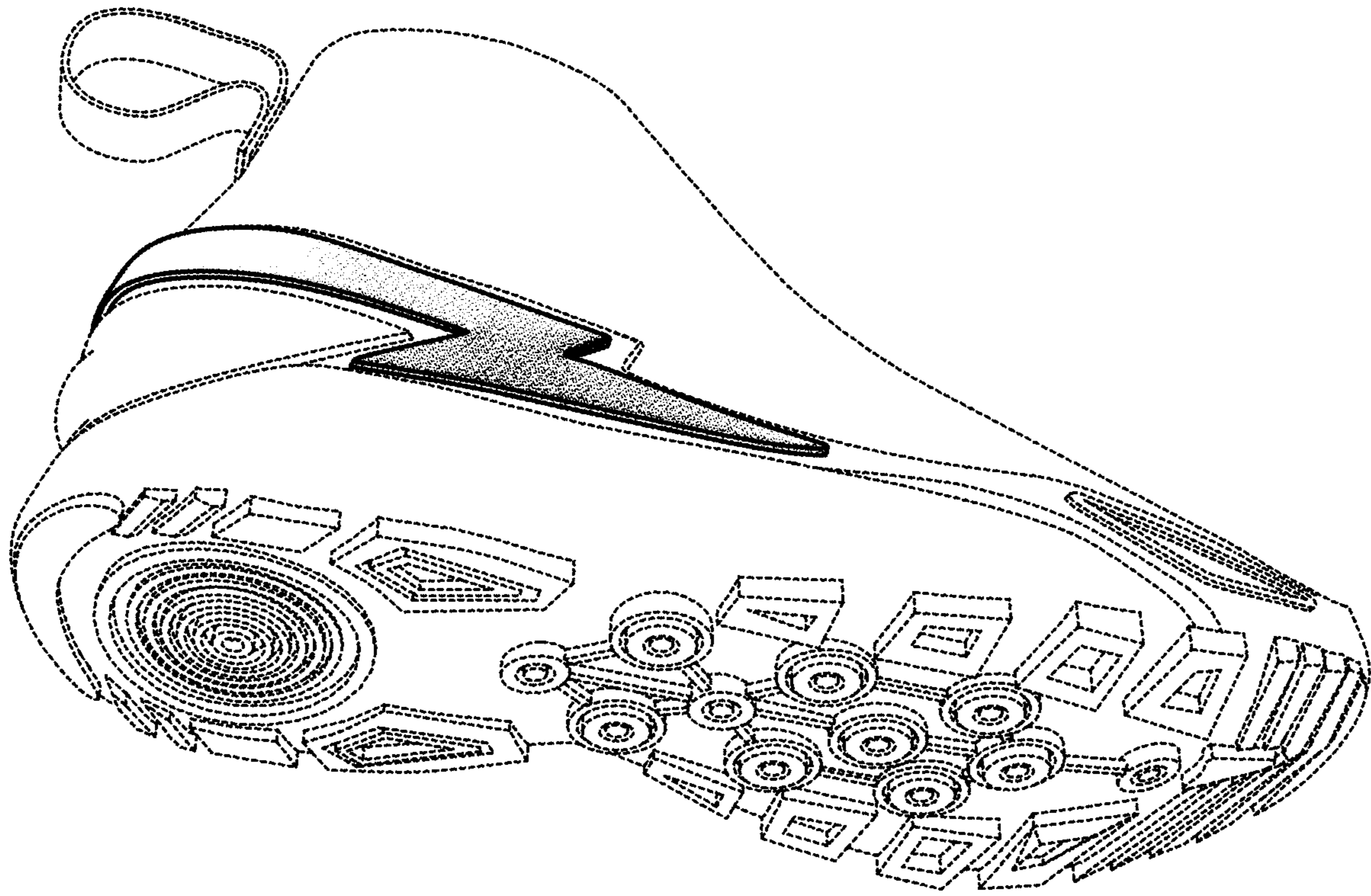

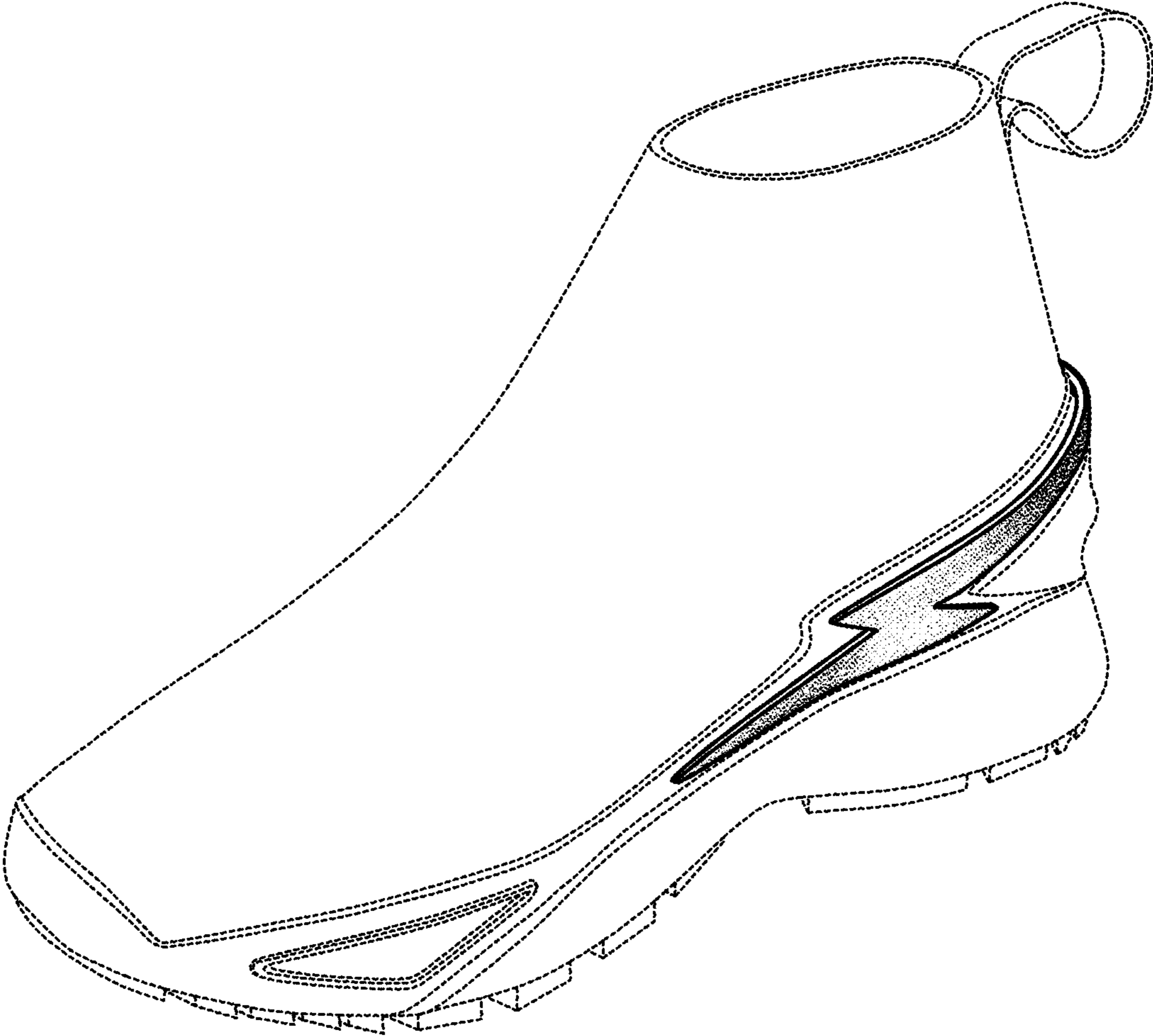

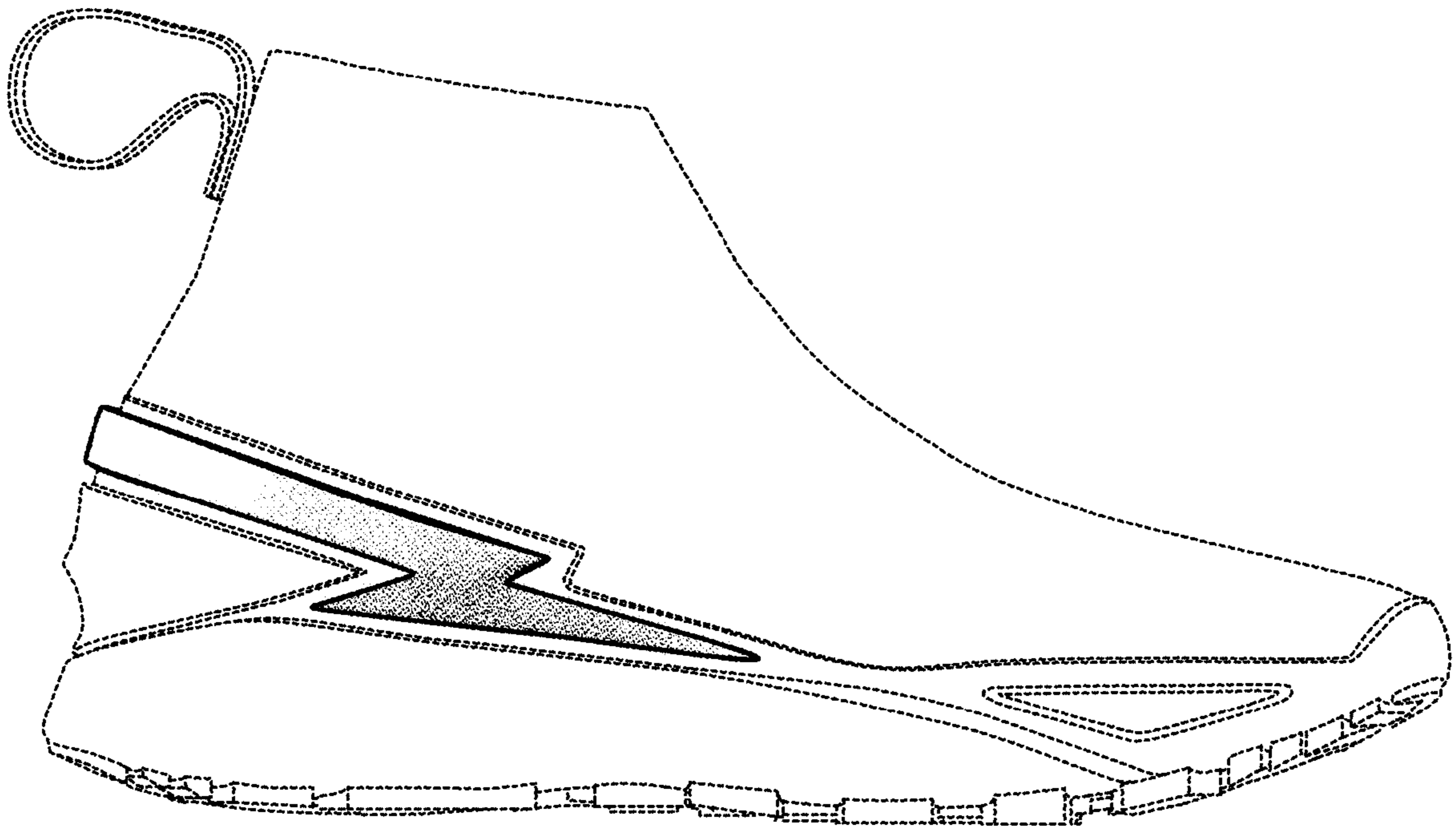

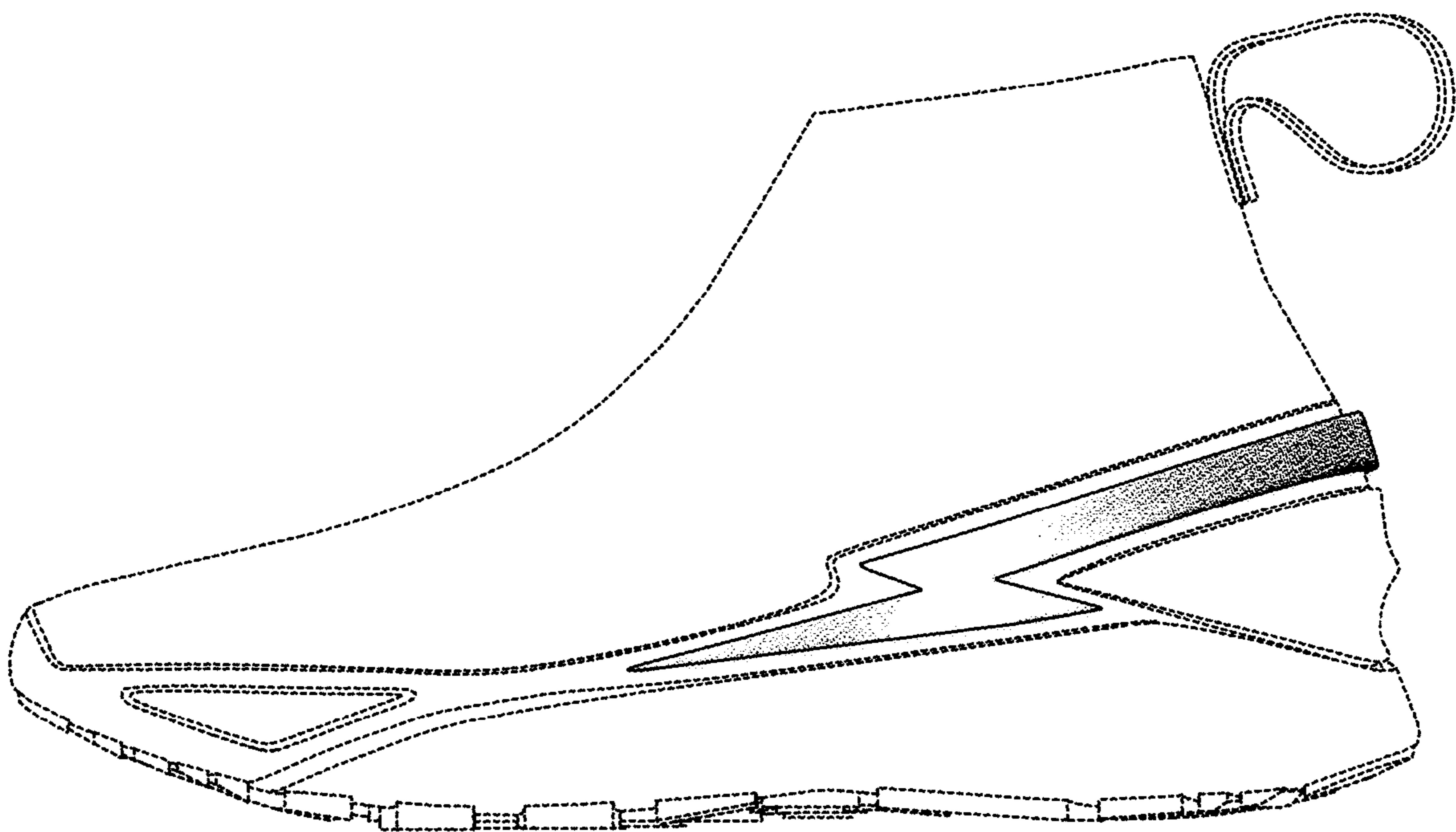

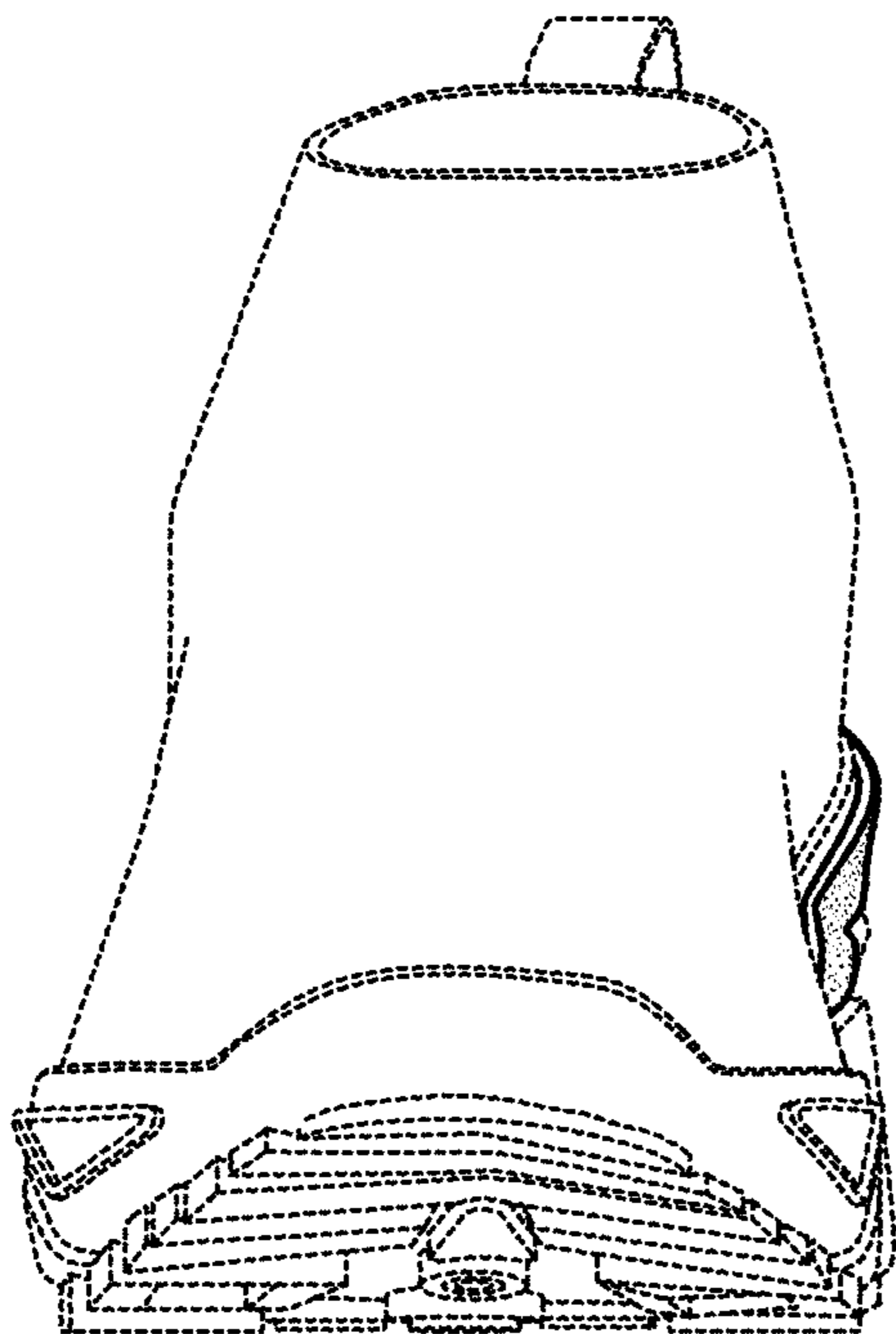

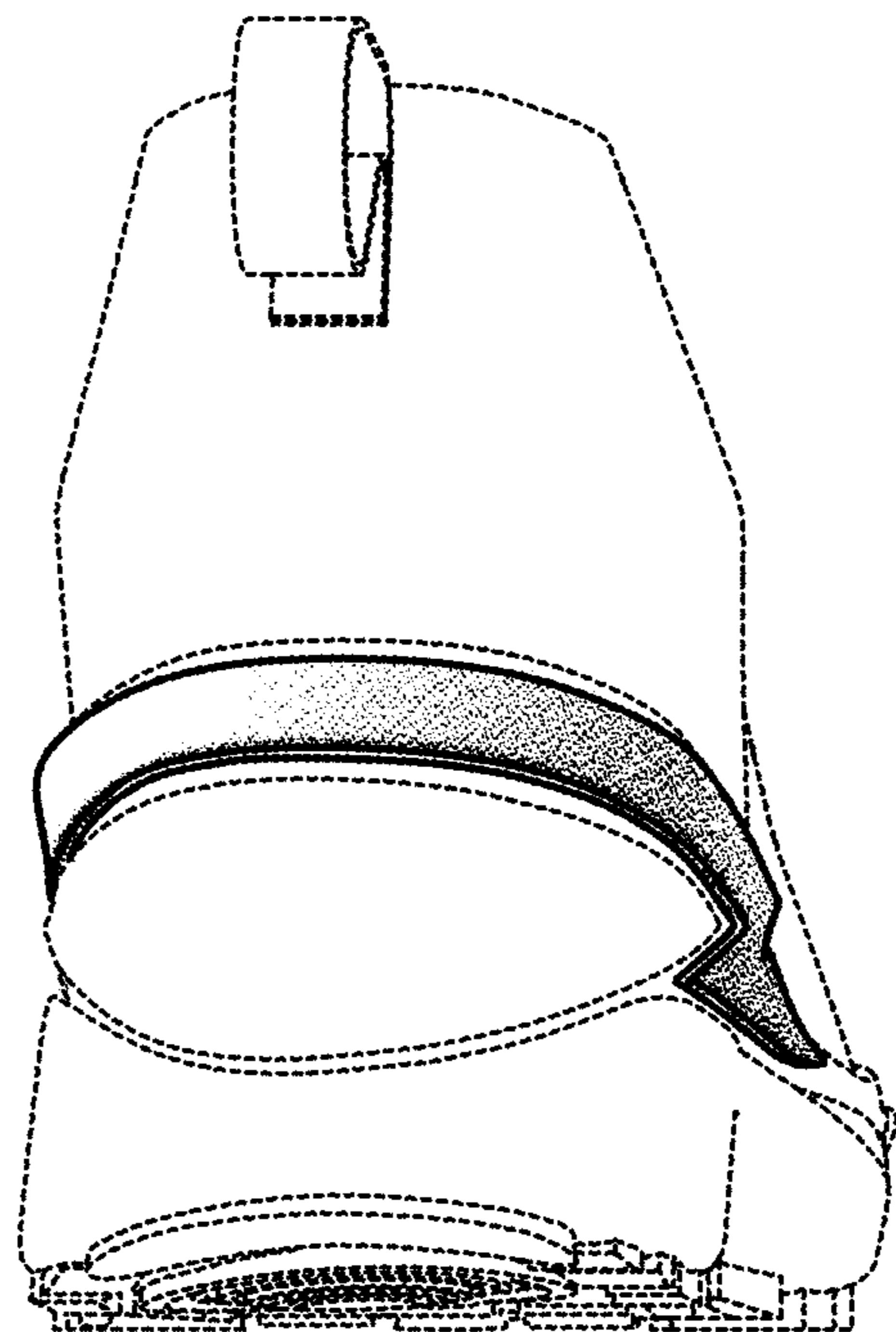

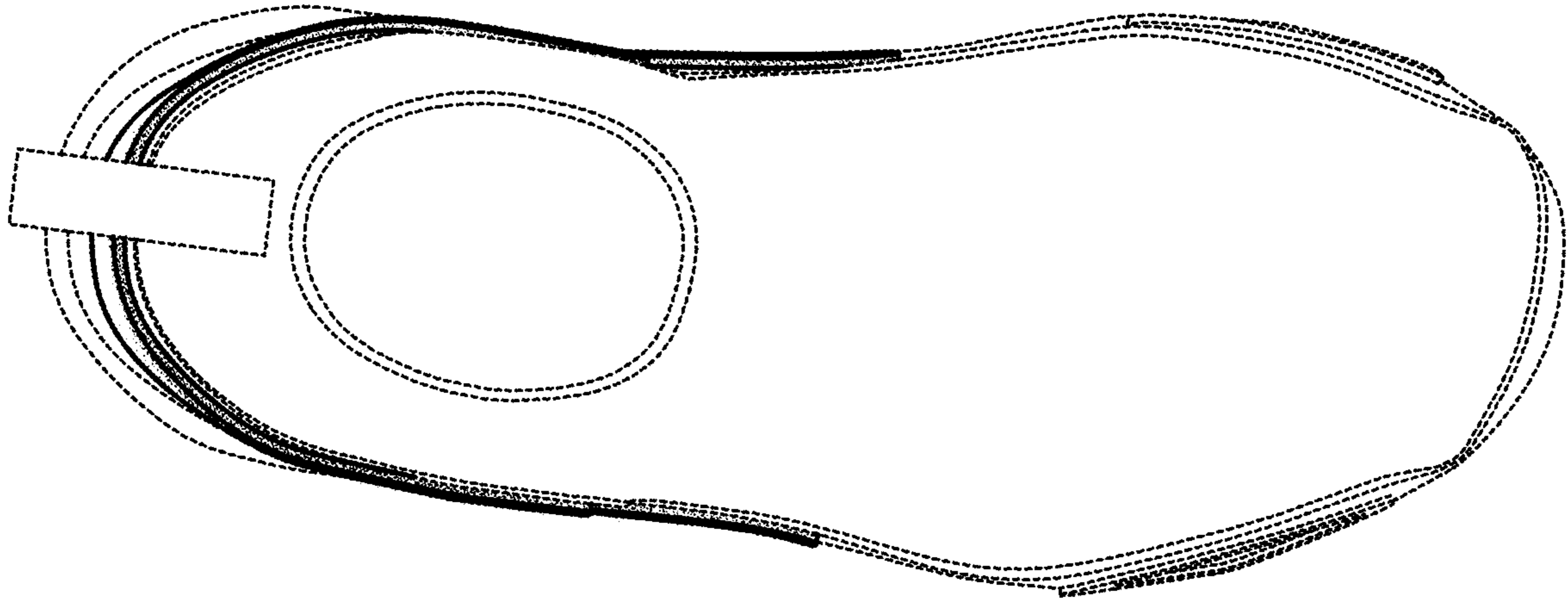

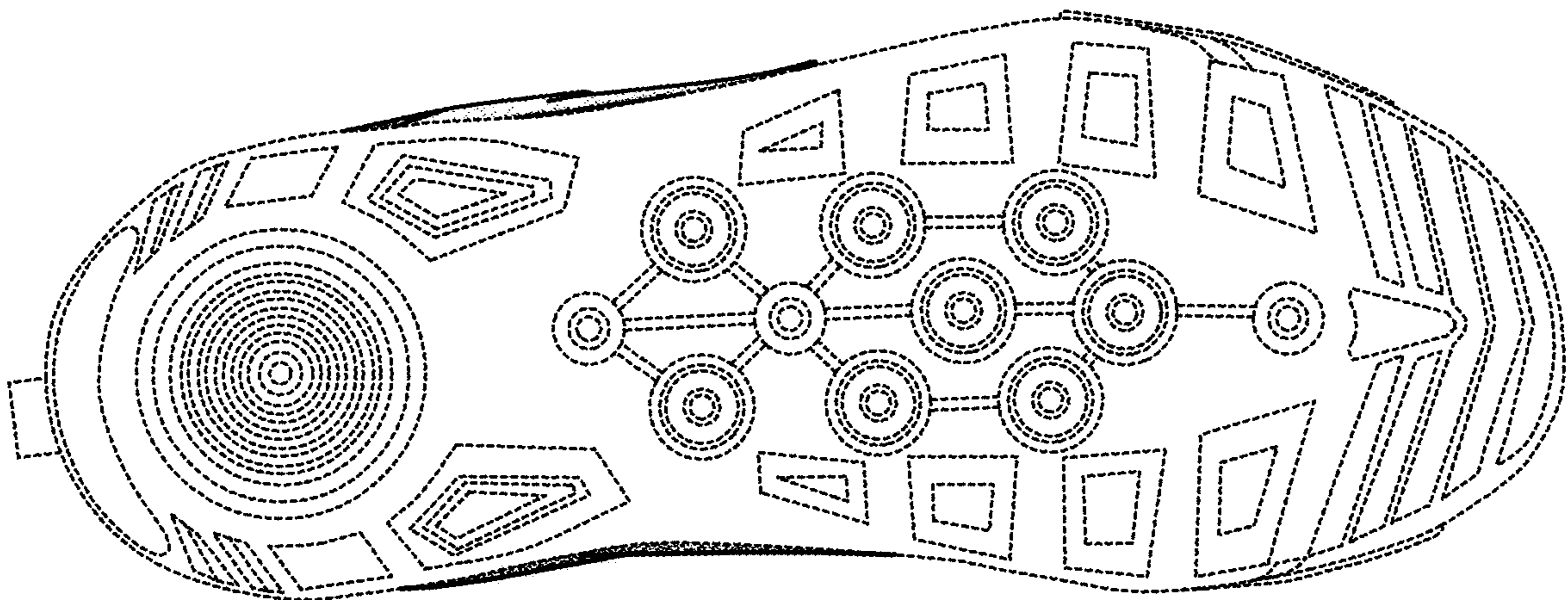
