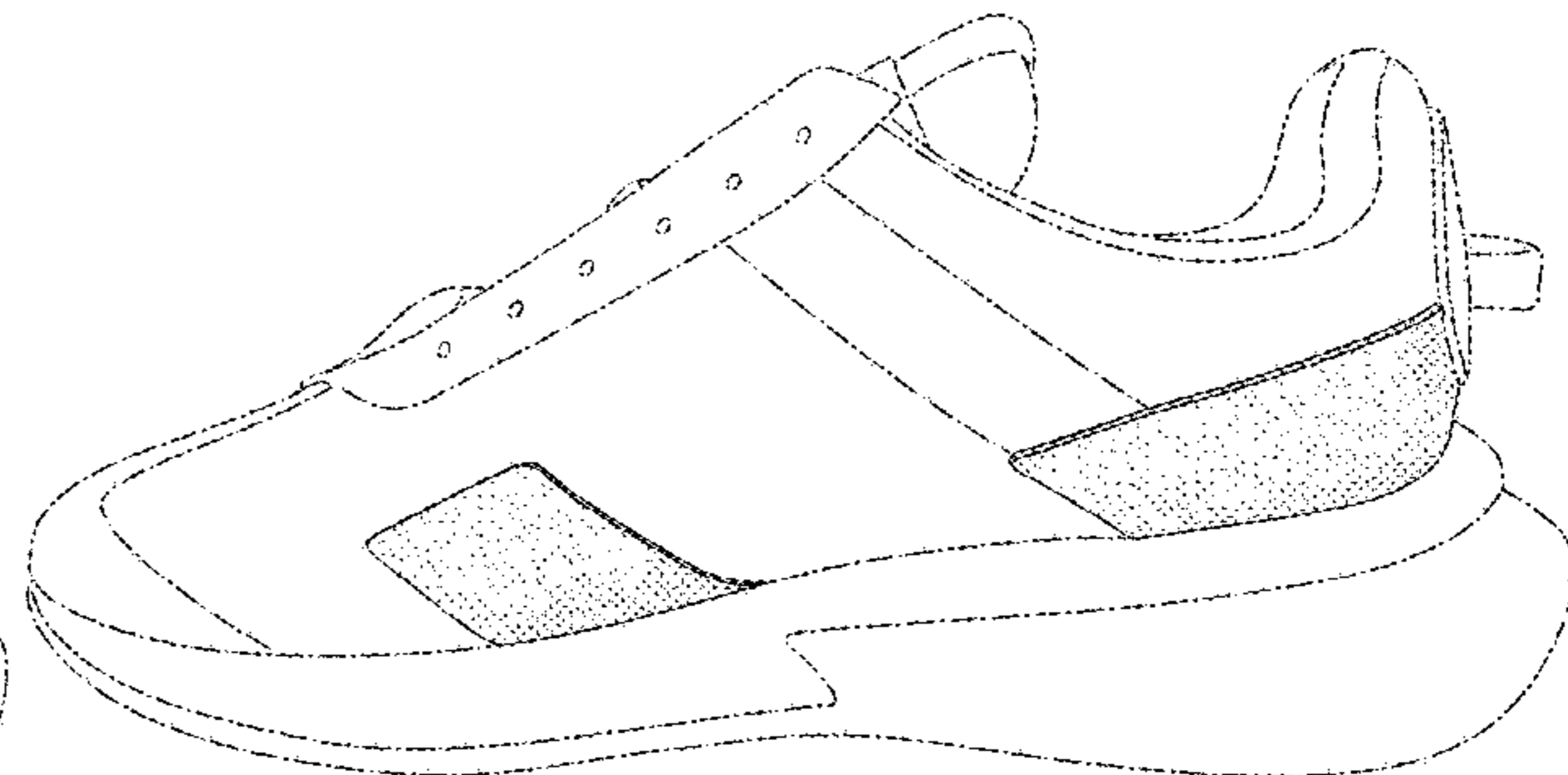
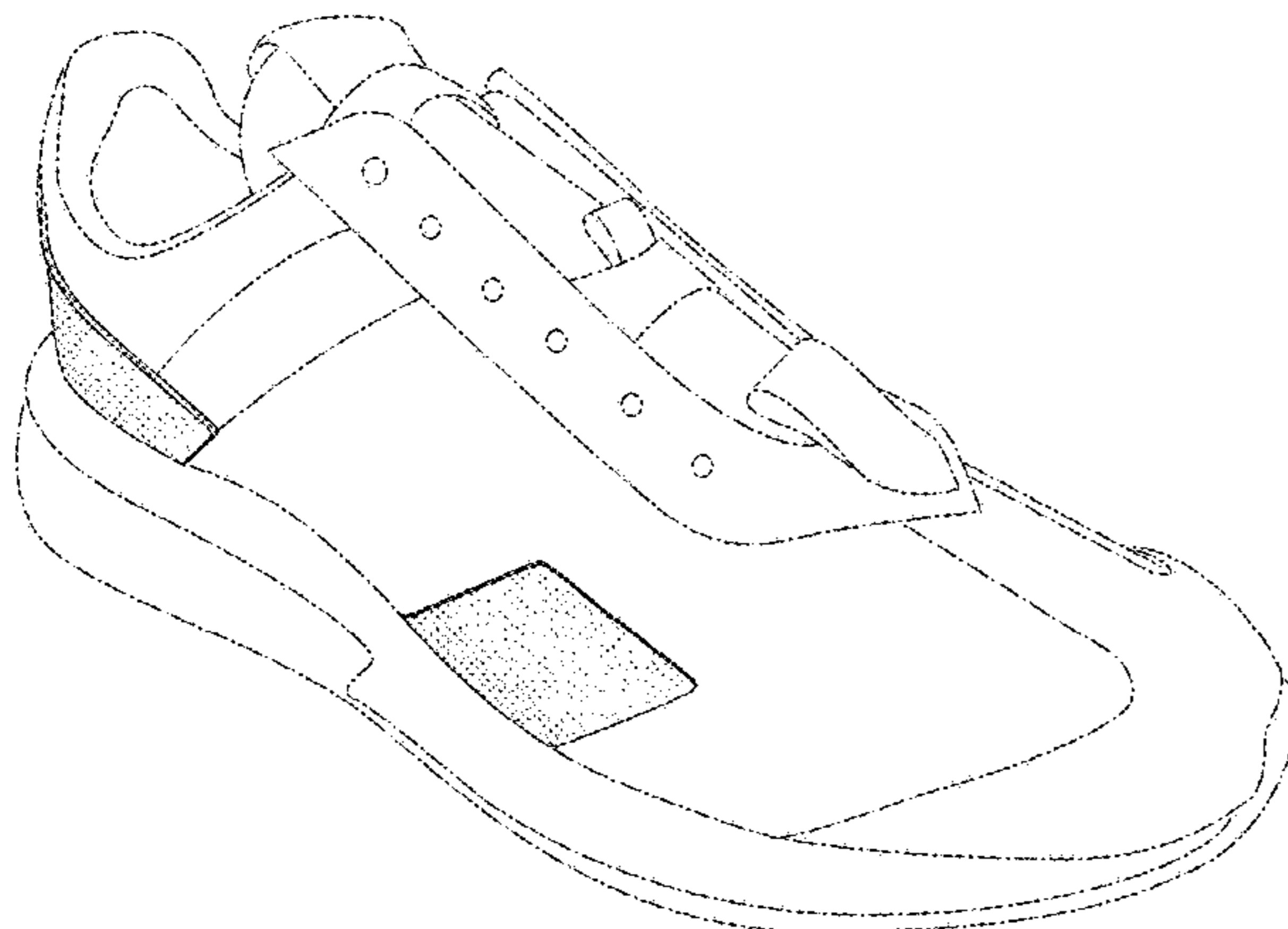
(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a shoe showing my new design;  
FIG. 2 is a side view thereof;  
FIG. 3 is a rear view thereof  
FIG. 4 is an opposite side view thereof; and,  
FIG. 5 is an opposite side front perspective view thereof.  
The broken line immediately adjacent to the semi-circular edge of the shaded area in the rear of the shoe defines the bounds of the claimed design and forms no part thereof. The broken lines depicting the remainder of the shoe form no part of the claimed design.

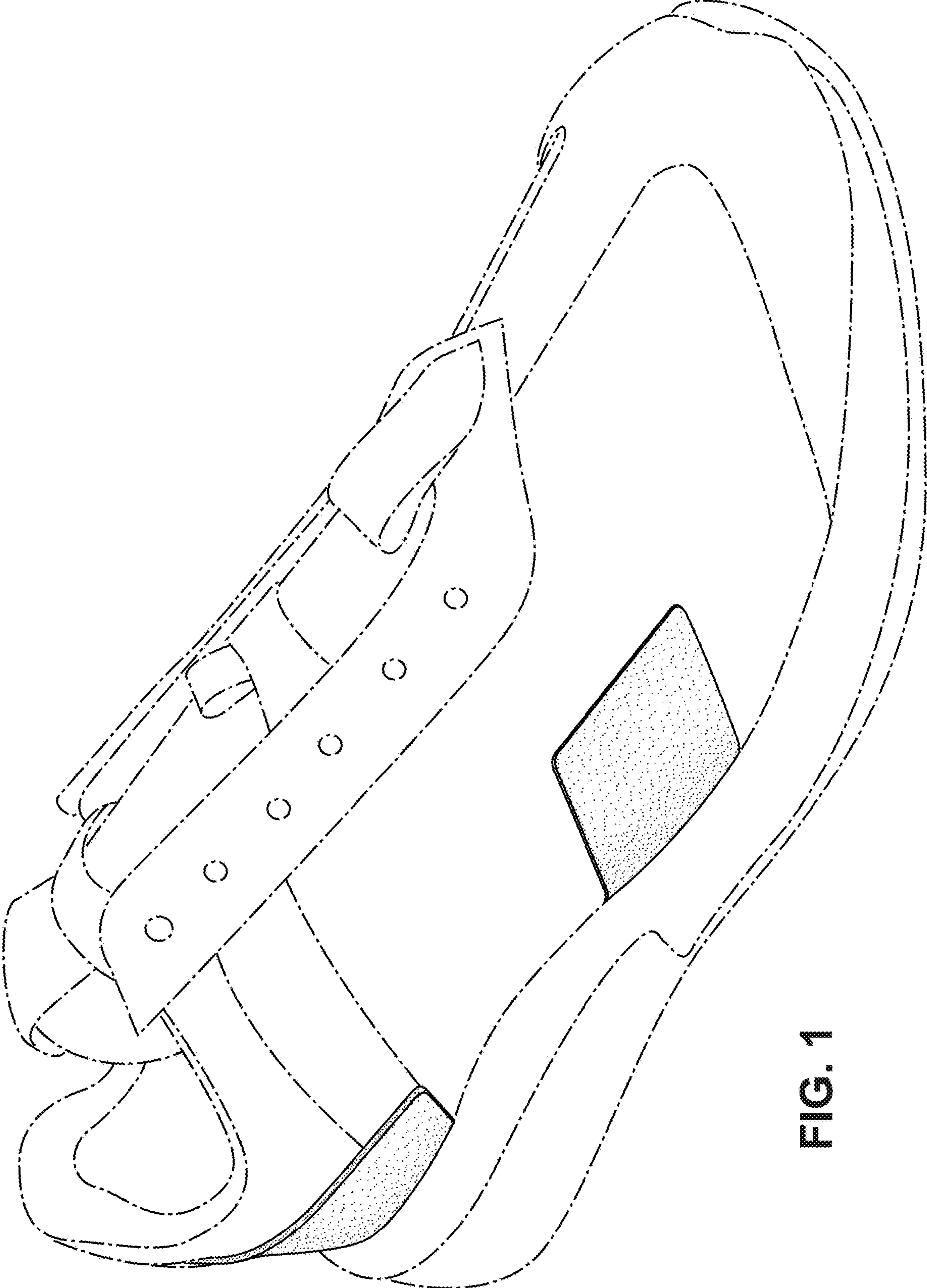

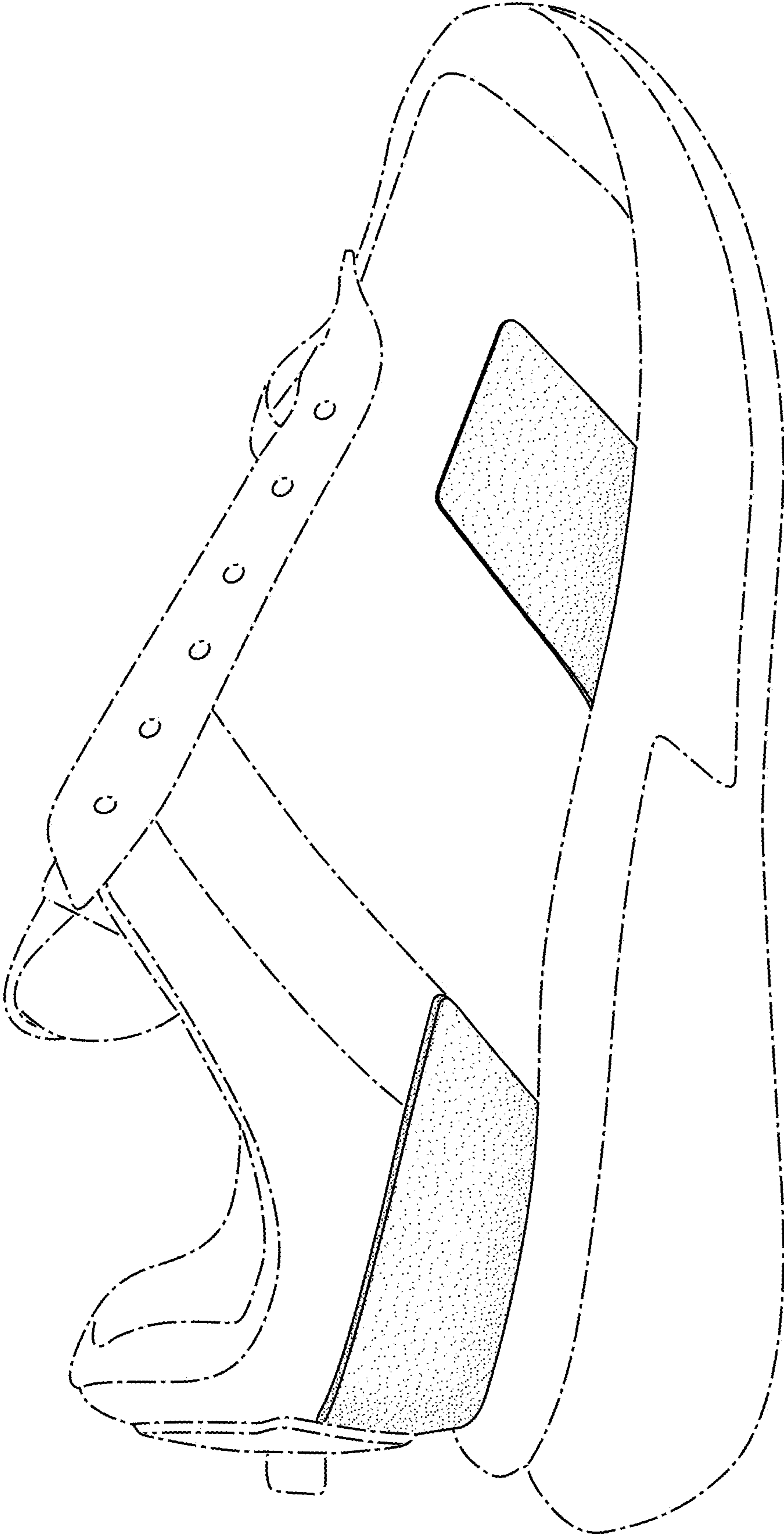

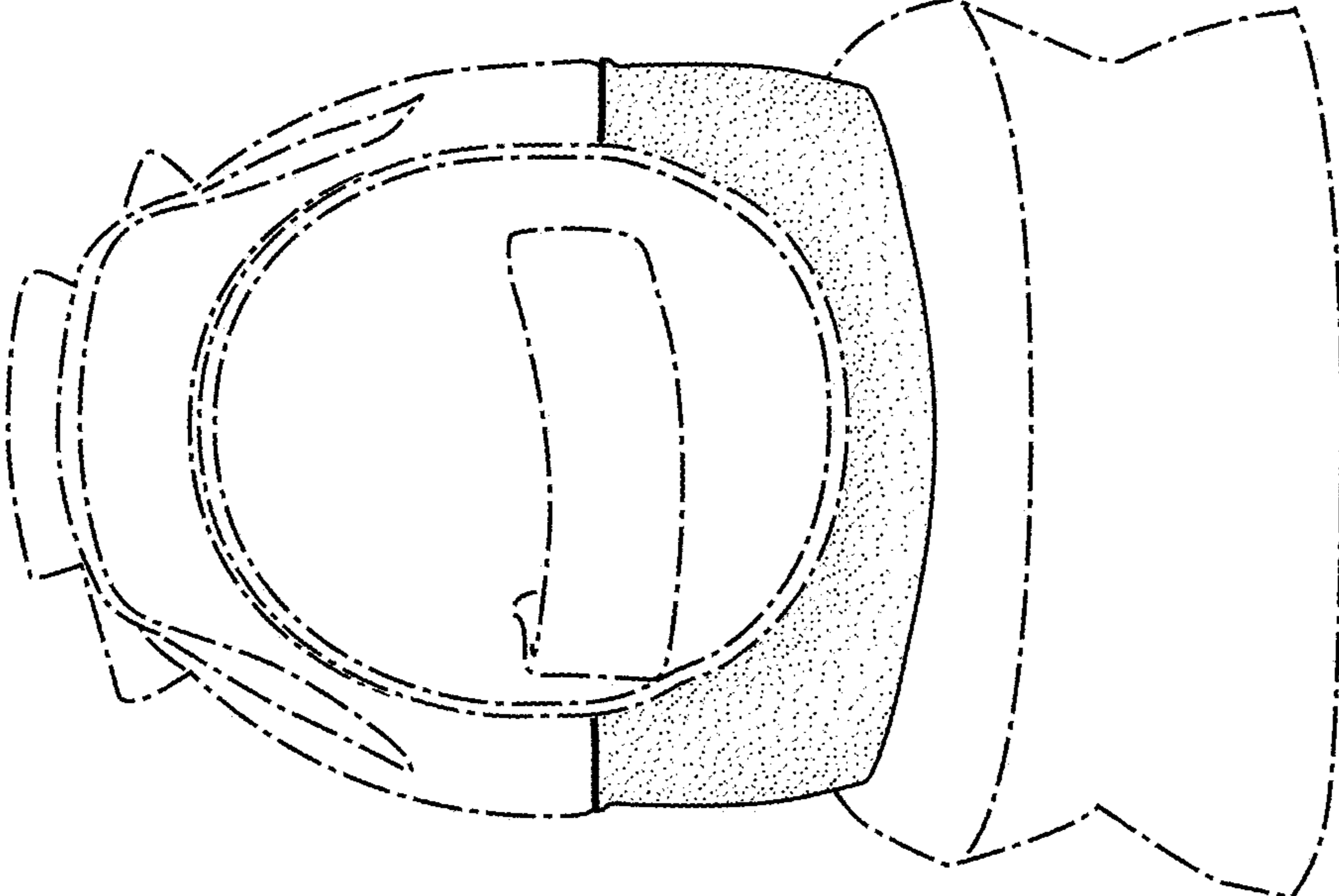

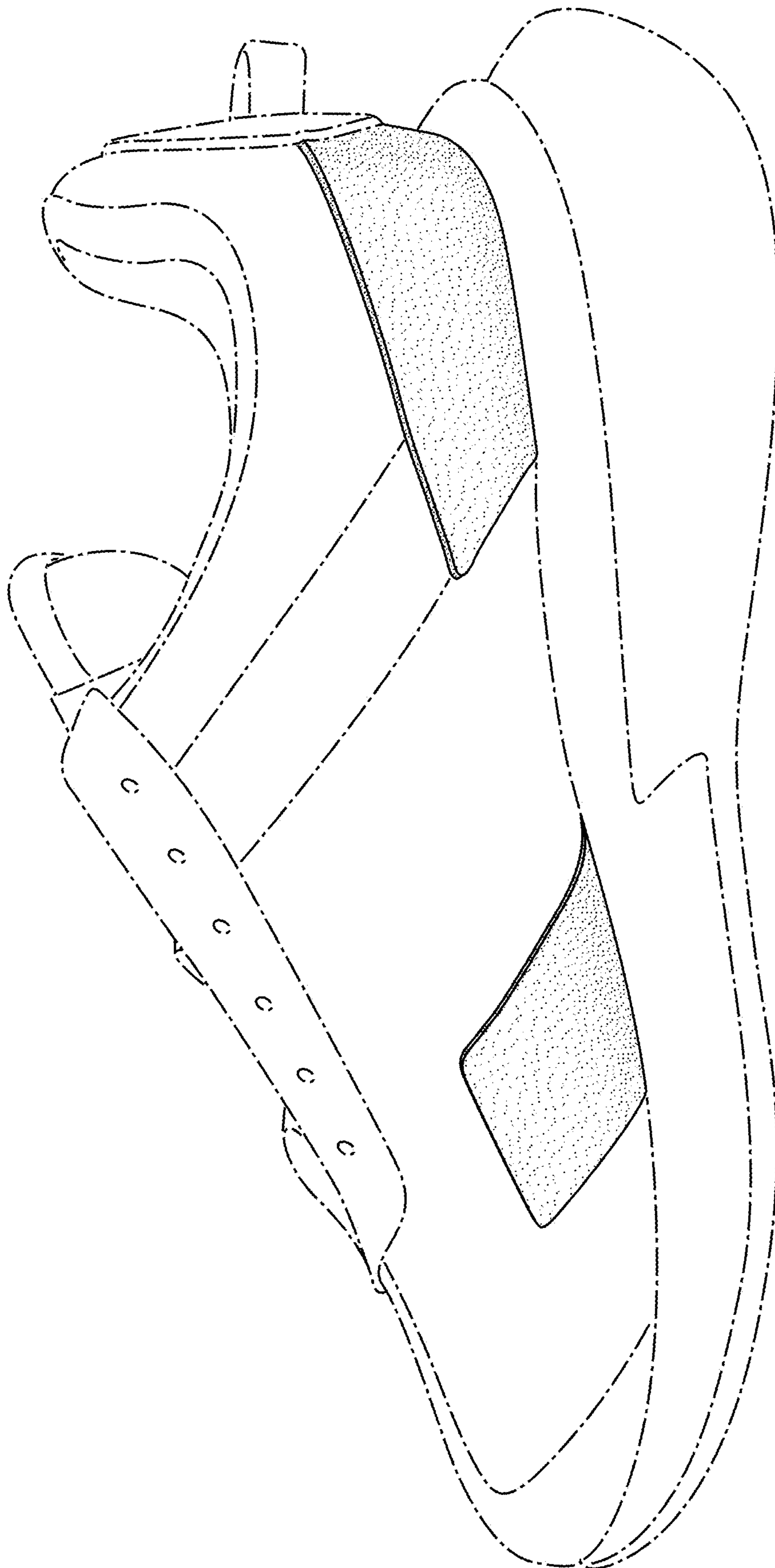

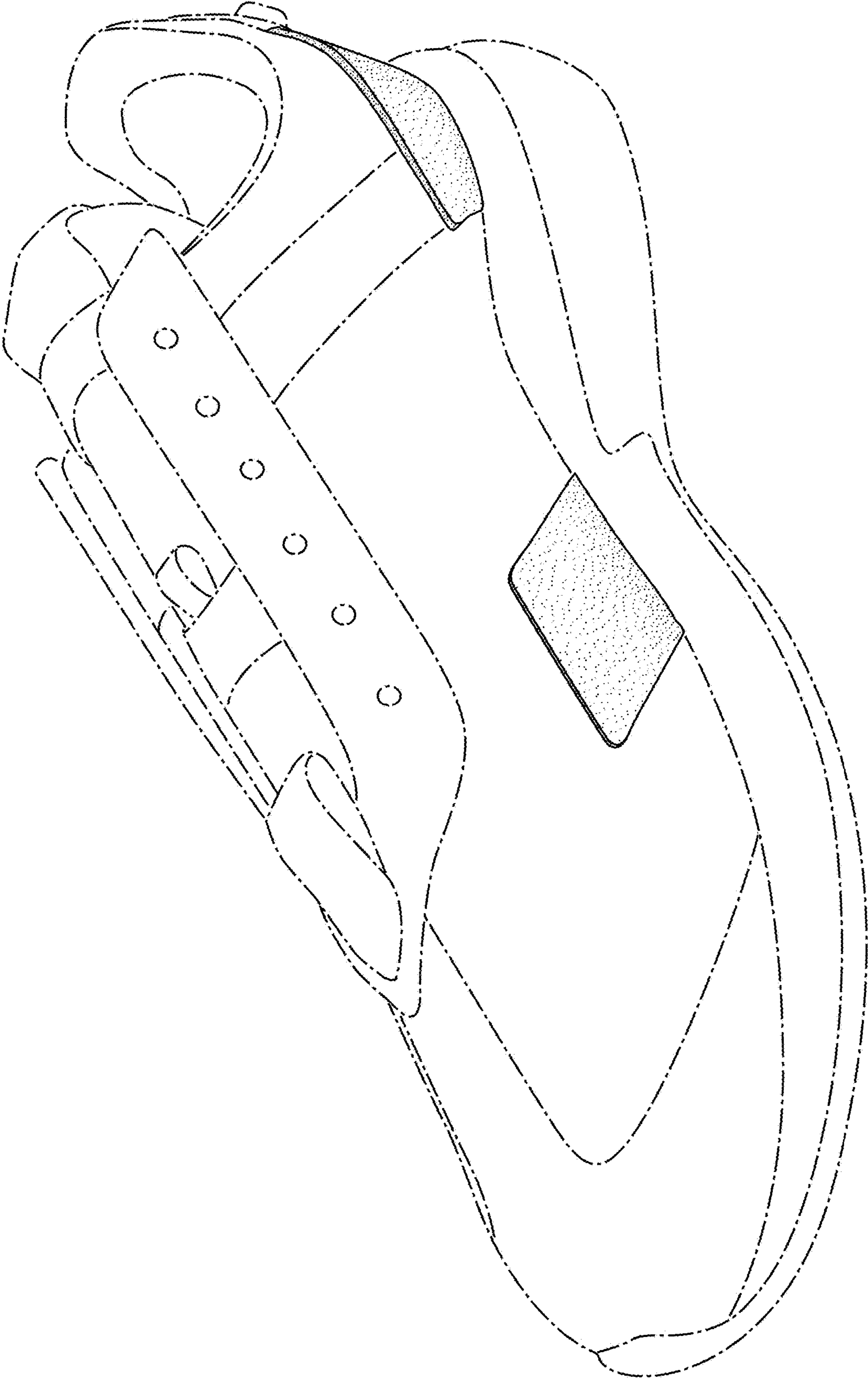
