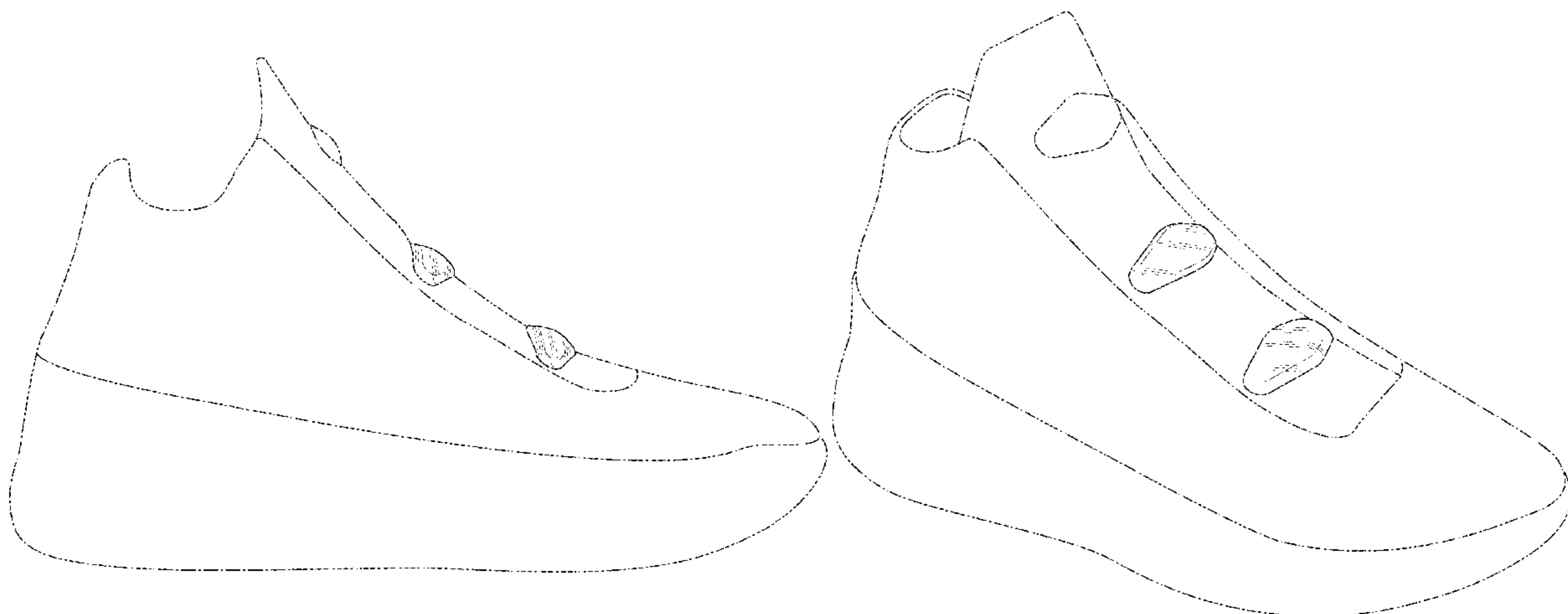
(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

**DESCRIPTION**

FIG. 1 is a side view of a shoe showing my new design;  
FIG. 2 is a front perspective view thereof;  
FIG. 3 is a front view thereof;  
FIG. 4 is an opposite side front perspective view thereof;  
FIG. 5 is an opposite side view thereof; and,  
FIG. 6 is a top view thereof.  
The oblique line shading represents that the surface has a transparent, translucent, highly polished or reflective appearance. The broken lines depicting the remainder of the shoe form no part of the claimed design.

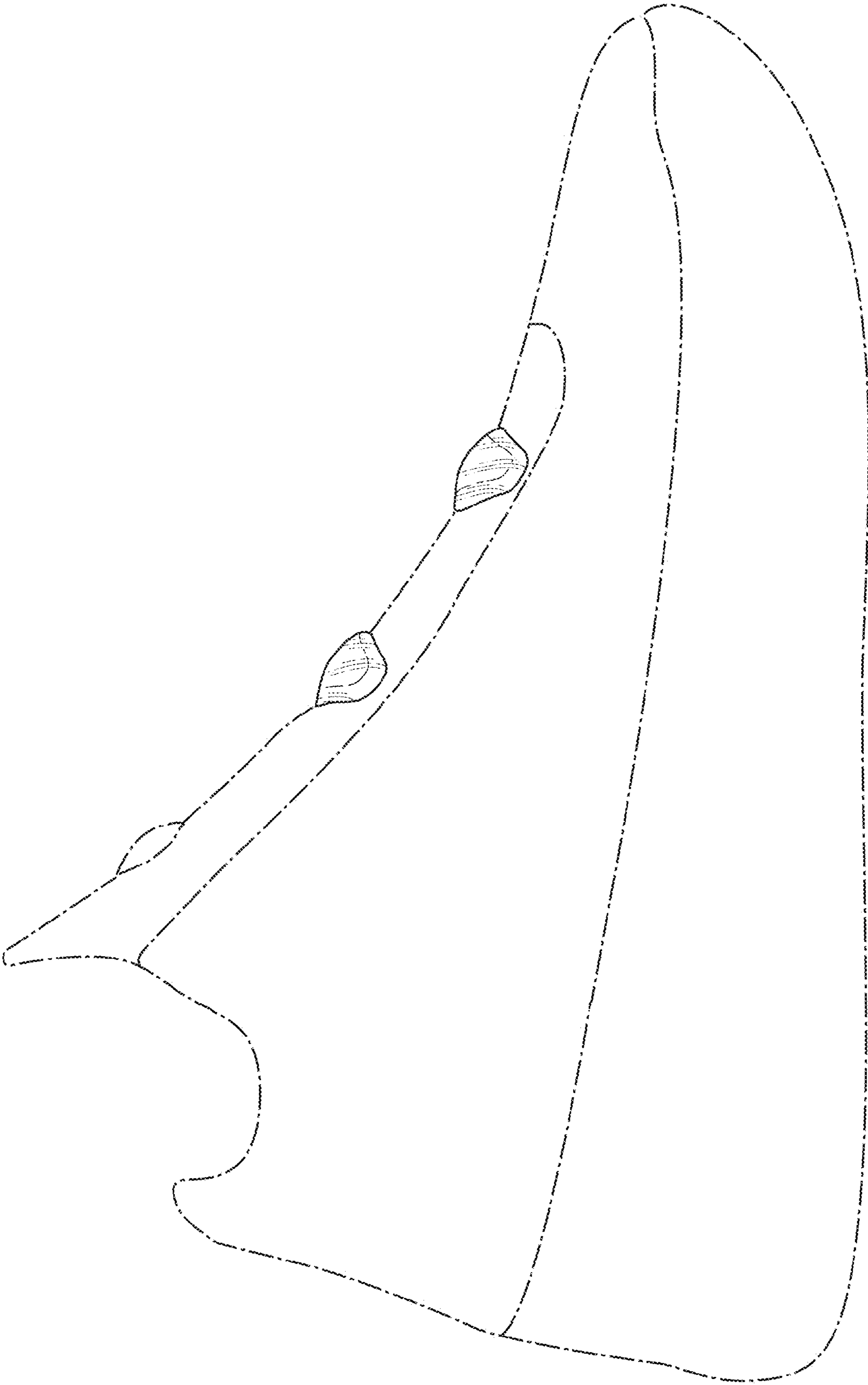

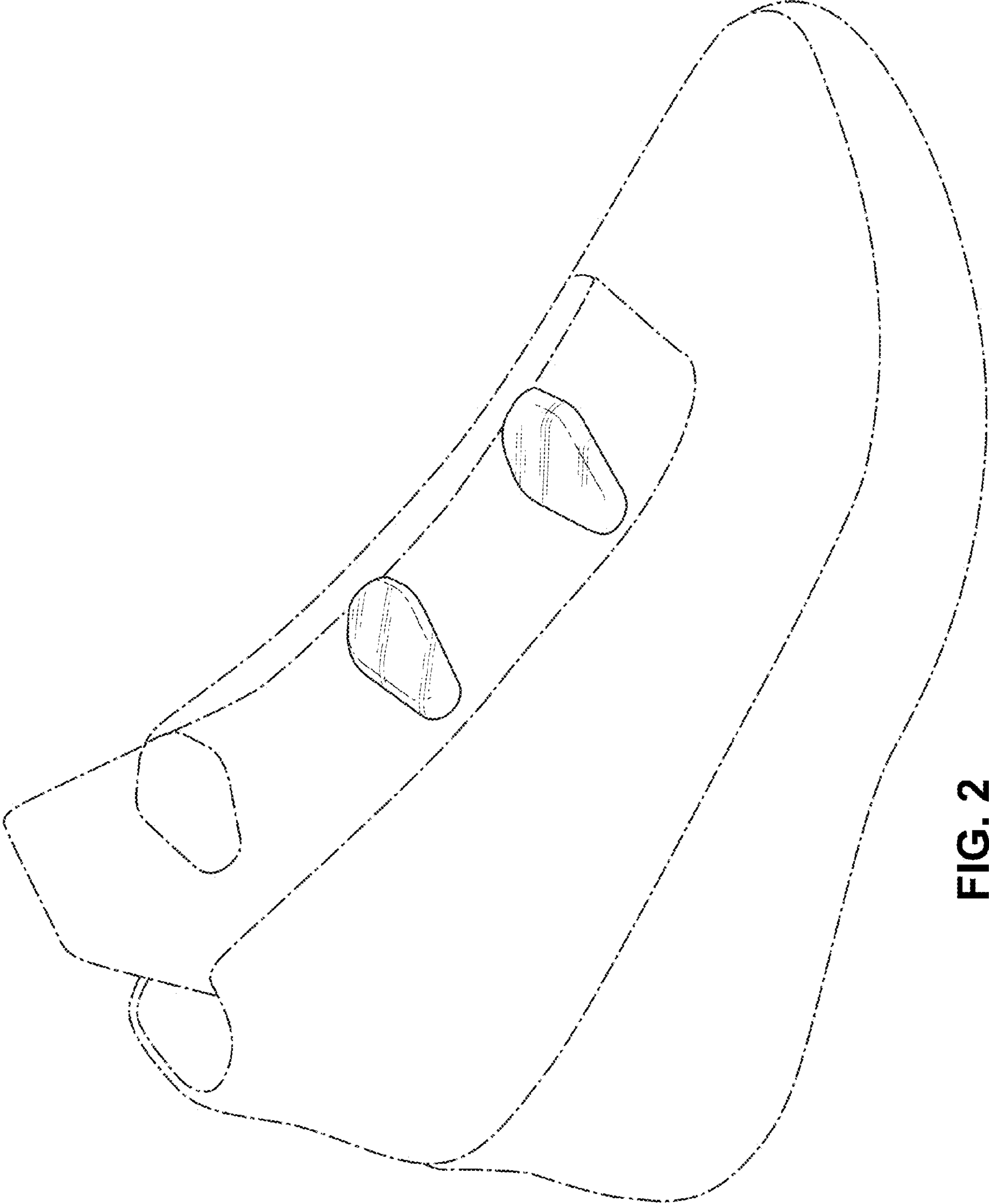

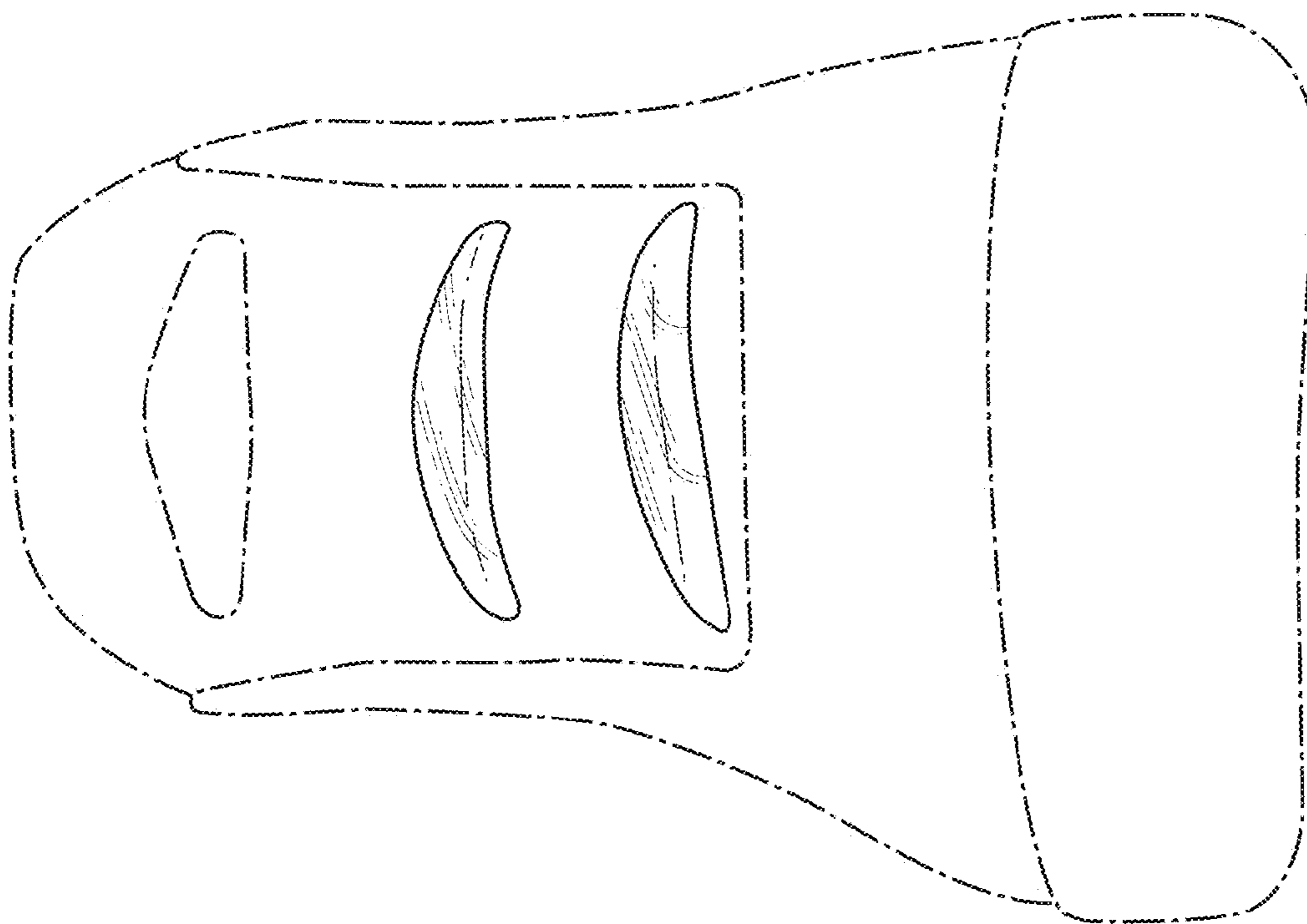
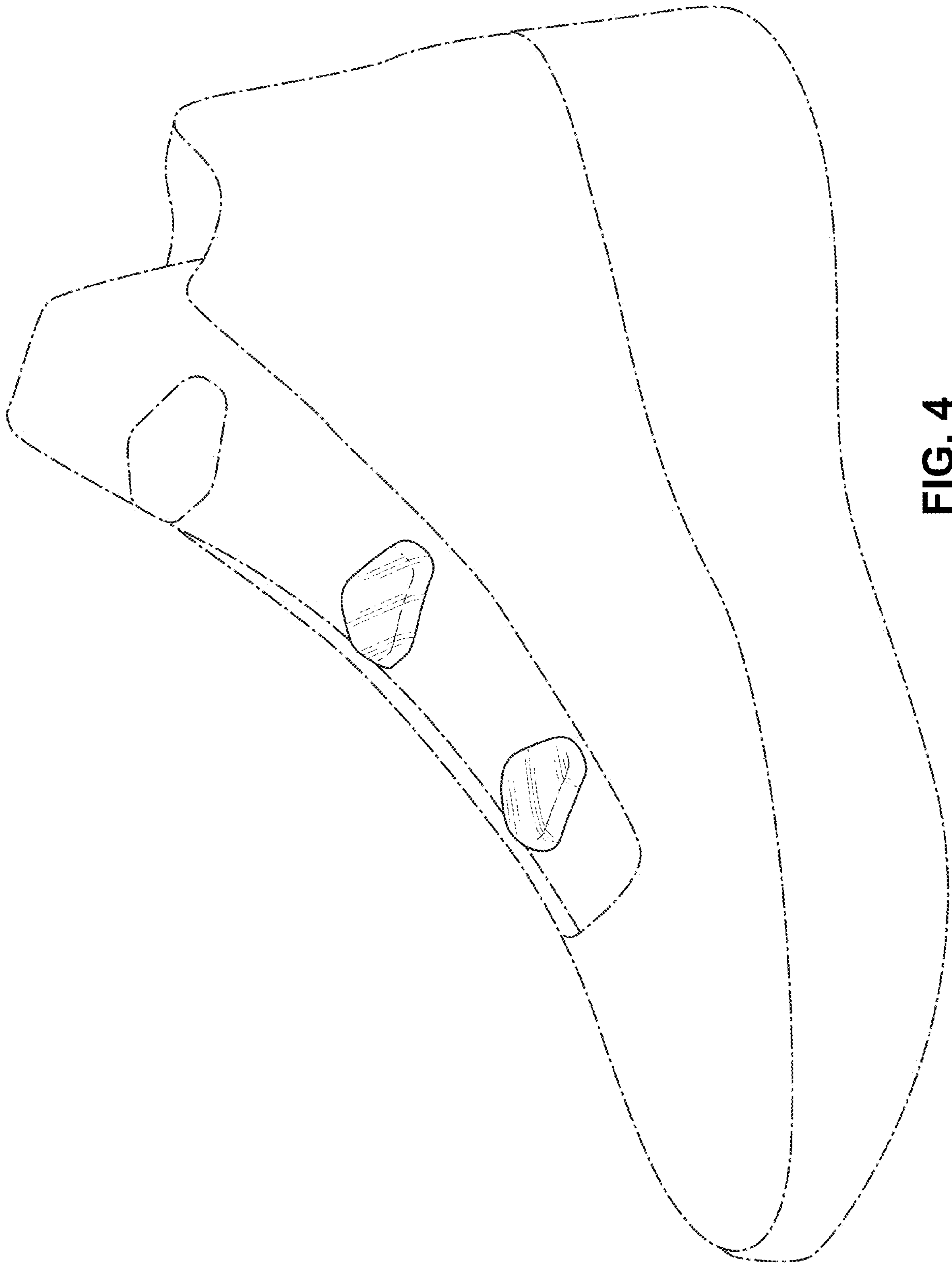

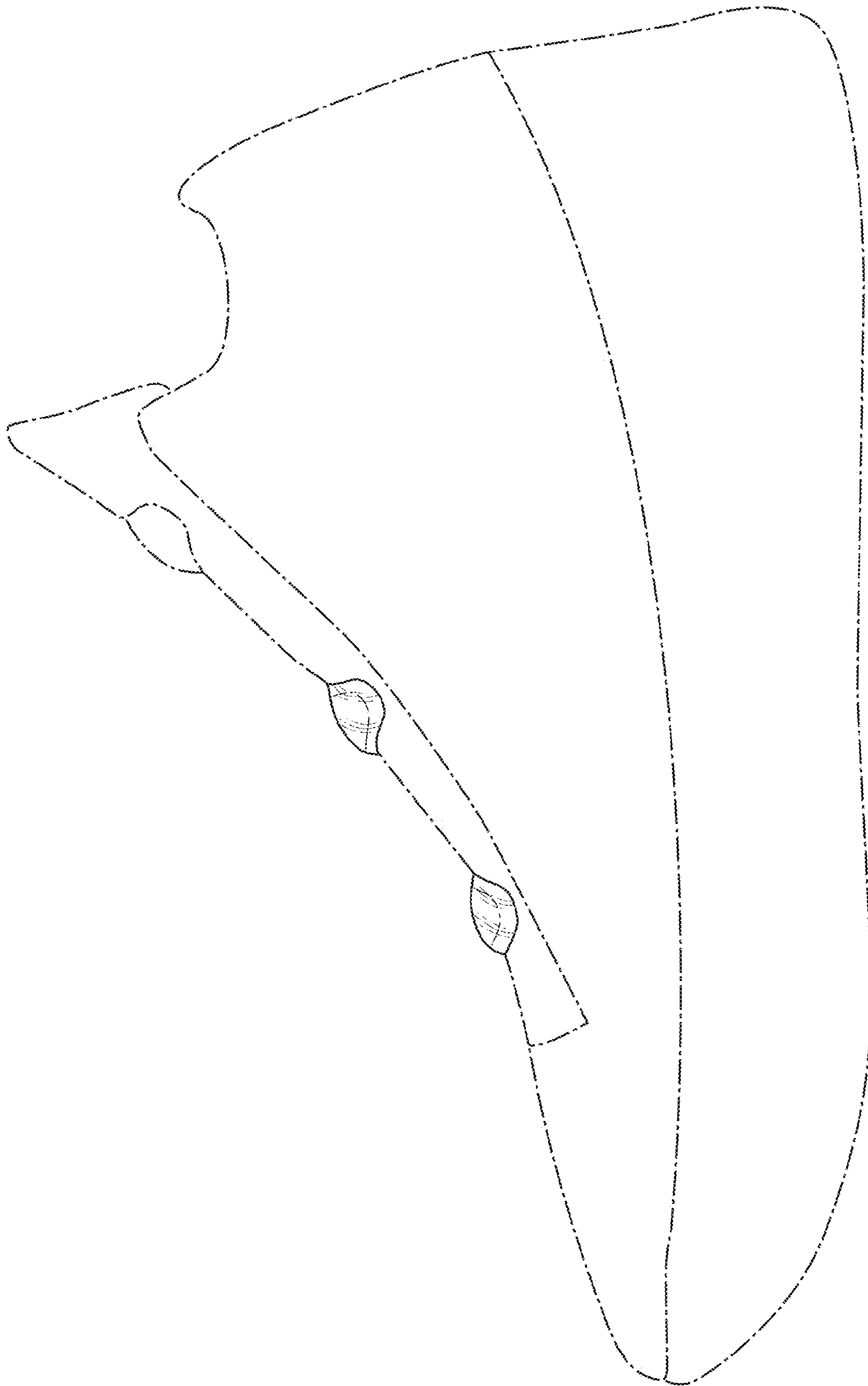

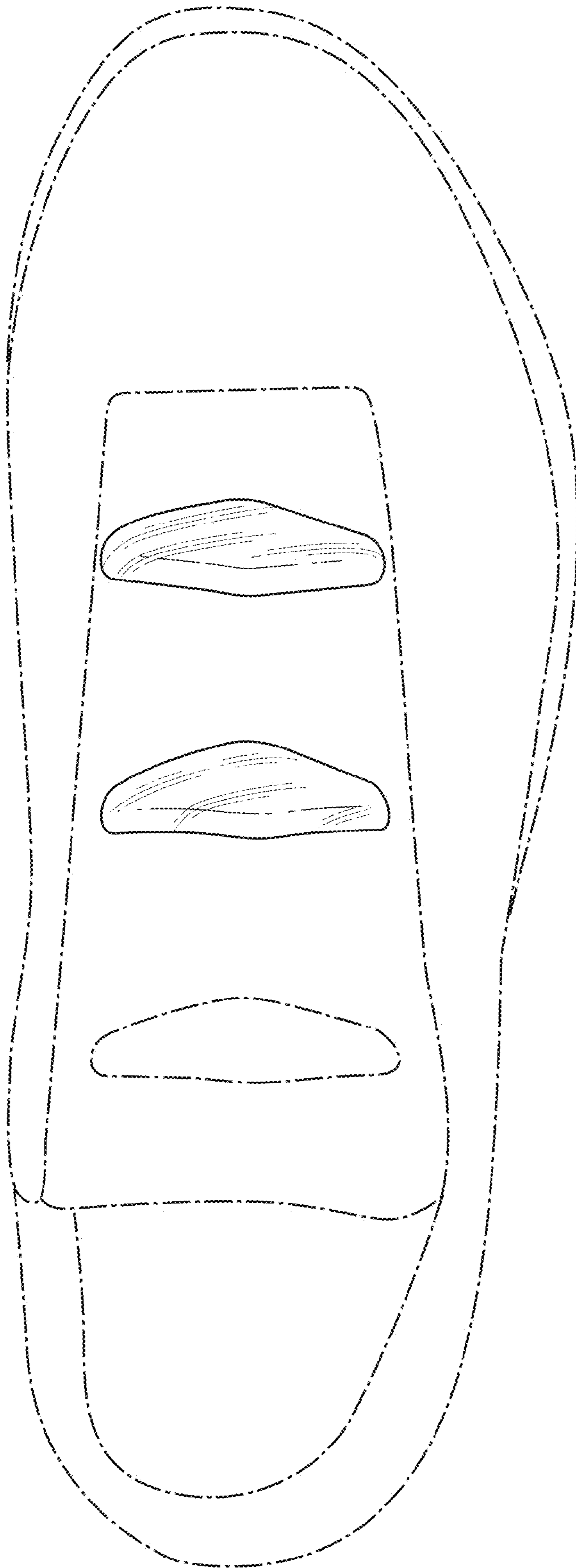
