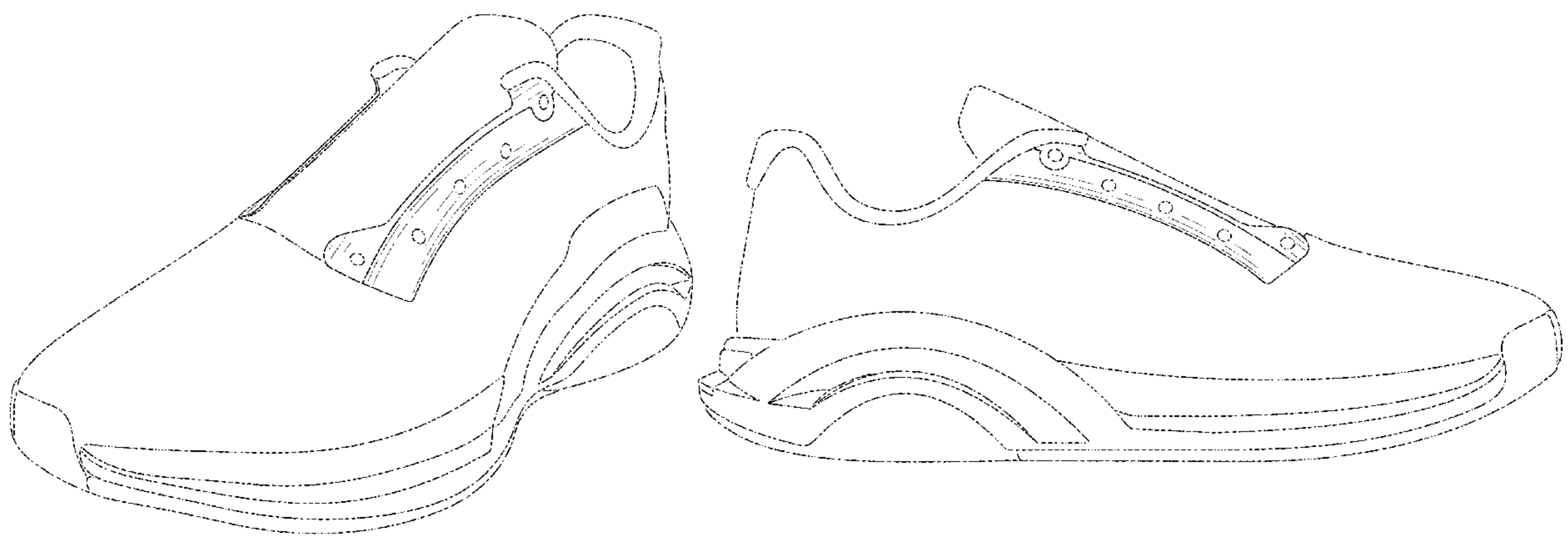
(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a shoe showing my new design;  
FIG. 2 is a side view thereof;  
FIG. 3 is a rear perspective view thereof;  
FIG. 4 is an opposite side front perspective view thereof;  
FIG. 5 is an opposite side view thereof; and,  
FIG. 6 is a top view thereof.  
The ten broken line circles within the shaded areas represent eyelets that form no part of the claimed design. The broken lines immediately adjacent to the shaded areas define the bounds of the claimed design and form no part thereof. The broken lines depicting the remainder of the shoe form no part of the claimed design.

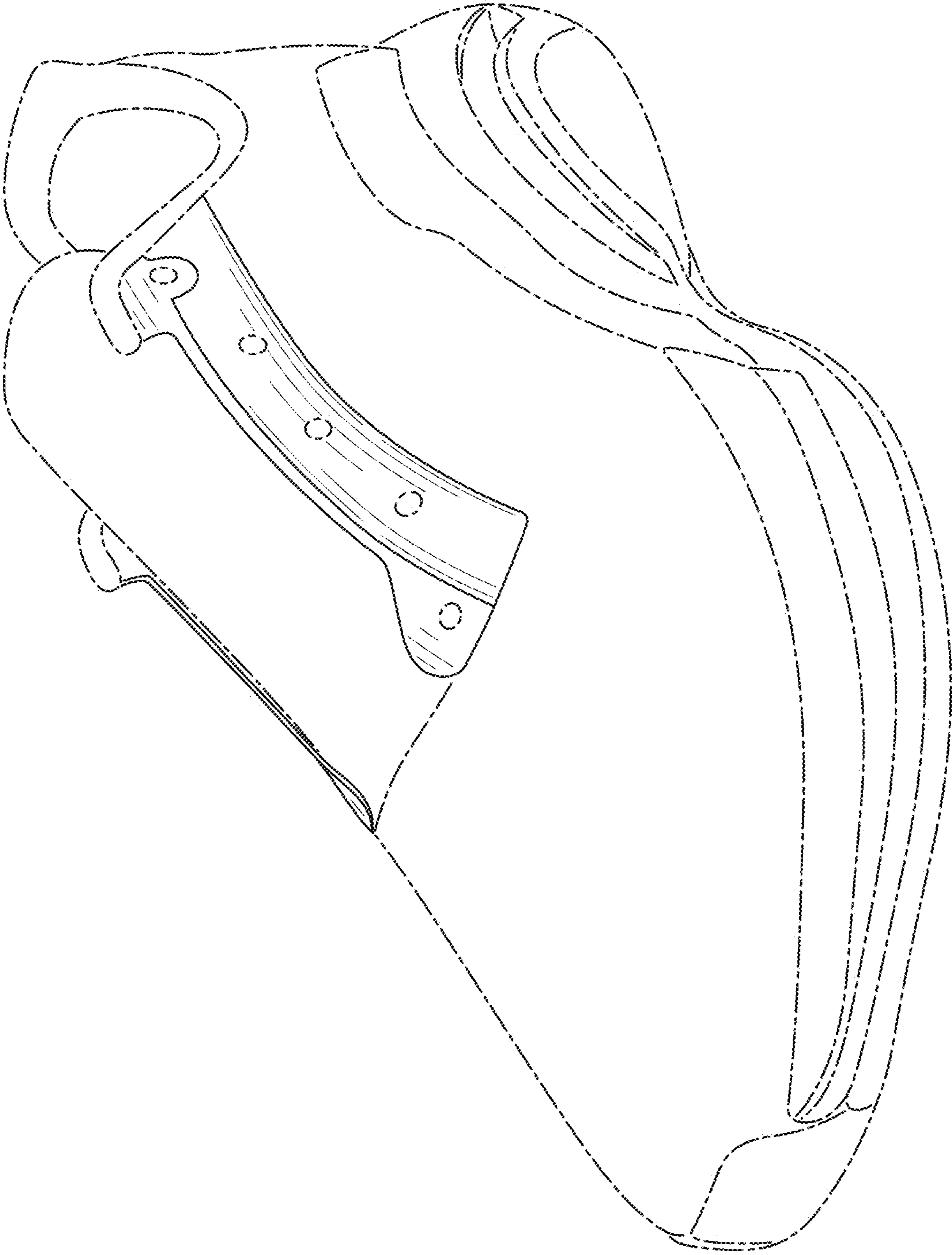

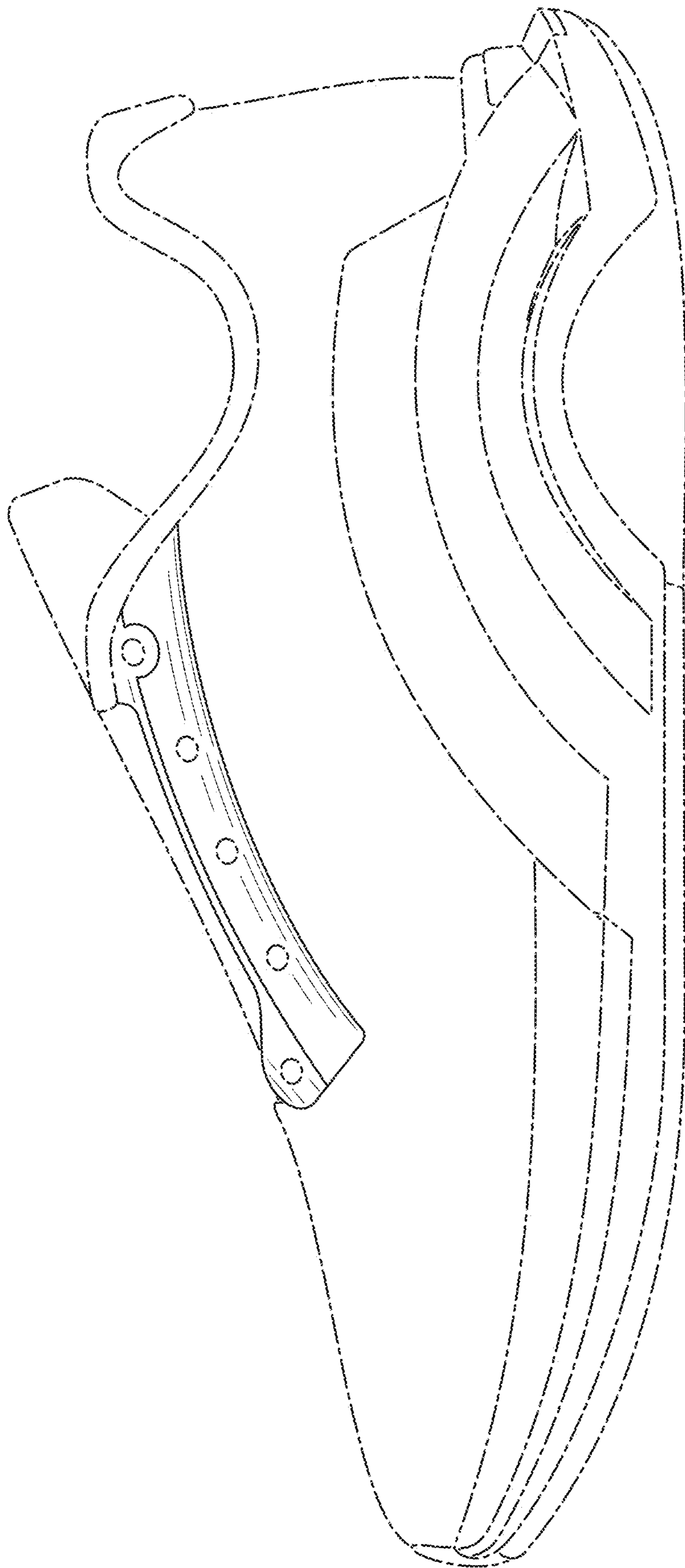

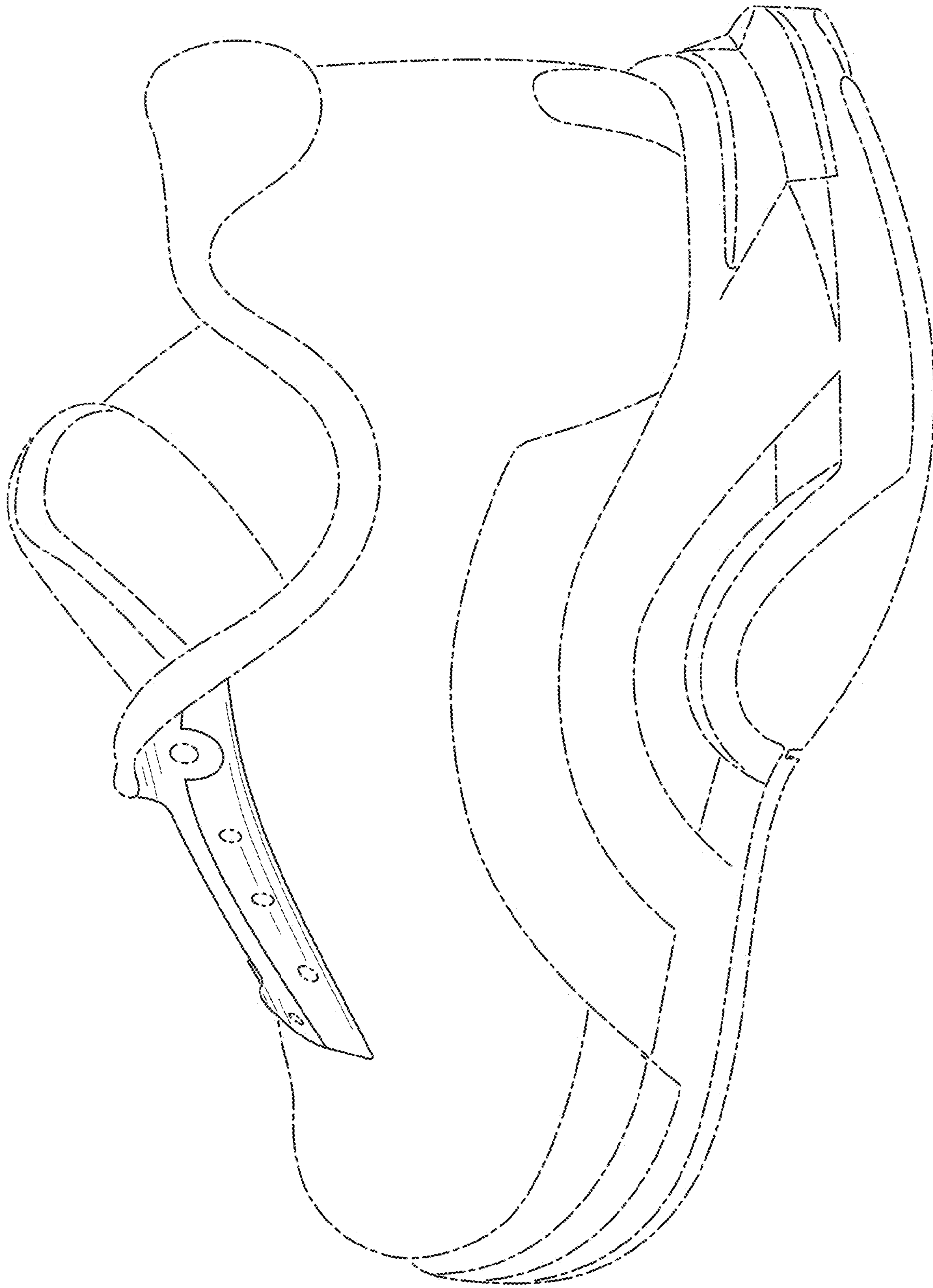

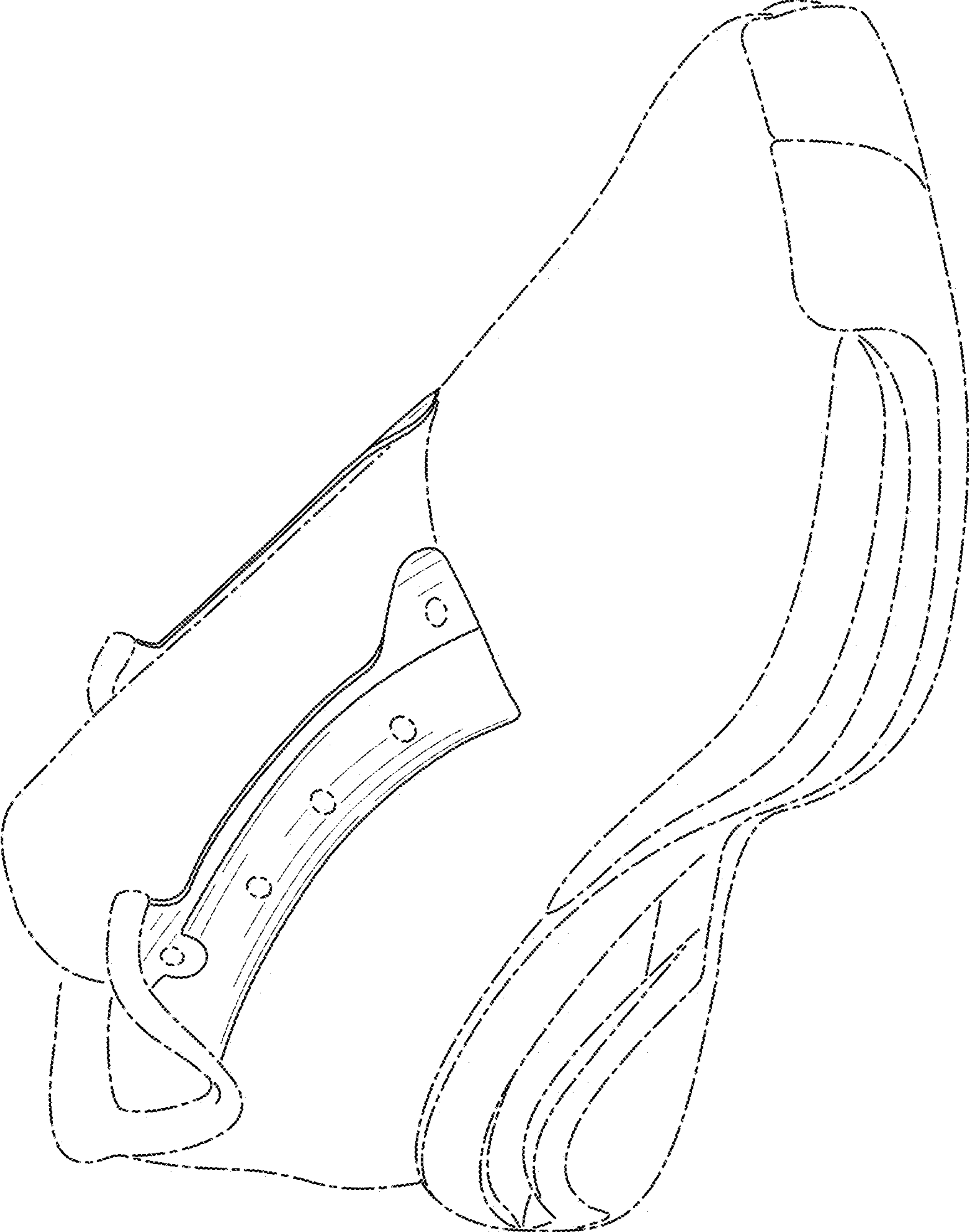

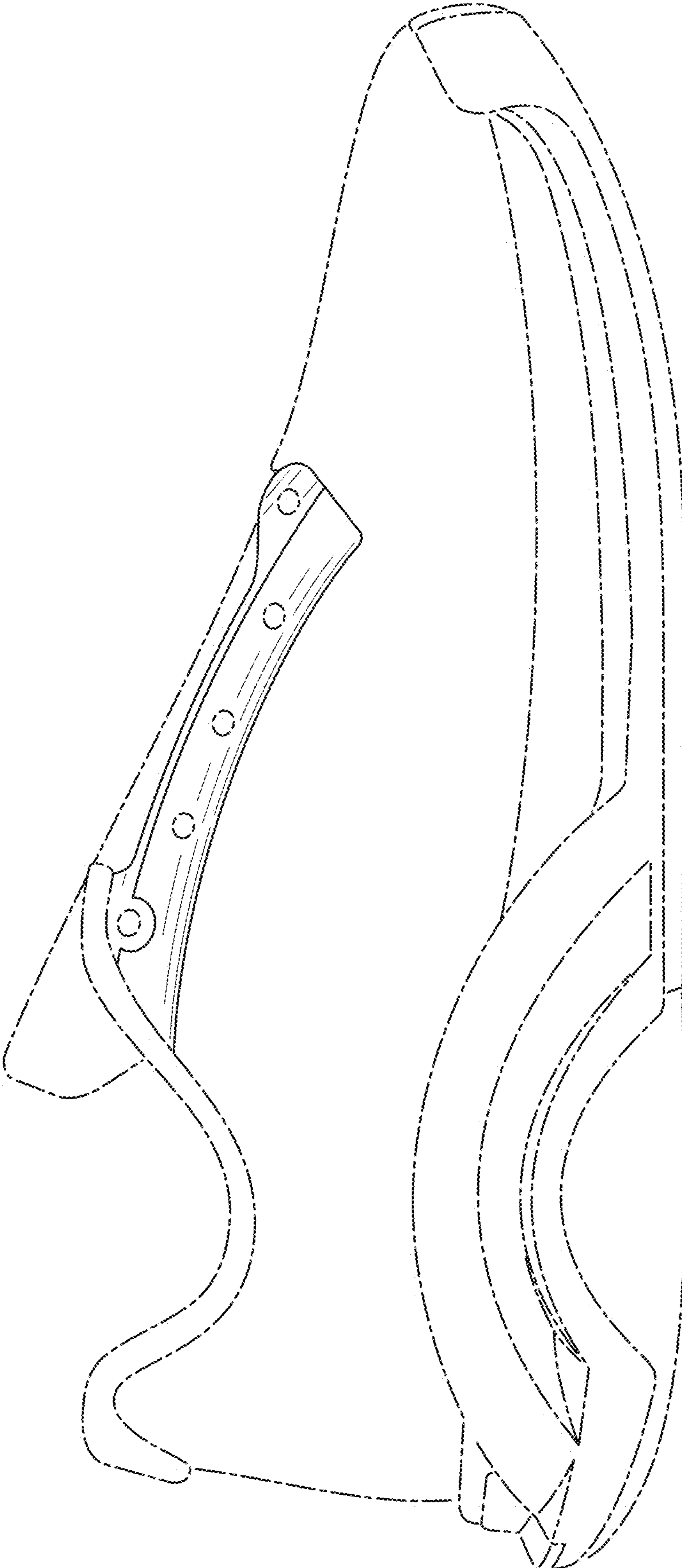

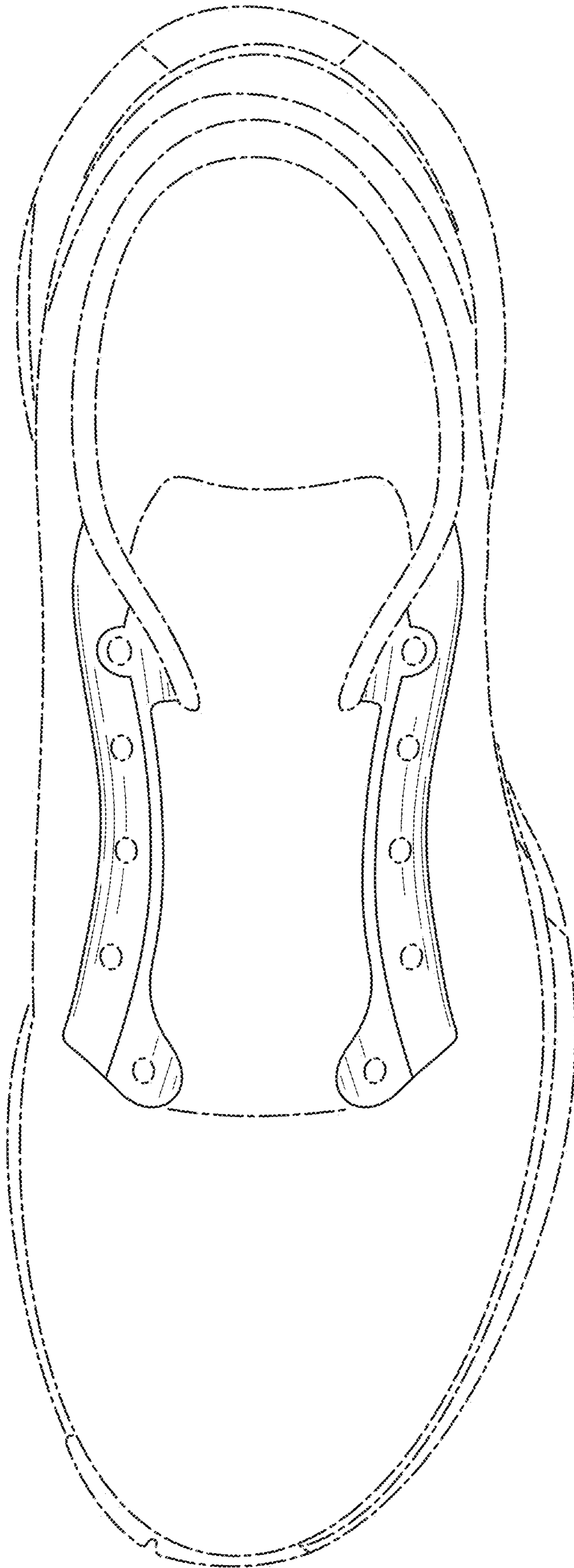
