FIG. 3 is an opposite side view thereof;

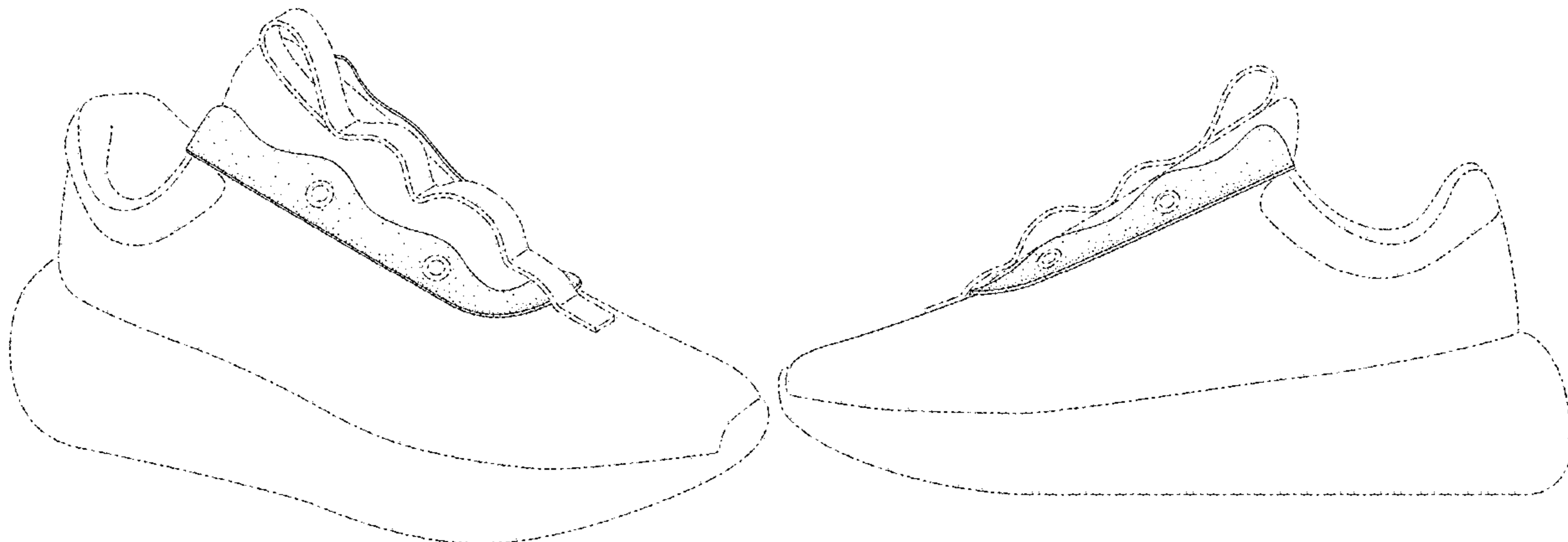
FIG. 4 is an opposite side front perspective view thereof; and,

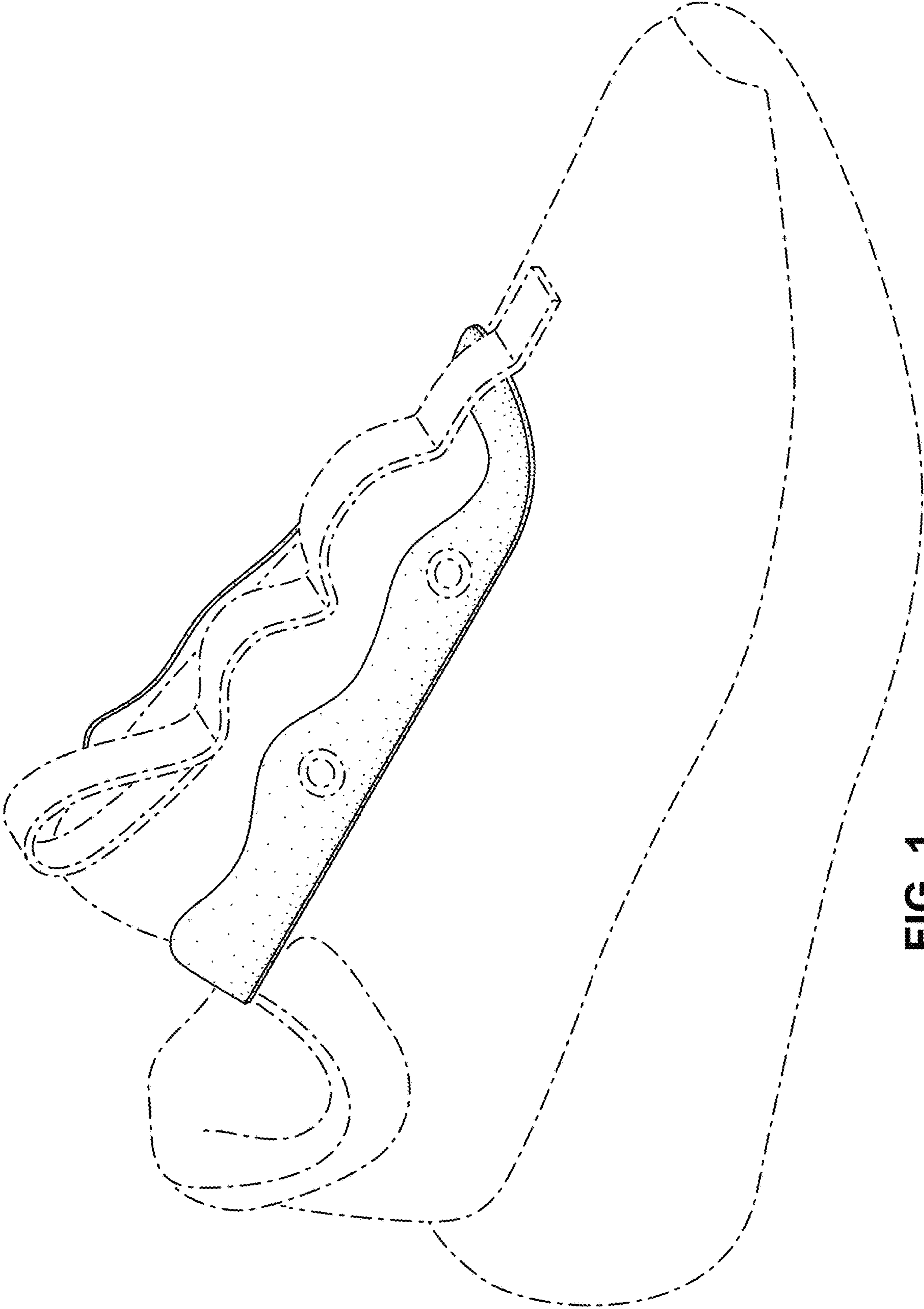

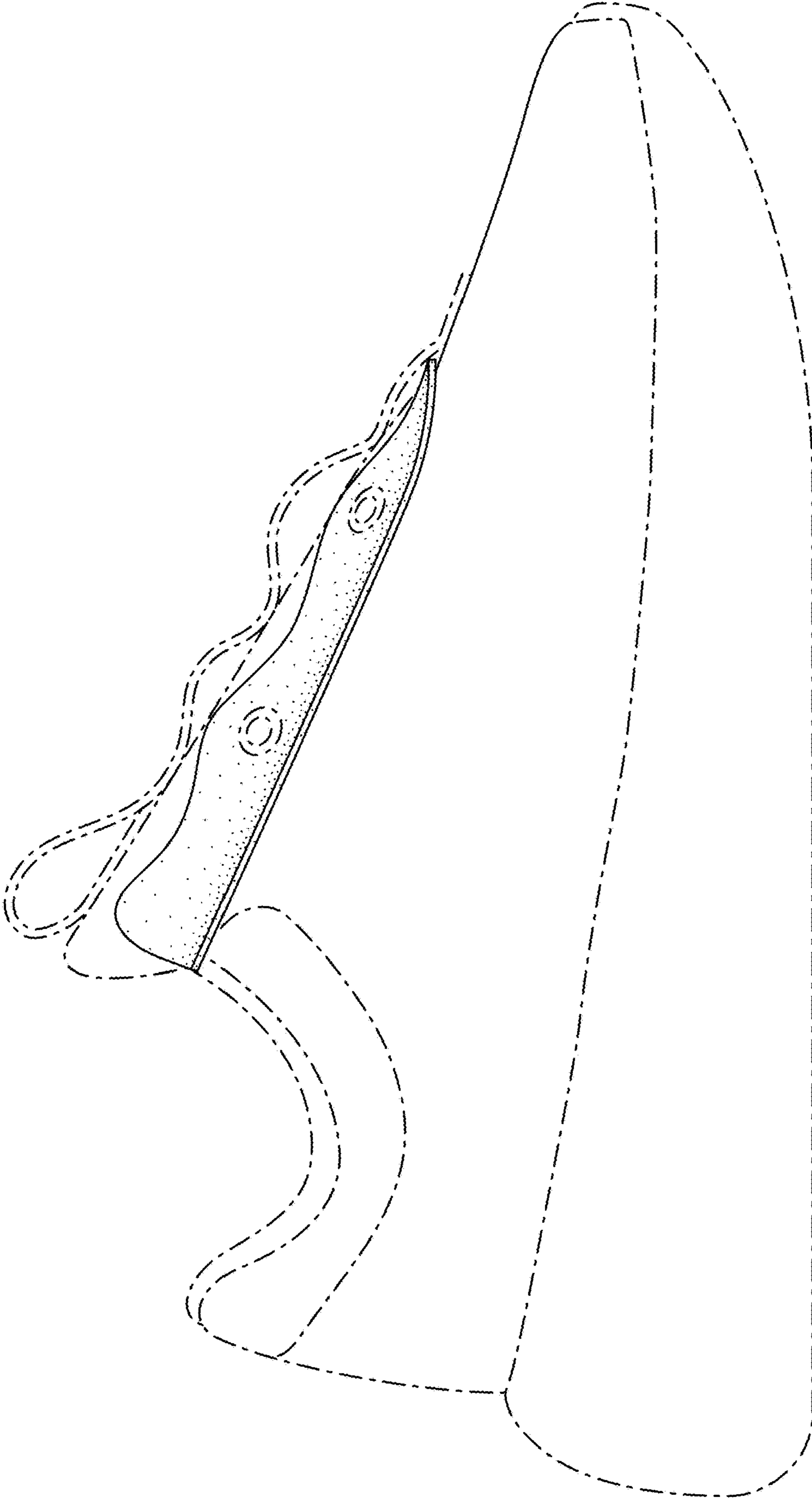

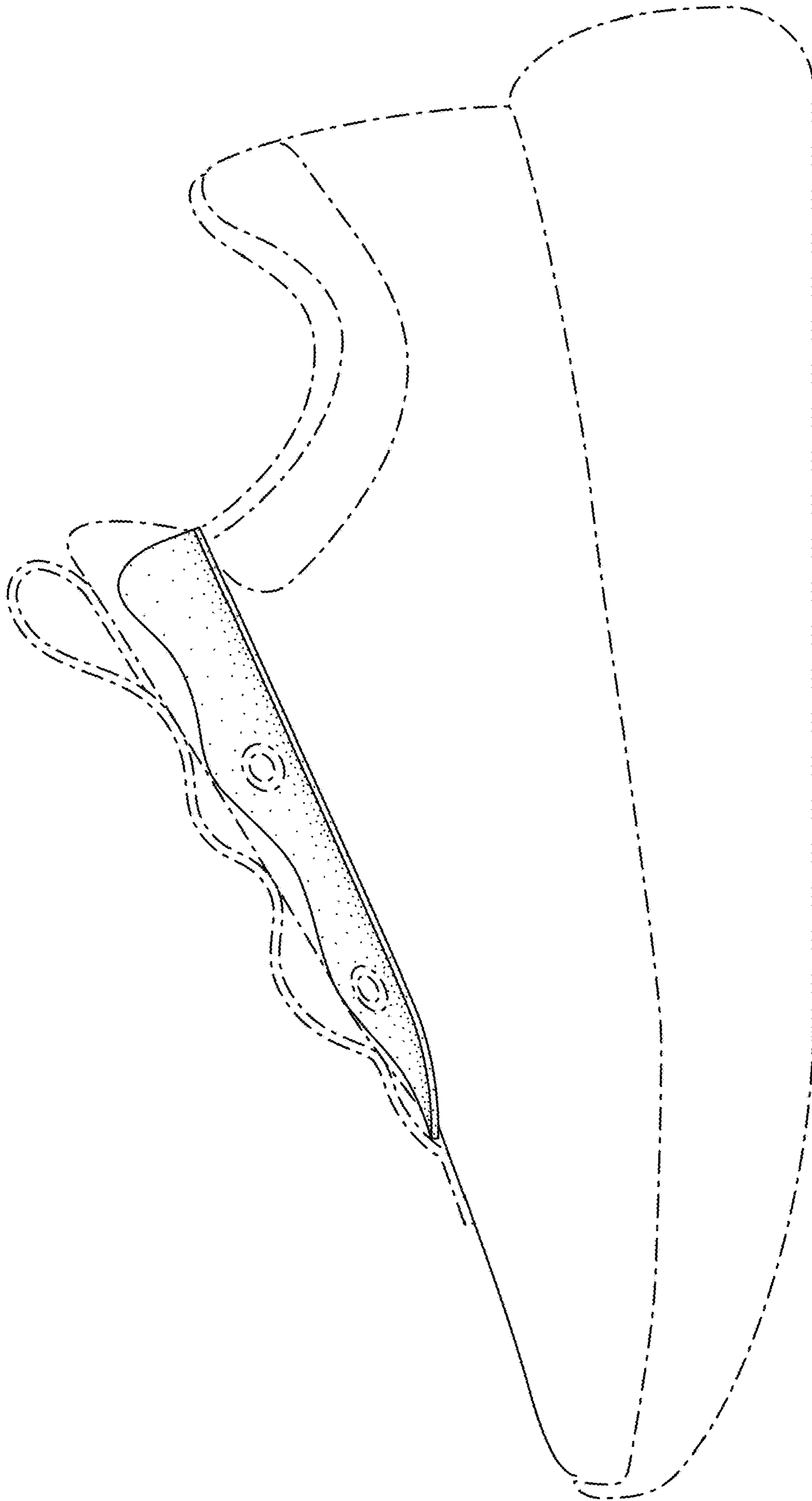

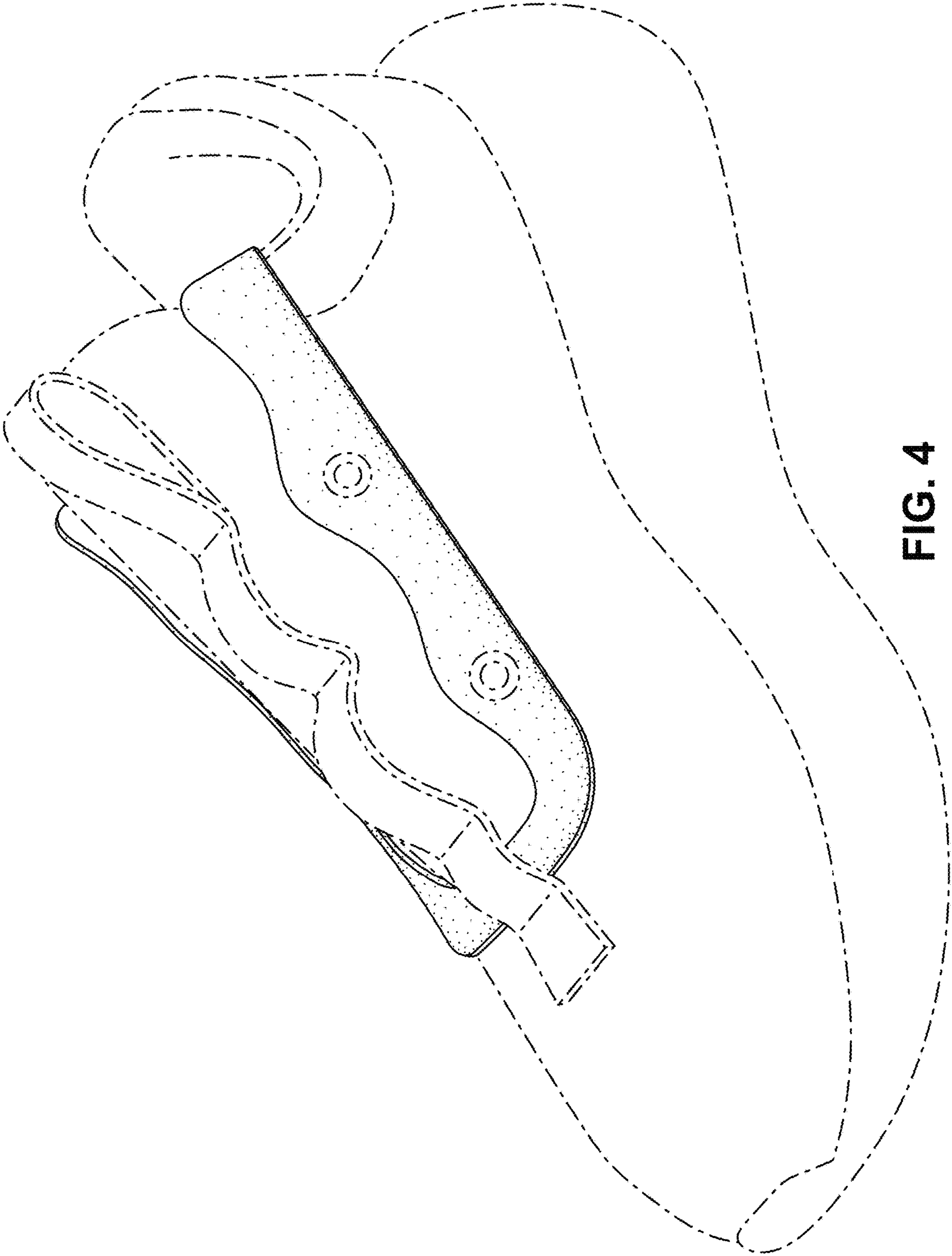

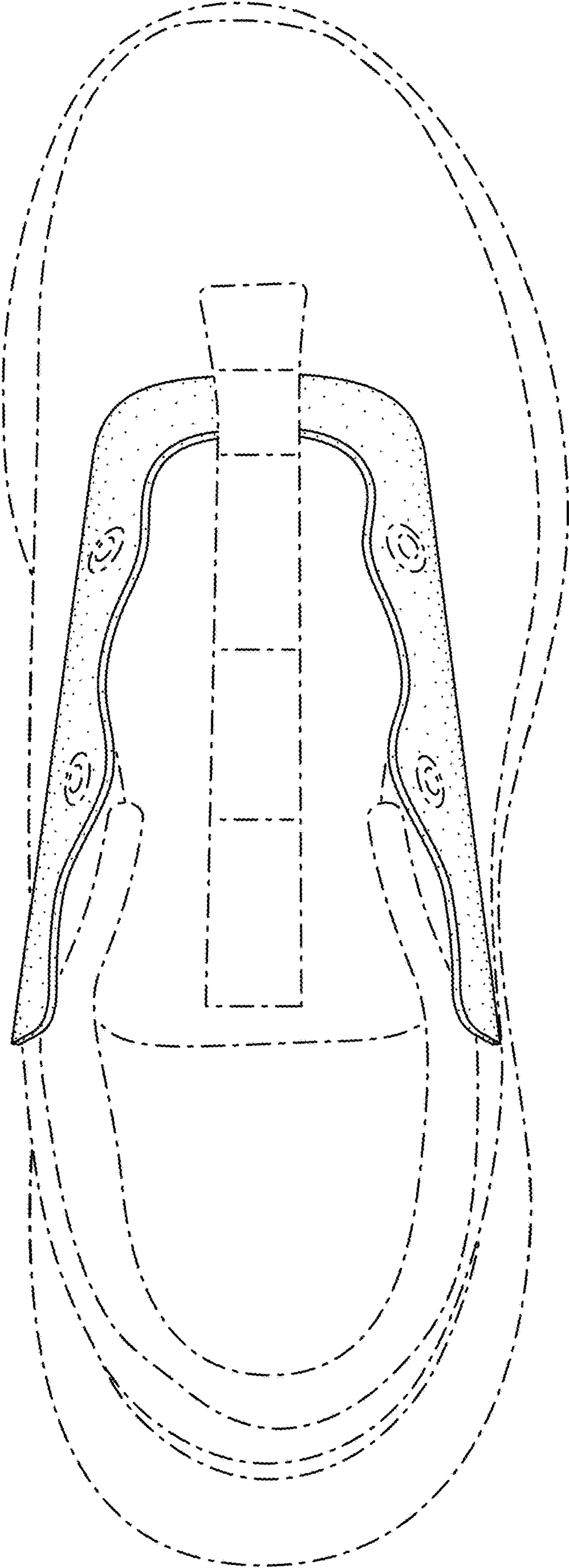
