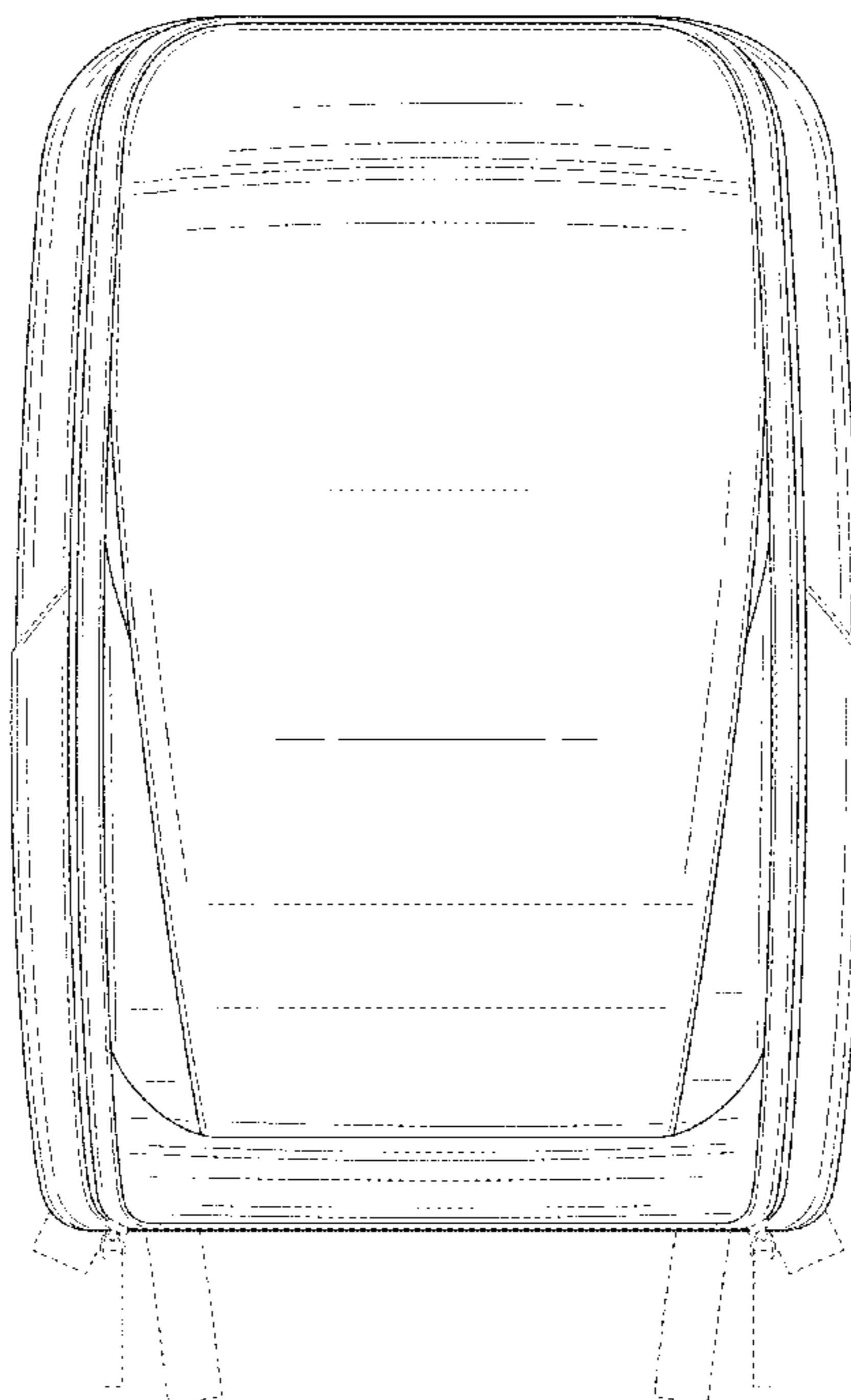
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front view showing my new design for a backpack.

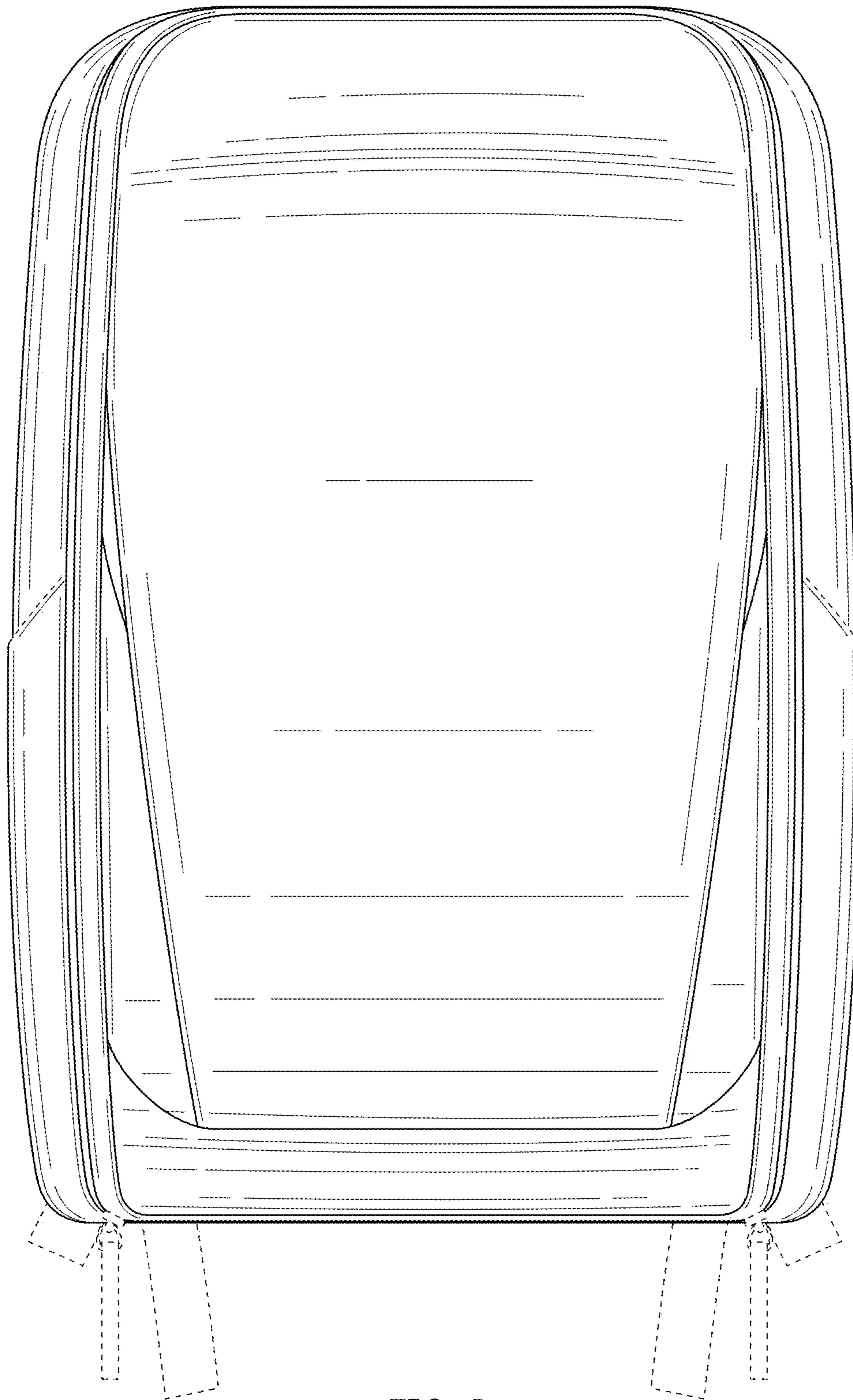

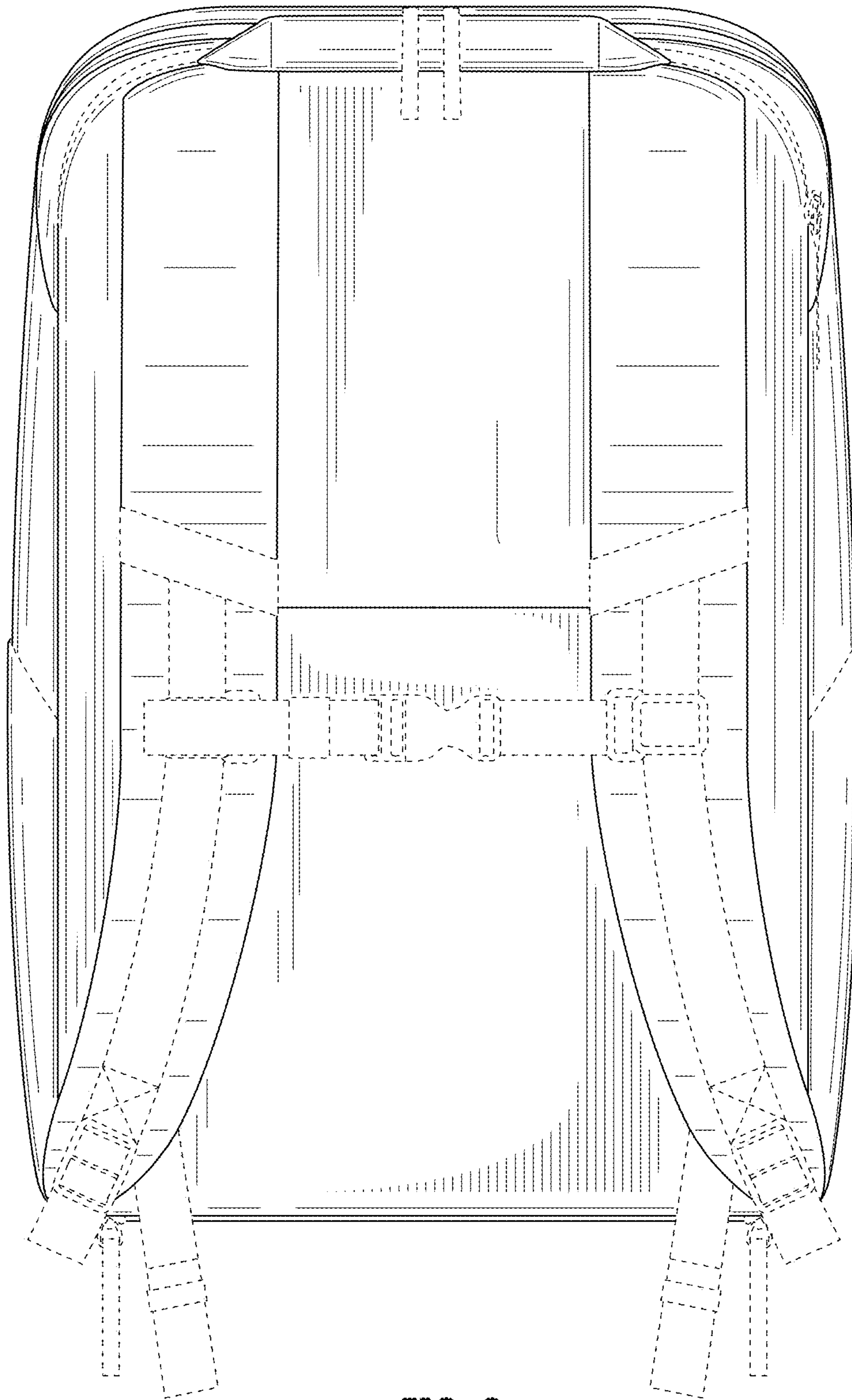

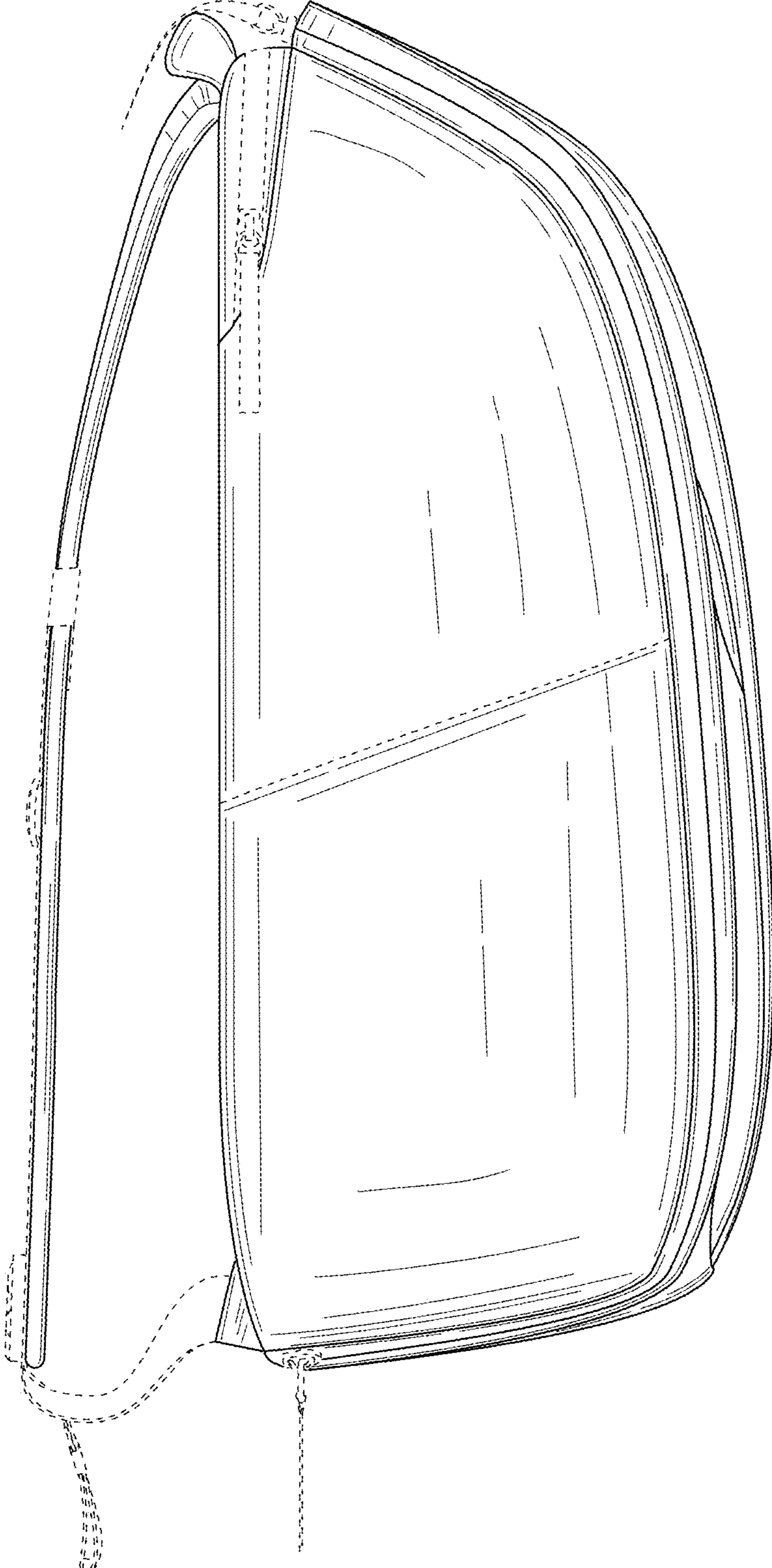

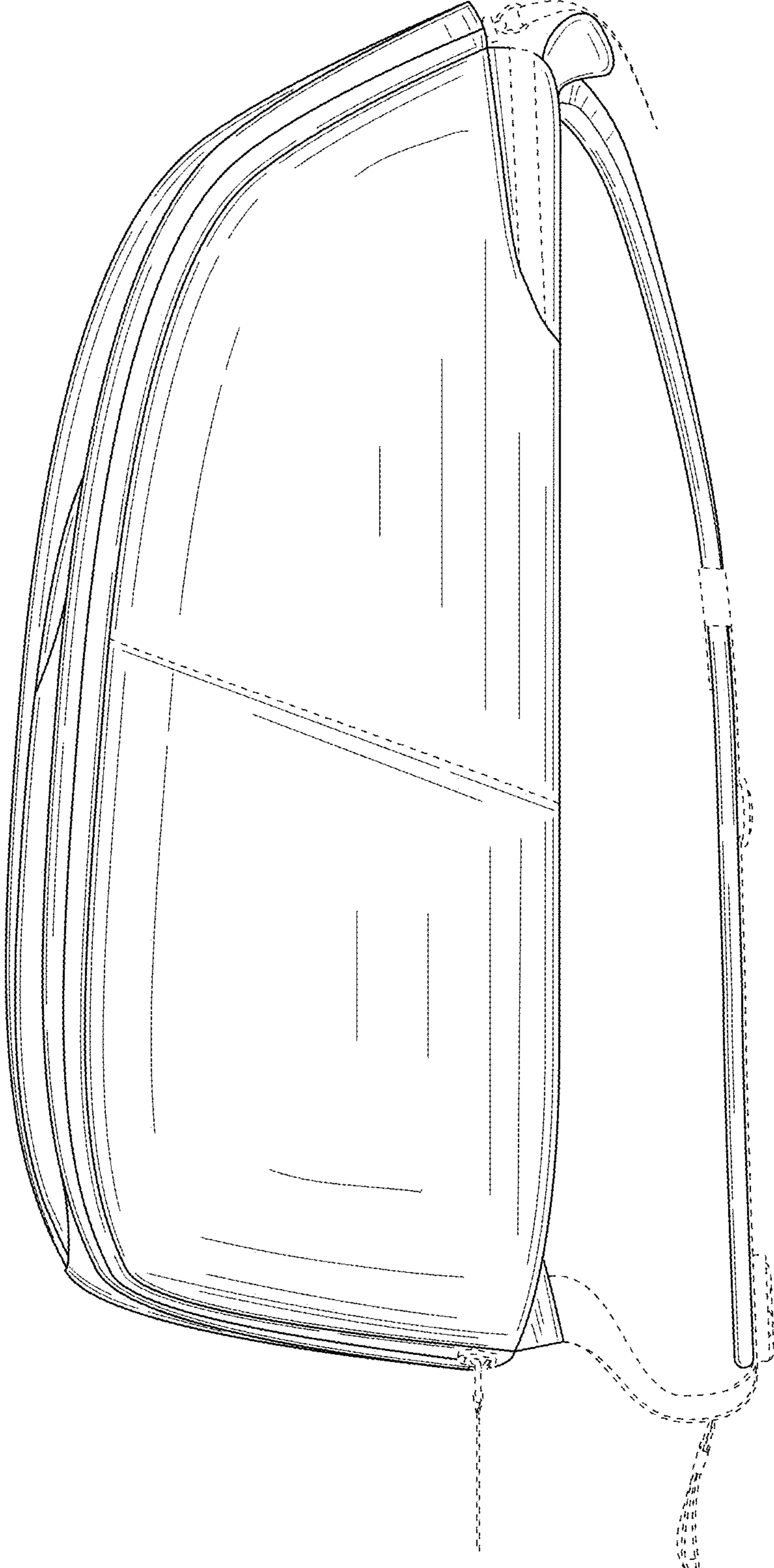

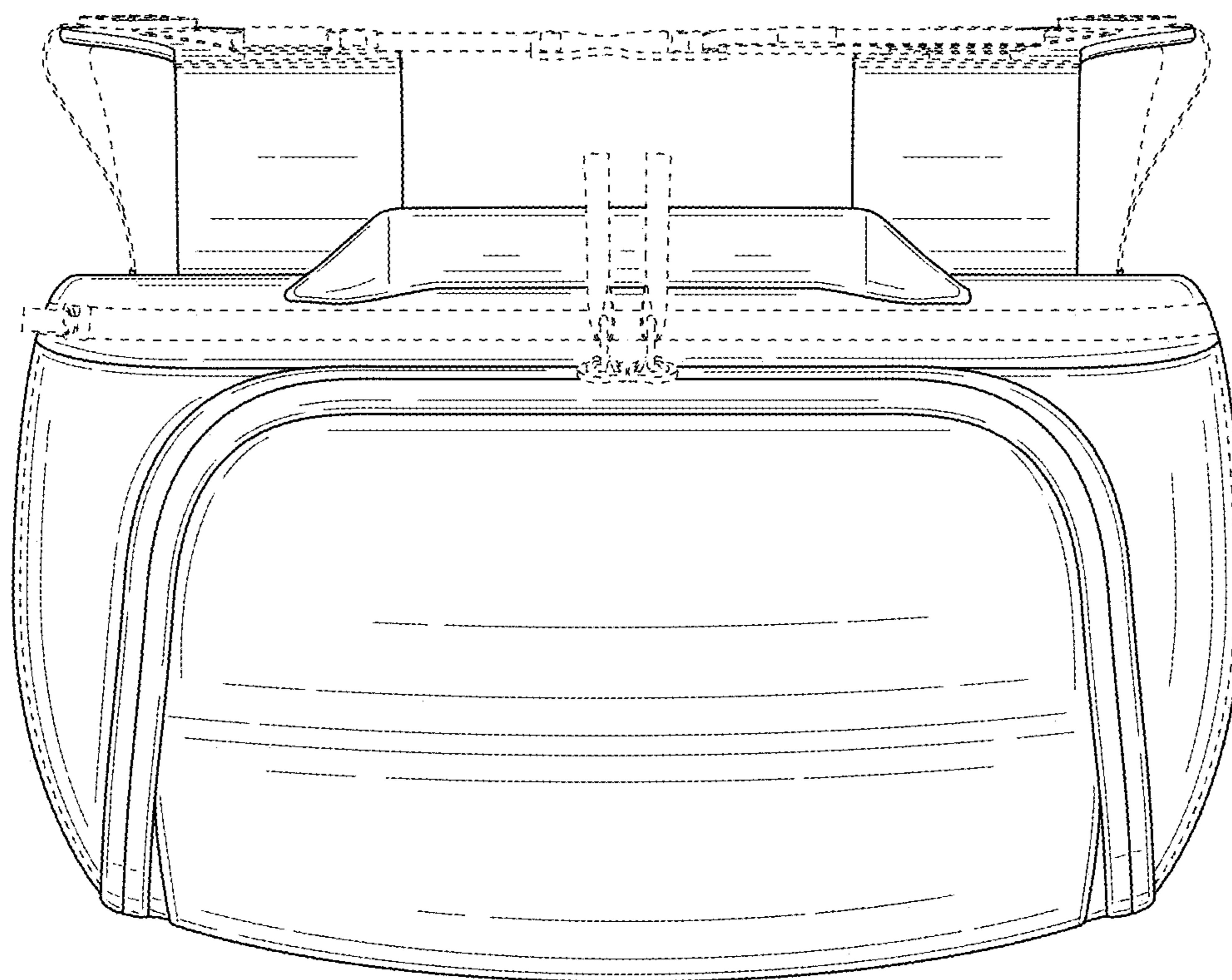

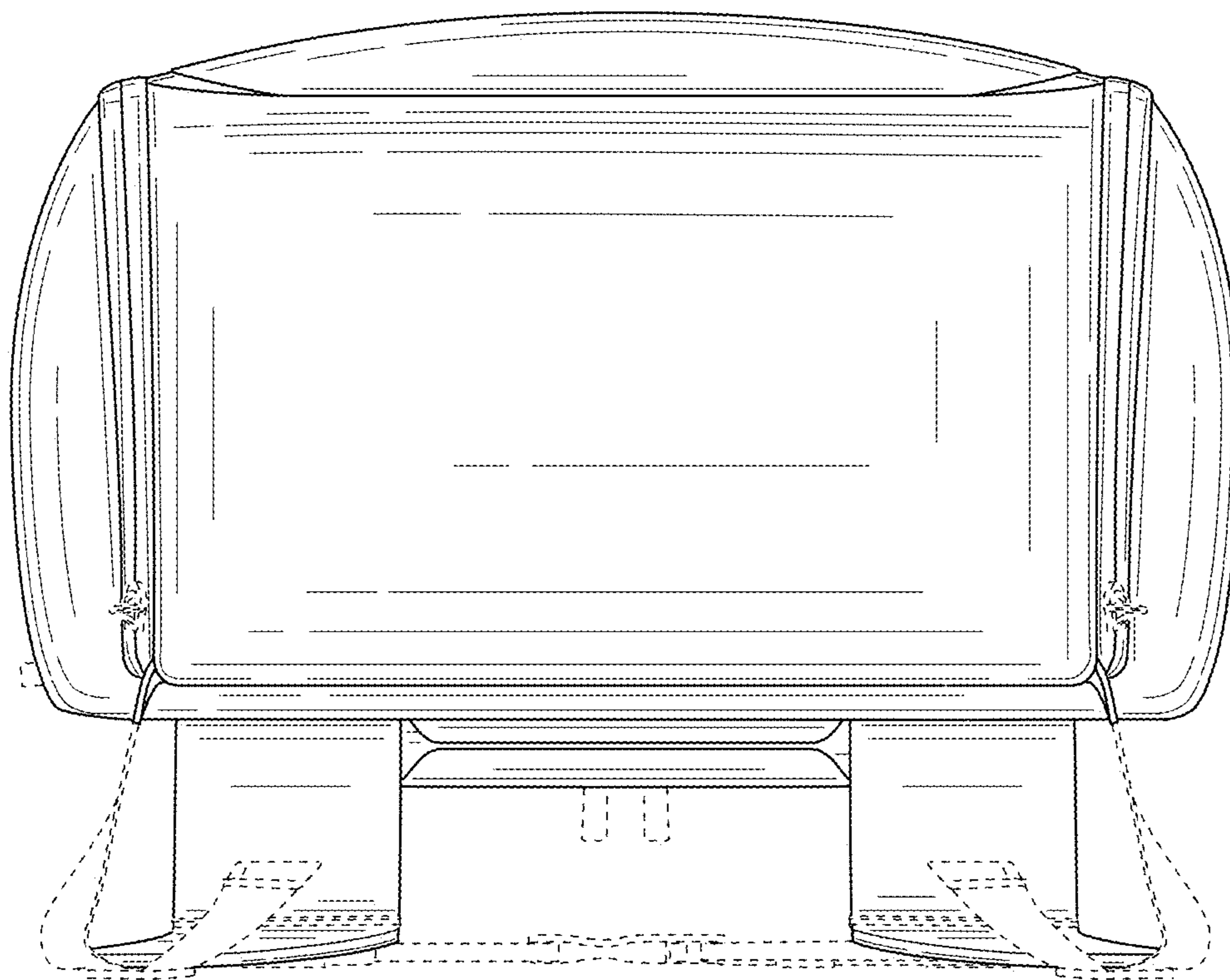
