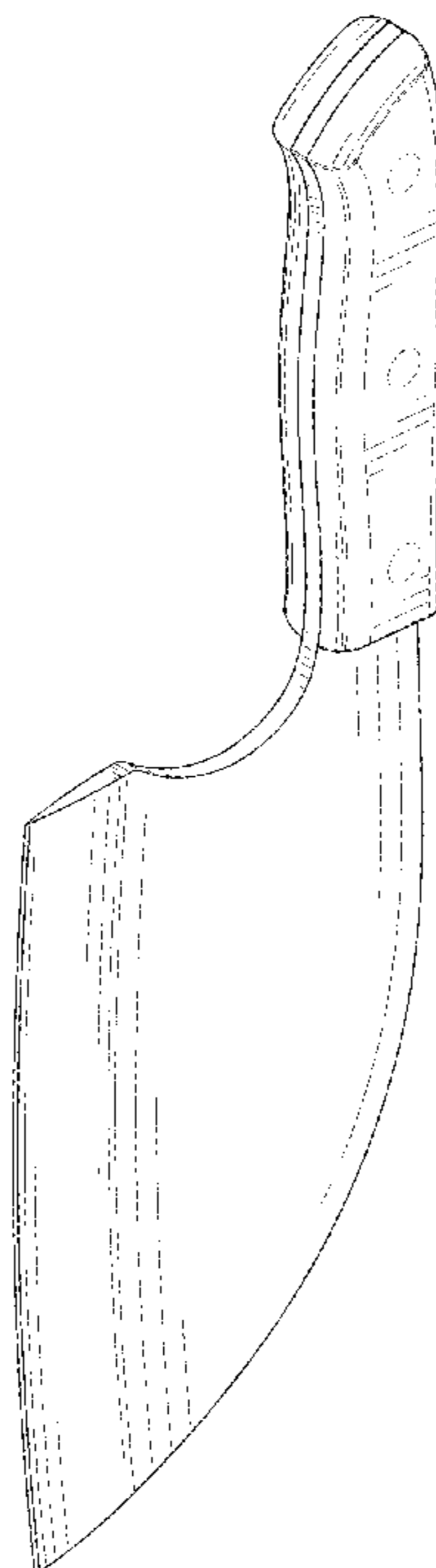
The ornamental design for a kitchen knife, as shown and described.

DESCRIPTION

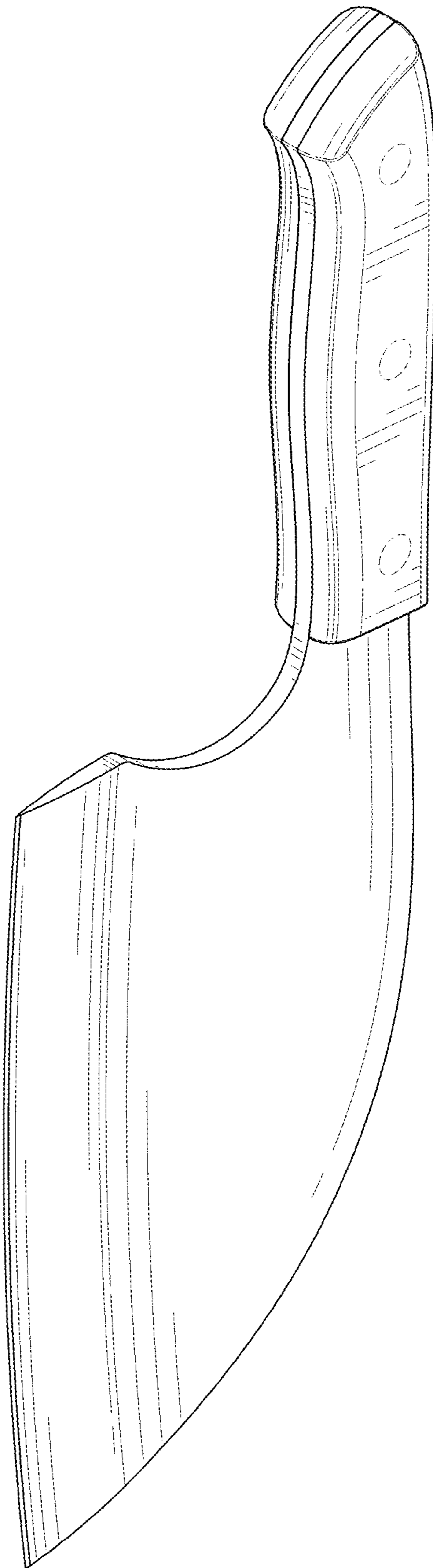

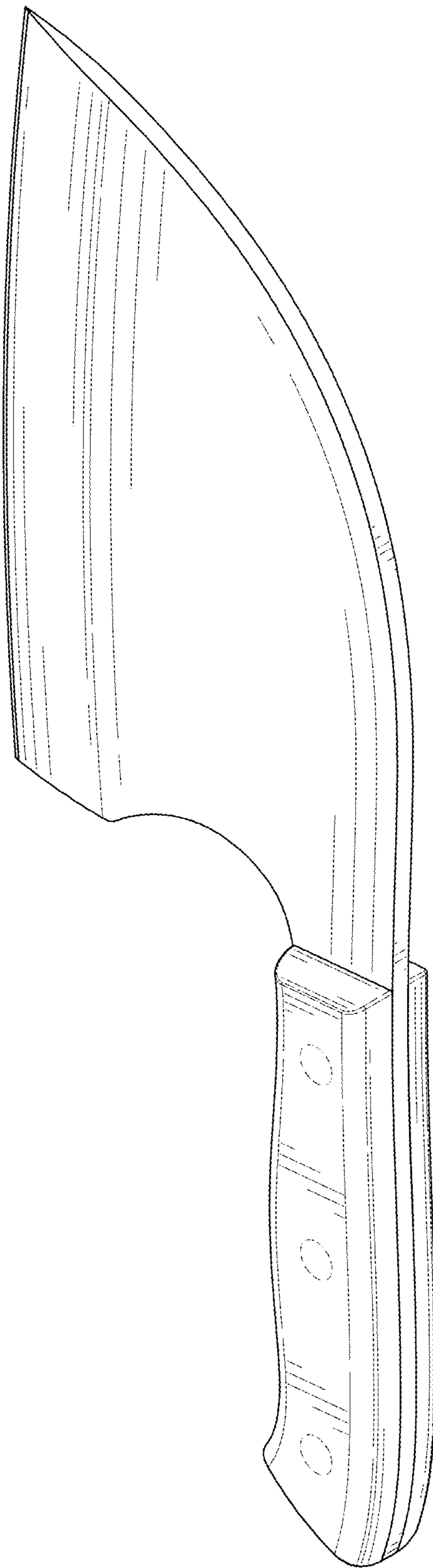

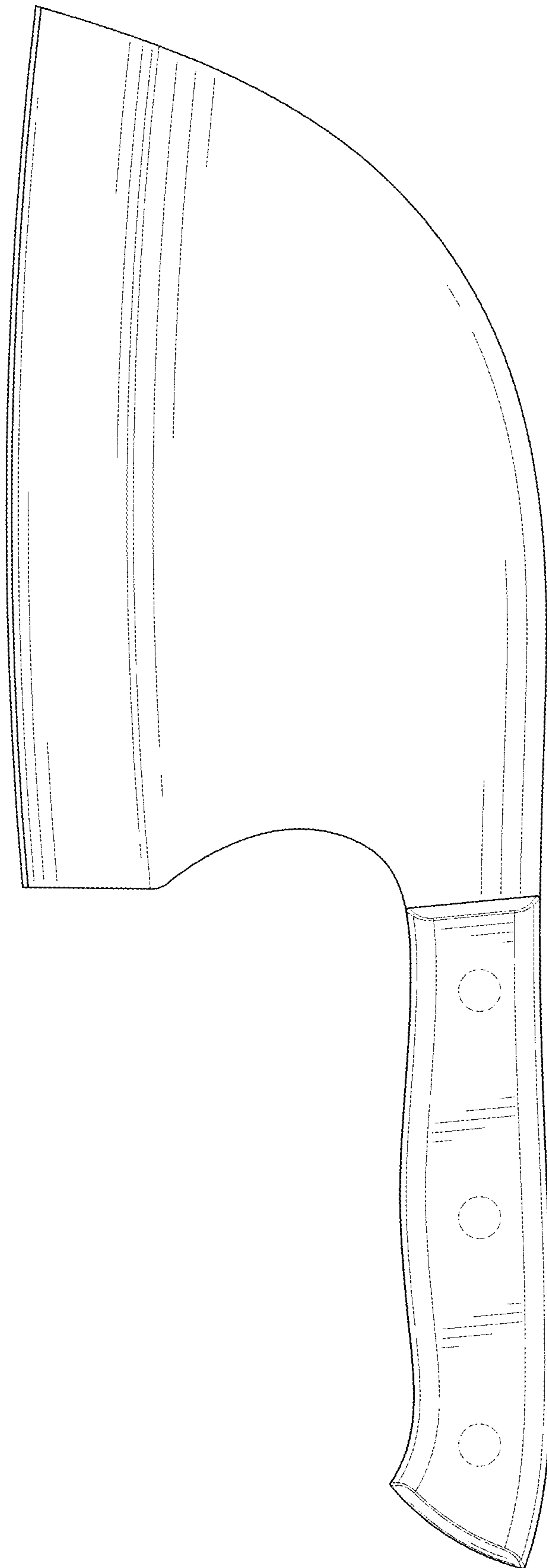

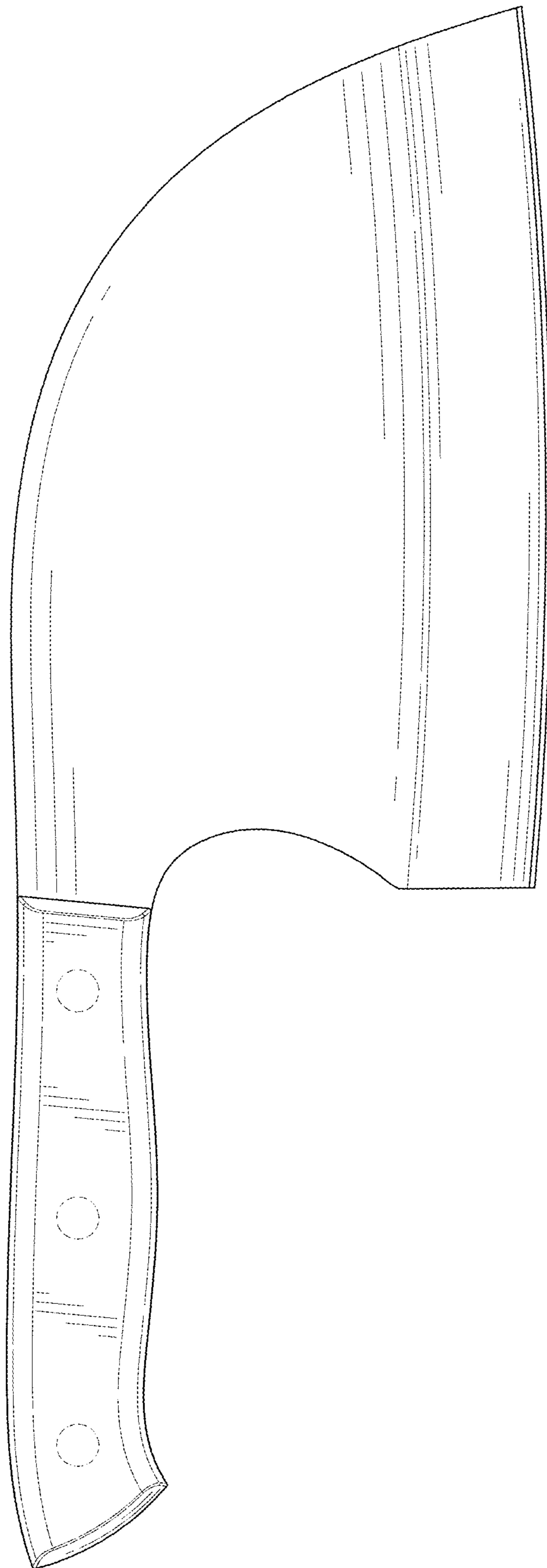

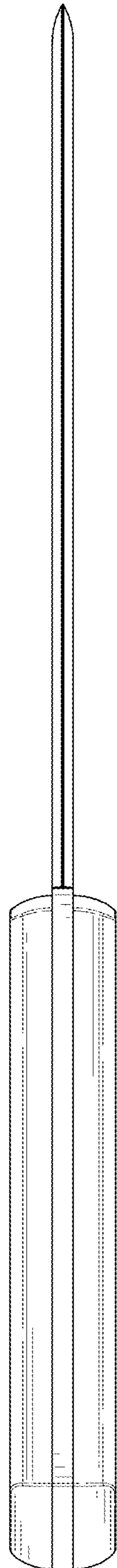

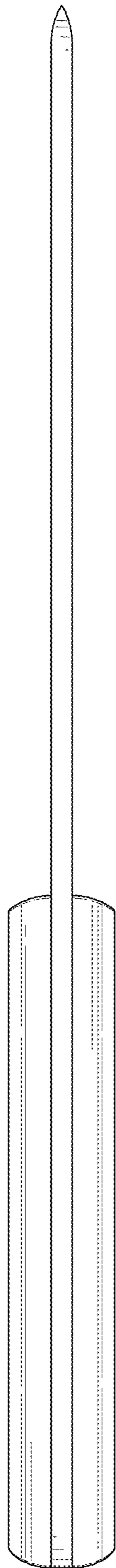

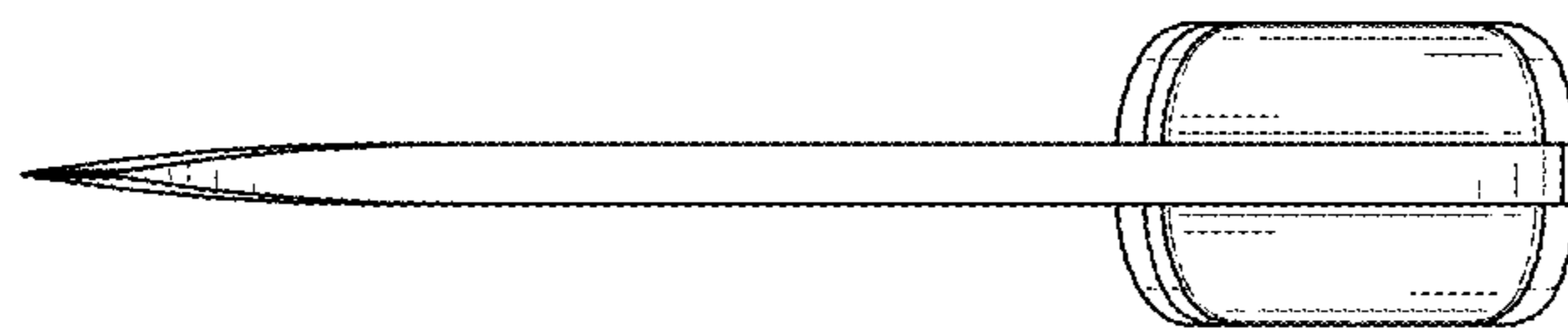

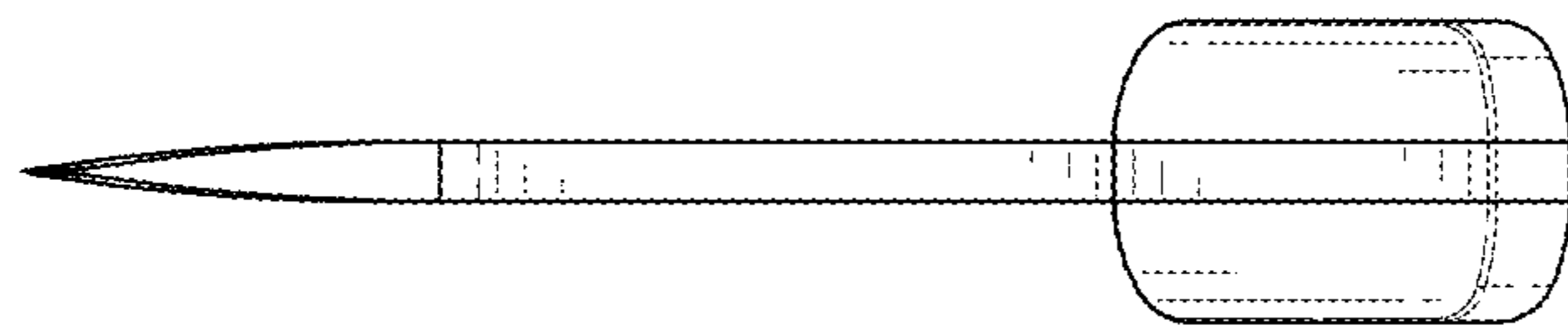
