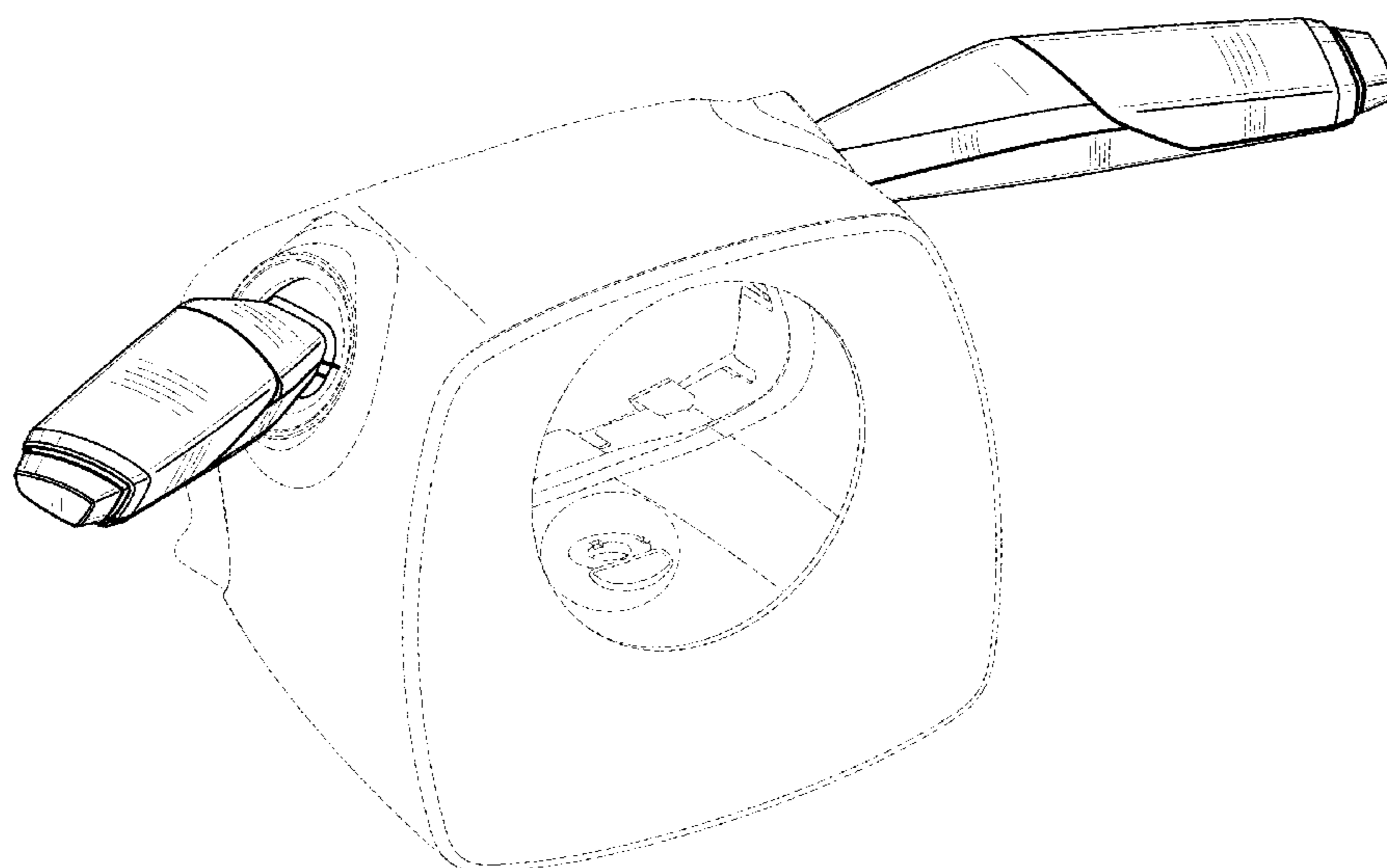
(57) **CLAIM**

The ornamental design for a vehicular control stalks adjacent to steering column shroud, as shown and described.

**DESCRIPTION**

FIG. 1 is a rear perspective view of a vehicular control stalks adjacent to steering column shroud embodying my new design;  
FIG. 2 is a front perspective view thereof;  
FIG. 3 is a rear elevation view thereof;  
FIG. 4 is a right side elevation view thereof;  
FIG. 5 is a left side elevation view thereof;  
FIG. 6 is a top plan view thereof;  
FIG. 7 is a front elevation thereof; and,  
FIG. 8 is a bottom plan view thereof.  
The broken line showing of the steering column shroud are provided for the purpose of illustrating environmental structure and form no part of the claimed design.

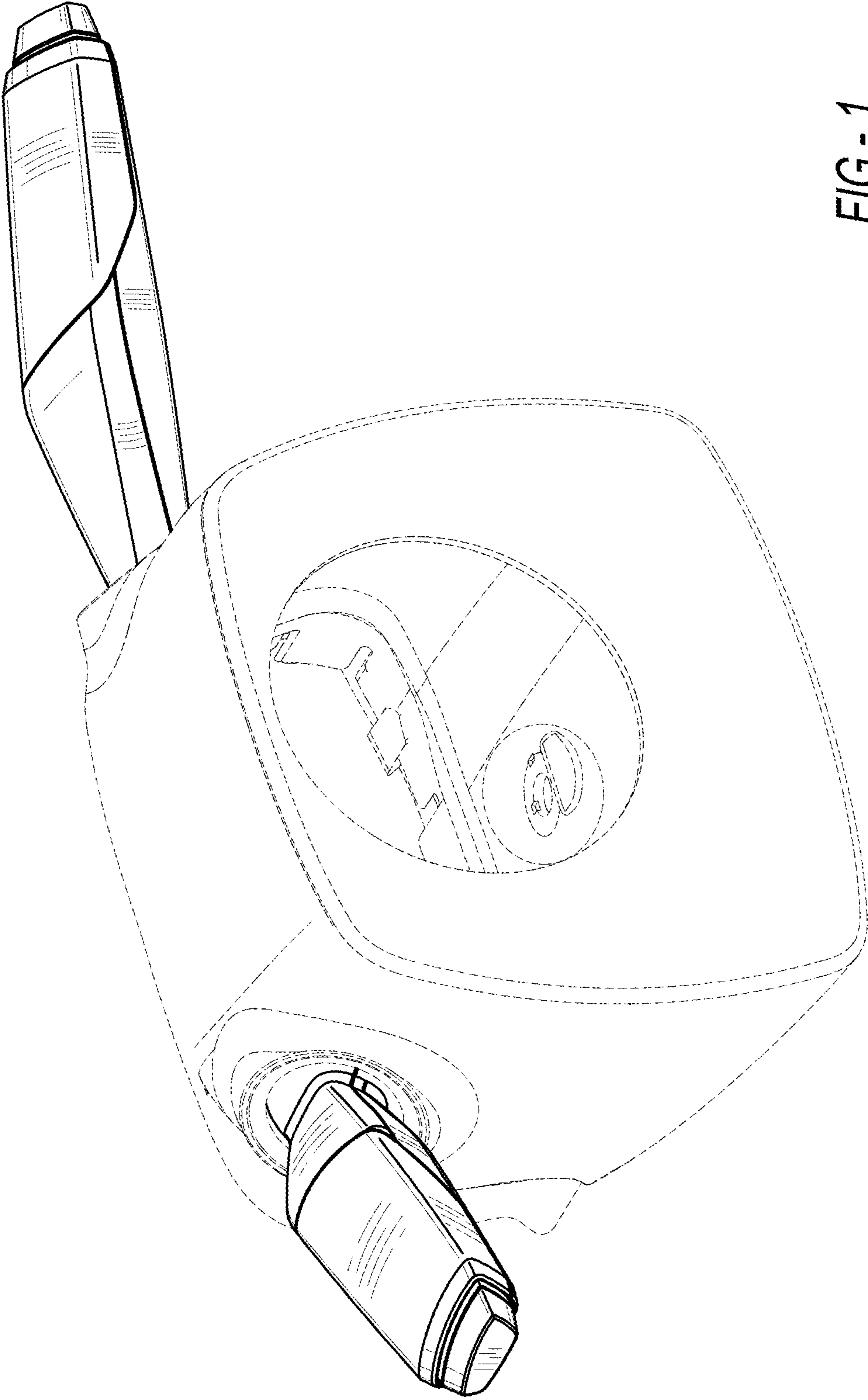

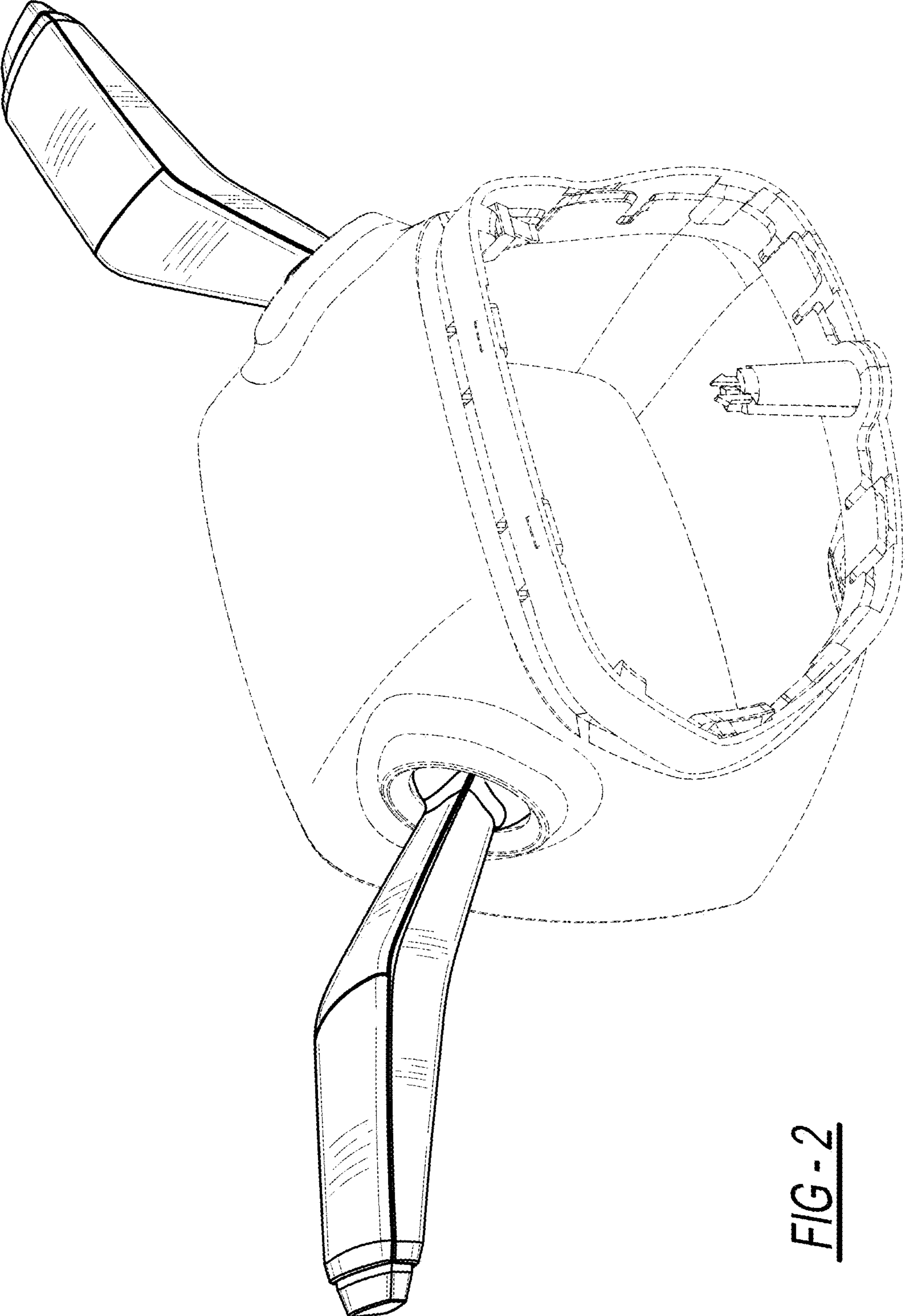

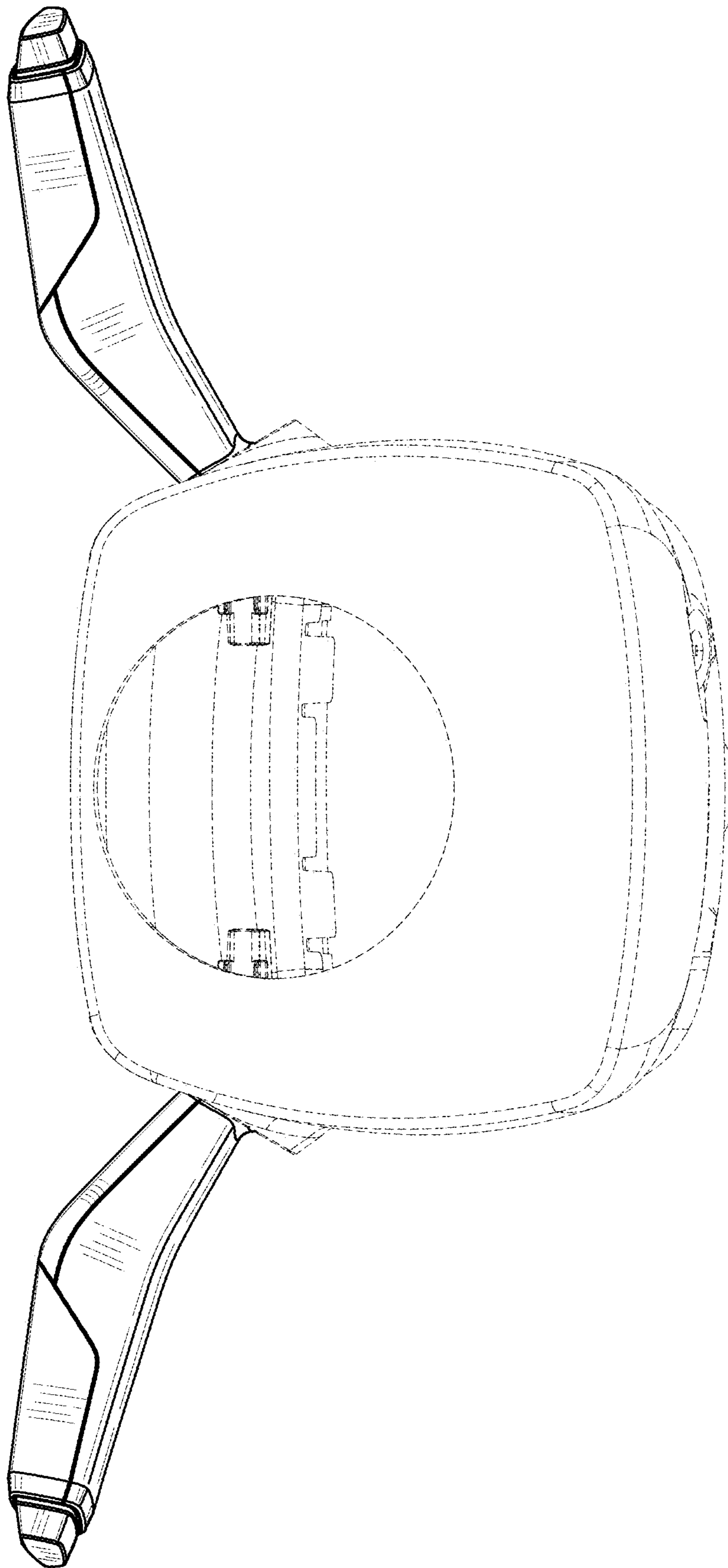

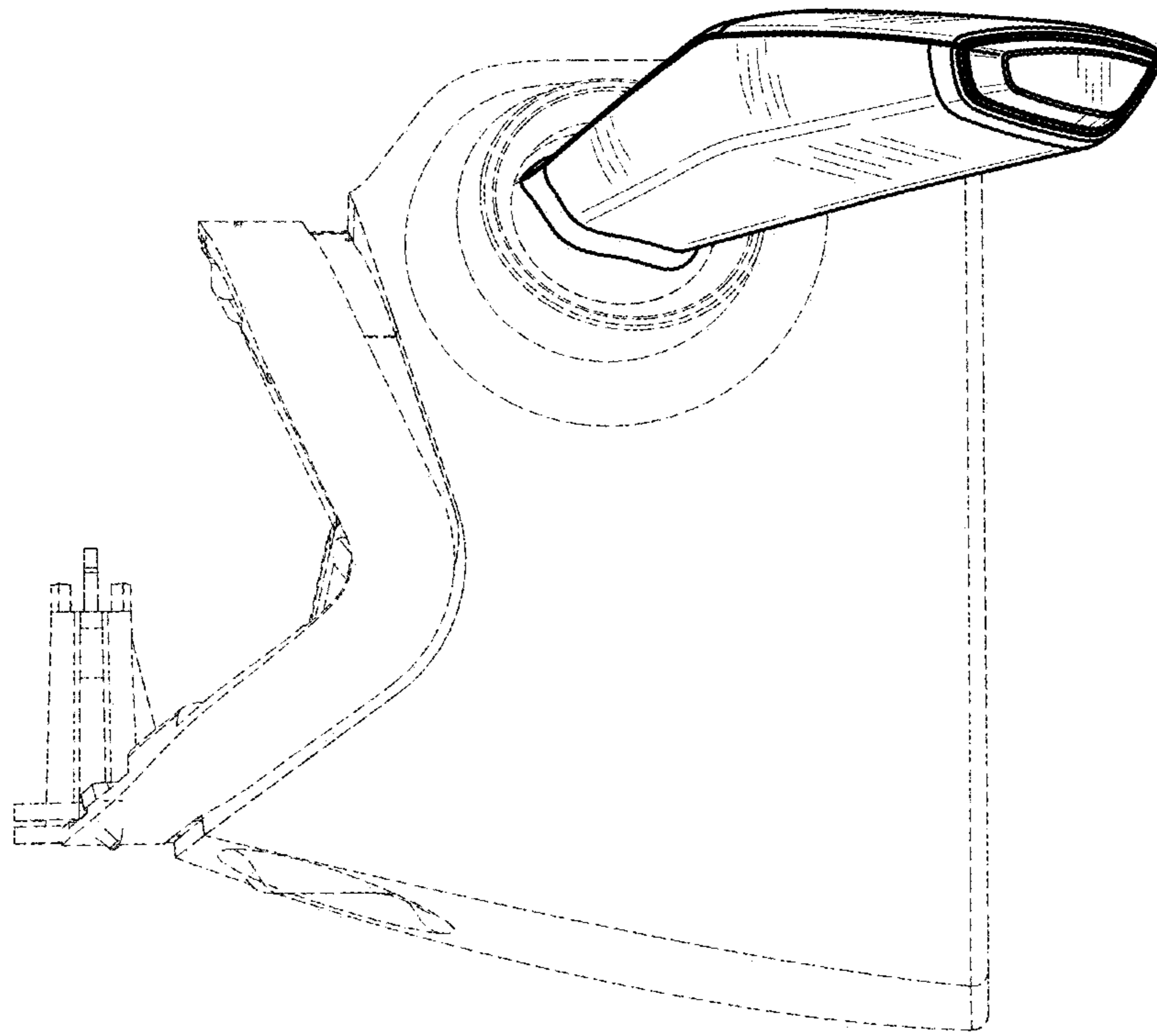

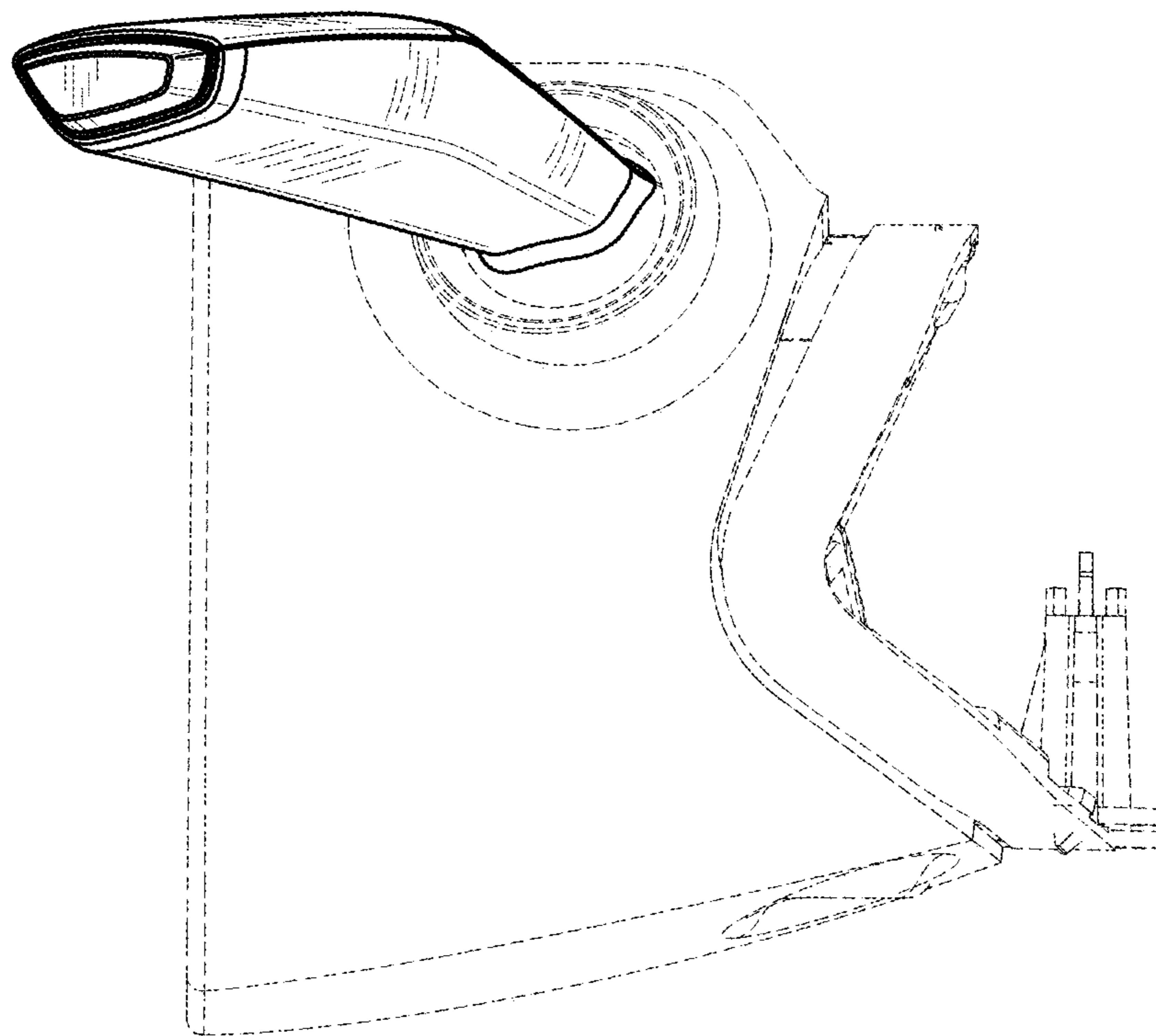

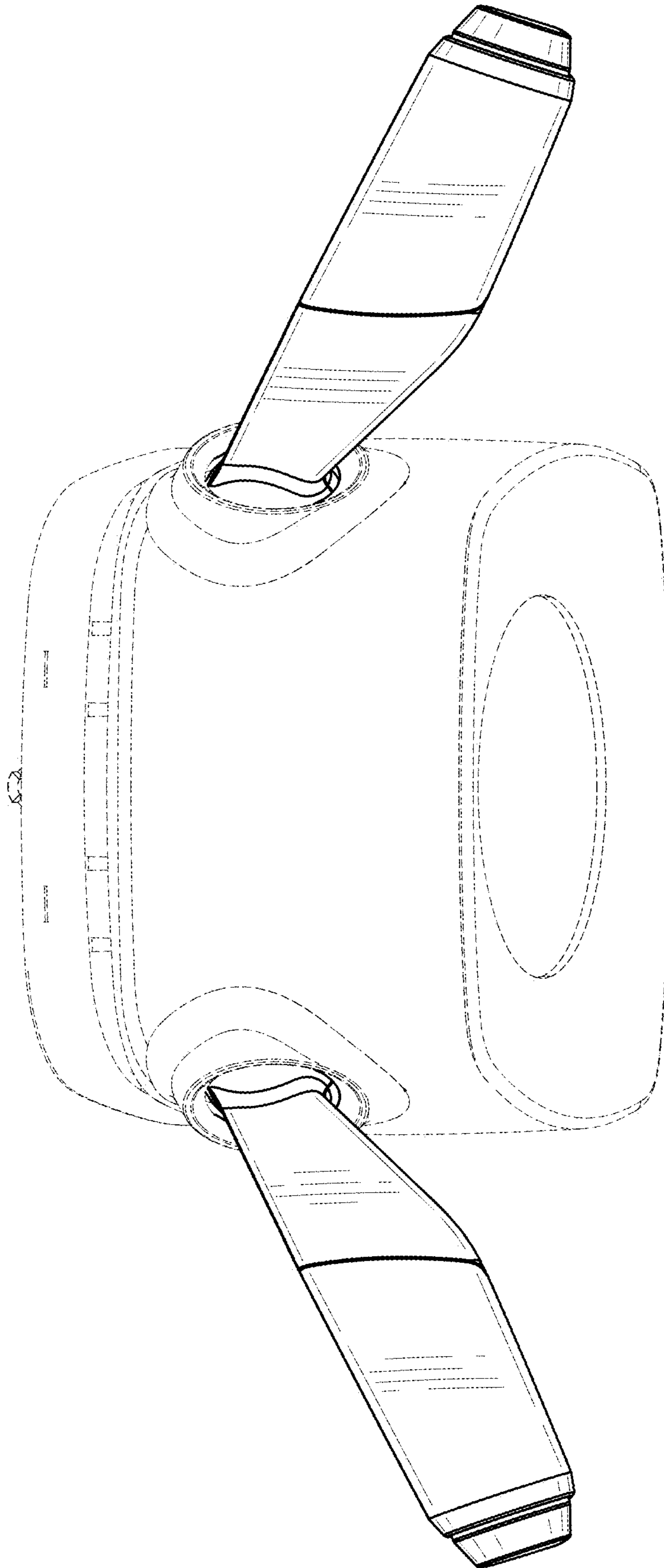

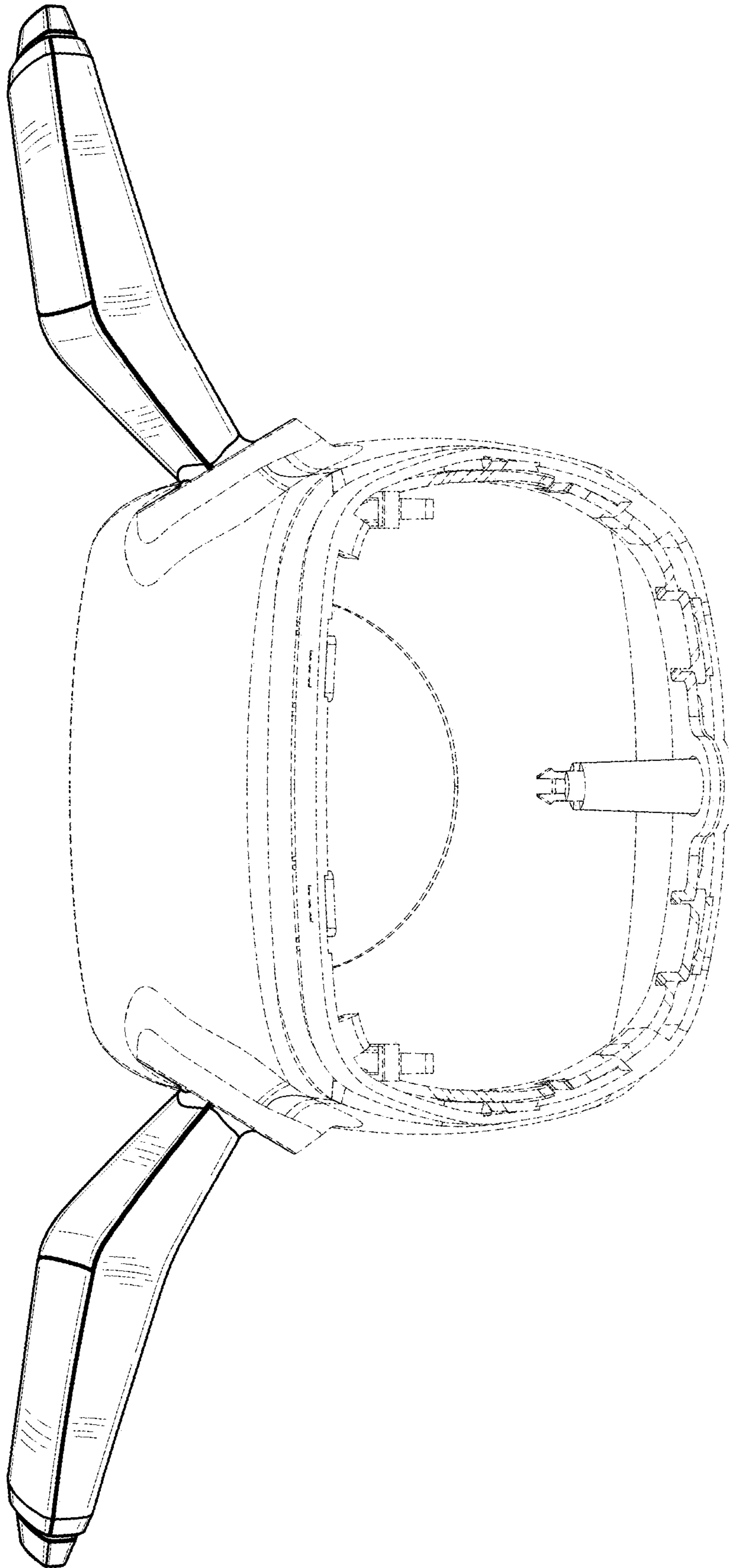

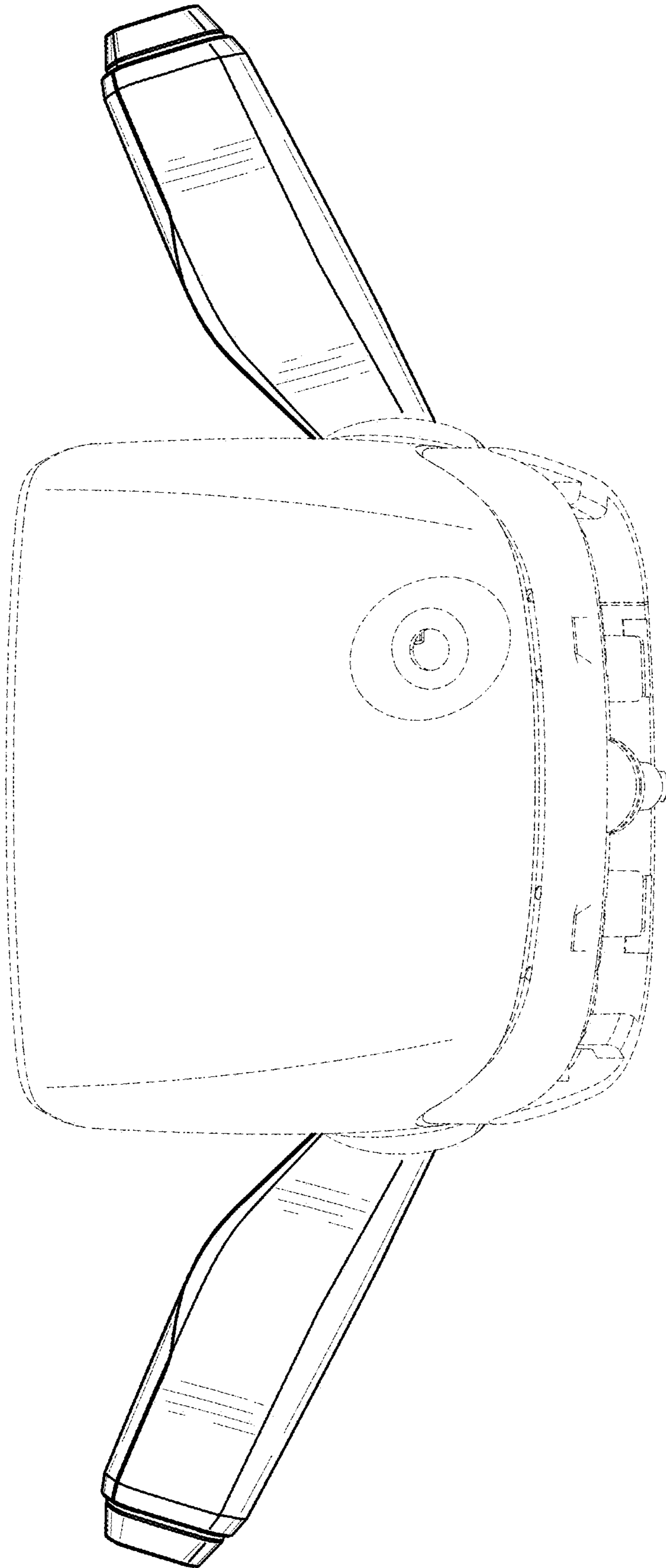
