DESCRIPTION

1. Boat

FIG. 1.11 is a perspective lower bottom side view of the boat;

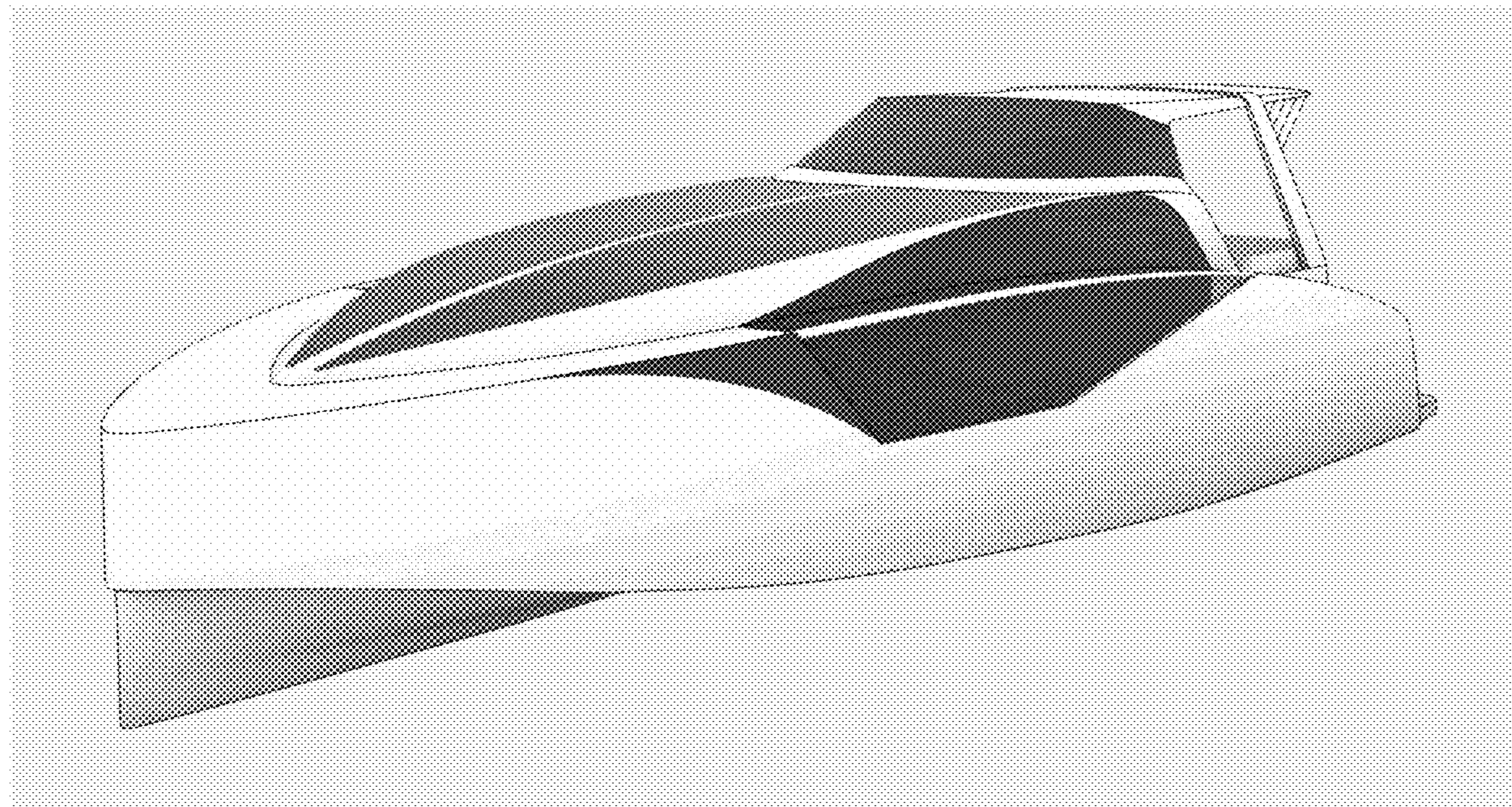
FIG. 1.12 is a perspective partial upper side view of the boat;

FIG. 1.13 is a second perspective partial upper side view of the boat;

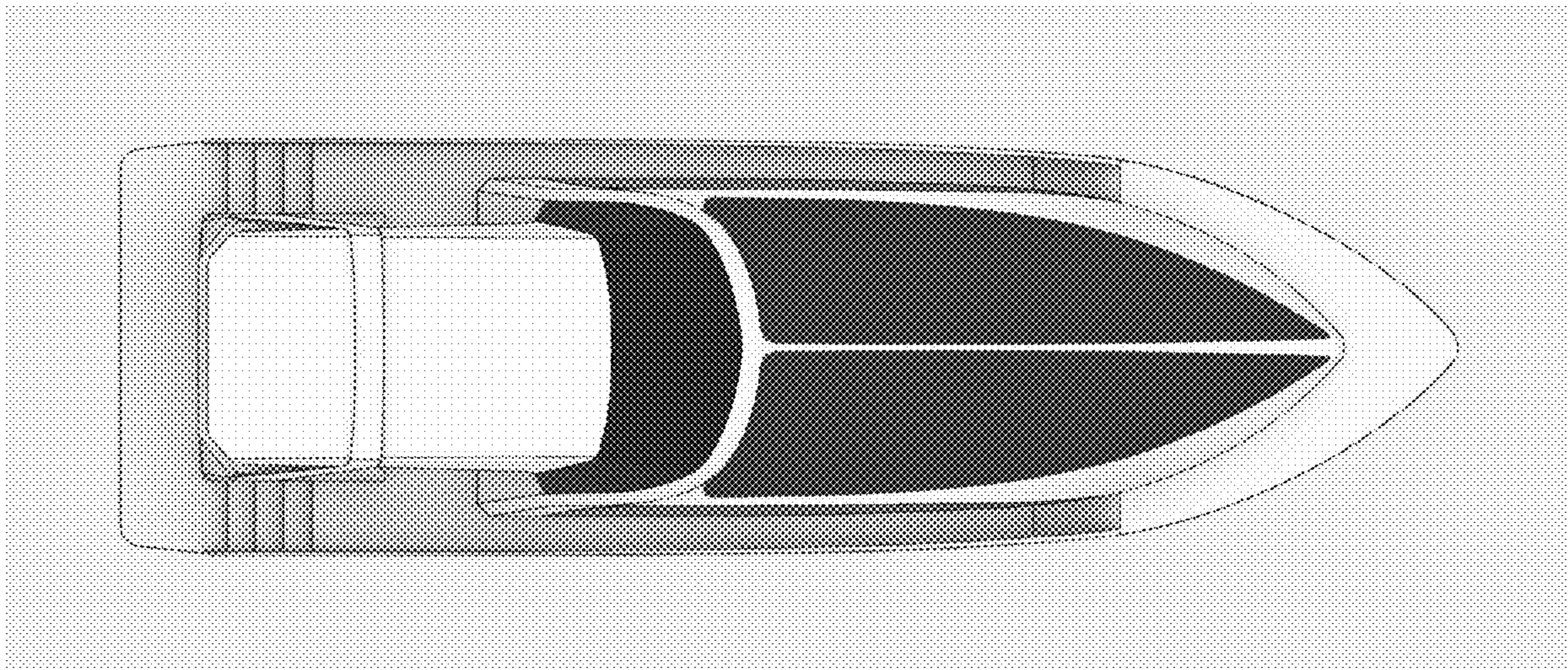
FIG. 1.14 is a cutaway perspective partial upper side view of the boat; and

FIG. 1.15 is a cutaway perspective partial upper back side view of the boat.

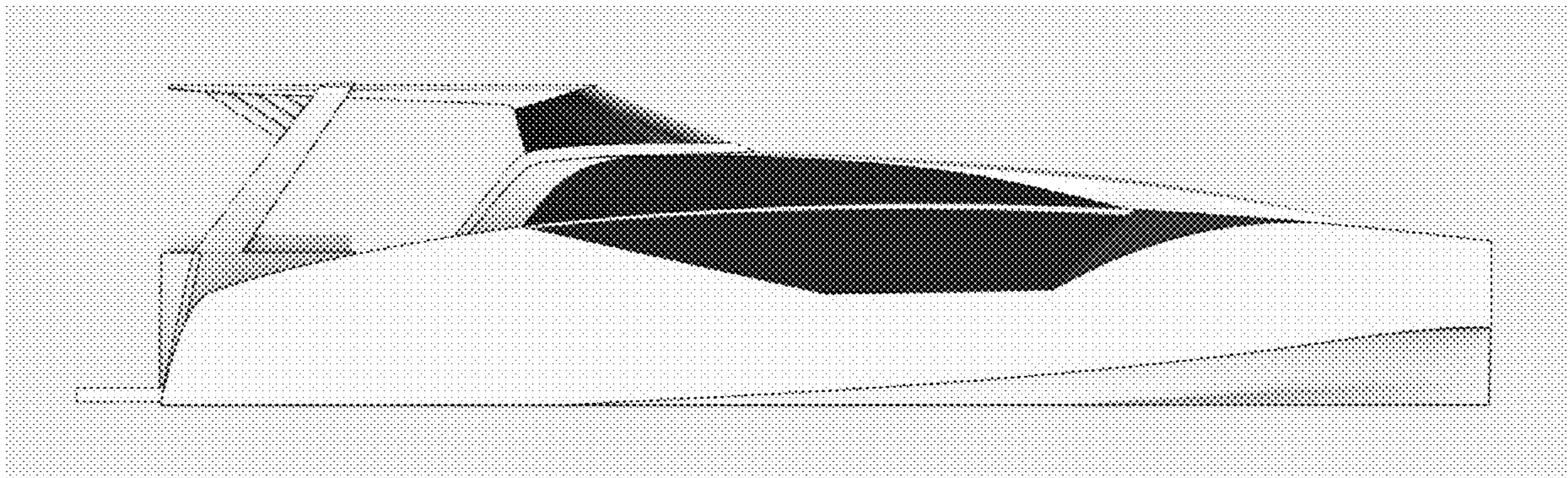

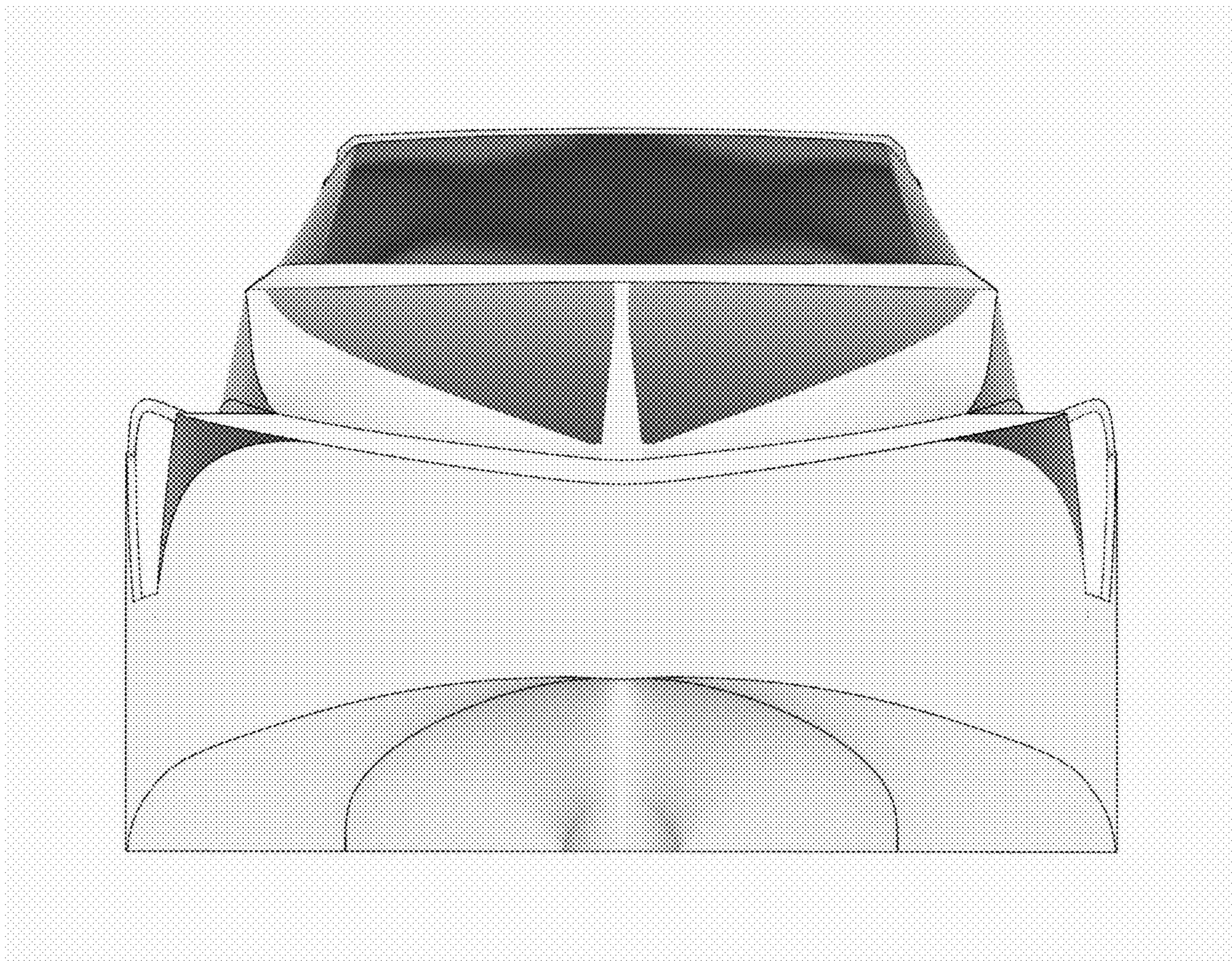

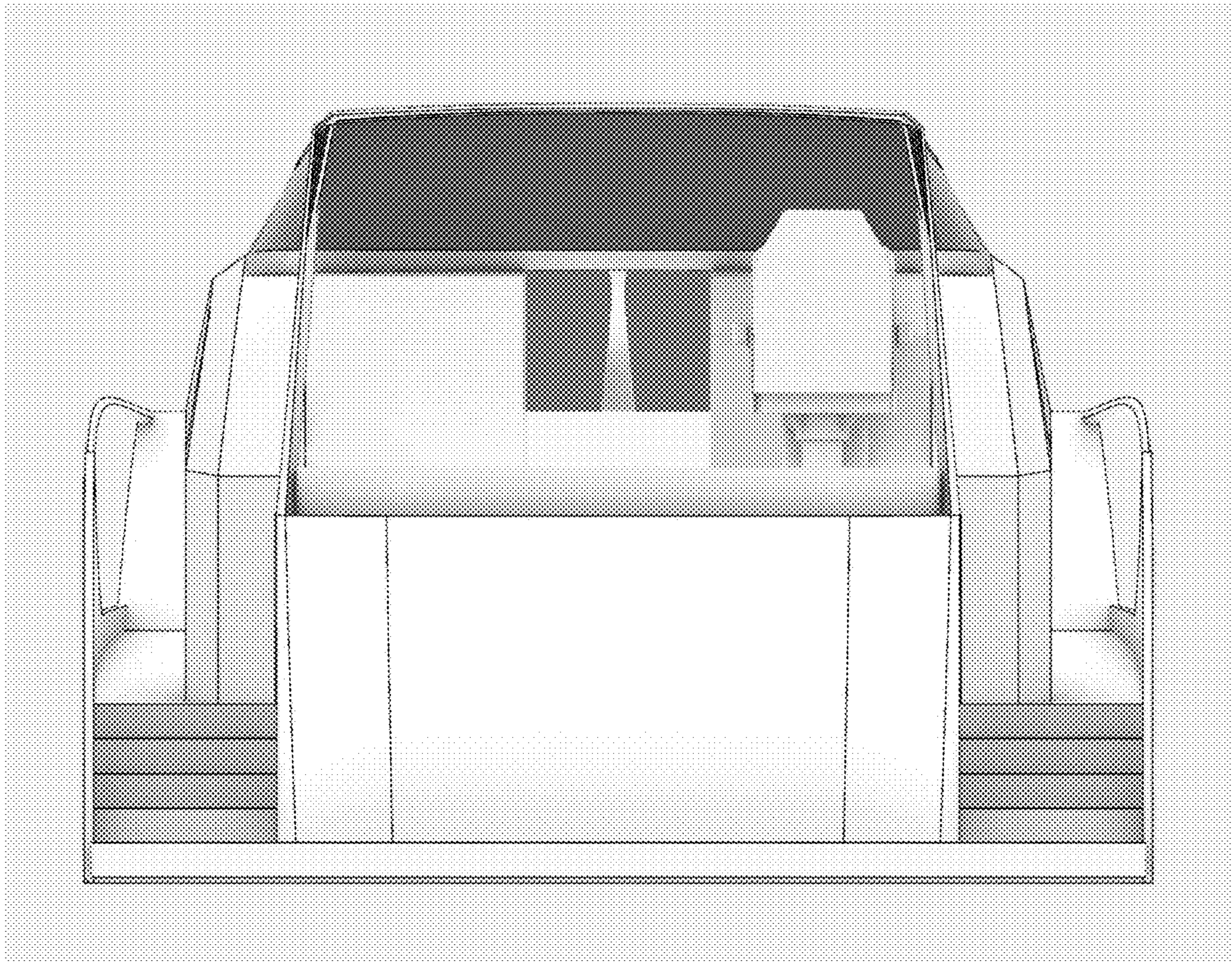

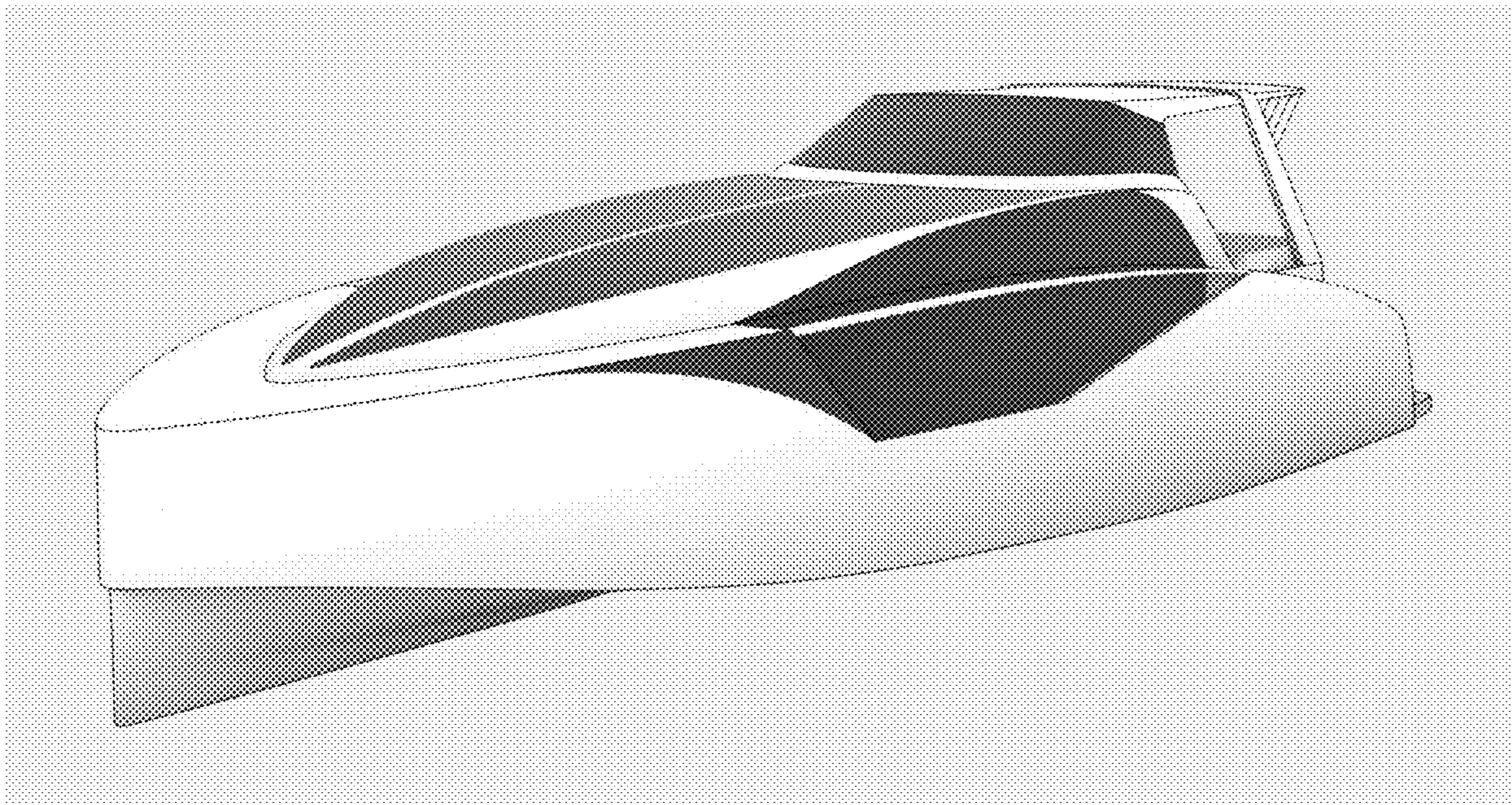

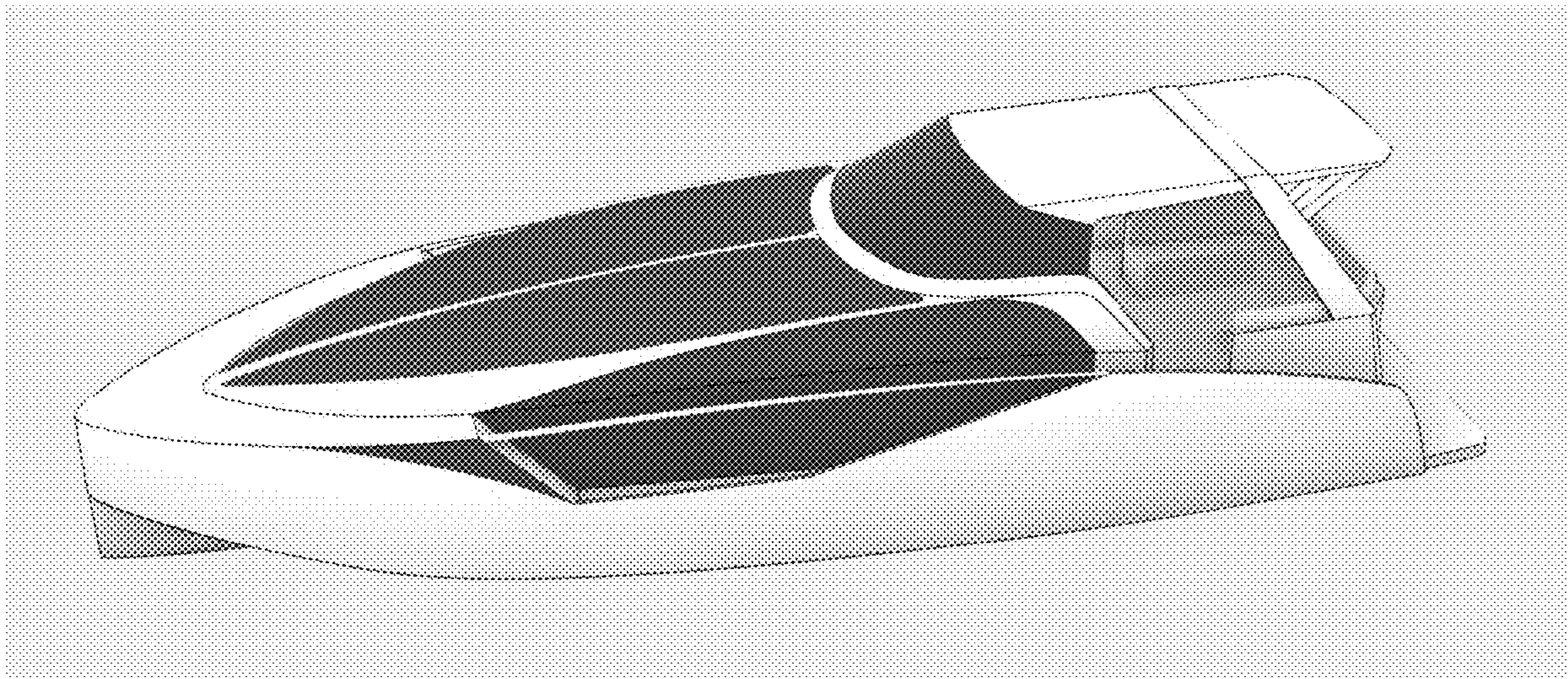

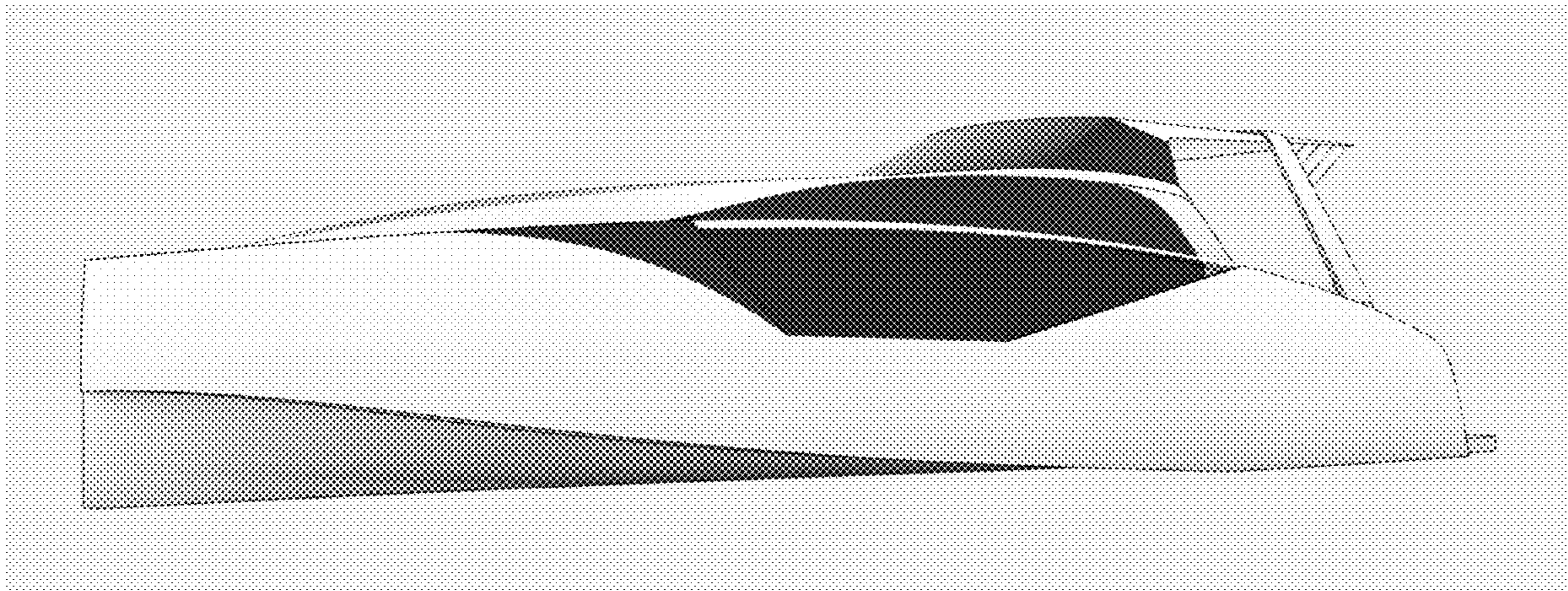

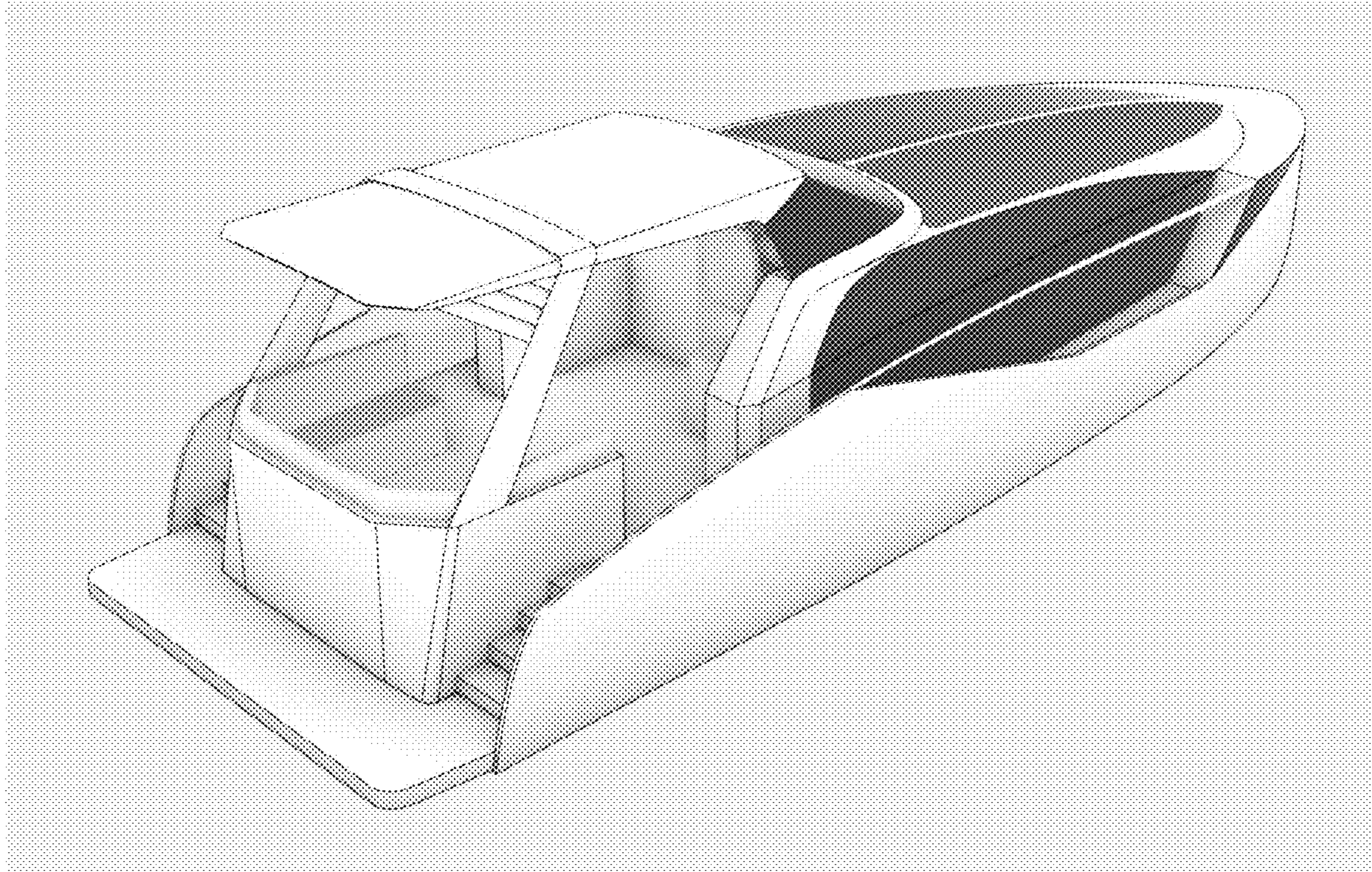

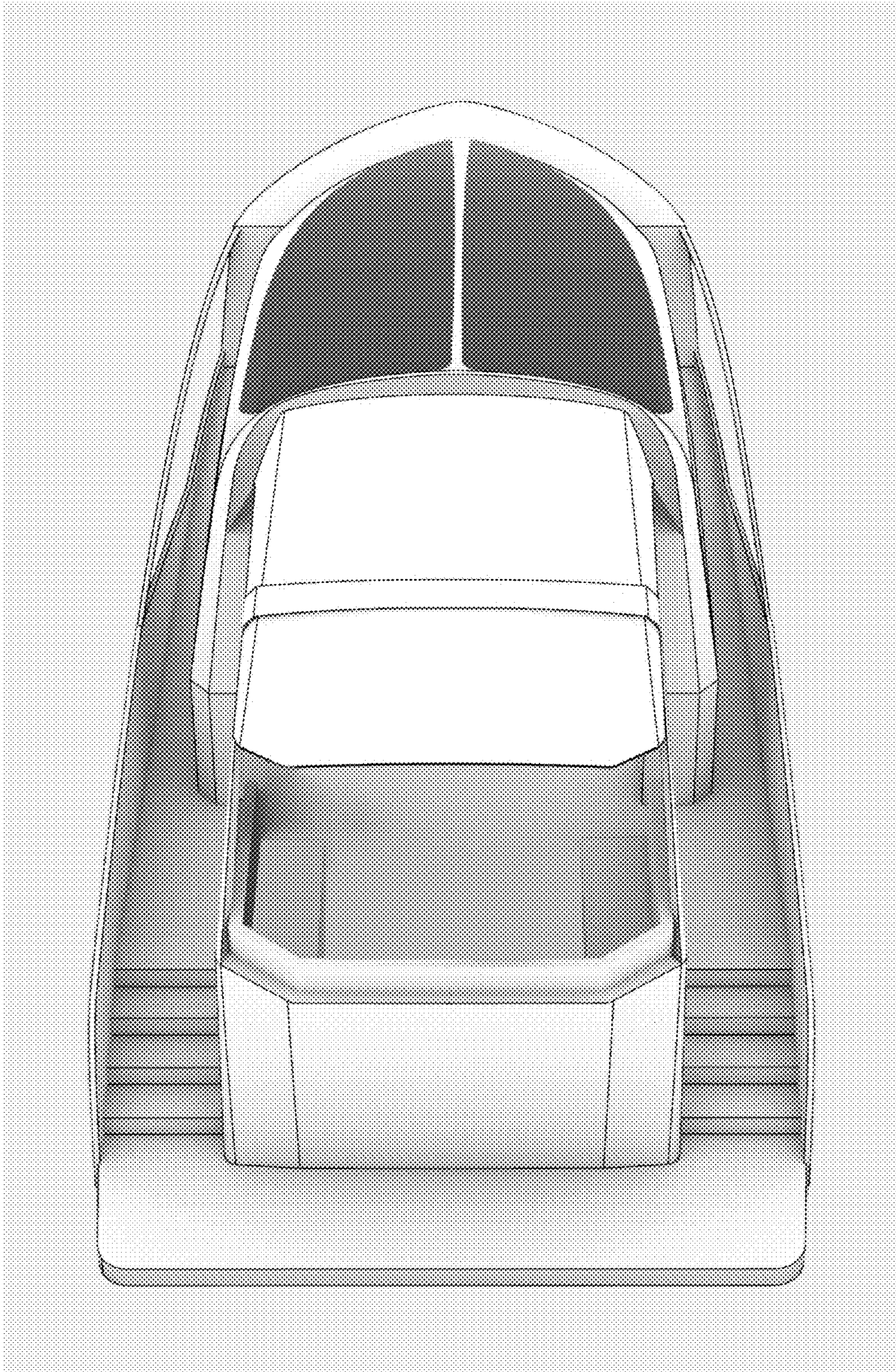

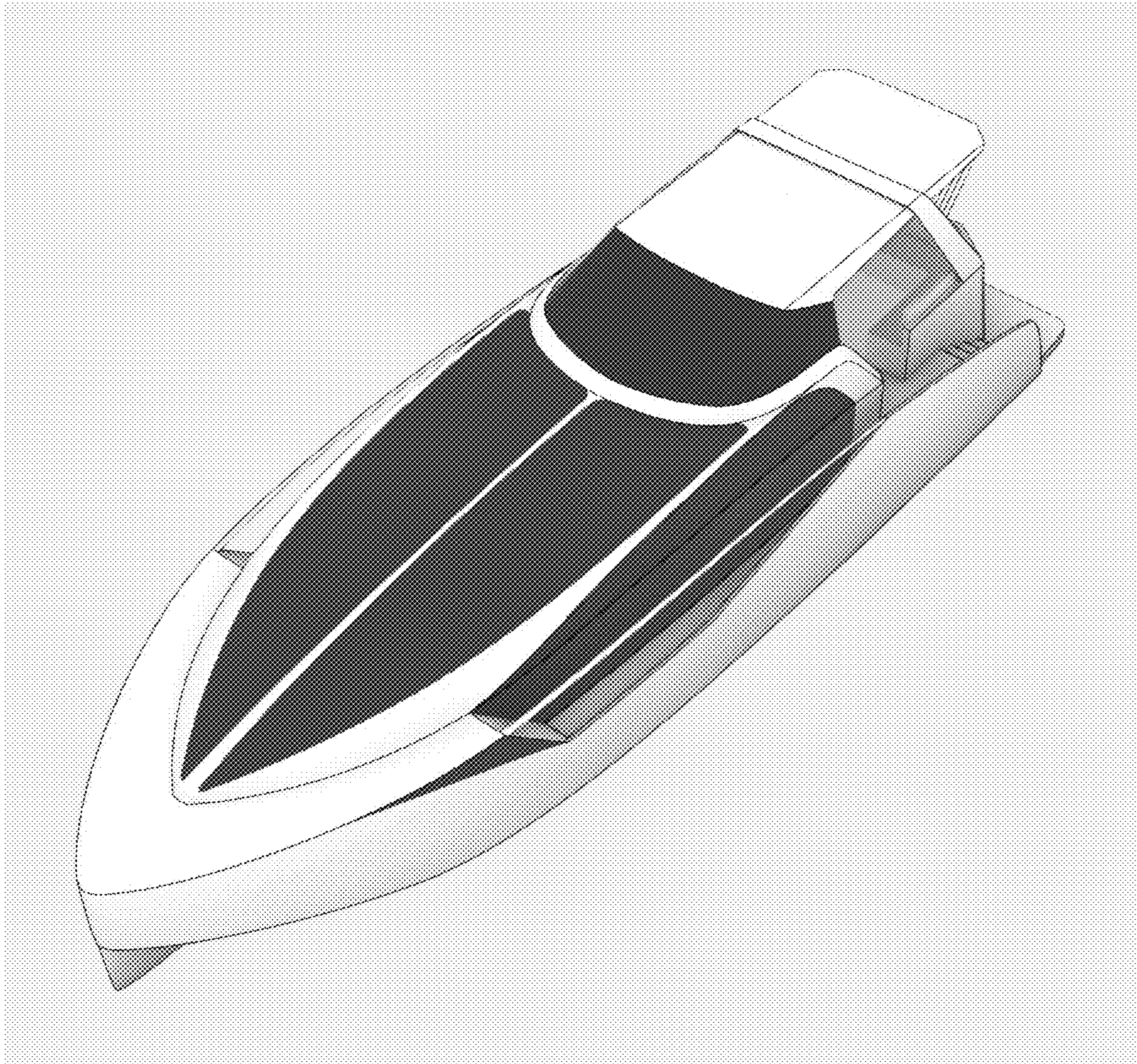

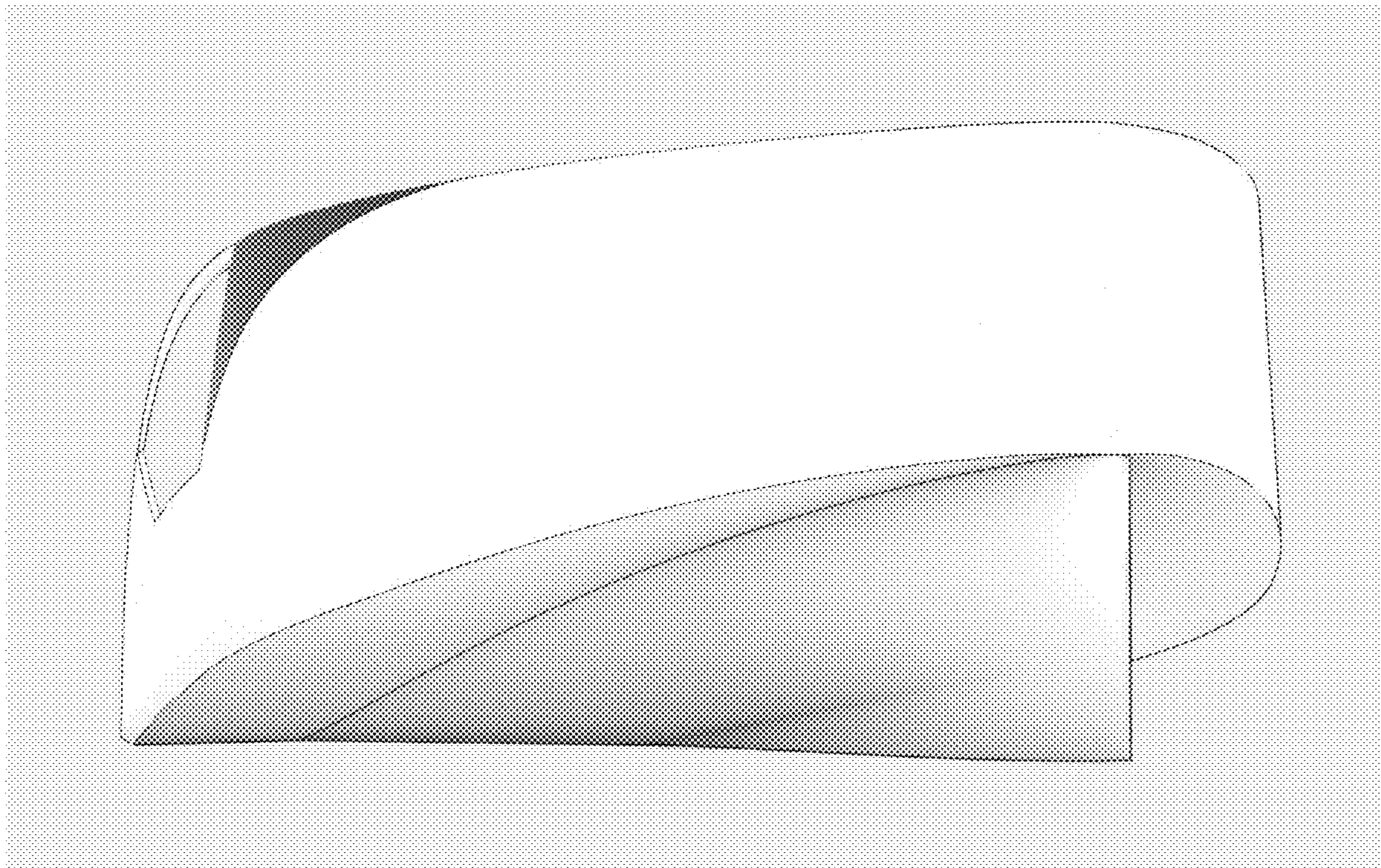

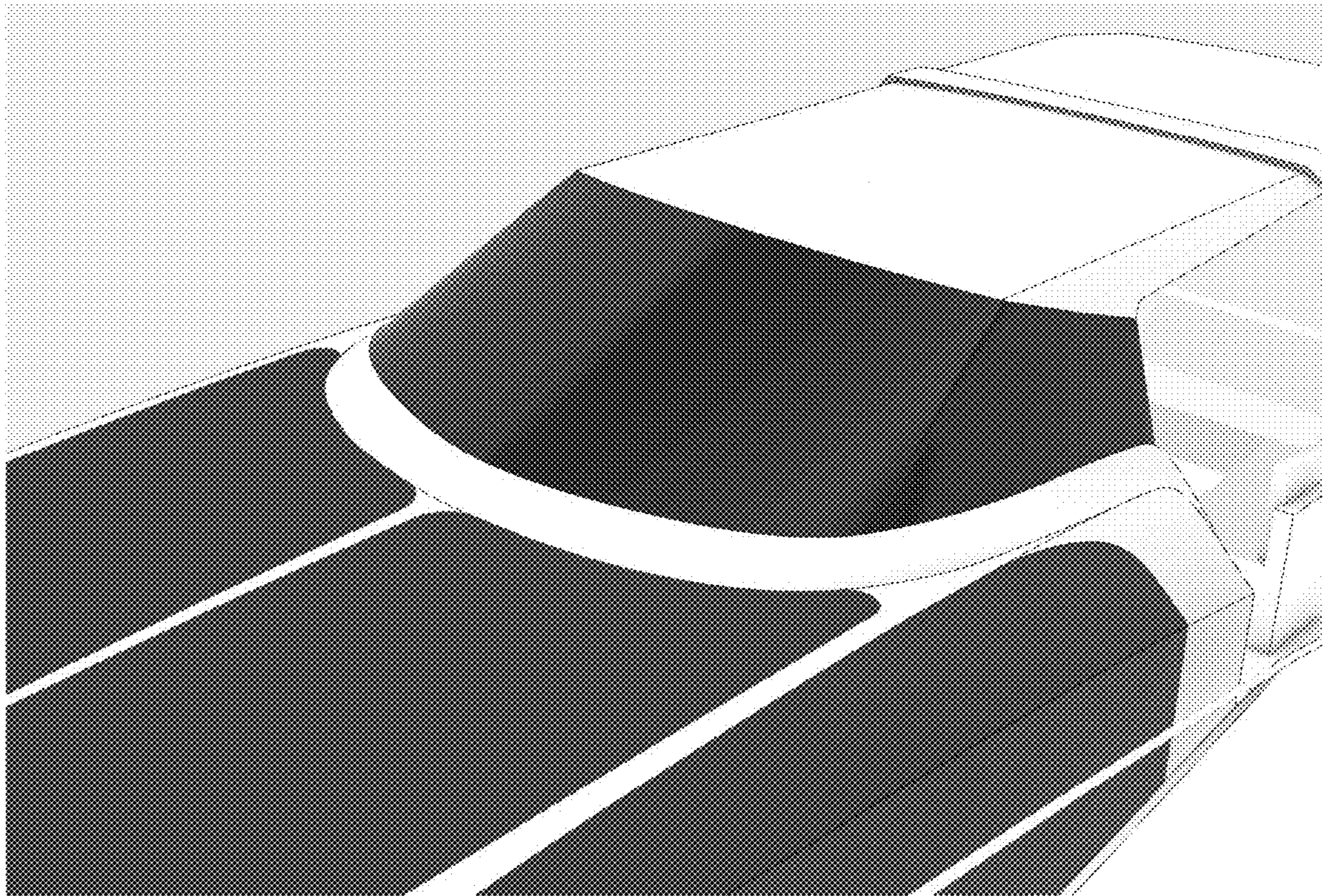

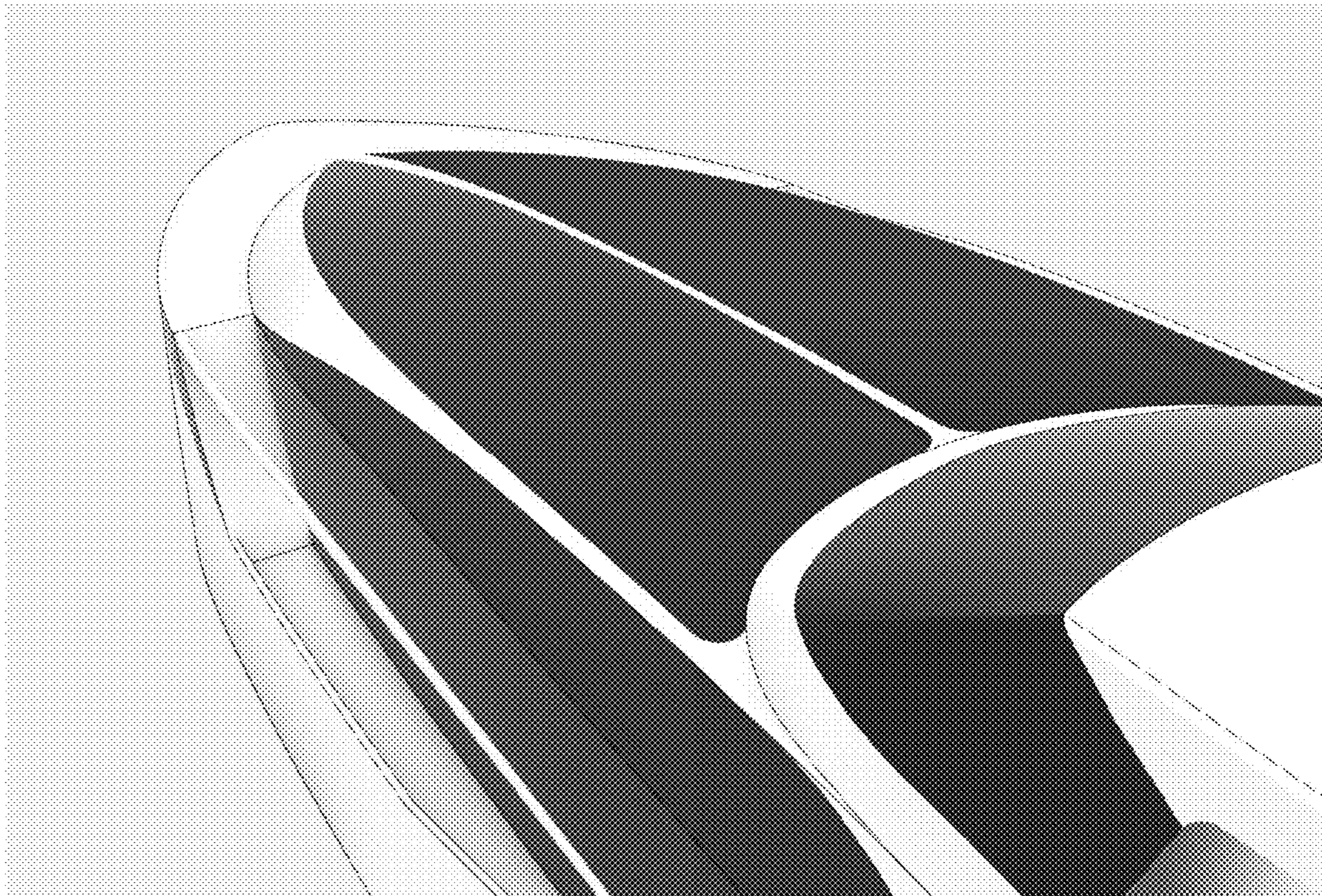

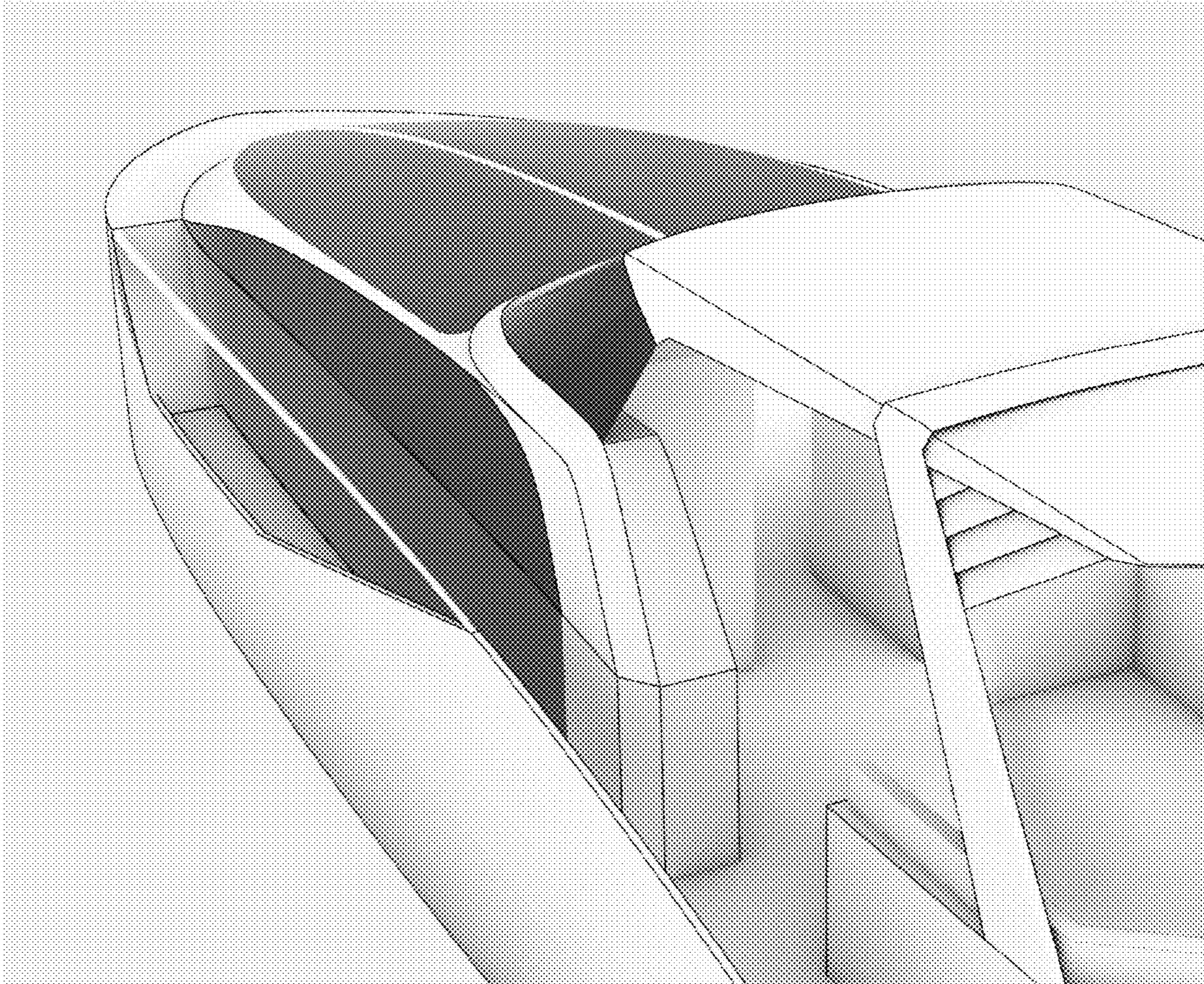
