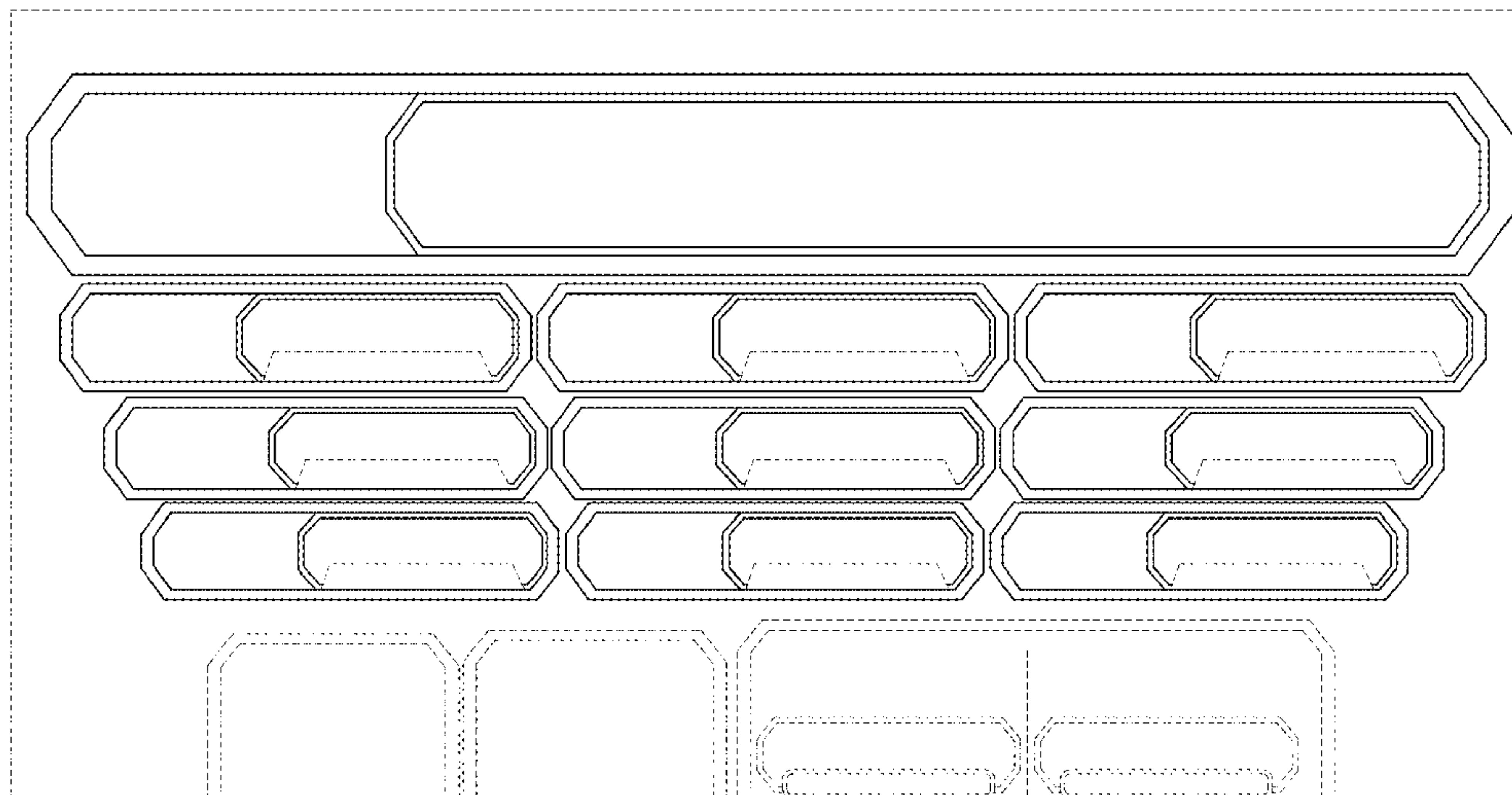
DESCRIPTION

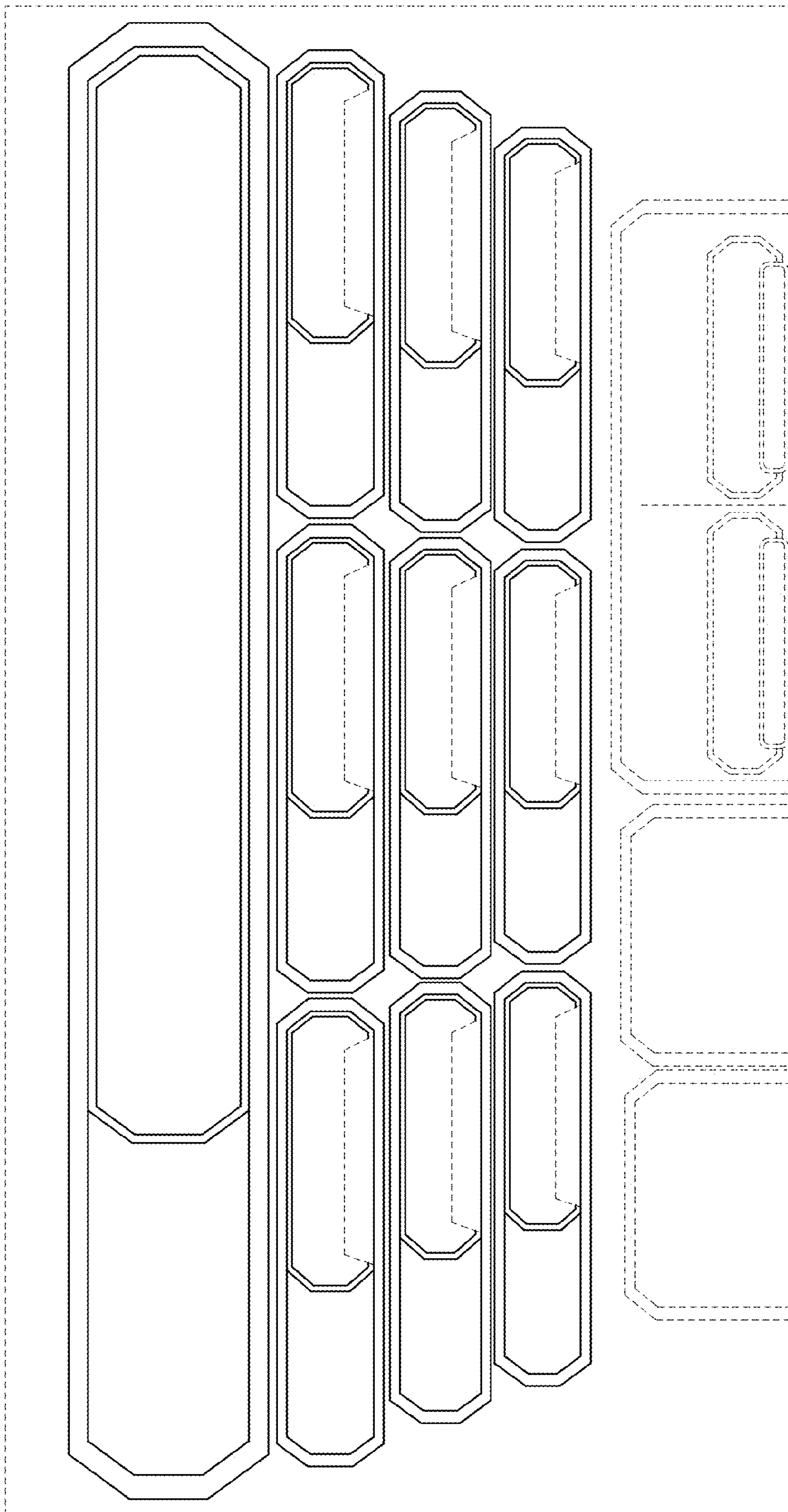

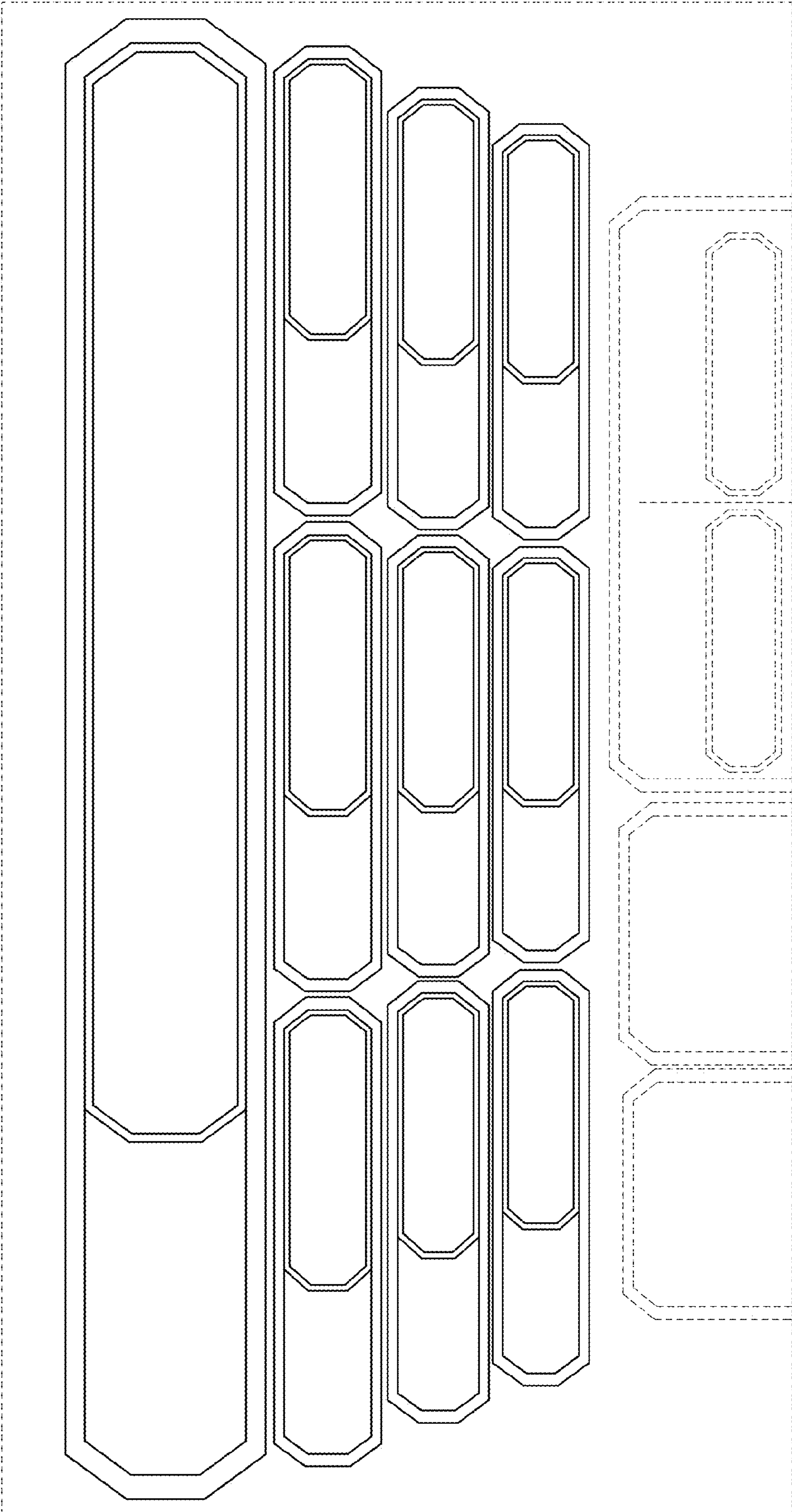

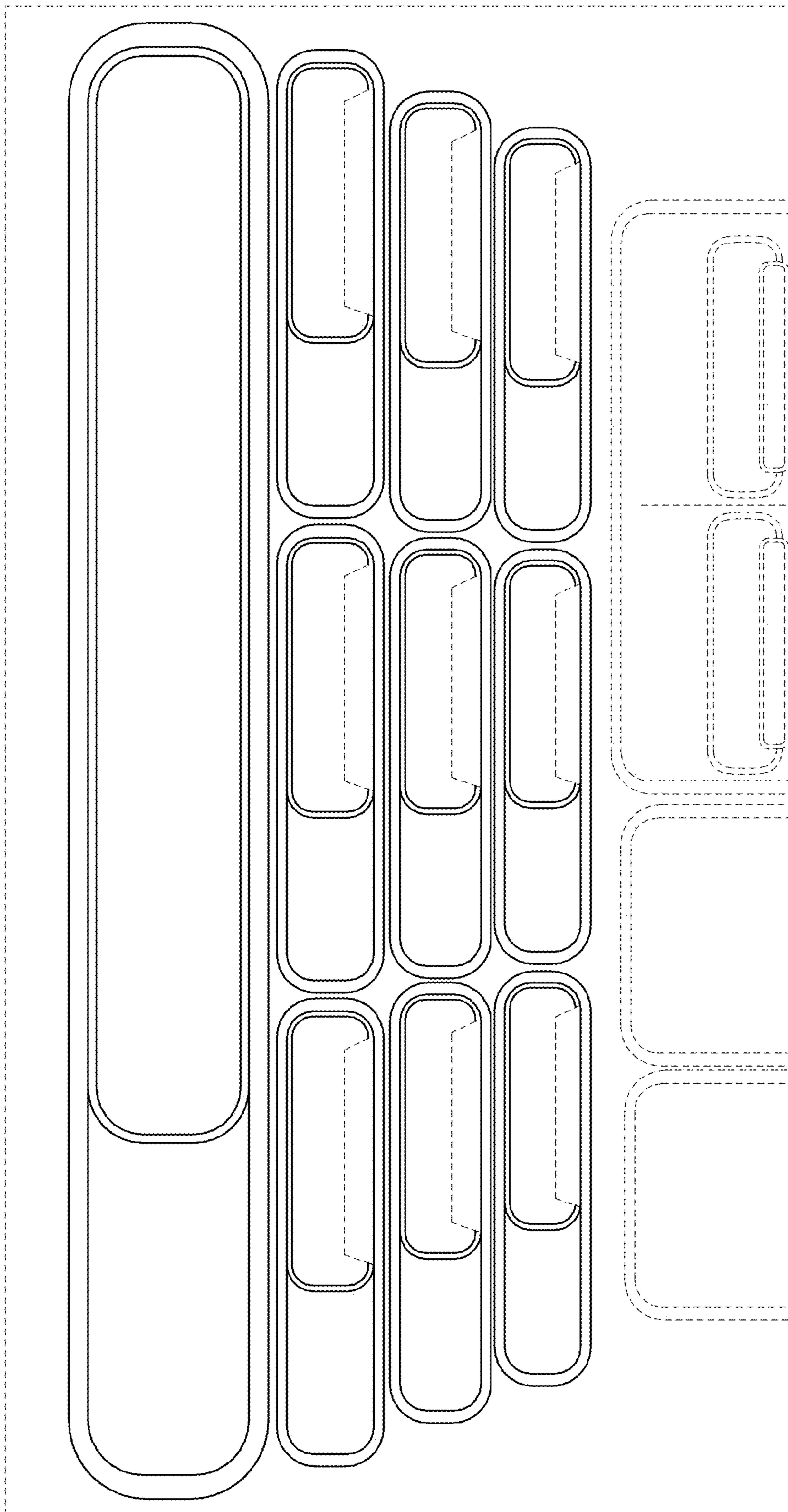

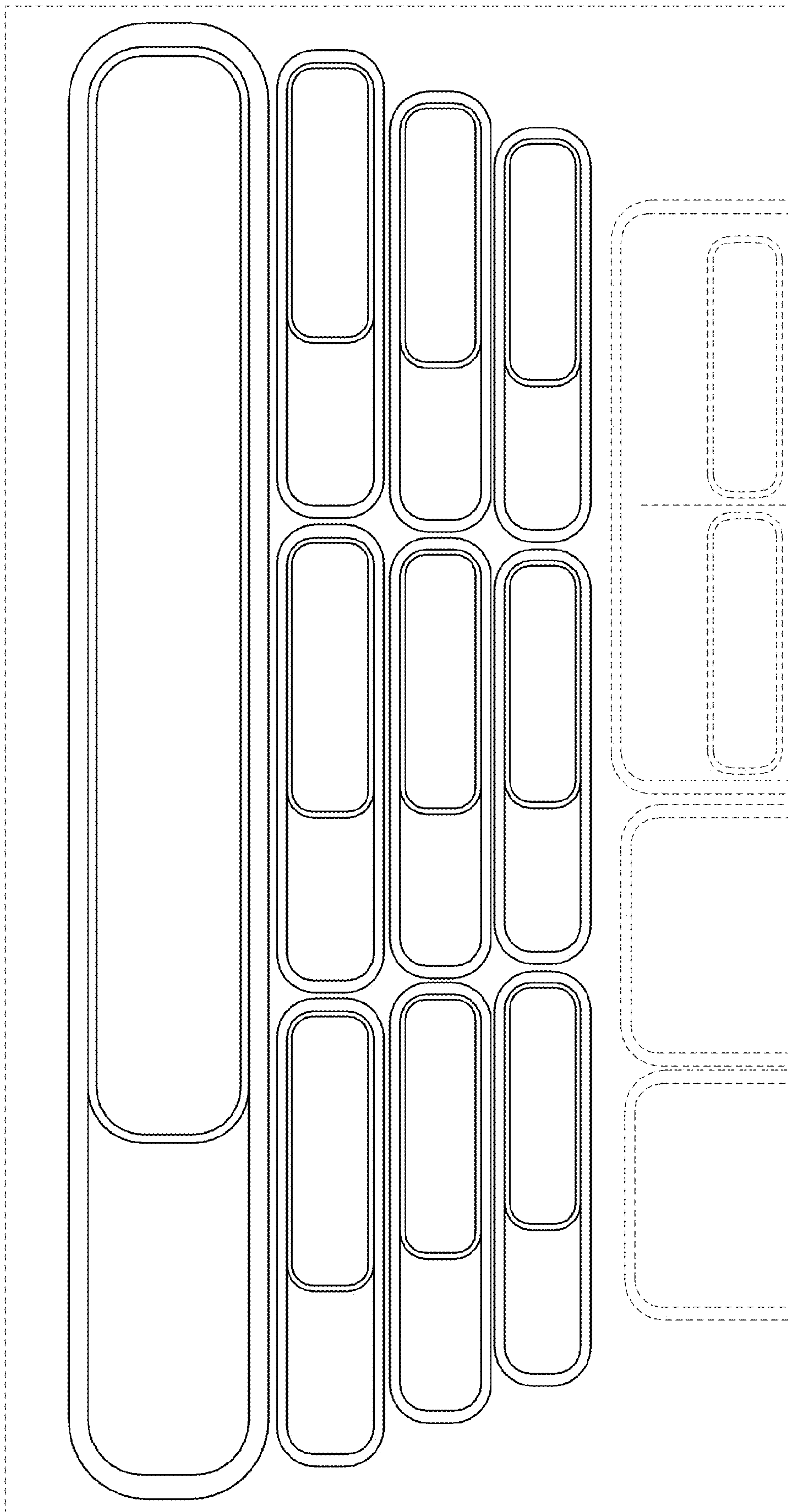

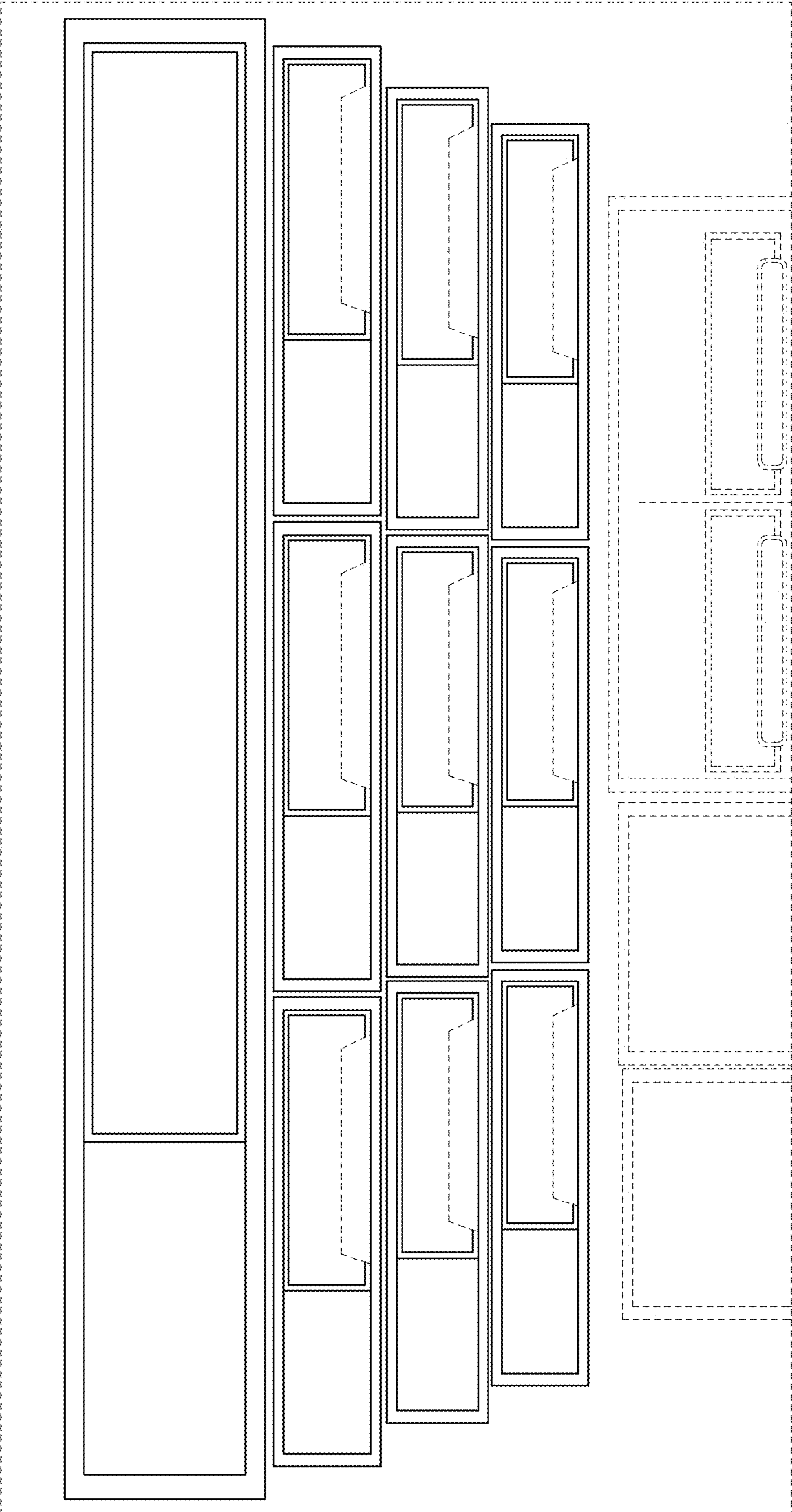

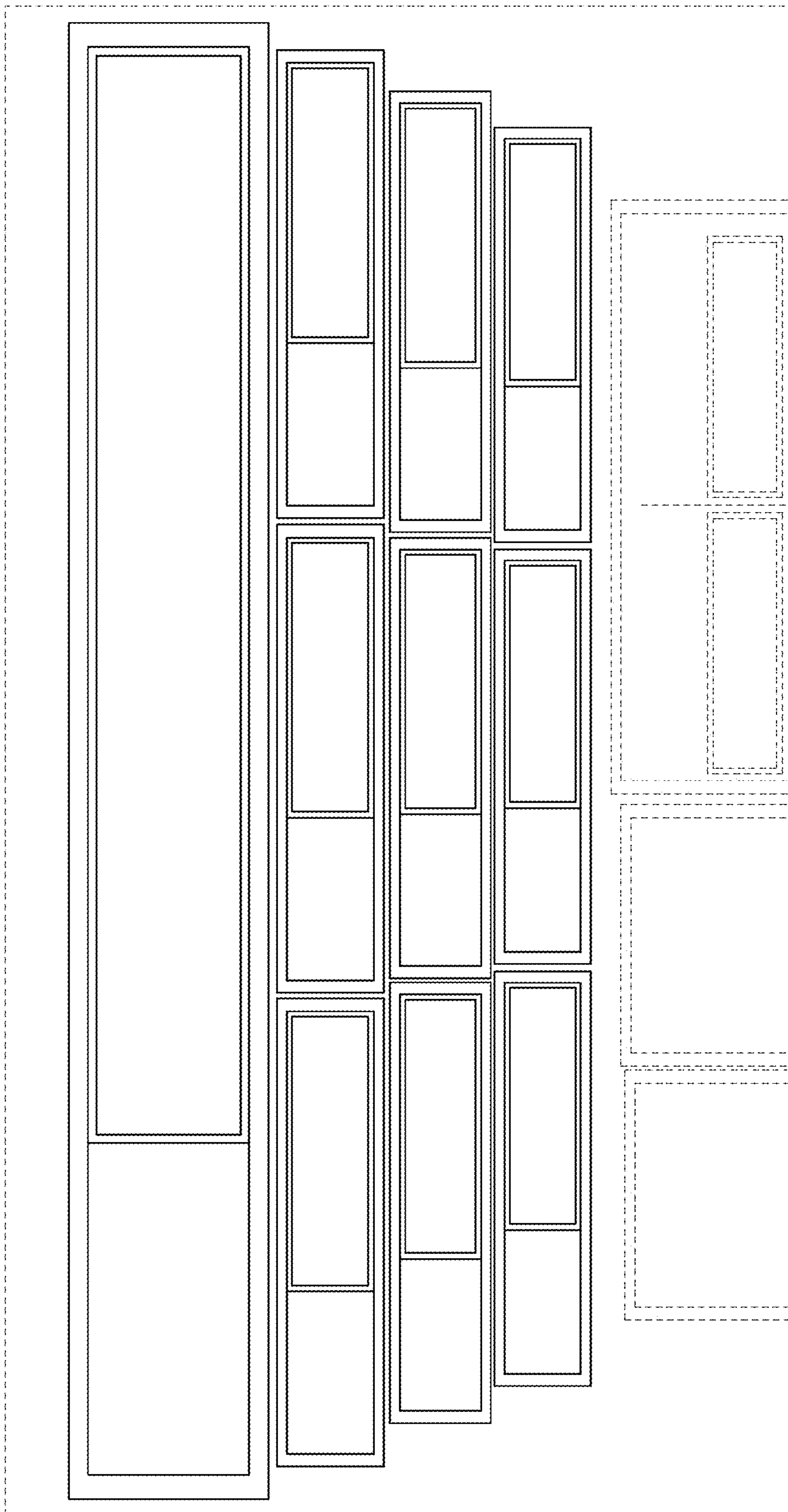

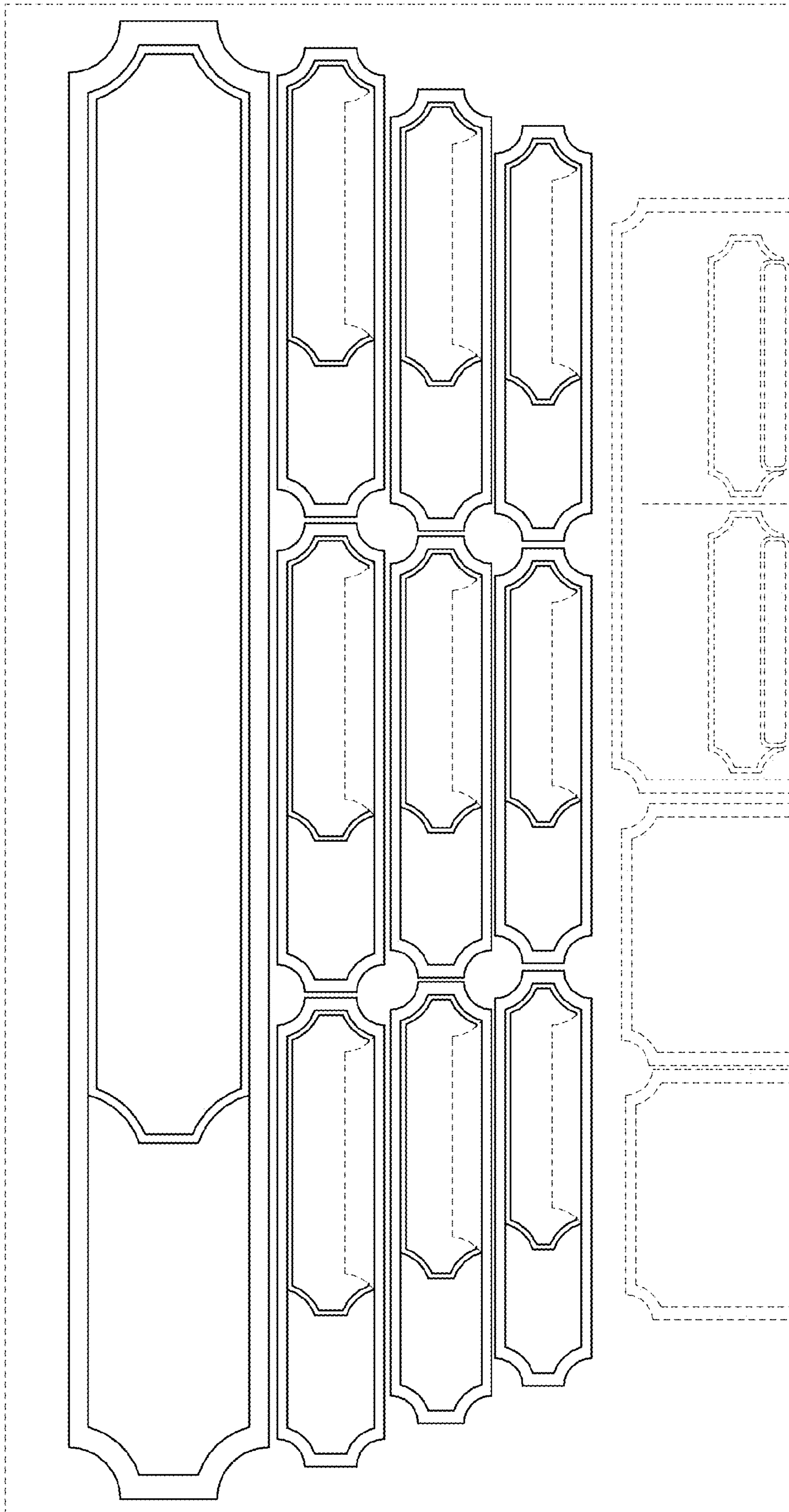

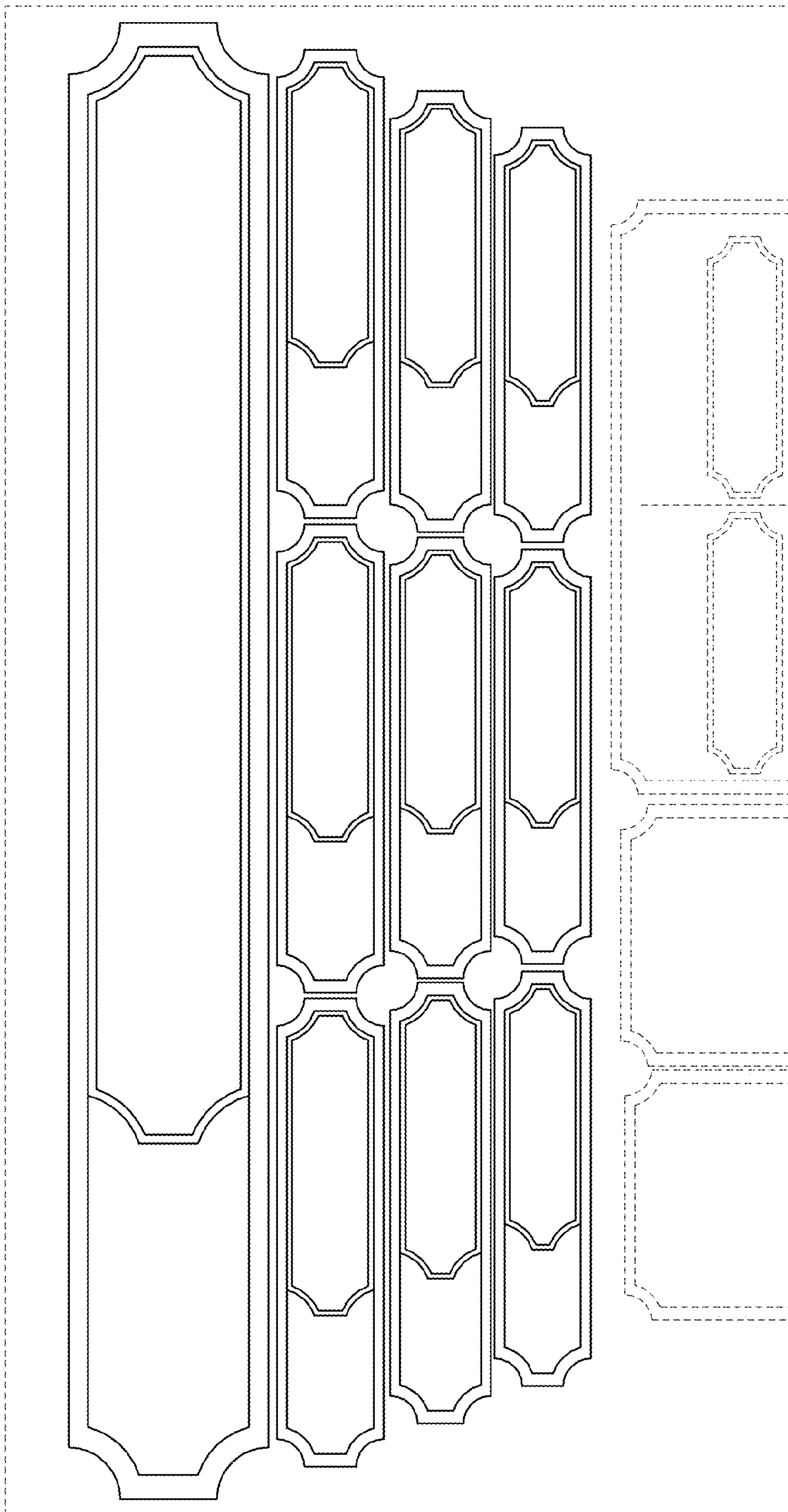
