DESCRIPTION

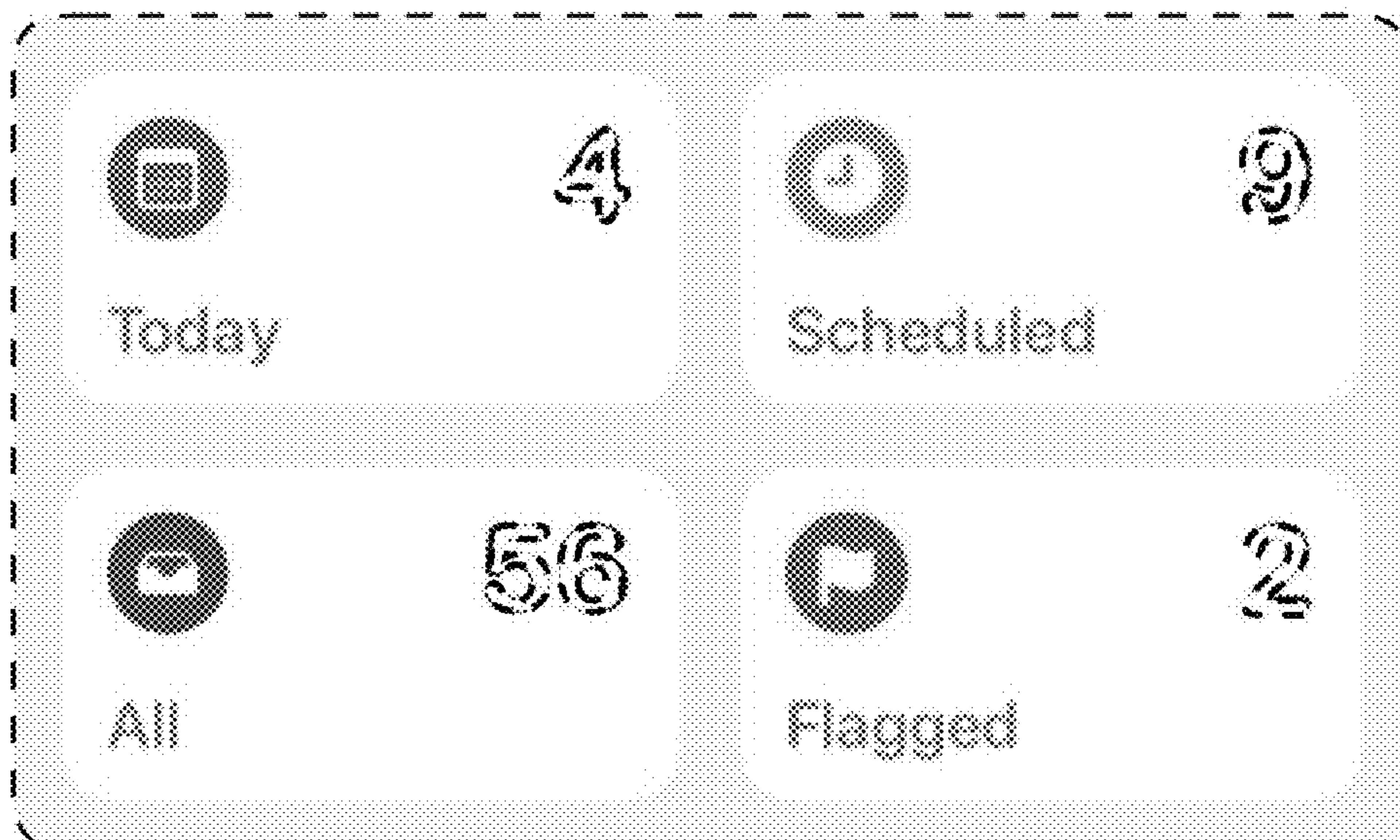

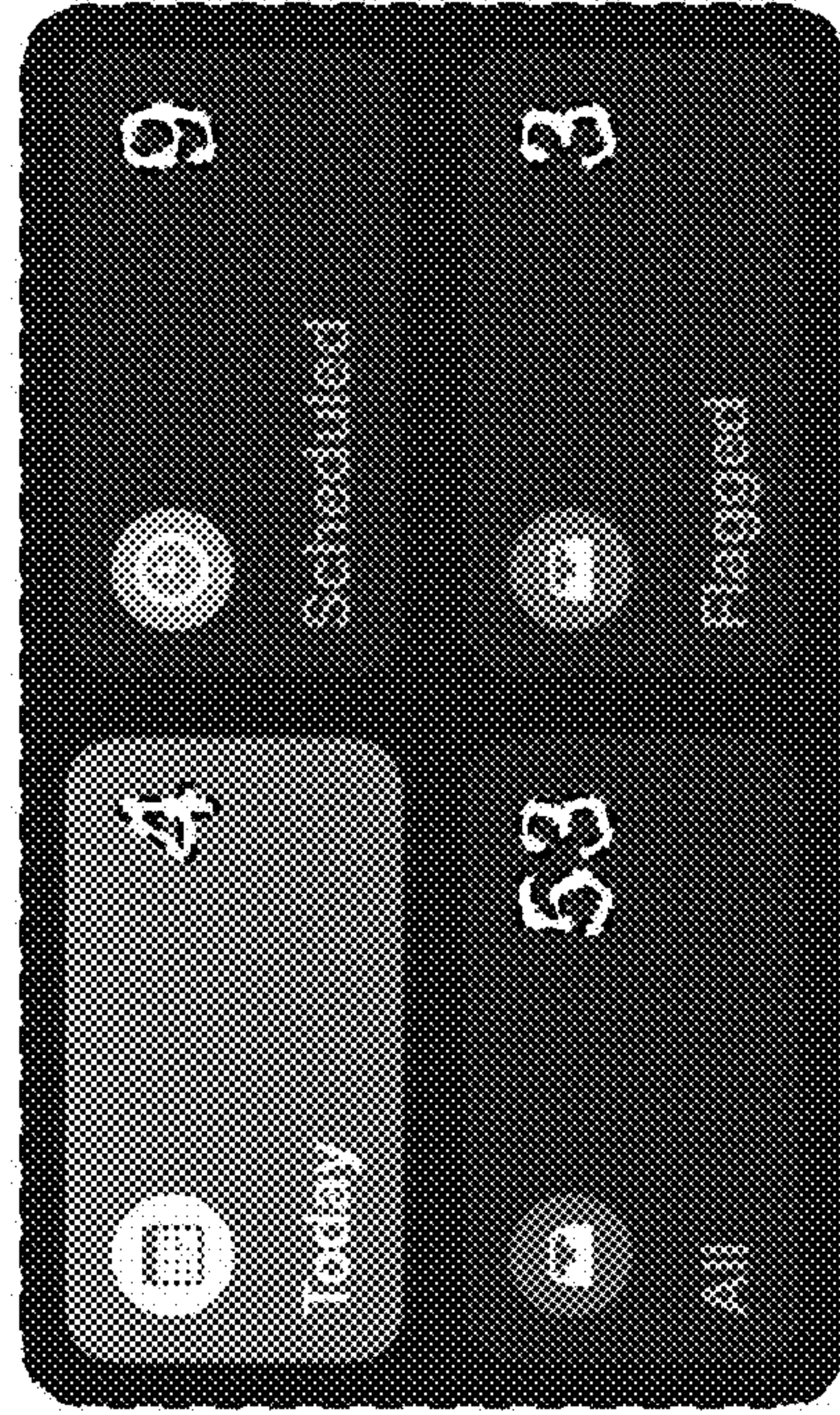

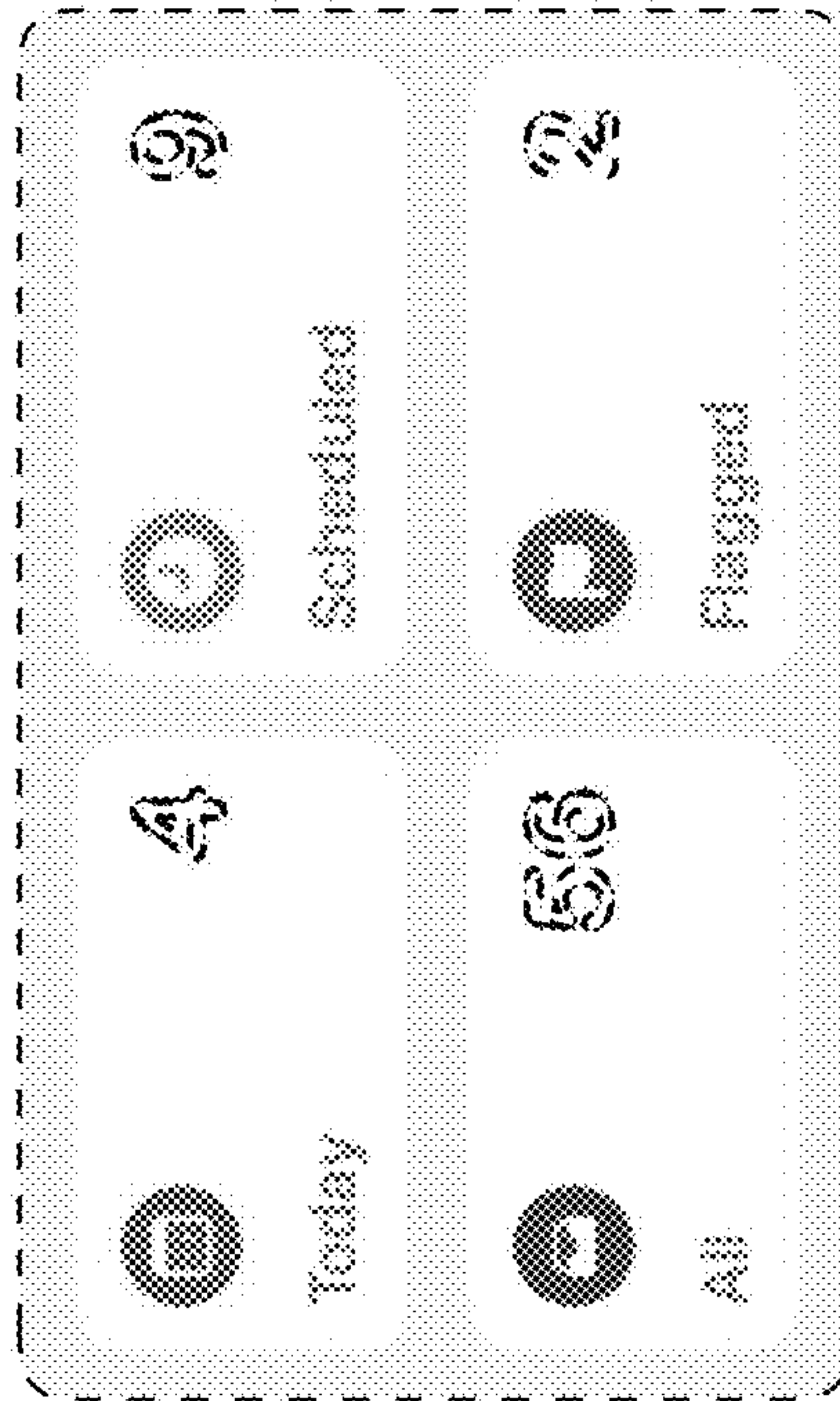
