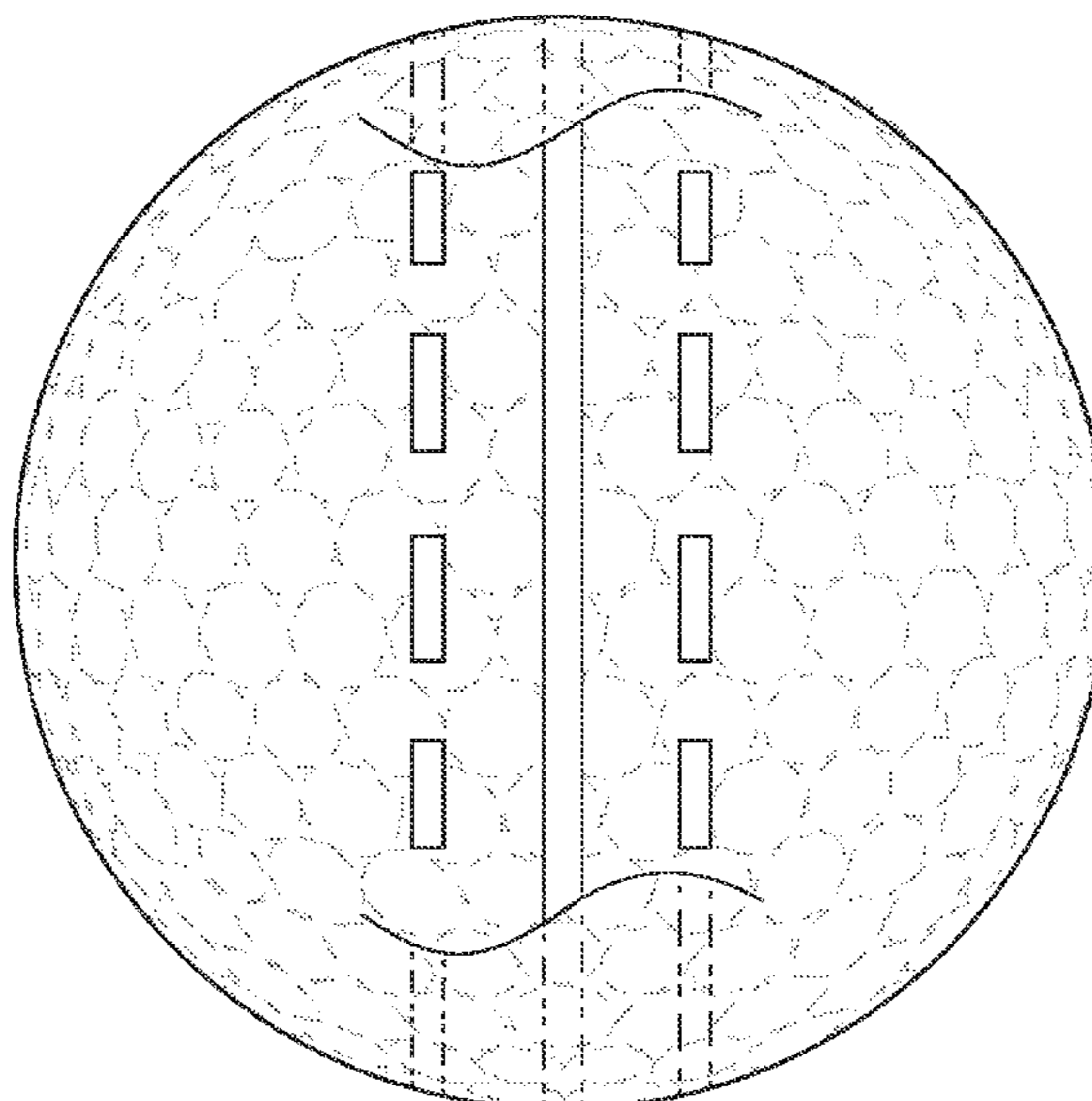
(57) **CLAIM**

The ornamental design for a golf ball, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of our new design for a golf ball with a solid line partially around a circumference of the golf ball with two parallel dashed lines;  
FIG. 2 is top plan view thereof;  
FIG. 3 is a front elevation view thereof;  
FIG. 4 is a bottom plan view thereof;  
FIG. 5 is another top plan view provided with indicia showing the area of enlargement in FIG. 6; and,  
FIG. 6 is an enlarged view of the area denoted by circle 6 of FIG. 5.  
The broken lines denoting the circumscribed area in FIG. 5 and depicting circular and linear surface details are for illustrative purposes only; and form no part of the claimed design.

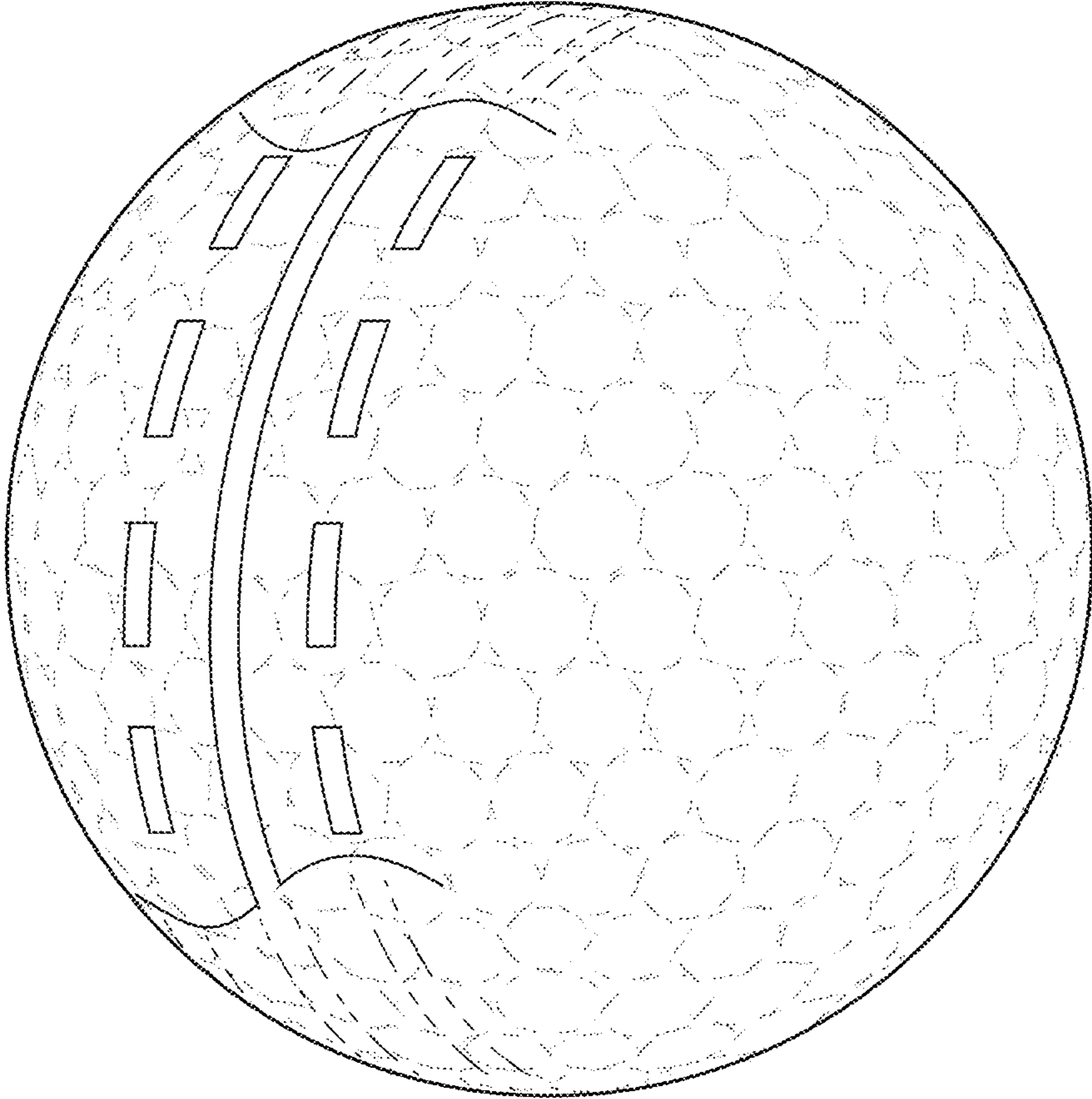

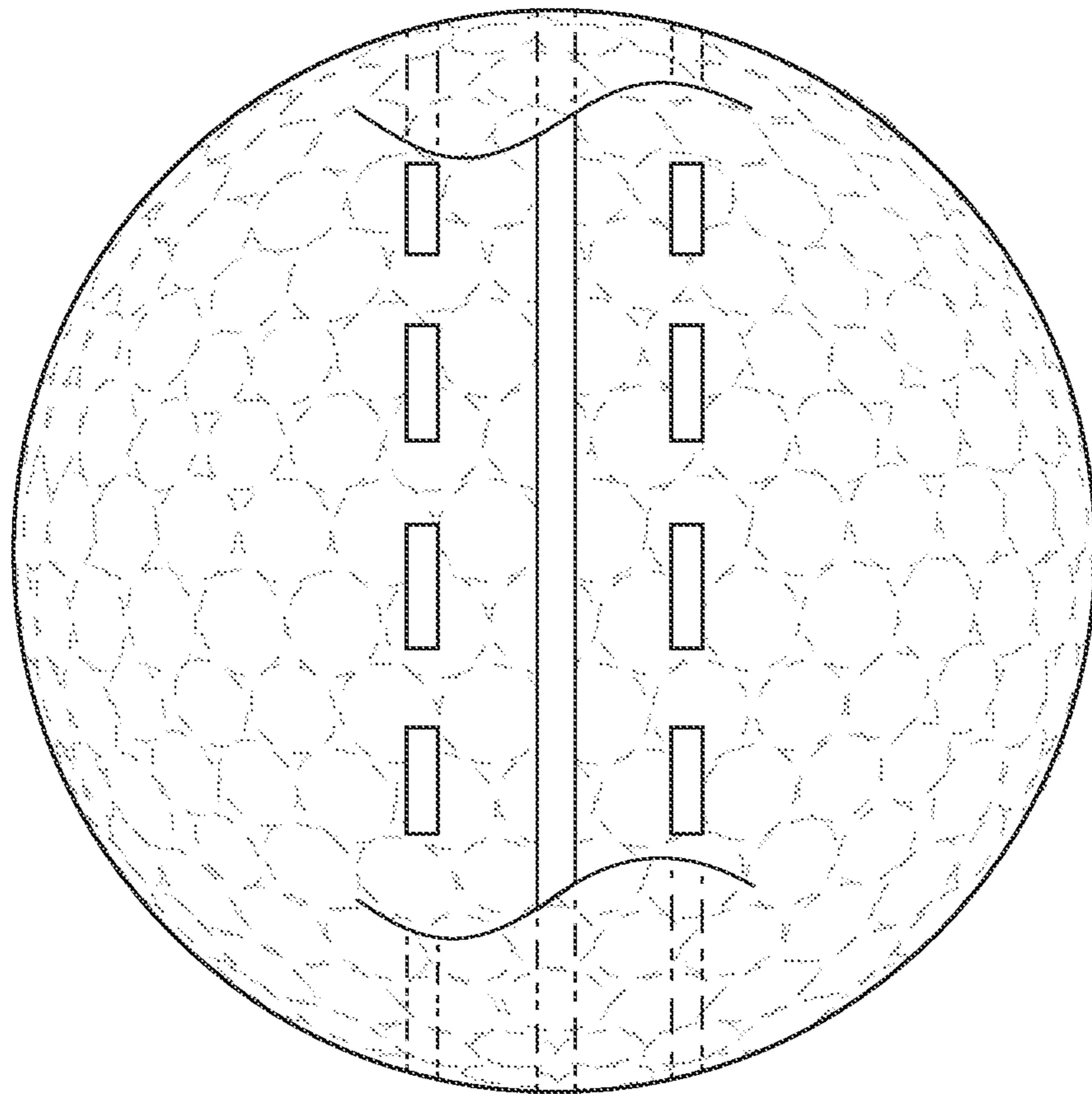

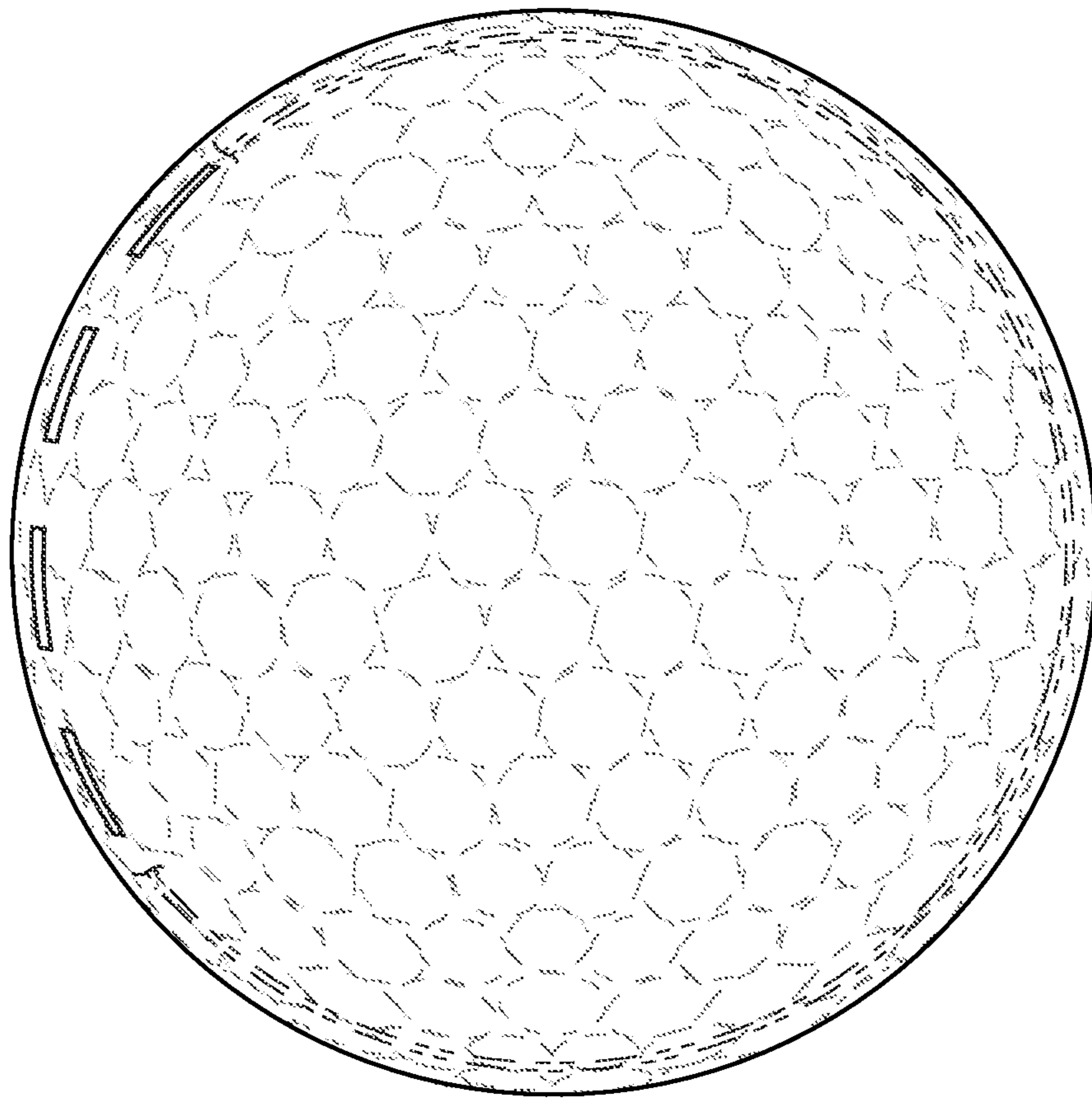

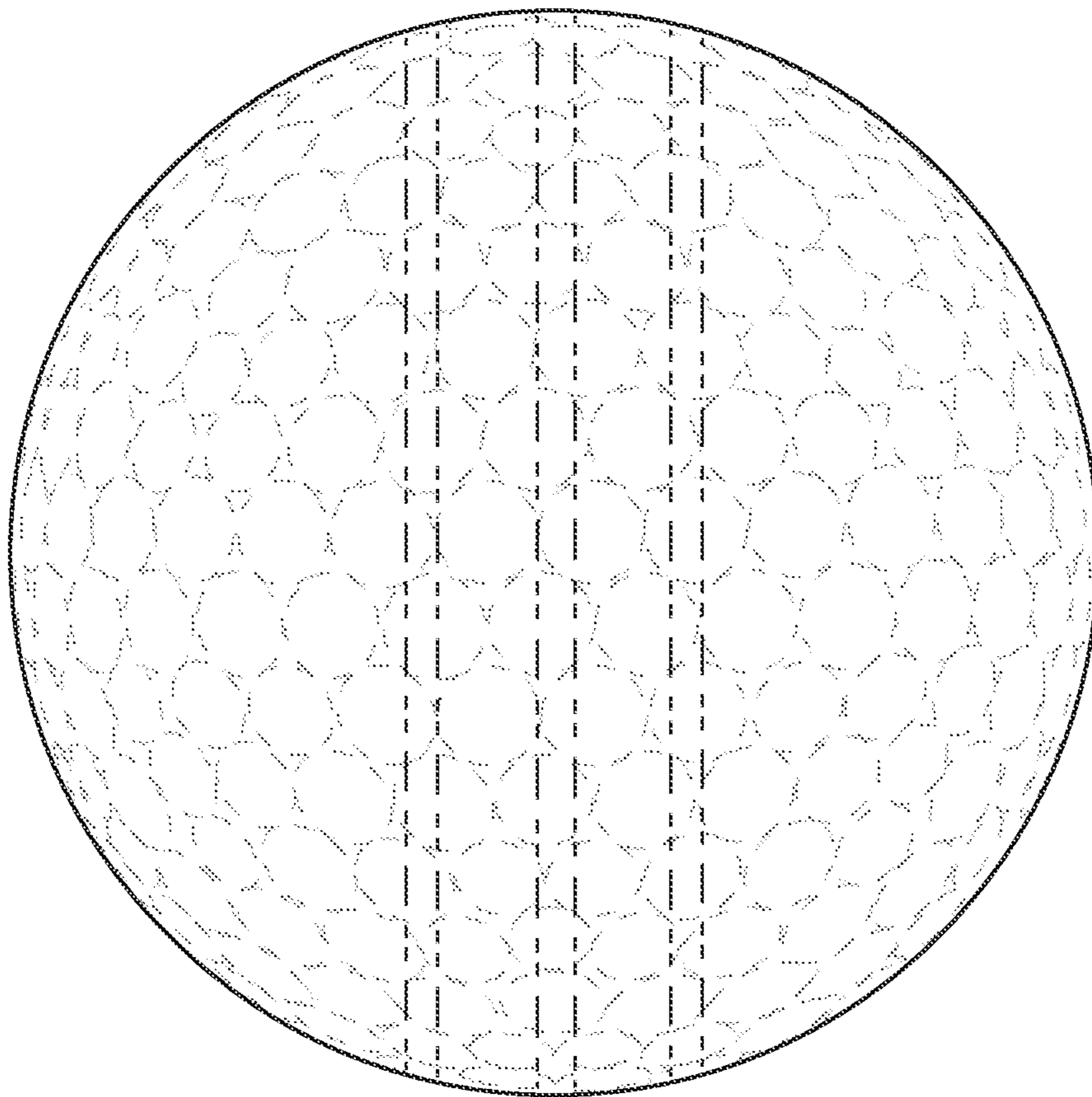

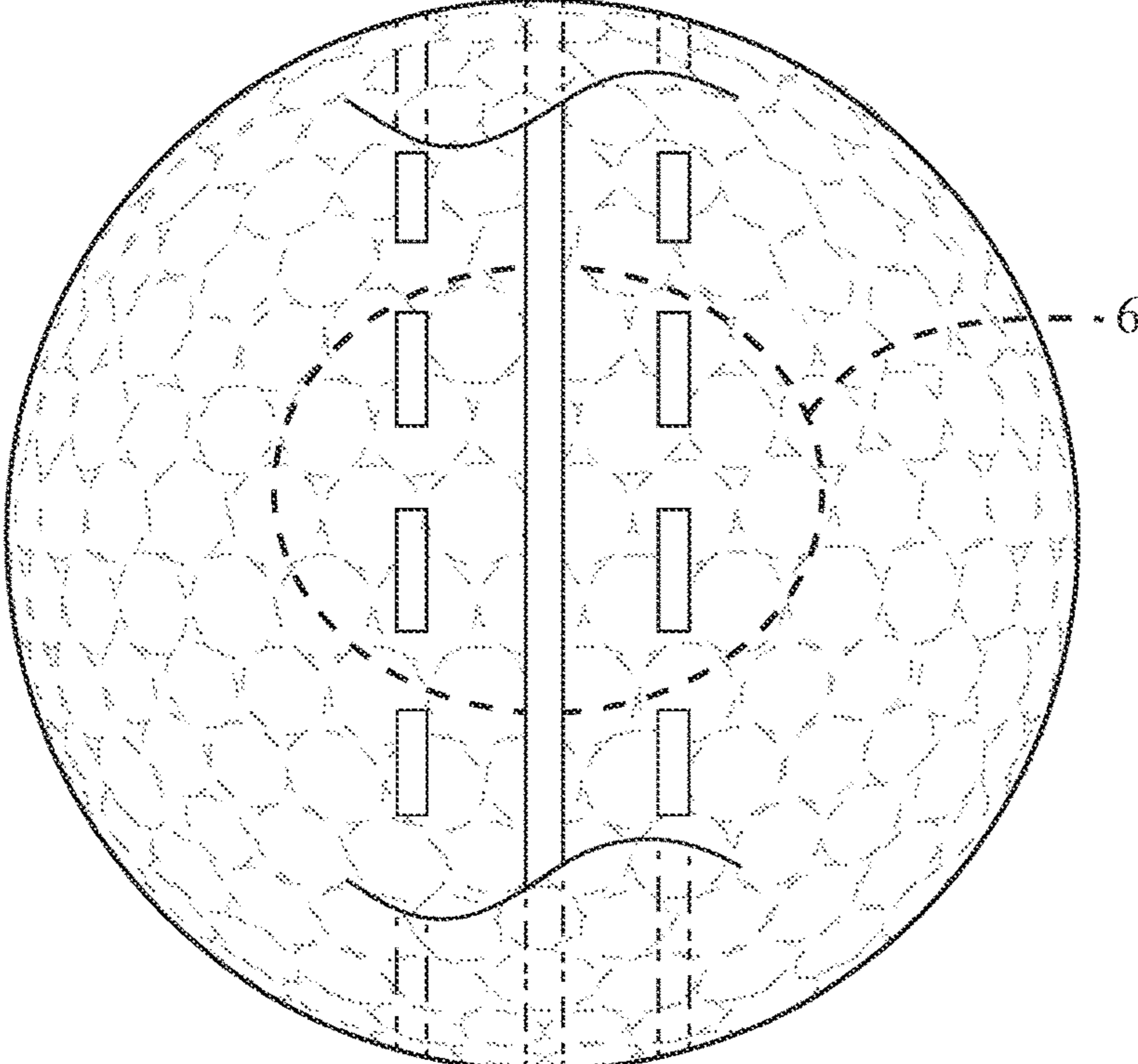

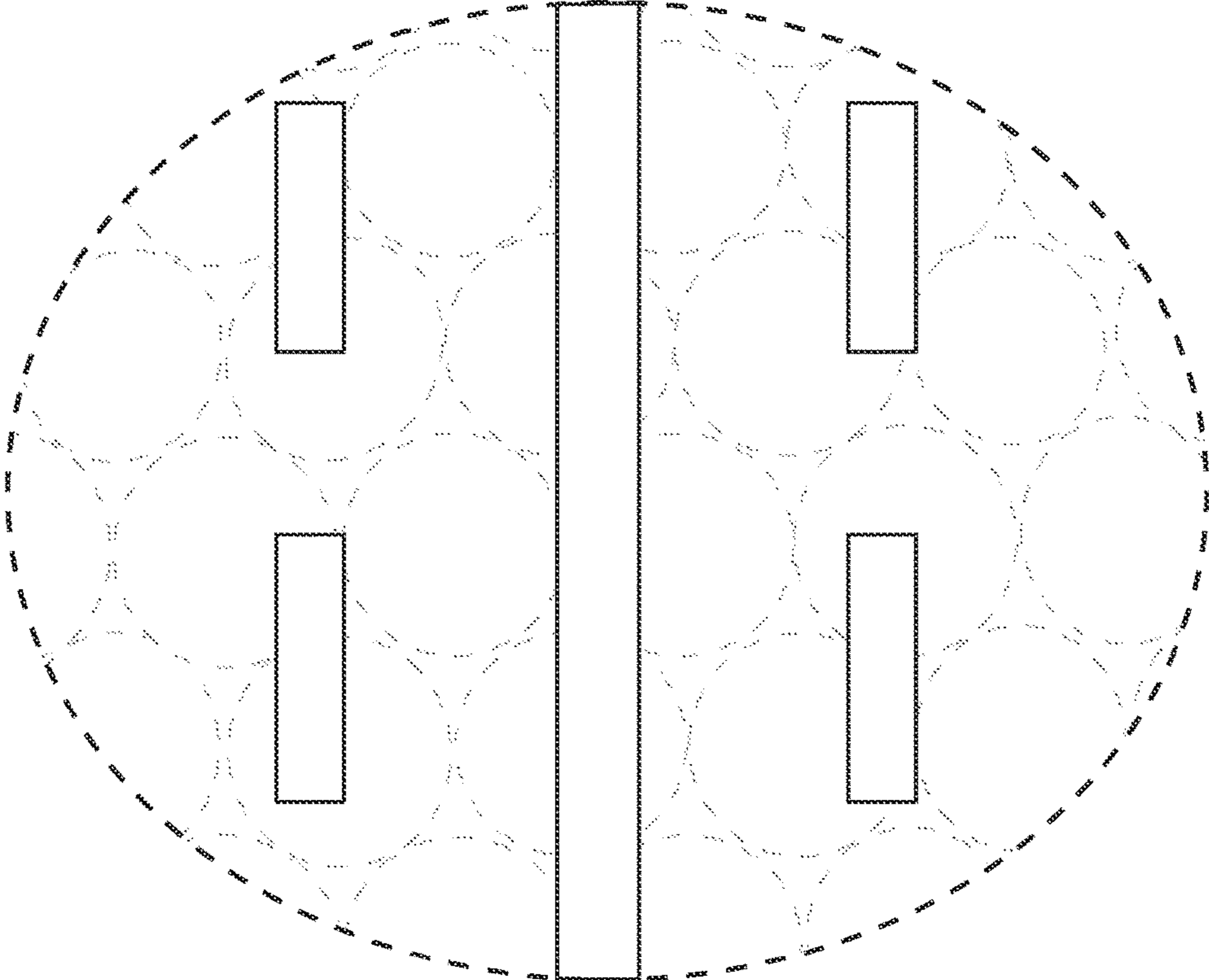
