DESCRIPTION

FIG. 1 is a perspective view of a vital injector showing my new design;

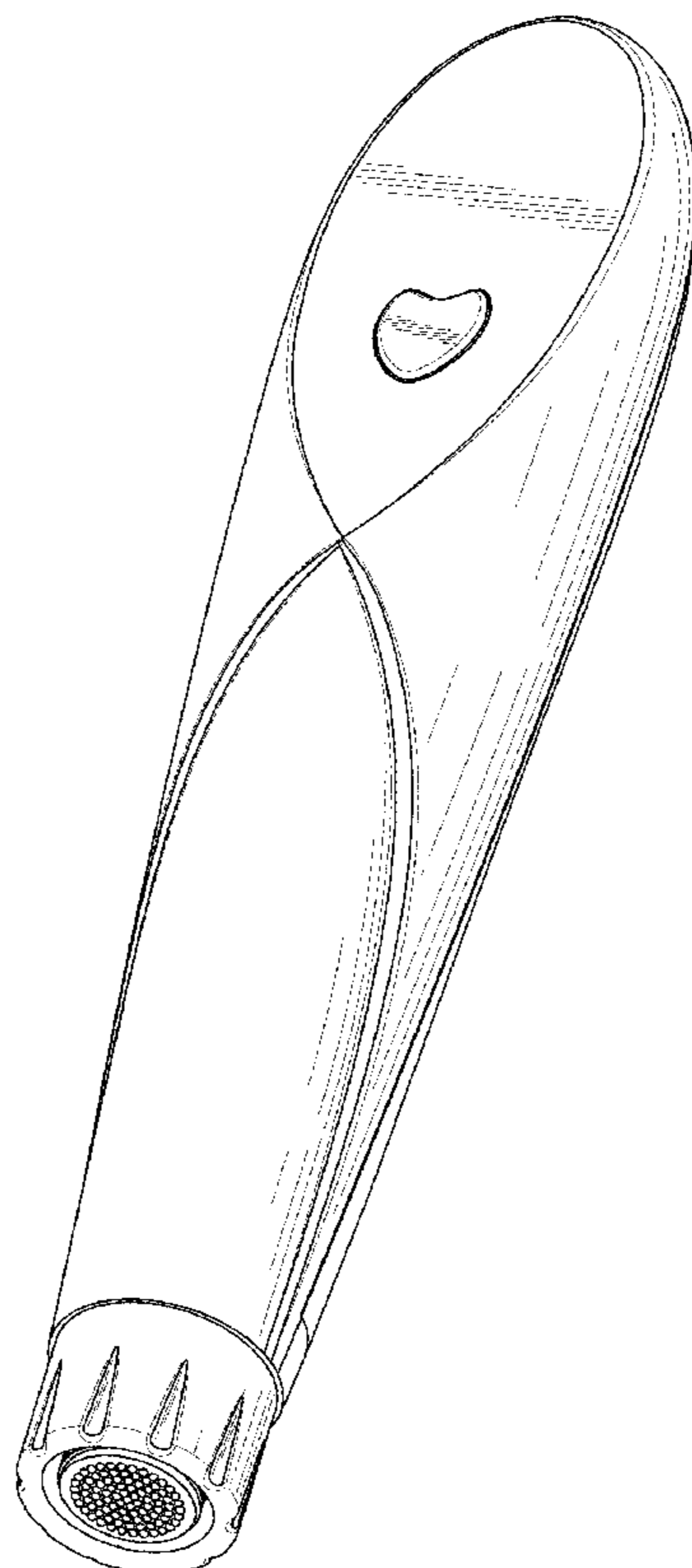

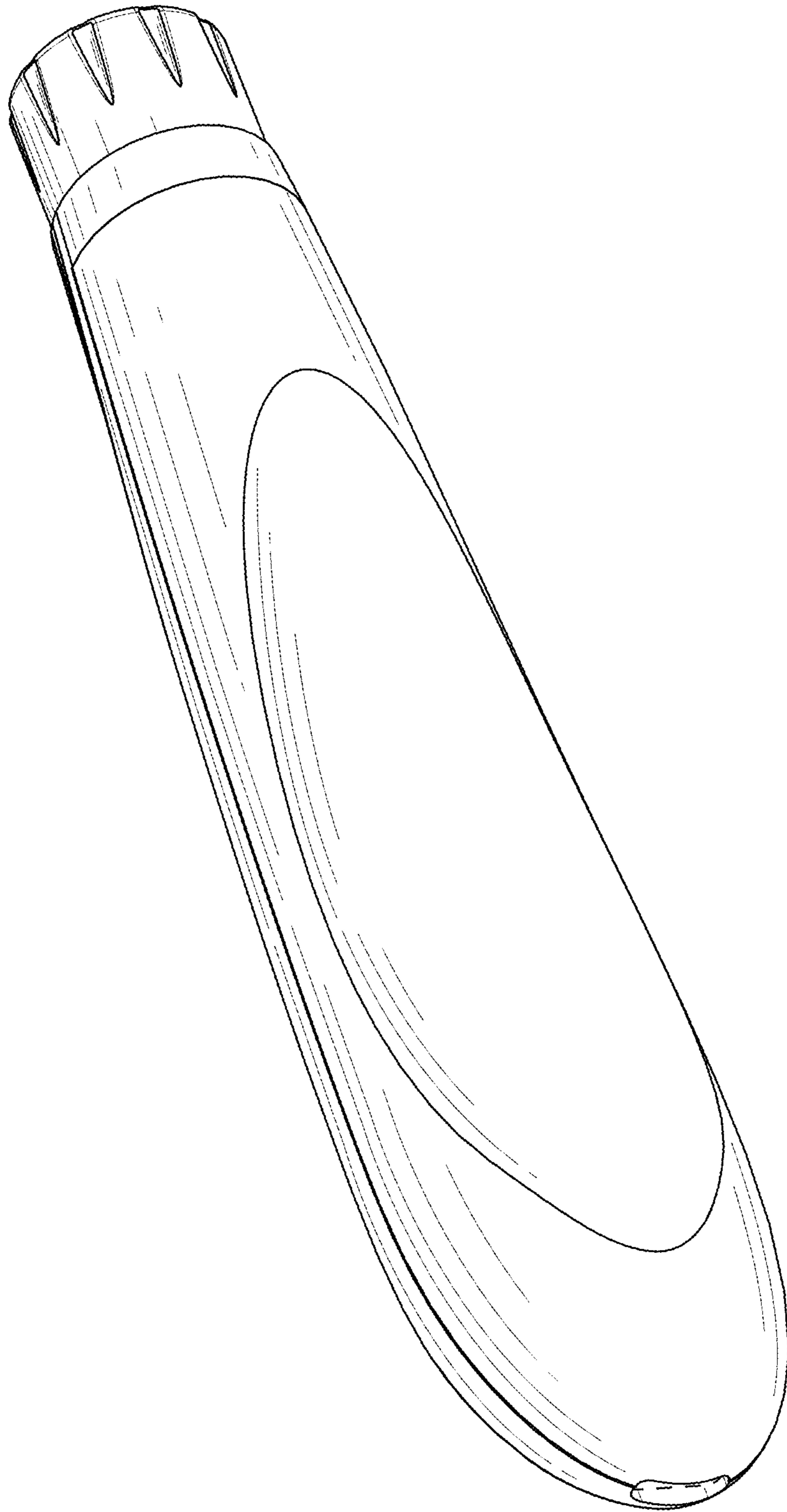

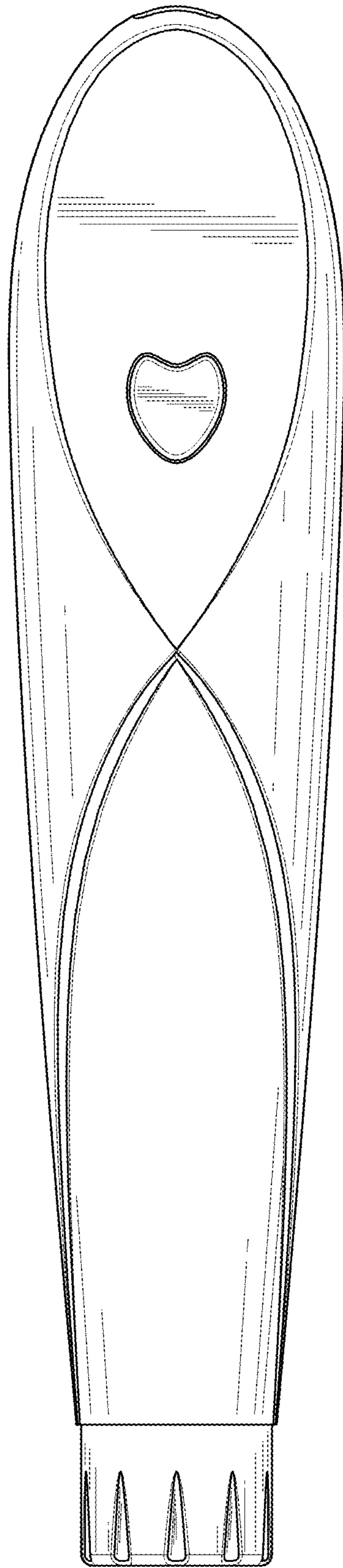

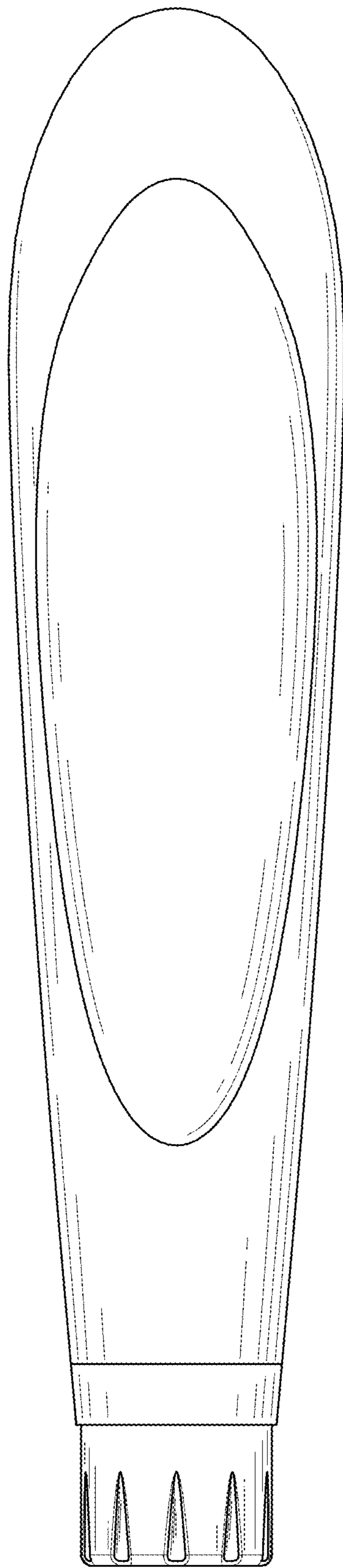

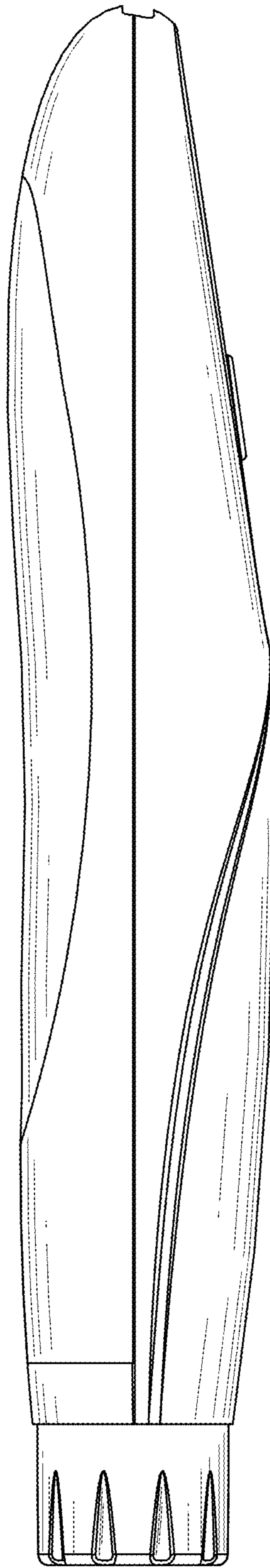

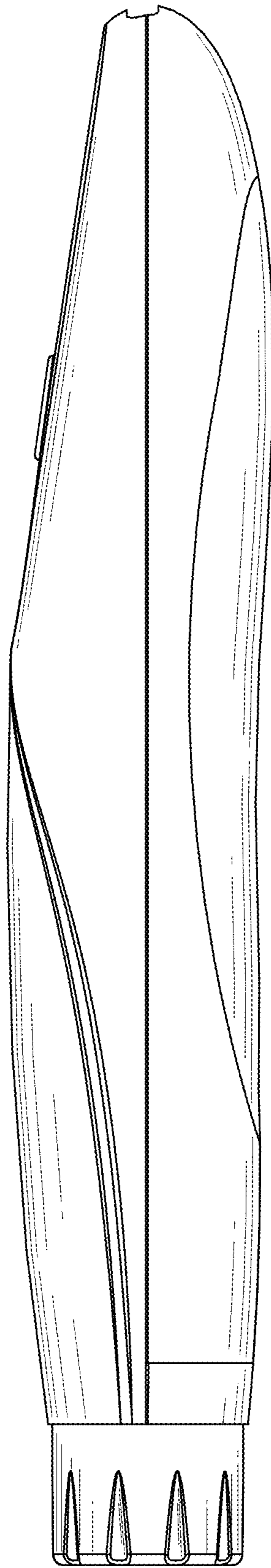

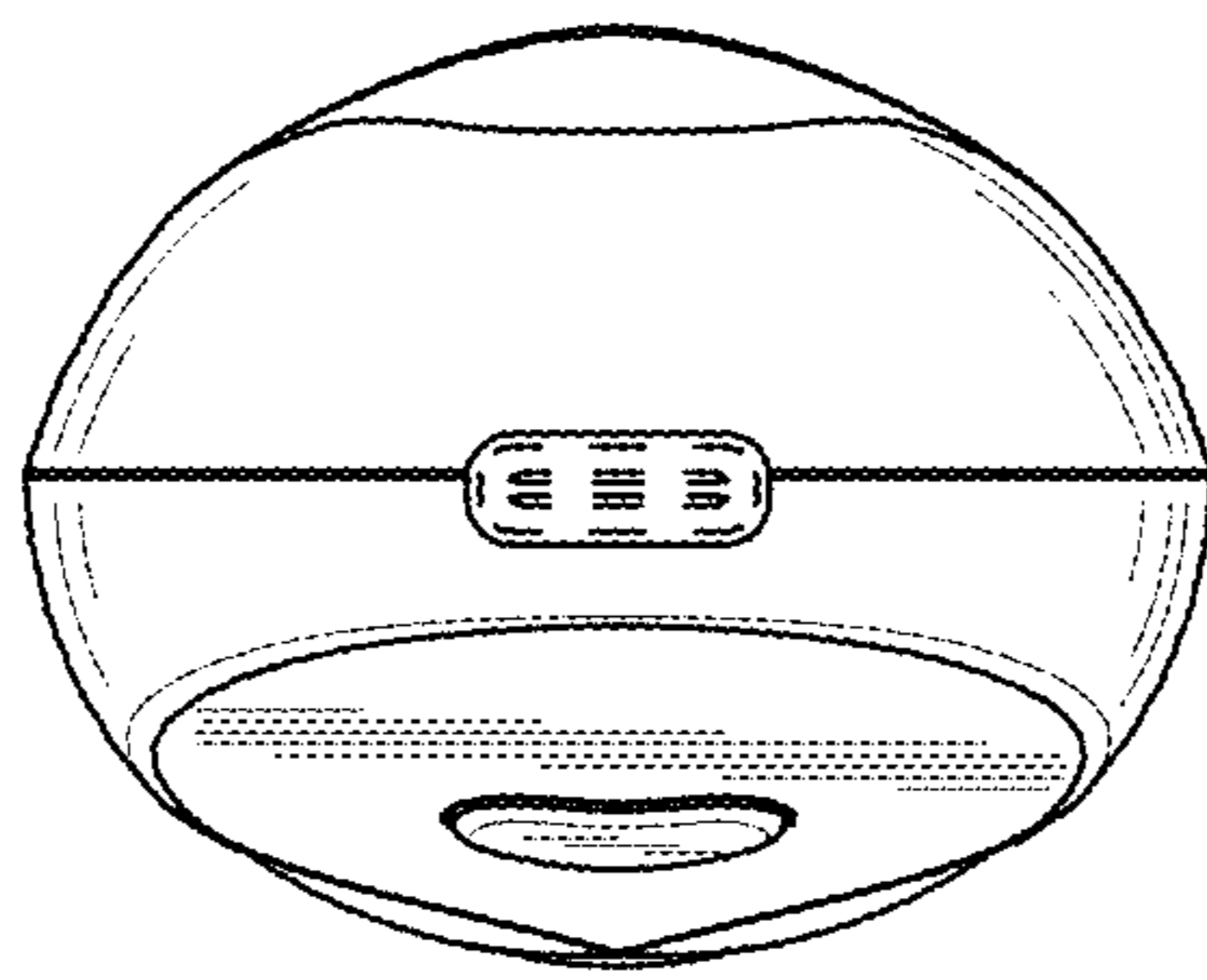

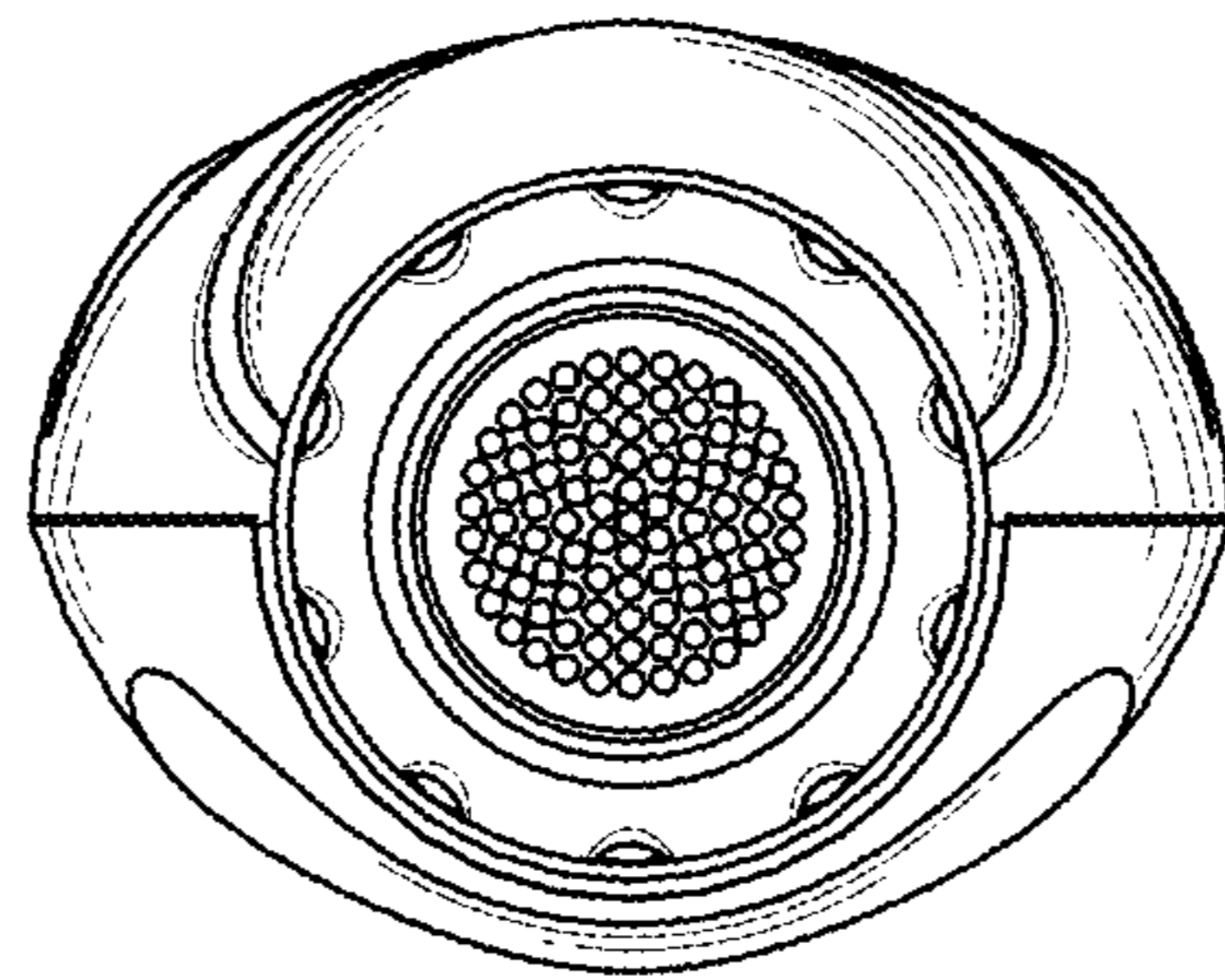
