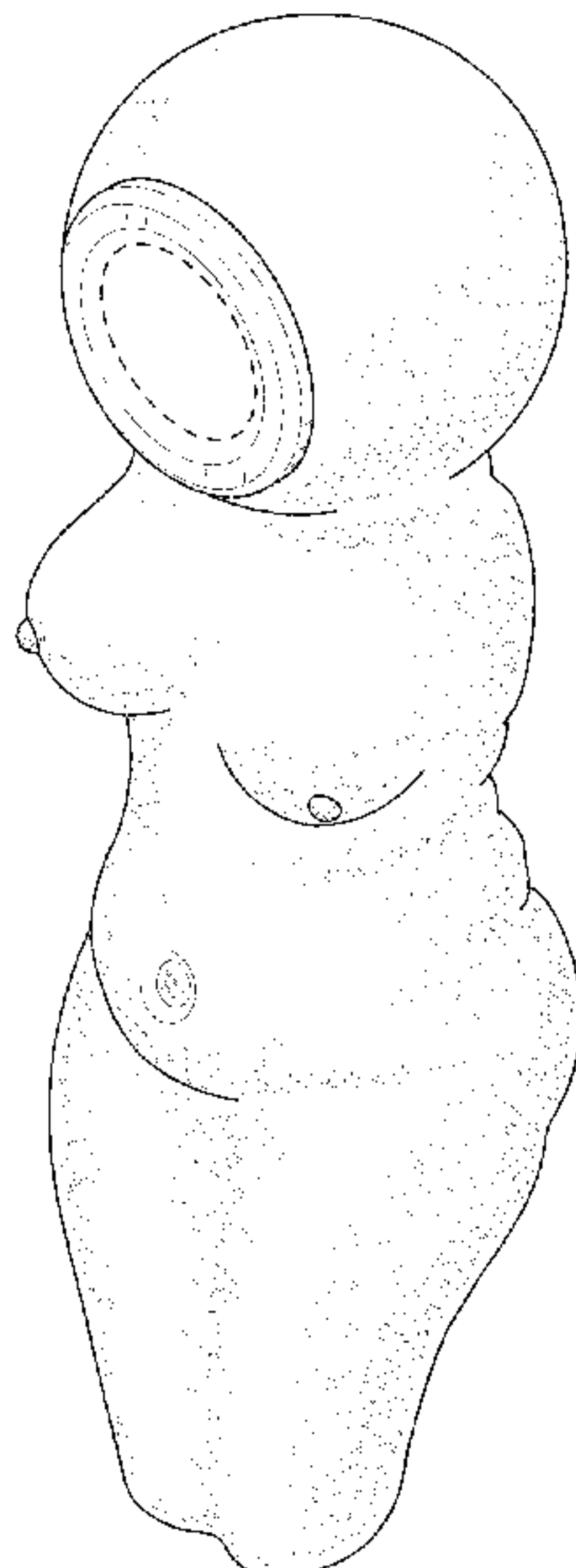
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front, right, and top perspective view of a pipe, showing my design.
FIG. 2 is a front elevation view thereof.
FIG. 3 is a rear elevation view thereof.
FIG. 4 is a left side elevation view thereof.
FIG. 5 is a right side elevation view thereof.
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.
The broken lines shown in the drawings are included for the purpose of illustrating portions of the pipe that form no part of the claimed design.
The stippling used in the drawings is for purposes of illustrating a contrast in surface appearance only.

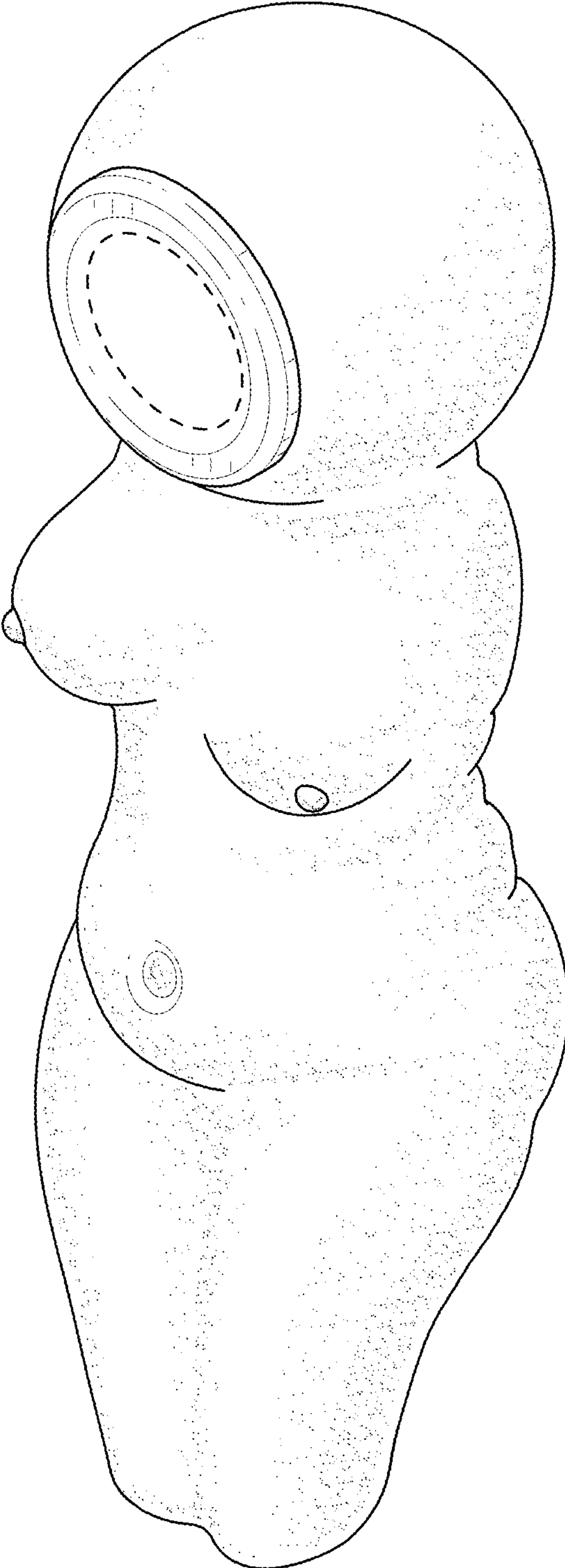

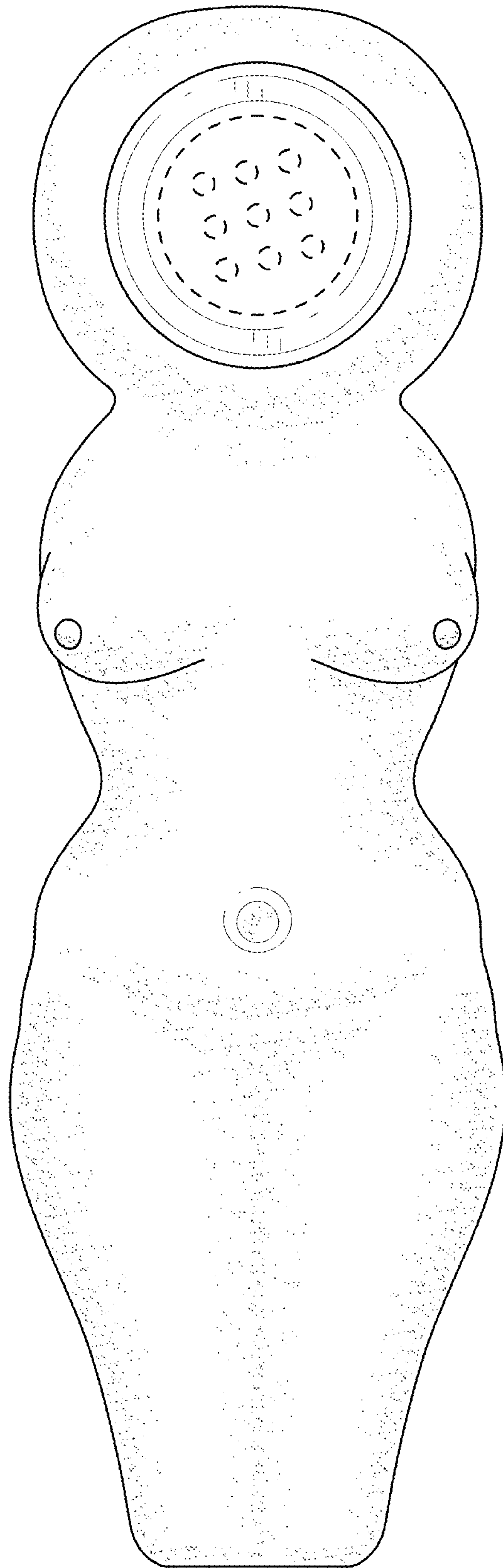

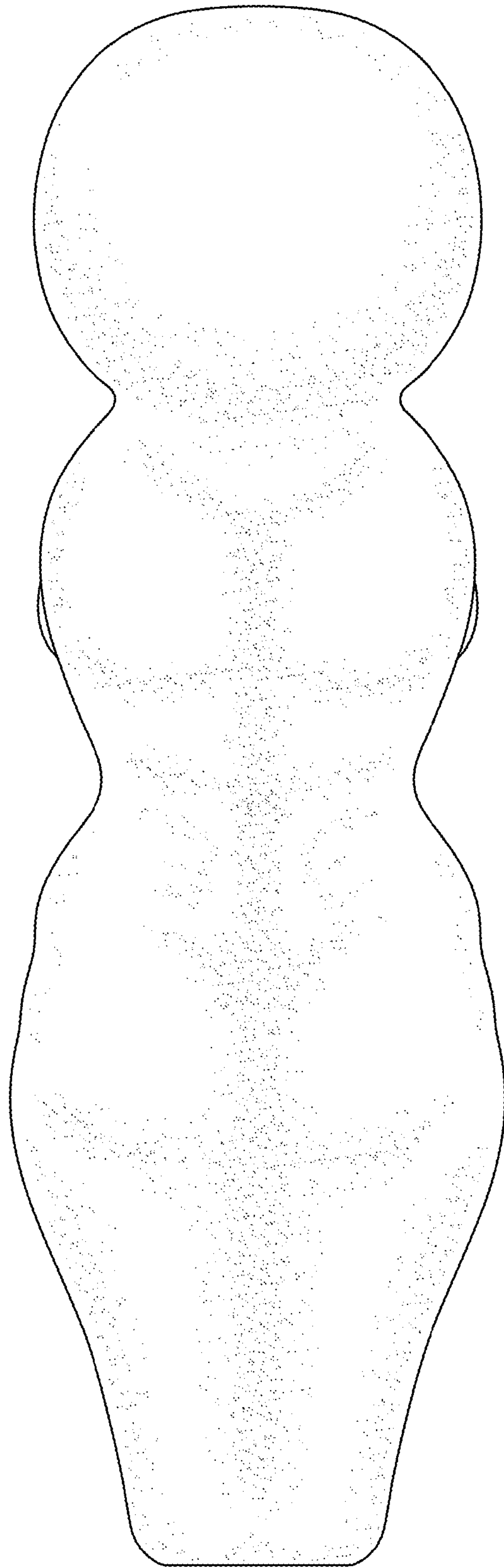

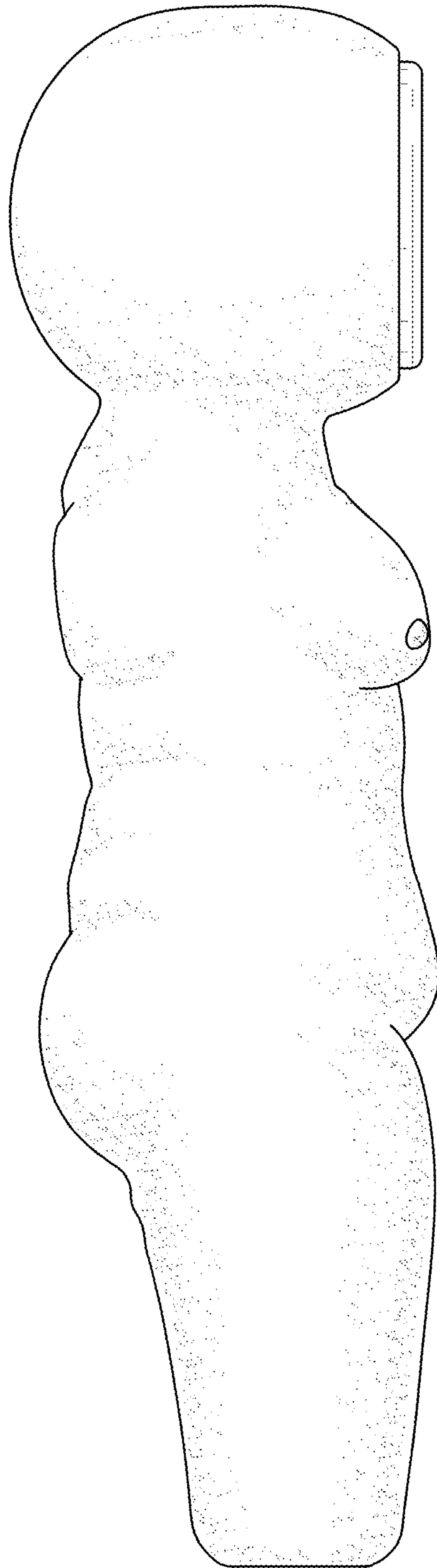

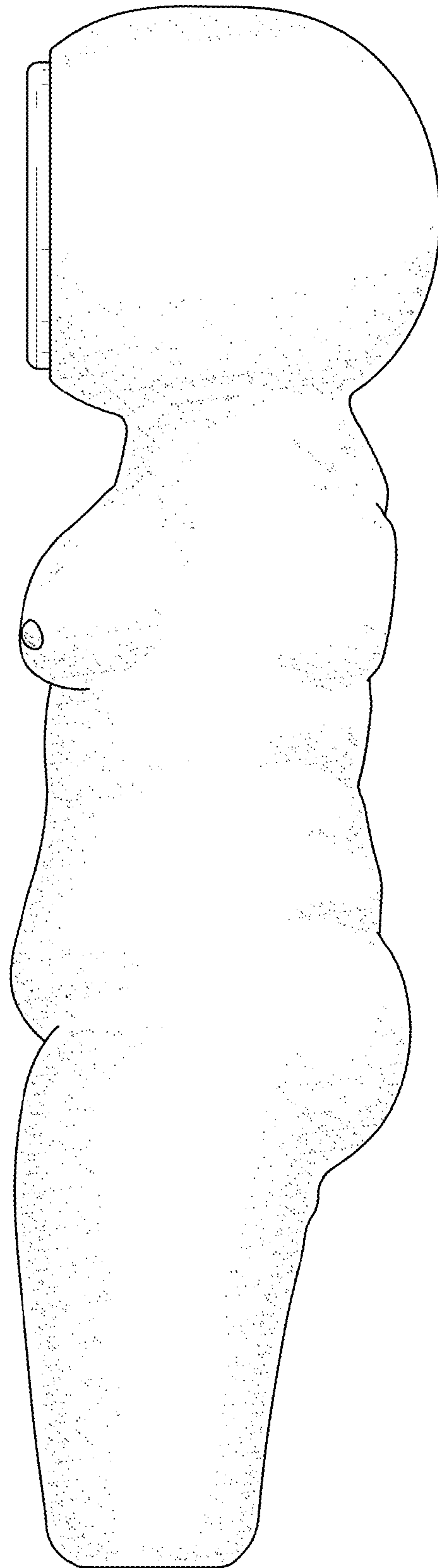

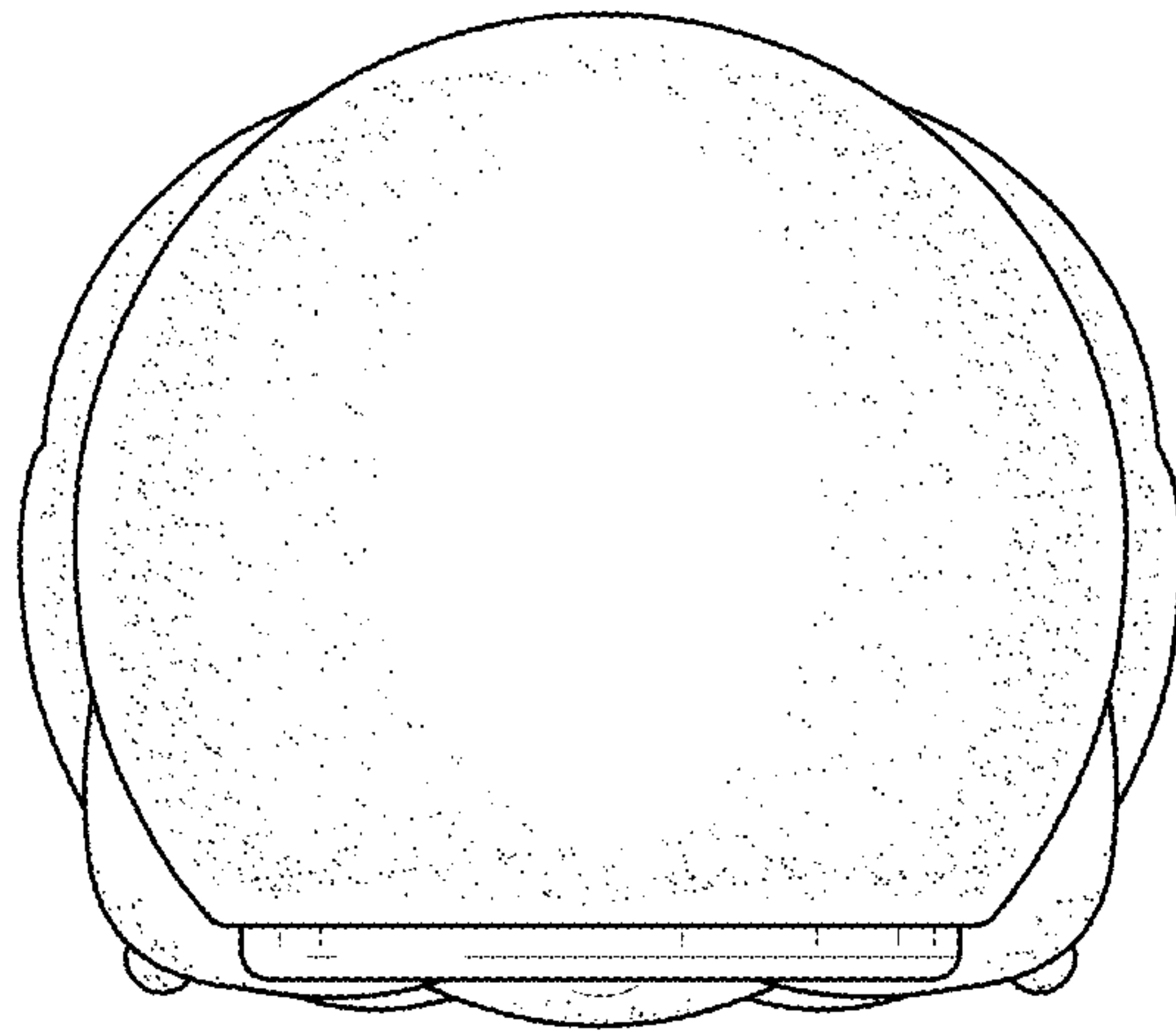

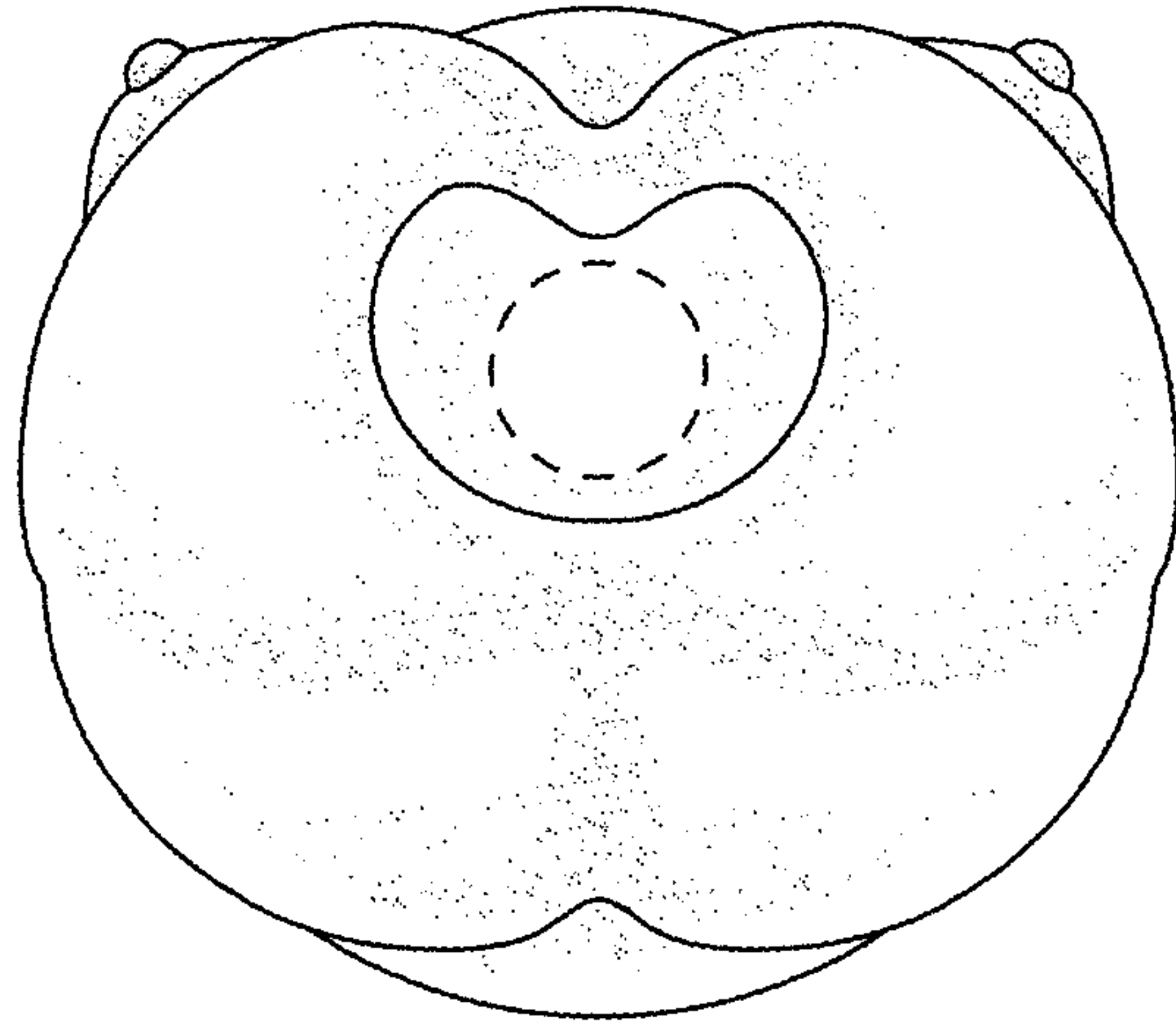
