FIG. 9 is an exploded view of the lipstick case, as shown in FIG. 1.

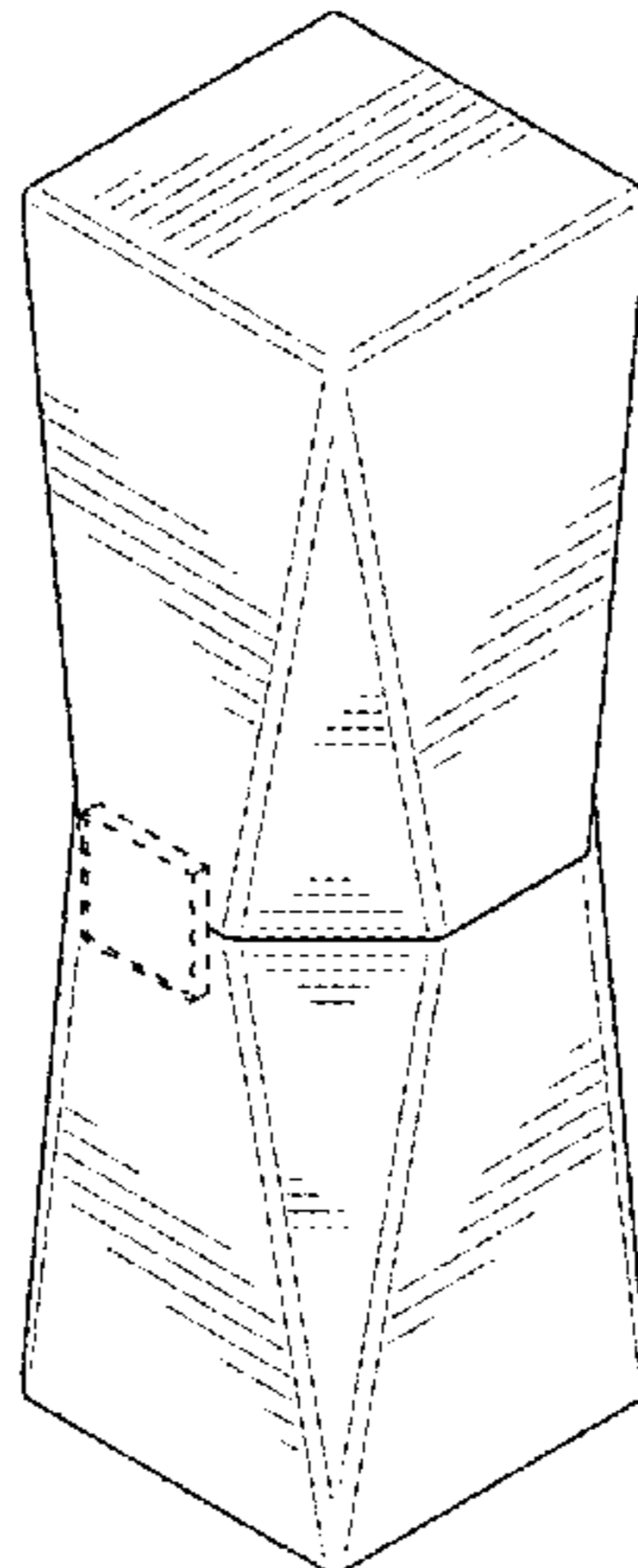

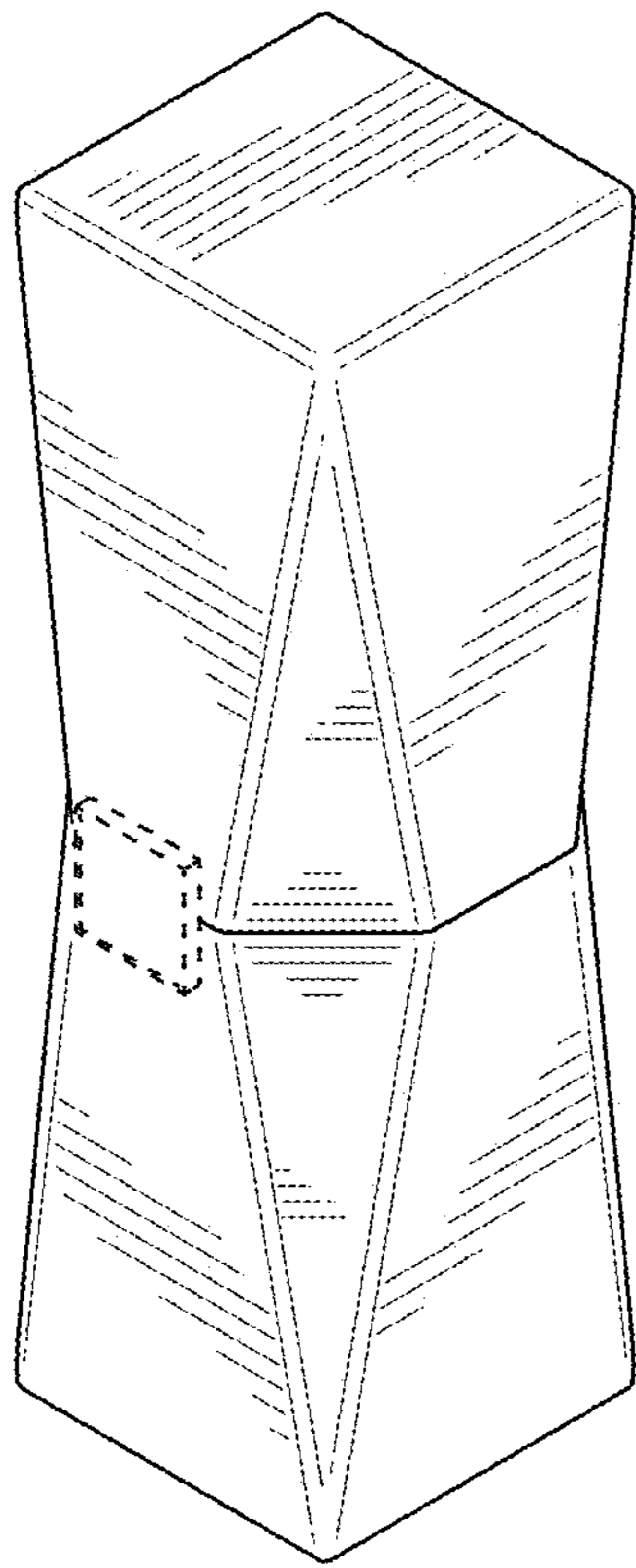

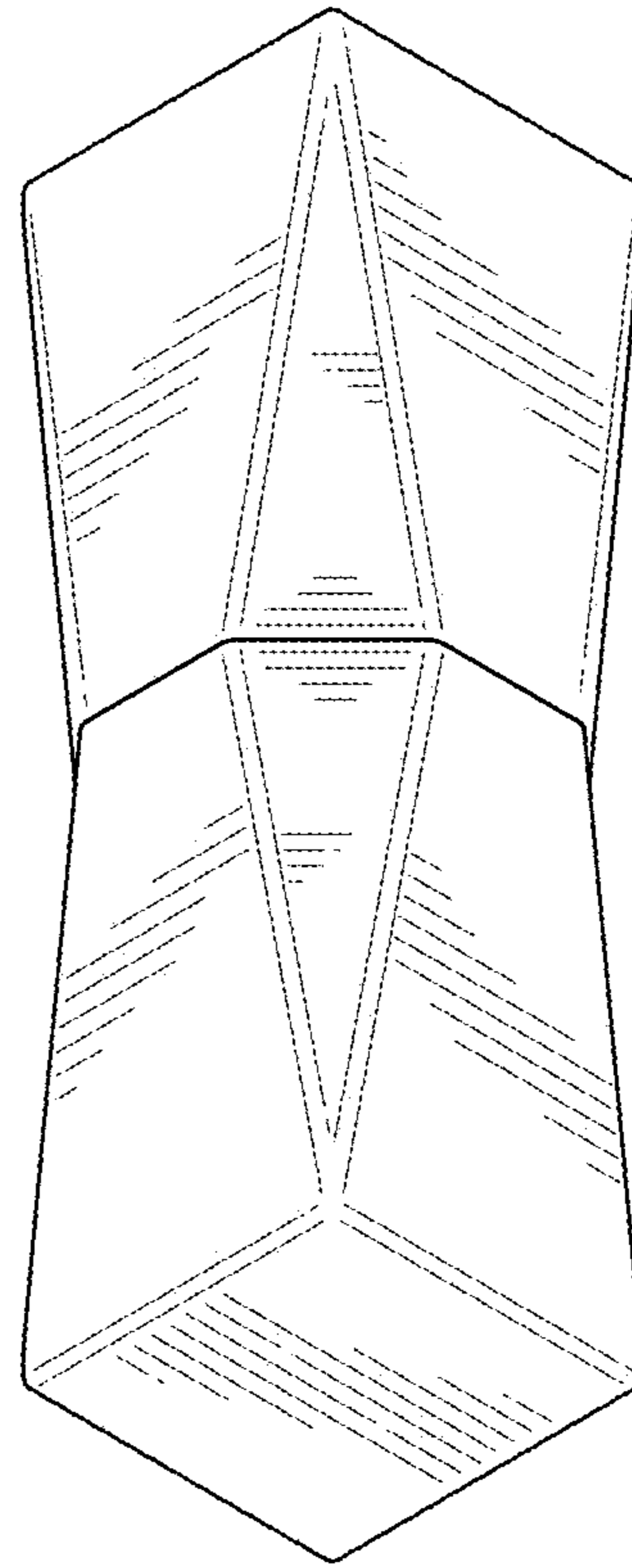

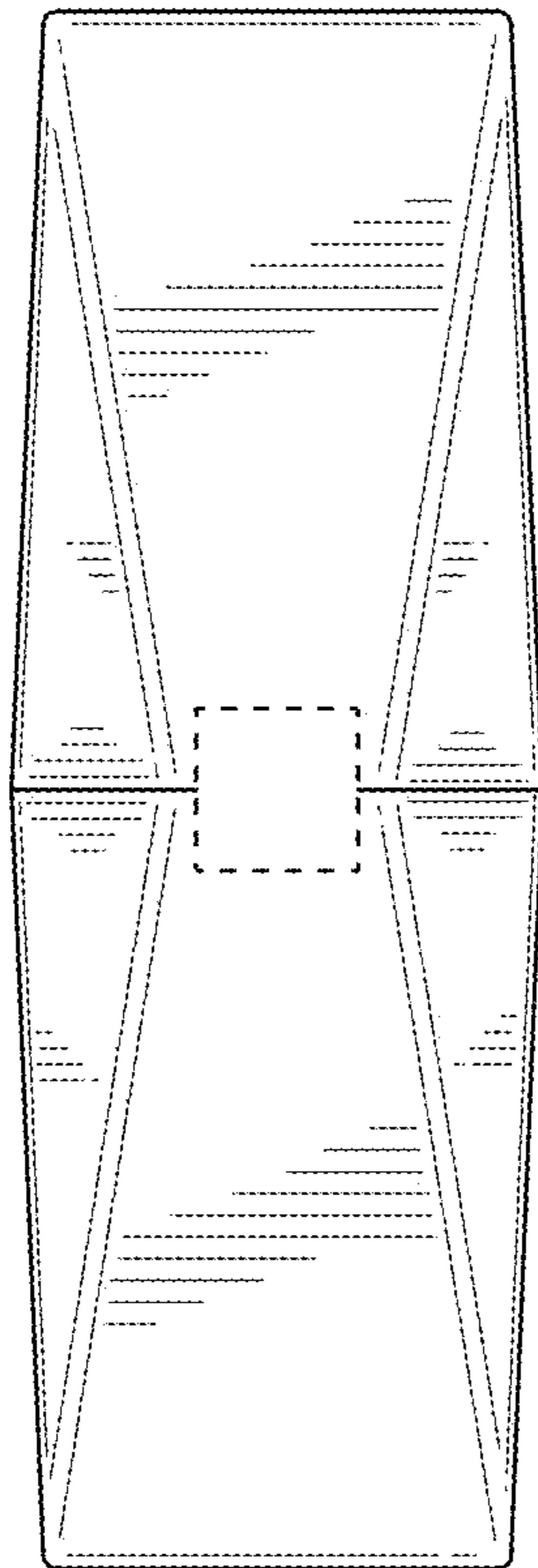

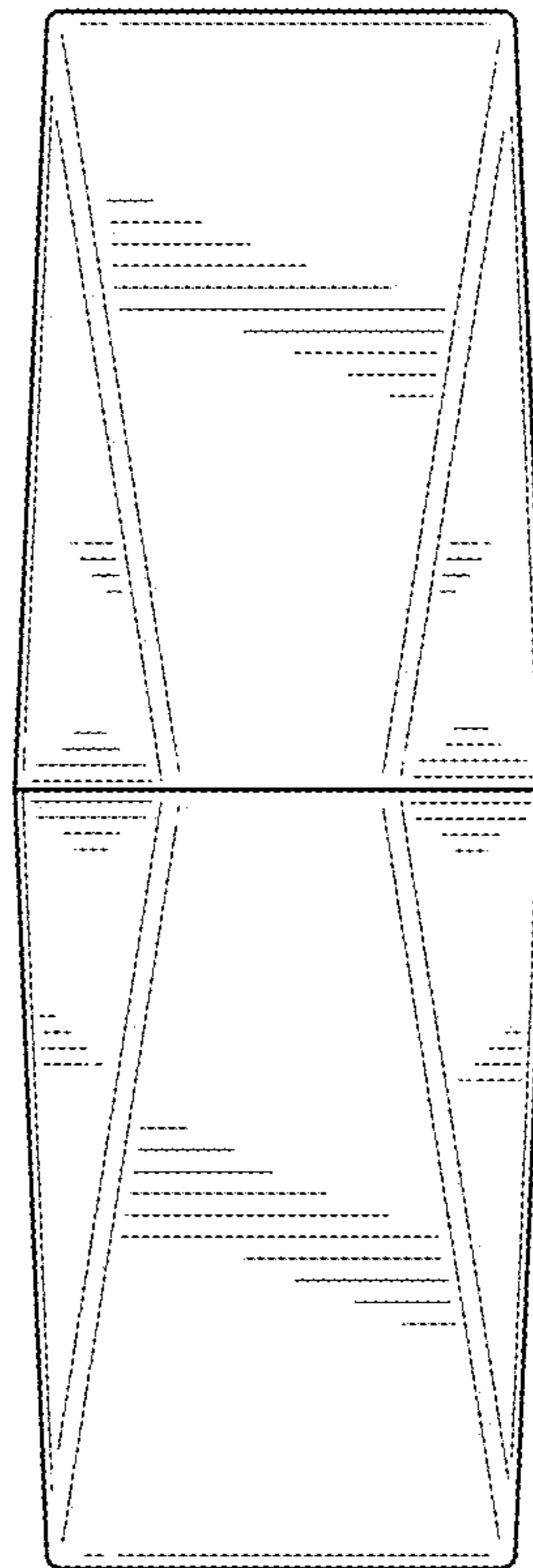

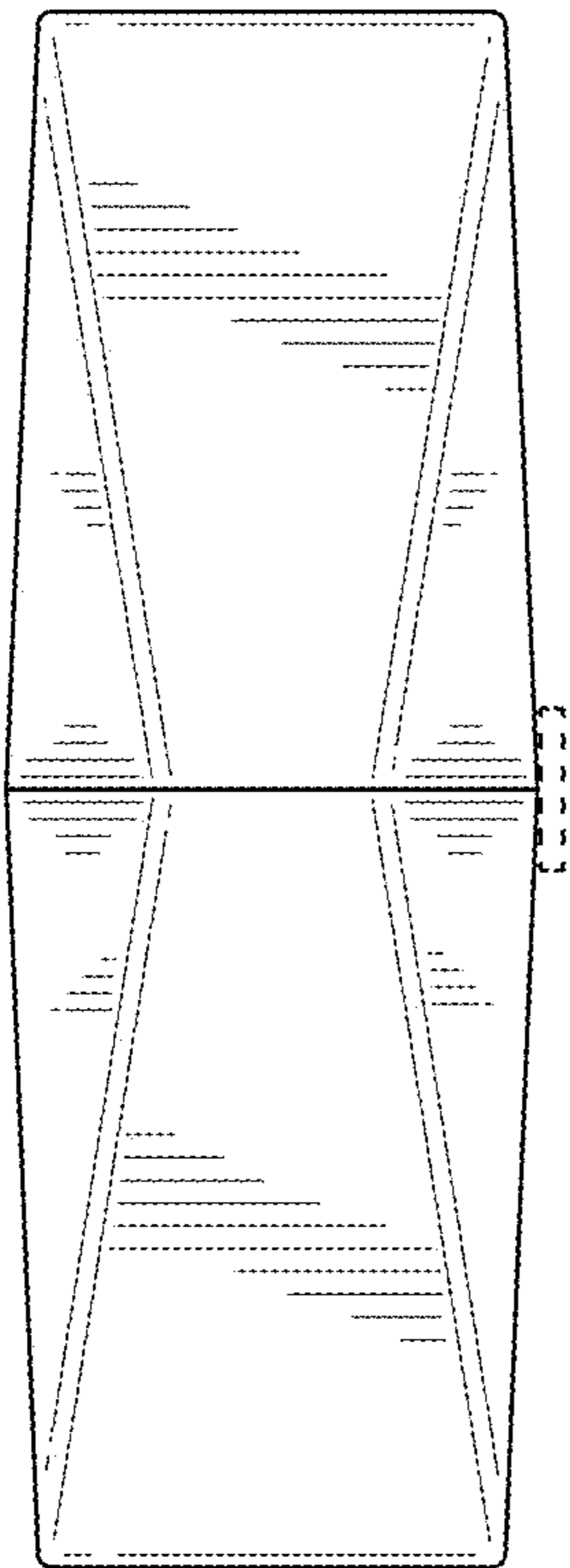

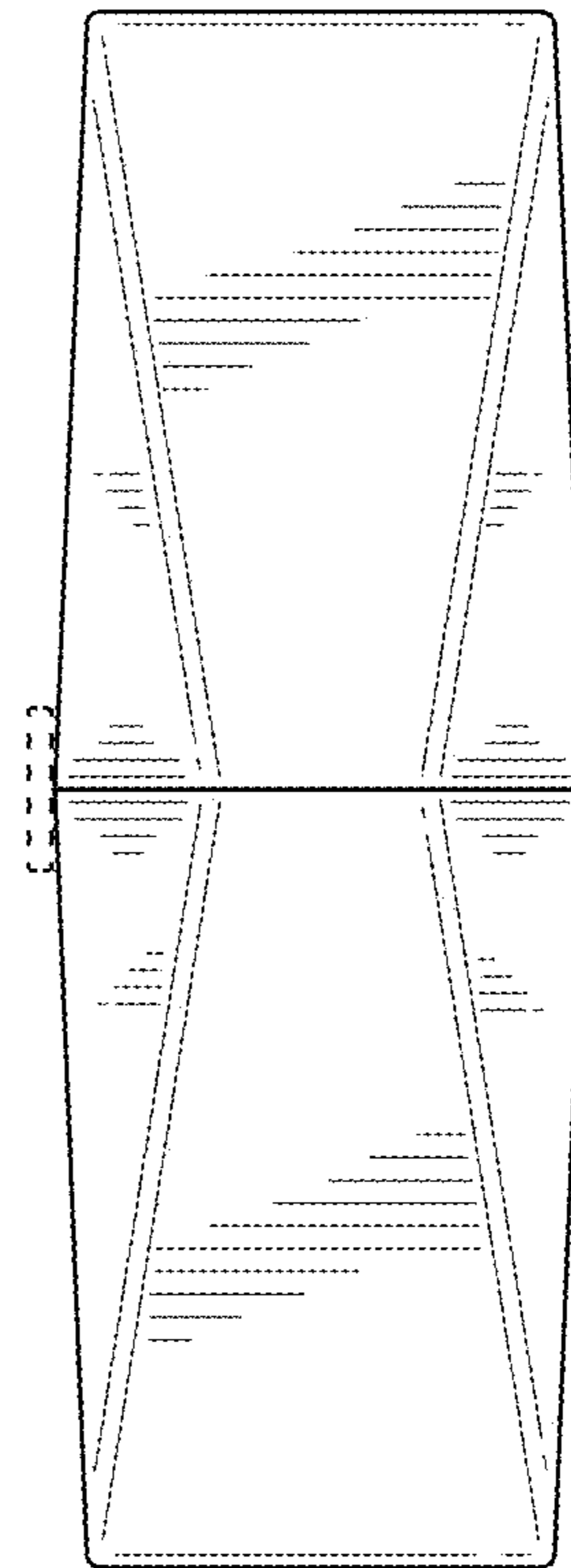

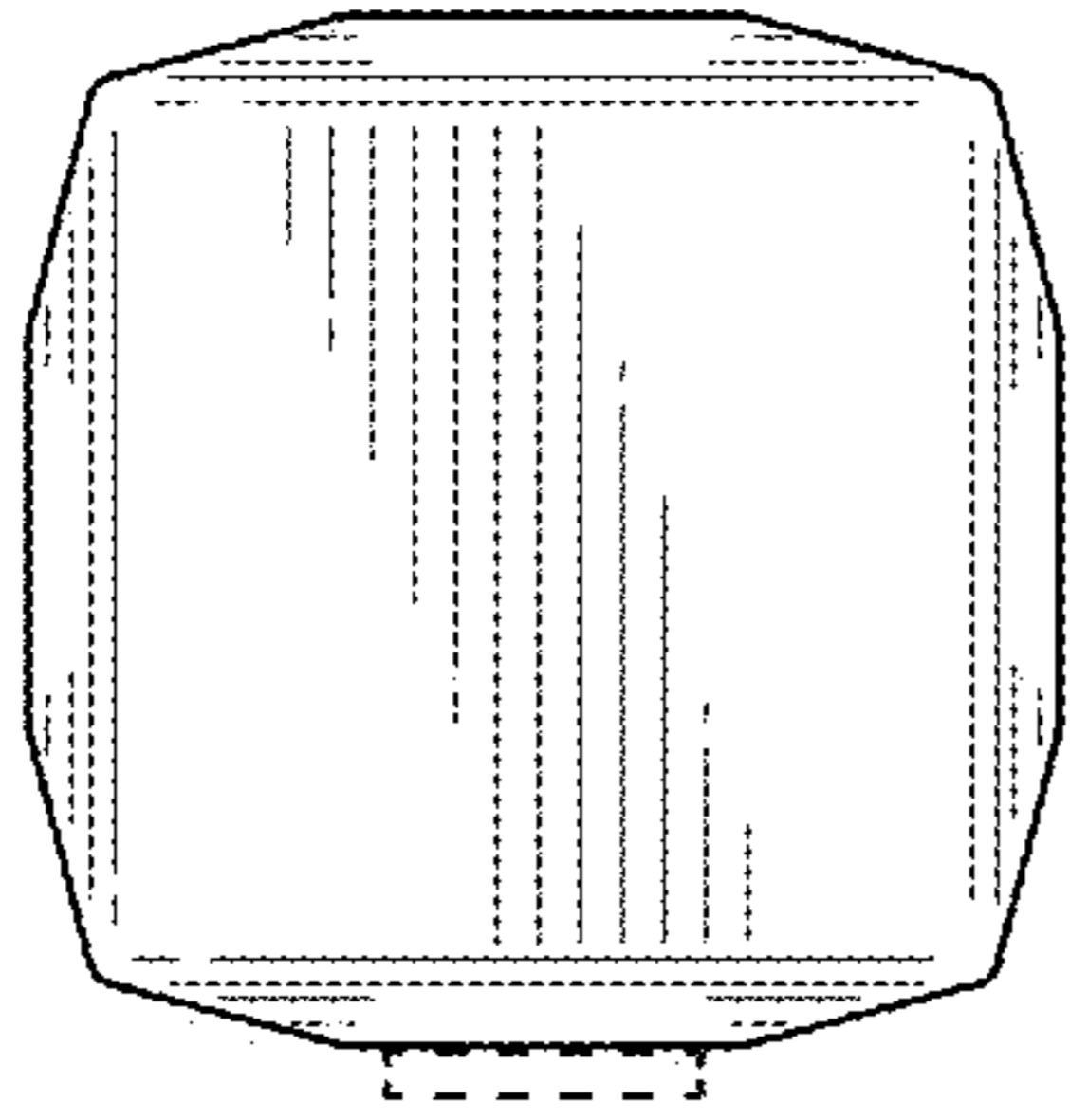

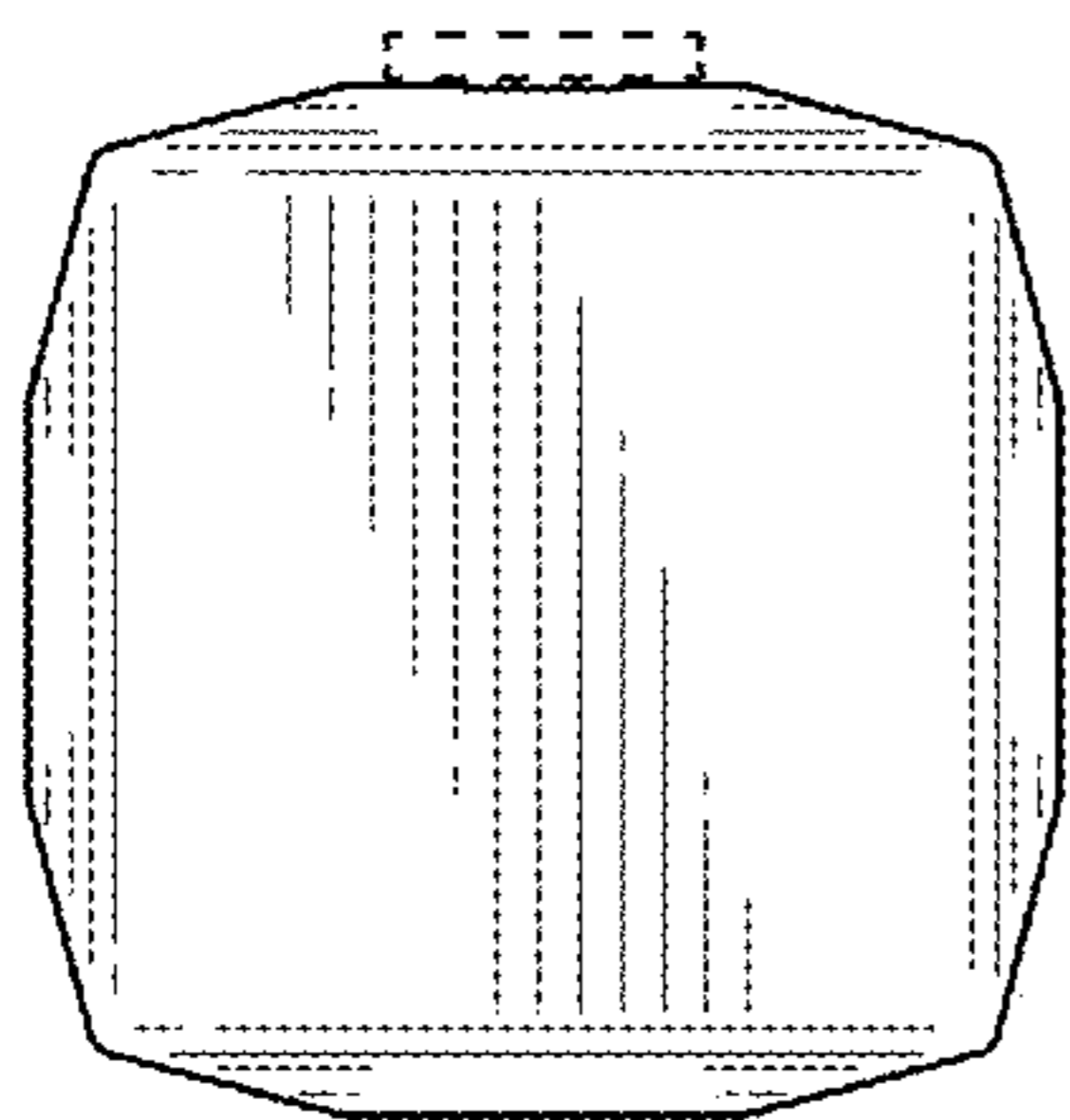

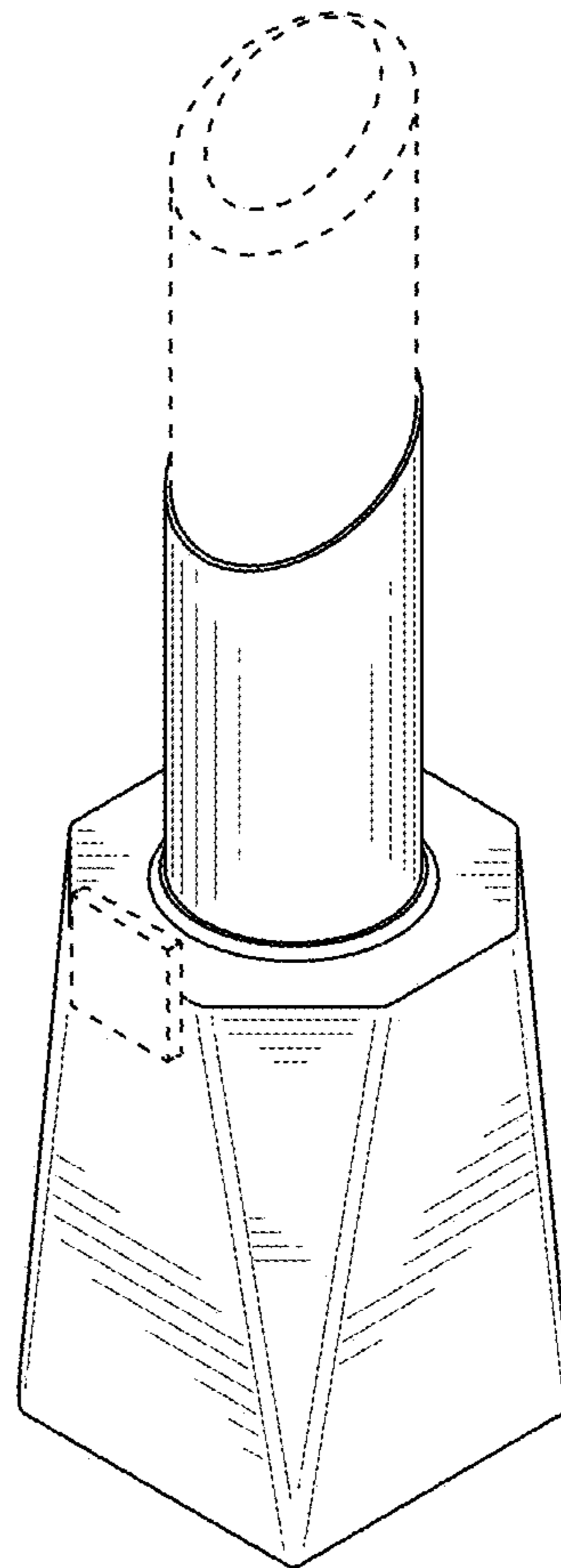
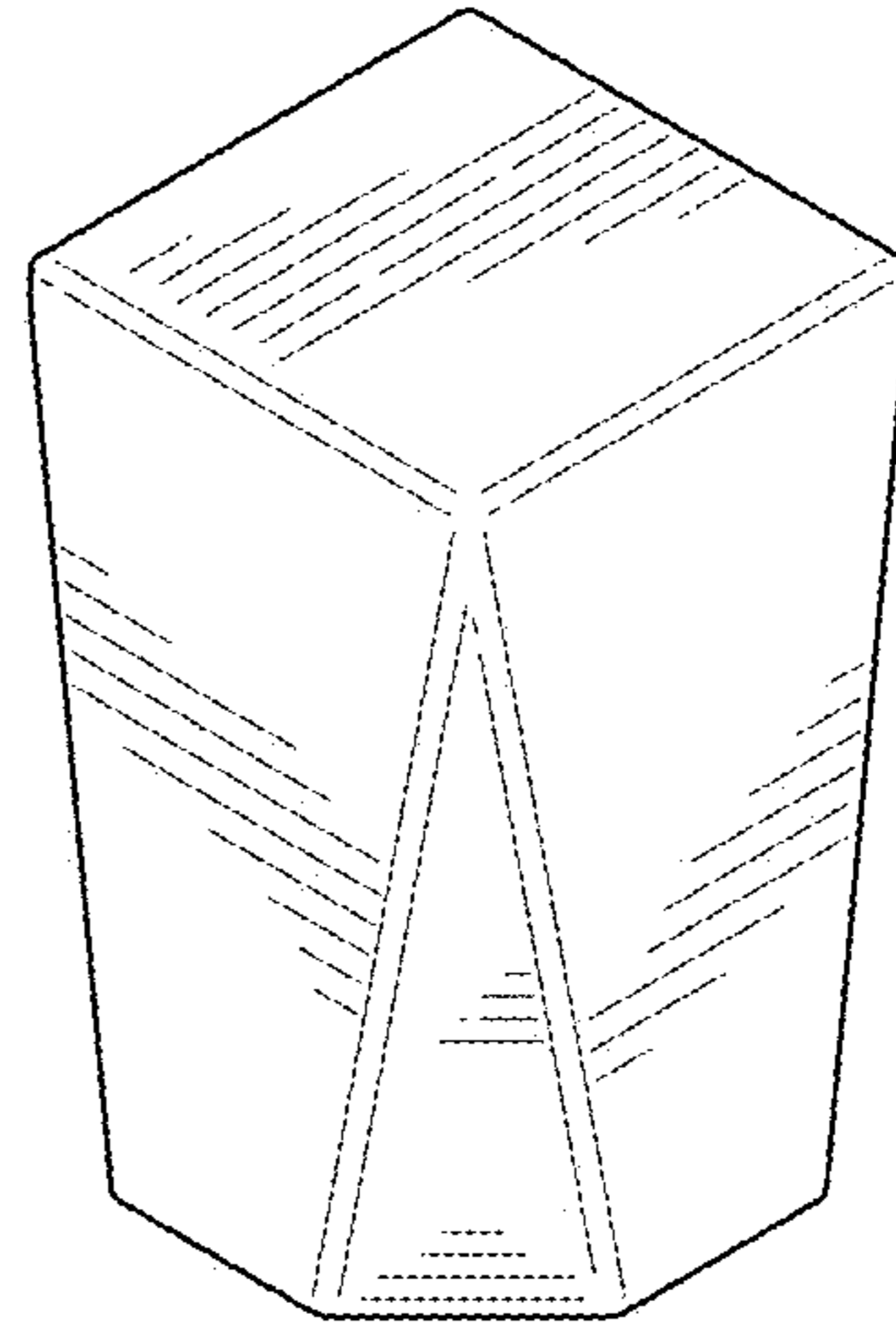
