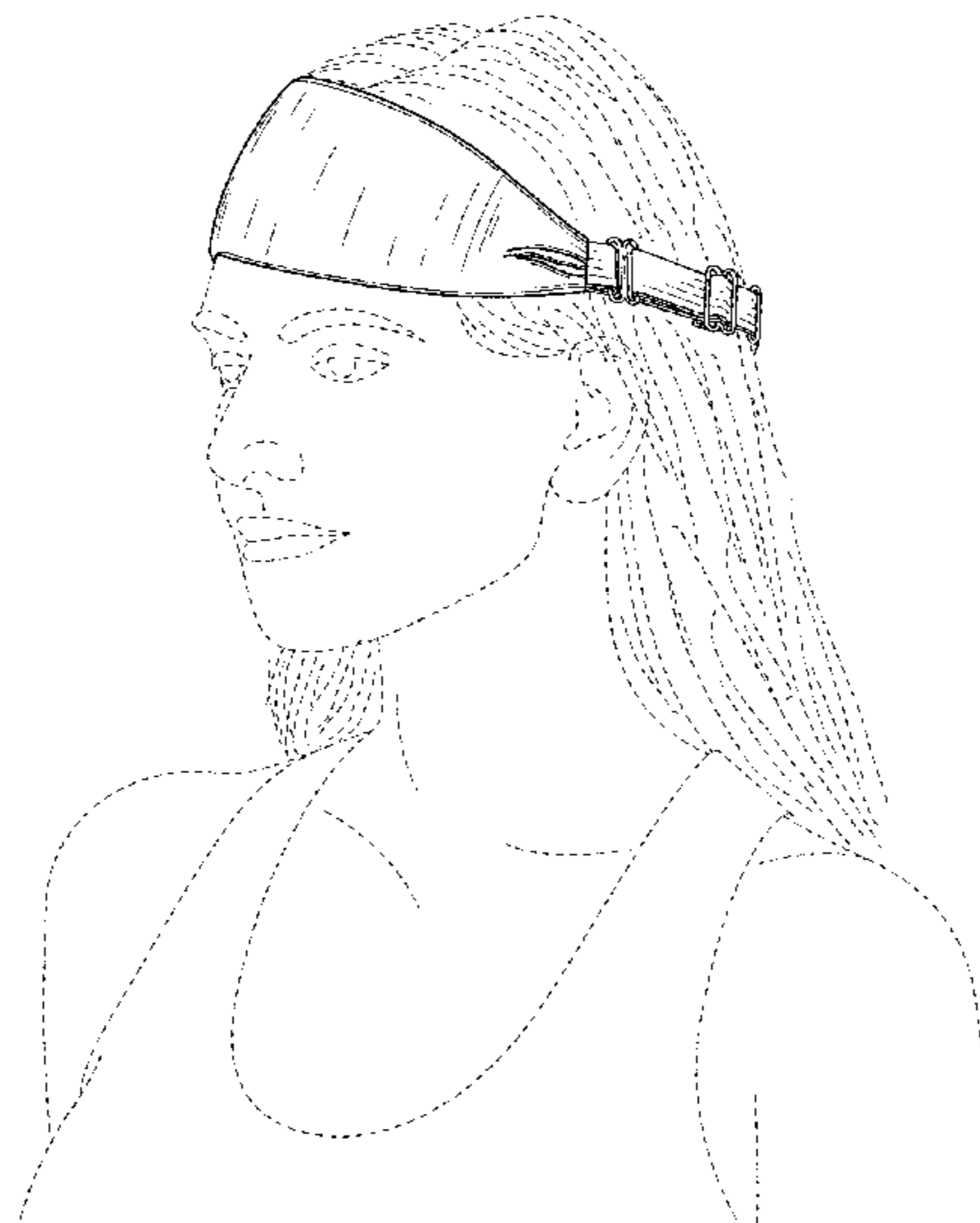
(57) **CLAIM**

The ornamental design for a headband with an adjustable strap, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a headband with an adjustable strap, showing my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left-side elevational view thereof;
FIG. 5 is a right-side elevational view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof; and,
FIG. 8 is a perspective view thereof, illustrated with a fabric sleeve pulled over a strap and buckles.
The broken lines showing a person in FIGS. 1 and 8 depict environmental matter and form no part of the claimed design. The remaining broken lines depict environmental features that form no part of the claimed design.

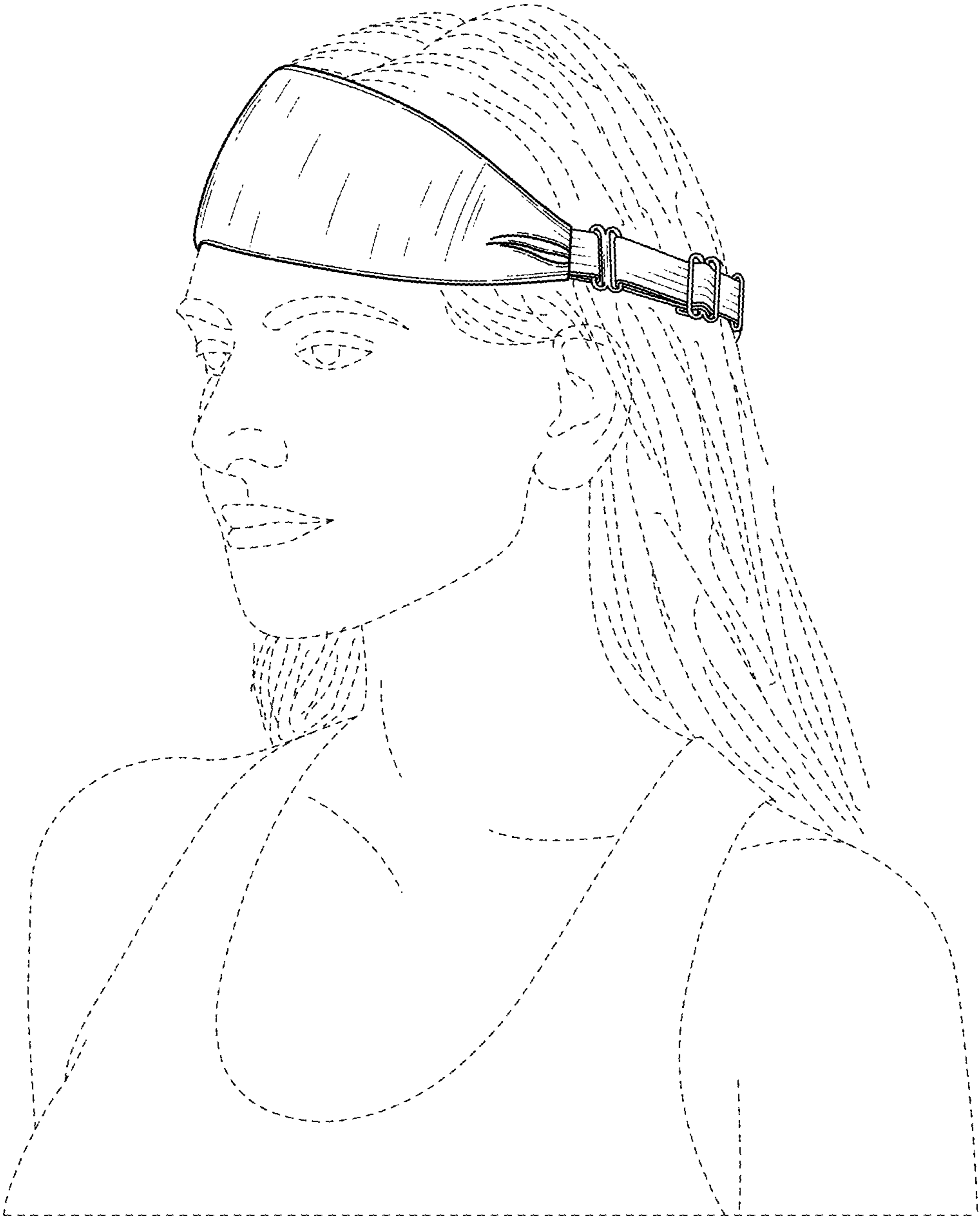

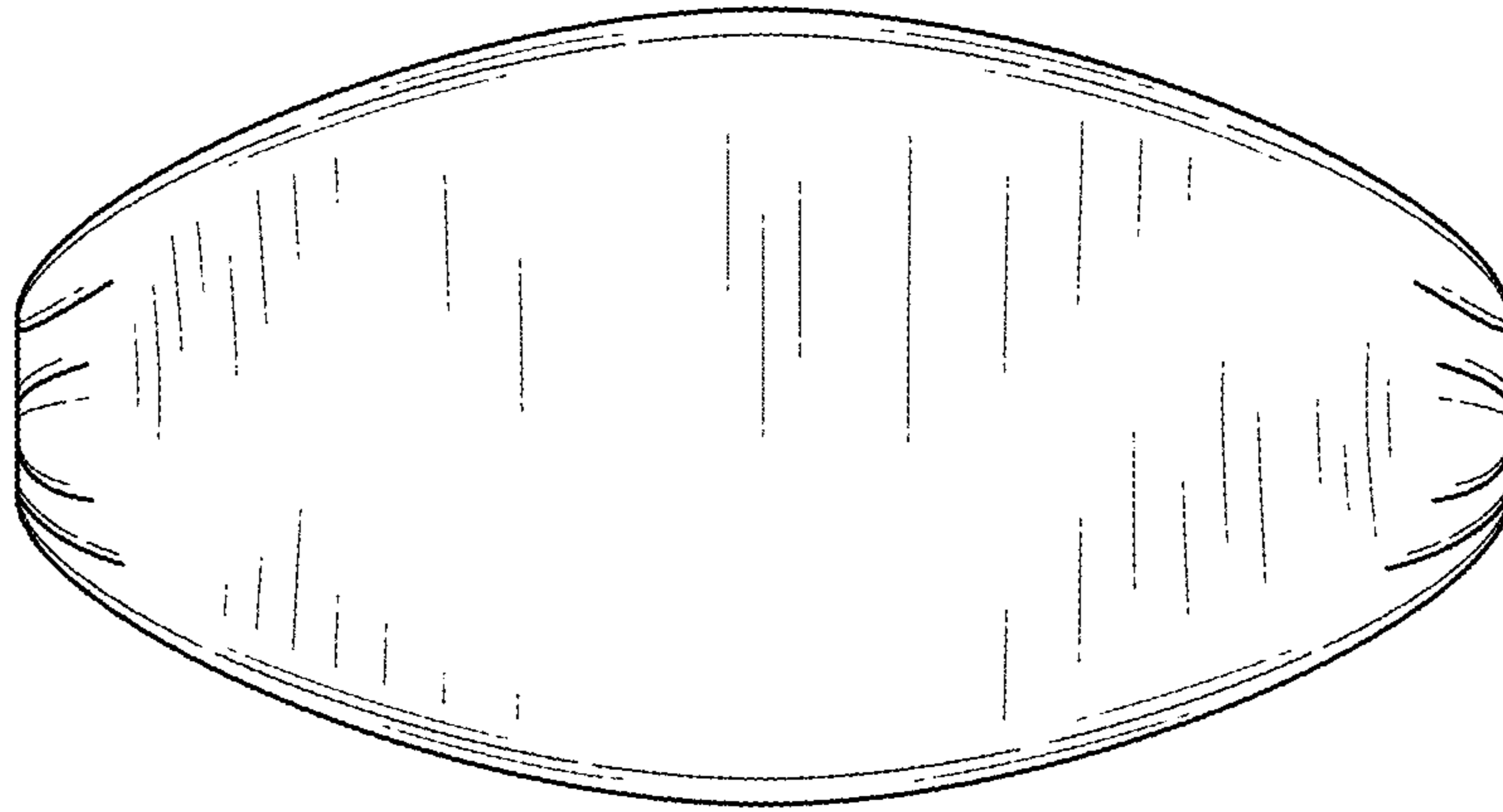

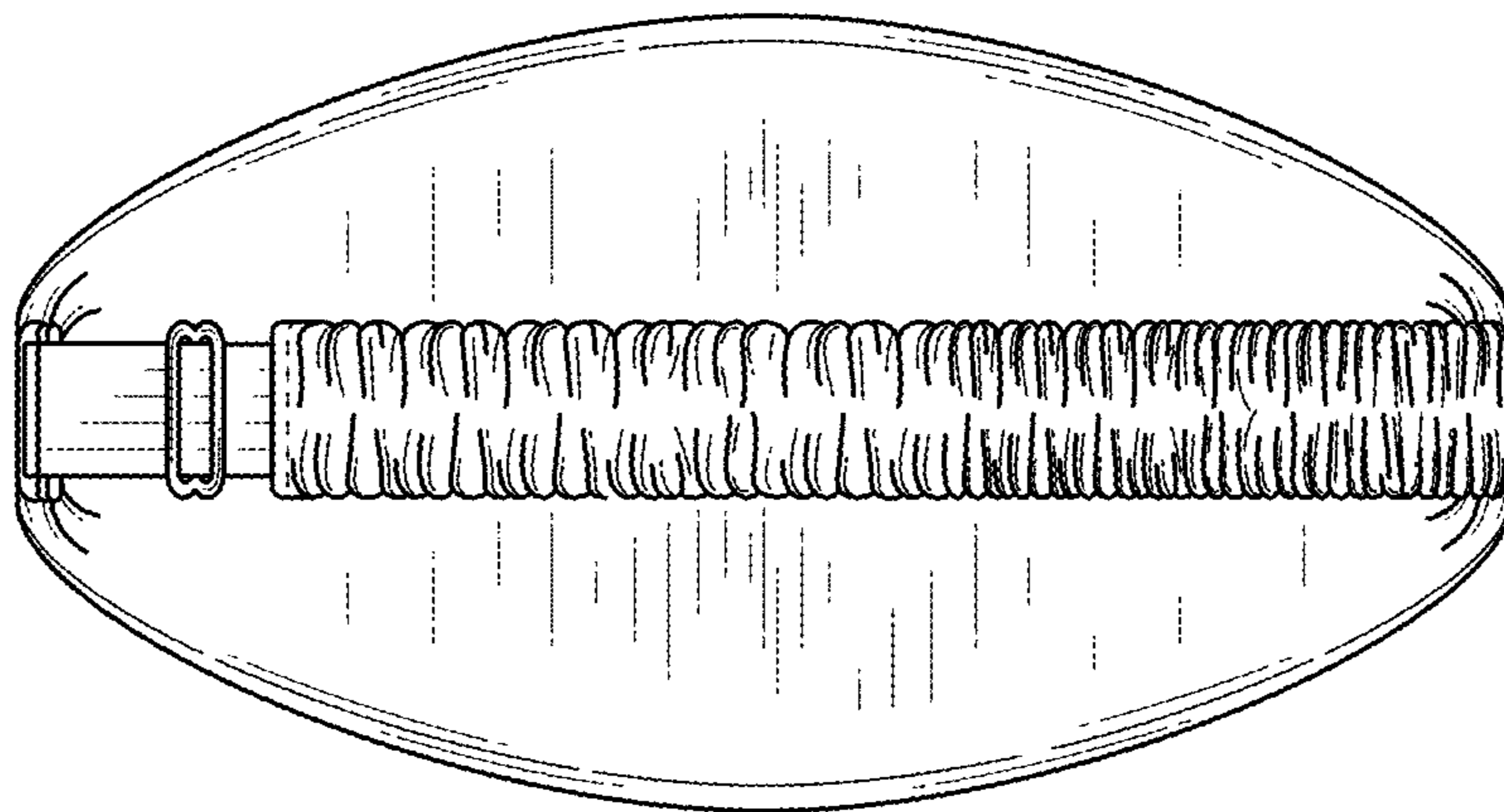

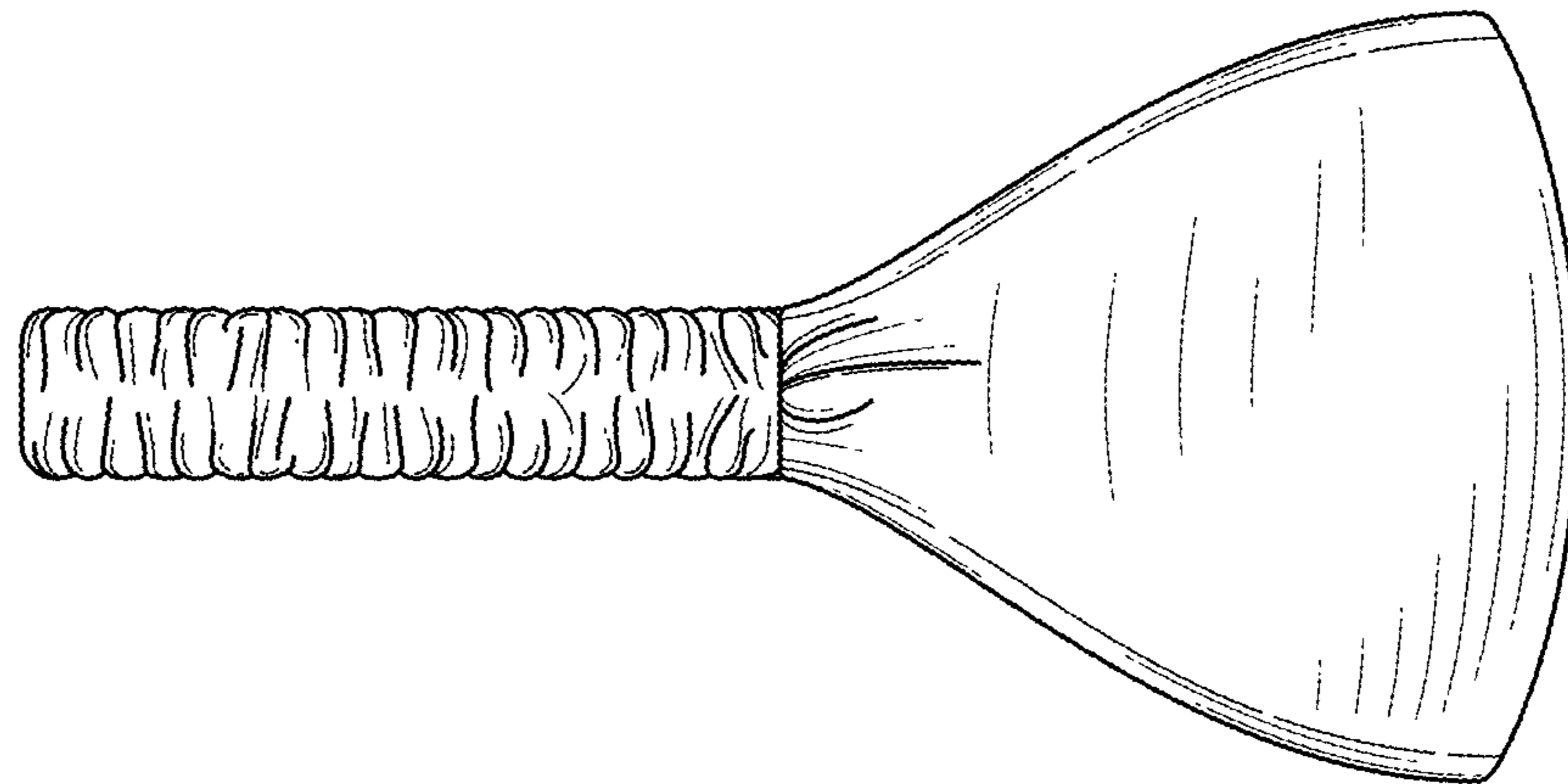

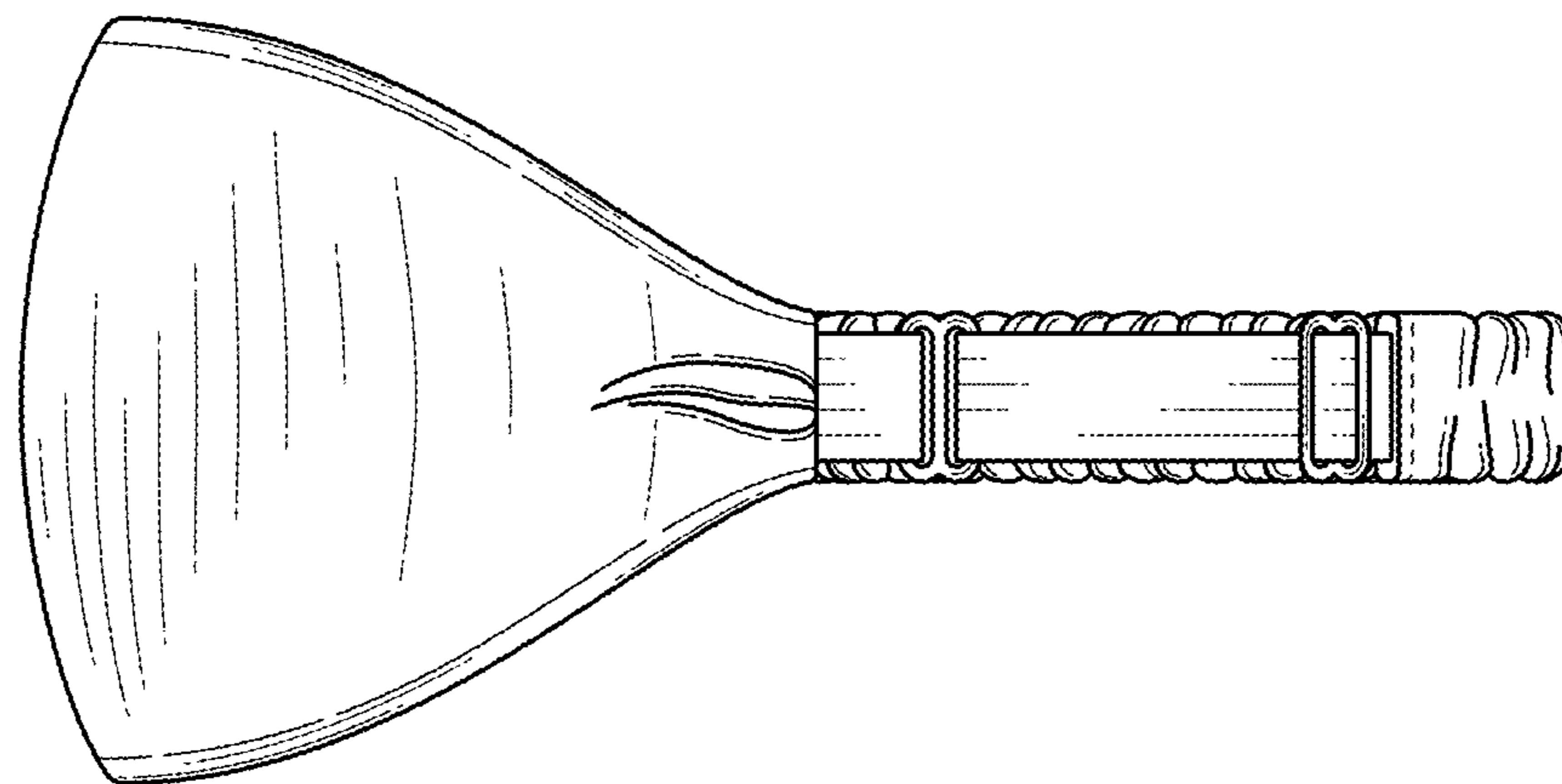

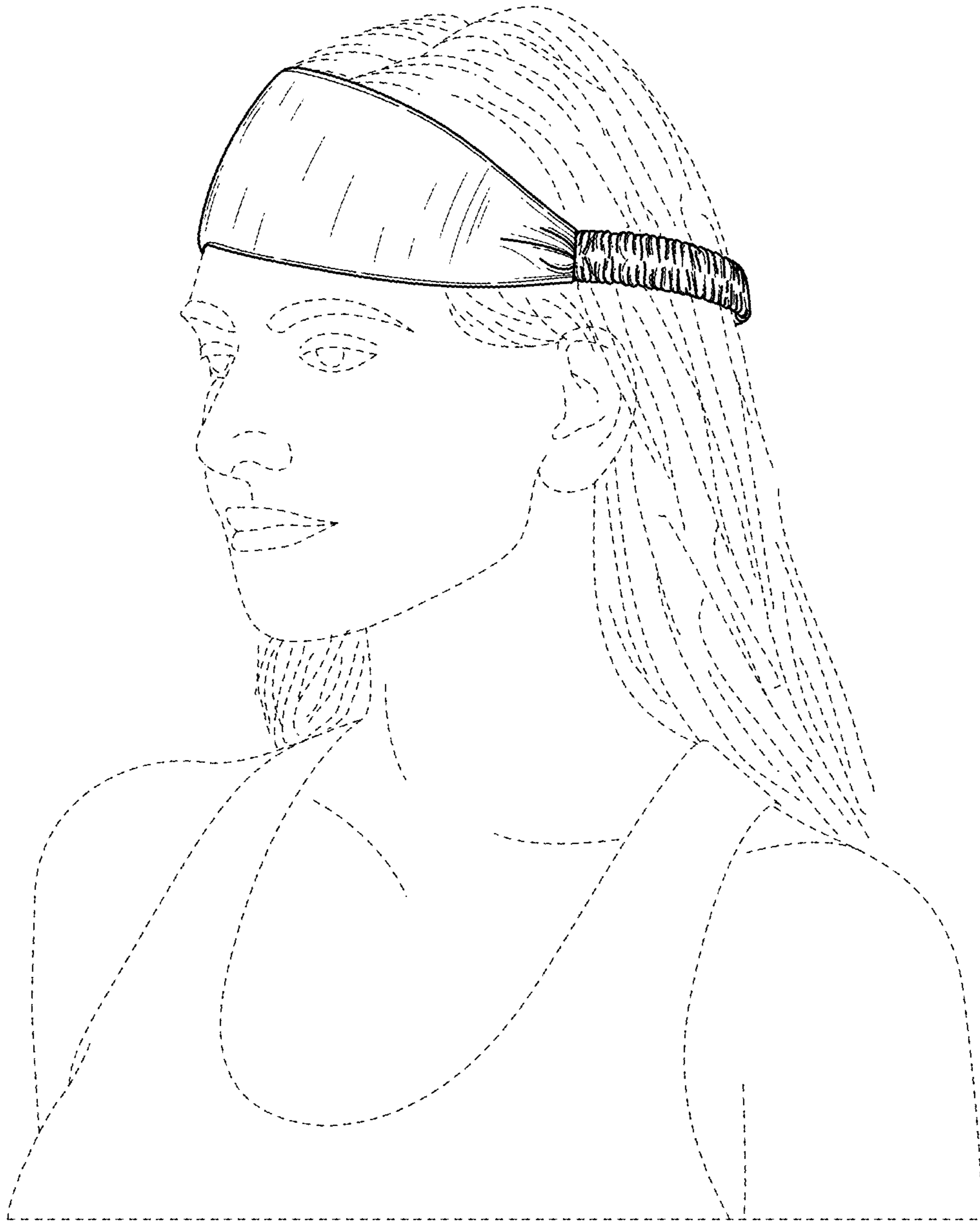
