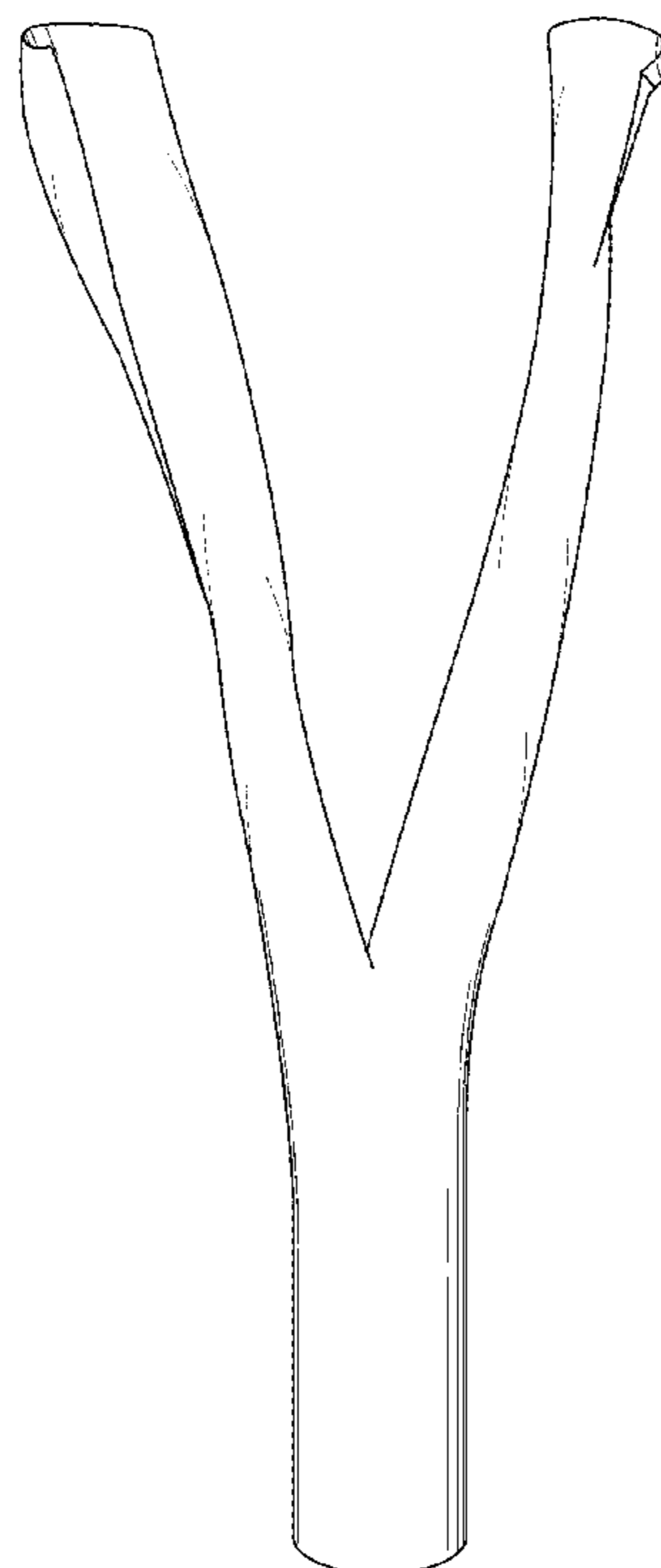

(57) **CLAIM**
The ornamental design for a turban, as shown and described.

DESCRIPTION
FIG. 1 is a front view of an unfolded turban showing my new design;
FIG. 2 is a perspective back view thereof;
FIG. 3 is a right side view thereof, with the left side view being a mirror image thereof;
FIG. 4 is a top view thereof;
FIG. 5 is a bottom view thereof; and,
FIG. 6 is a front view of the turban depicted in FIG. 1 in a partially folded state.
The broken lines shown in the figures represent portions of the turban that form no part of the claimed design.

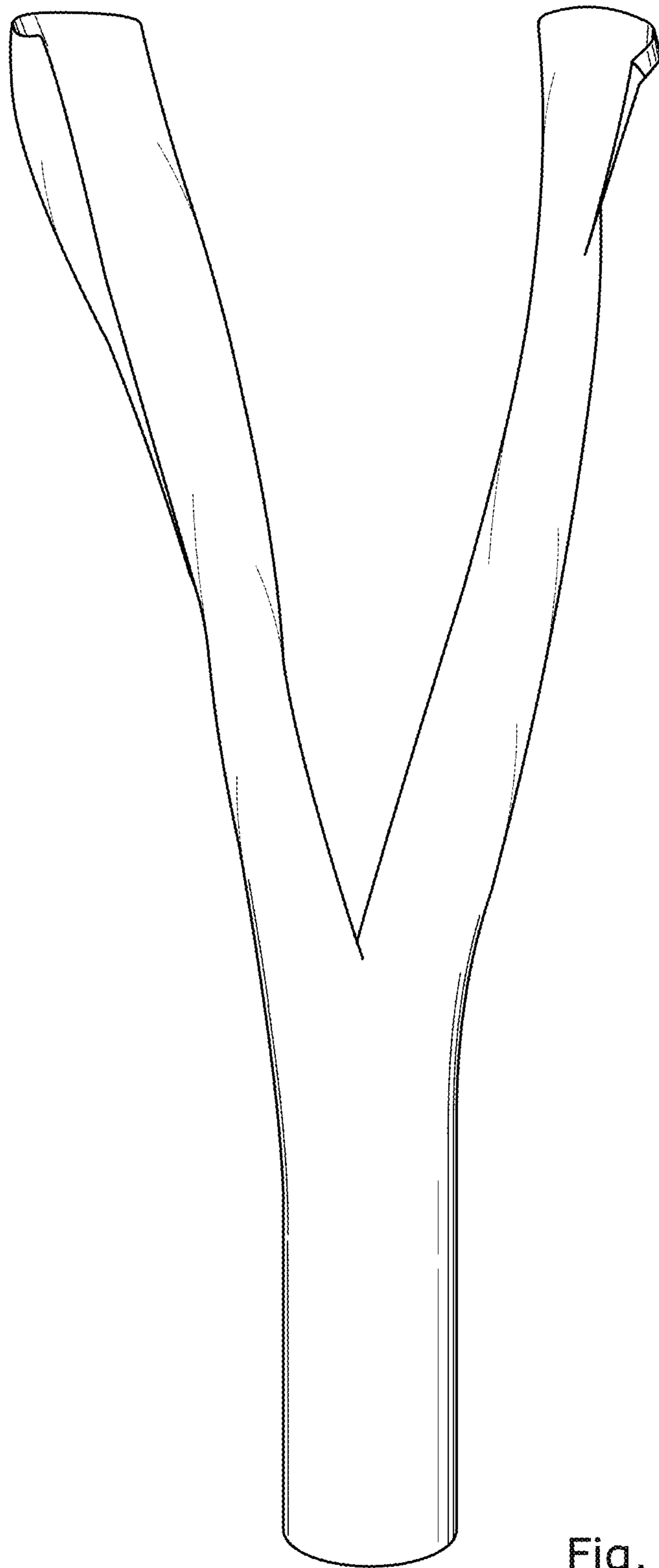

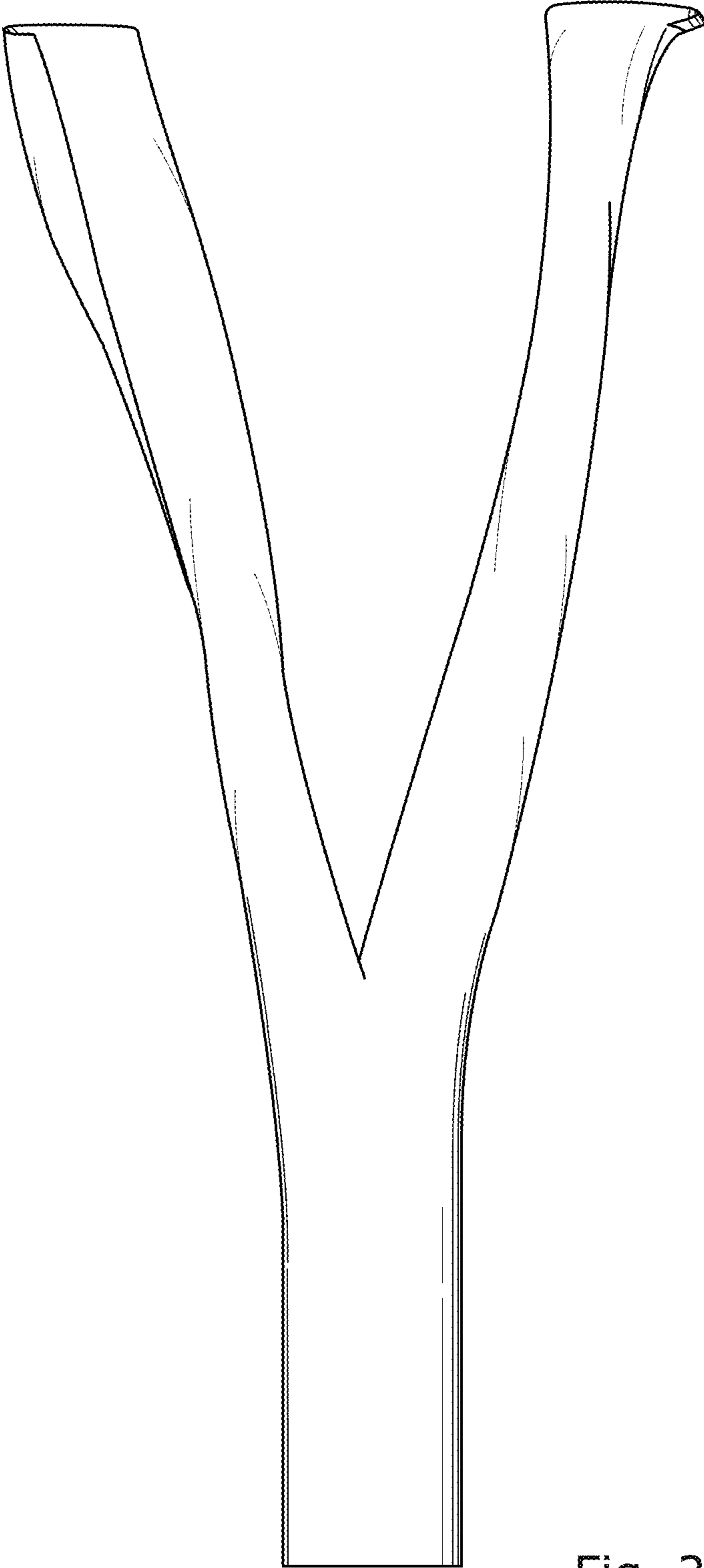

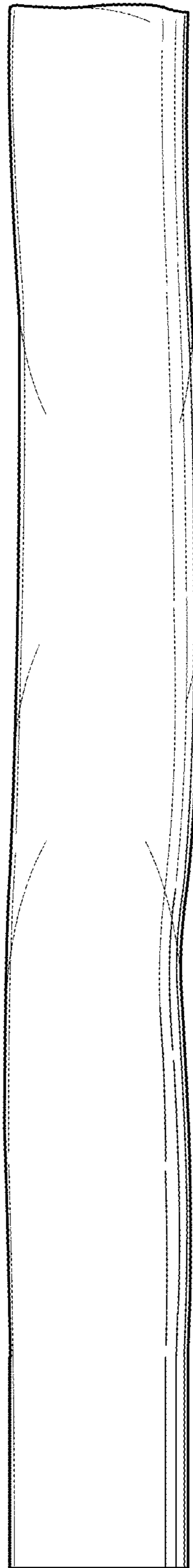

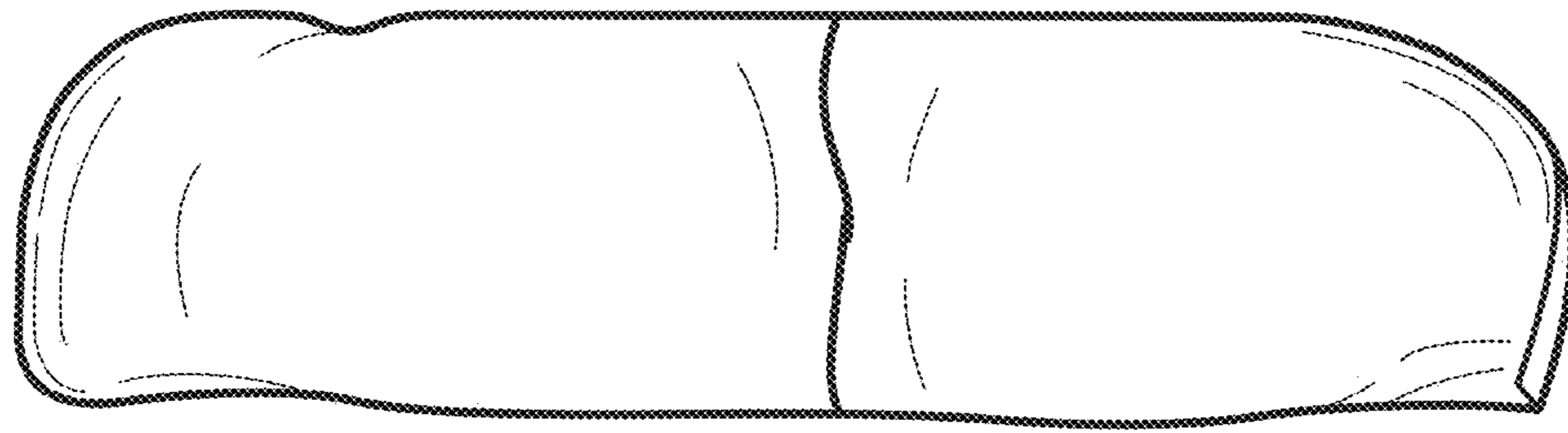

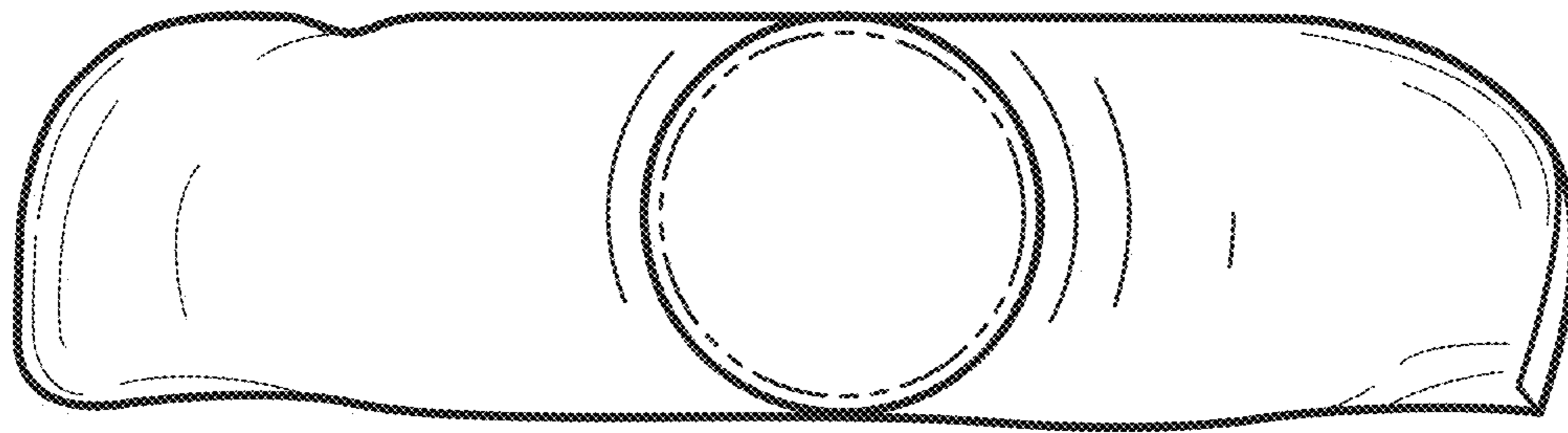

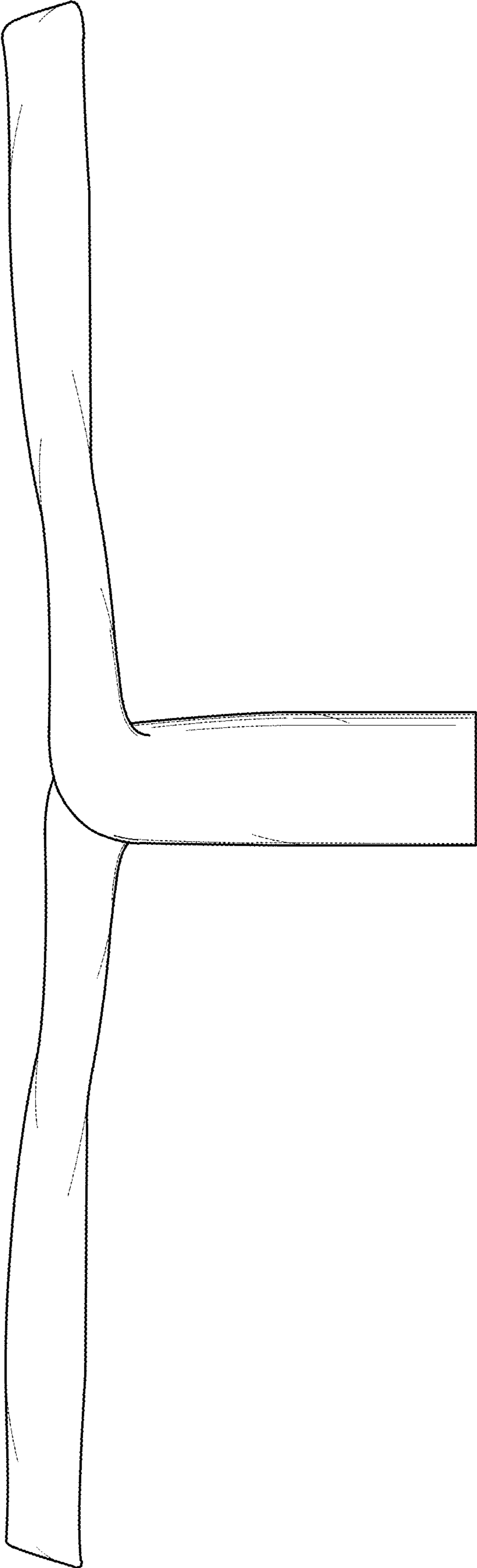
