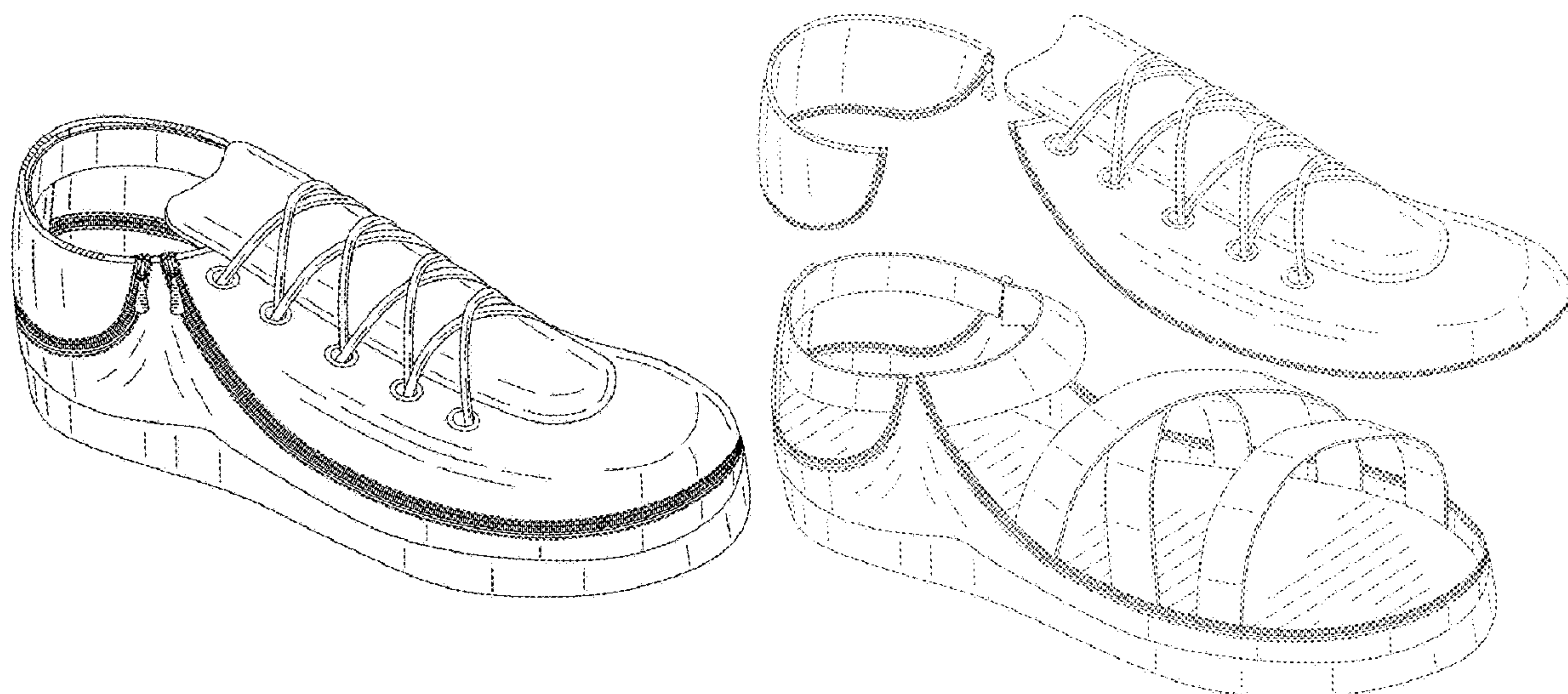
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective view of a zip off footwear showing my new design;

FIG. 13 is a right side view thereof with the front portion and rear portion removed;  
FIG. 14 is a bottom view thereof with the front portion and rear portion removed; and,  
FIG. 15 is an exploded view thereof.

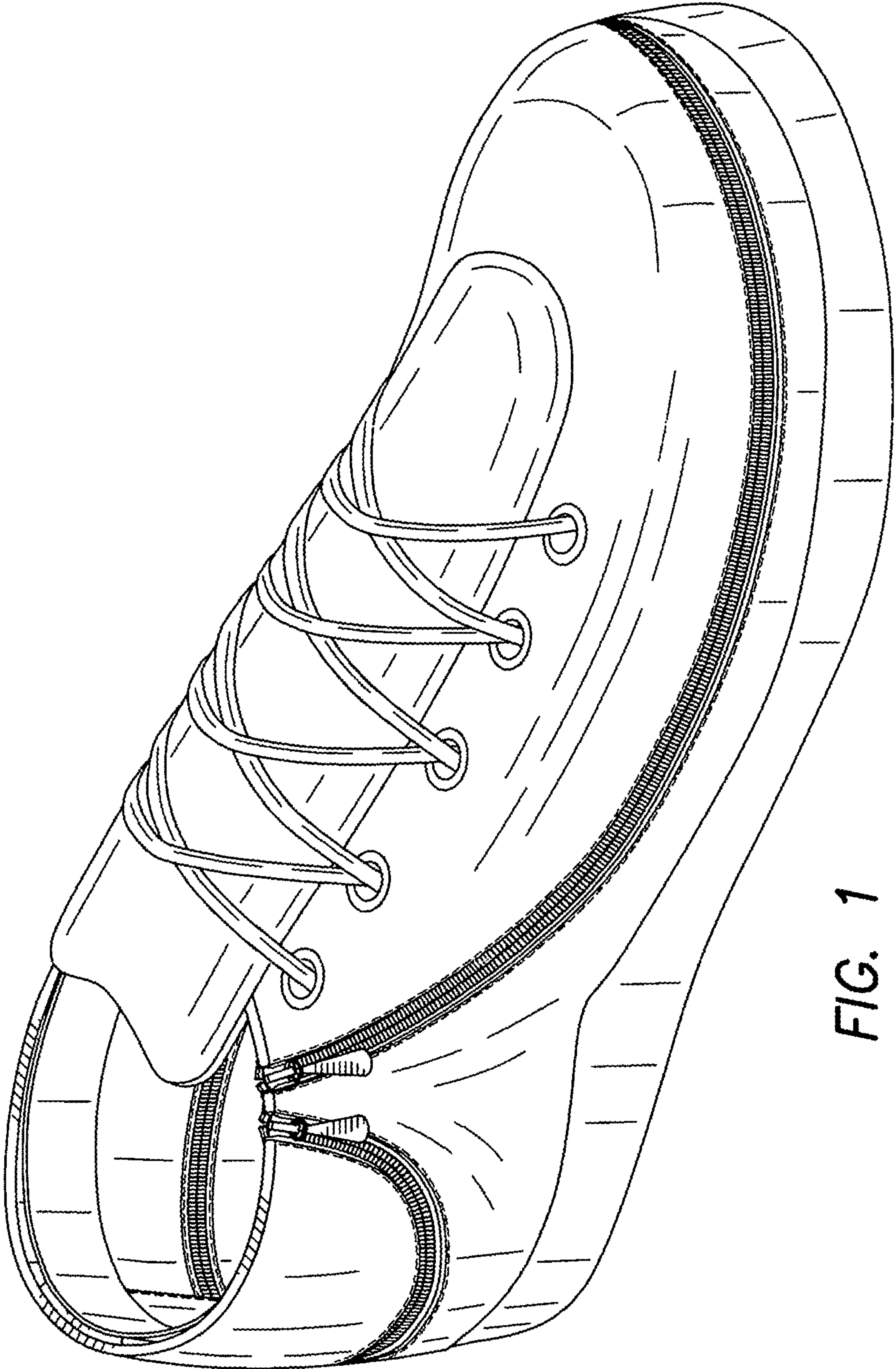

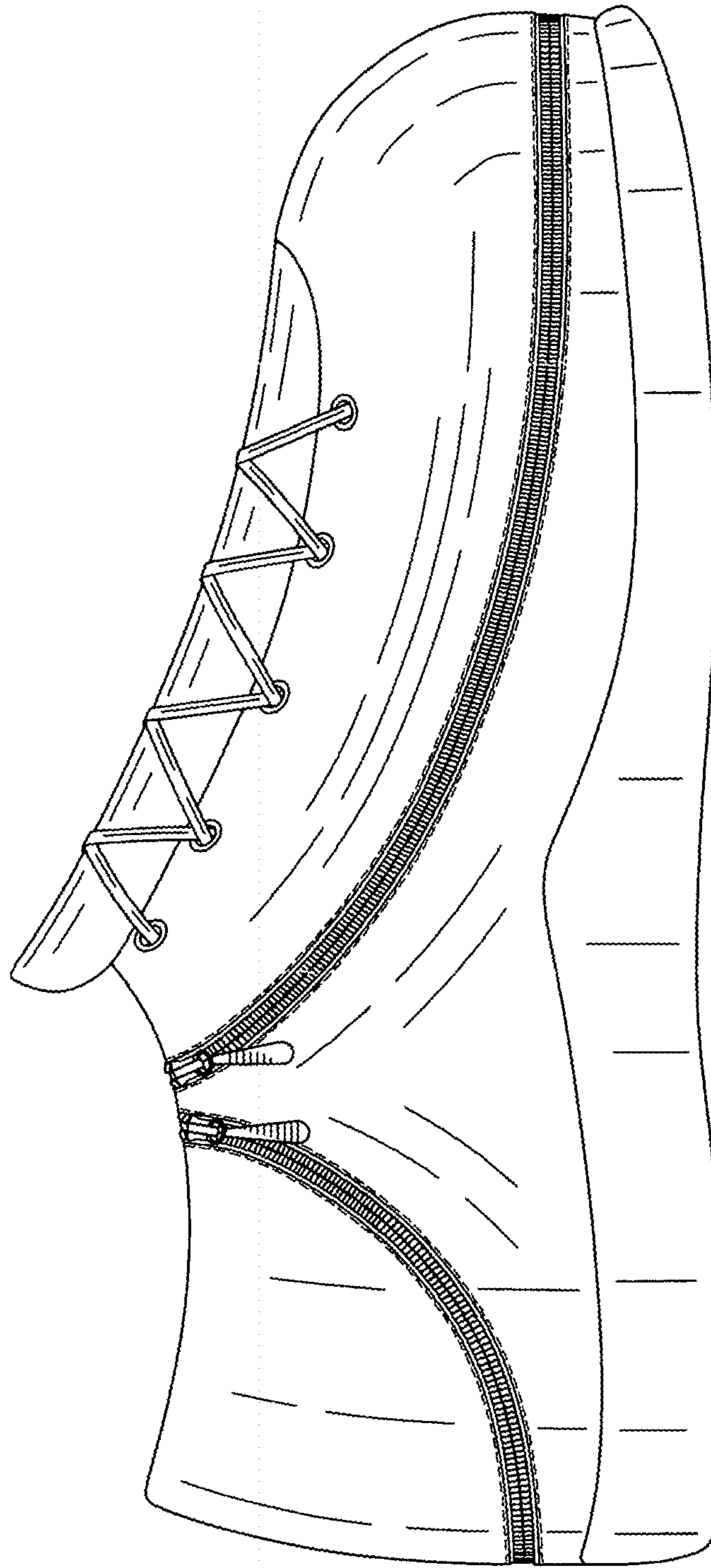

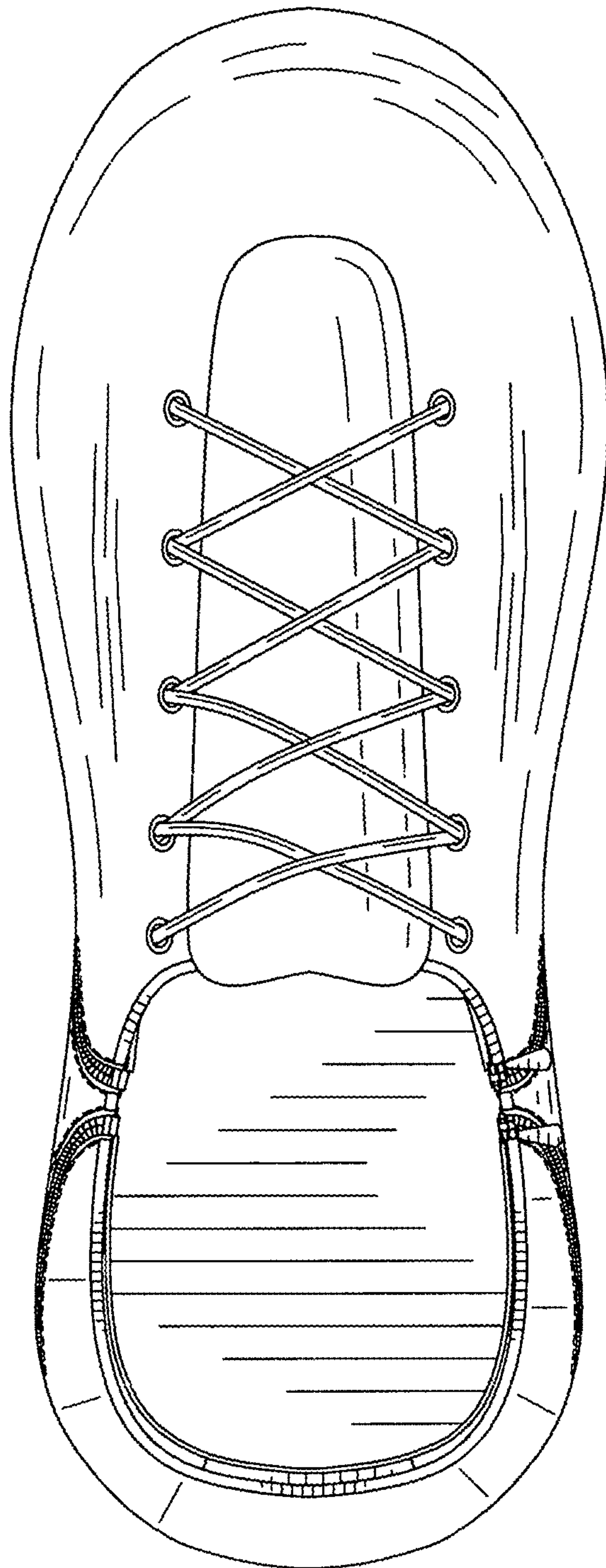
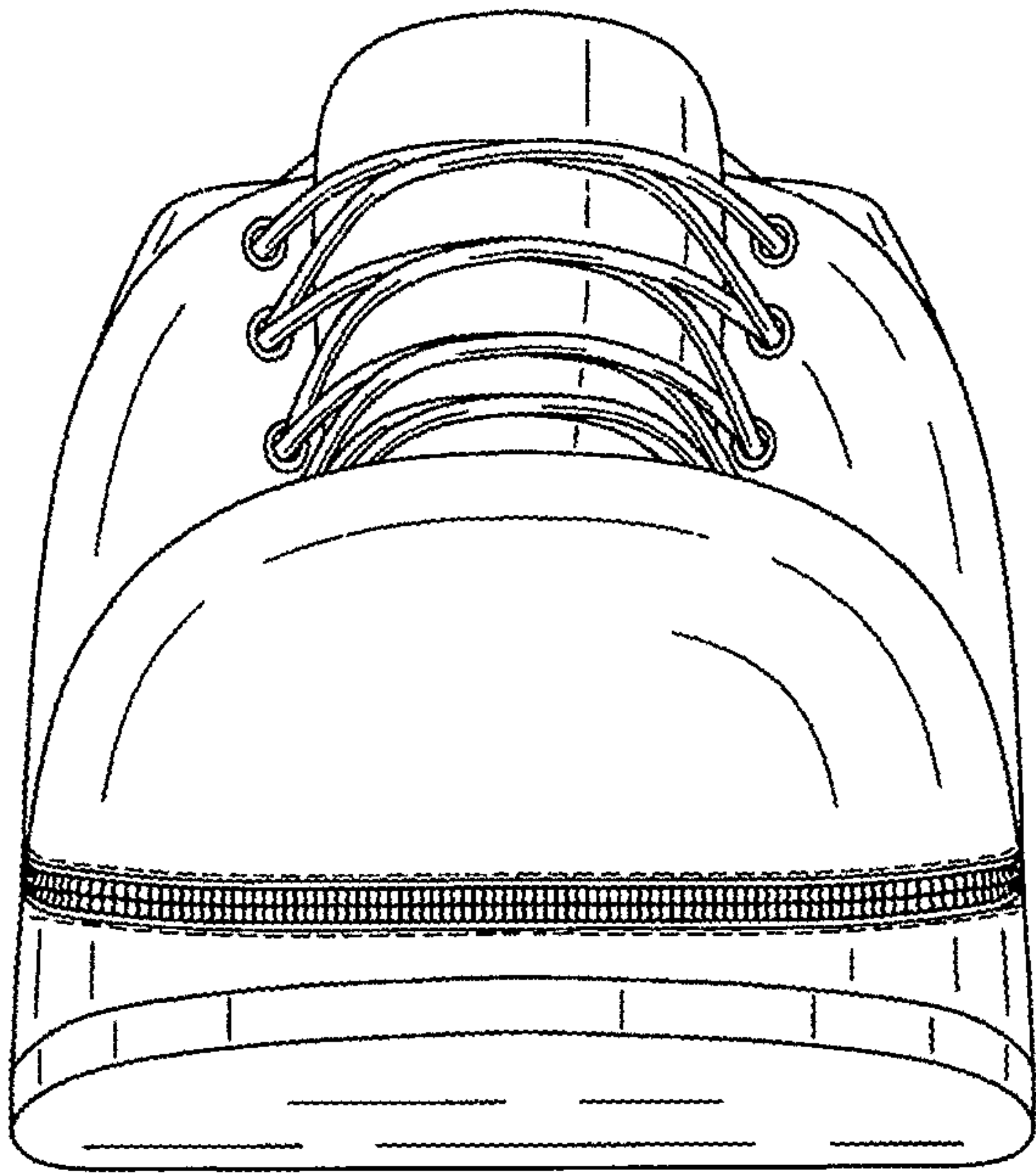
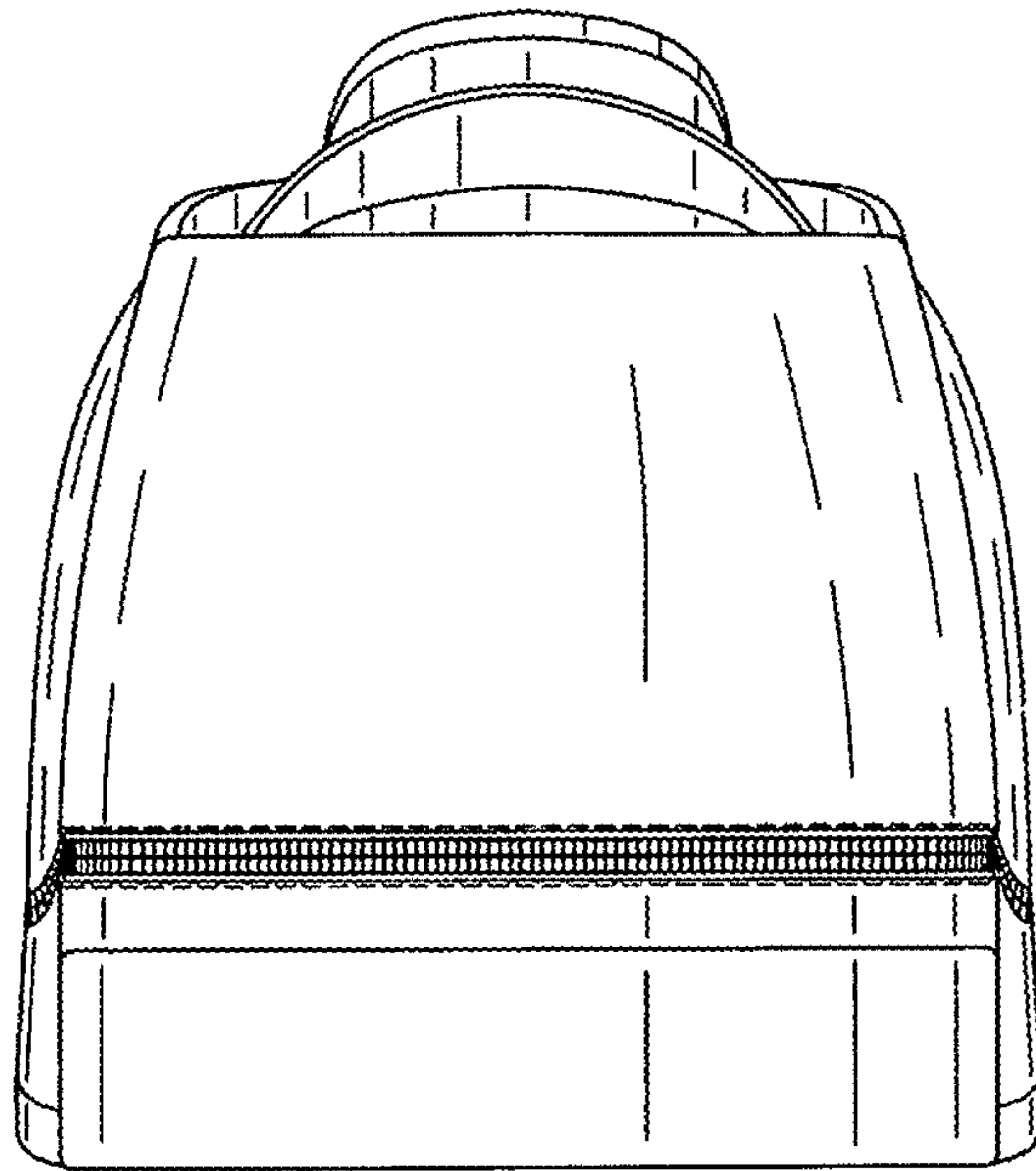

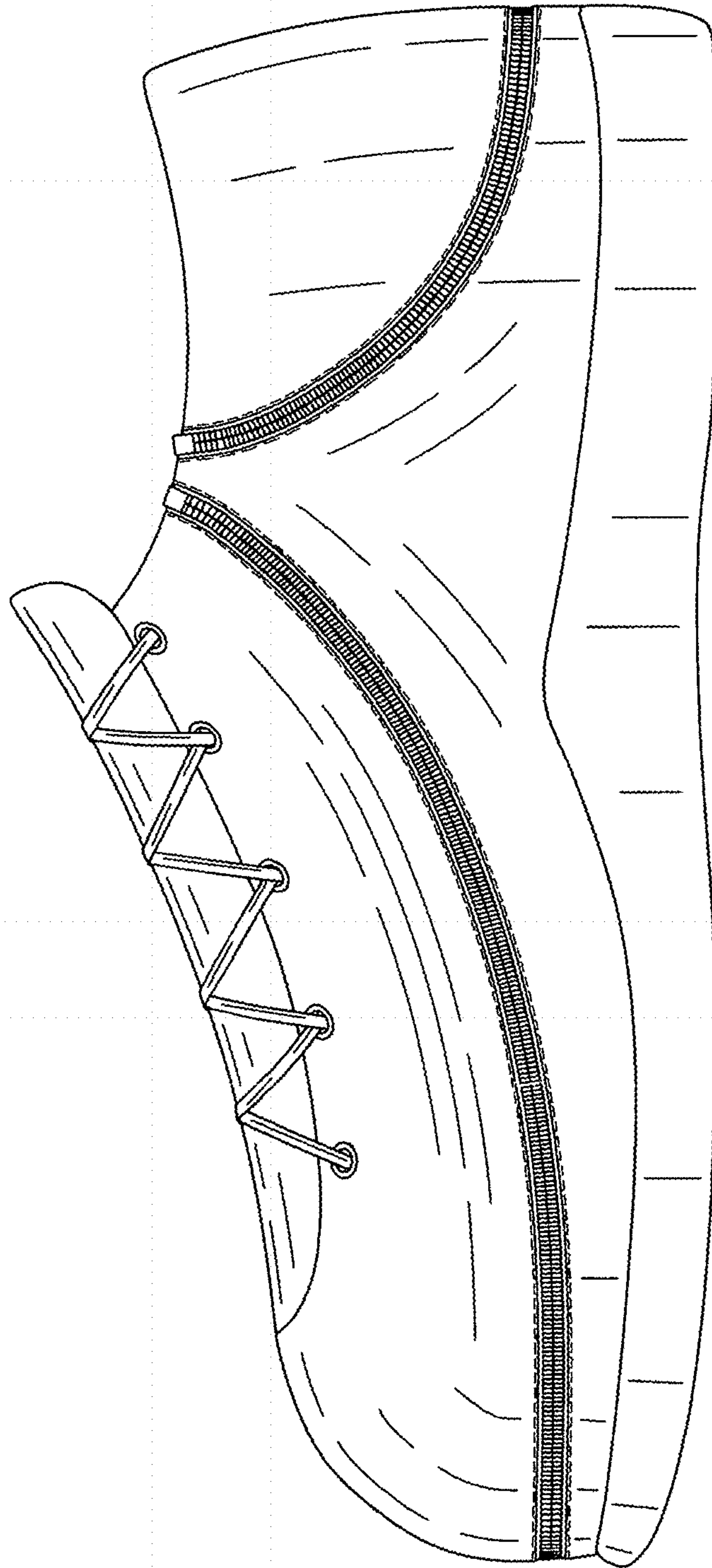

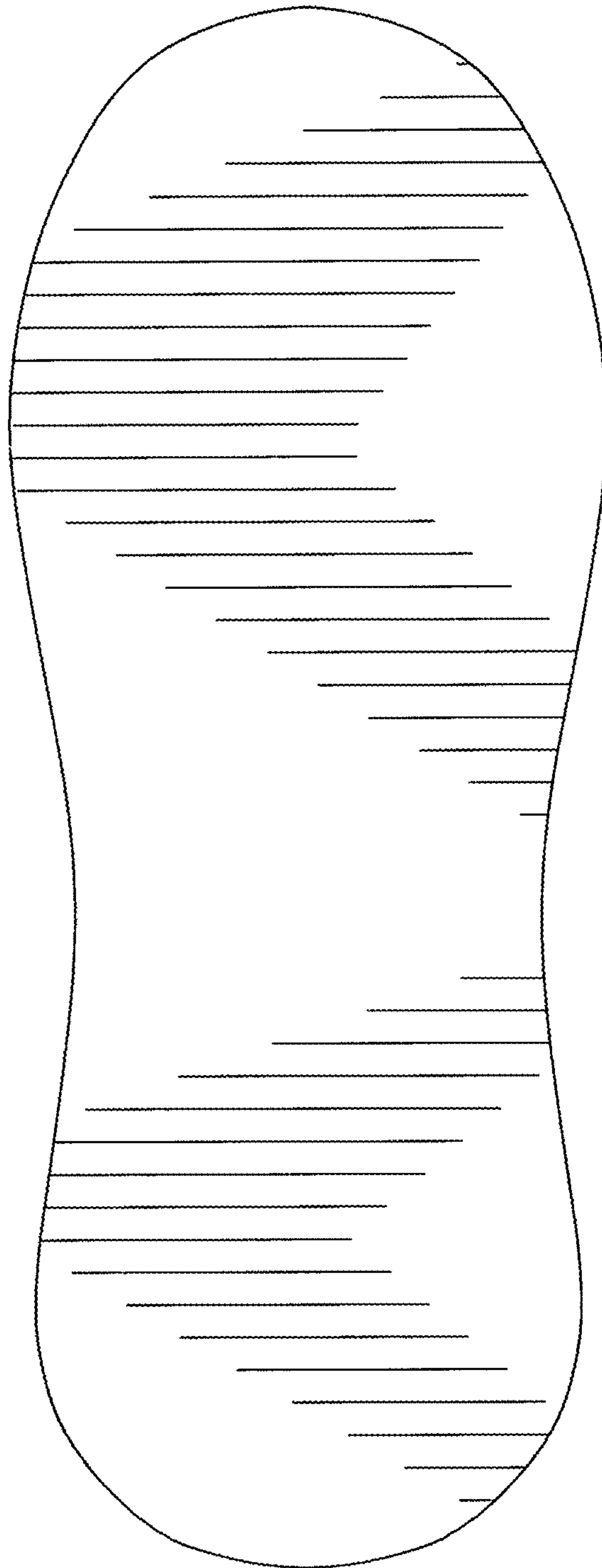

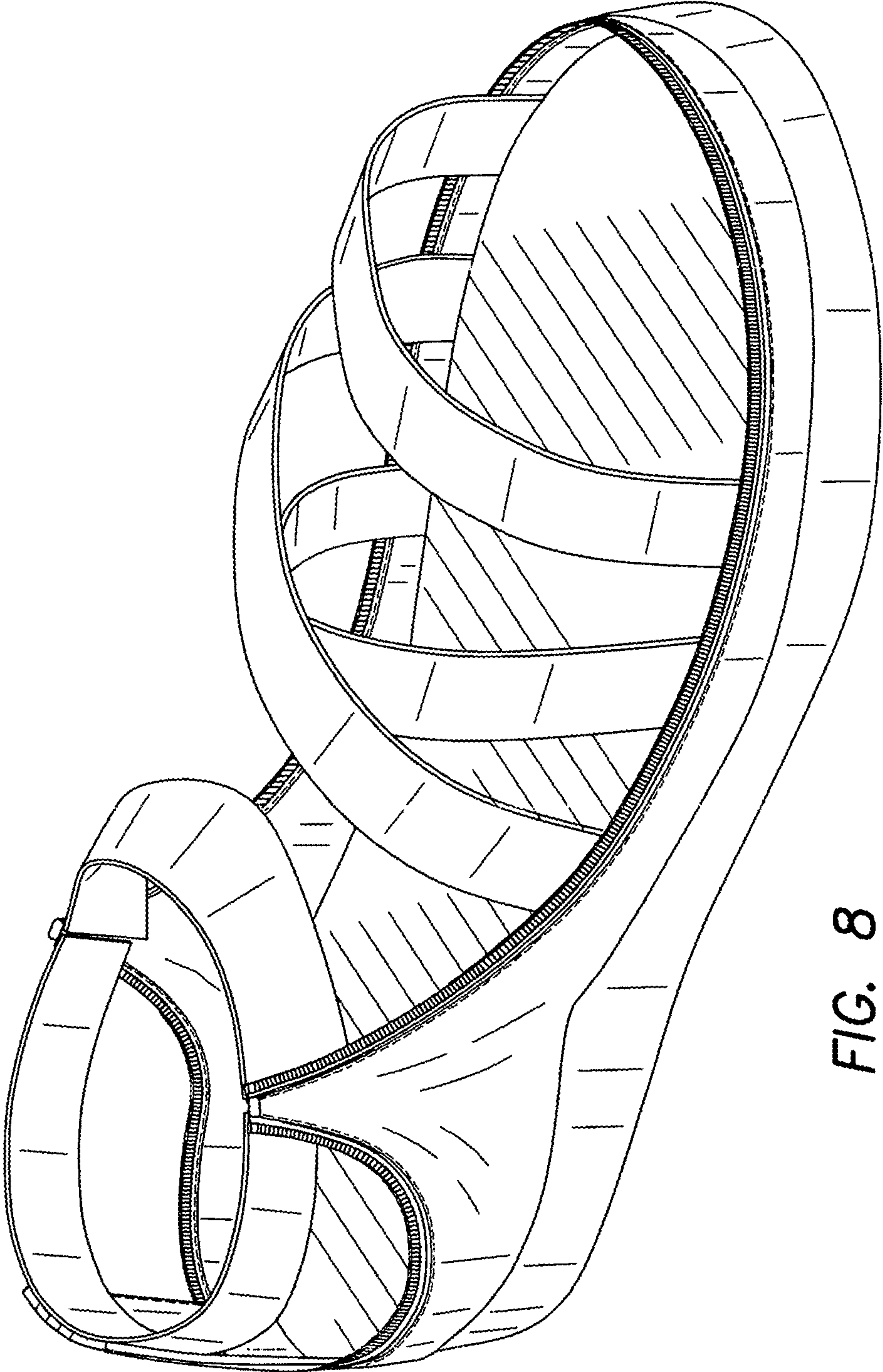

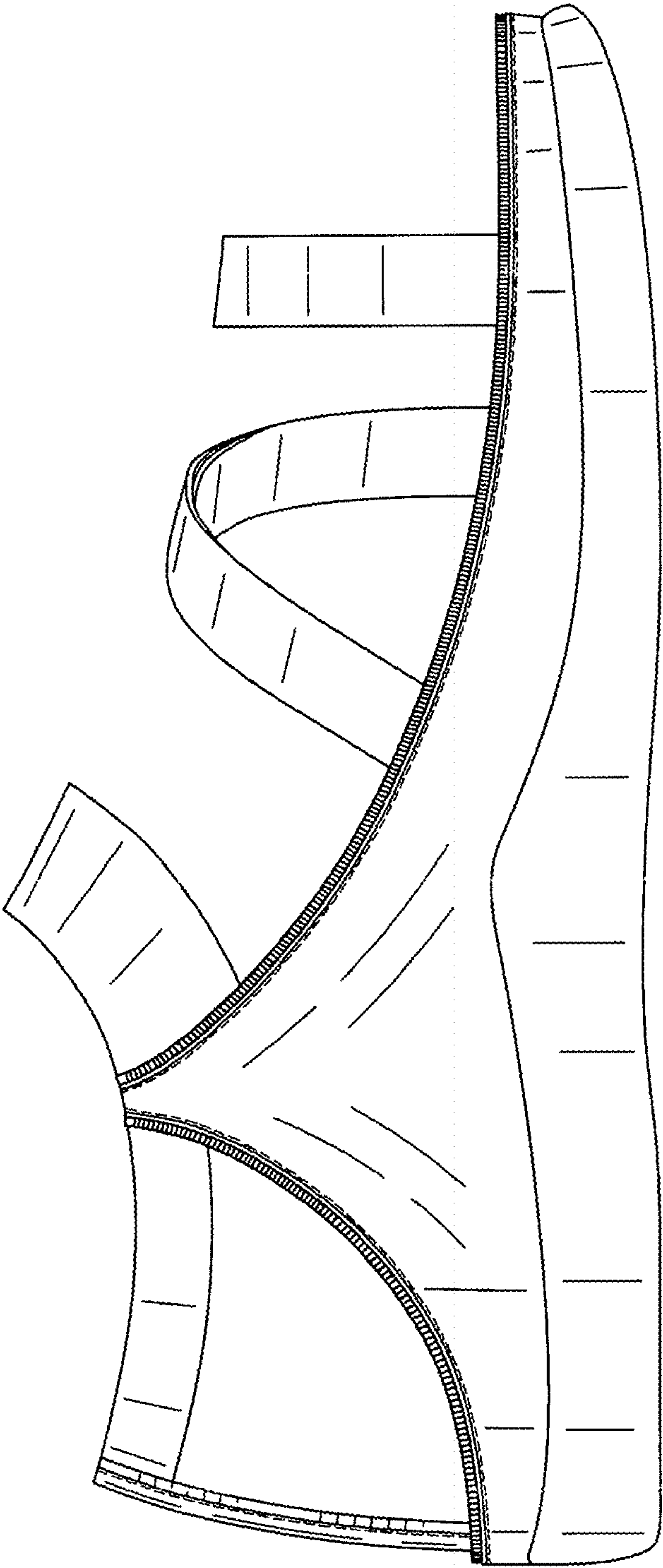

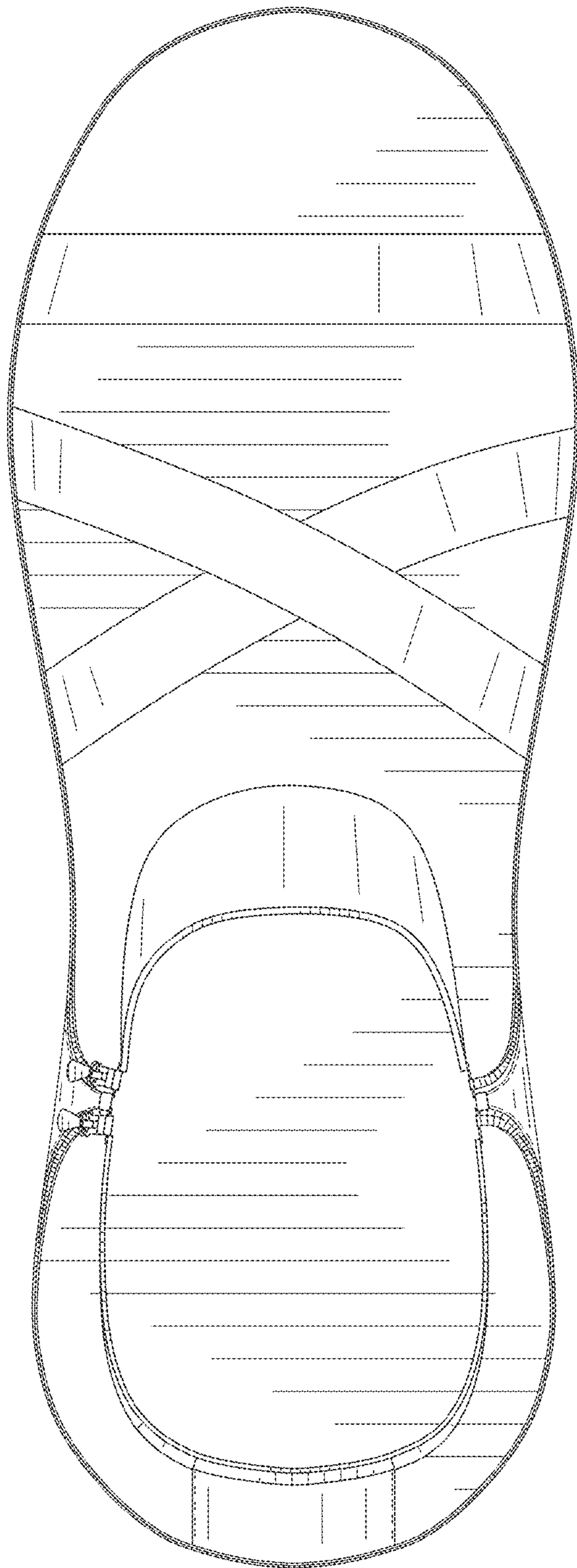

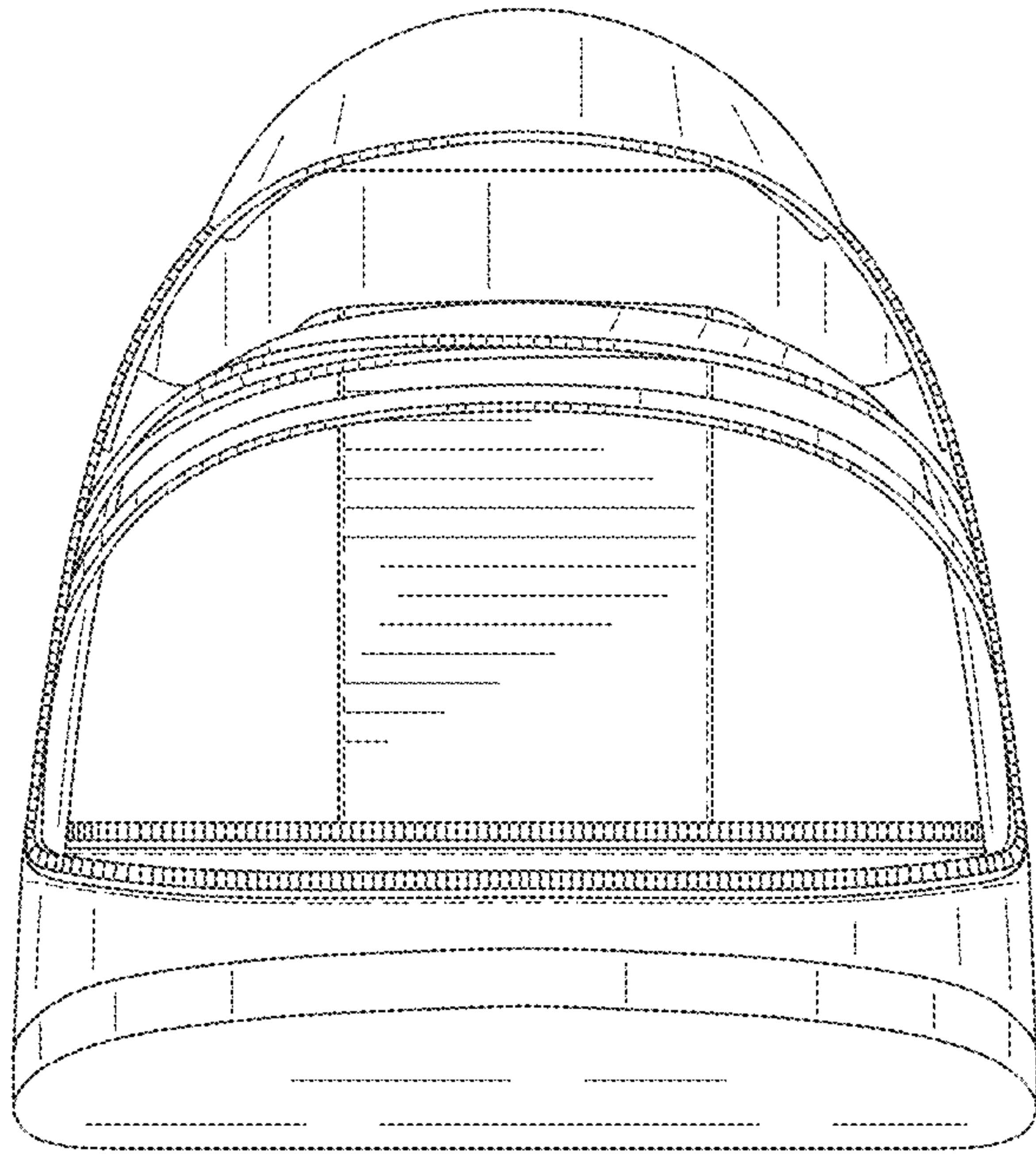

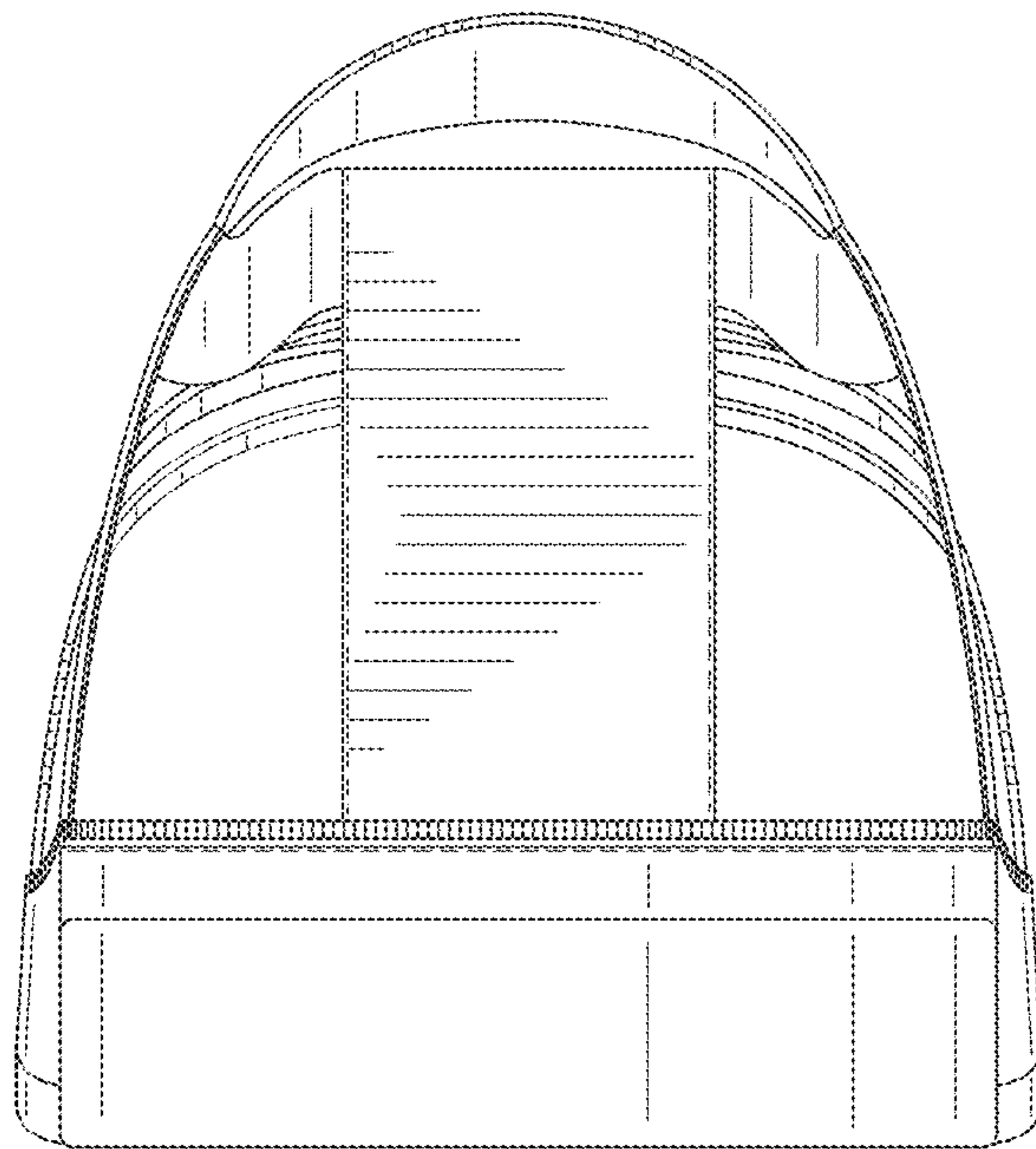

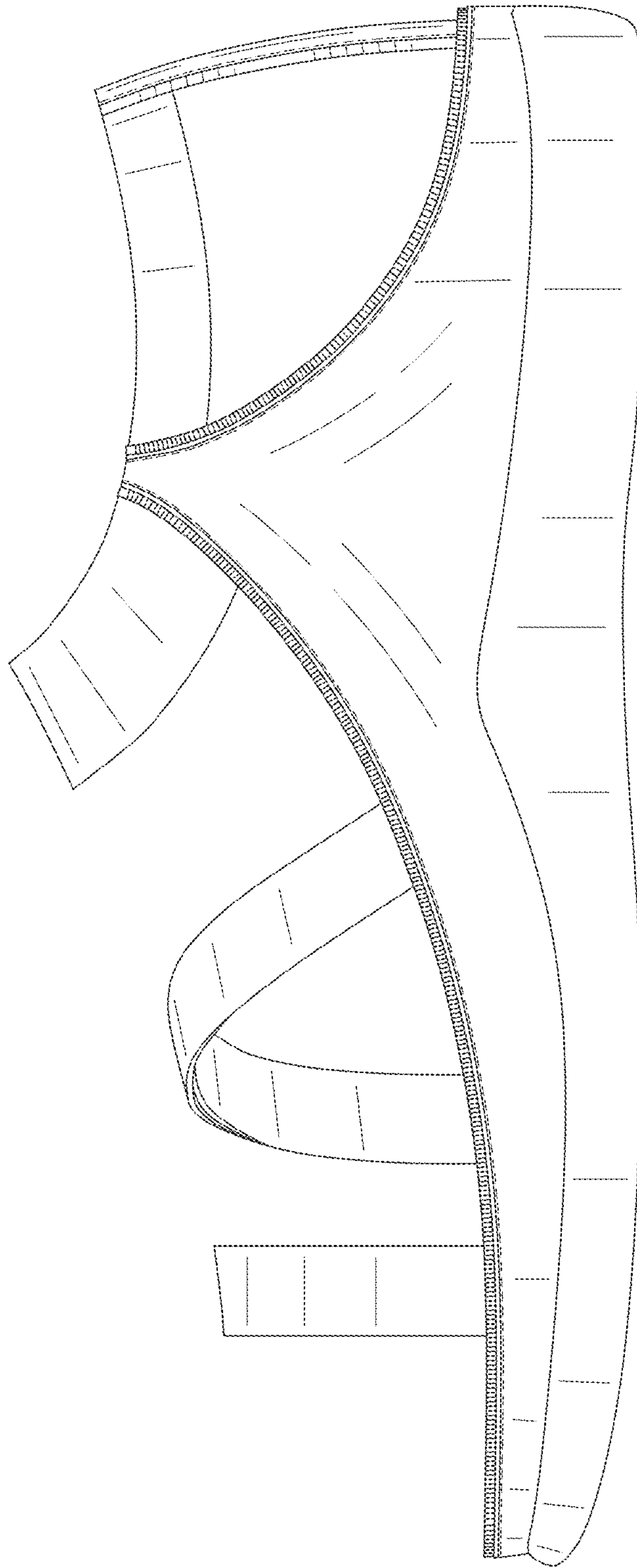

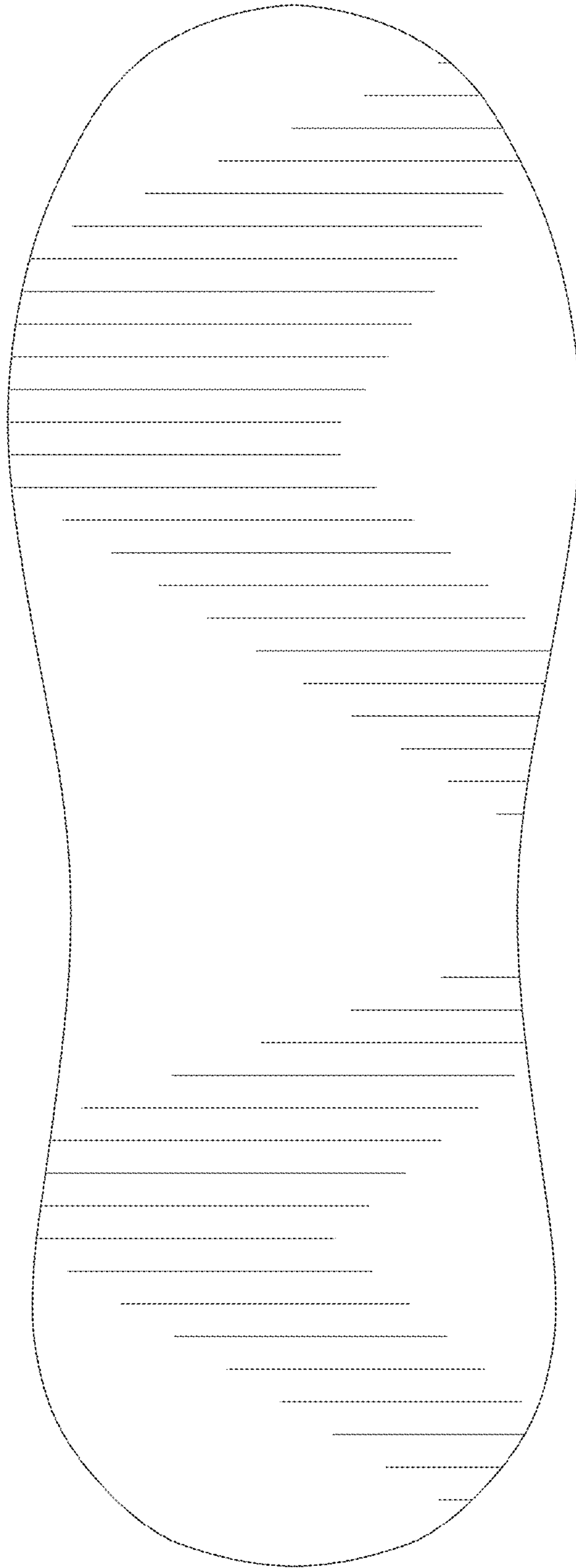
