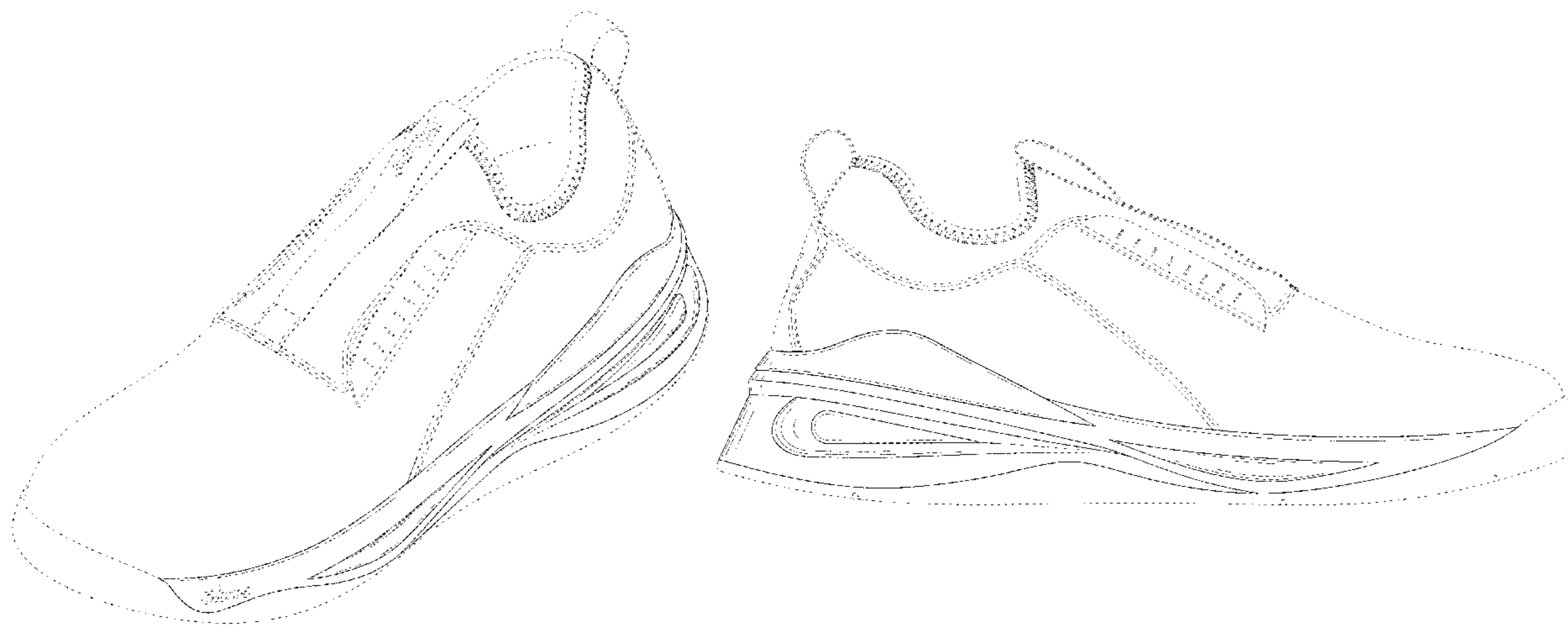
(57) **CLAIM**

The ornamental design for a periphery of an outsole, as shown and described.

DESCRIPTION

FIG. 1 is a top front perspective view of a periphery of an outsole showing our new design;
FIG. 2 is a bottom rear perspective view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a medial side view thereof;
FIG. 6 is a lateral side view thereof;
FIG. 7 is a top plan view thereof; and,
FIG. 8 is a bottom plan view thereof.
The broken lines in the drawings depict portions of the periphery of an outsole that form no part of the claimed design.

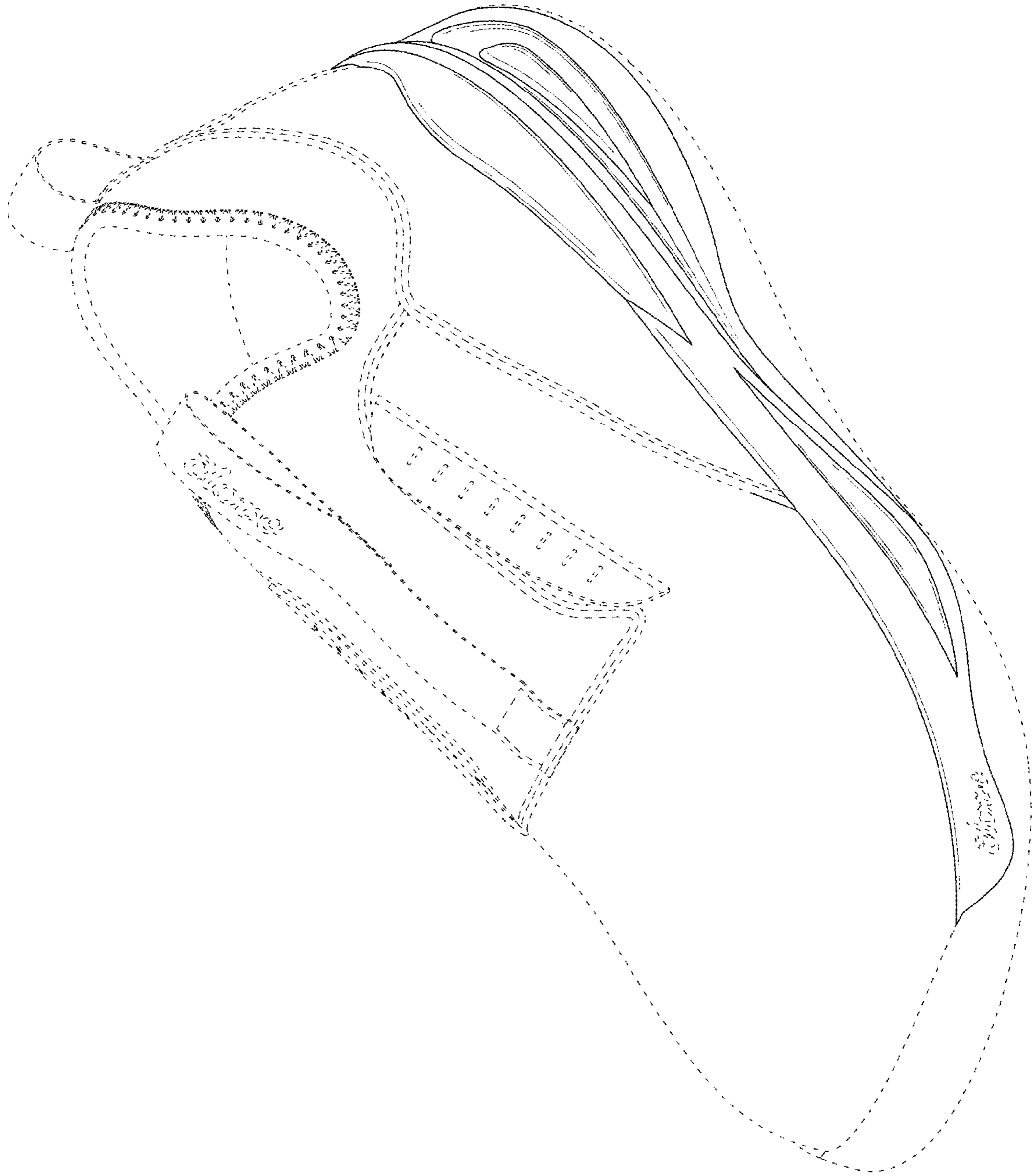

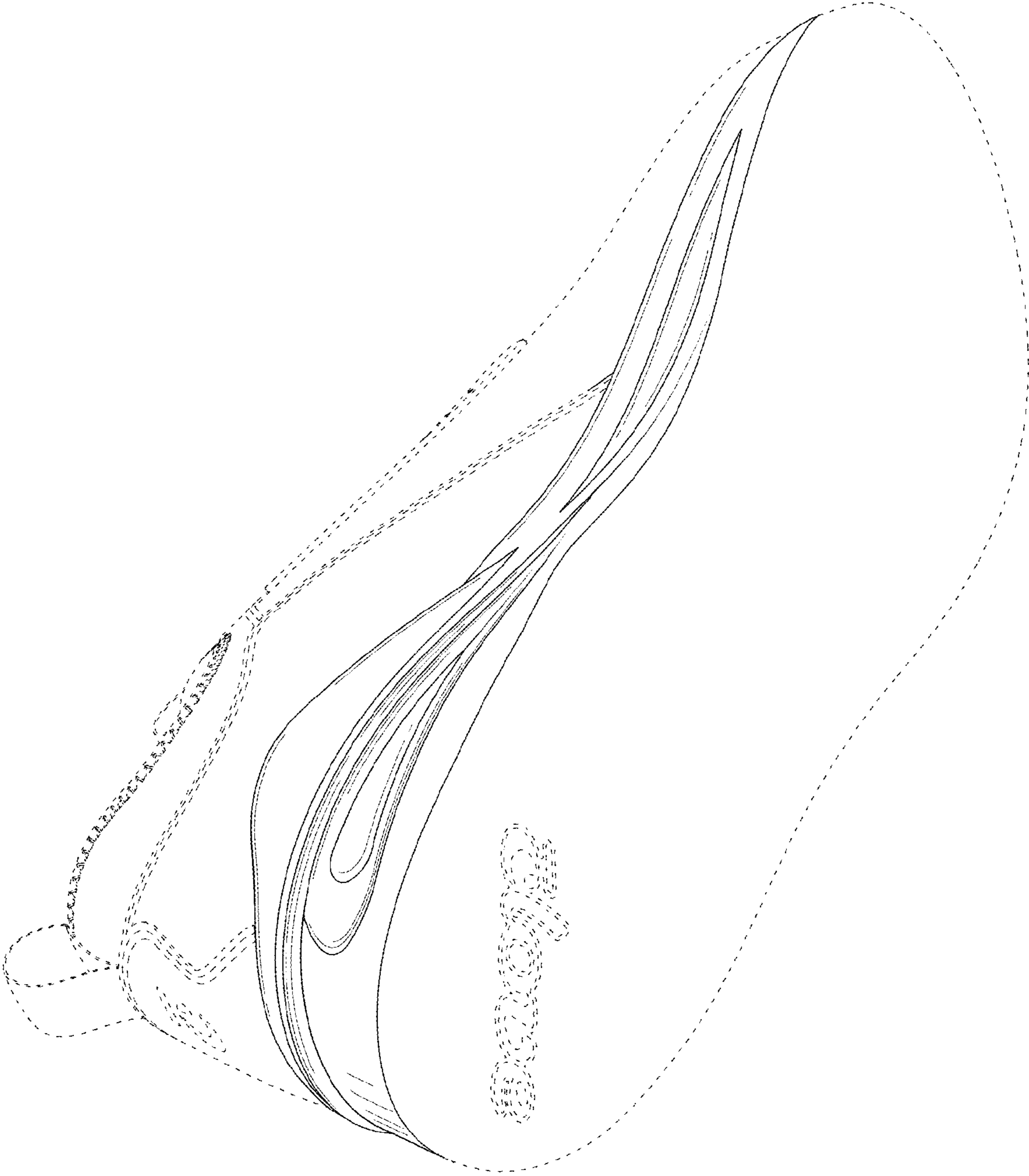

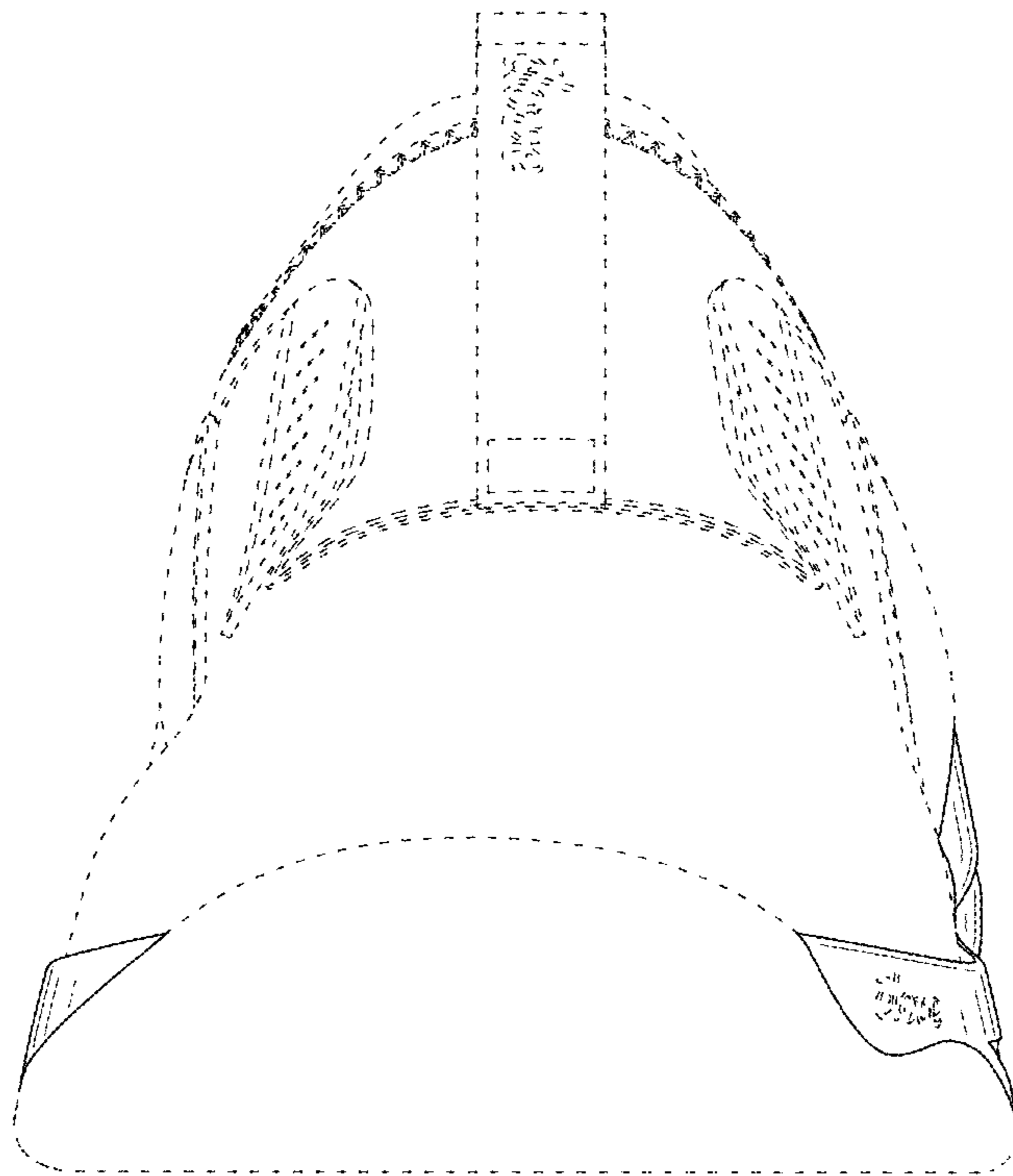

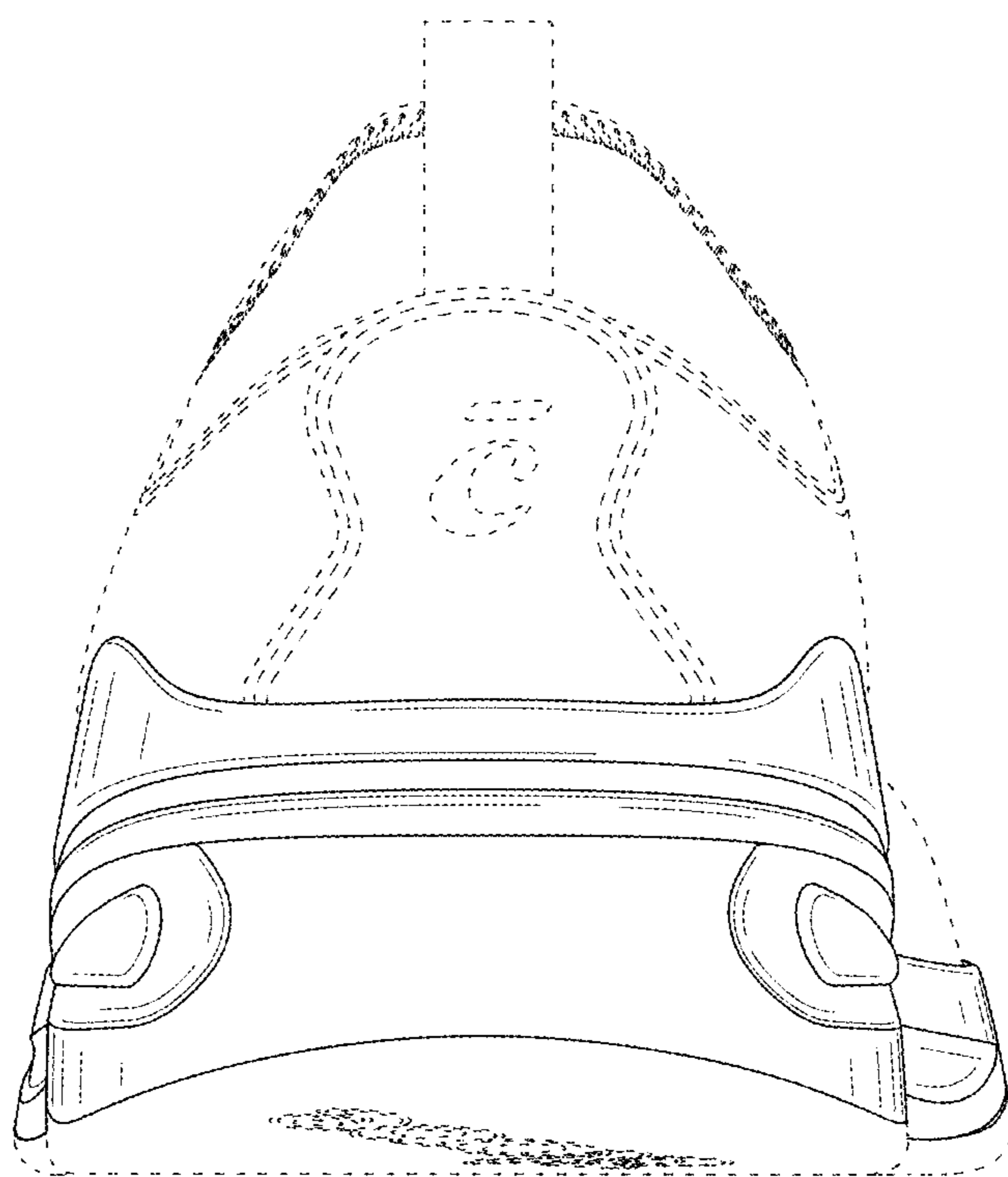

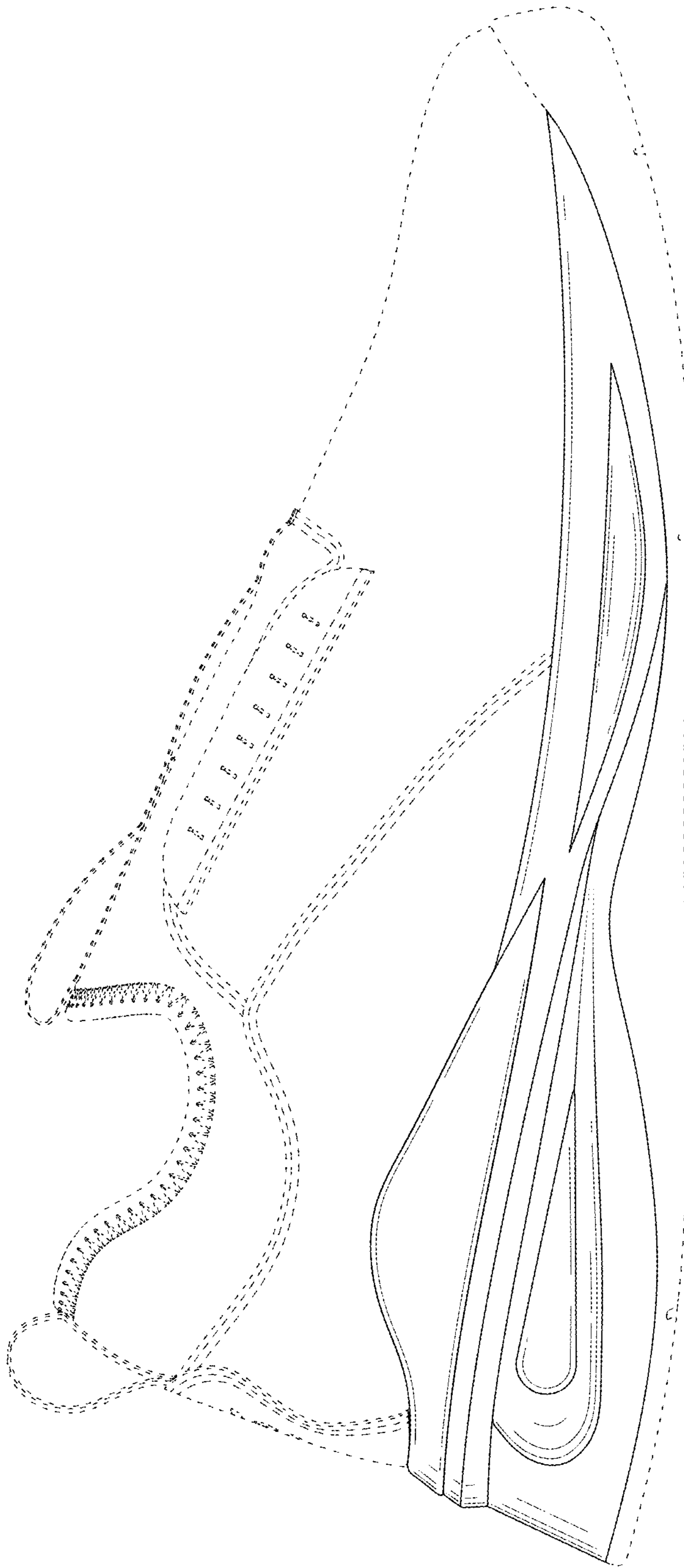

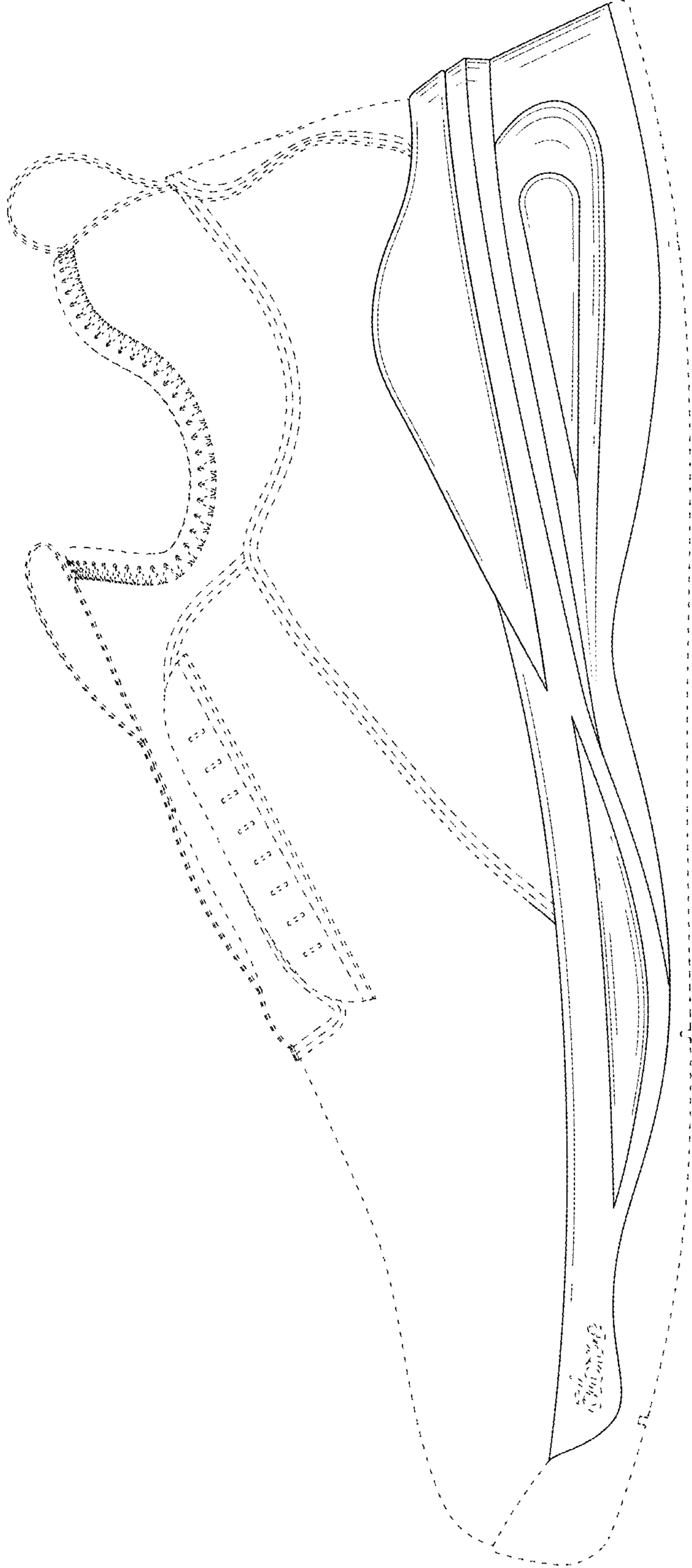

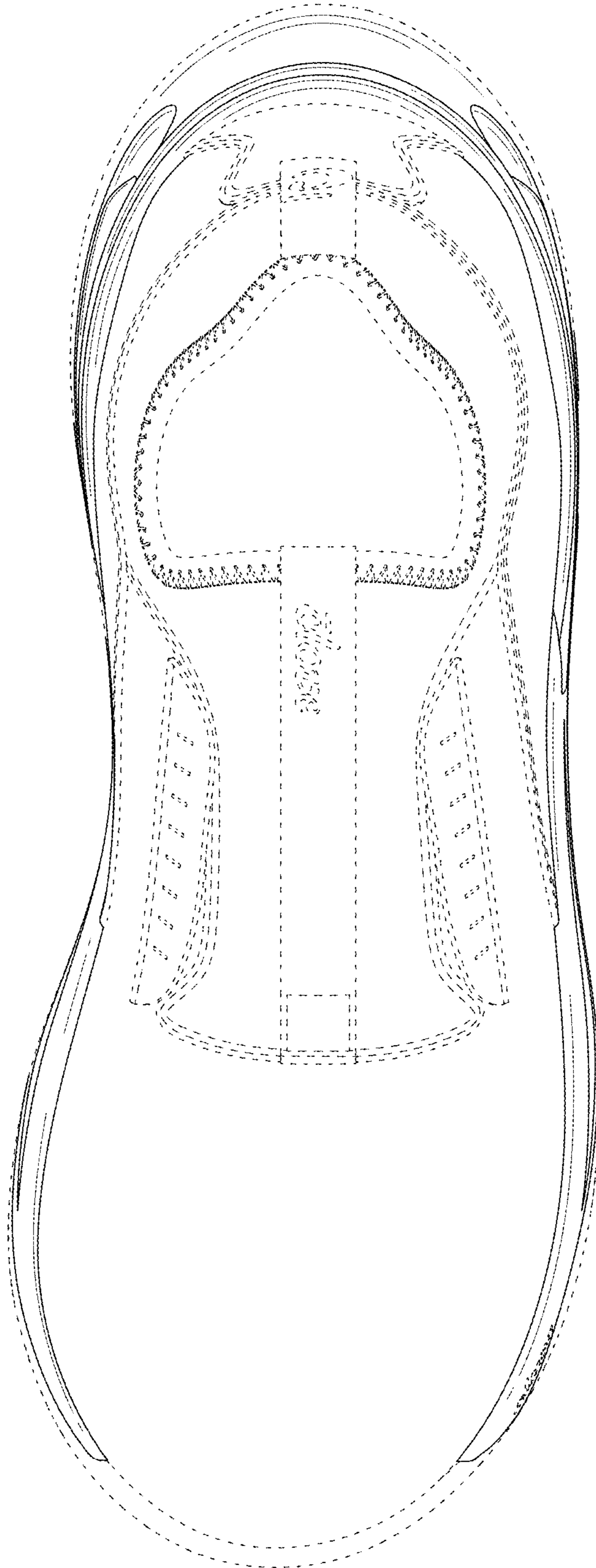

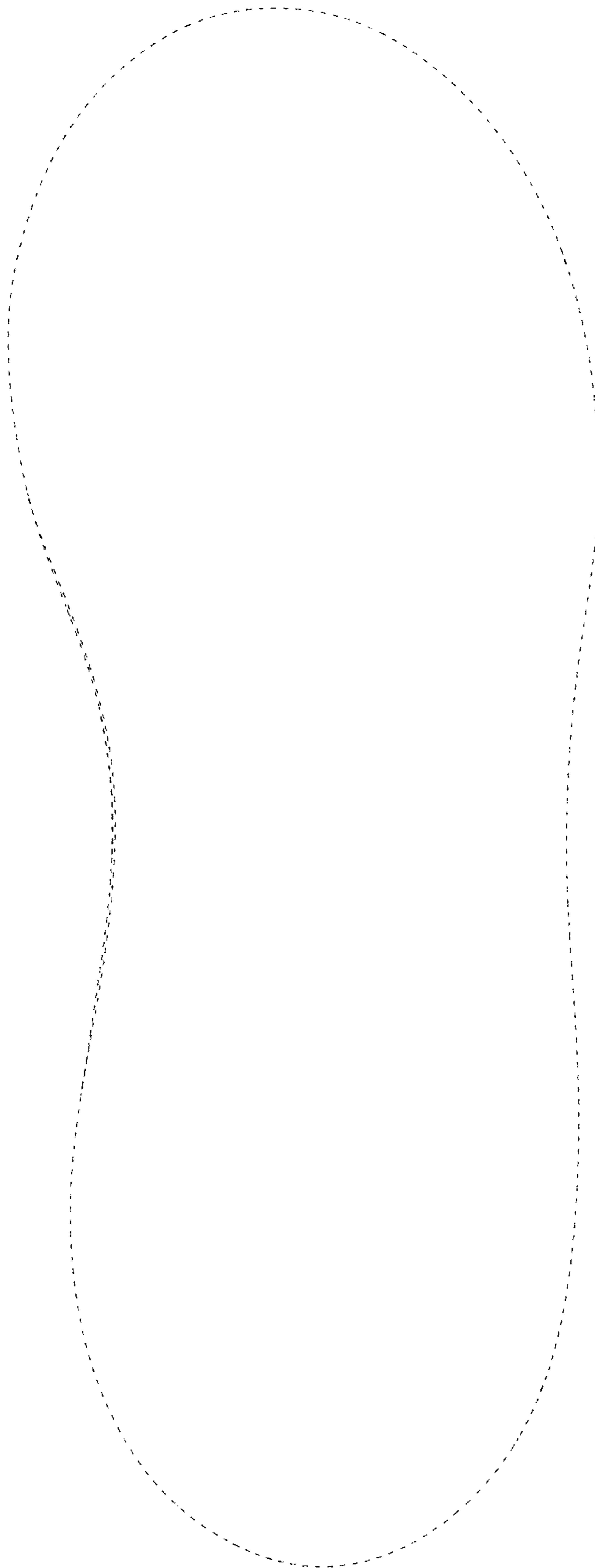
