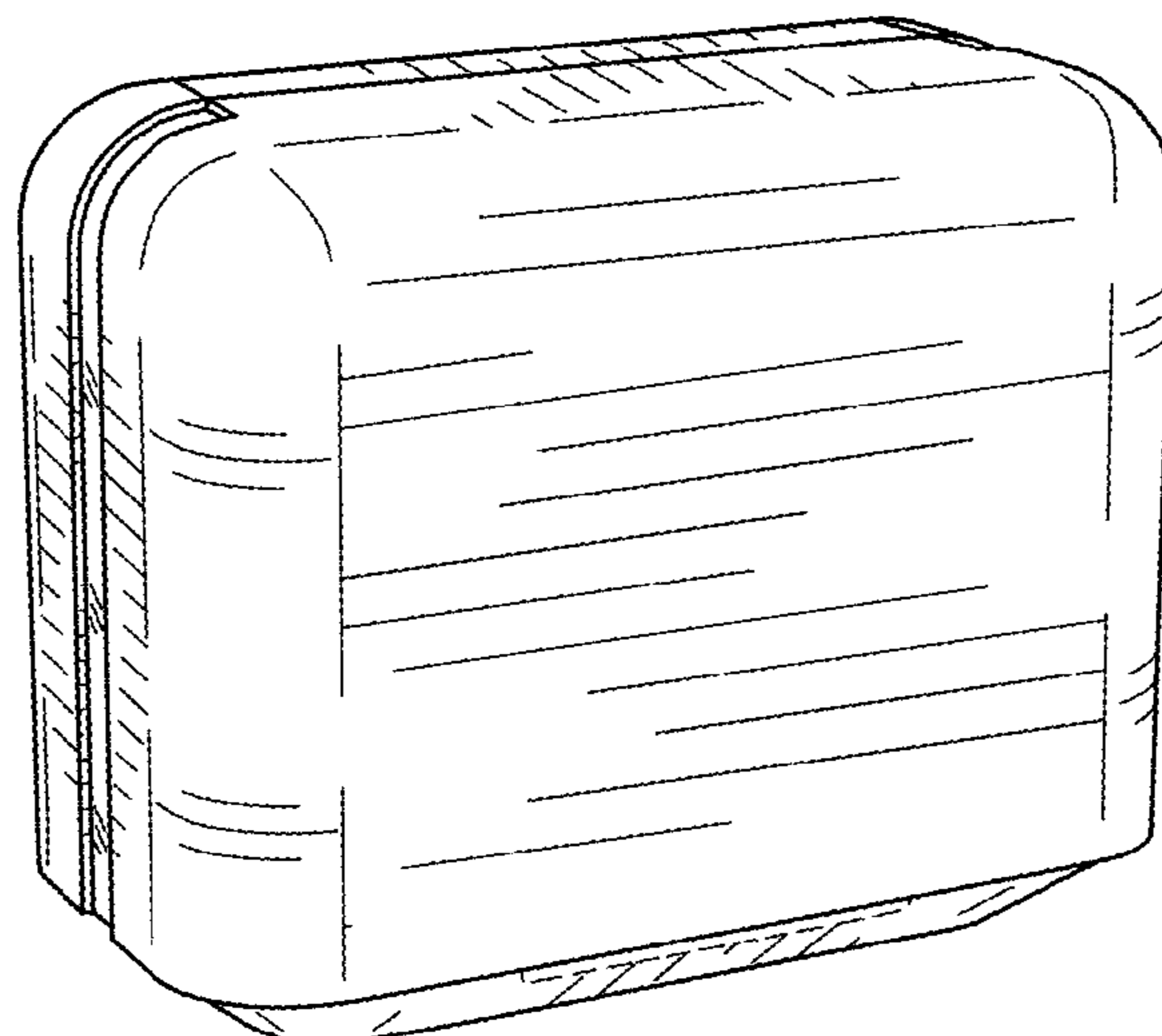
The ornamental design for a paper dispenser, as shown and described.

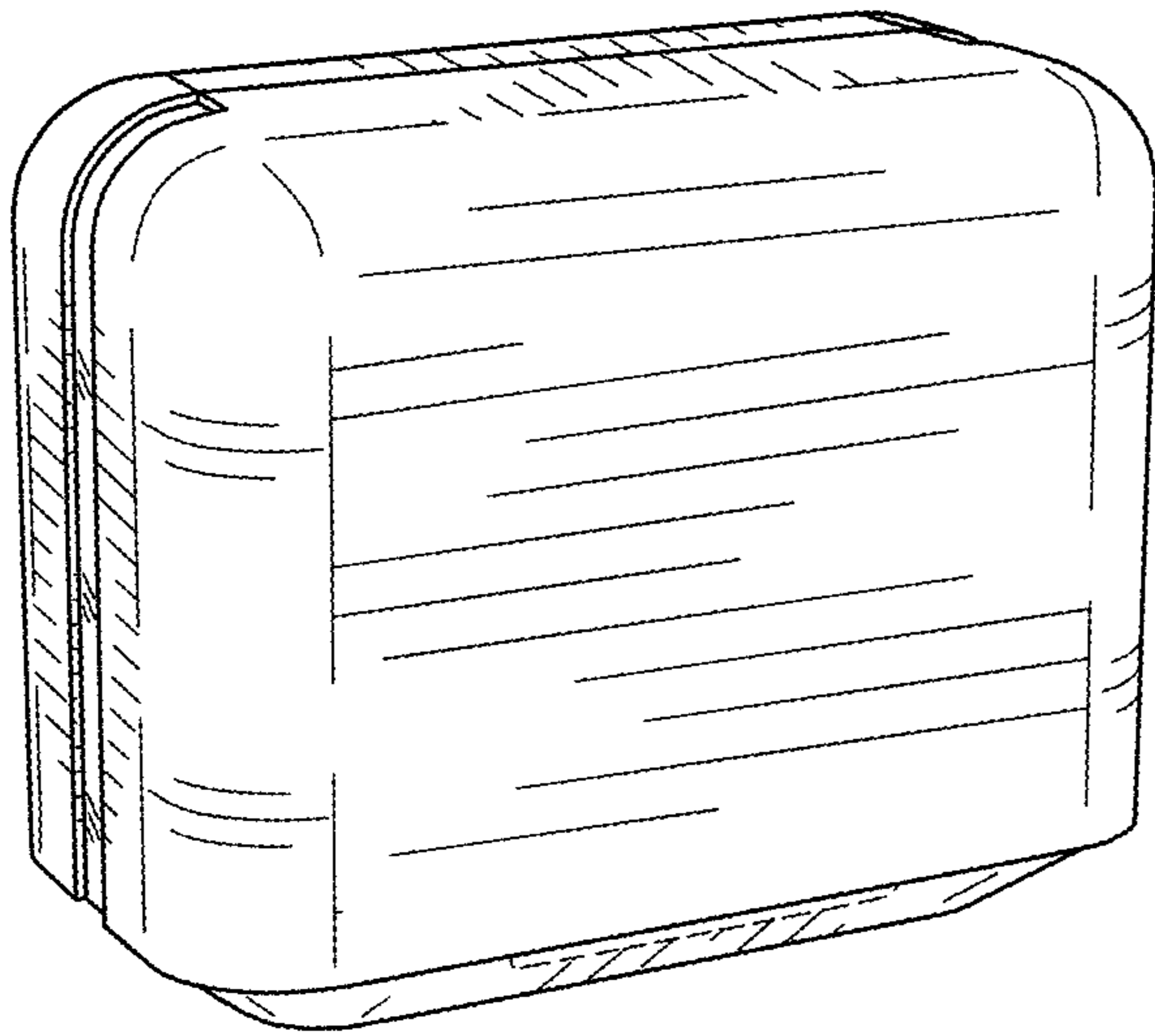

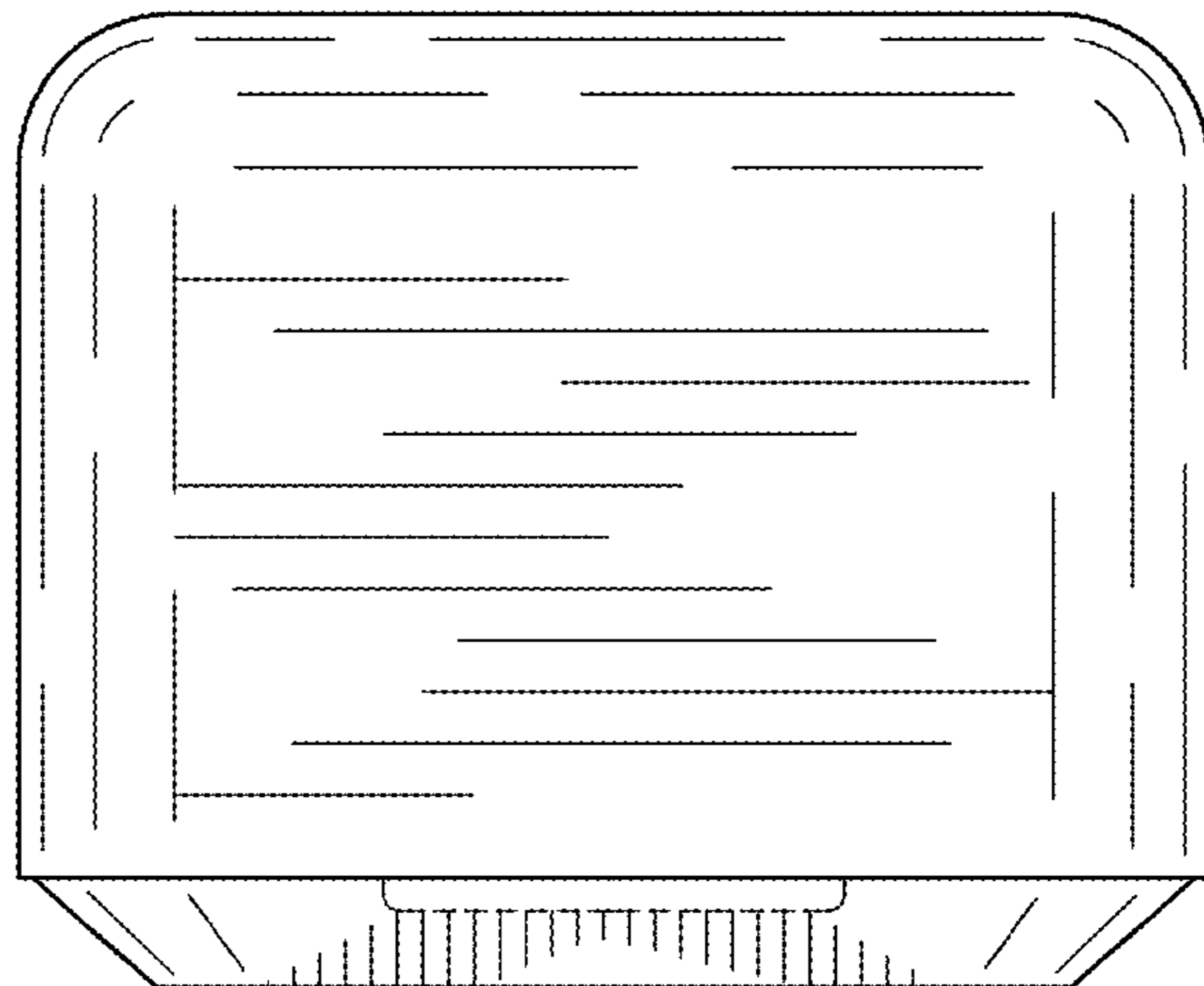

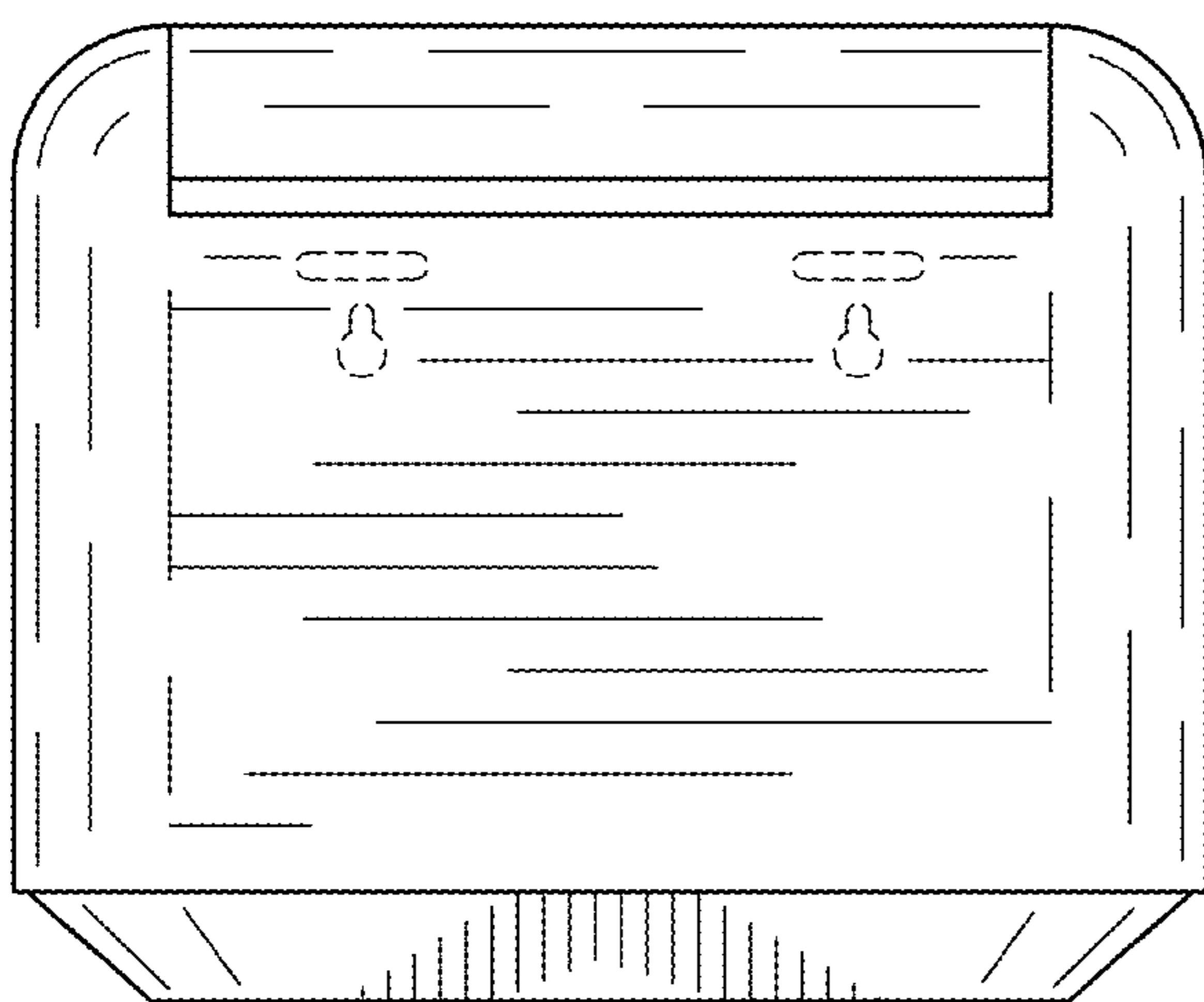

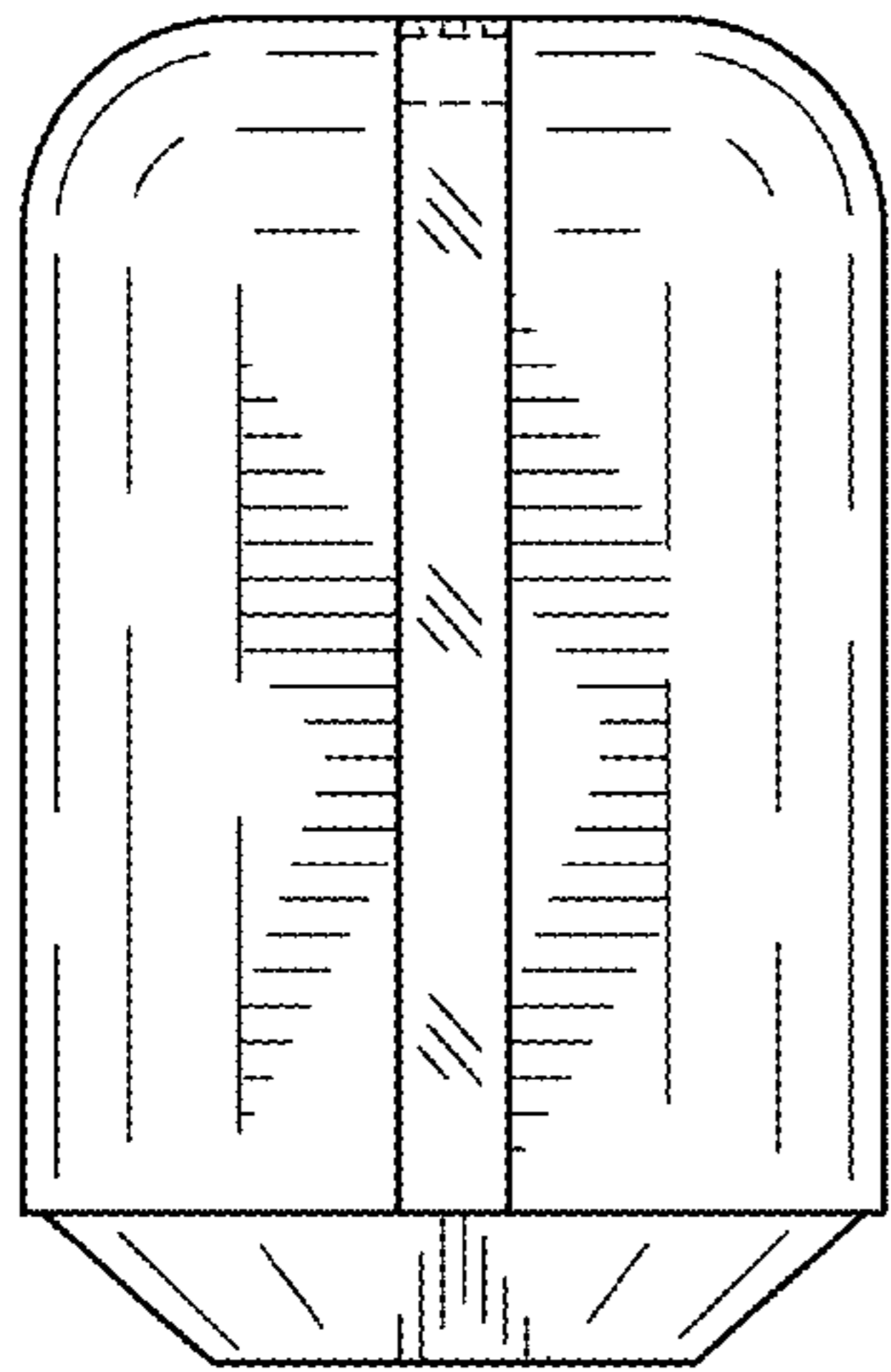

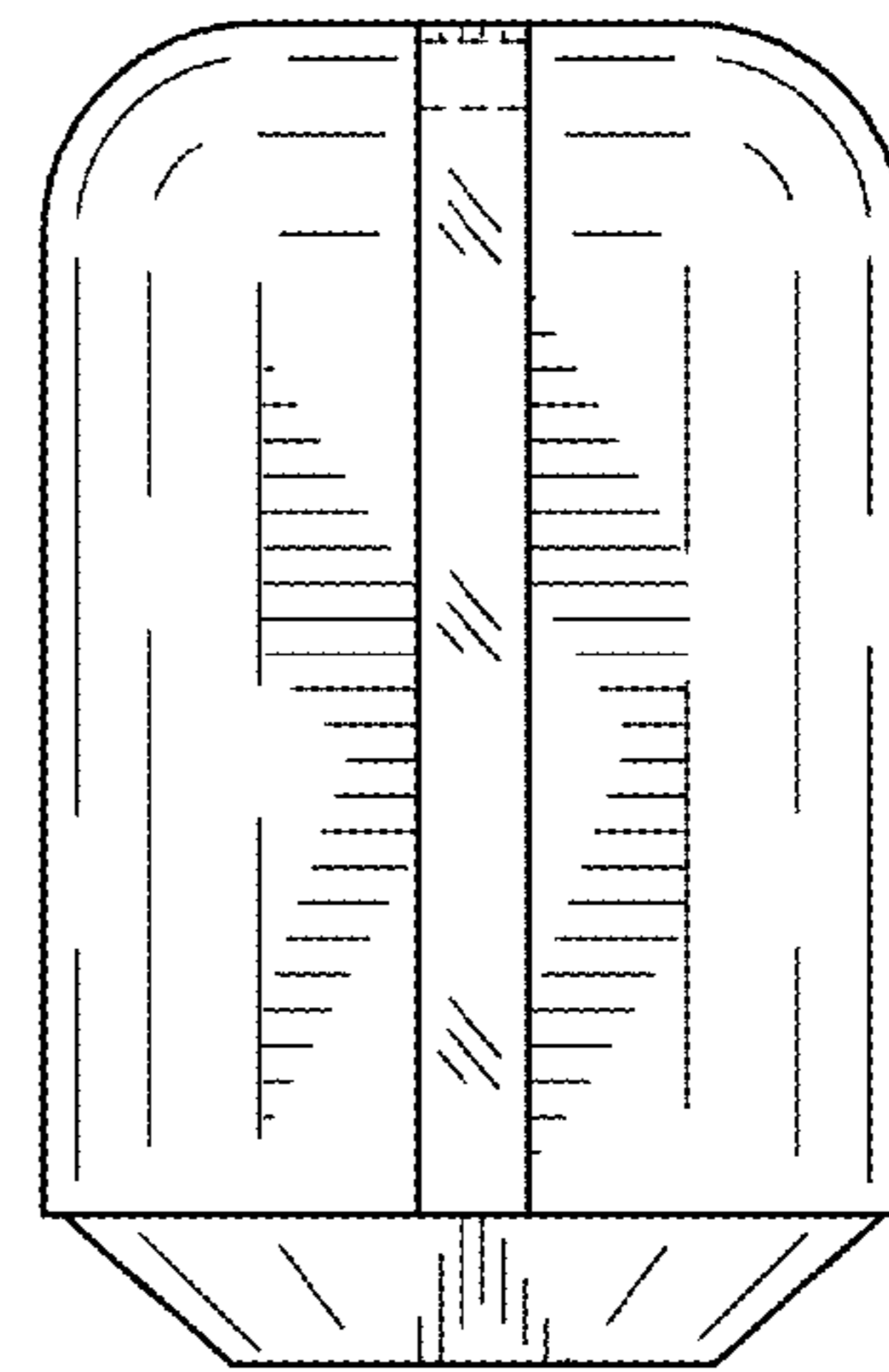

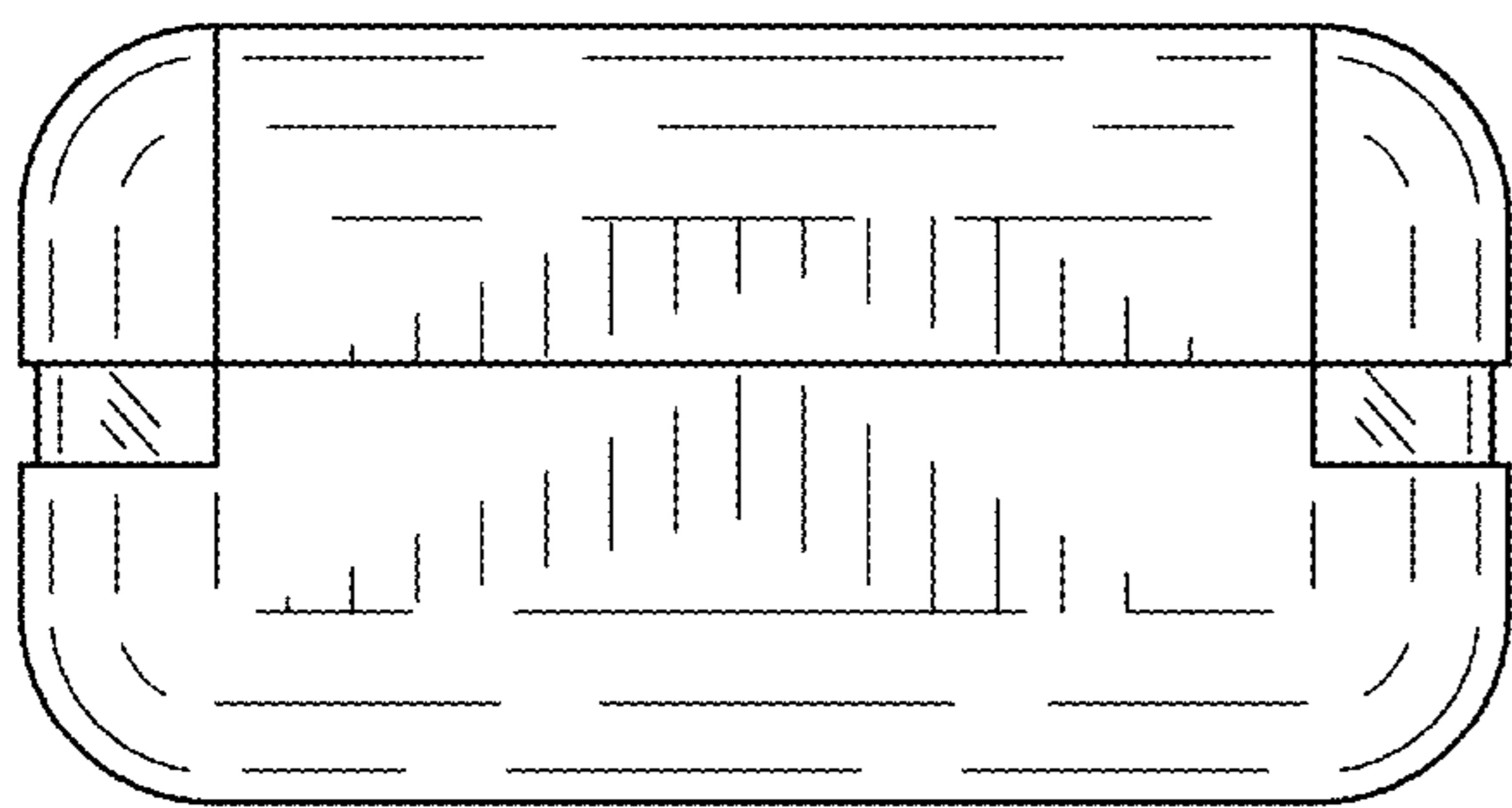

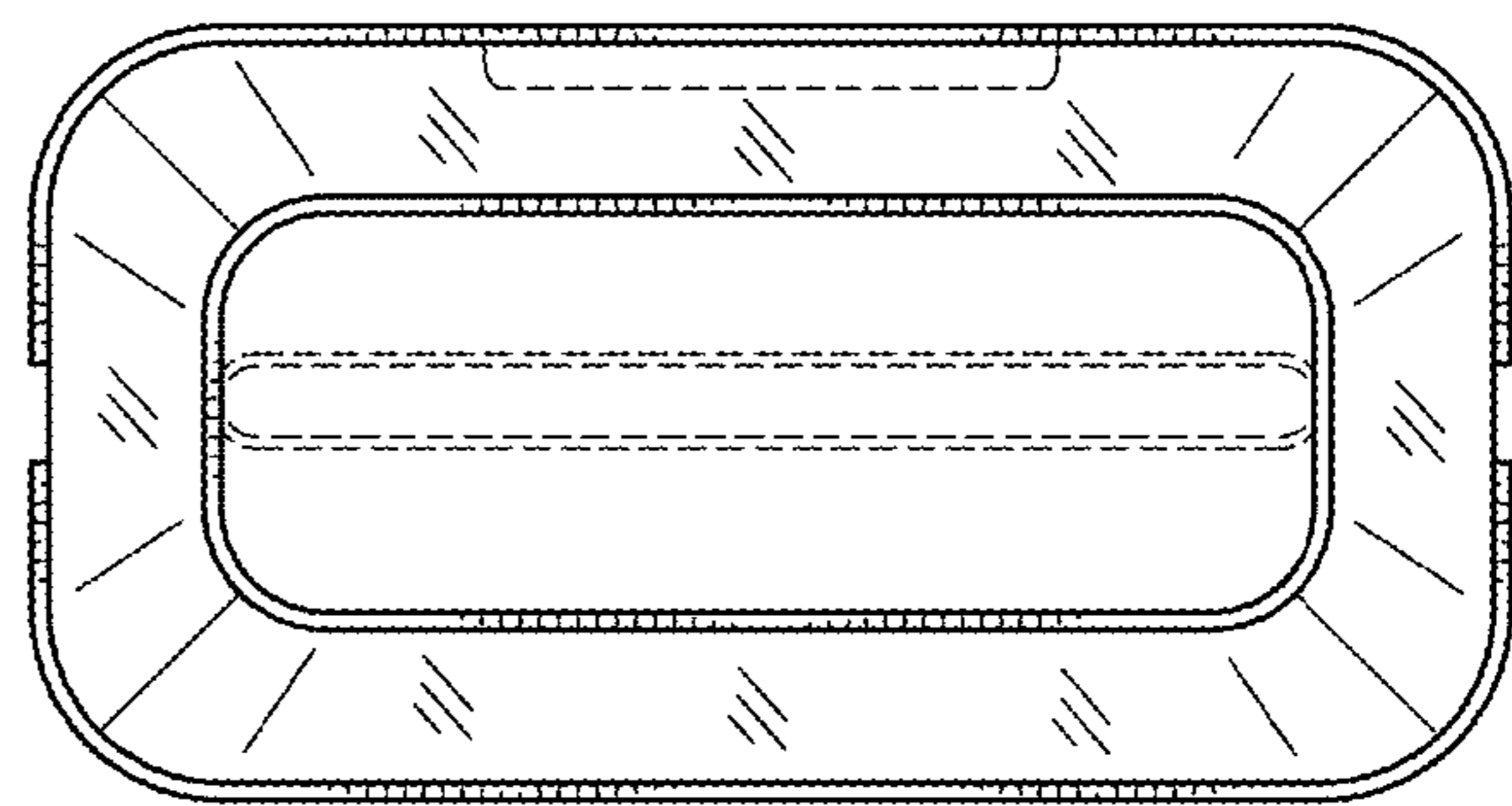
