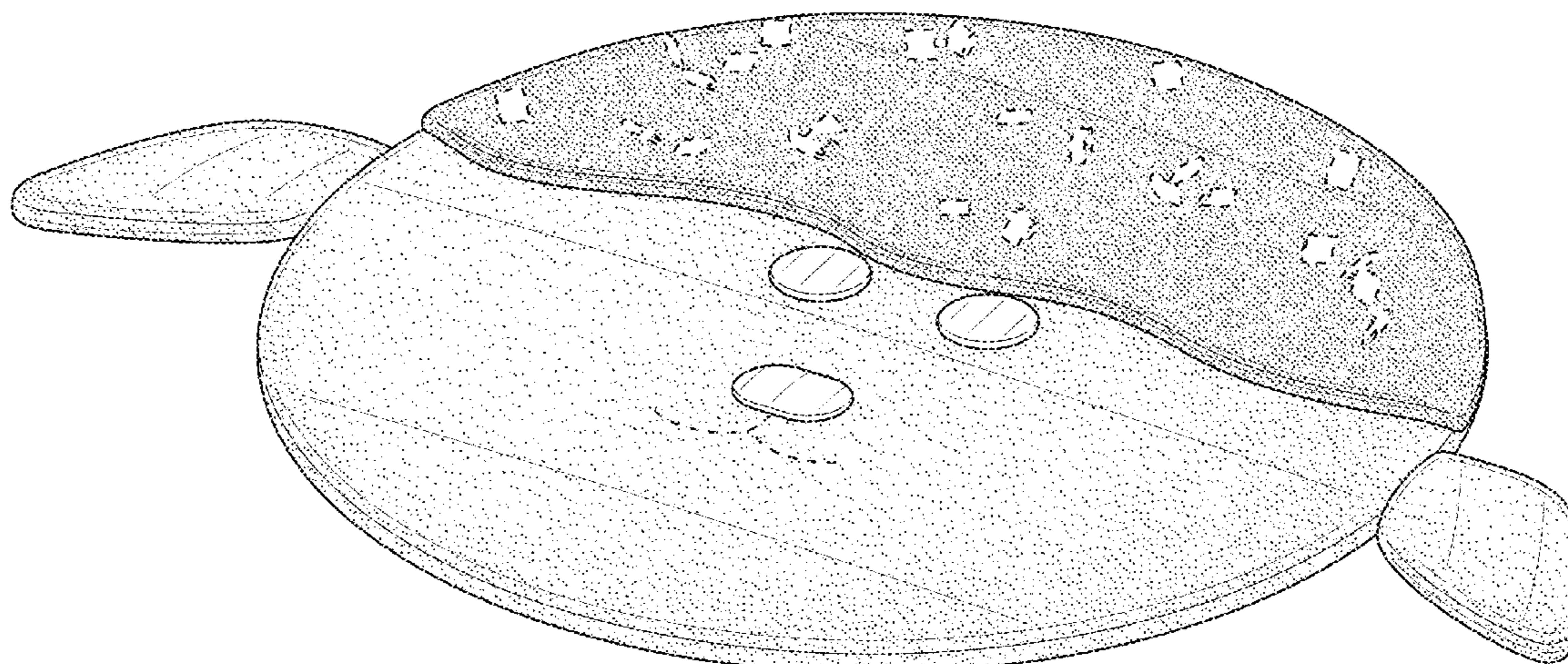

(57) **CLAIM**

The ornamental design for an animal shaped blanket, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of an animal shaped blanket showing my new design;

FIG. 2 is a bottom view thereof;

FIG. 3 is a top view thereof;

FIG. 4 is a left-side view thereof;

FIG. 5 is a right-side view thereof;

FIG. 6 is a front view thereof; and,

FIG. 7 is a back view thereof.

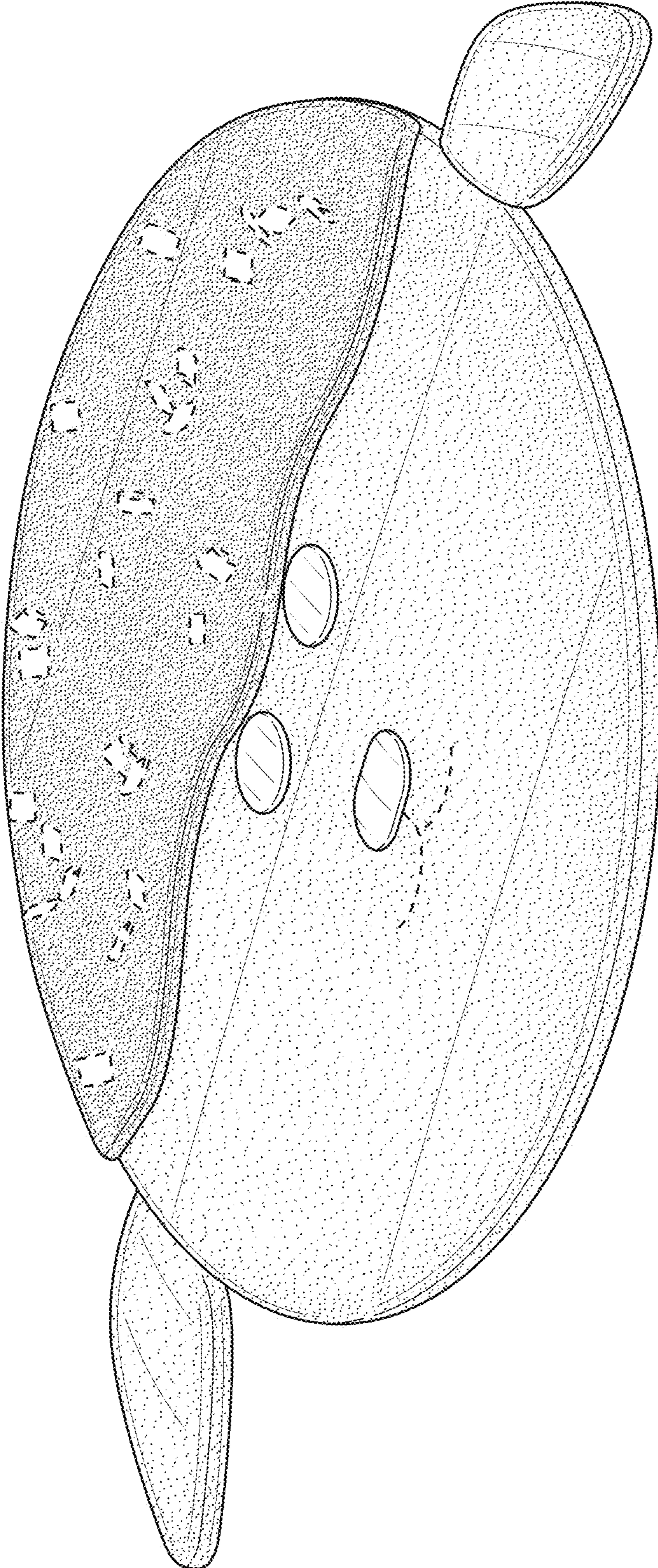

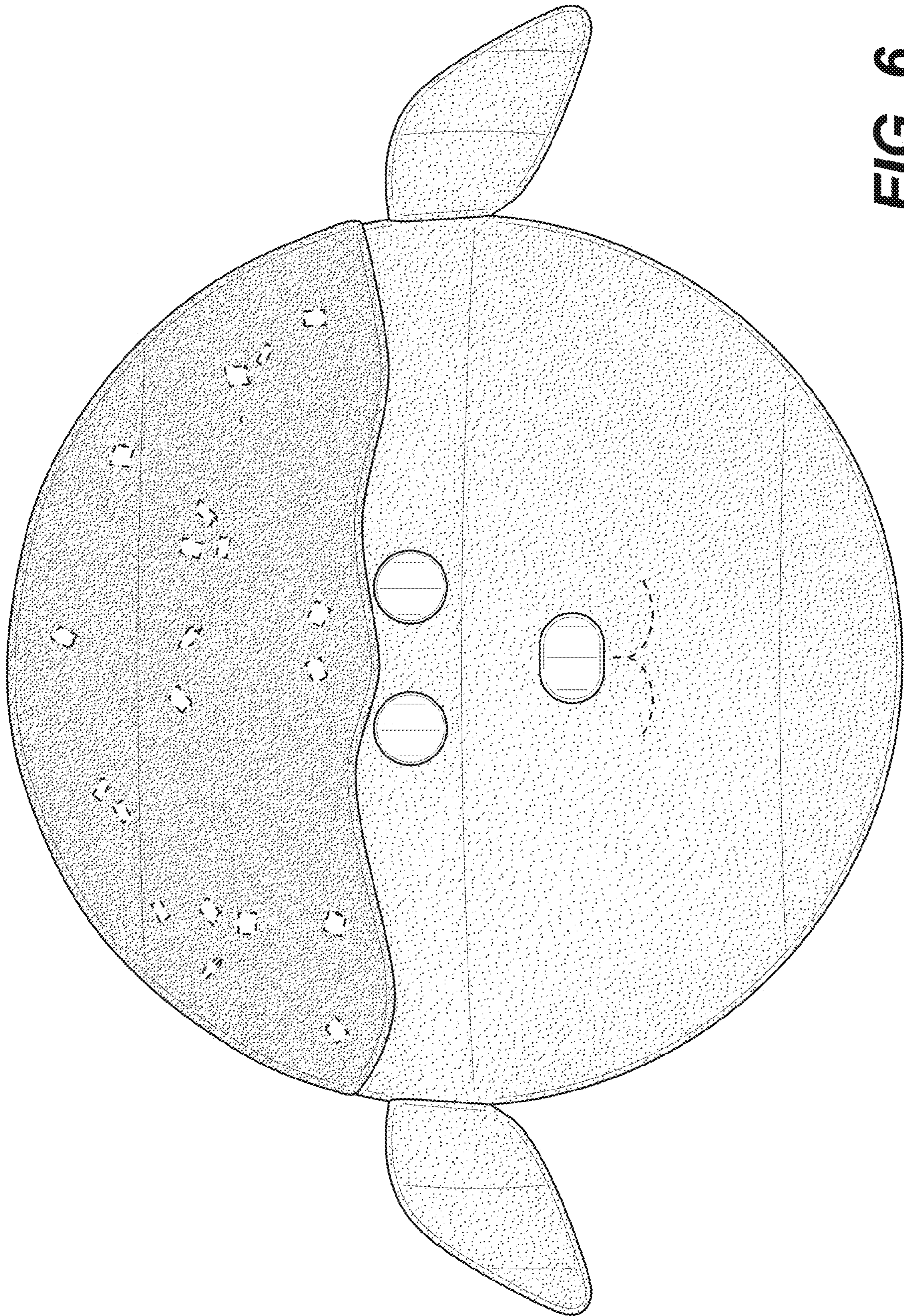

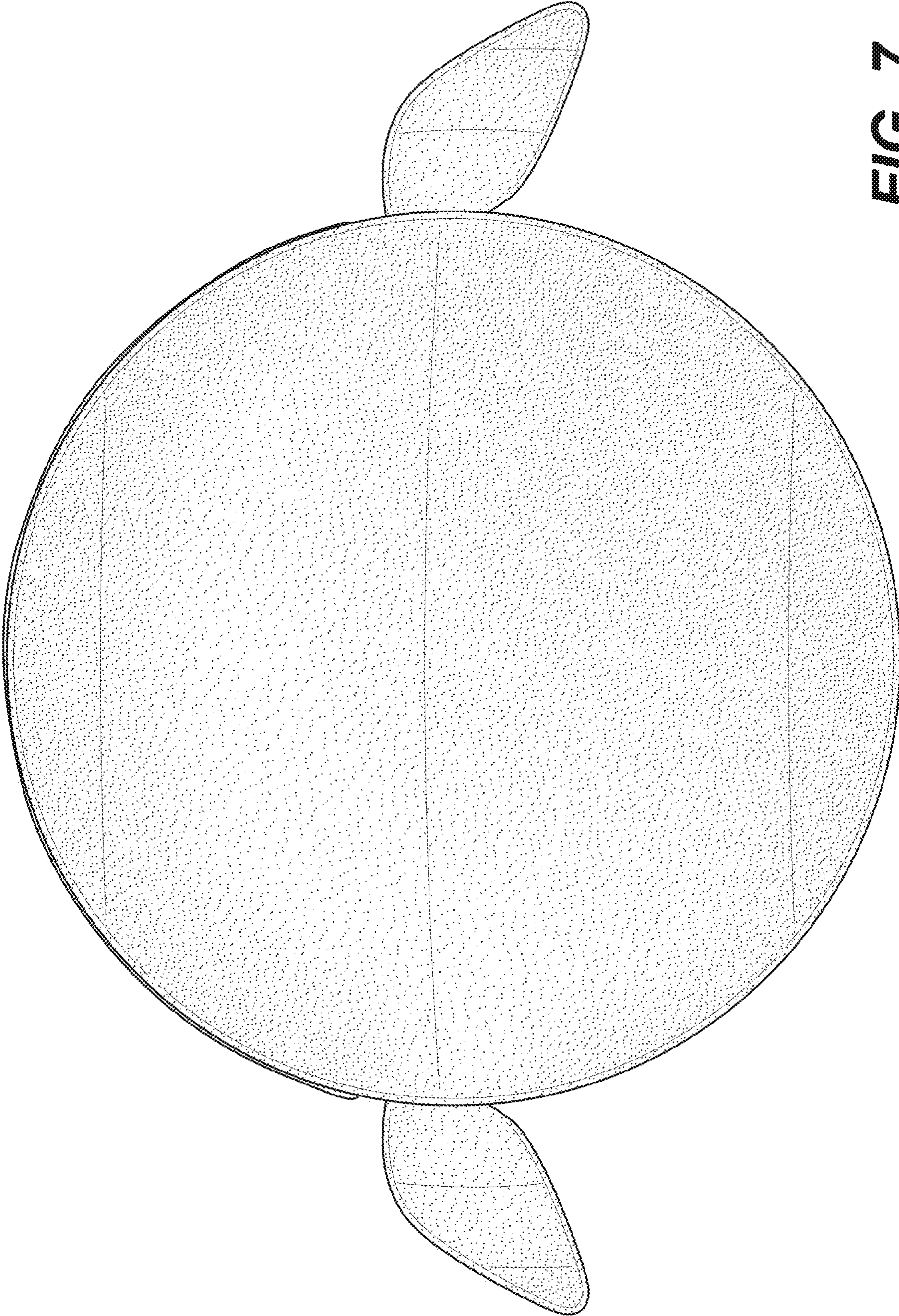
