(57) **CLAIM**

We claim the ornamental design for a countertop appliance, as shown and described.

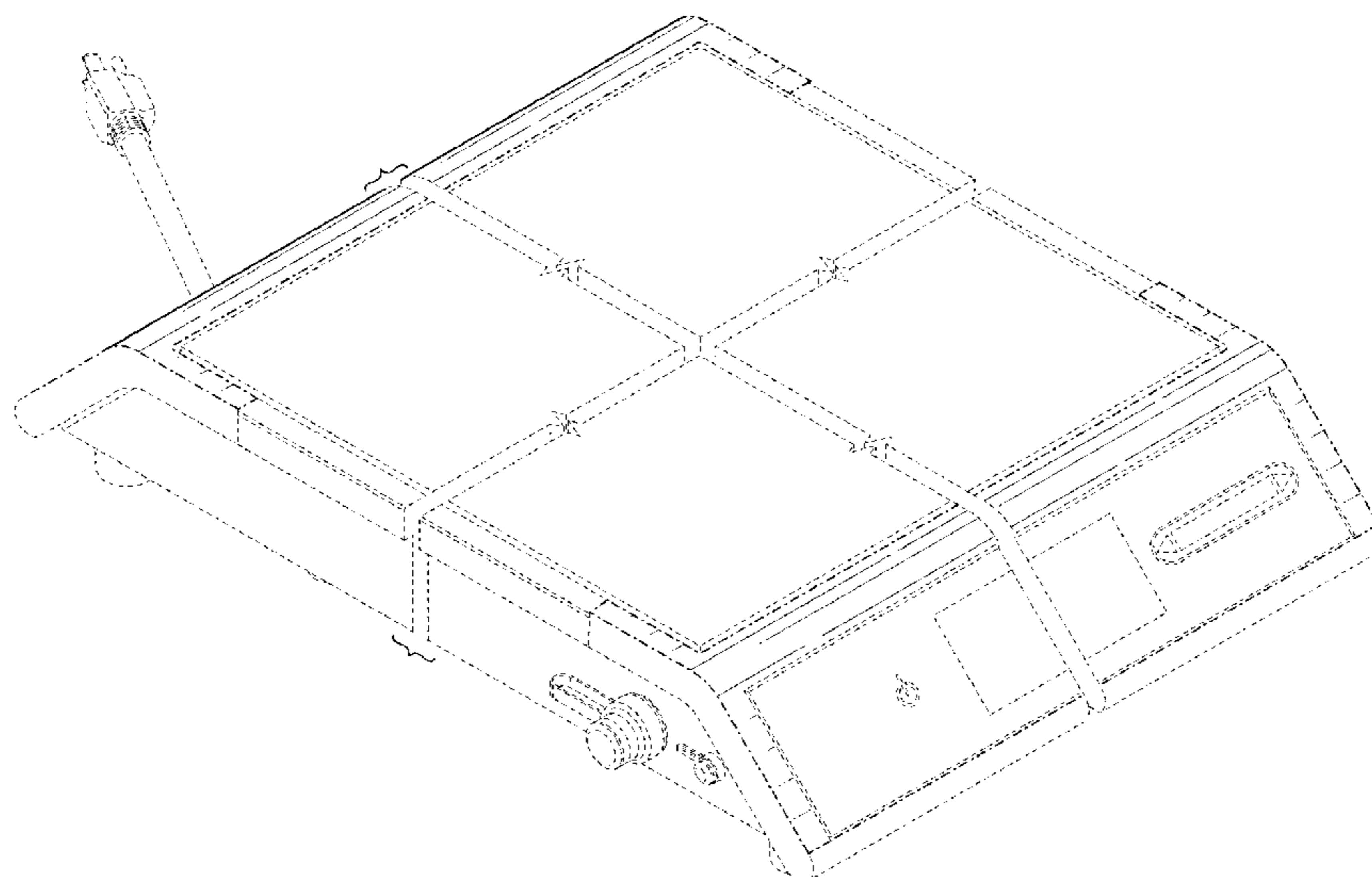
**DESCRIPTION**

FIG. 1 is a front perspective view of a first embodiment of a countertop appliance of our new design; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a right side elevation view thereof; FIG. 5 is a left side elevation view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; FIG. 8 is a front perspective view of a second embodiment of a countertop appliance of our new design; FIG. 9 is a front elevation view thereof; FIG. 10 is a rear elevation view thereof; FIG. 11 is a right side elevation view thereof; FIG. 12 is a left side elevation view thereof; FIG. 13 is a top plan view thereof; and, FIG. 14 is a bottom plan view thereof.

The even spaced dash-dash broken lines in the figures depict portions of the countertop appliance that form no part of the claimed design. The dash-dot broken lines in the figures define the bounds of the claimed design and form no part thereof.

The countertop appliance is shown with symbolic breaks in length and width. The appearance of any portion of the article between the break lines forms no part of the claimed design.

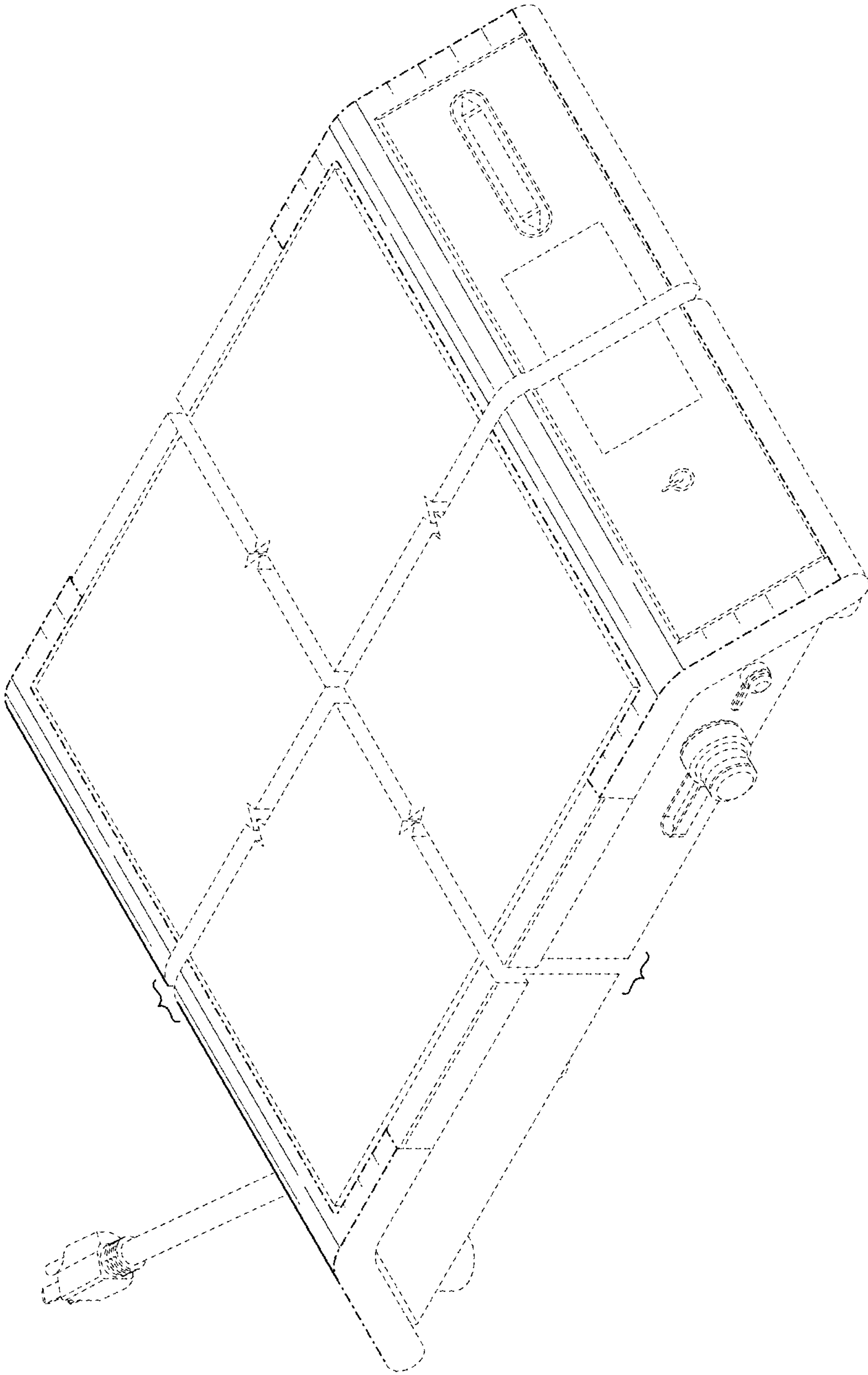

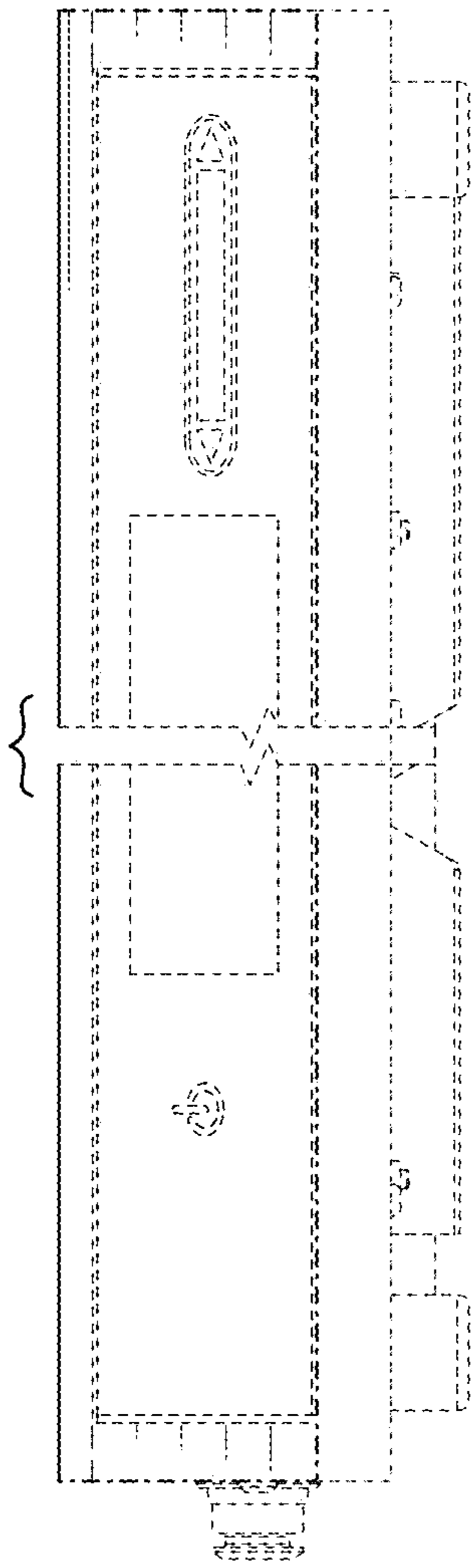

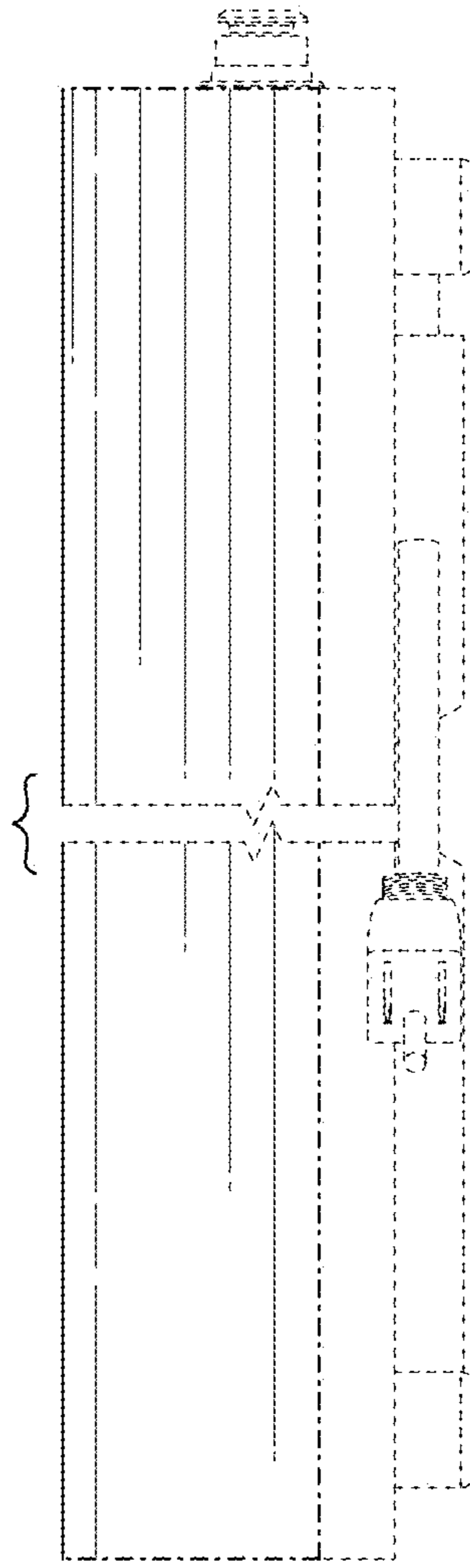

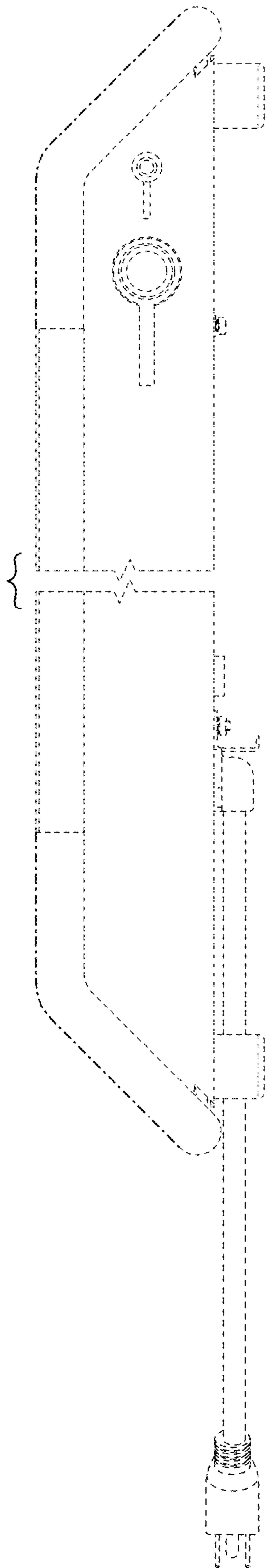

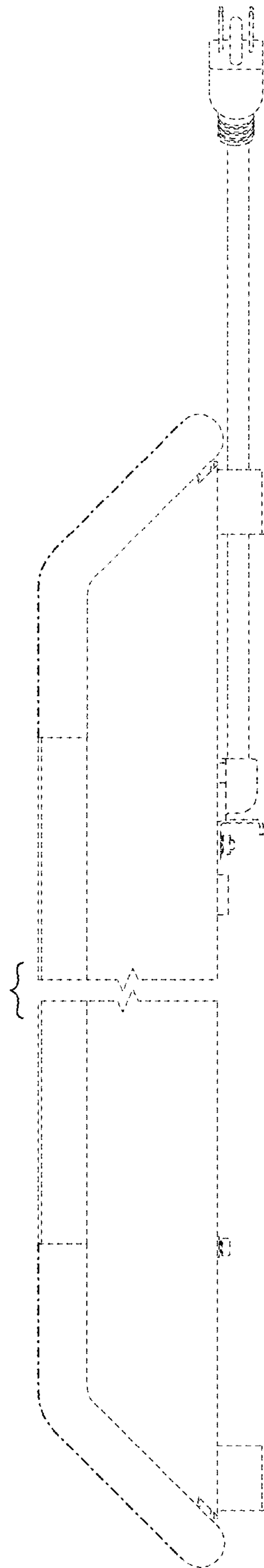

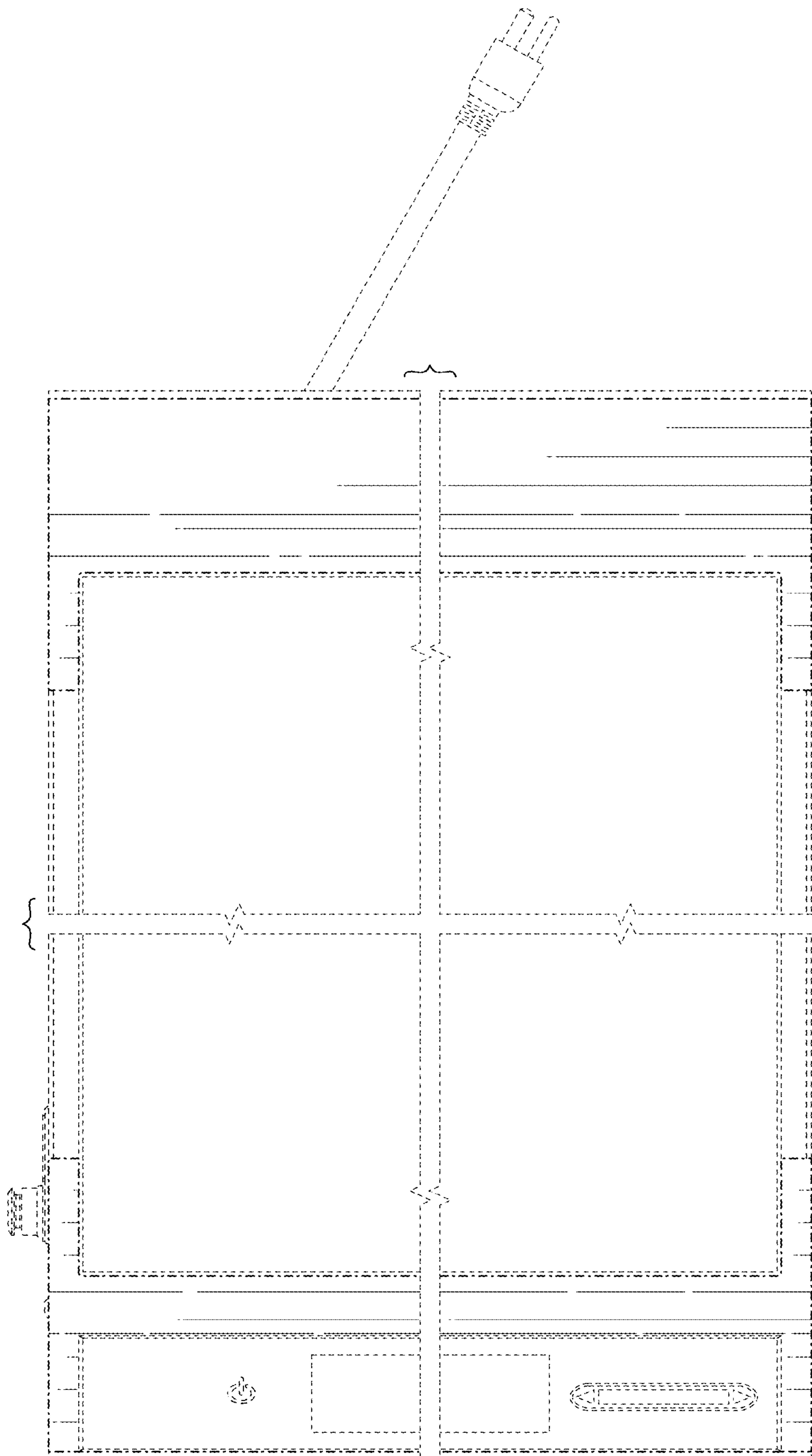
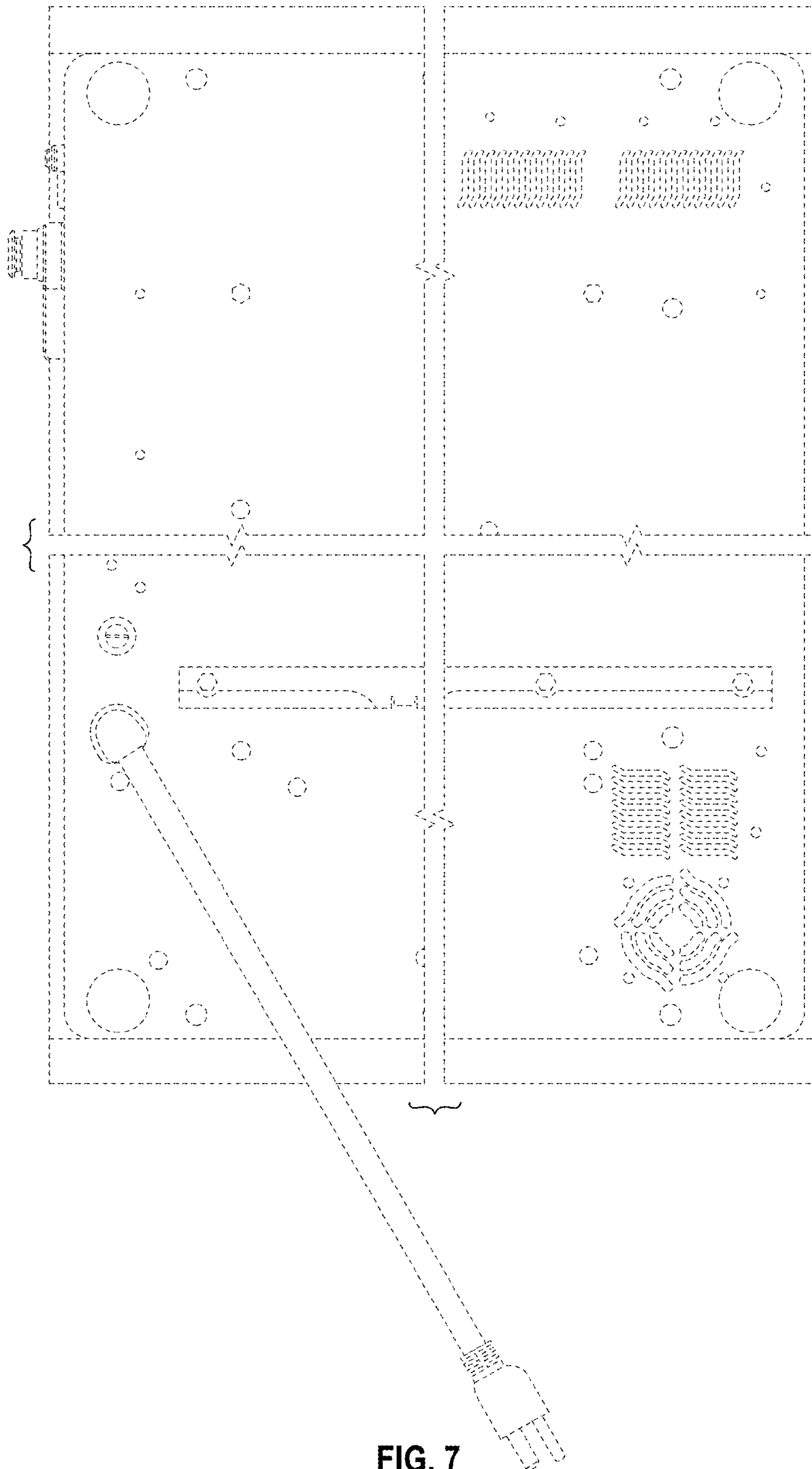

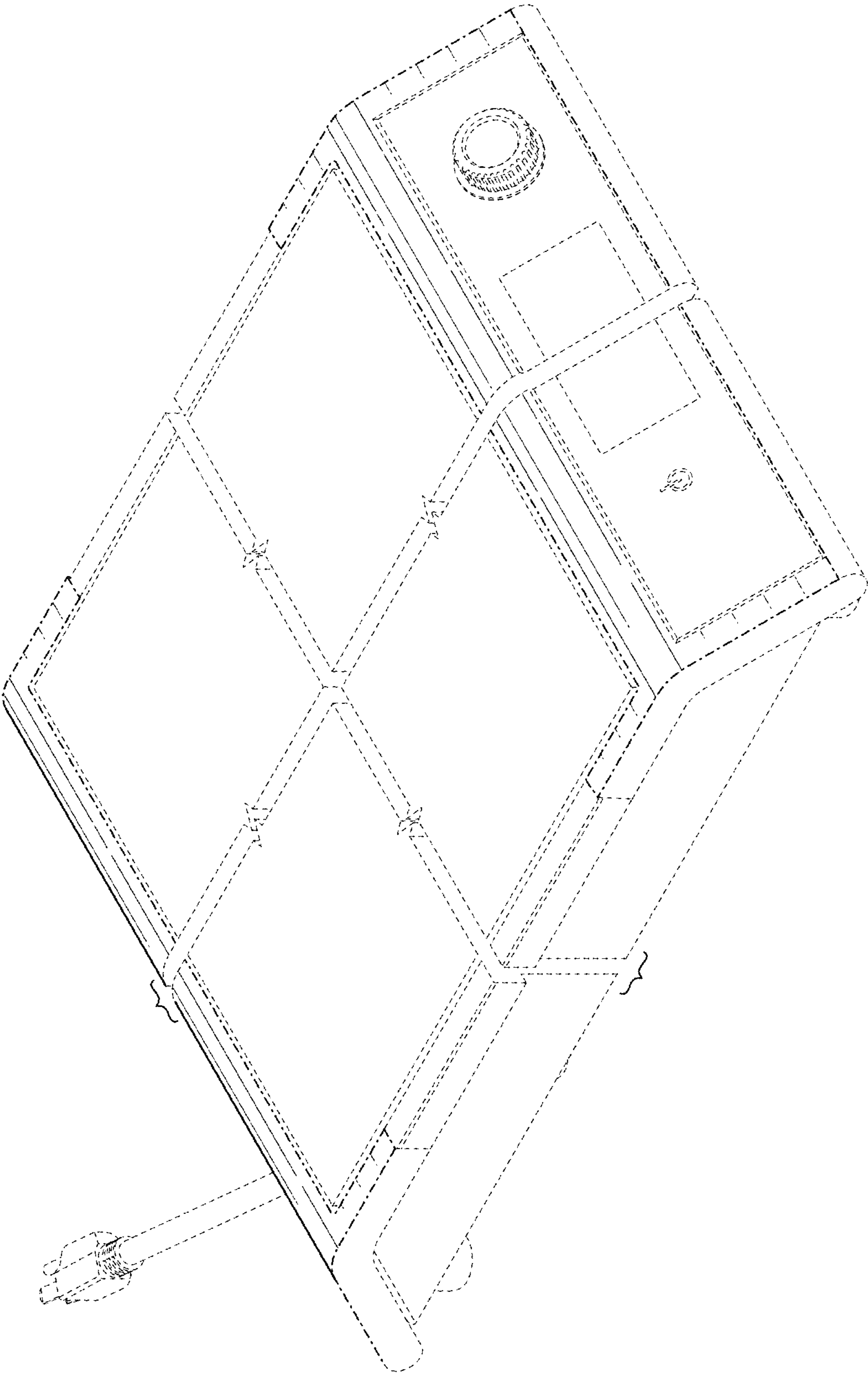

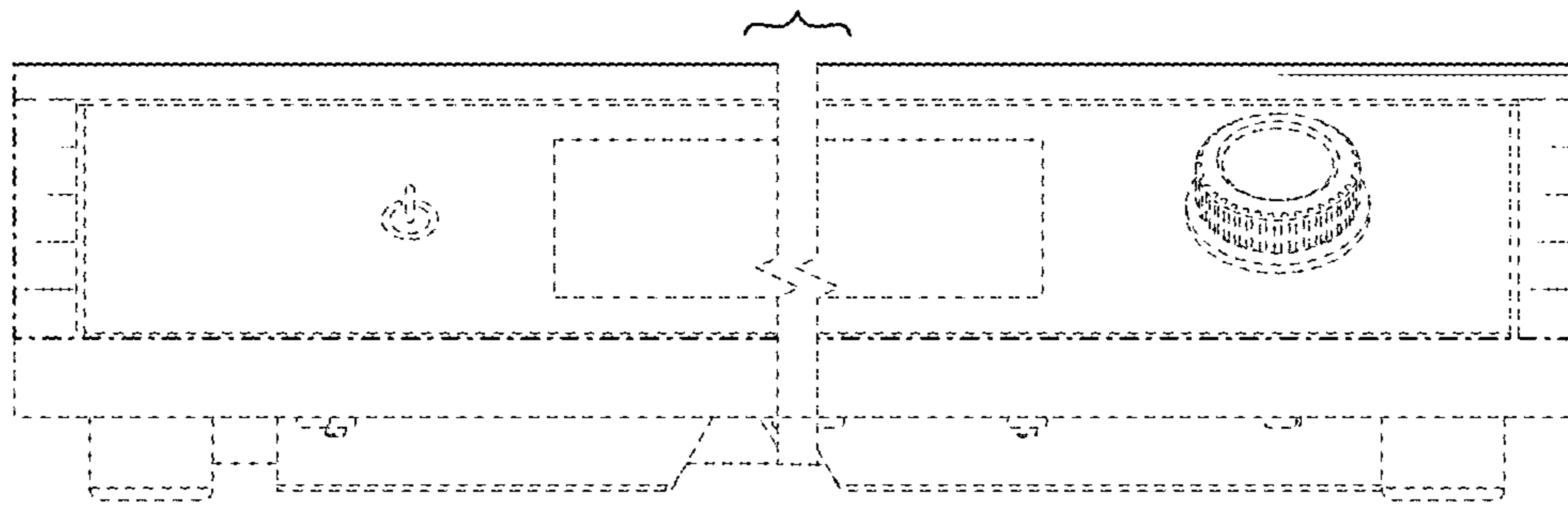

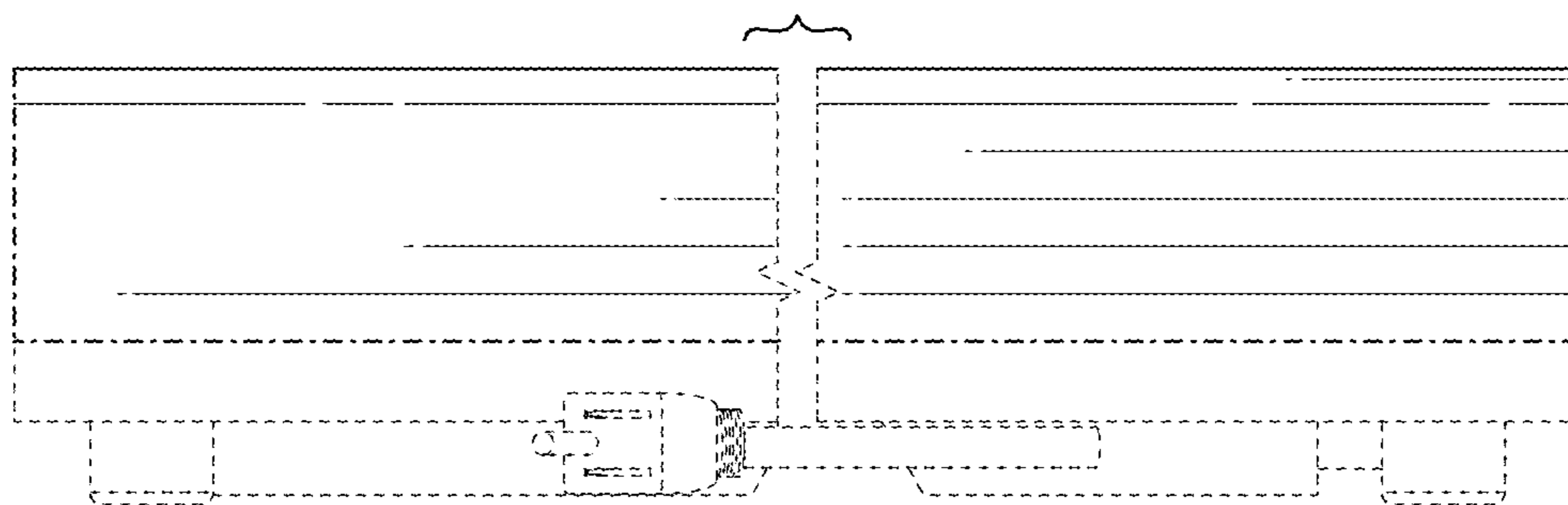

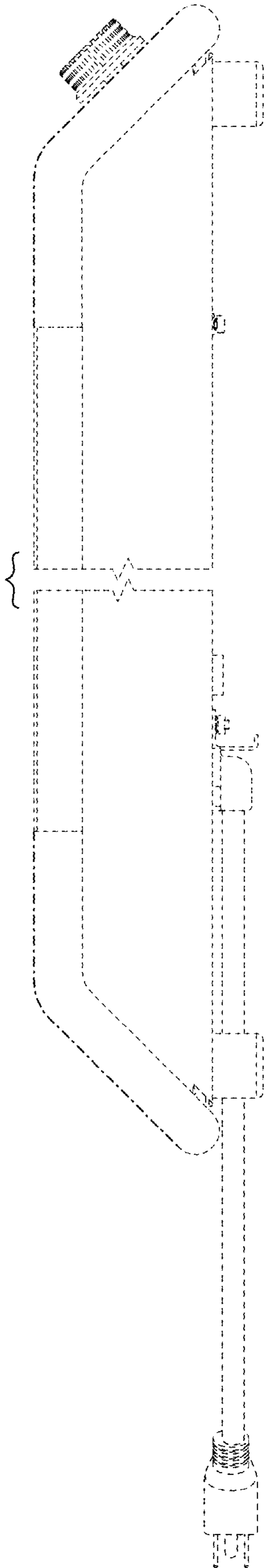

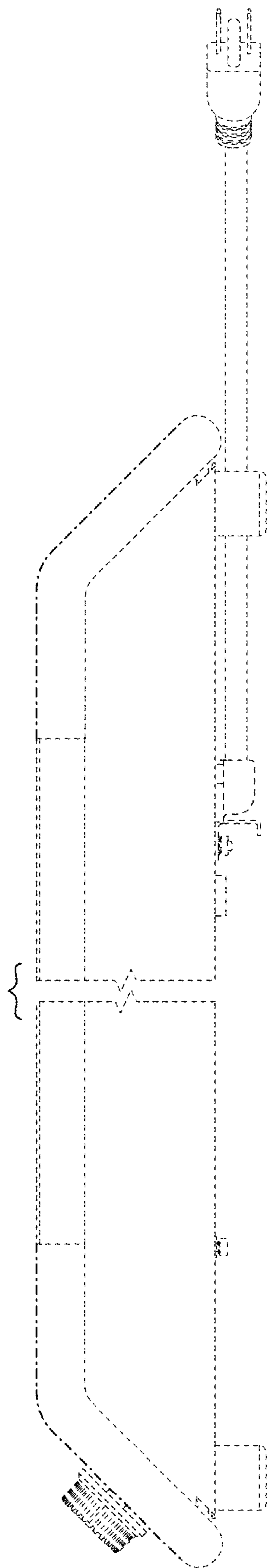

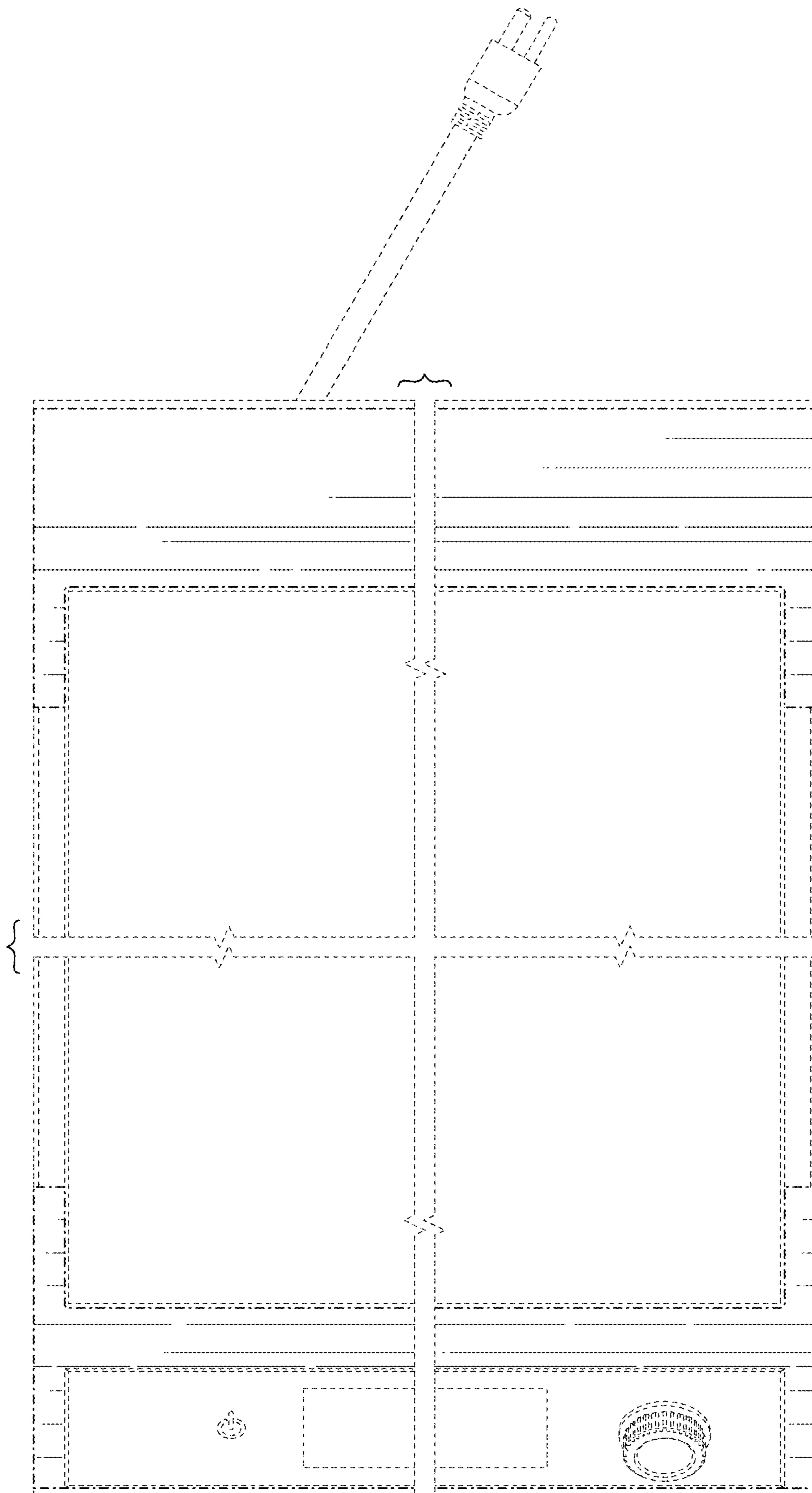

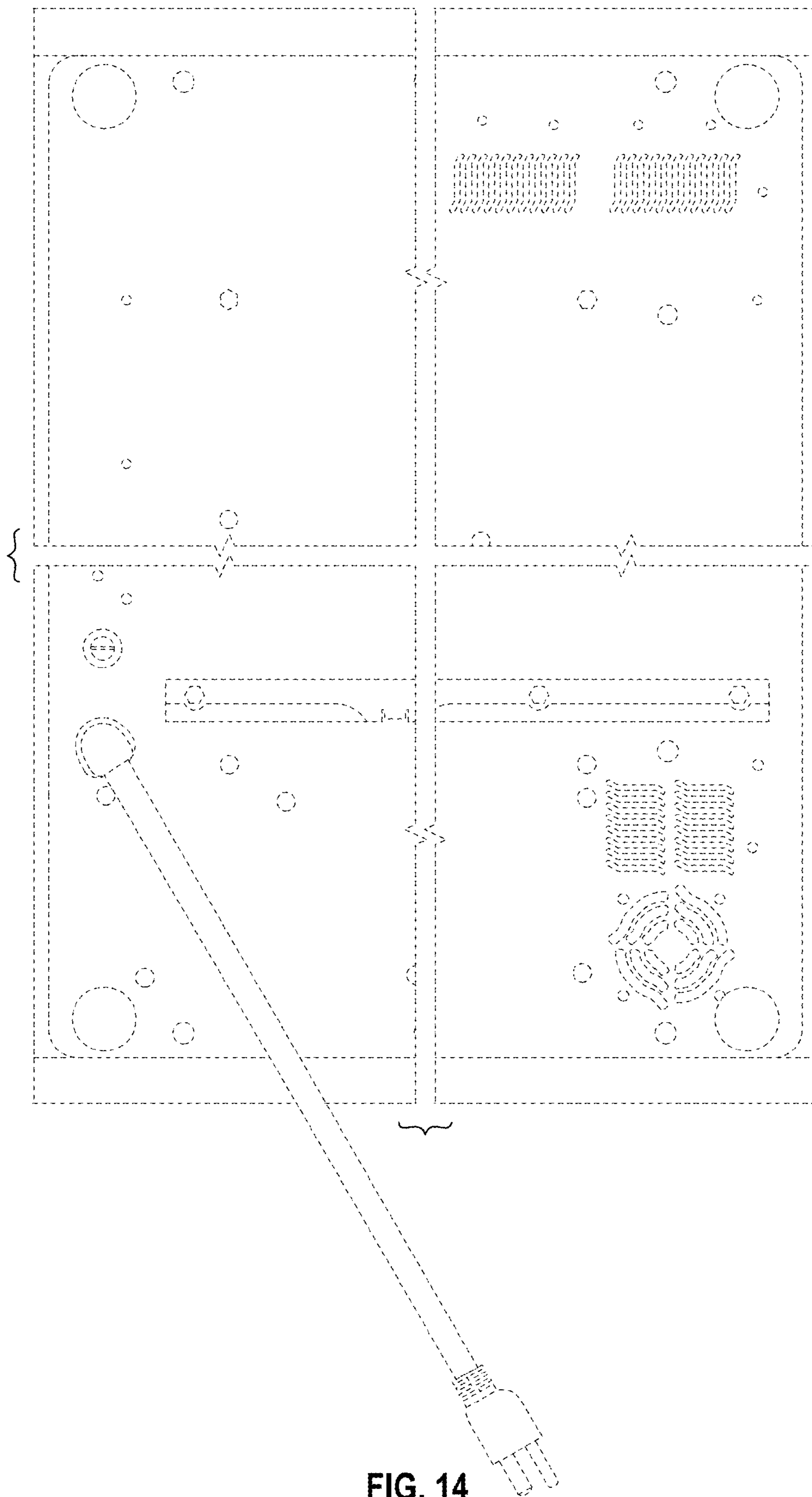
