DESCRIPTION

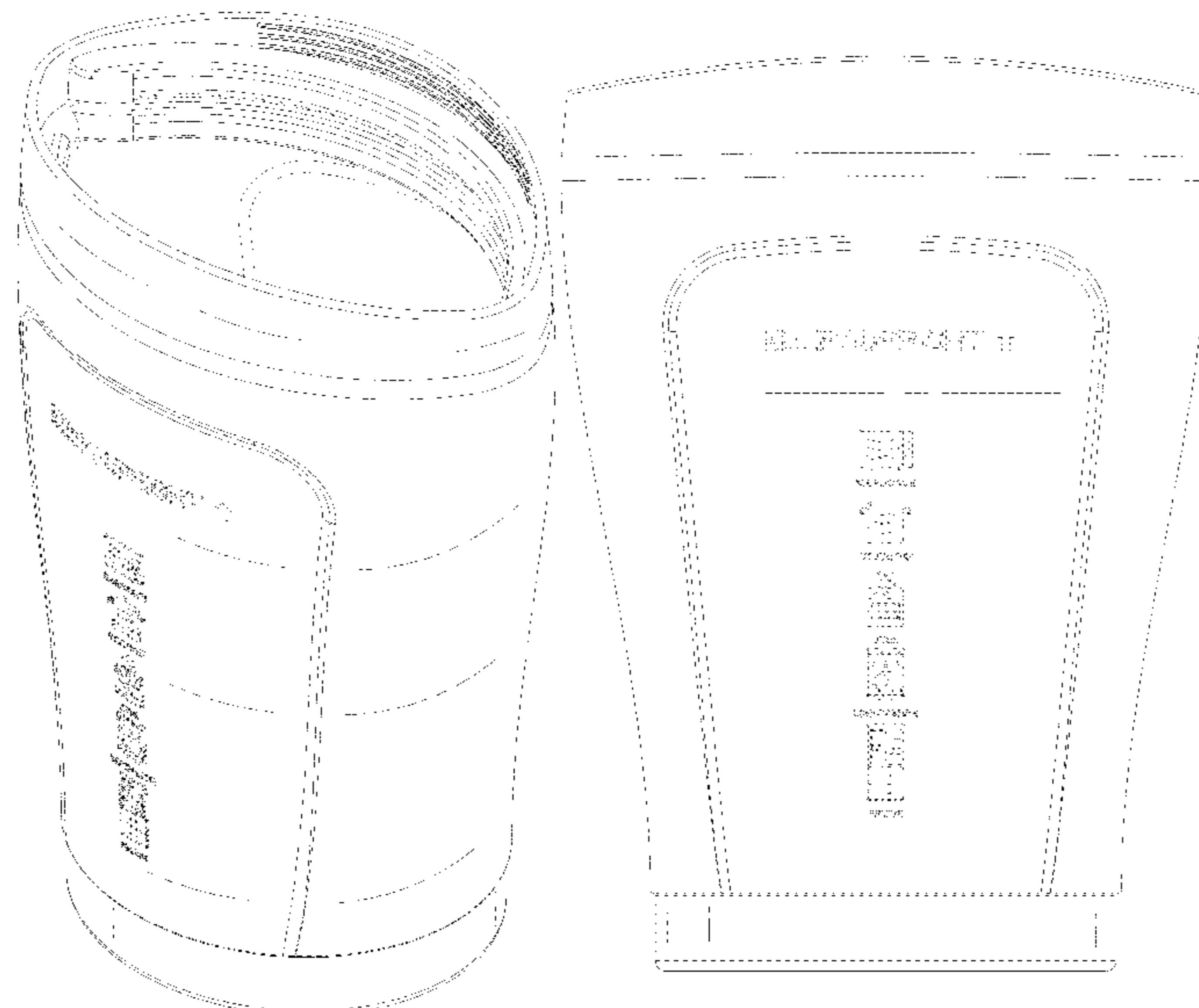
FIG. 1 is a Perspective view of a cup showing my new design;

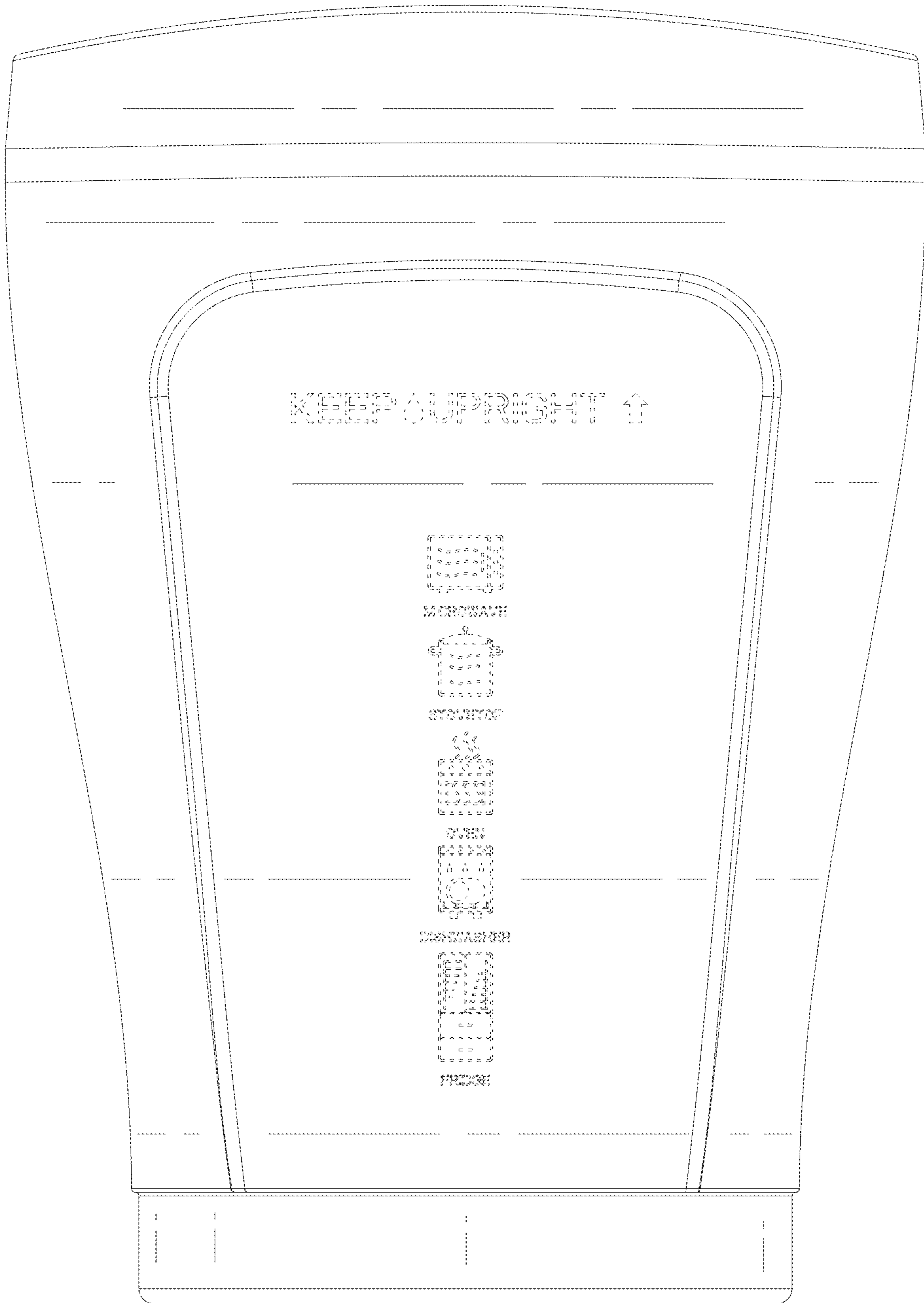

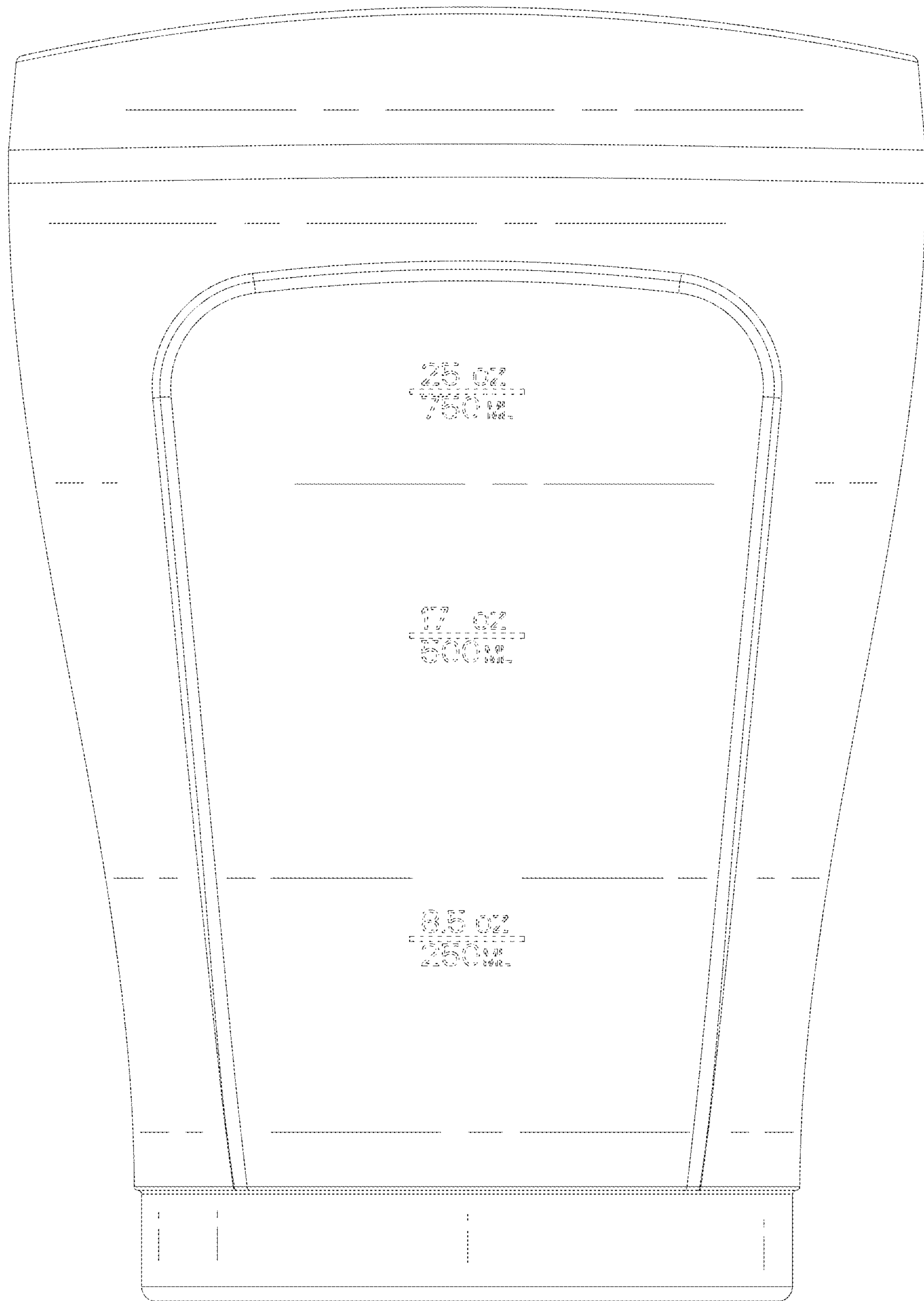

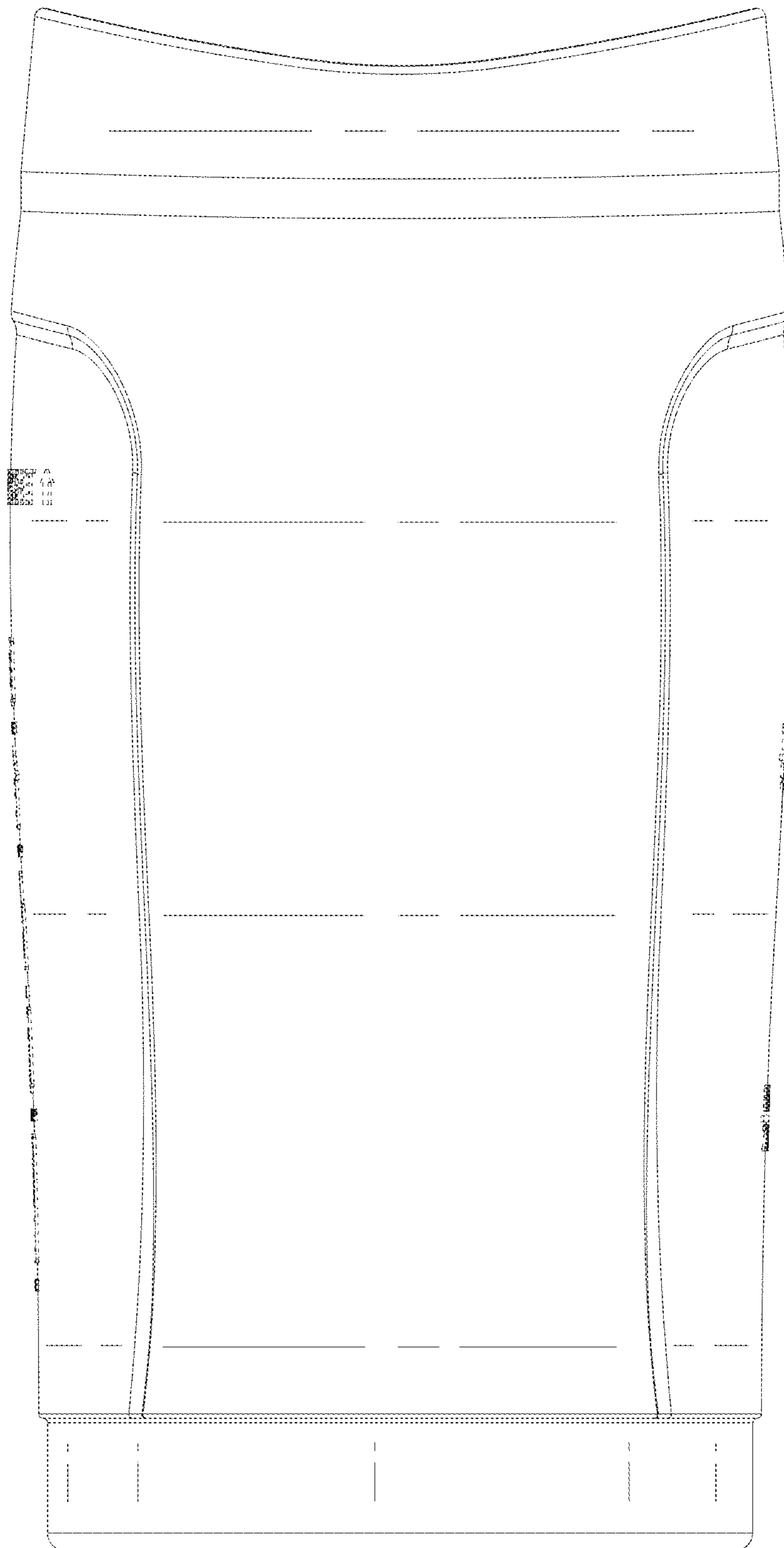

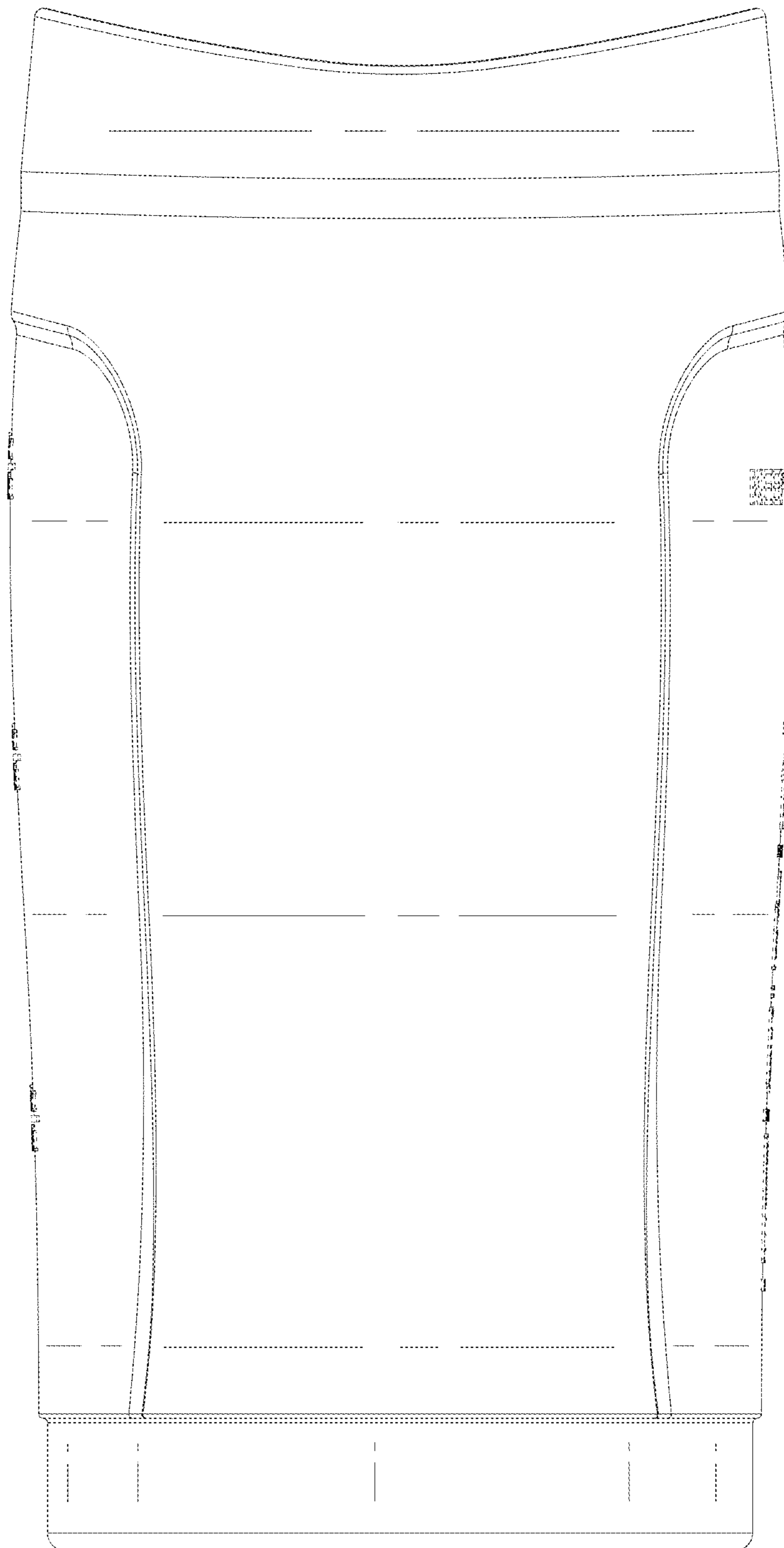

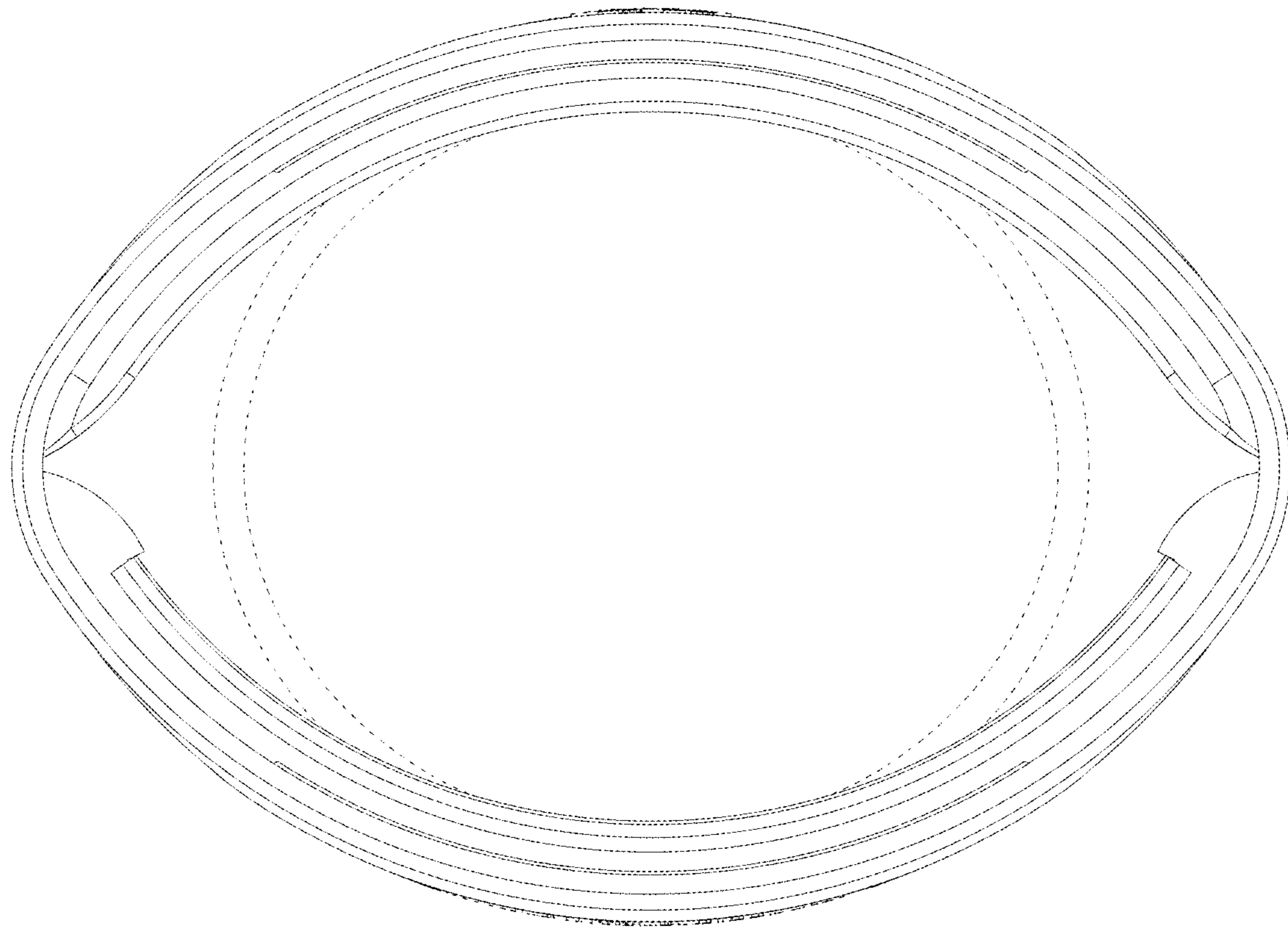

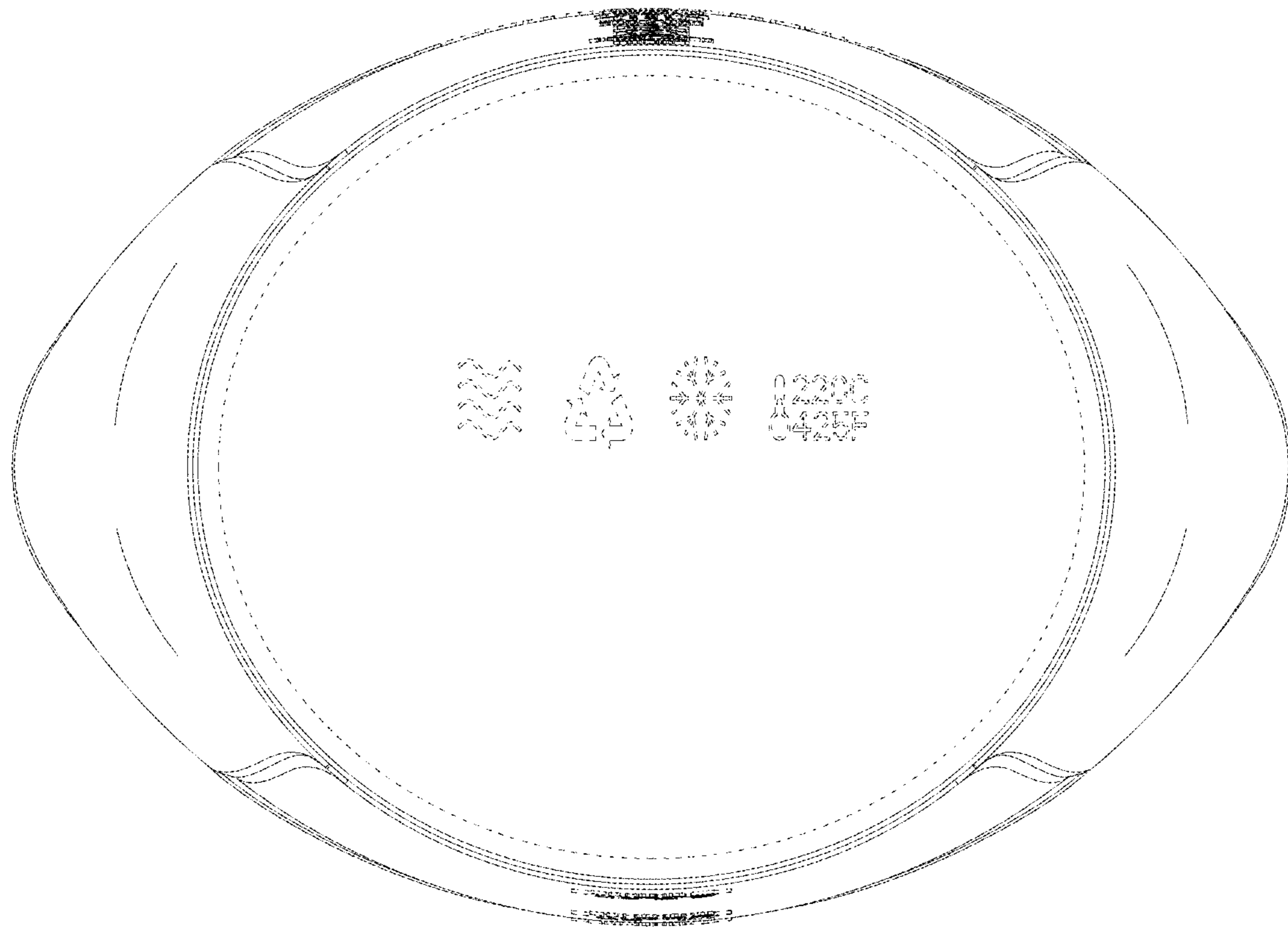
