DESCRIPTION

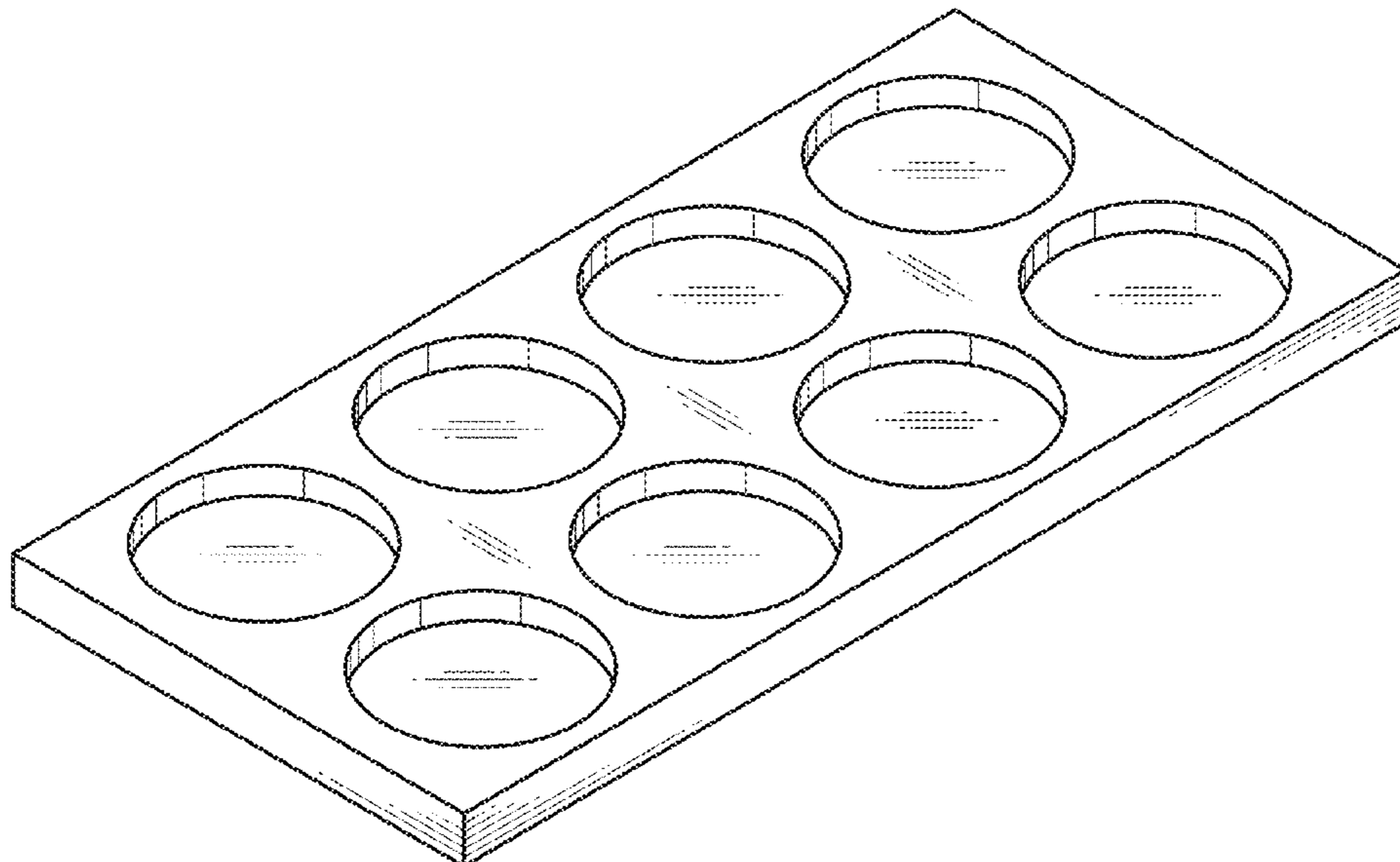

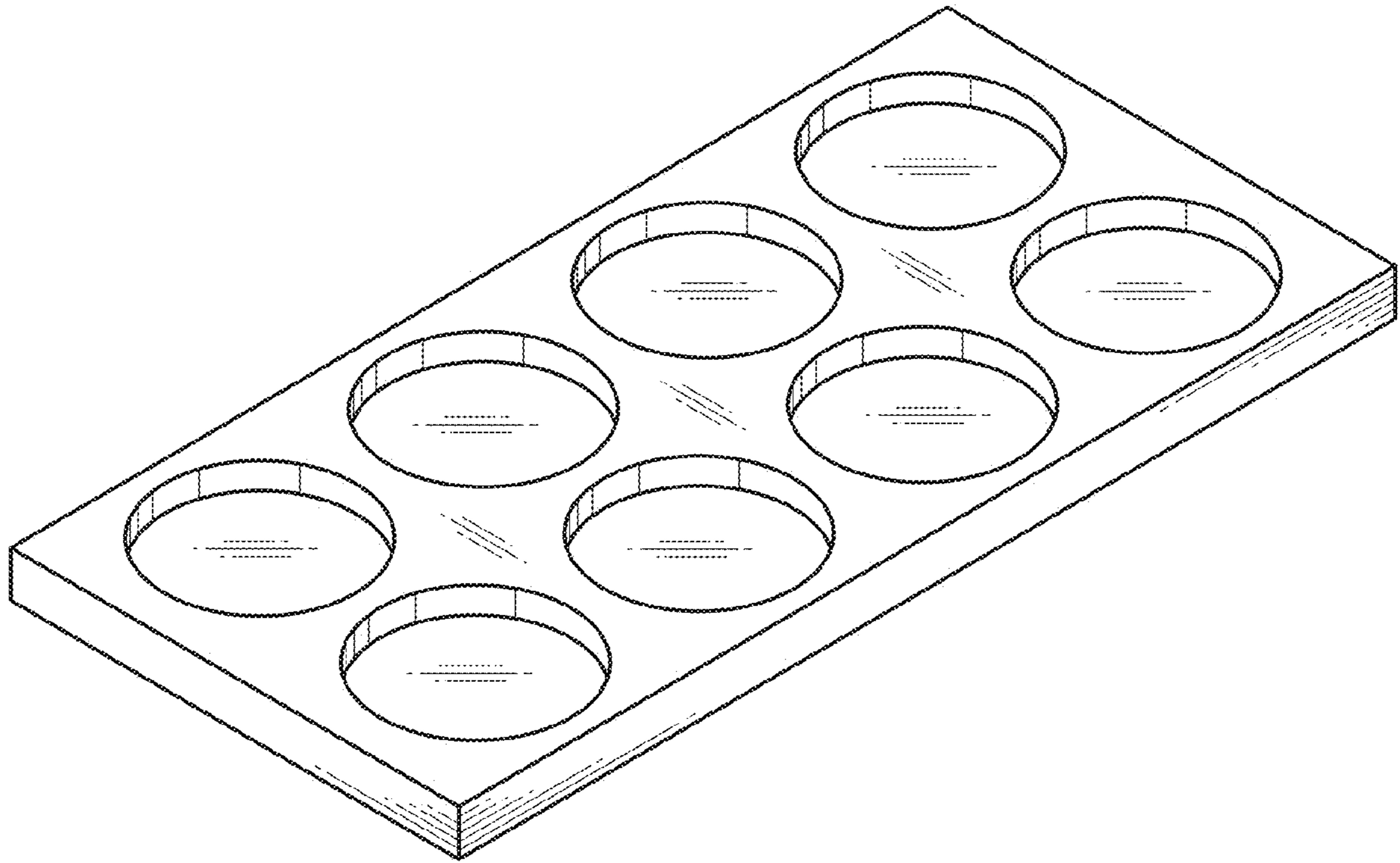

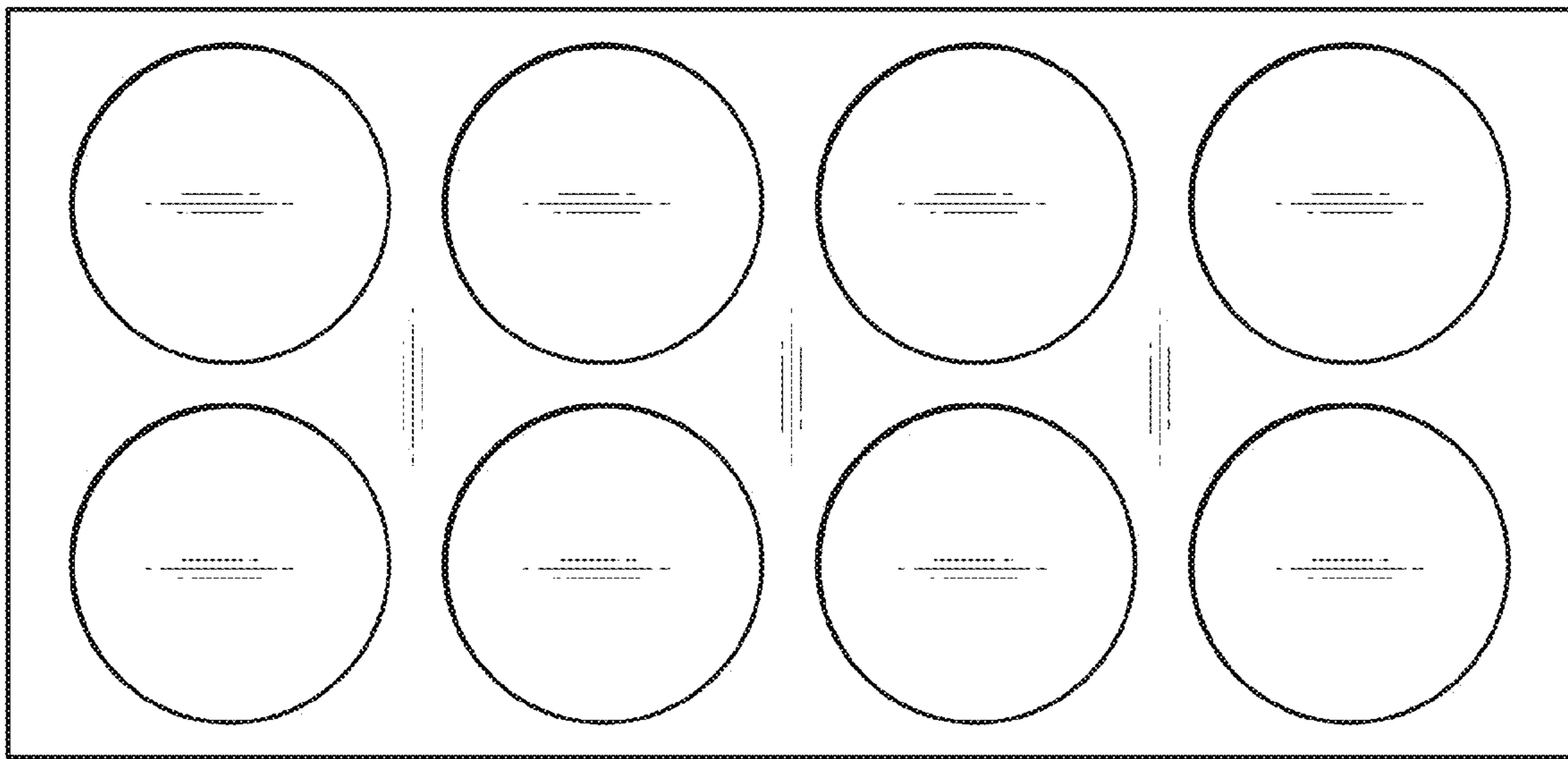

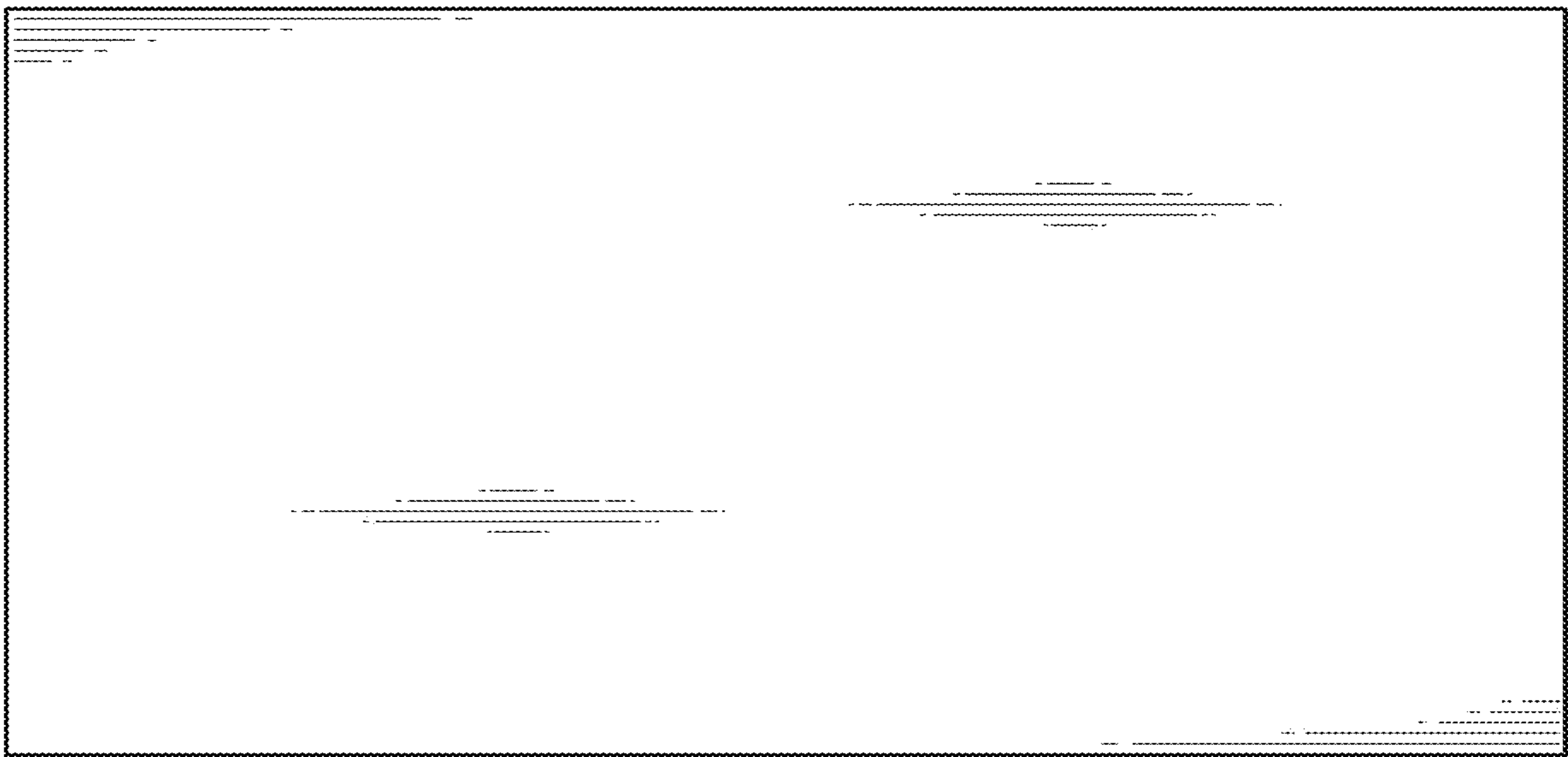
