**DESCRIPTION**

FIG. 7 is a left elevational view thereof;

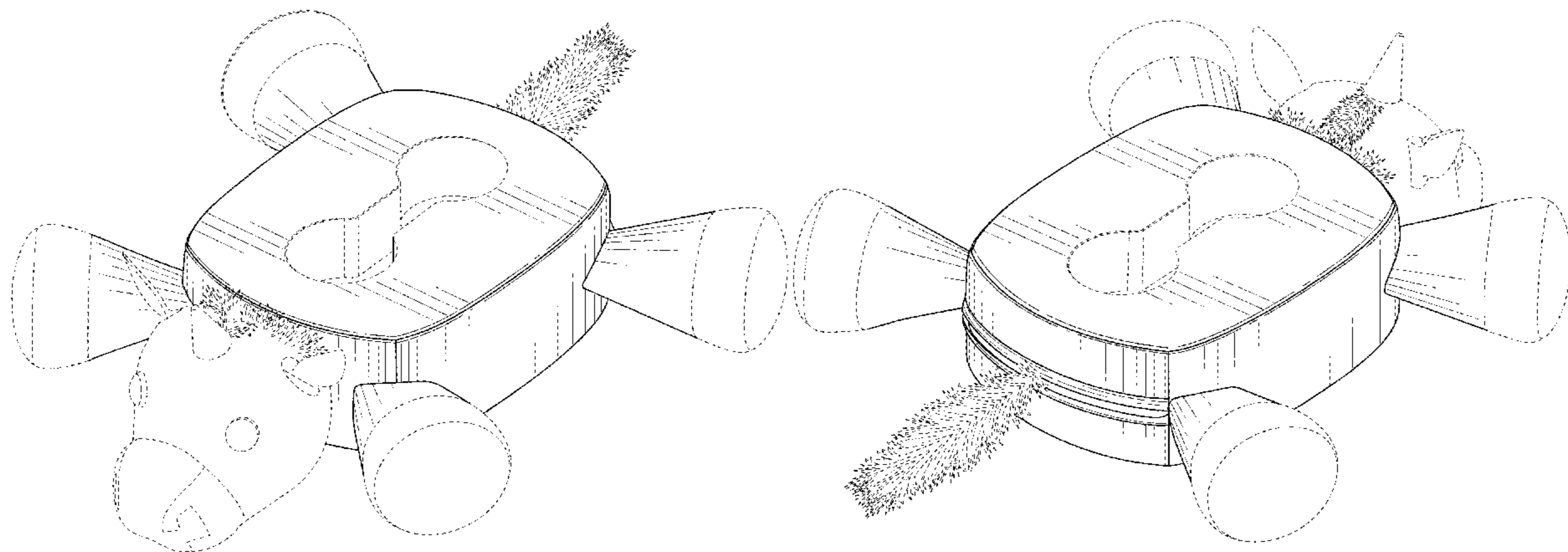
FIG. 8 is a right elevational view thereof;

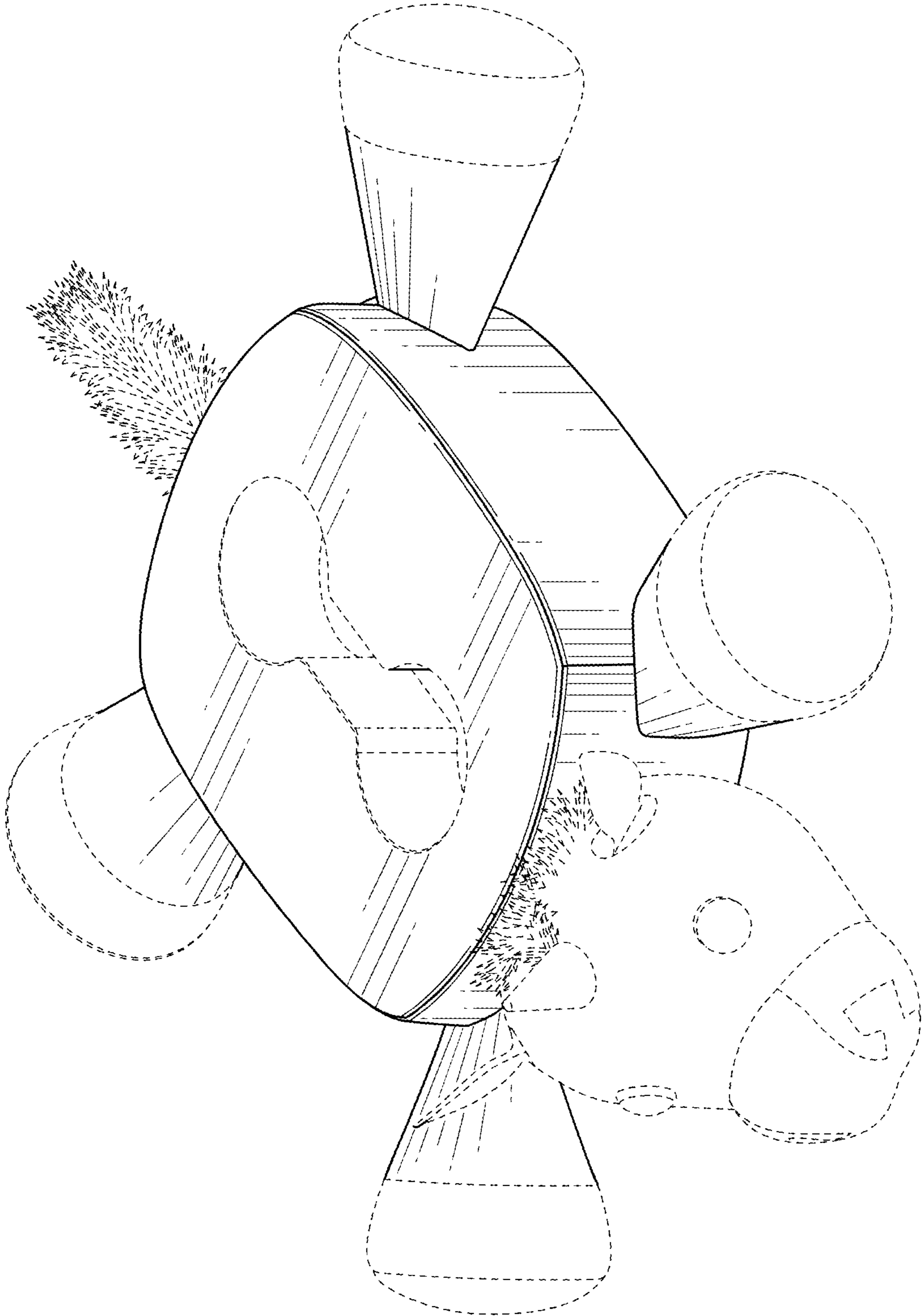

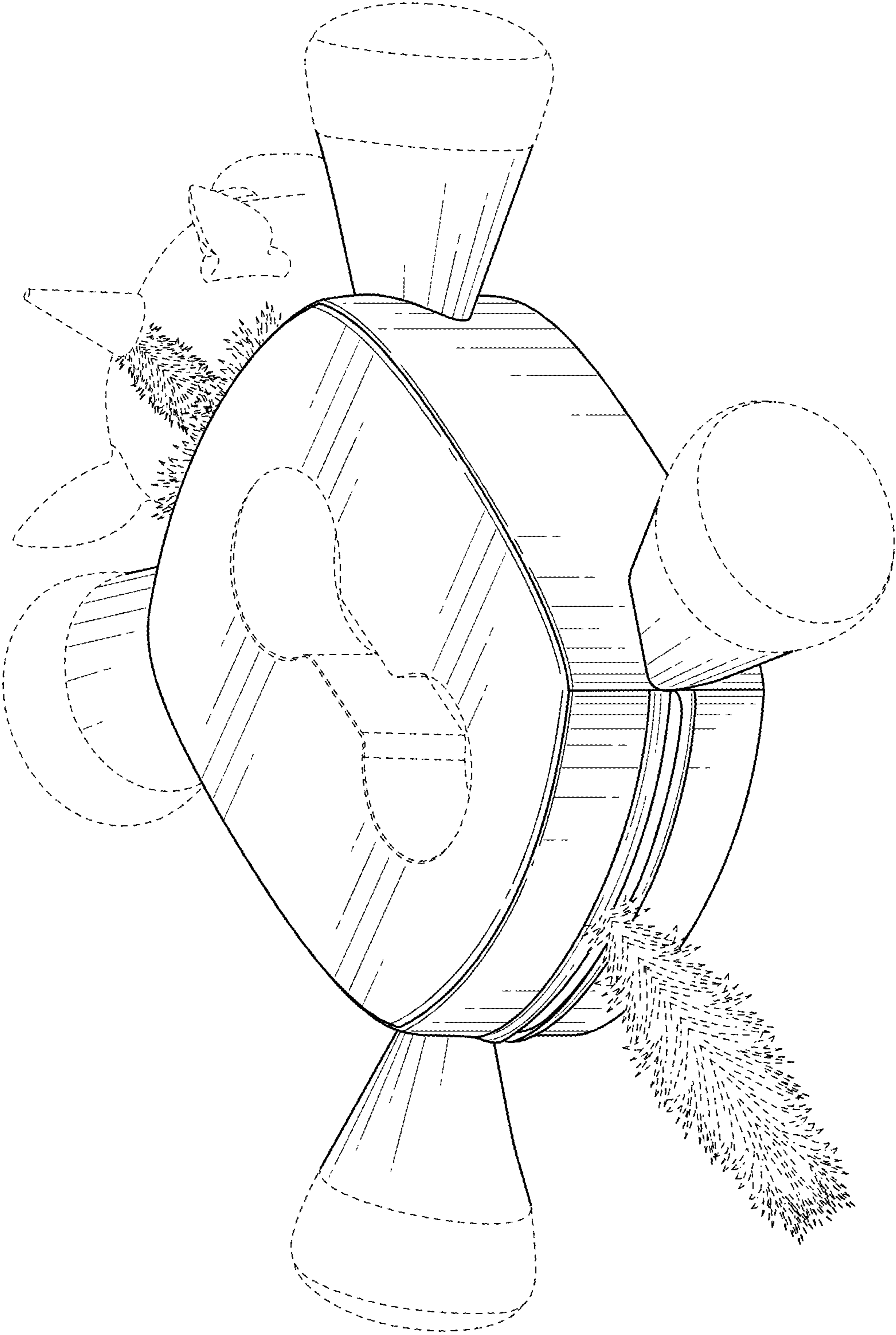

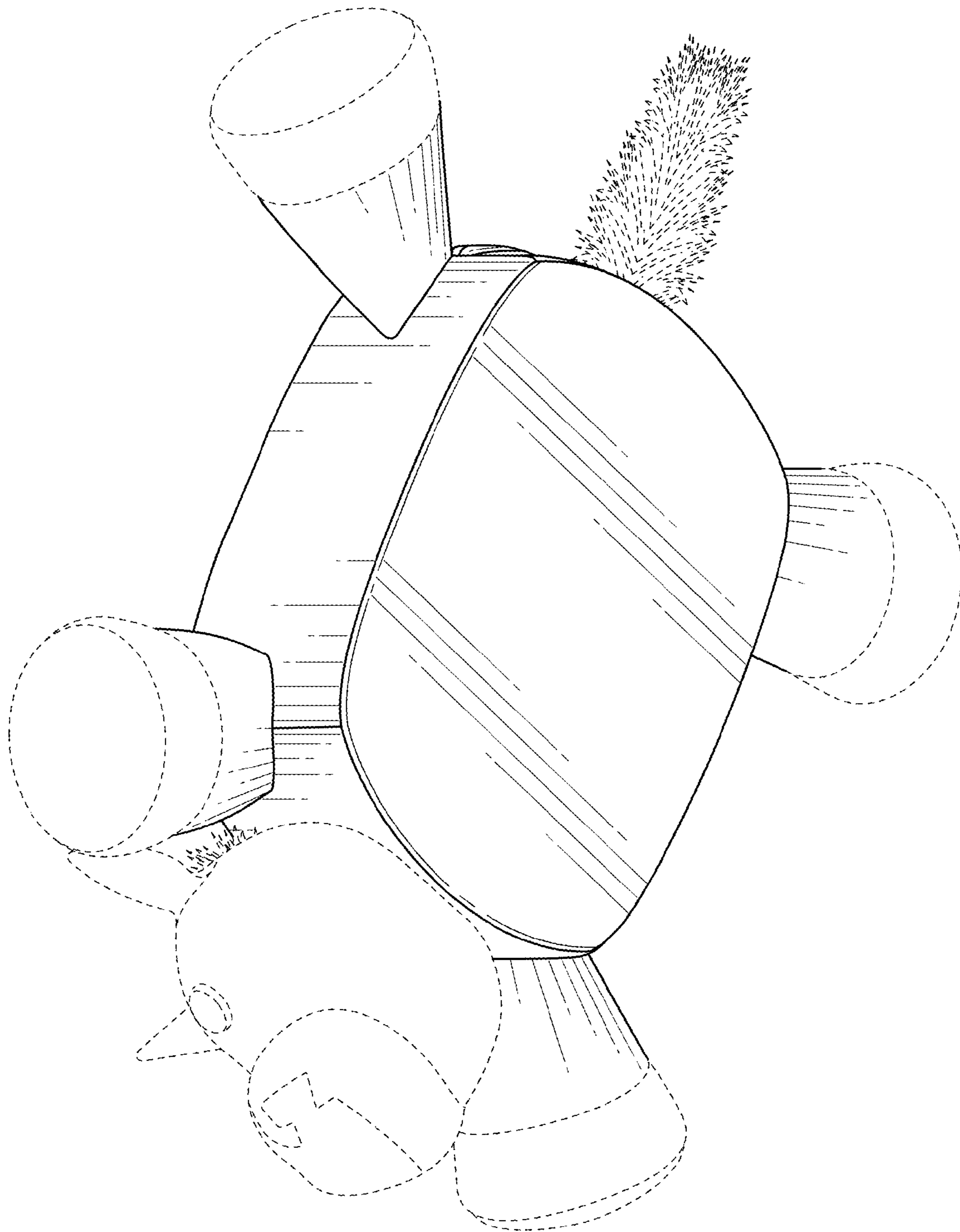

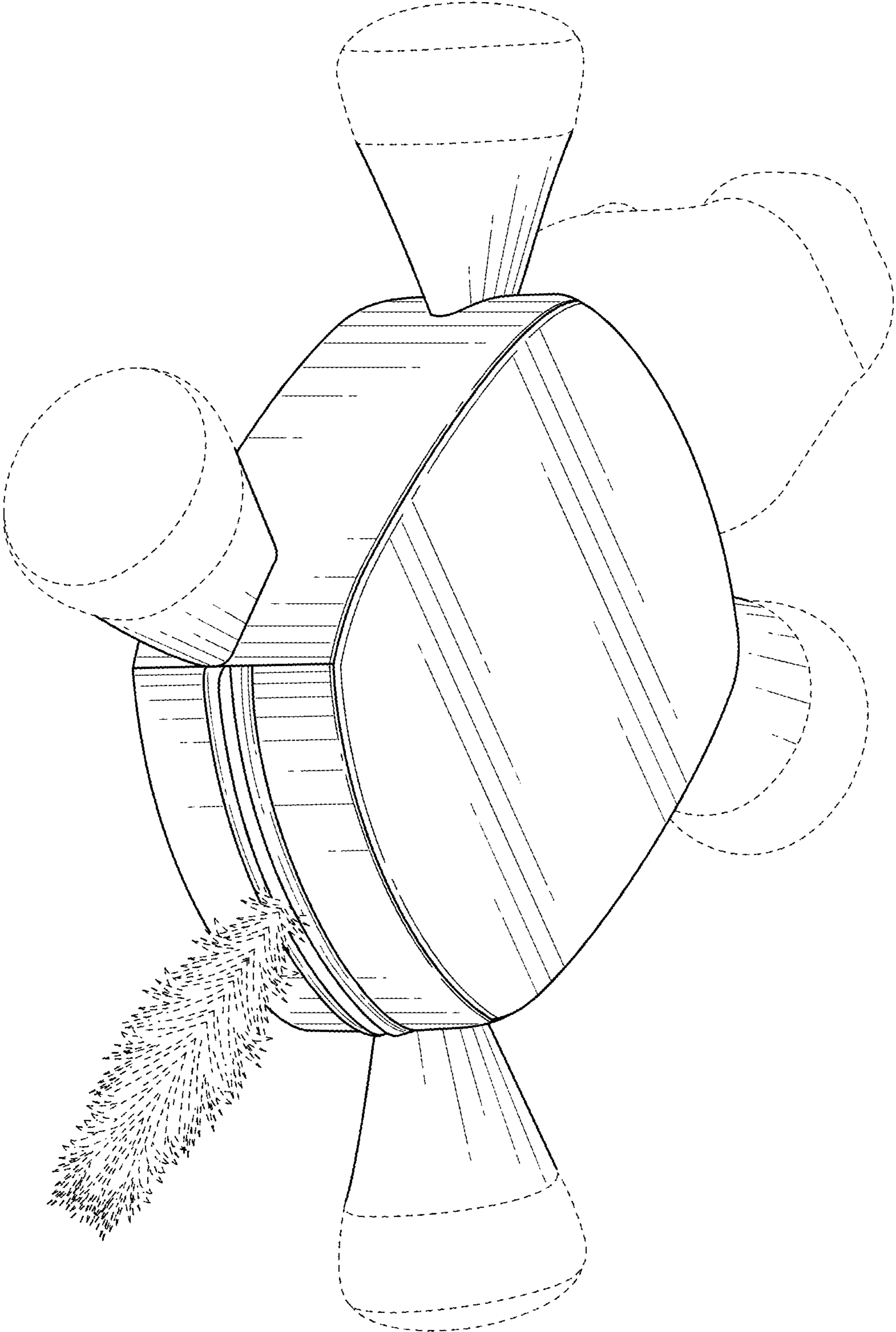

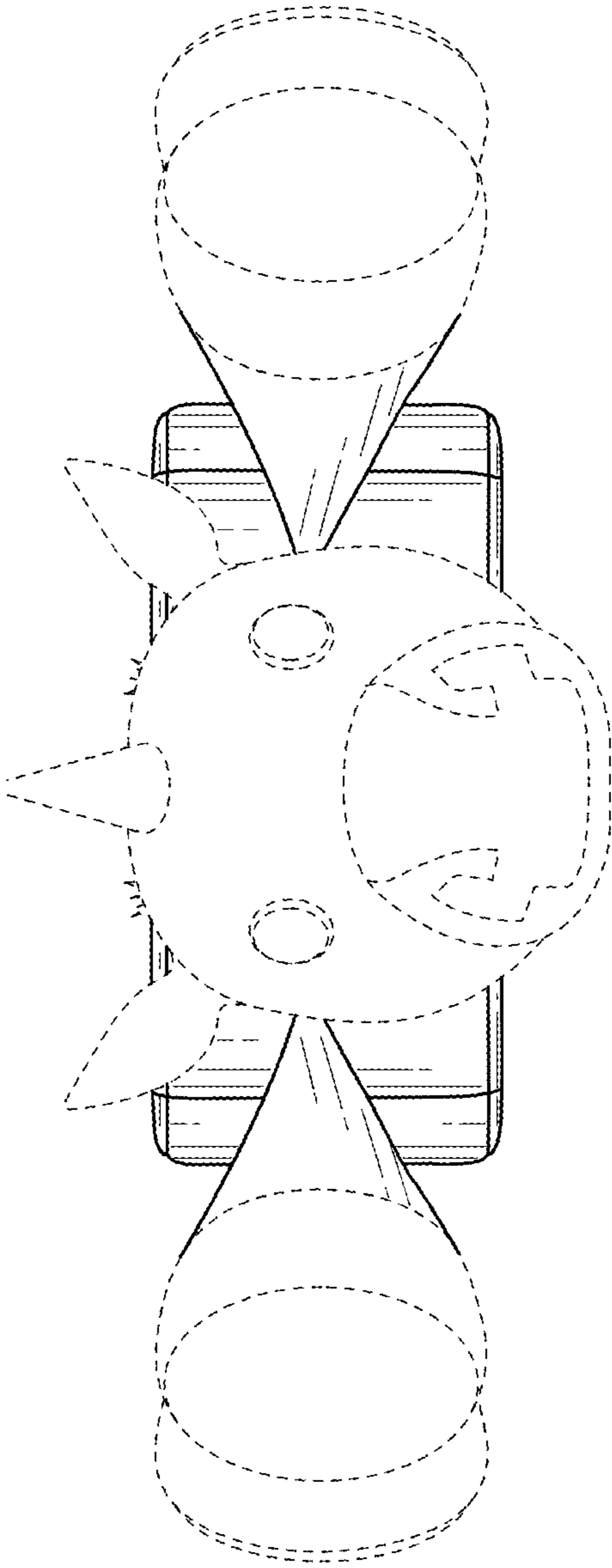

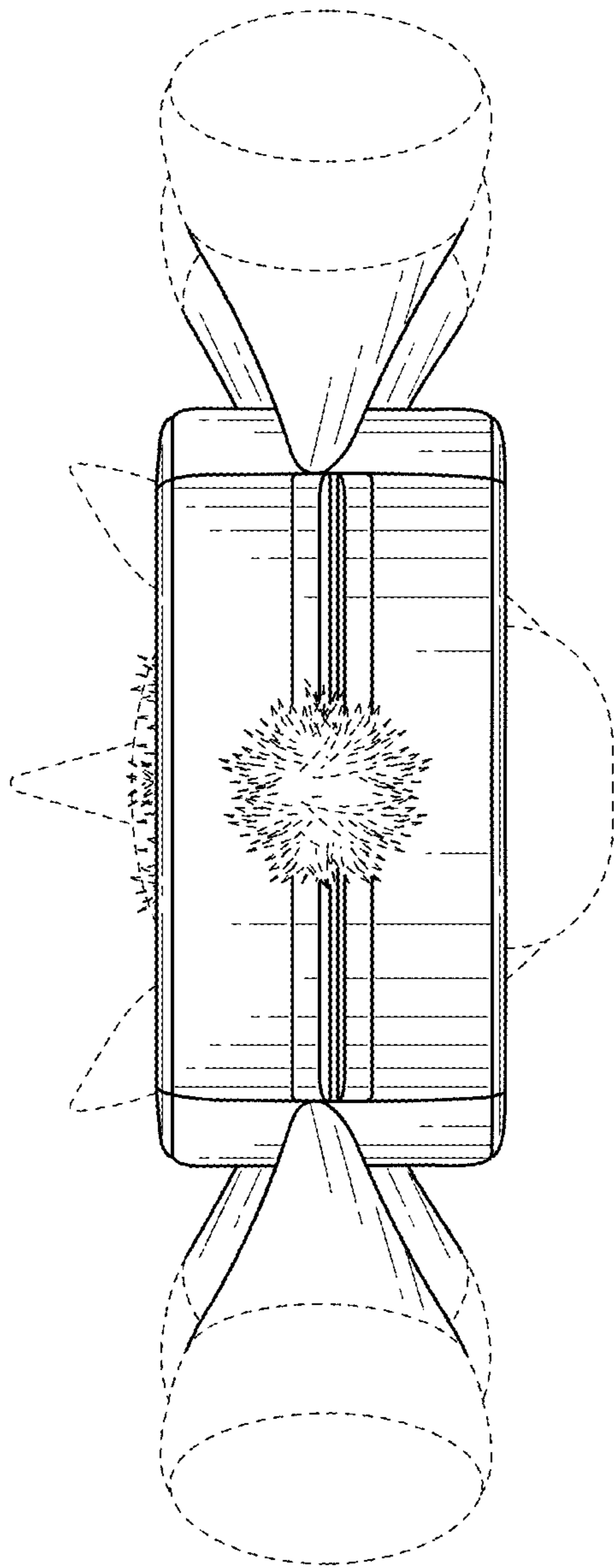

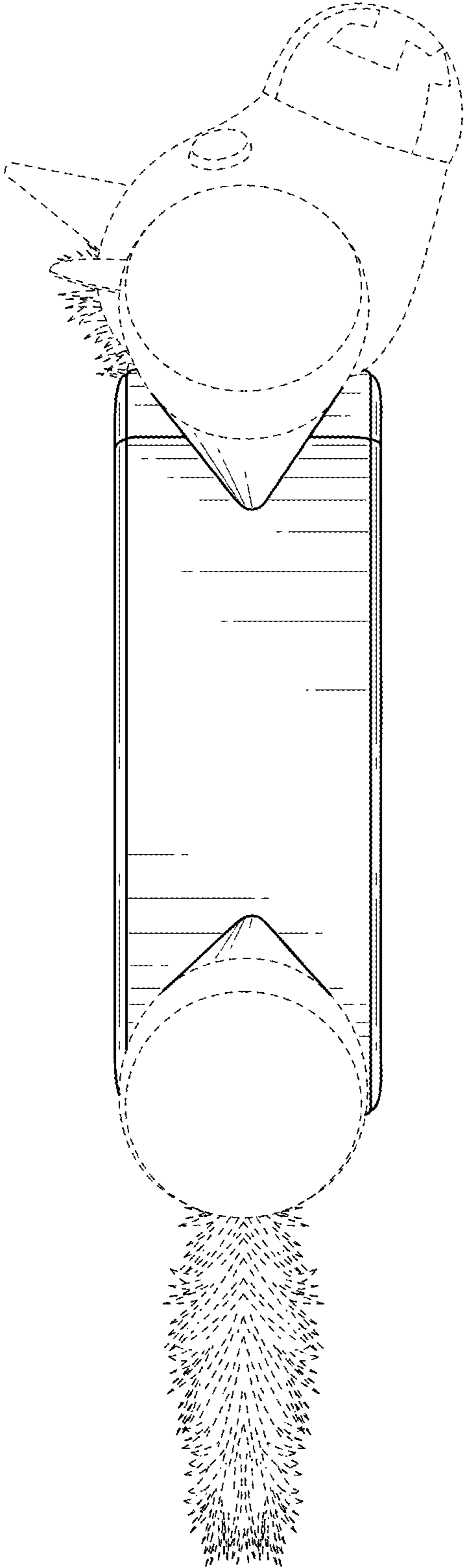

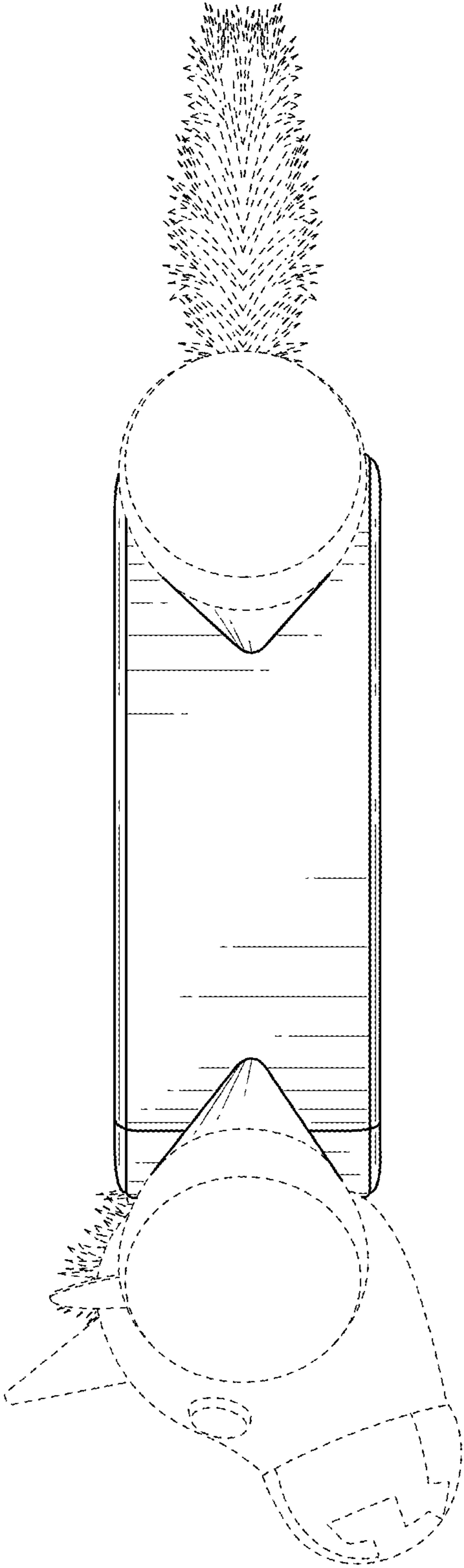

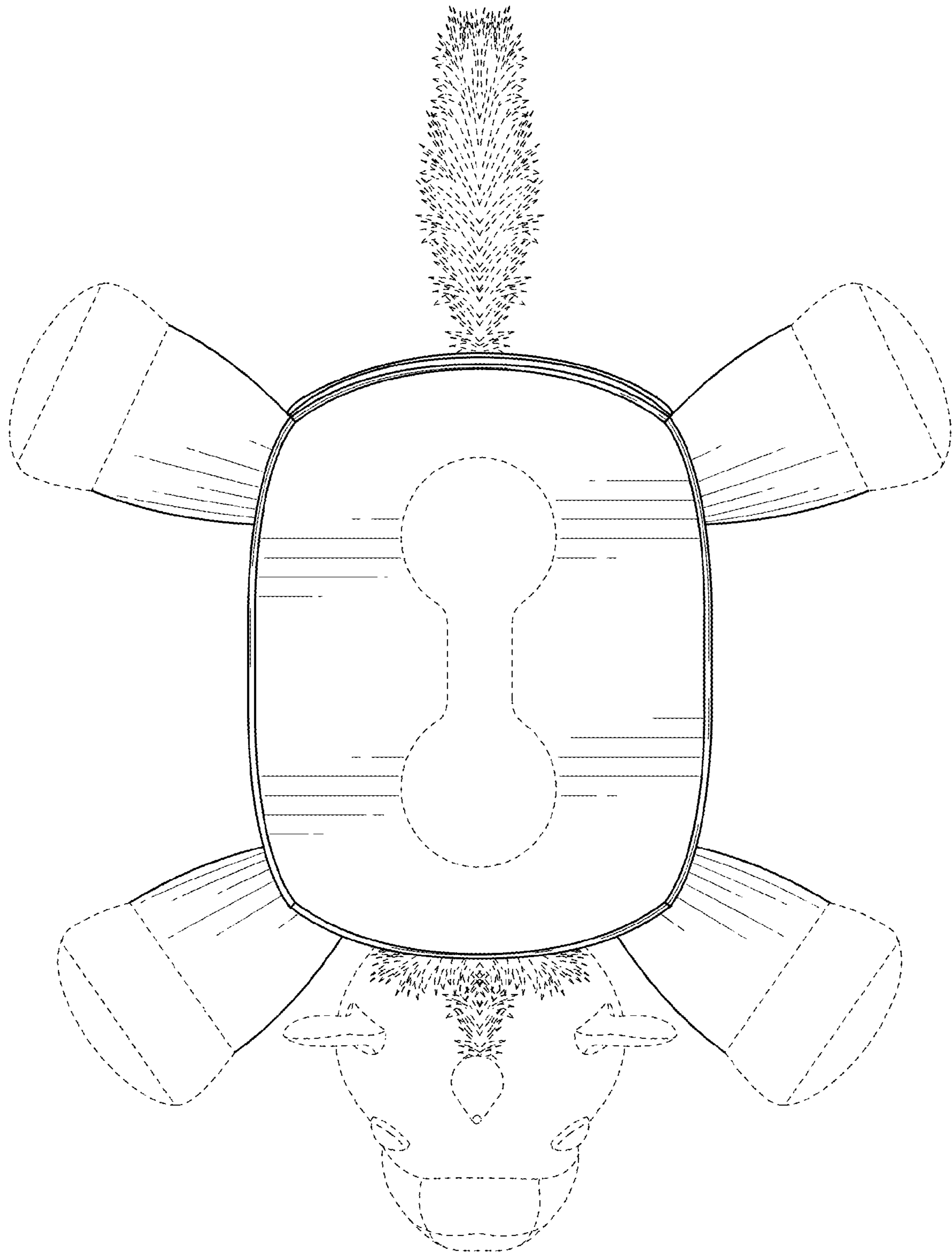

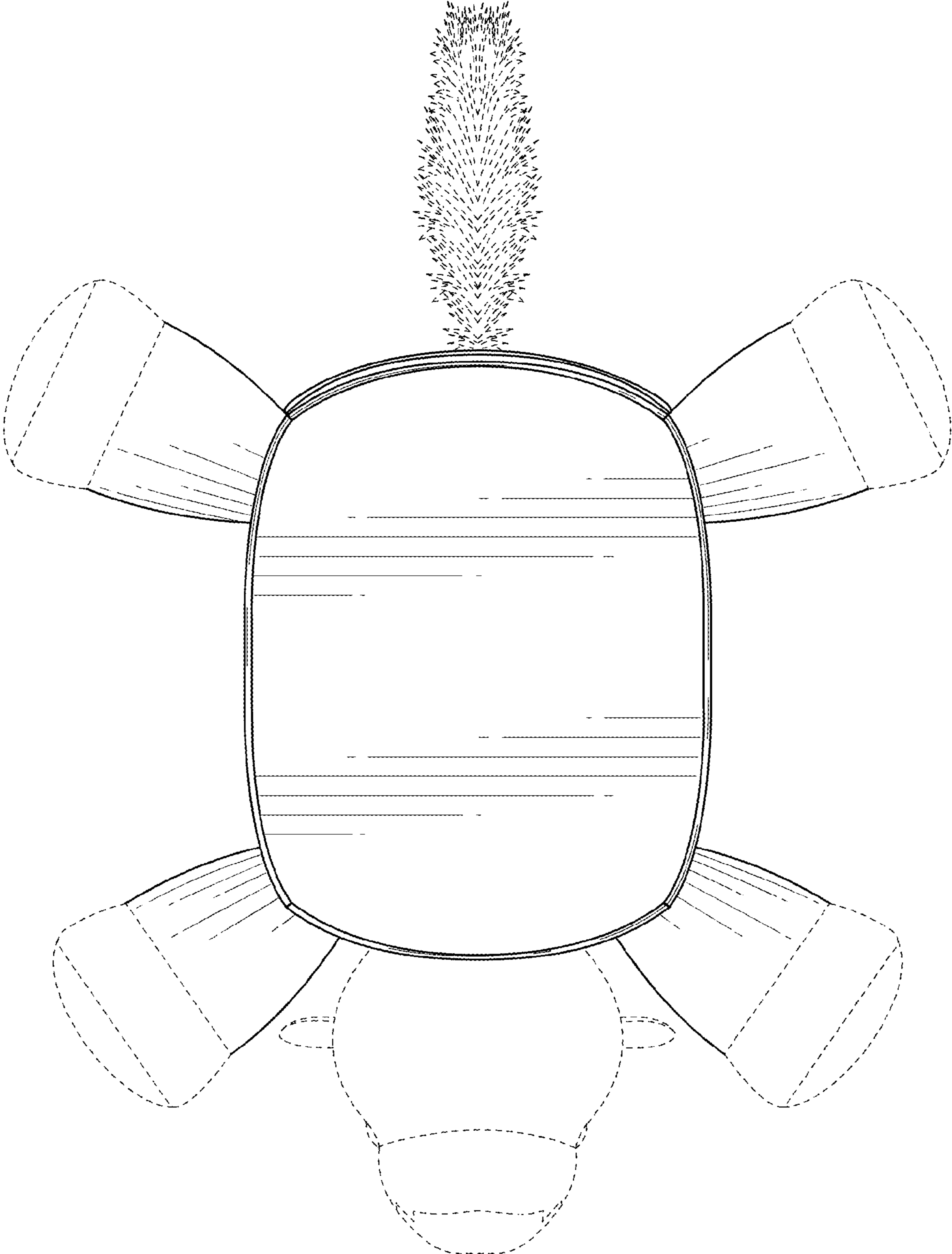
