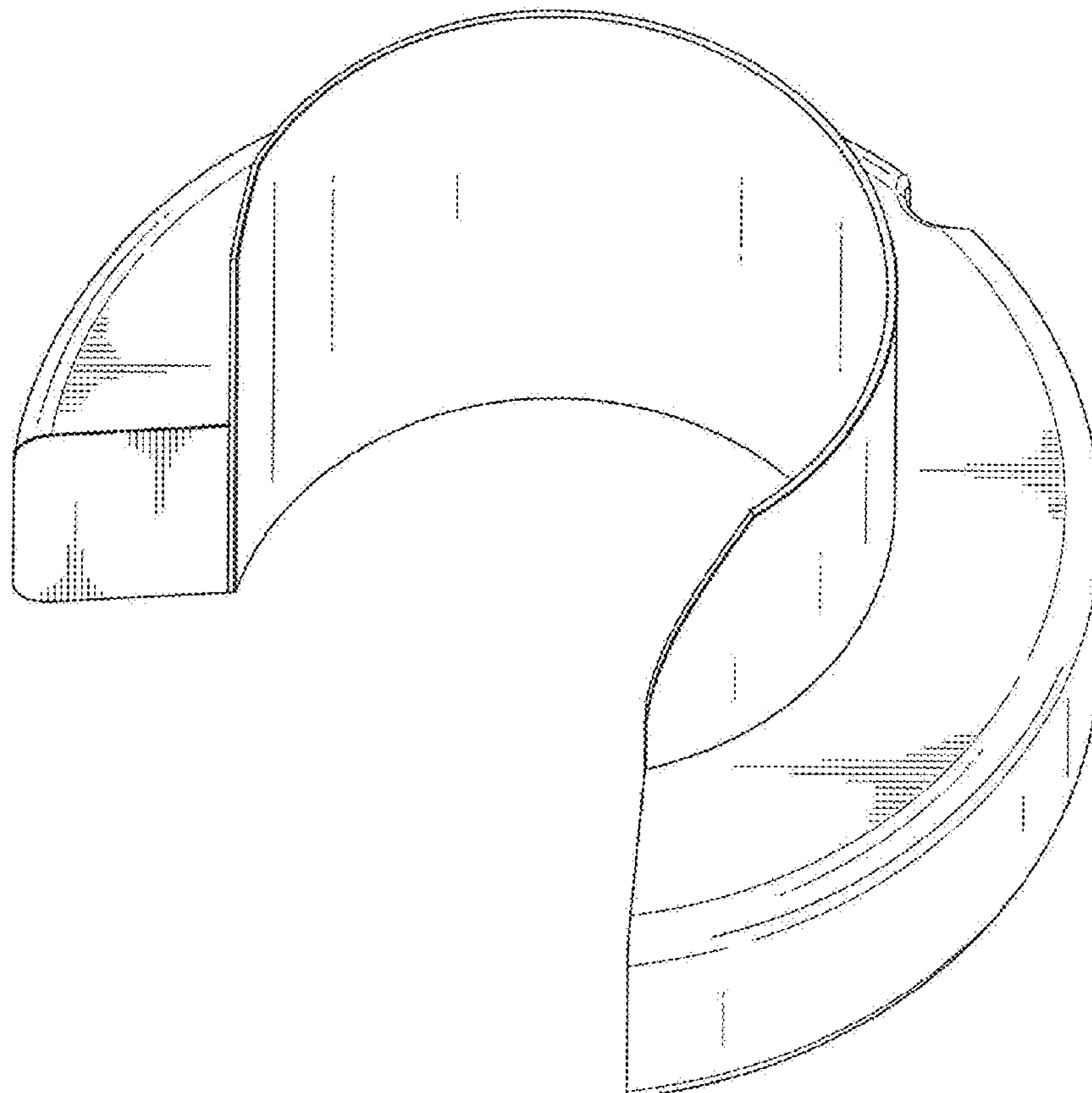
(57) **CLAIM**

I claim the ornamental design for an EvoPEX connector removal tool, as shown and described.

**DESCRIPTION**

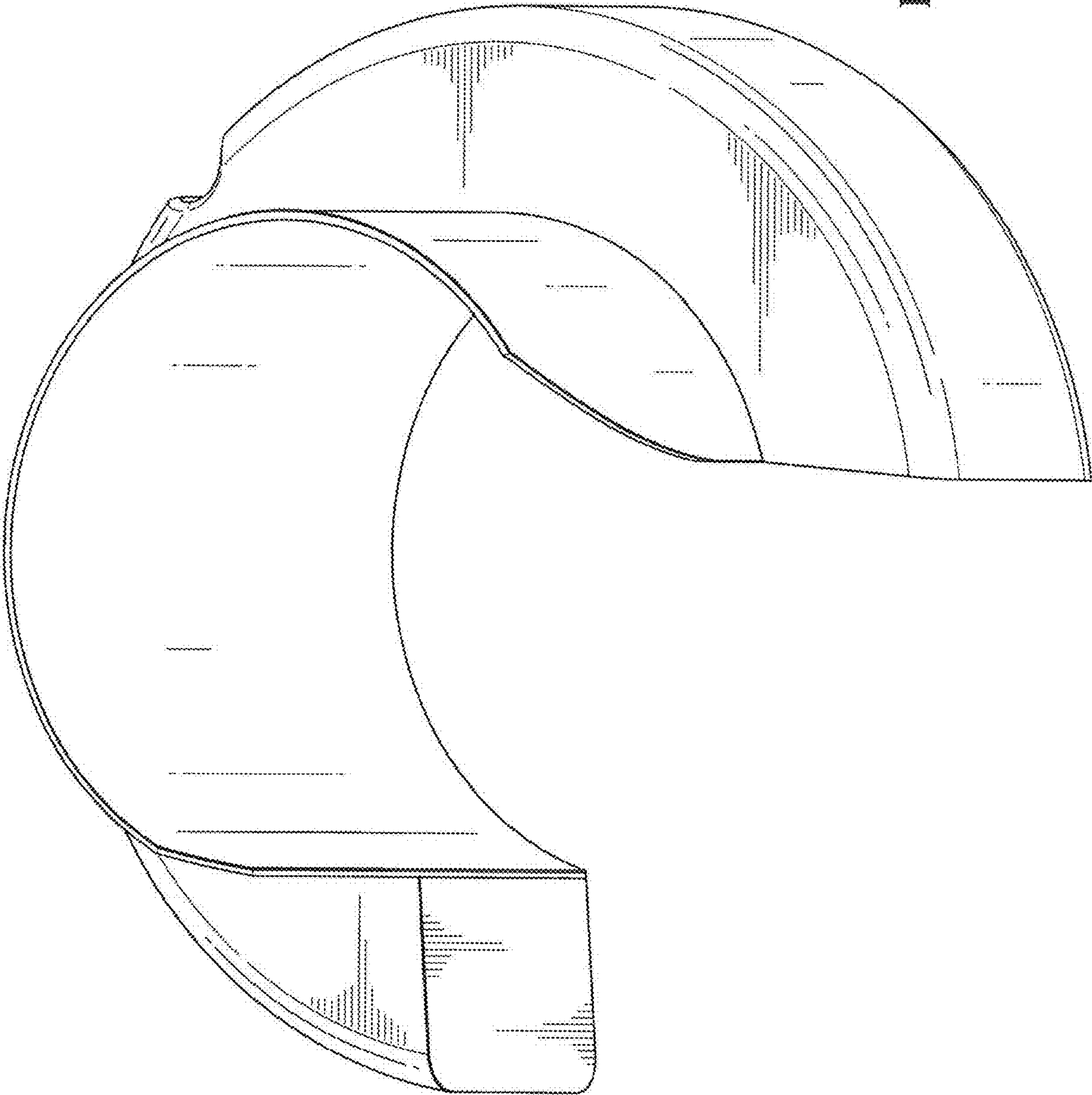

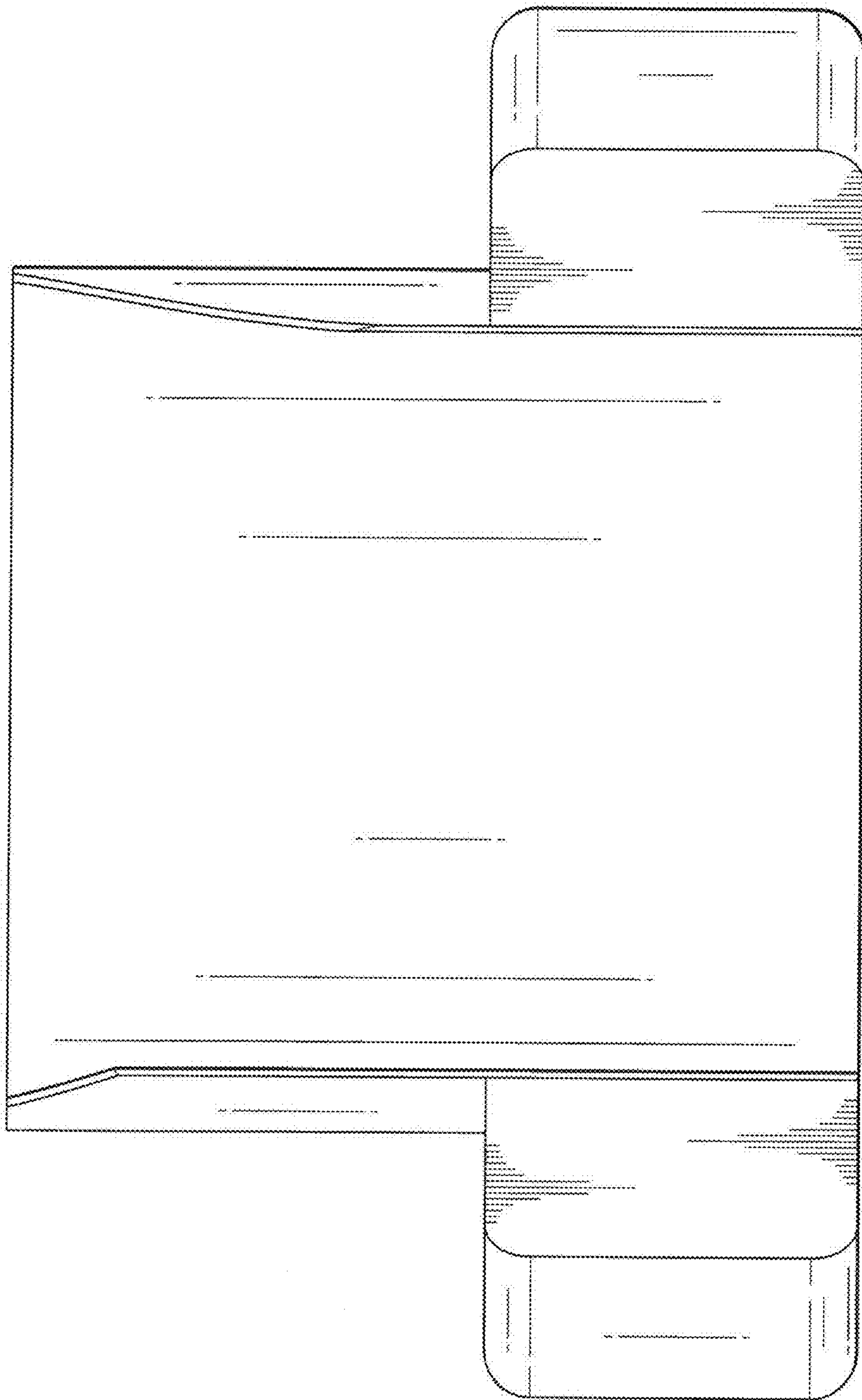

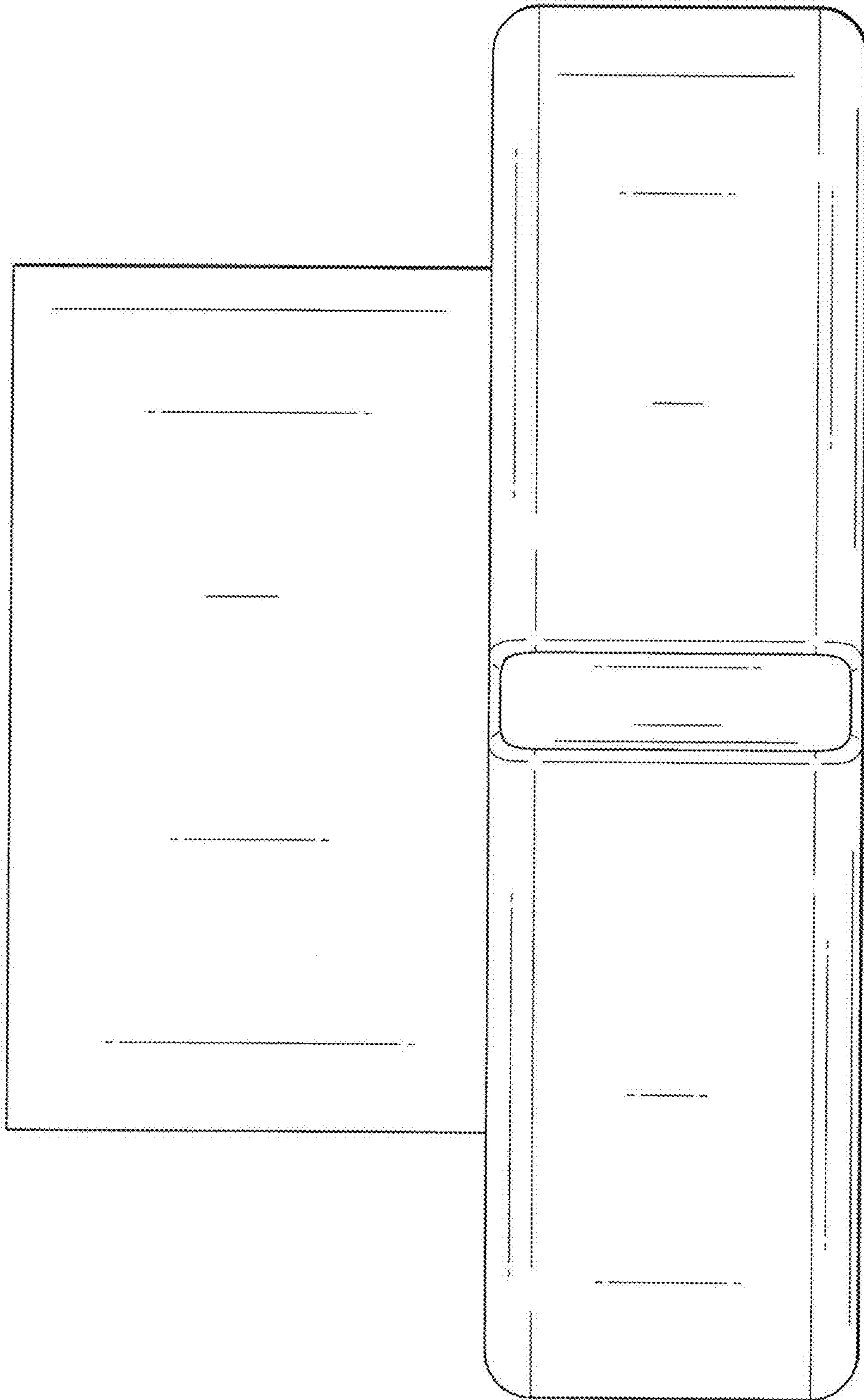

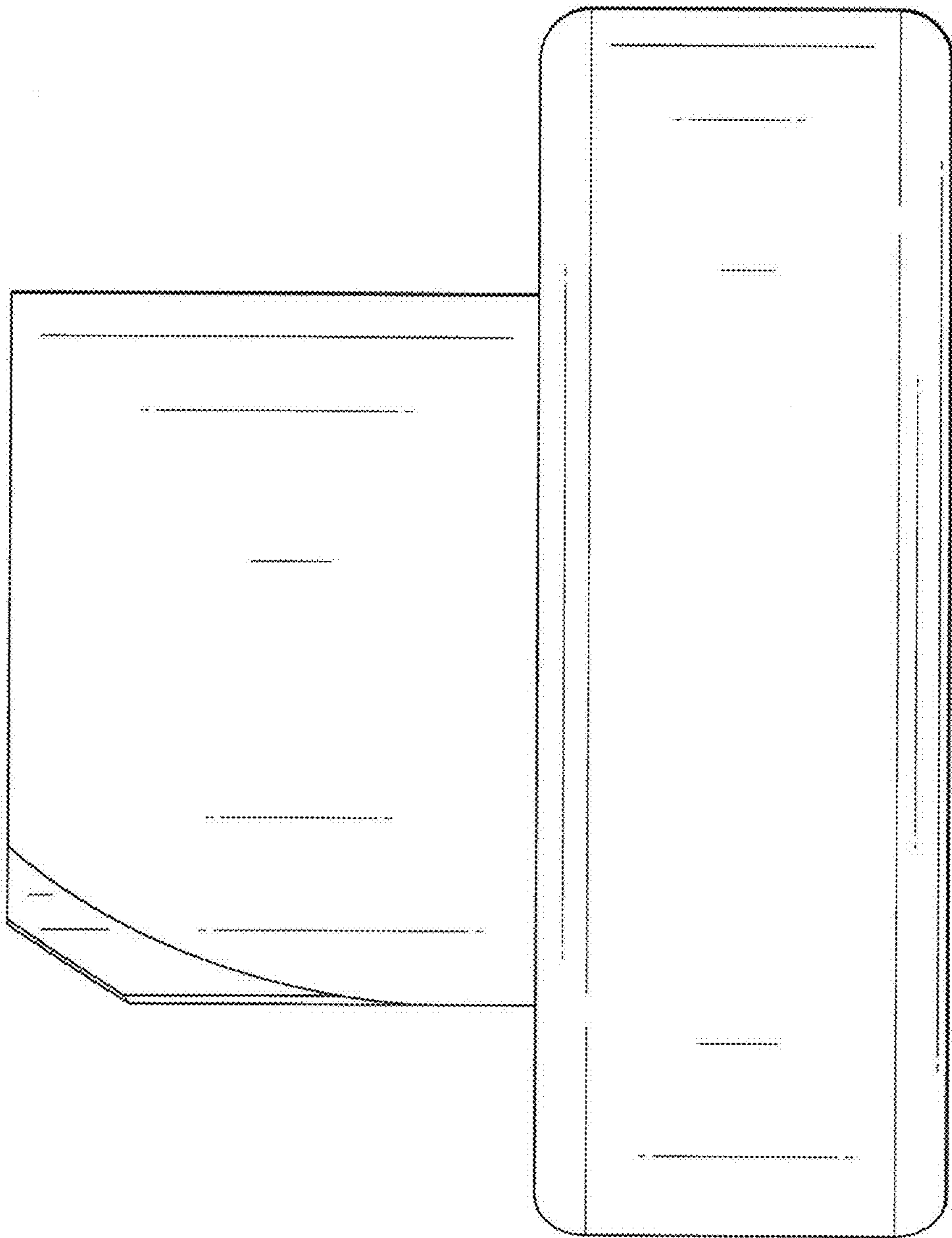

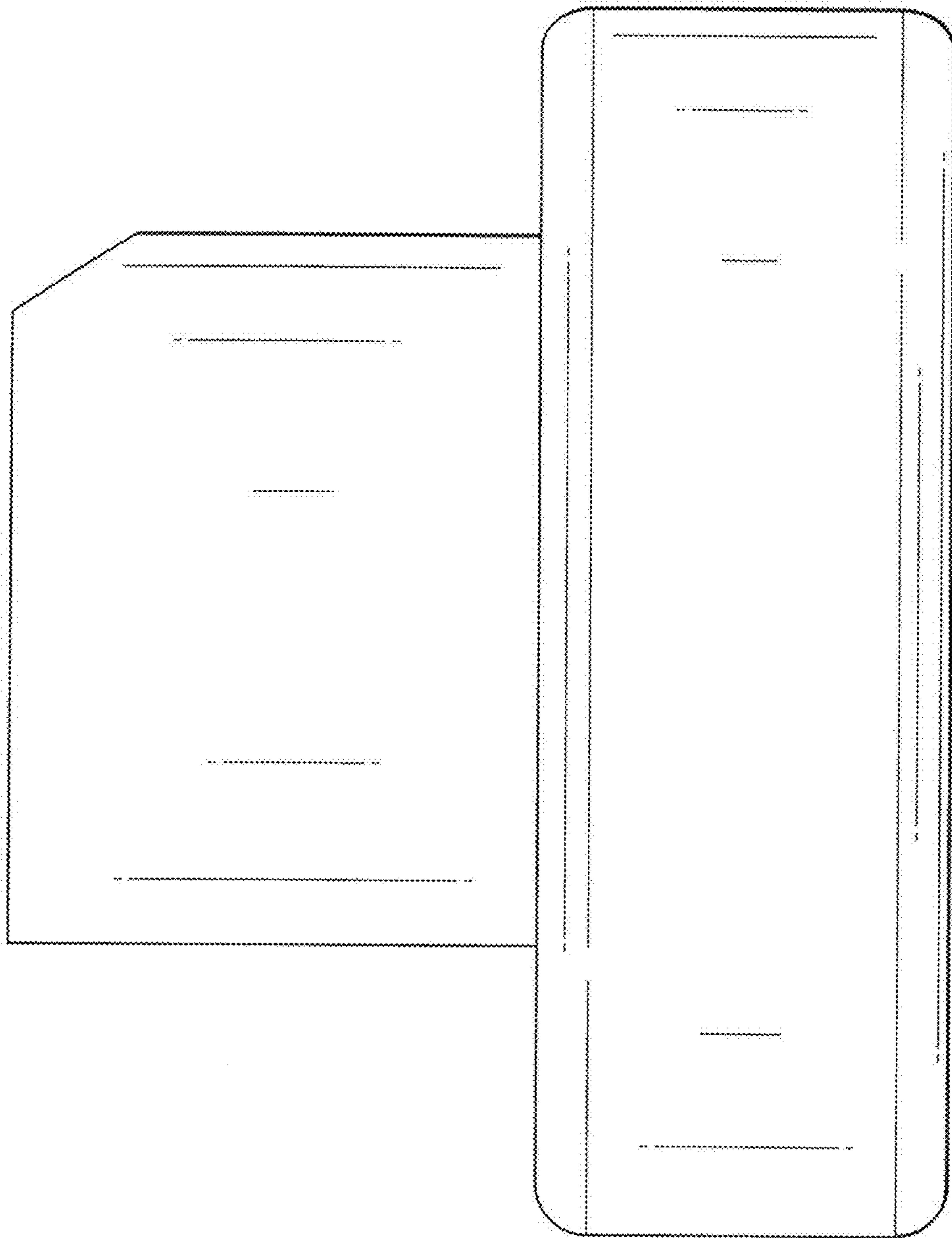

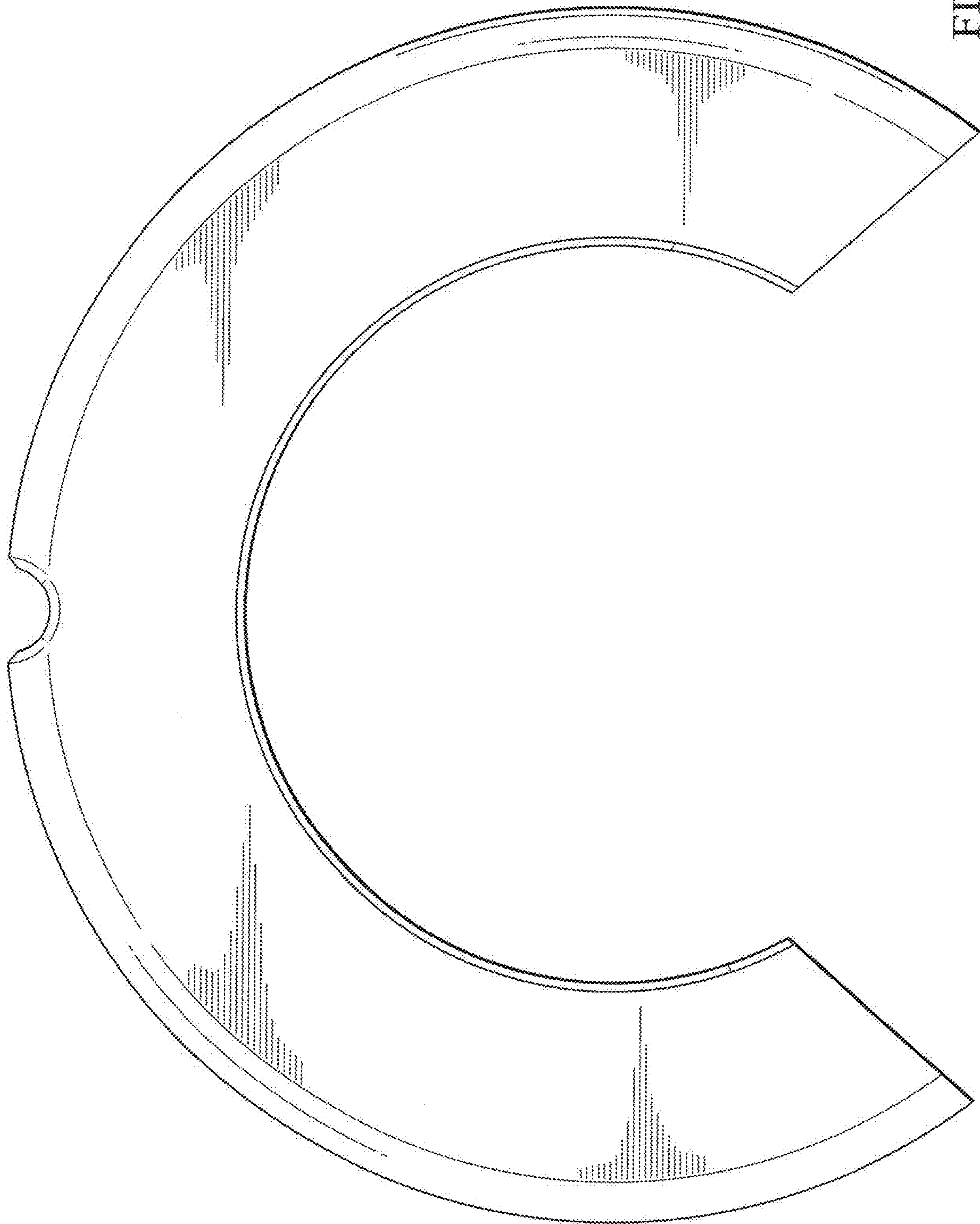

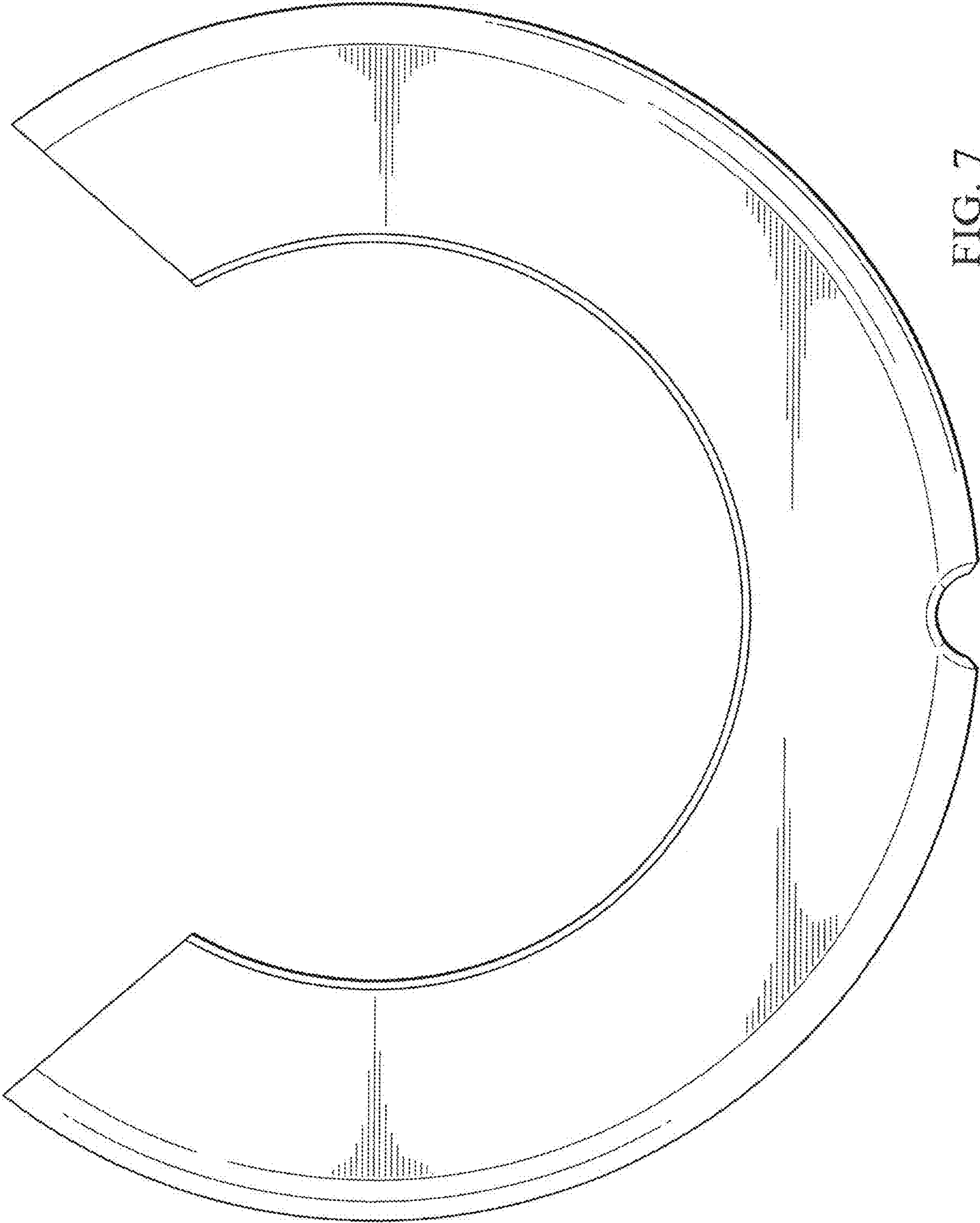

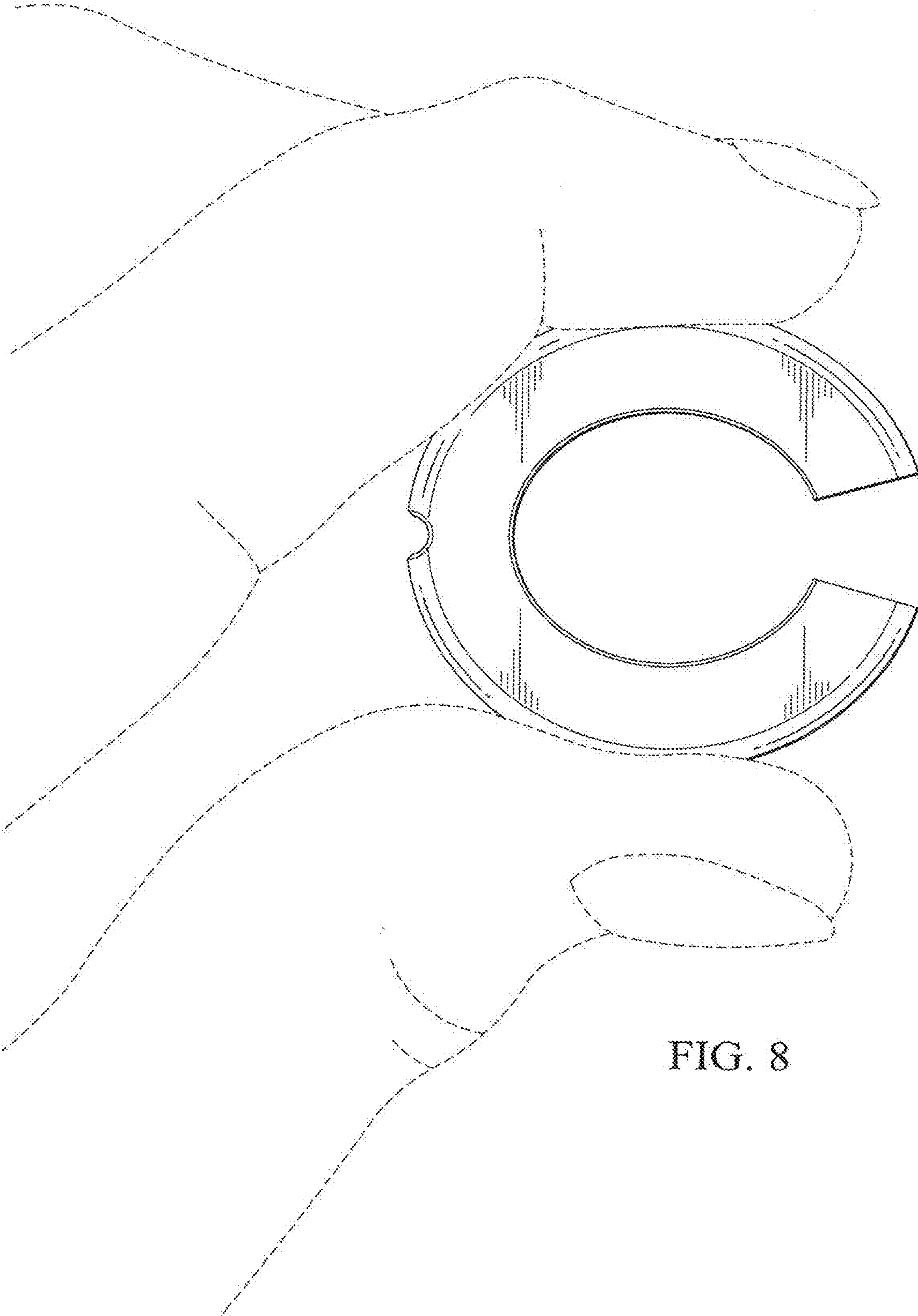
