(57) **CLAIM**

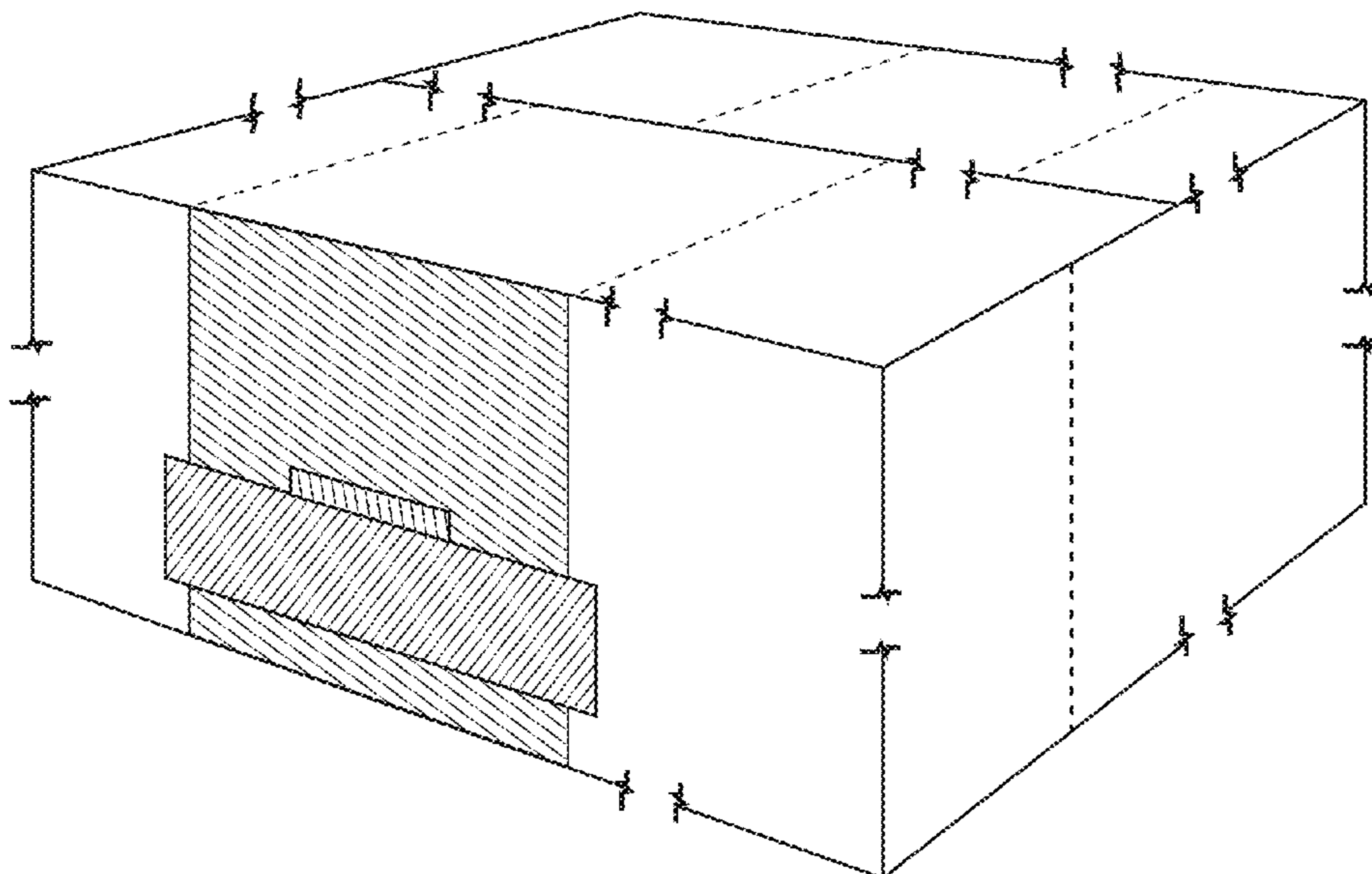
The ornamental design for a carton with color striping, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a carton with color striping, with the color striping indicated by the cross-hatching; FIG. 2 is a front view of the carton of FIG. 1; FIG. 3 is a top view of the carton of FIG. 1; and, FIG. 4 is a right side view of the carton of FIG. 1; and the rear view, bottom view, and left side view form no part of the claimed design.

Portions of the carton with color striping shown in broken lines form no part of the claimed design. Unshaded portions of the carton with color striping adjacent solid lines form no part of the claimed design. The carton with color striping is shown with symbolic breaks in height, length and width. The appearance of any portion of the article between the break lines forms no part of the claimed design.

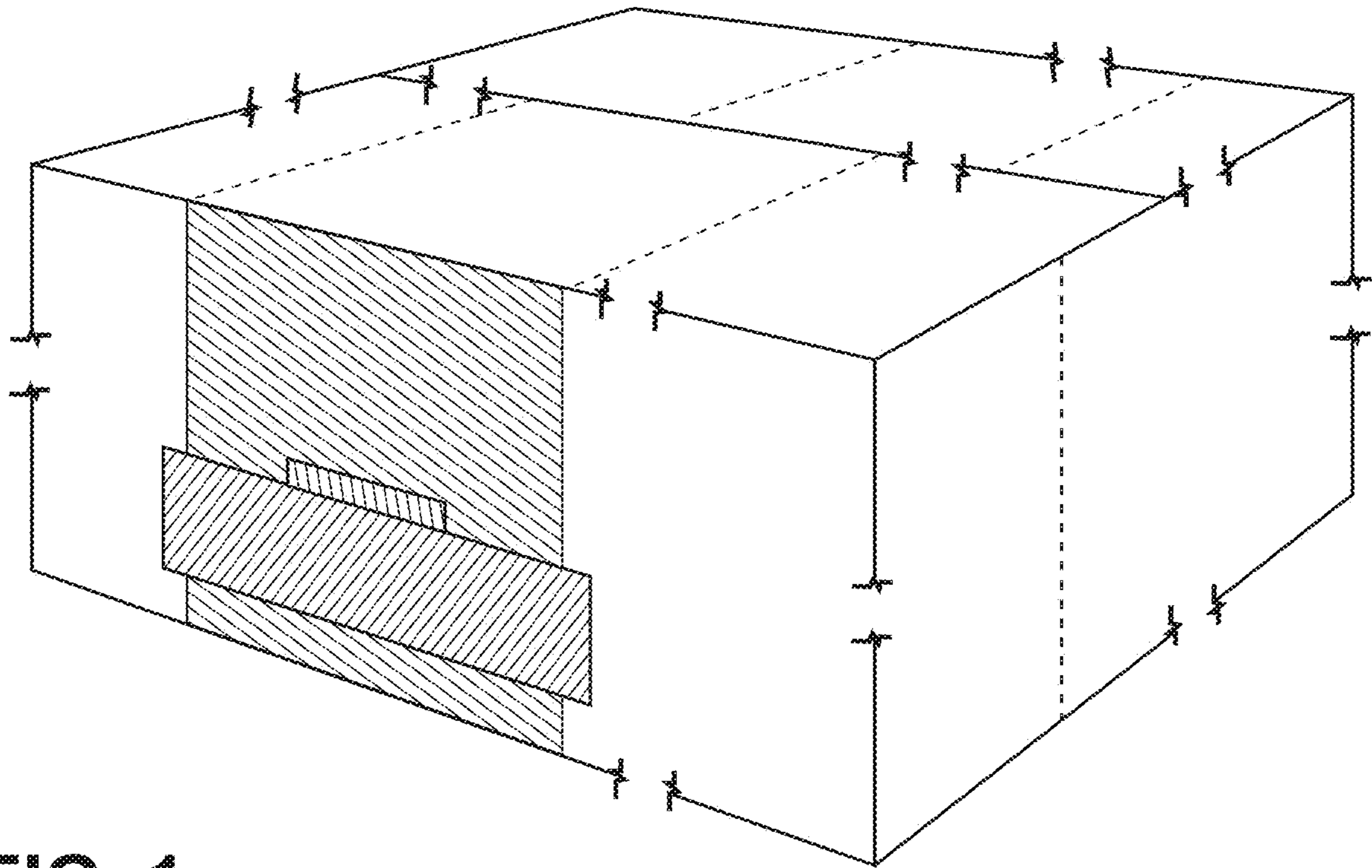

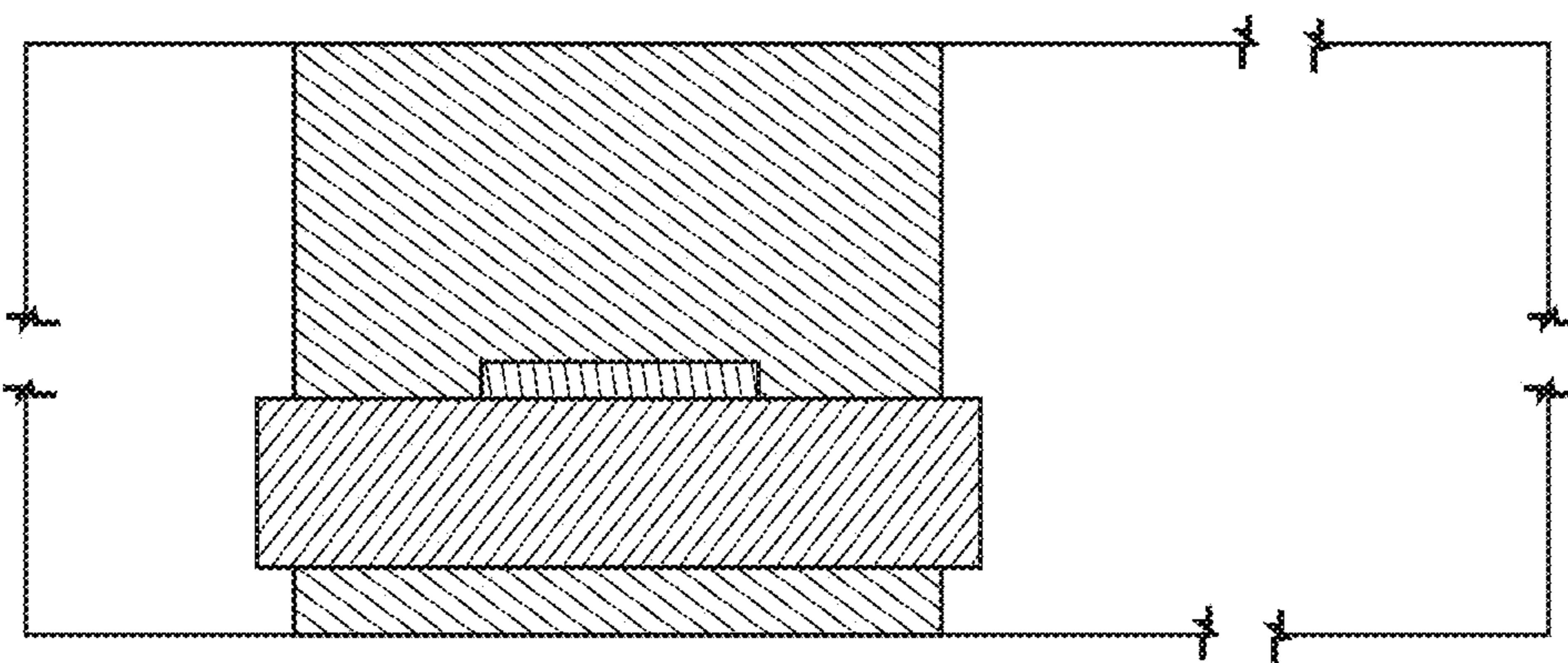

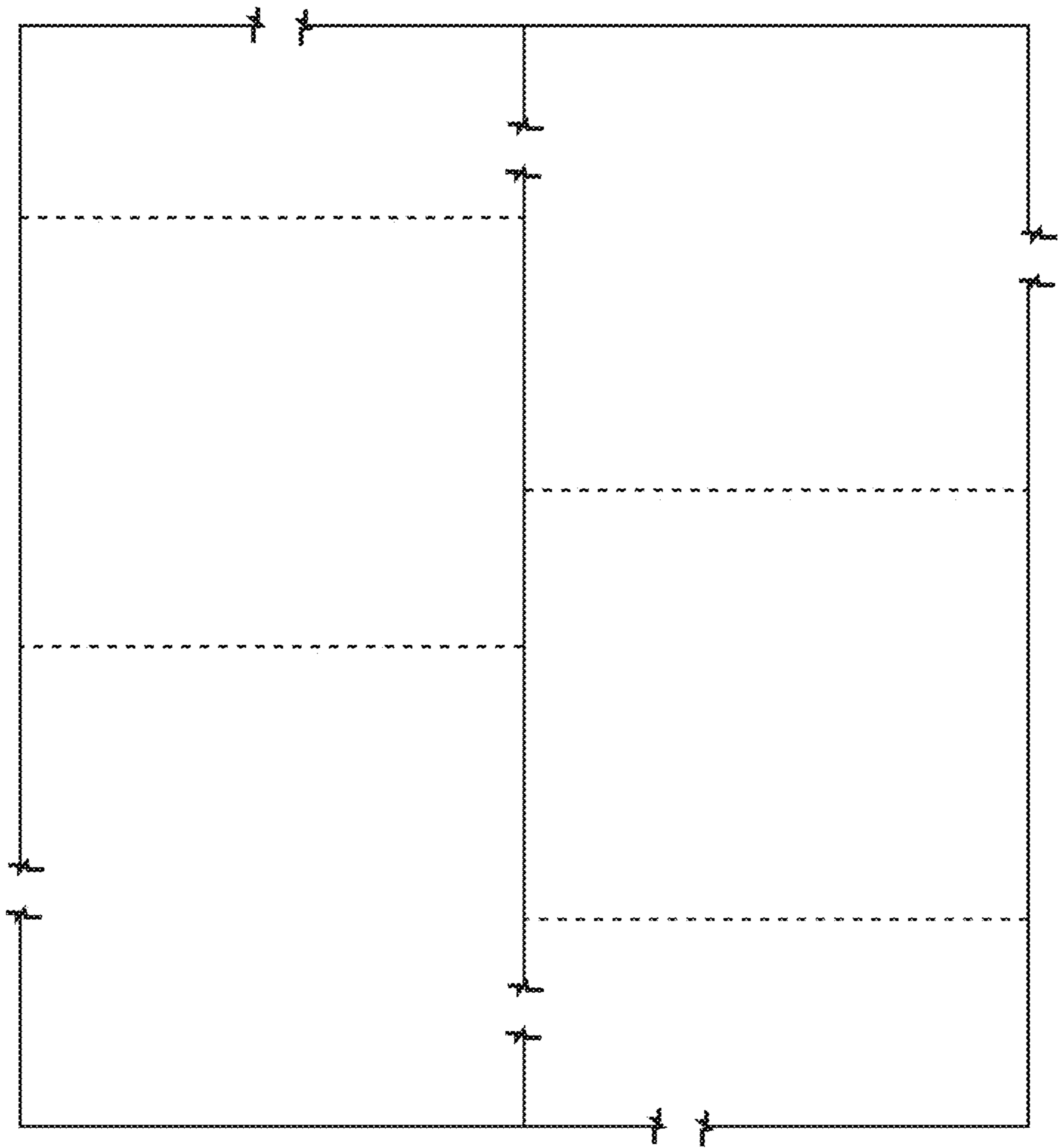

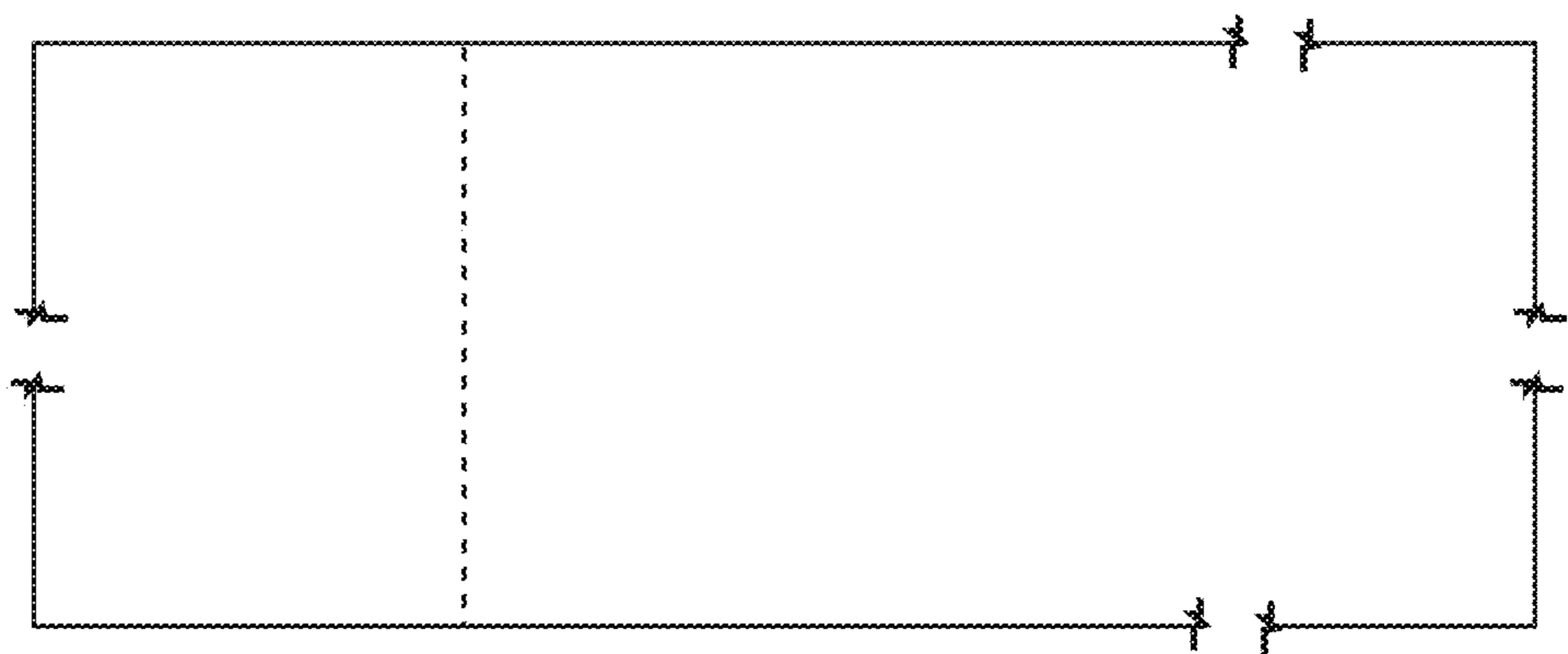
