FIG. 1 is a perspective view of a bottle showing our new design;

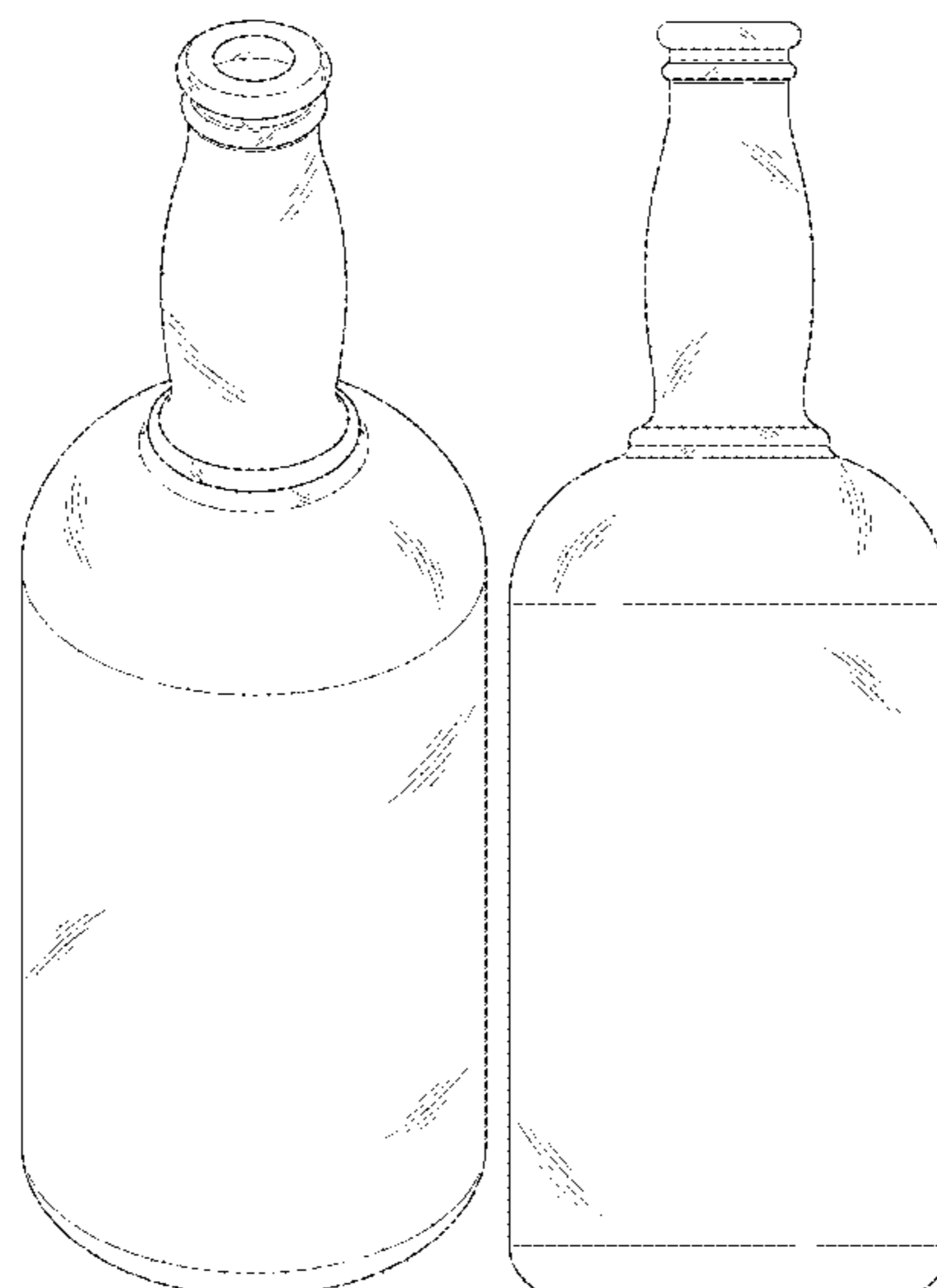
FIG. 2 is a front view thereof, the rear, right side and left side views being substantially identical;

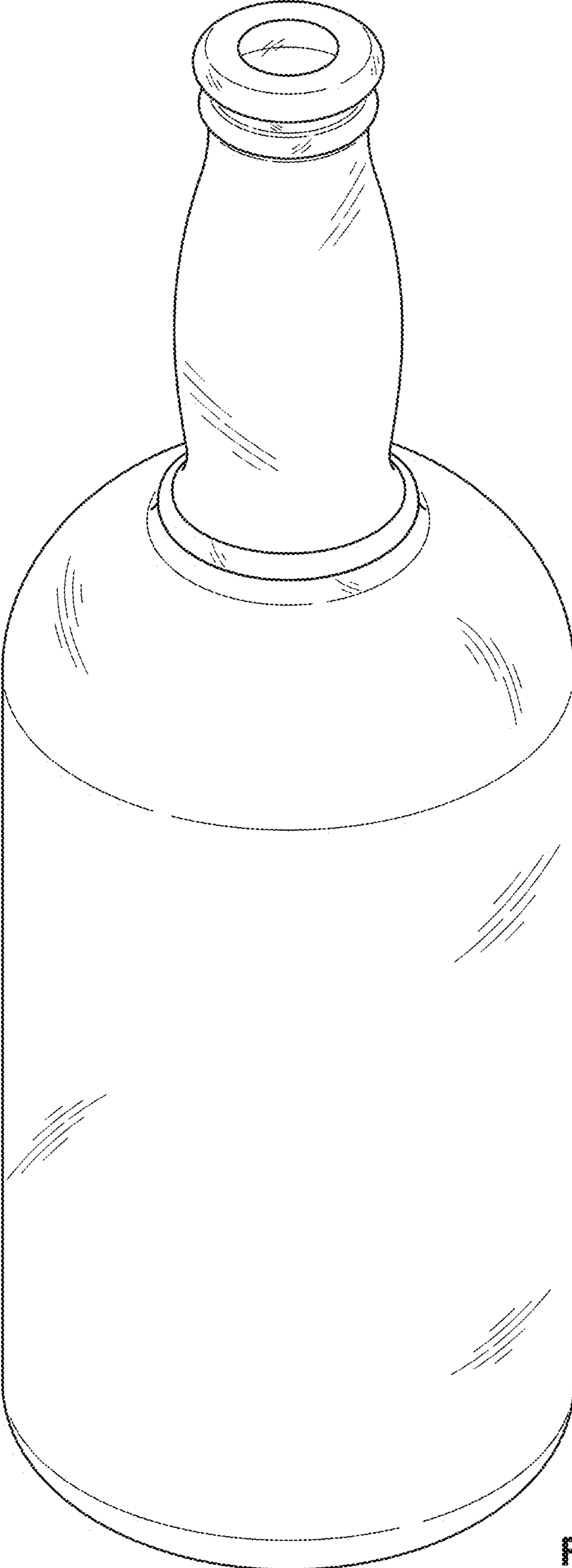

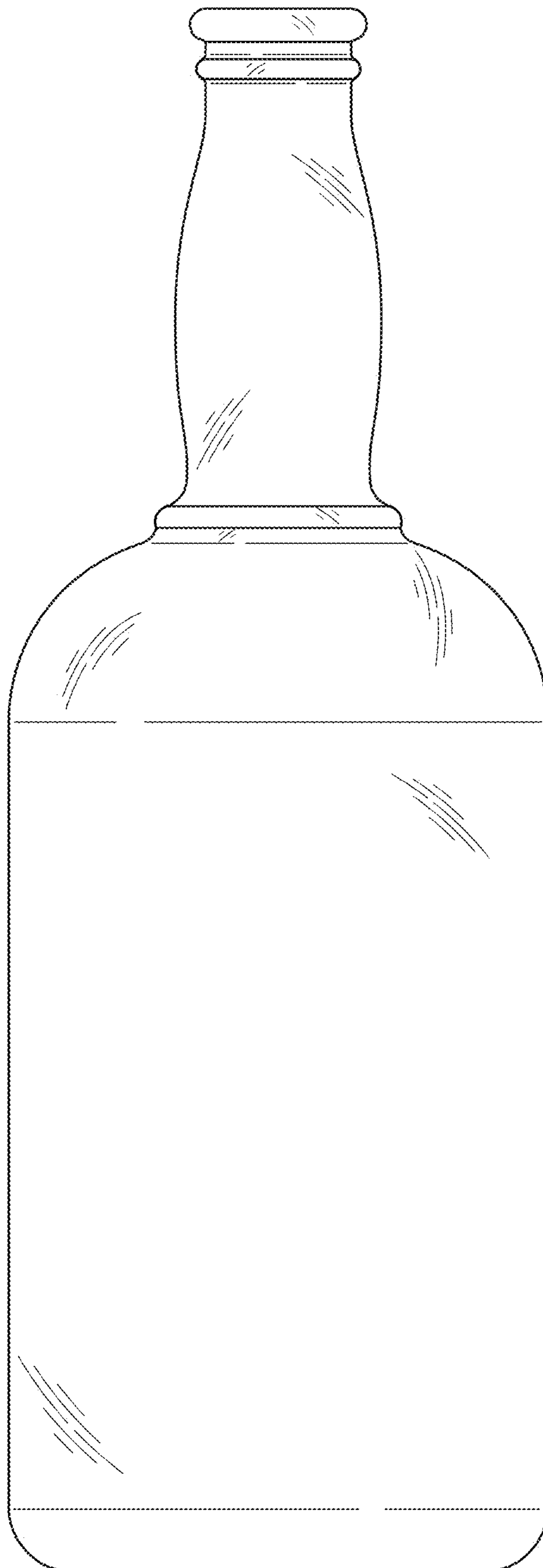

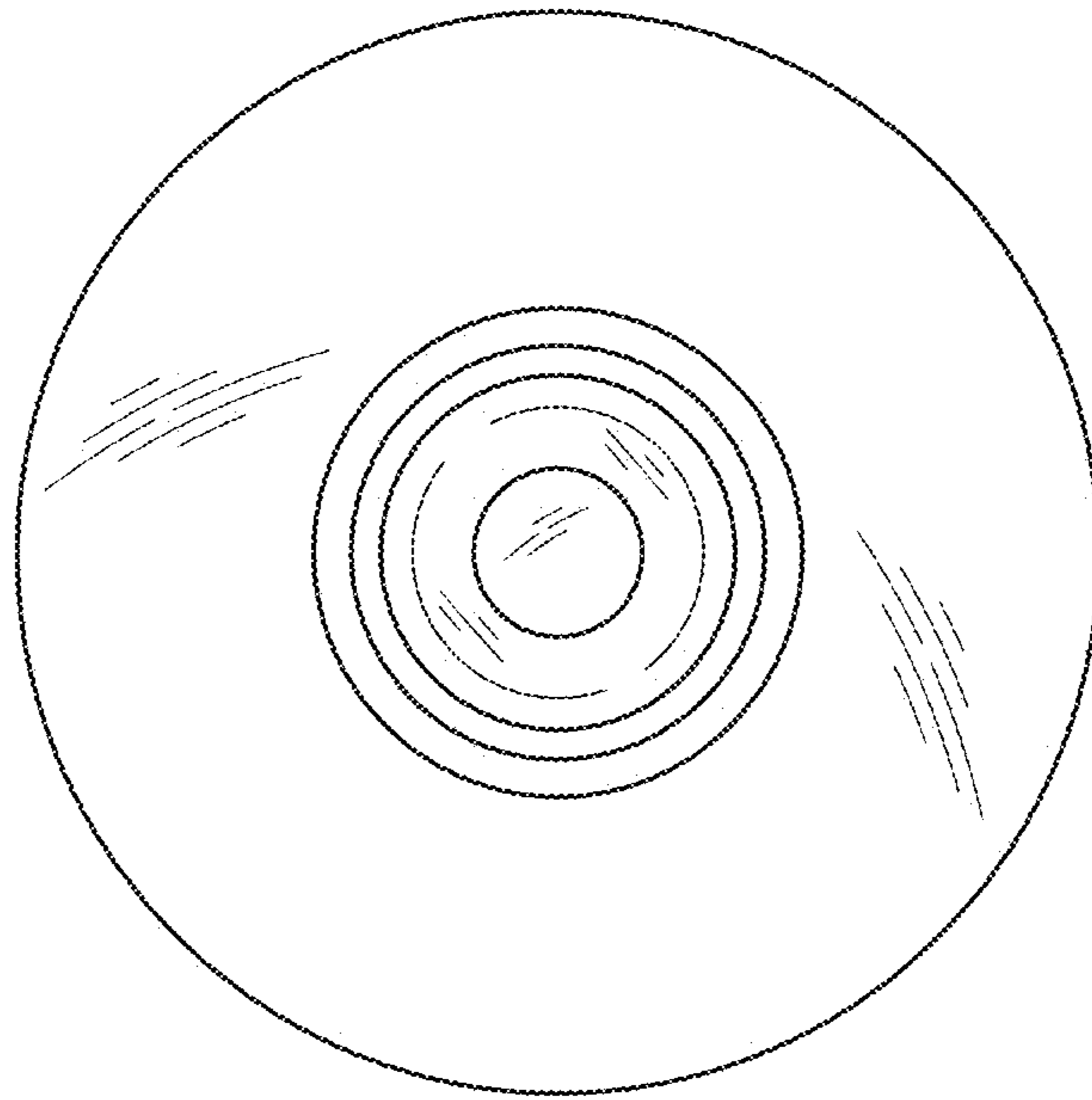

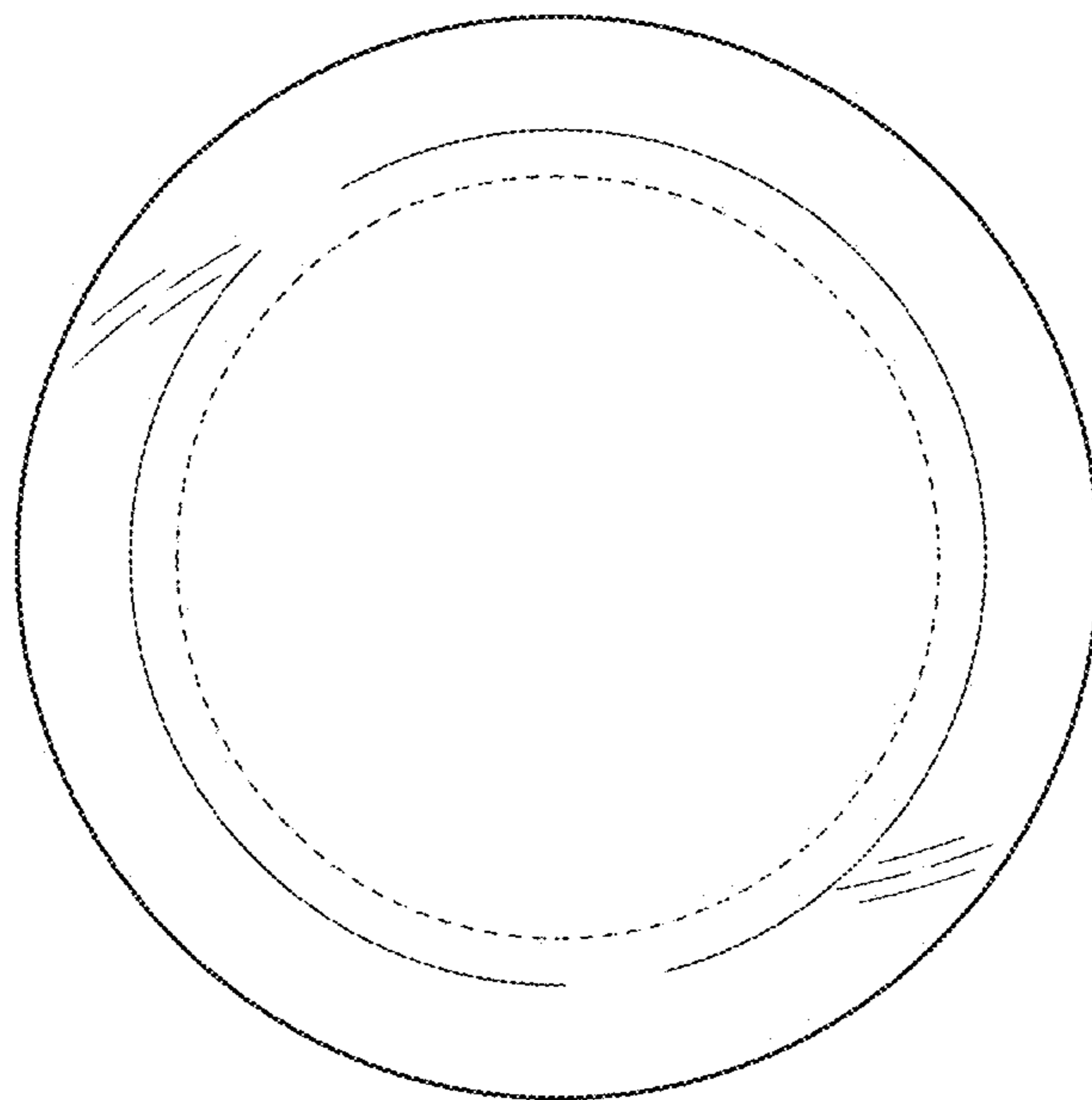
