(57) **CLAIM**

The ornamental design of a wheel rim, as shown and described.

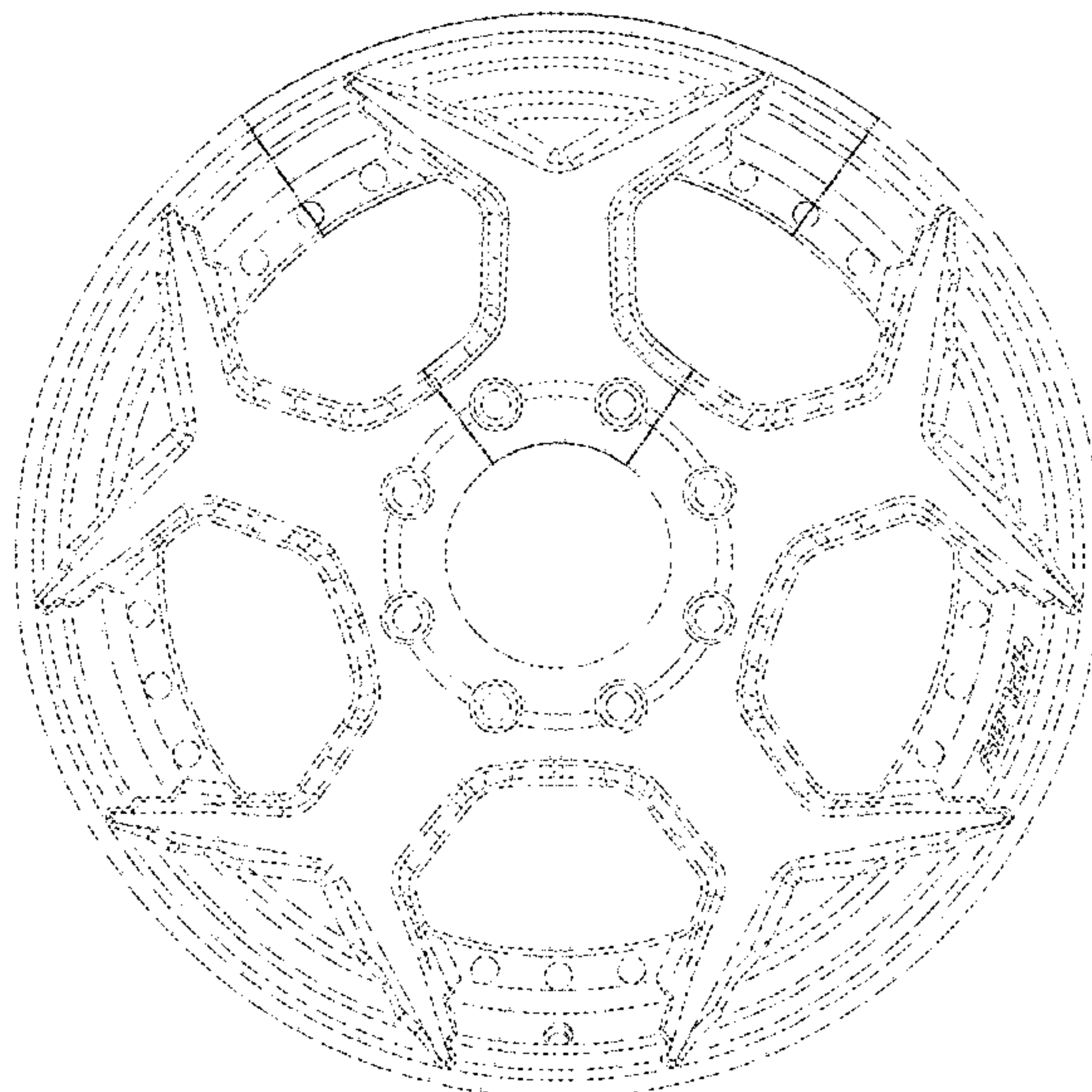
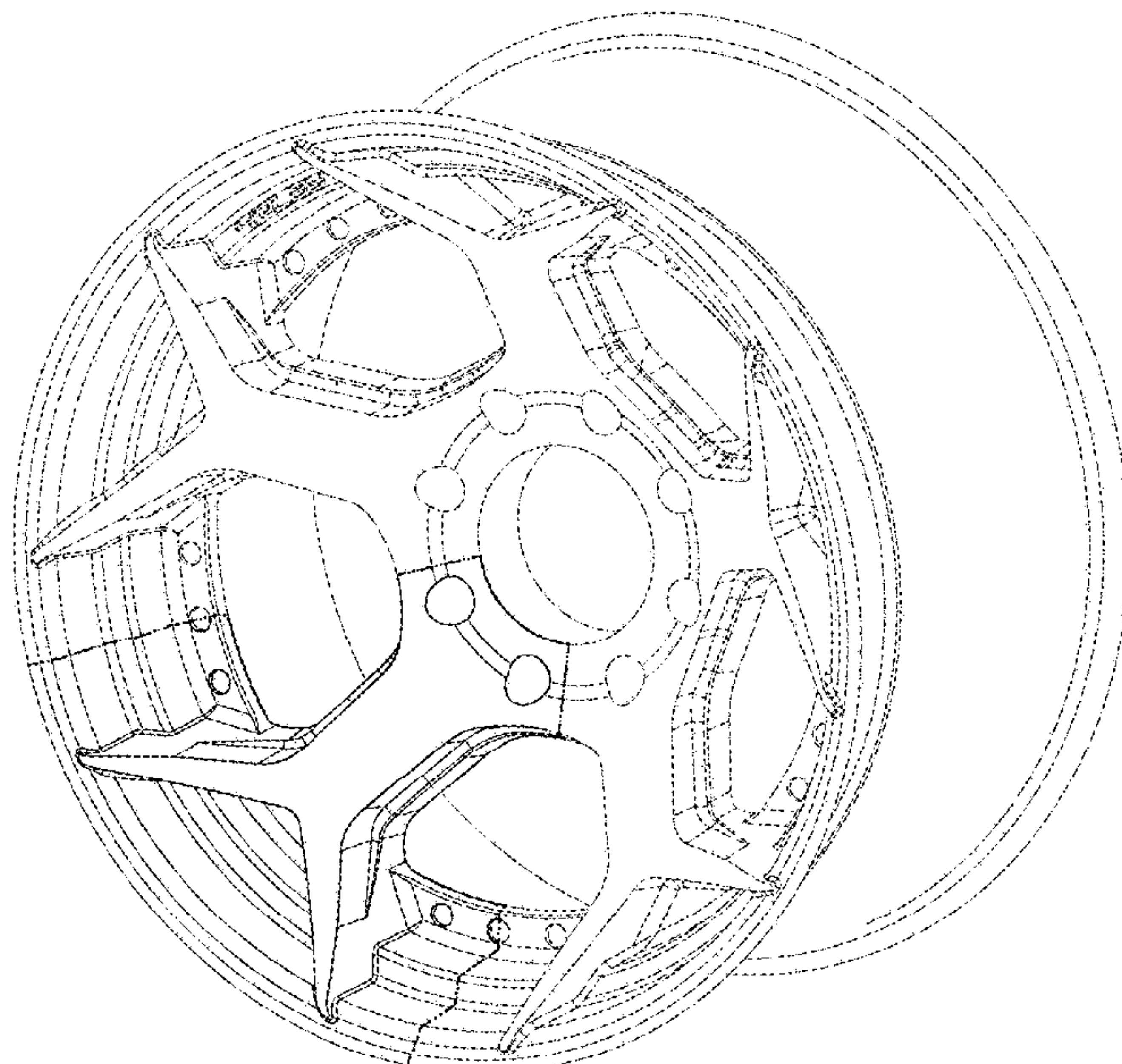

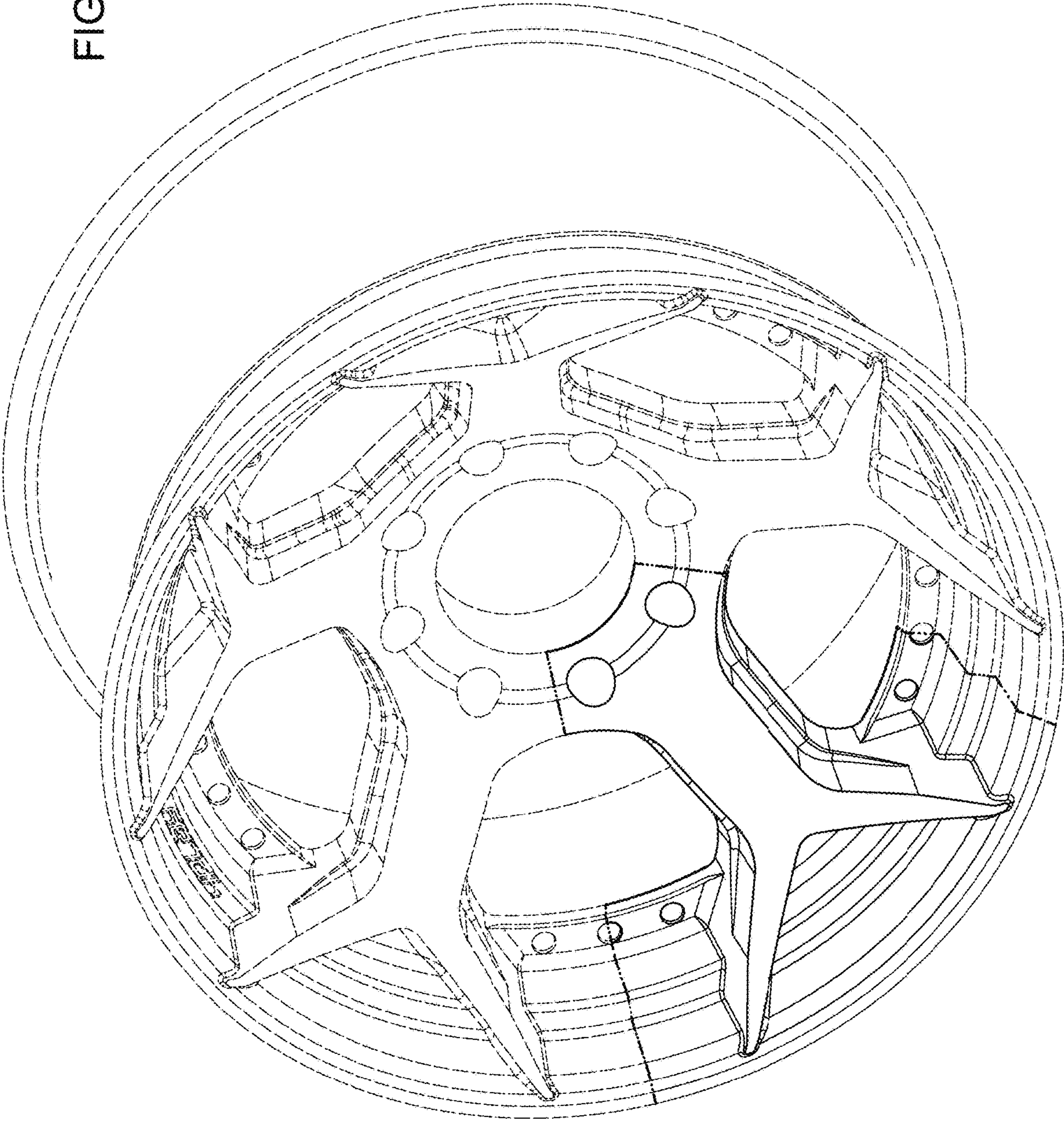
