DESCRIPTION

FIG. 1 is a front, left and top side perspective view of a tire showing our new design;

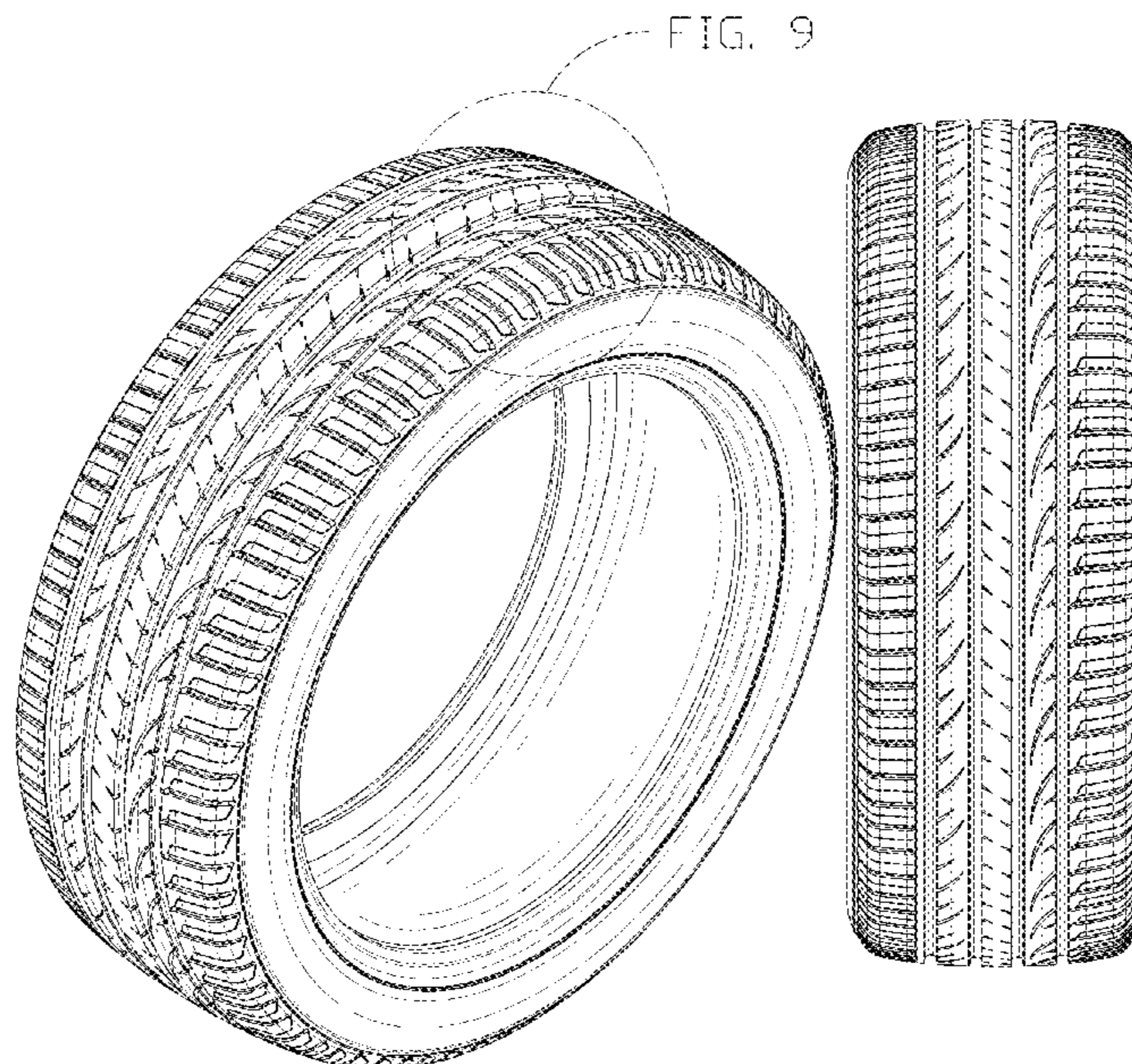

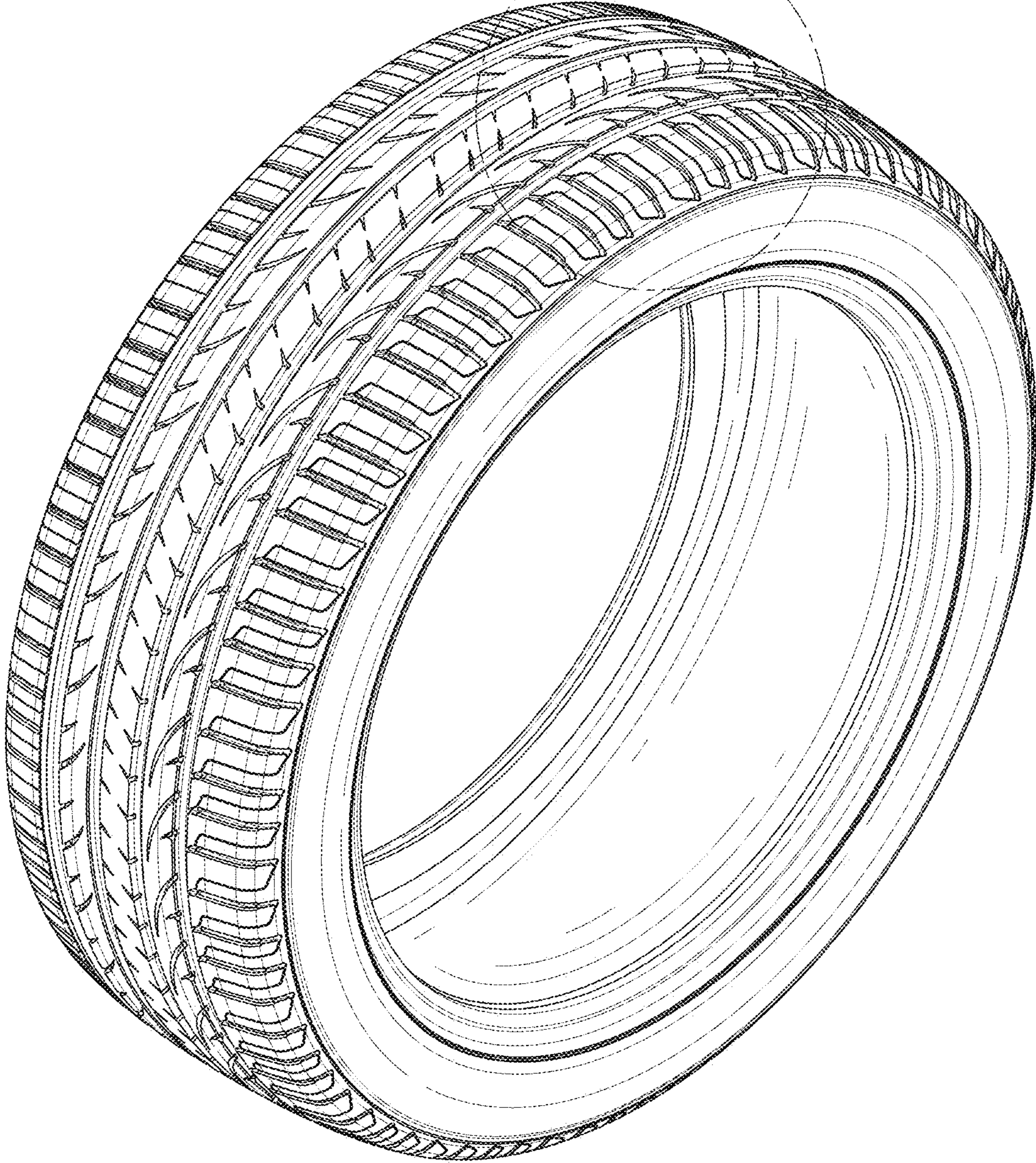

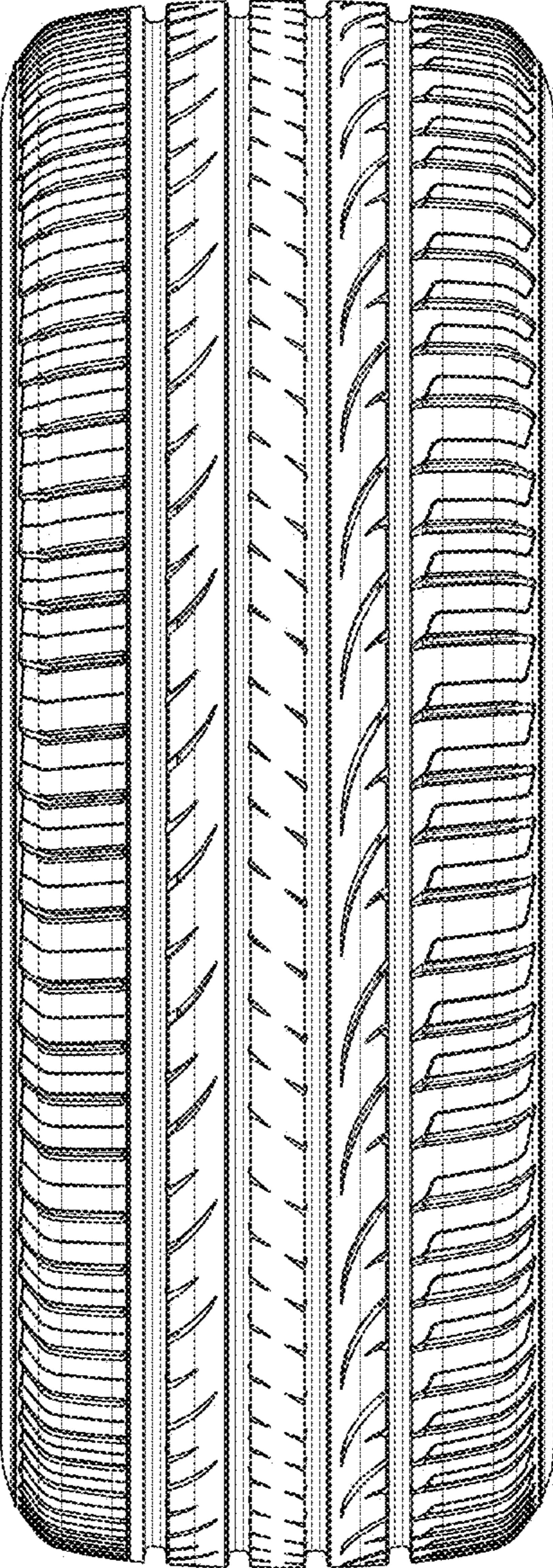

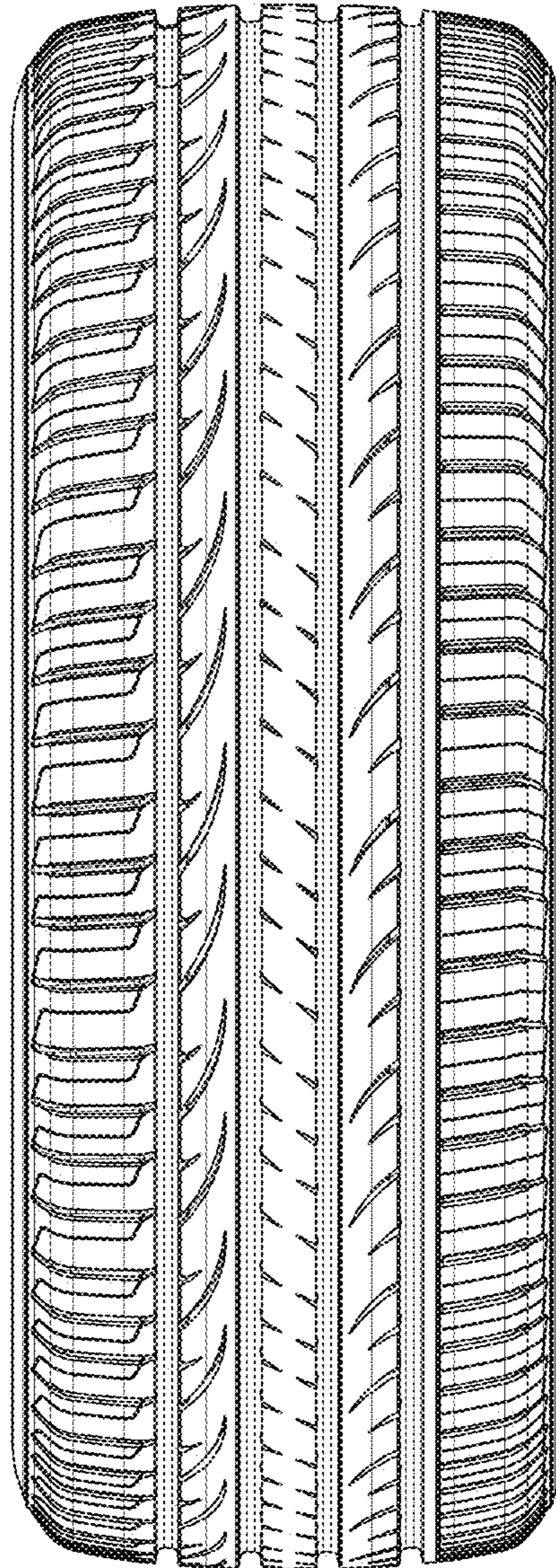

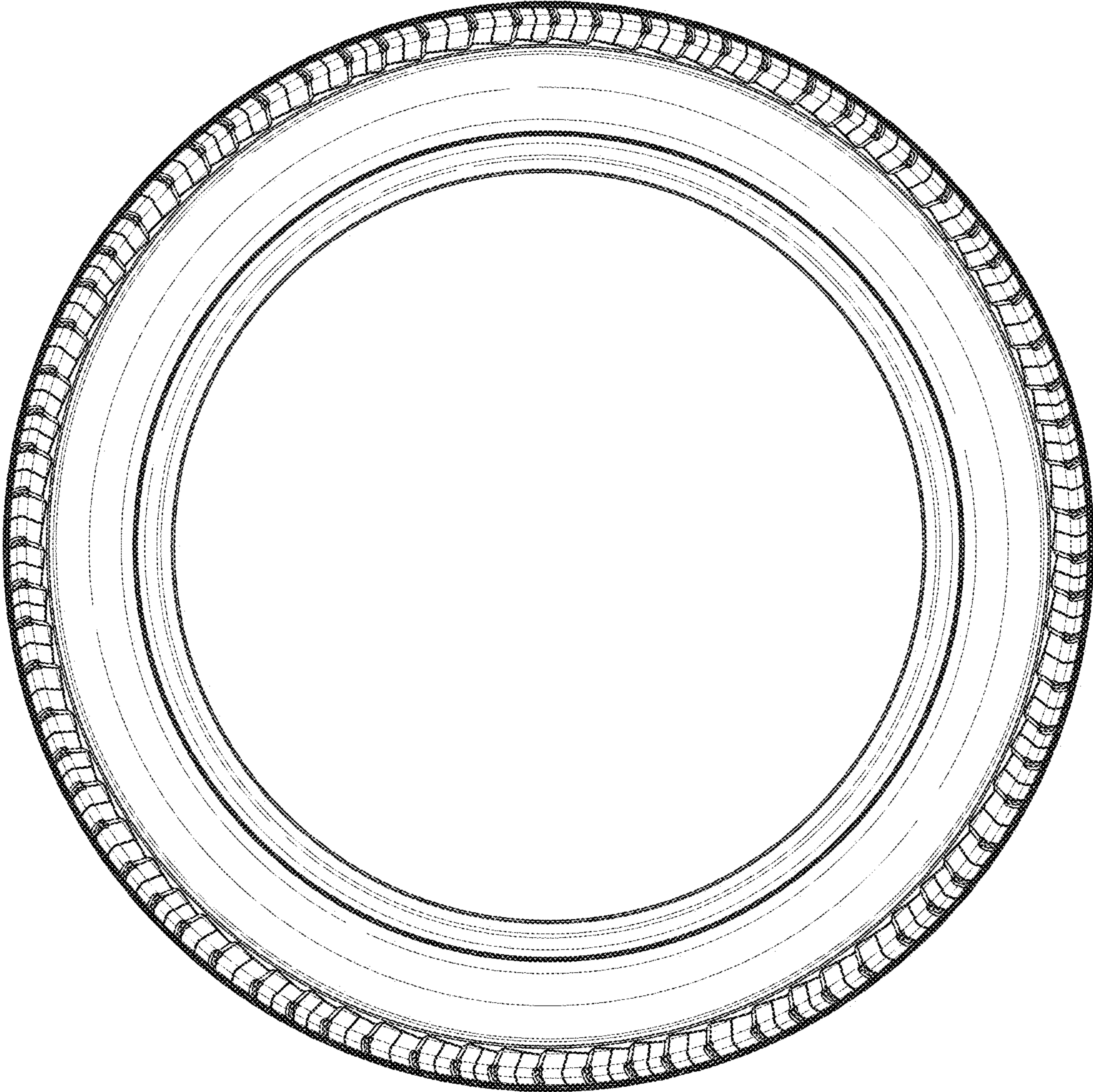

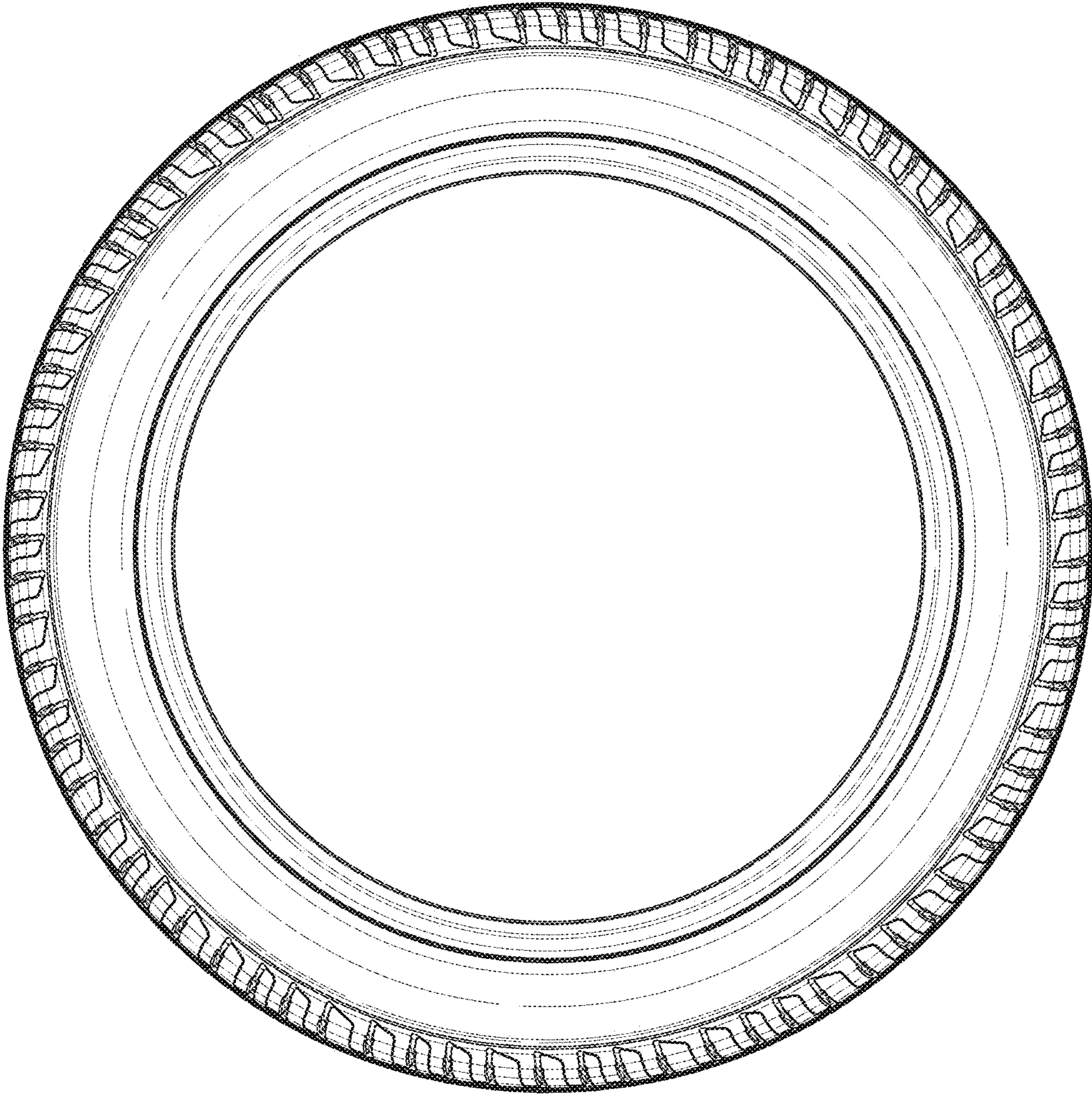

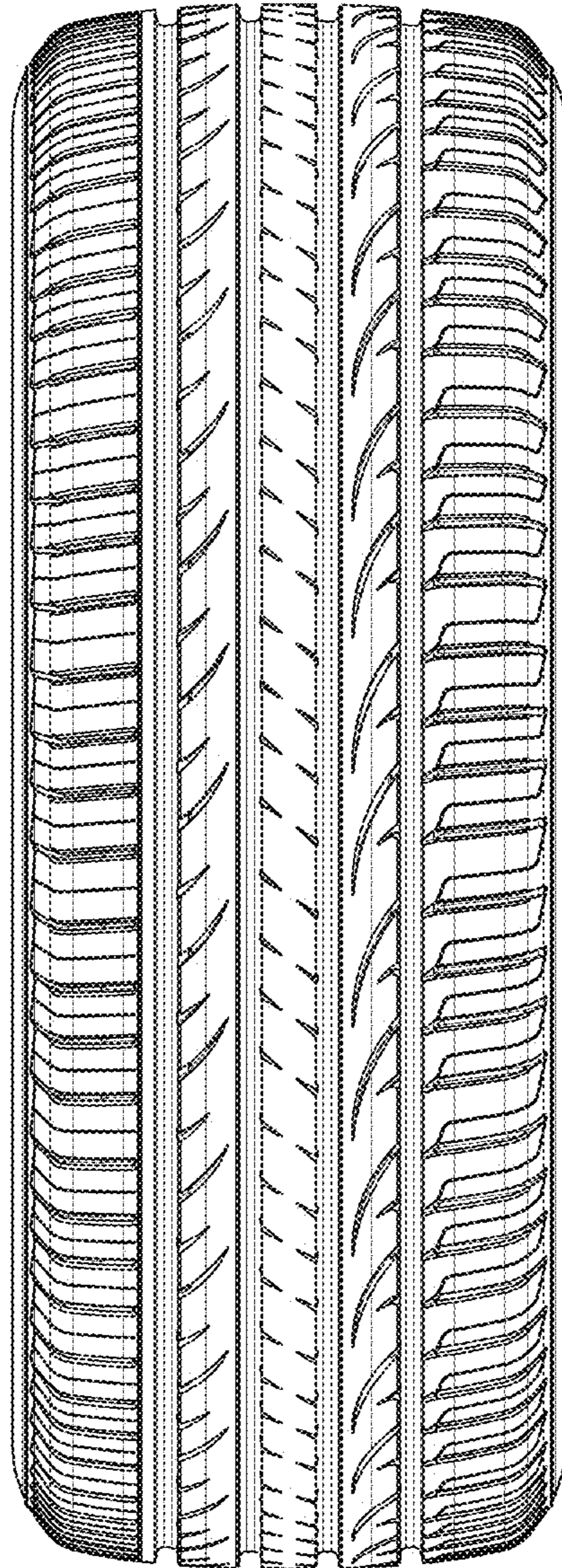

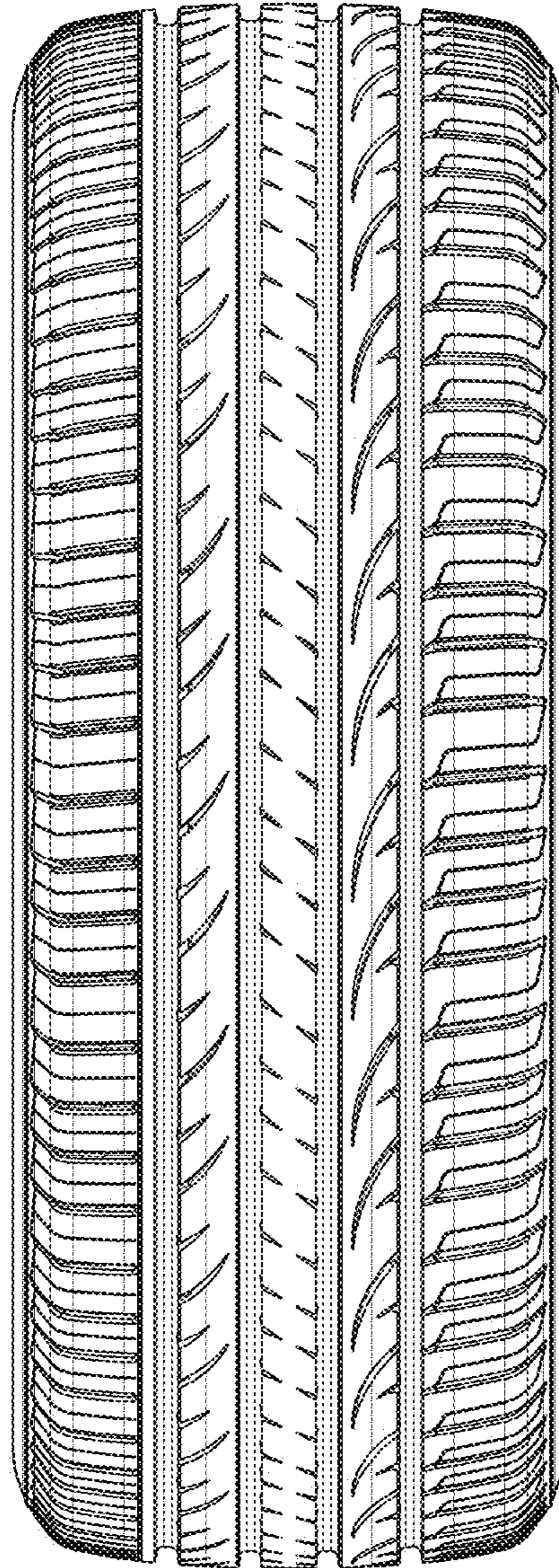

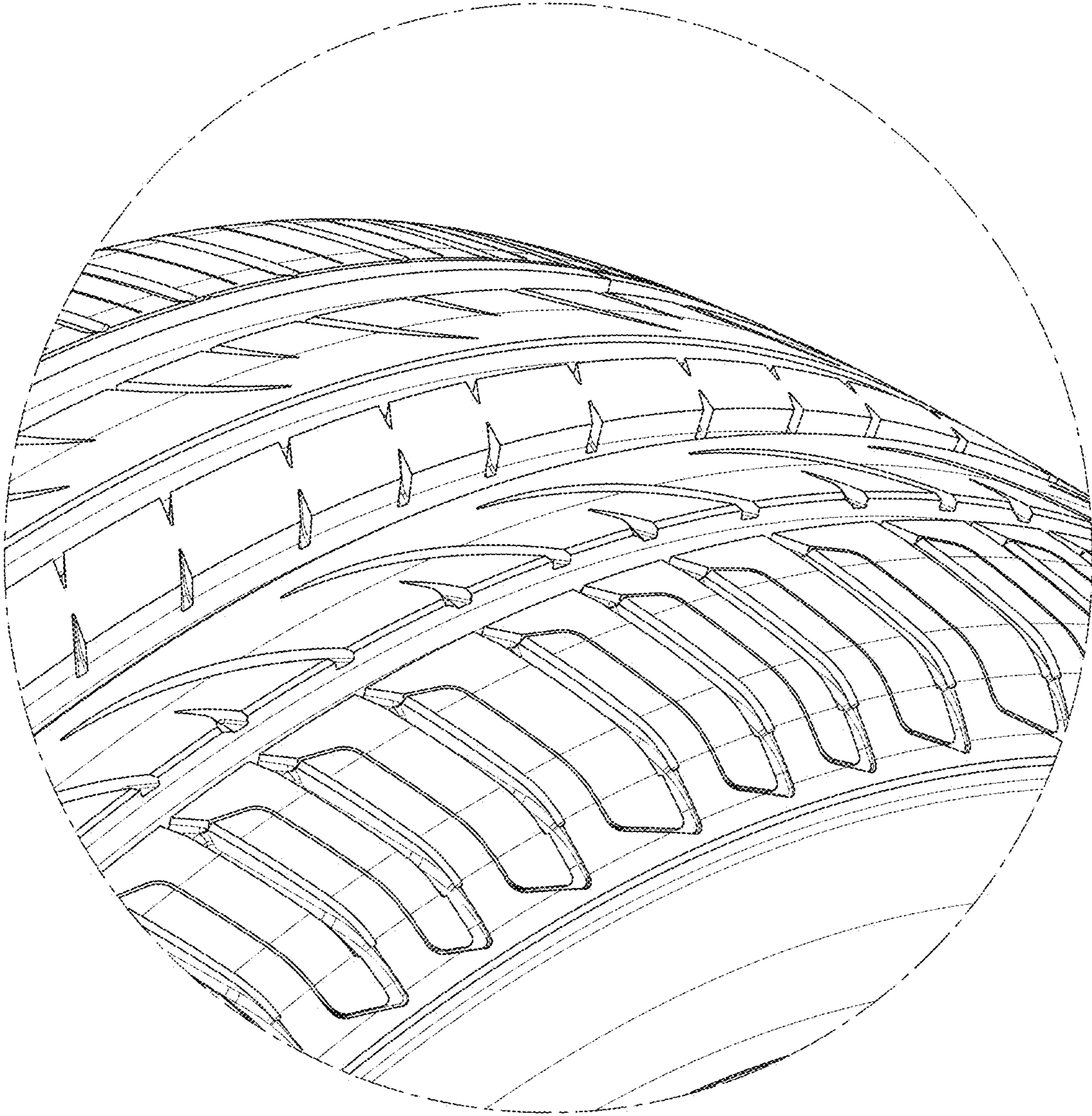
