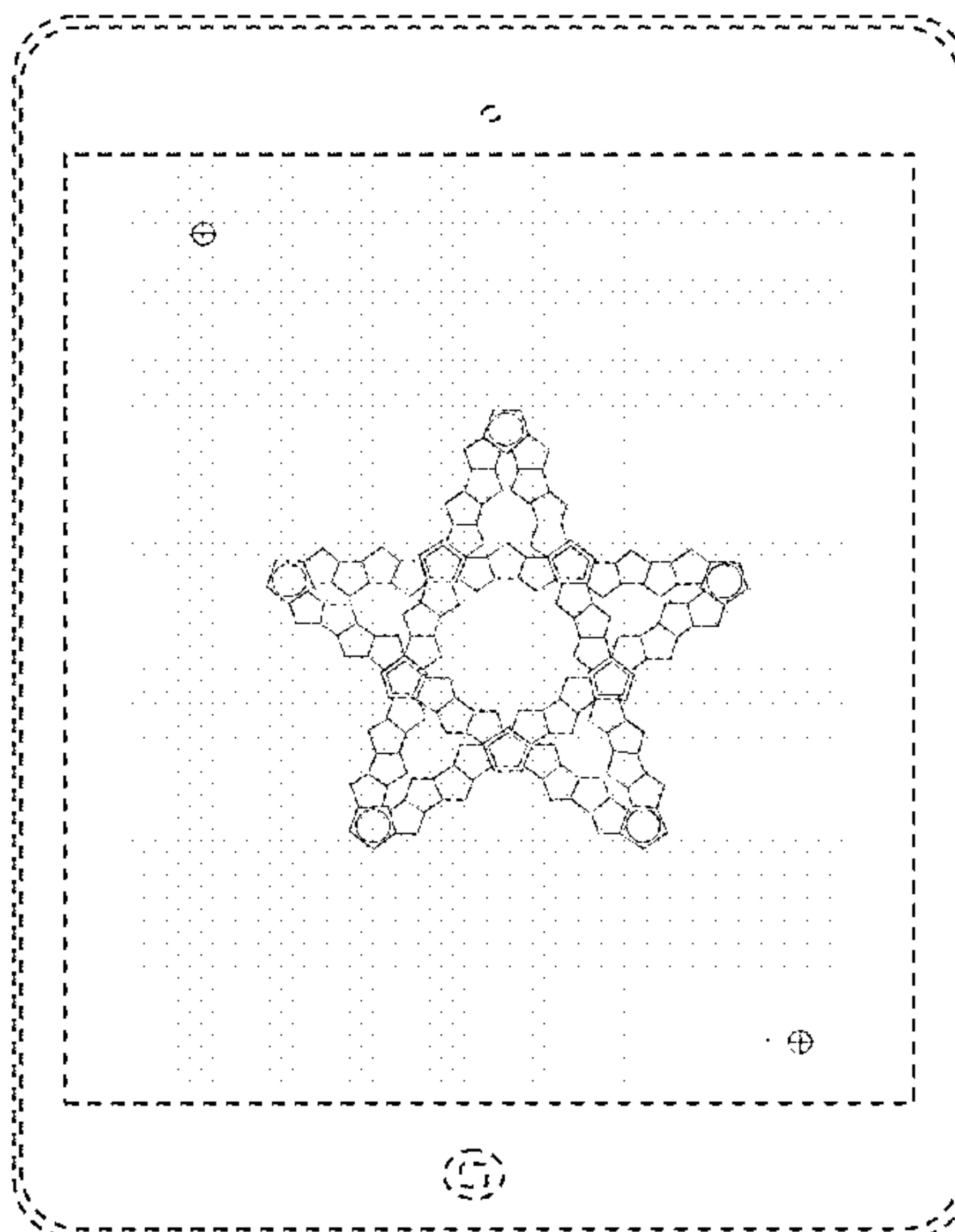
The ornamental design for a display screen with graphical user interface for a digital game, as shown and described.
