FIG. 12 is a twelfth image thereof;

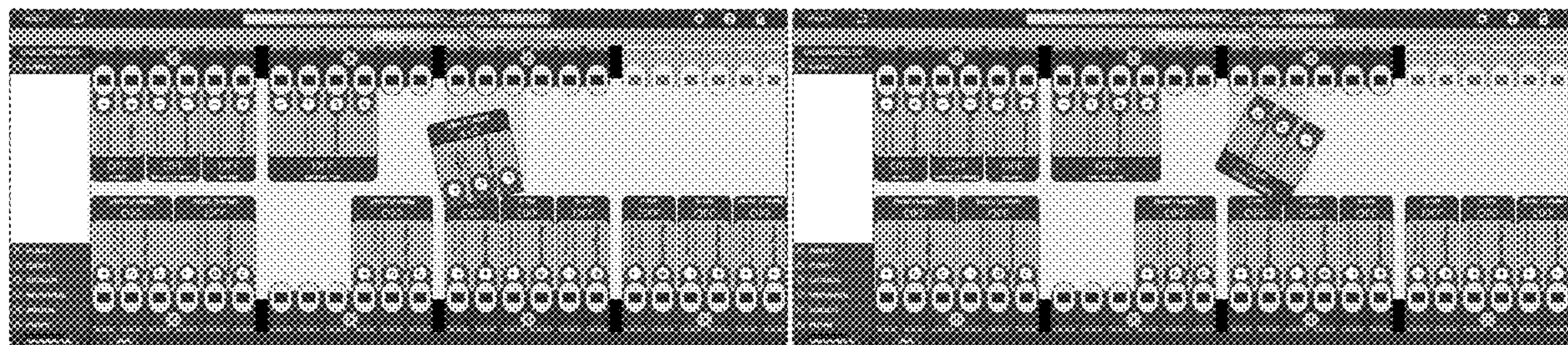
FIG. 13 is a thirteenth image thereof; and,

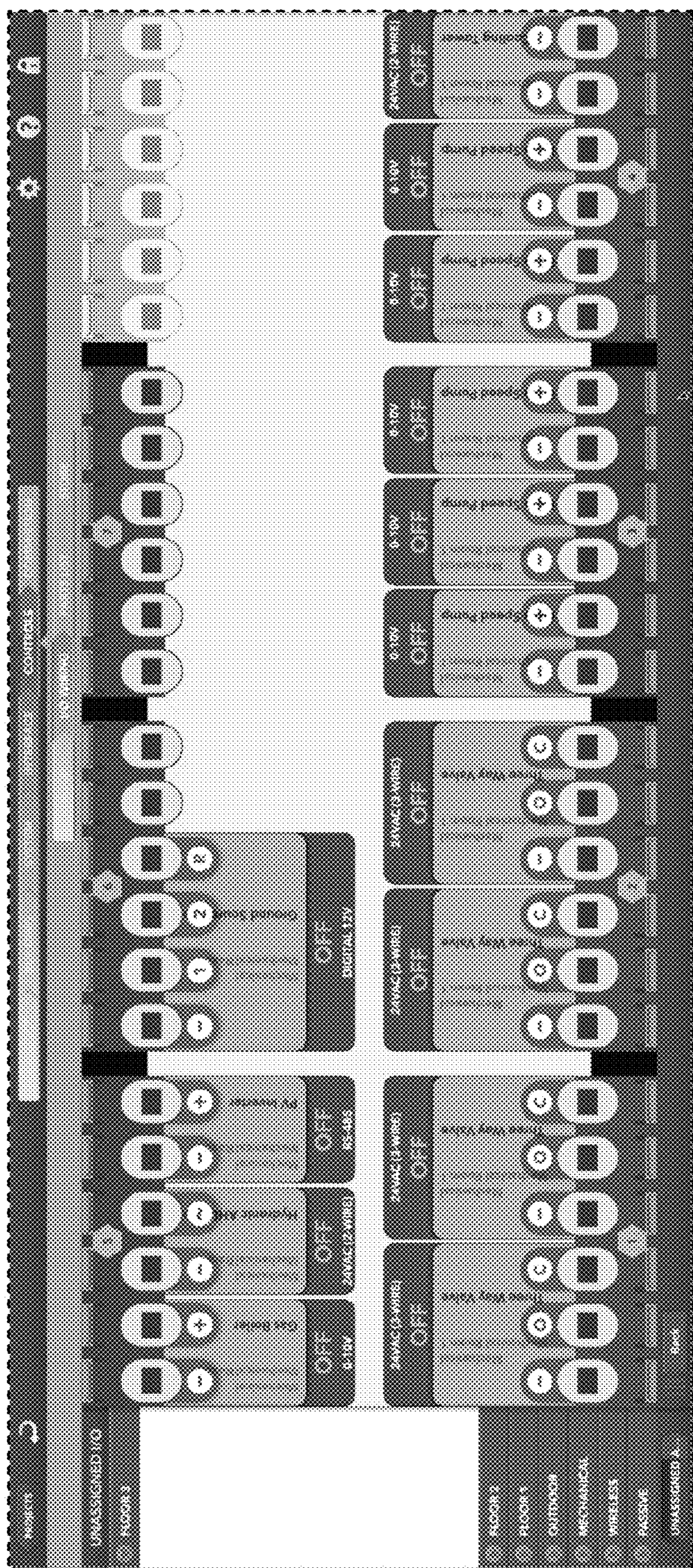

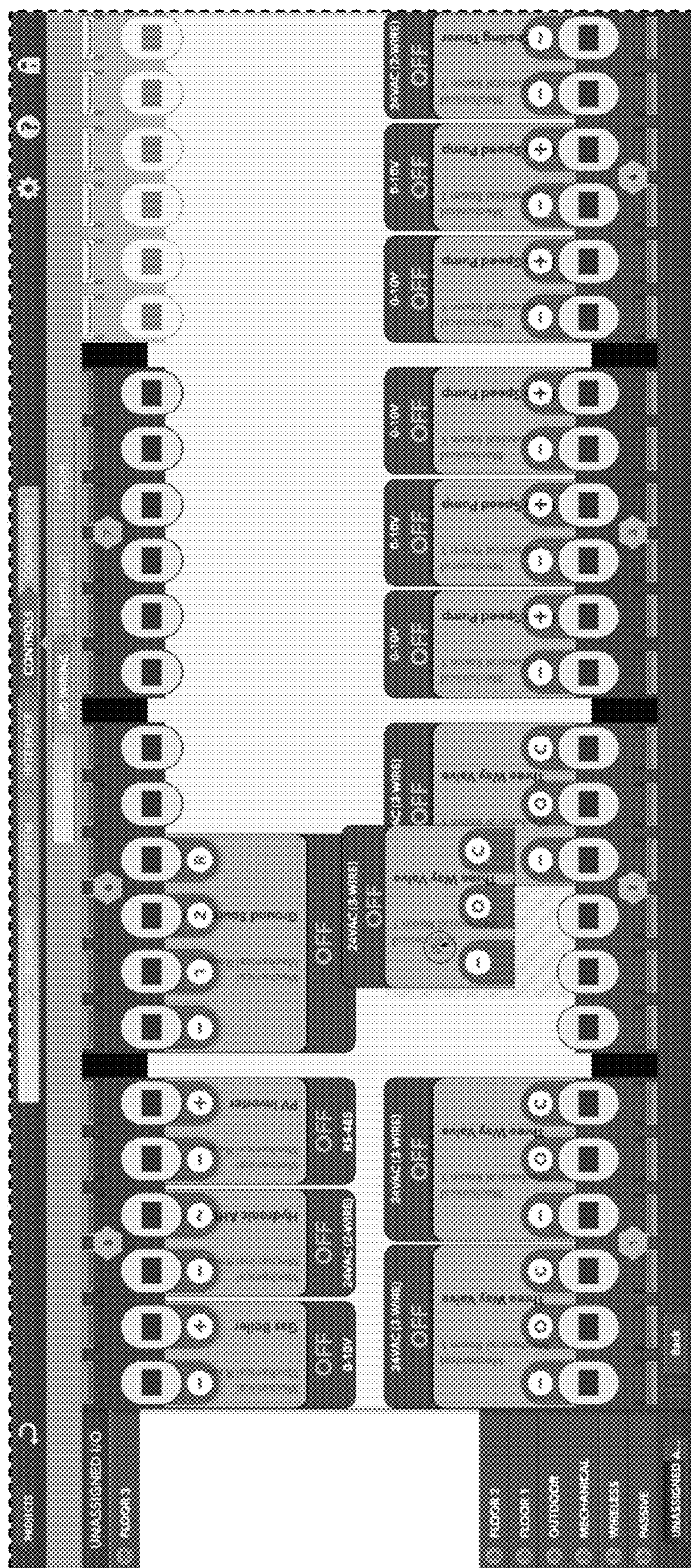

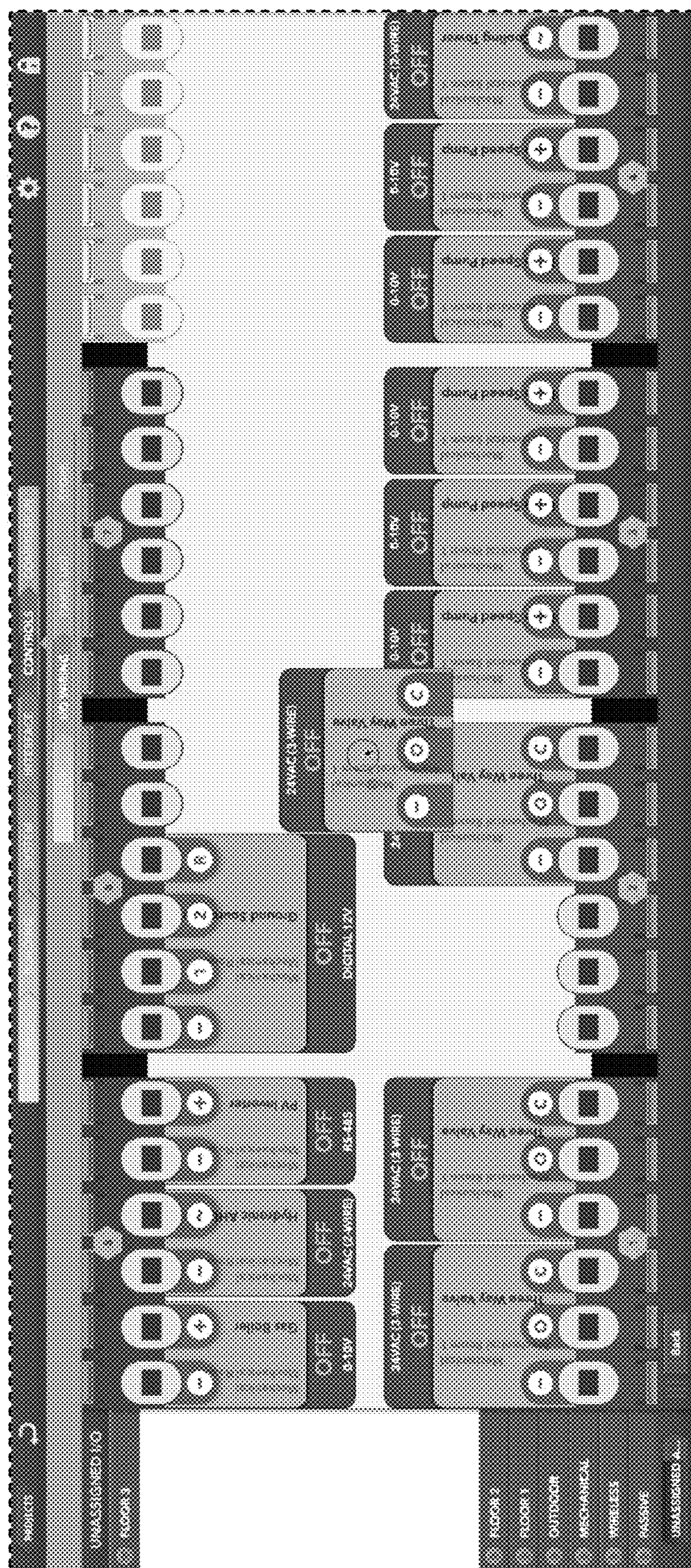

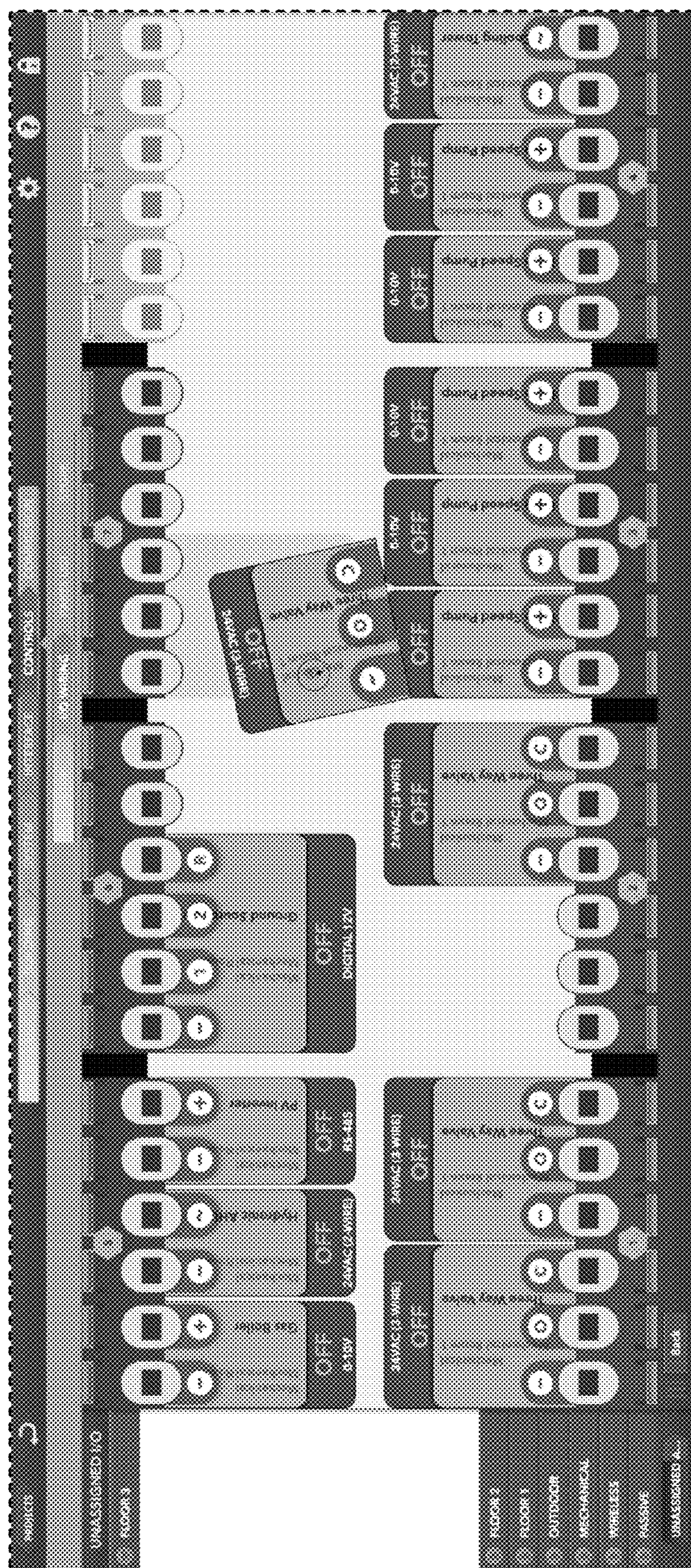

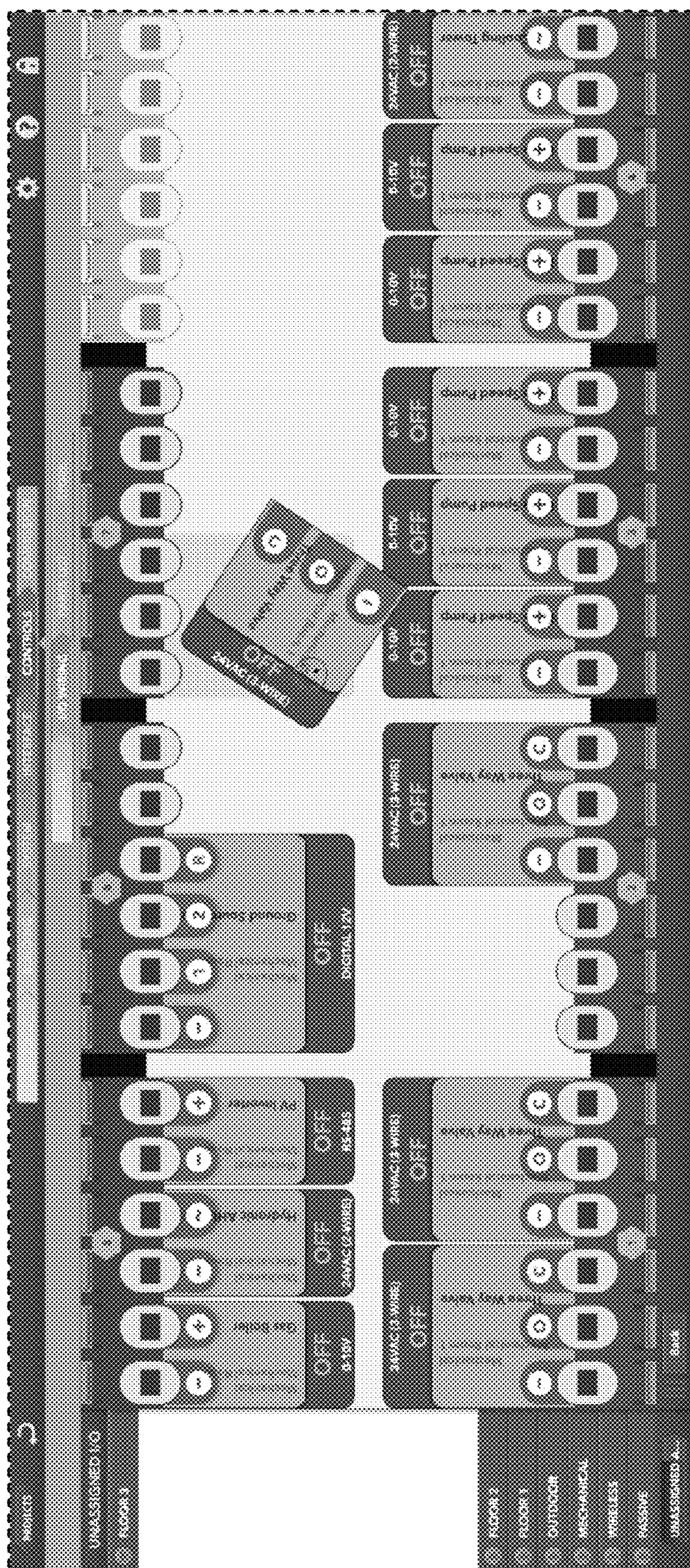

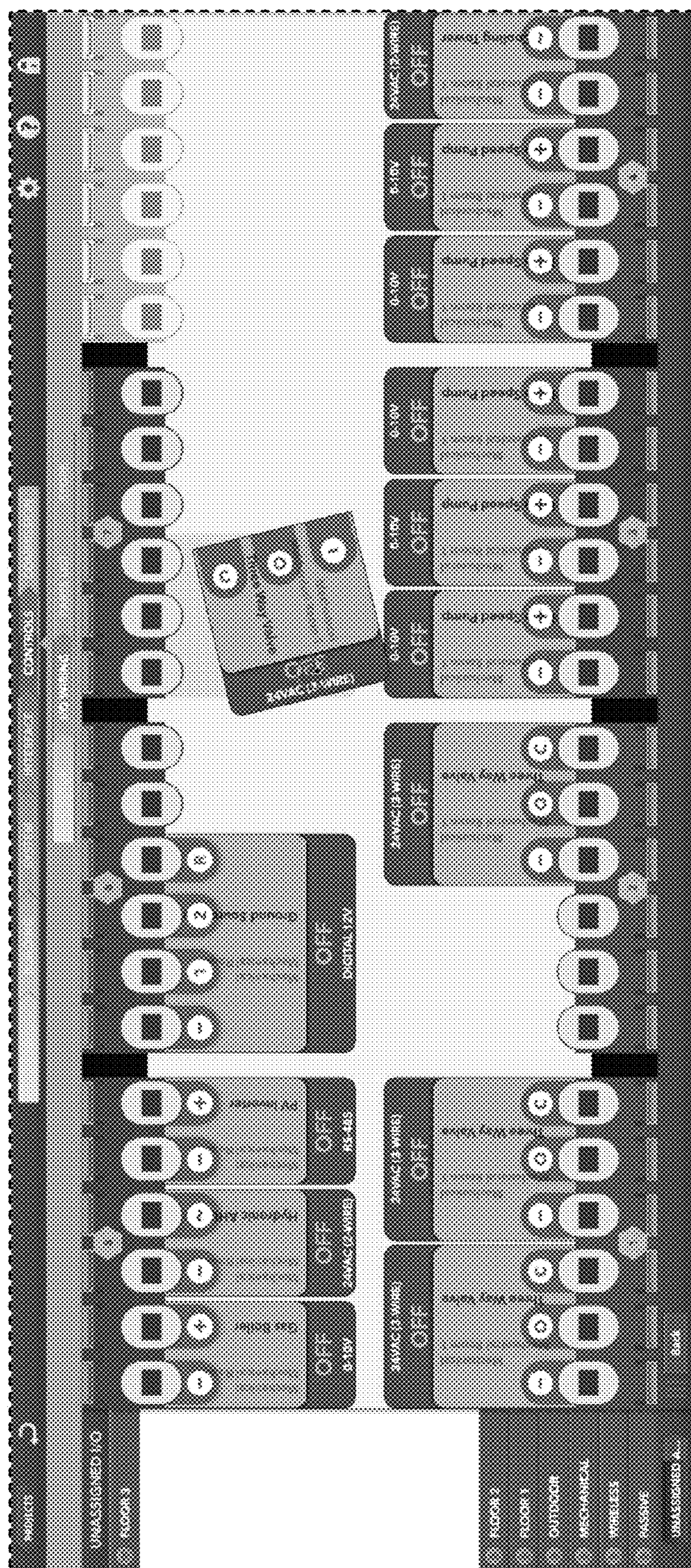

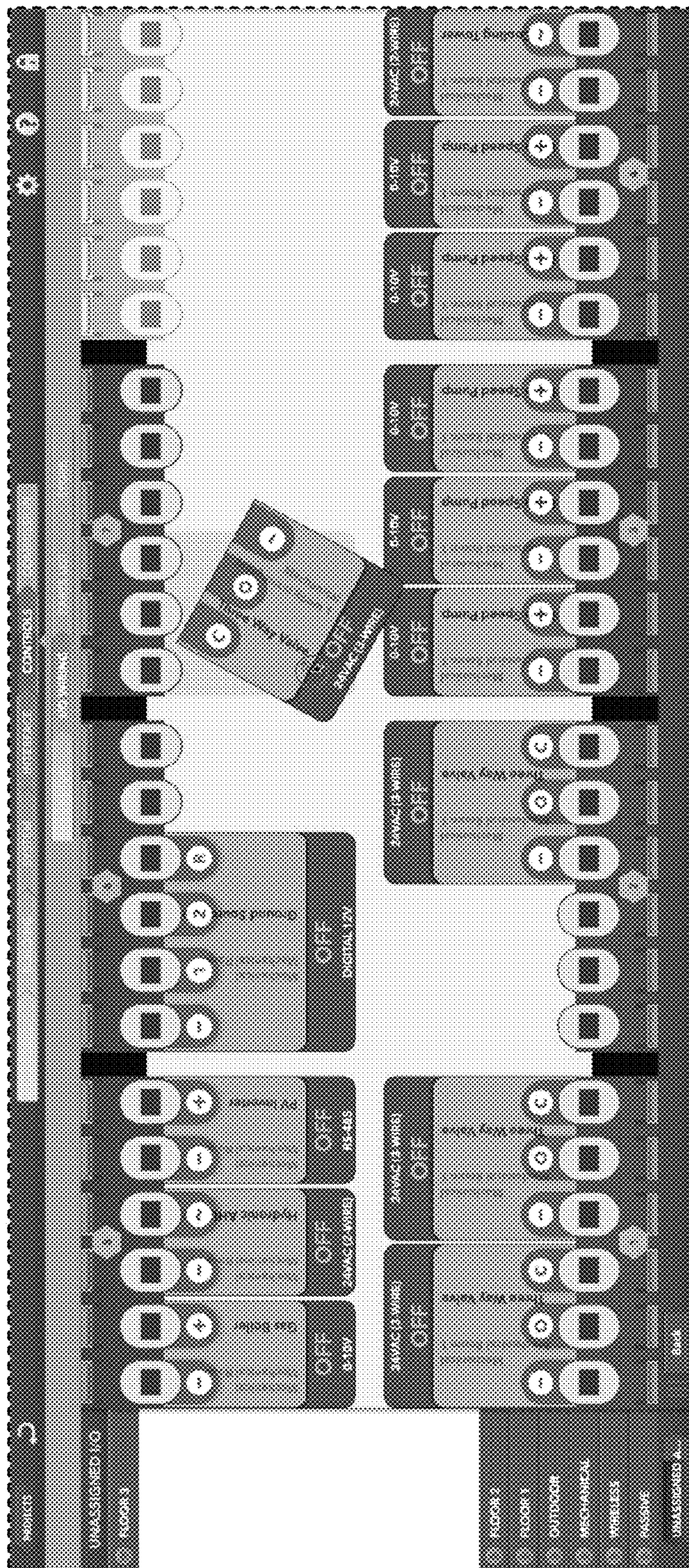

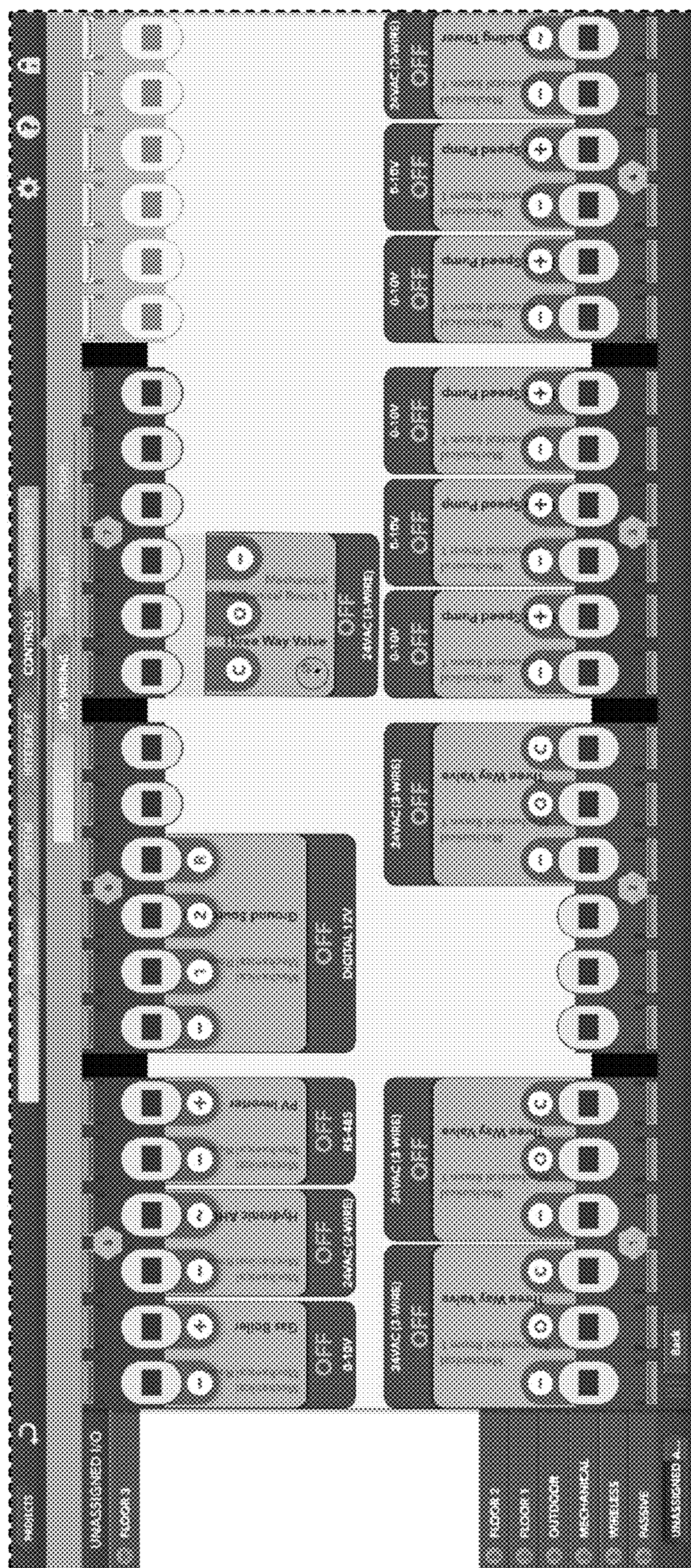

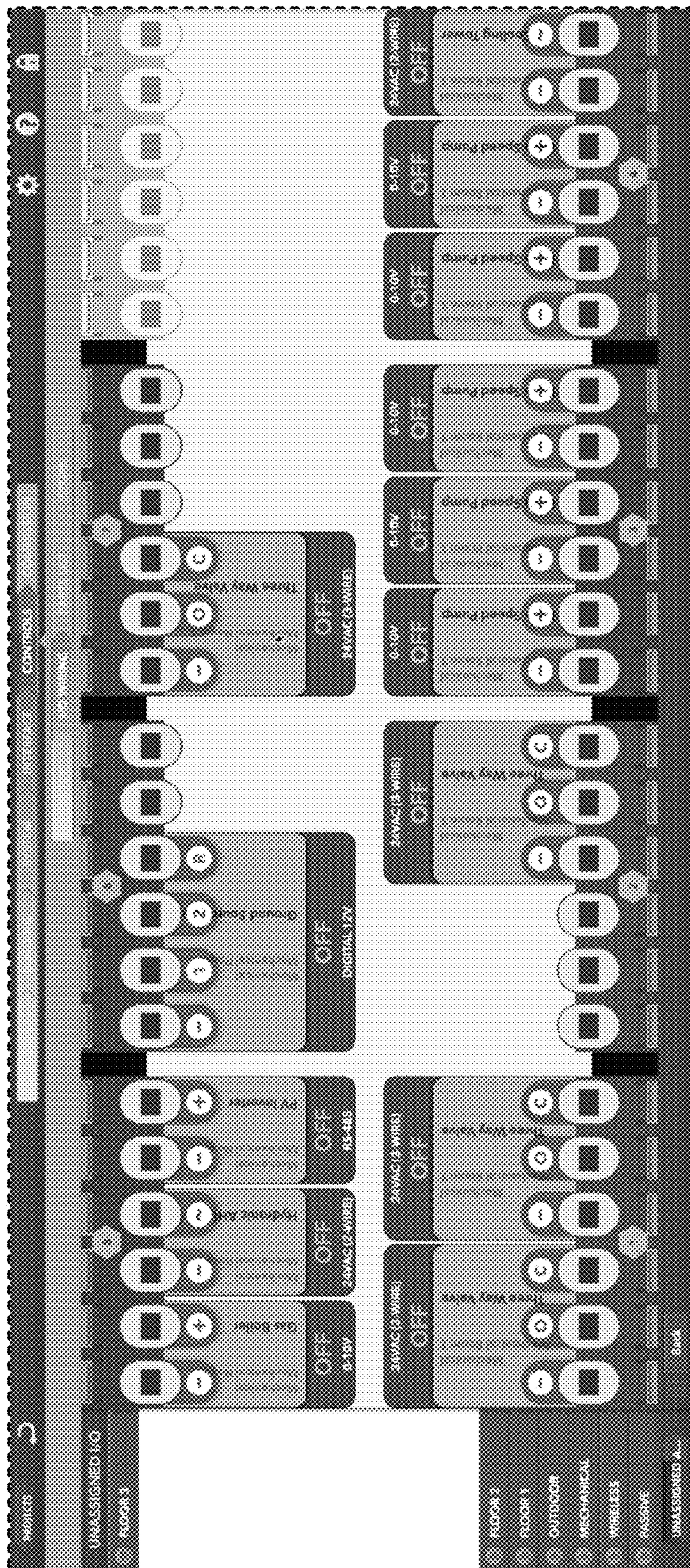

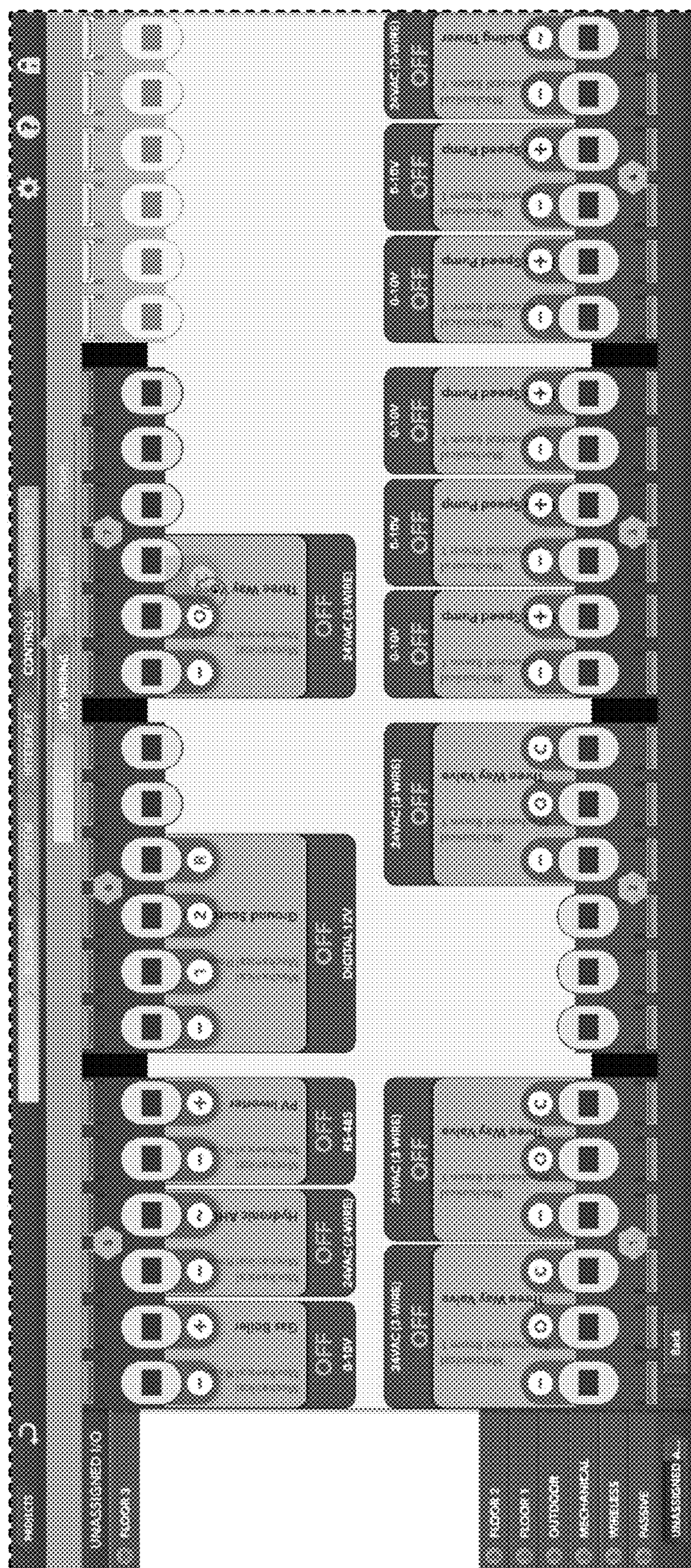

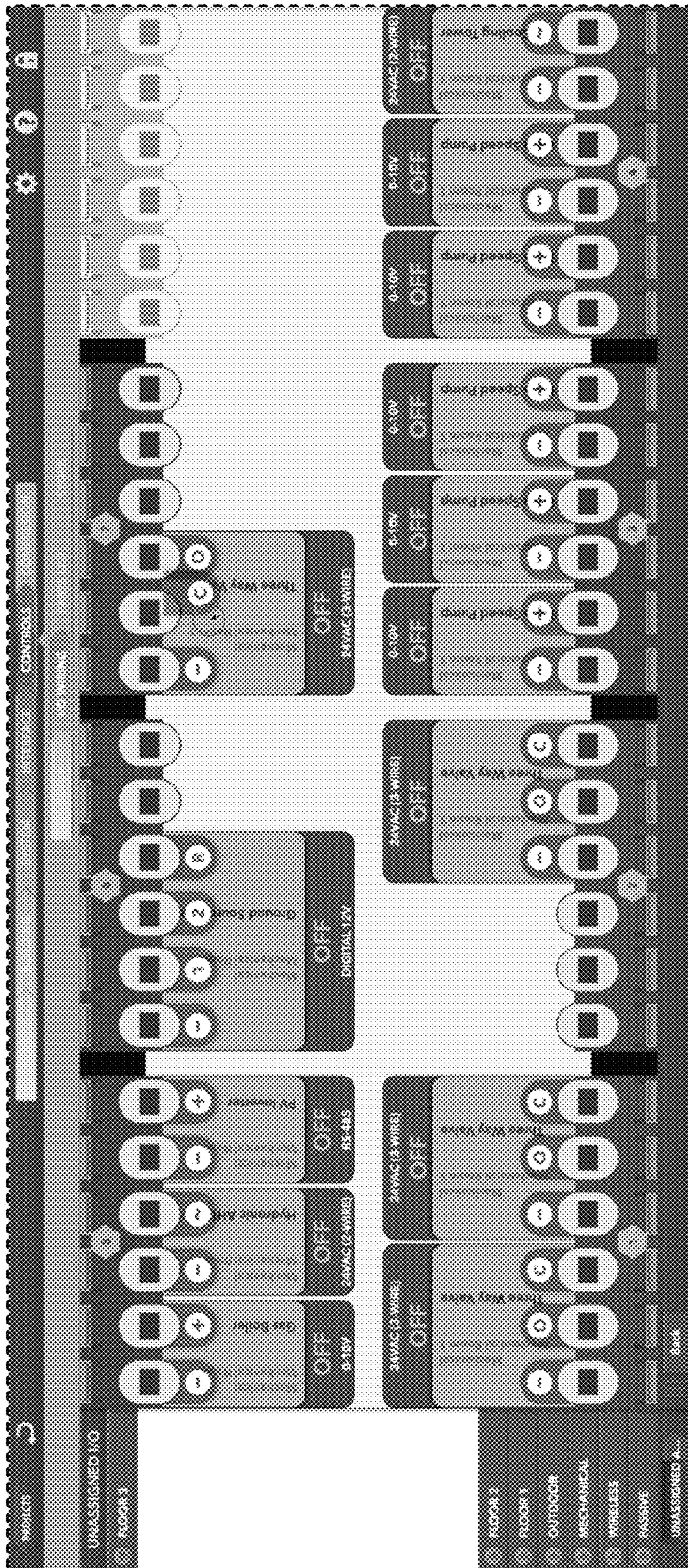

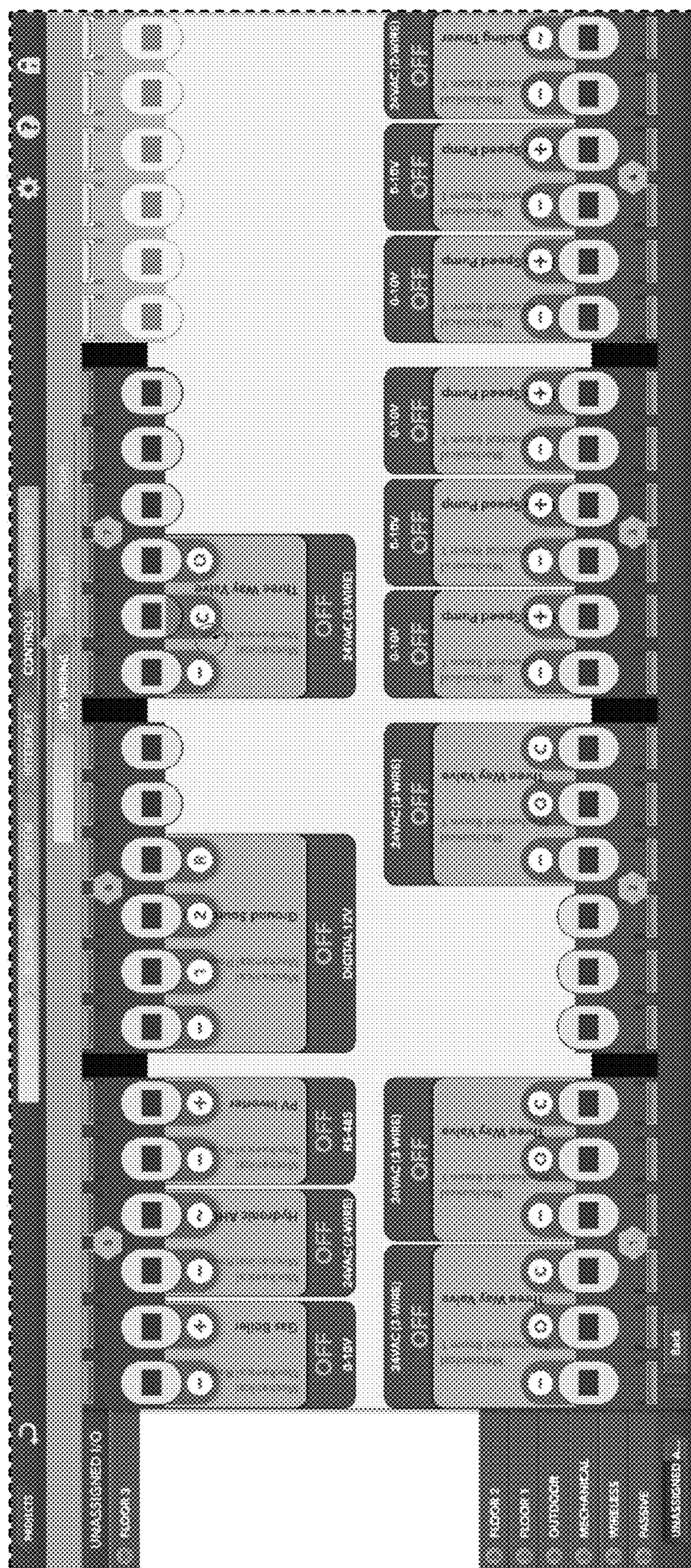

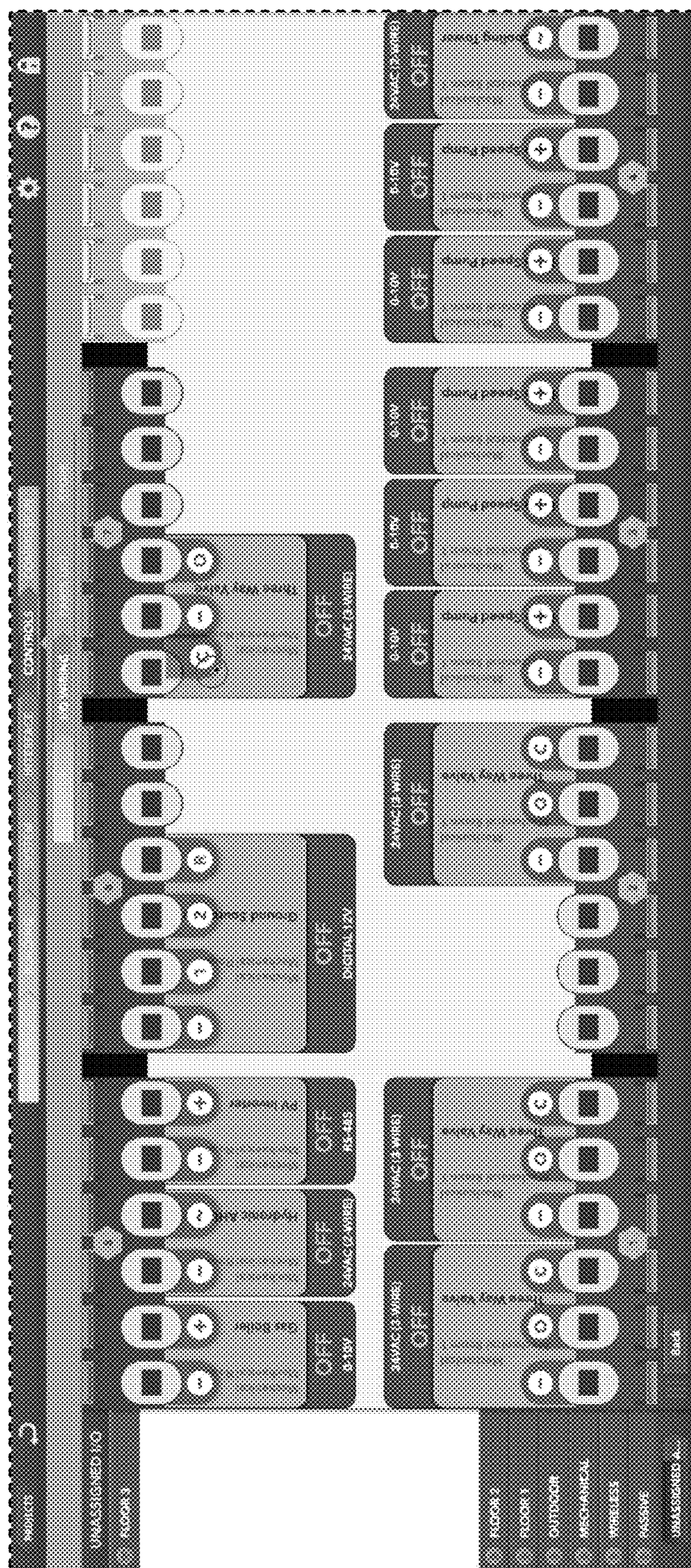

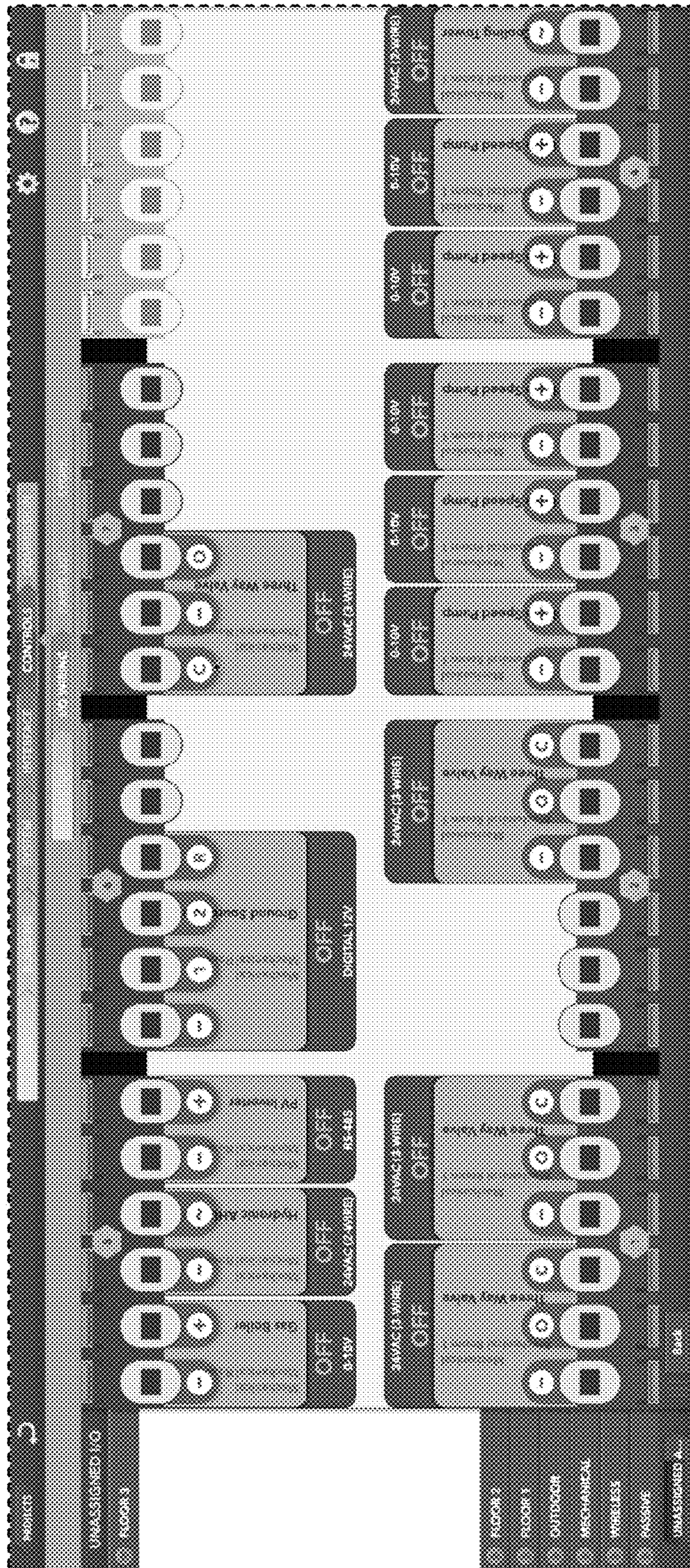
