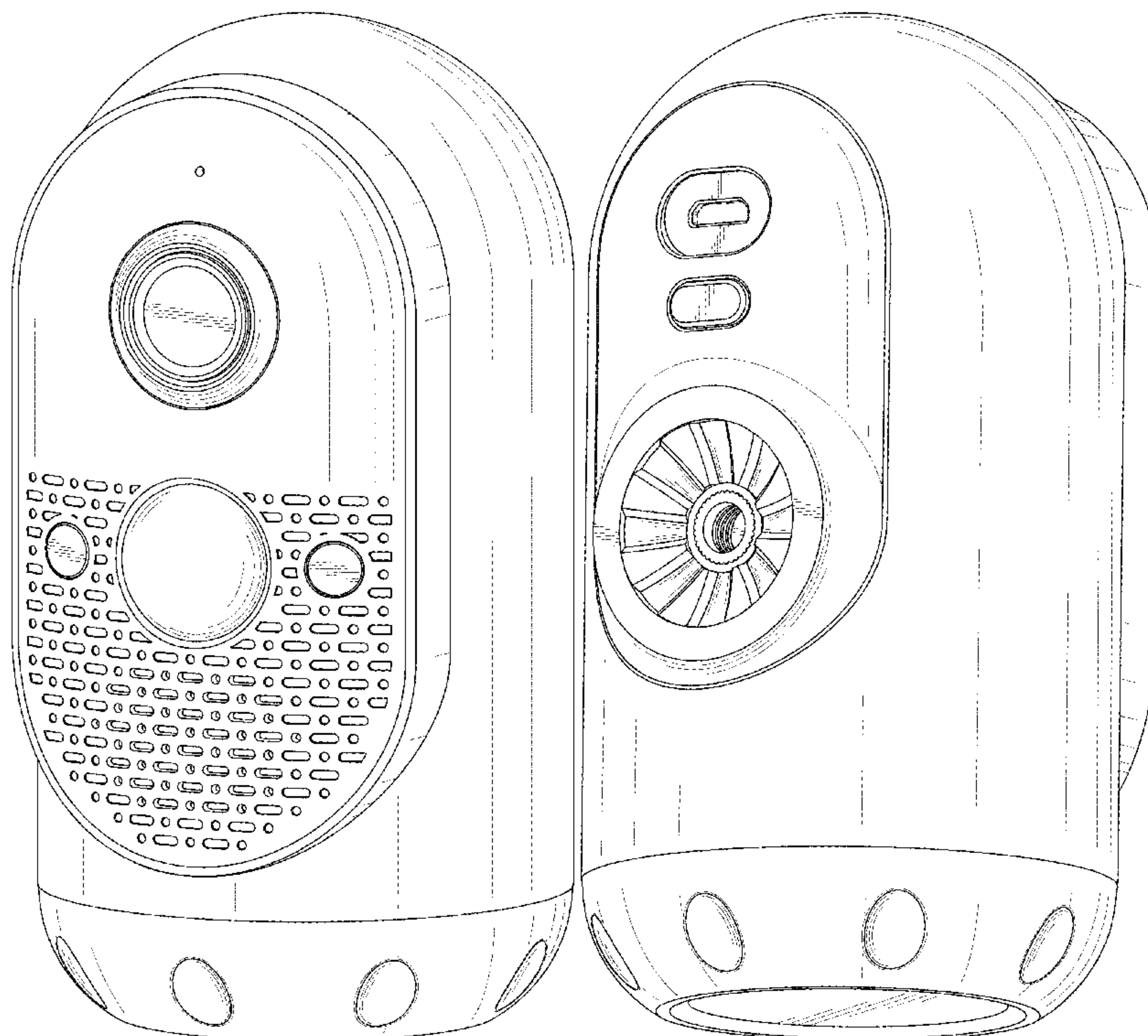
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top, front and right side perspective view of a battery camera showing my new design;
FIG. 2 is a bottom, rear and left side perspective view thereof;

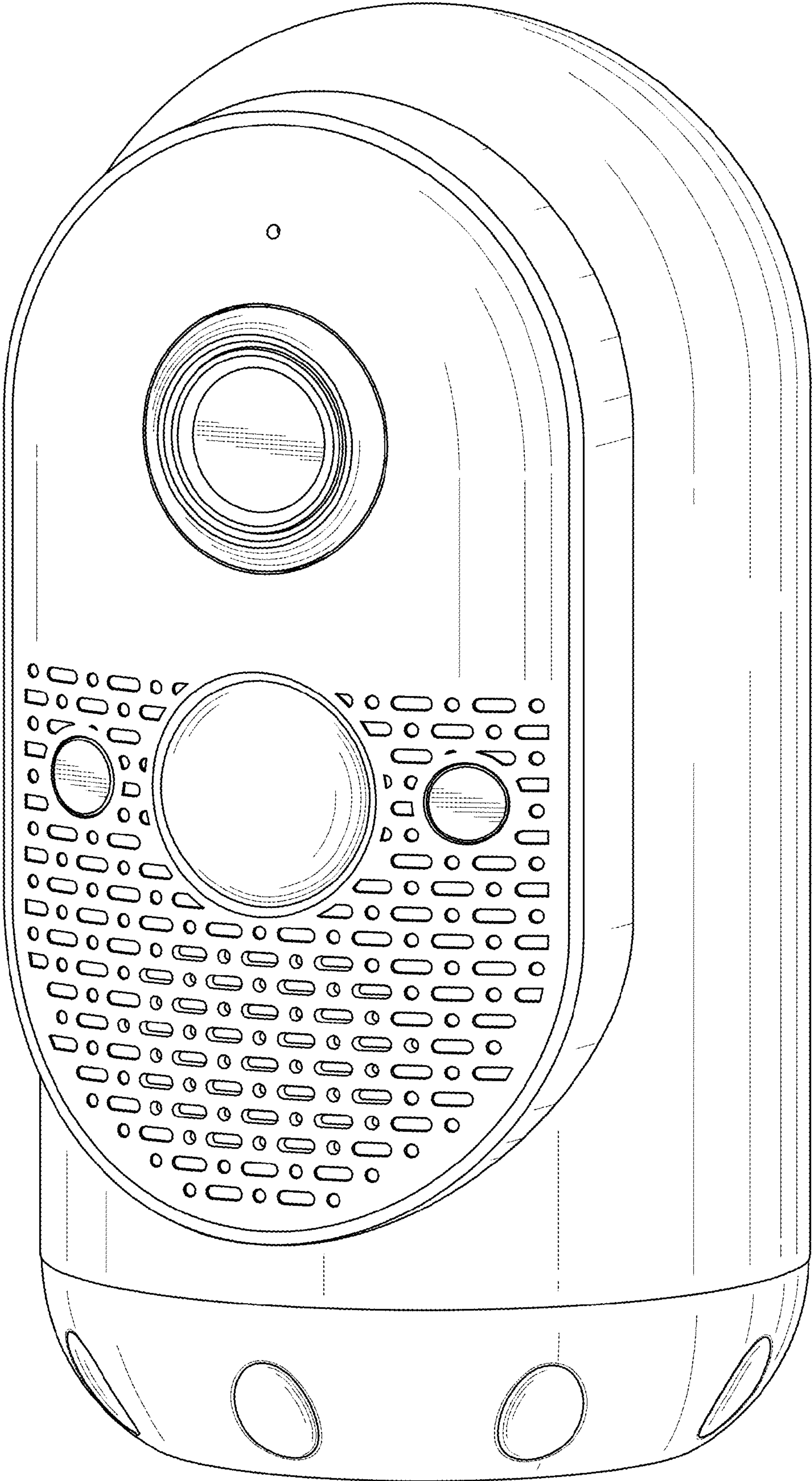

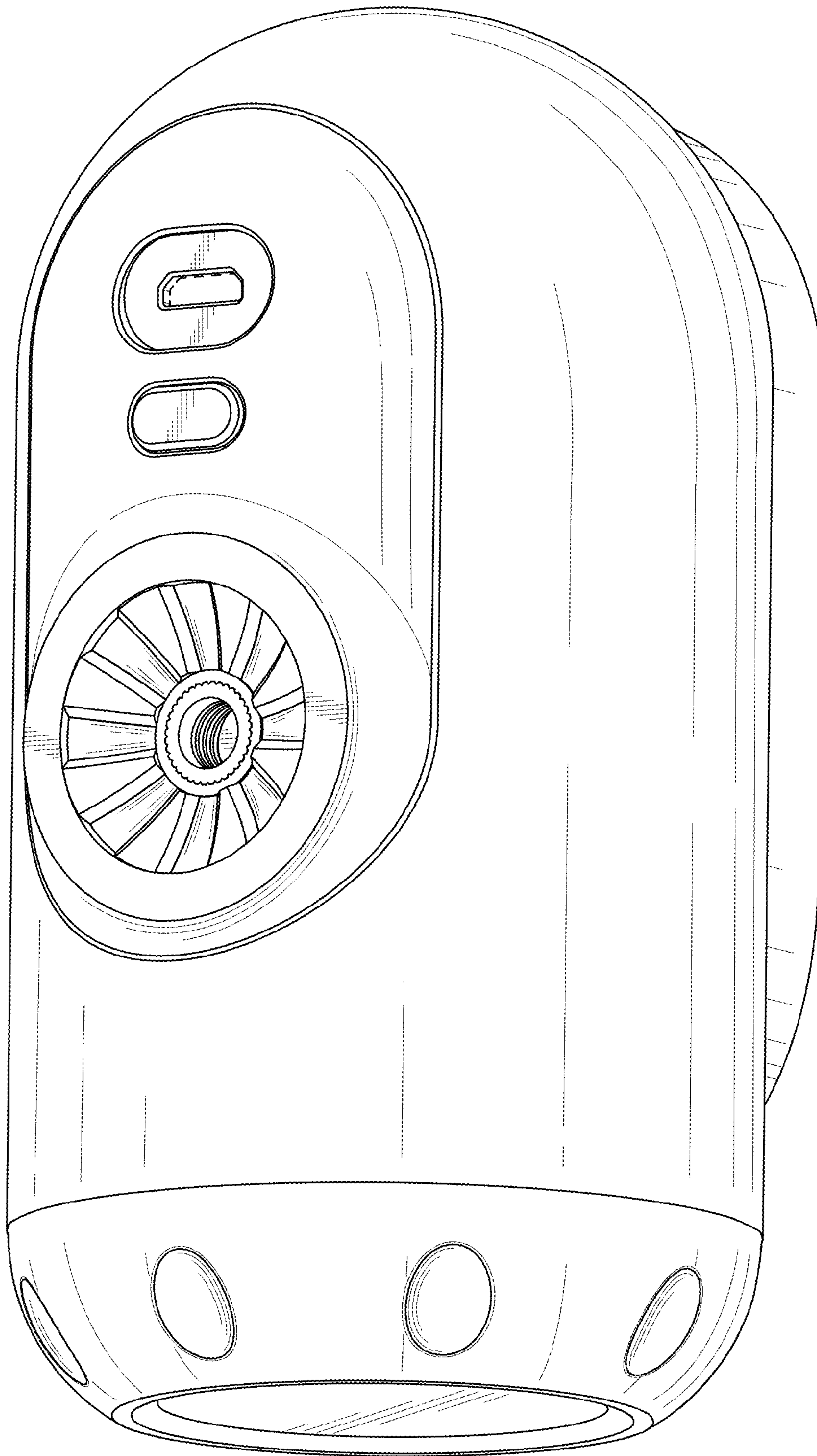

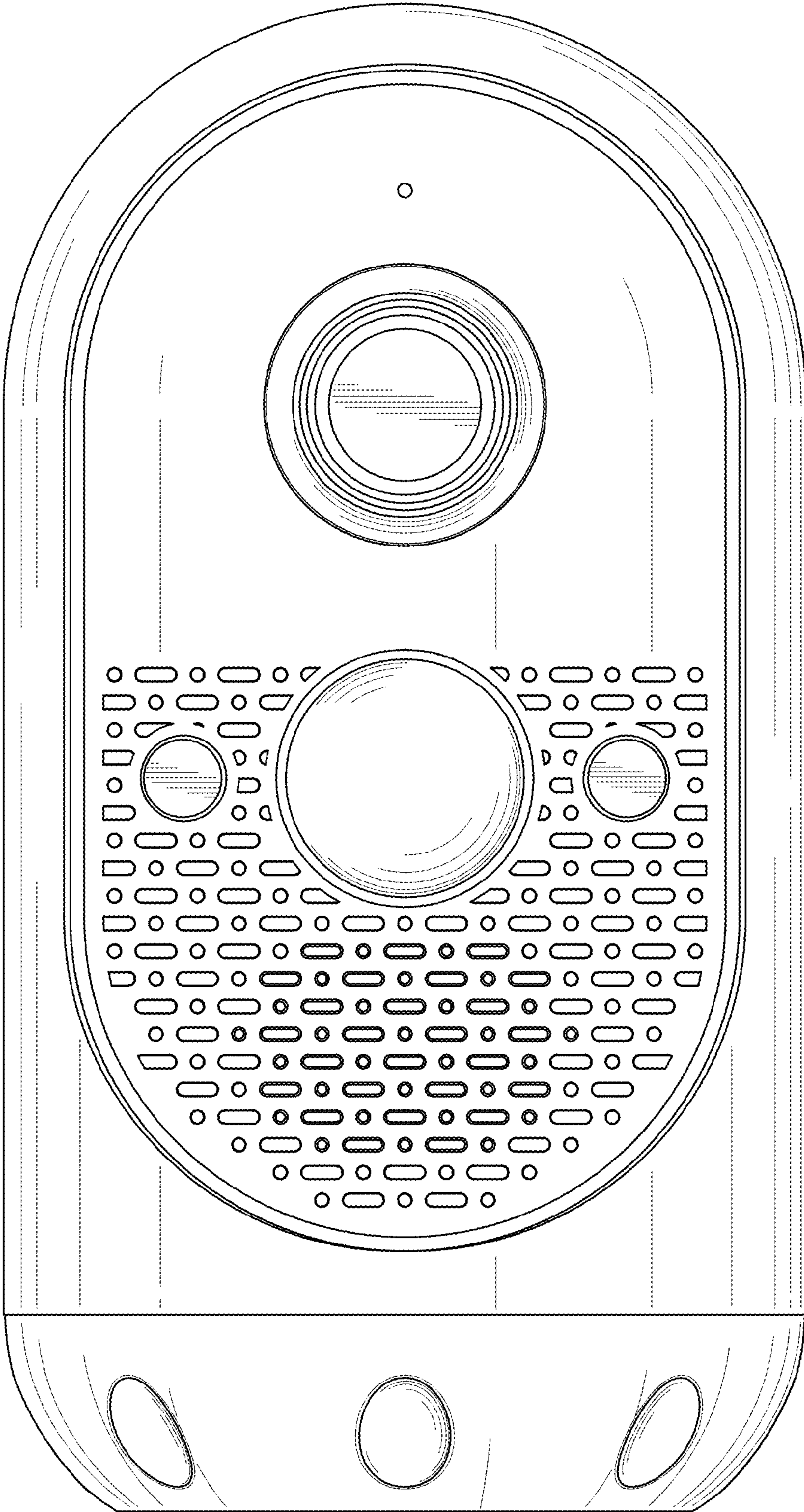

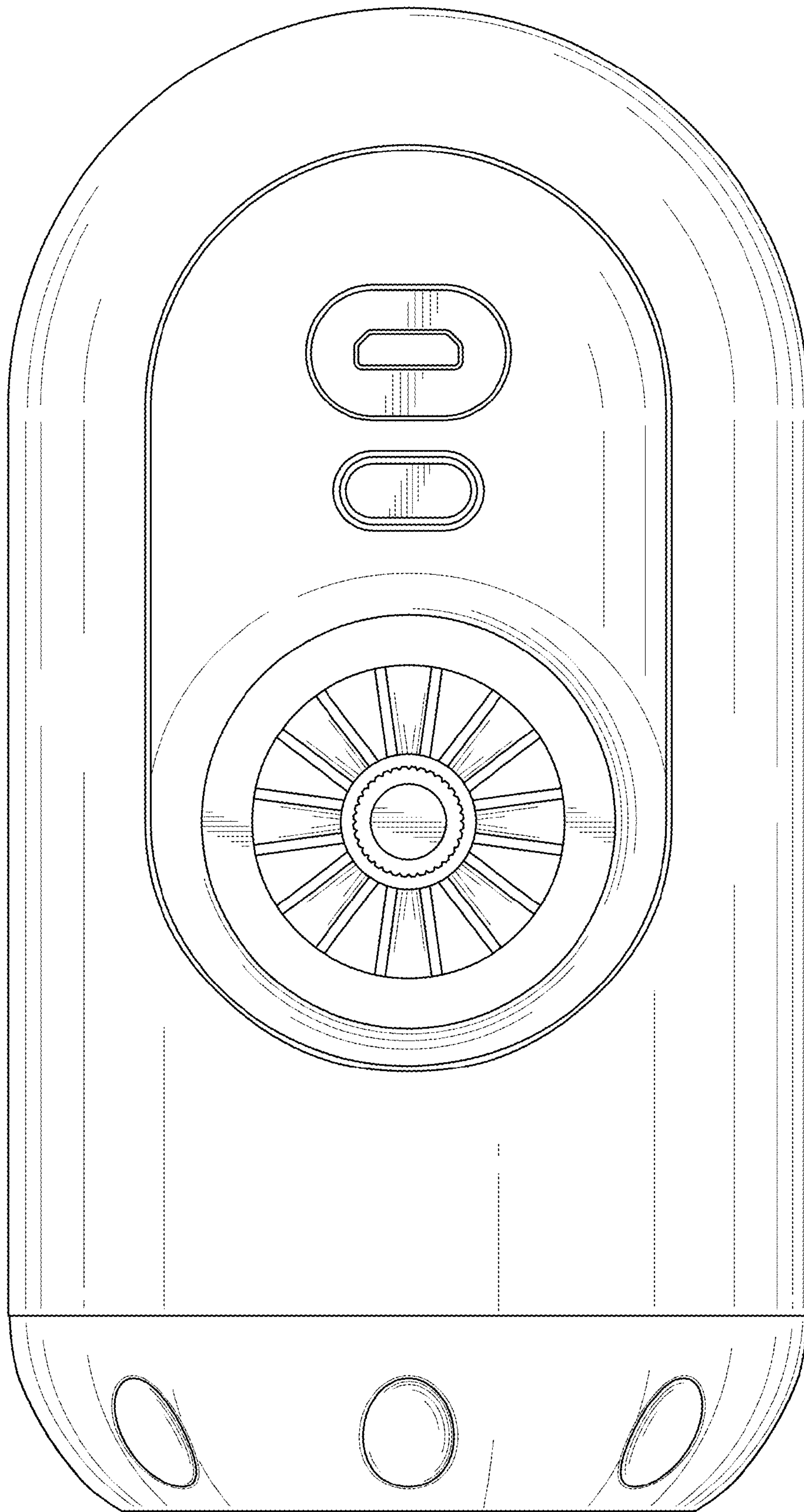

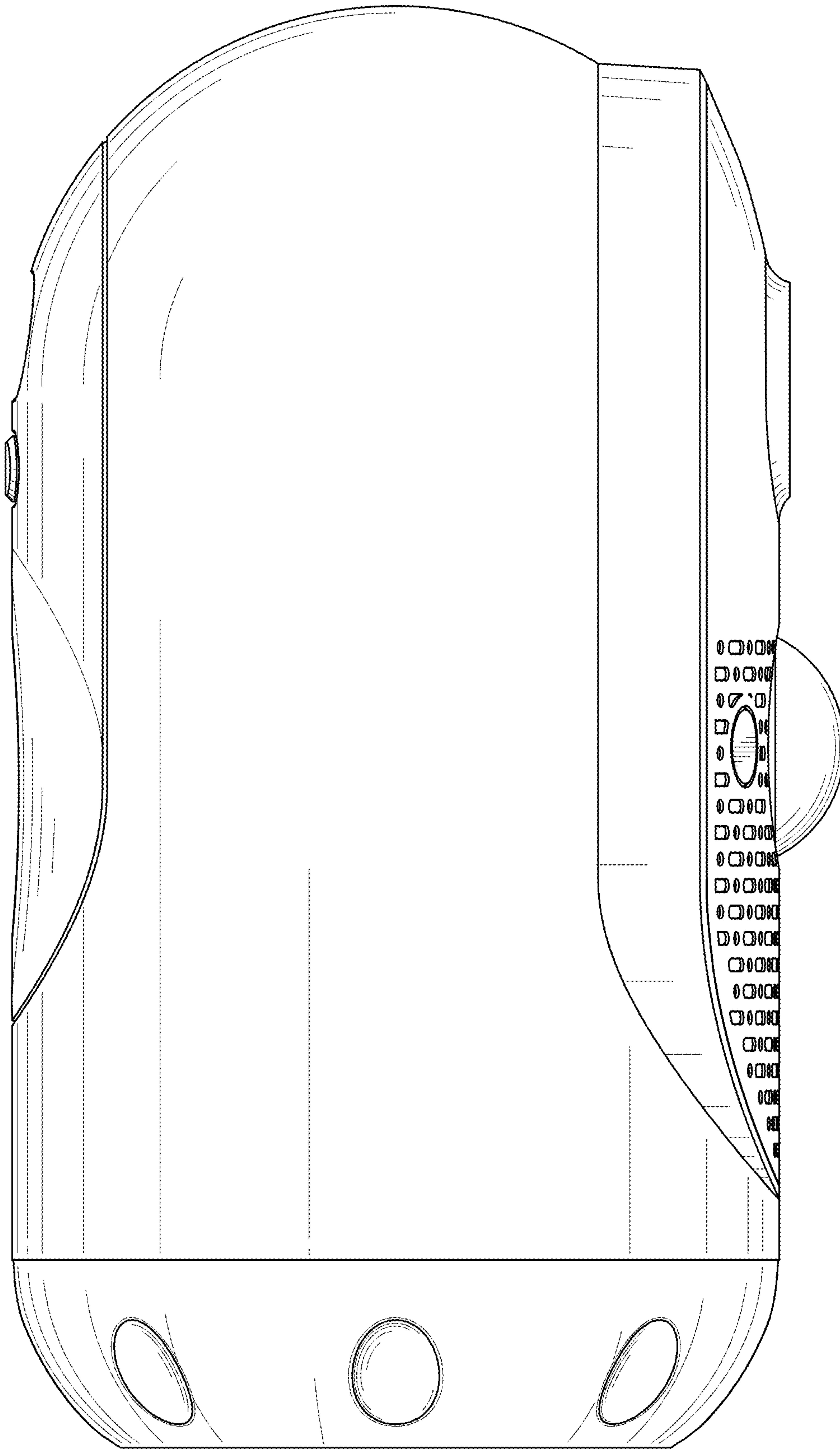

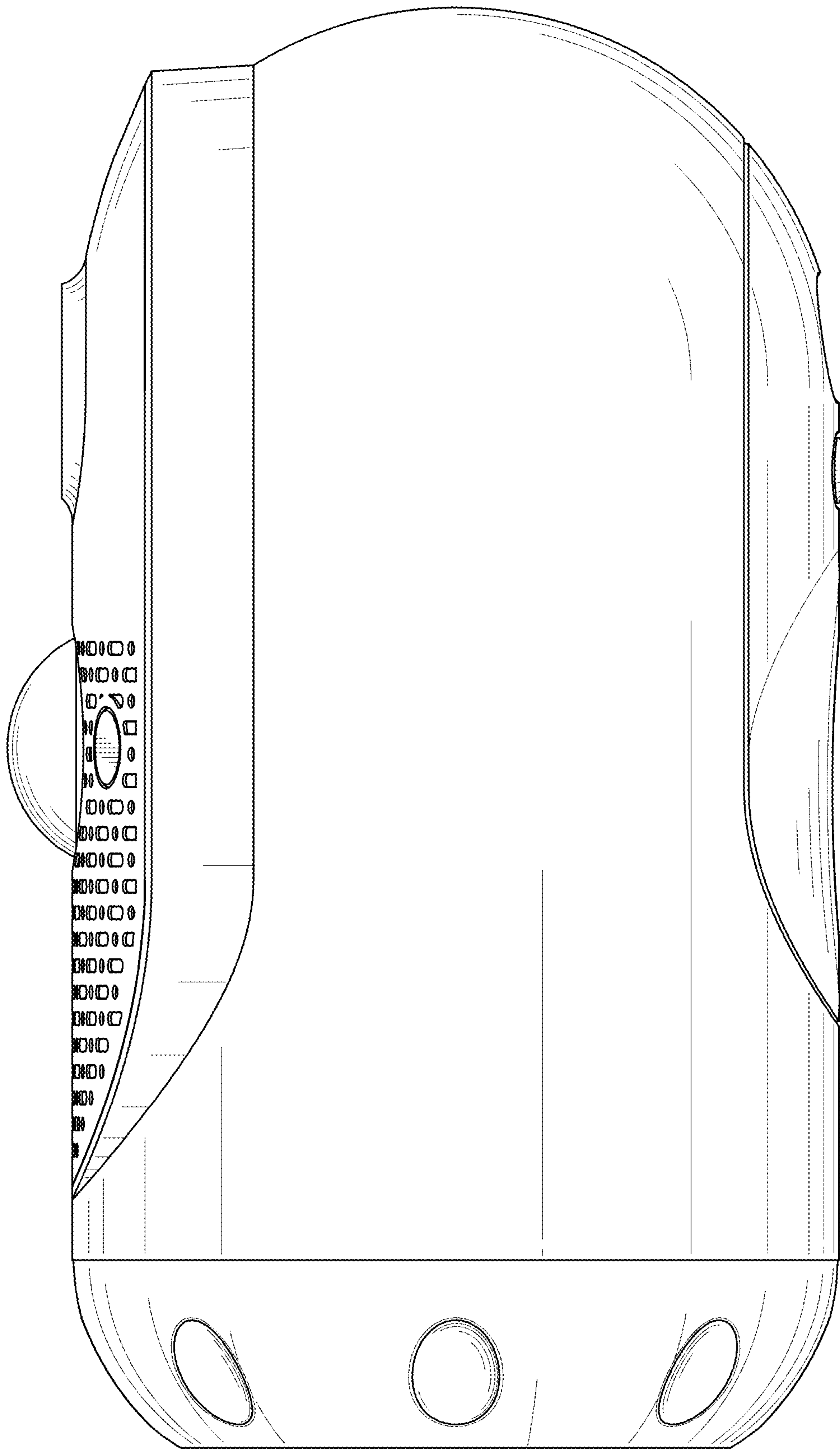

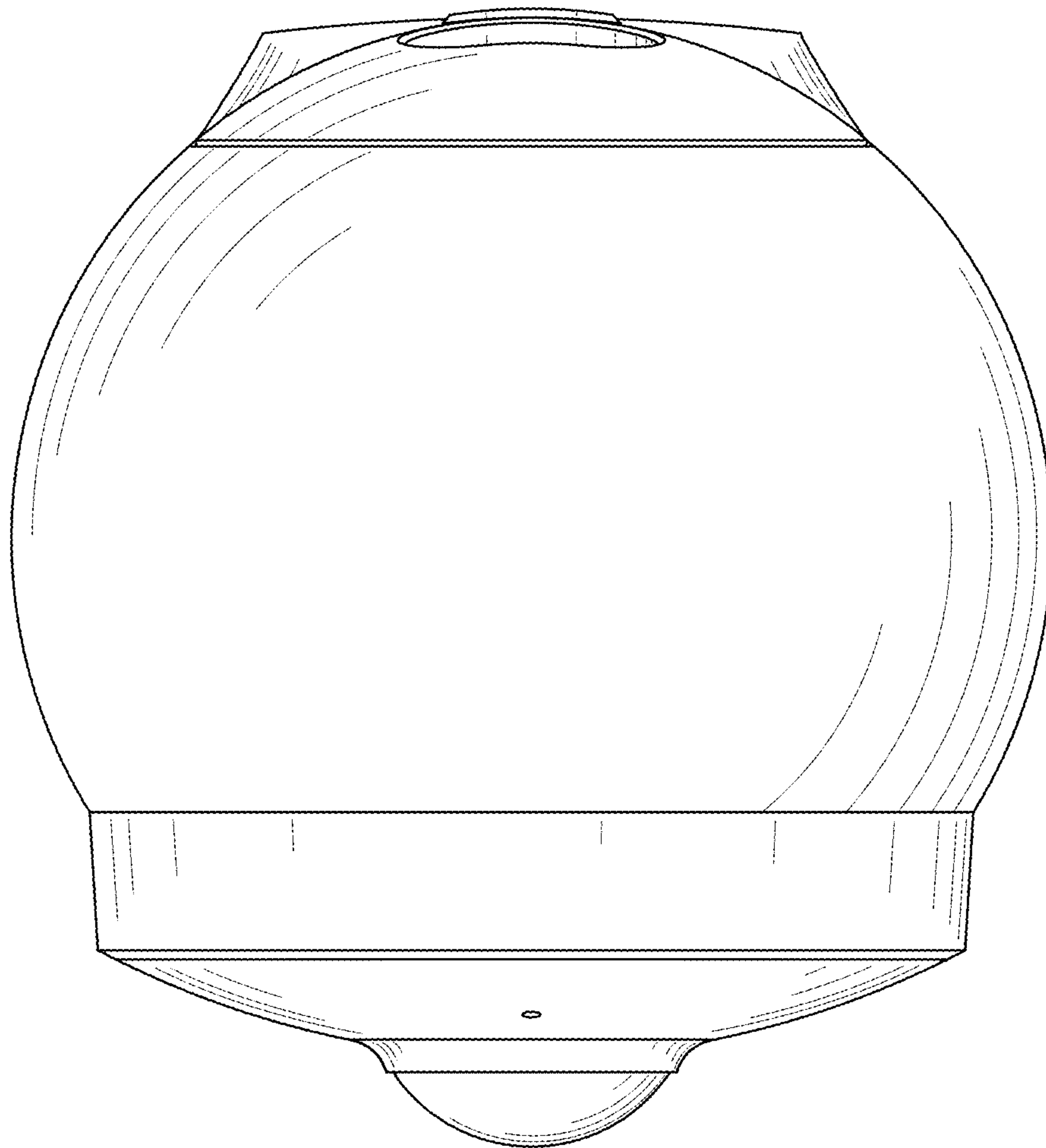

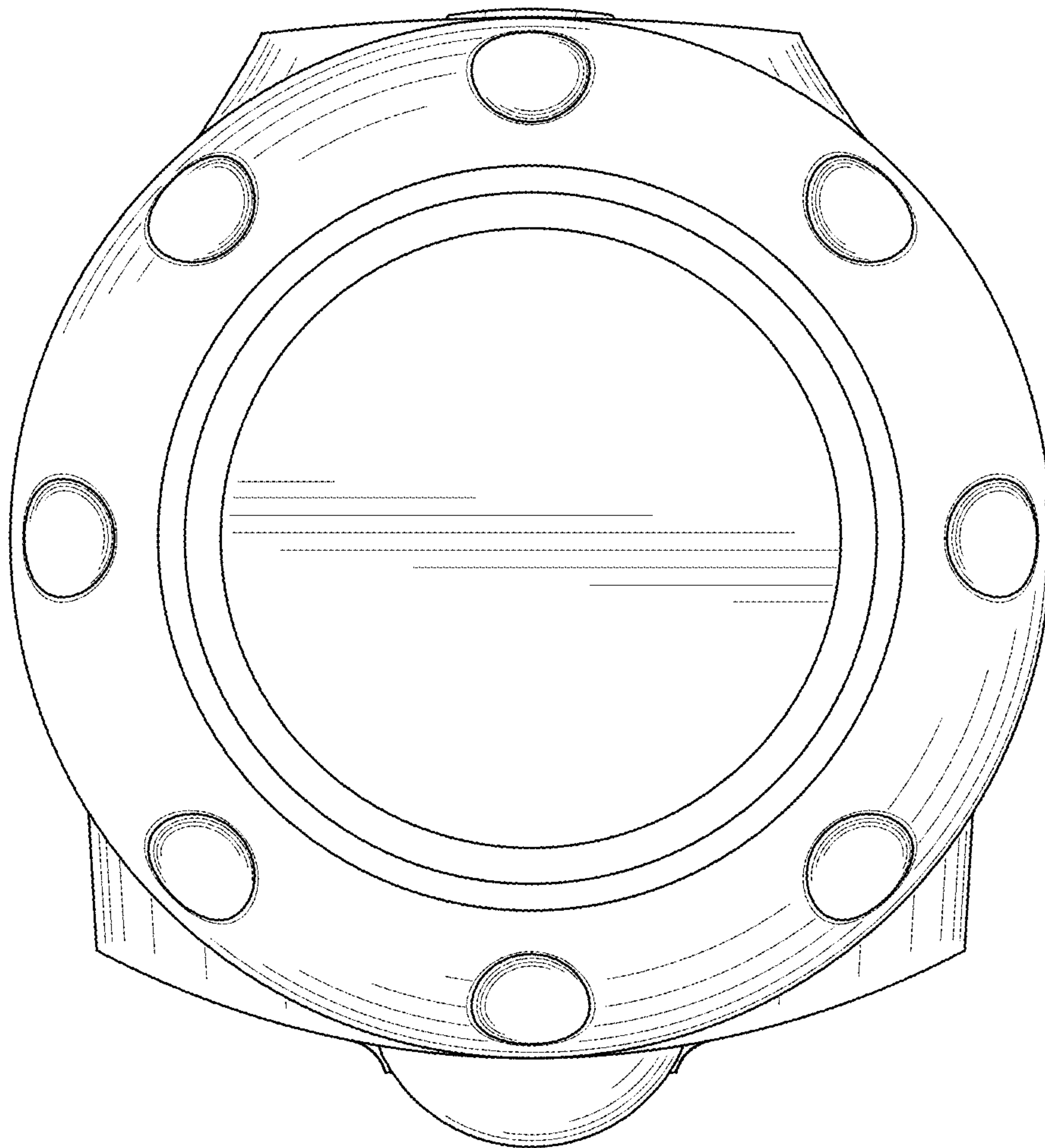
