1. Typeface

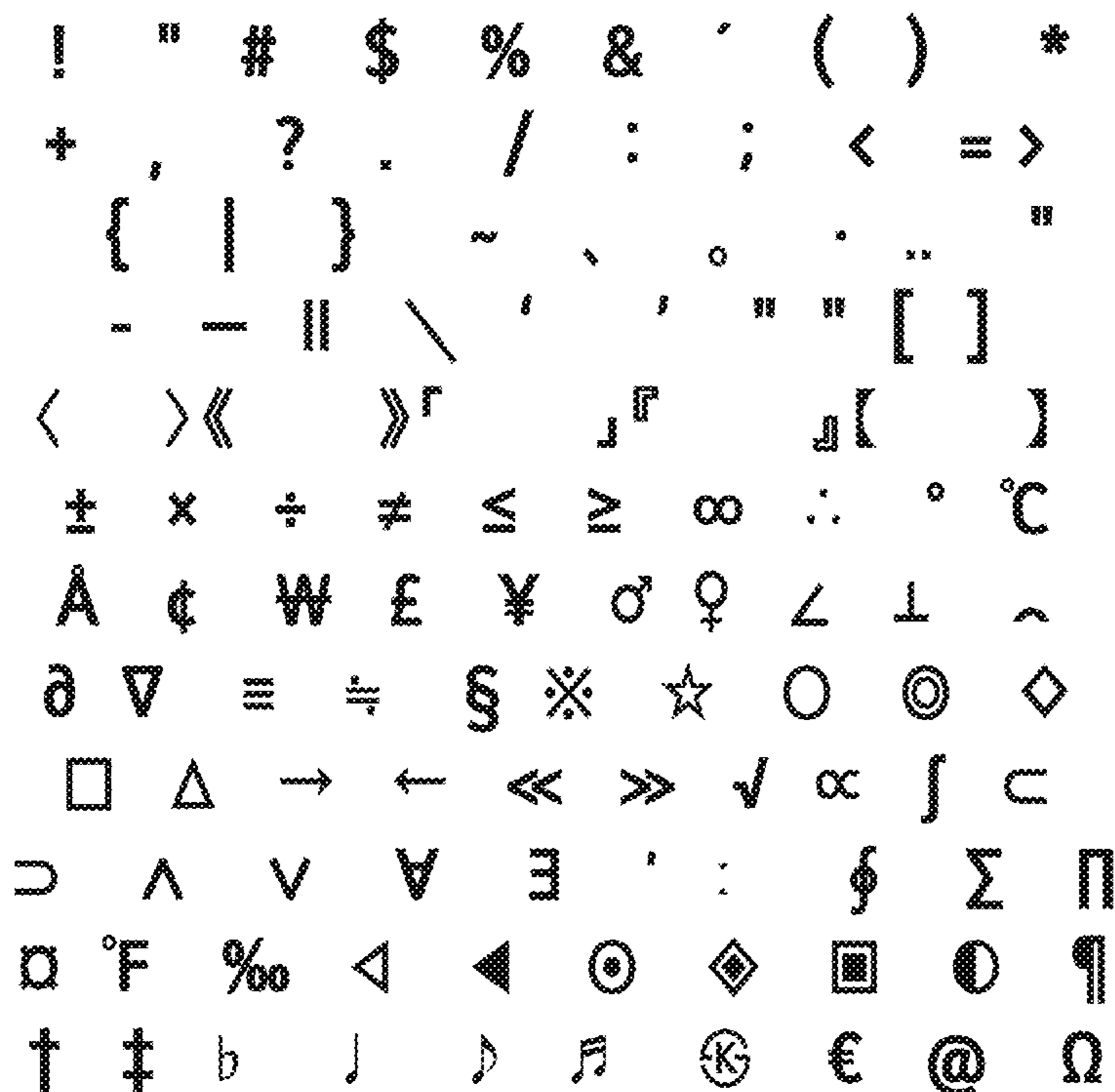
1.1 : Front

1.2 : Front view 2

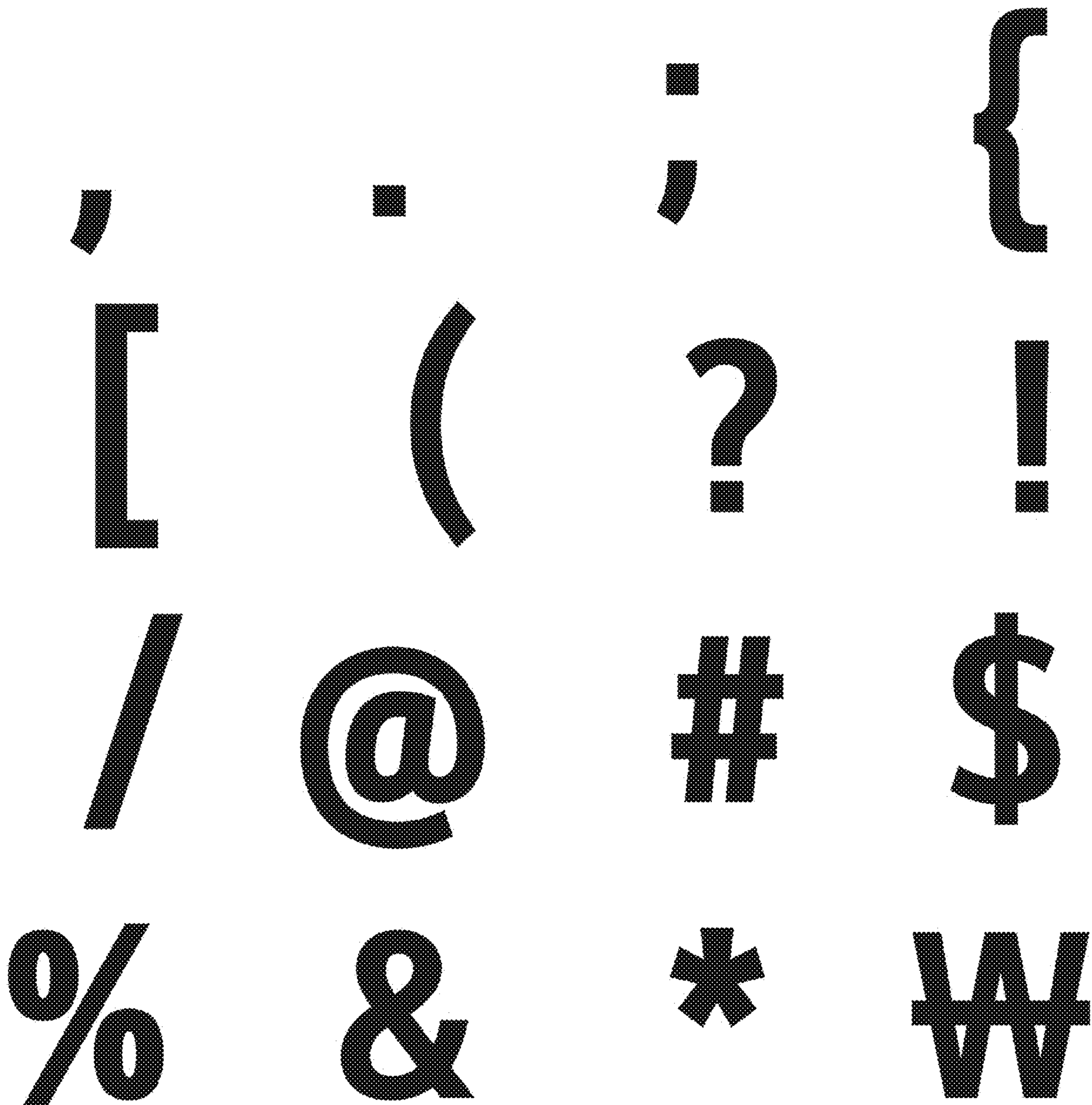
1.3 : Front view 3
