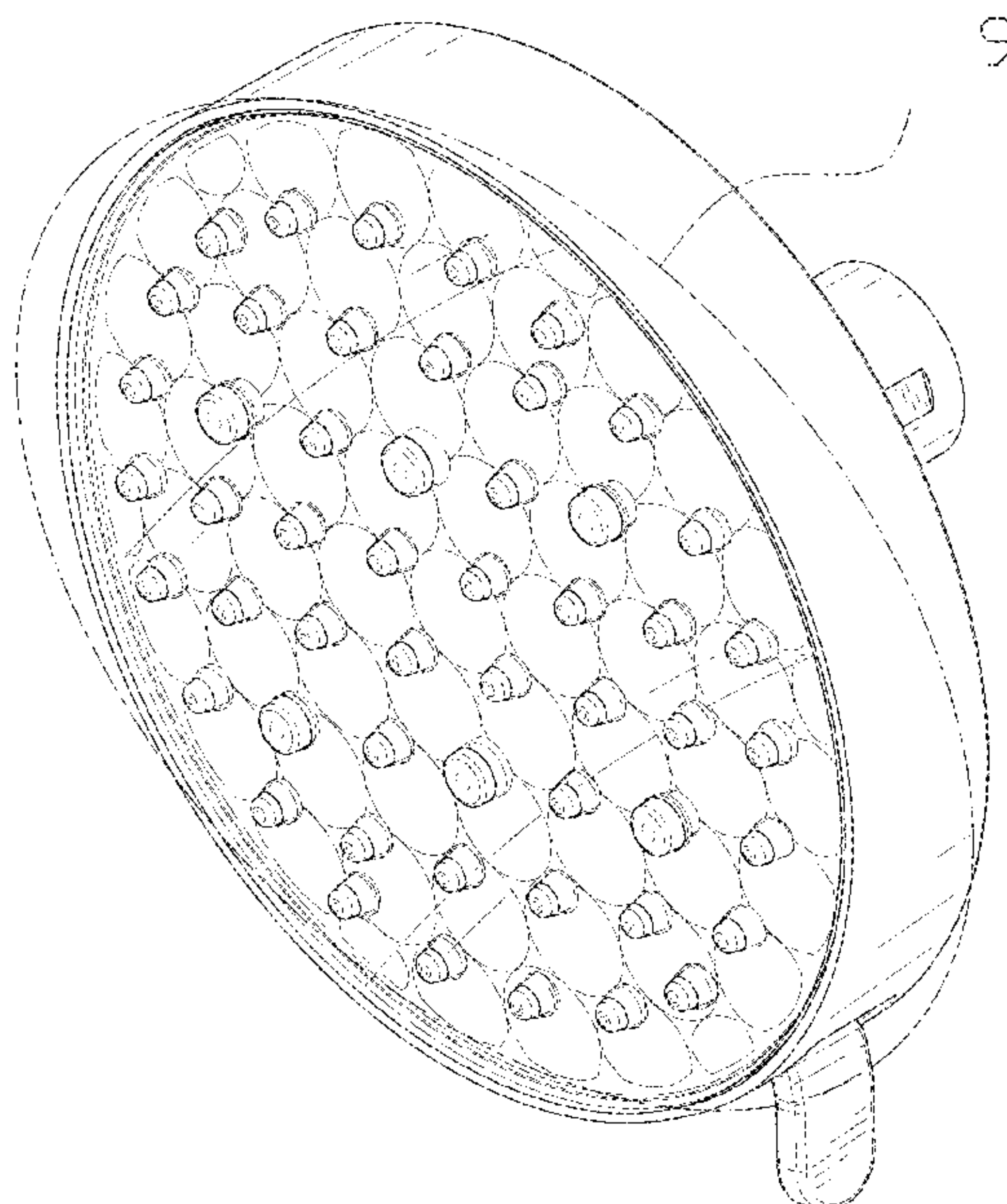
(57) **CLAIM**

We claim the ornamental design for a shower head, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view for a shower head;
FIG. 2 is a rear perspective view thereof;
FIG. 3 is a front view thereof;
FIG. 4 is a back view thereof;
FIG. 5 is a right side view thereof;
FIG. 6 is a left side view thereof;
FIG. 7 is a top view thereof;
FIG. 8 is a bottom view thereof; and,
FIG. 9 is a partially enlarged view of enlargement section 9 in FIG. 1 to emphasize the shower head spray nozzles.

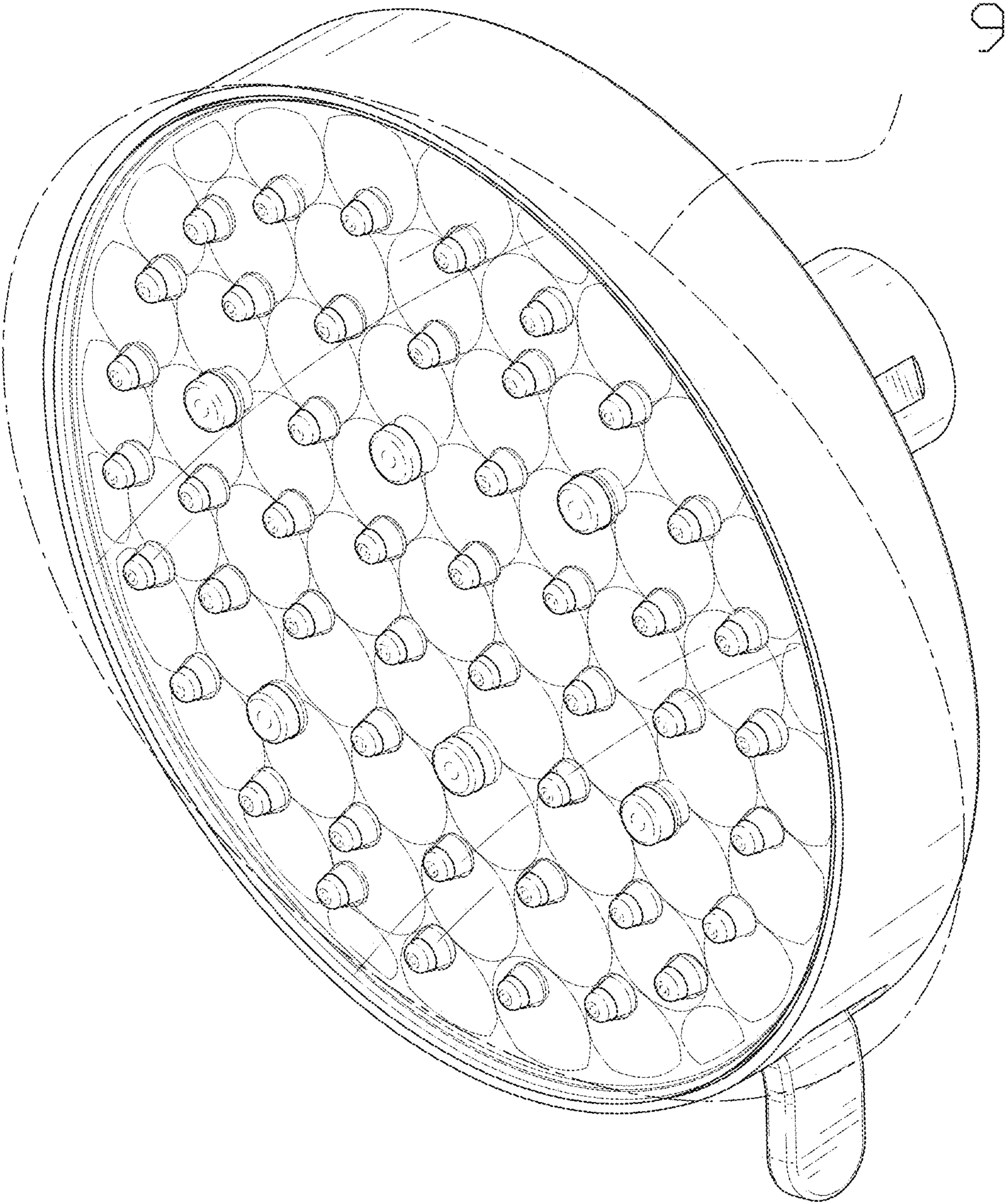

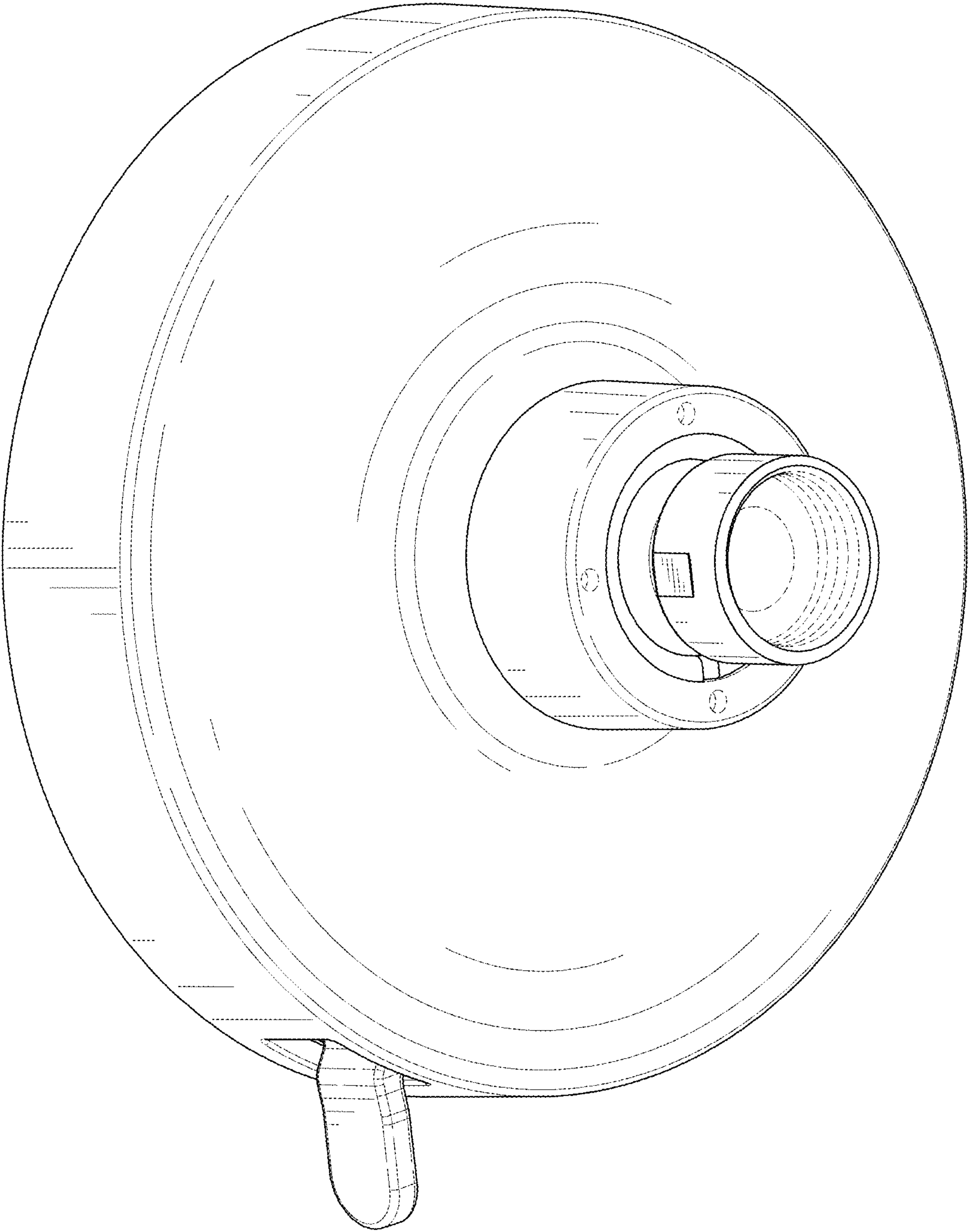

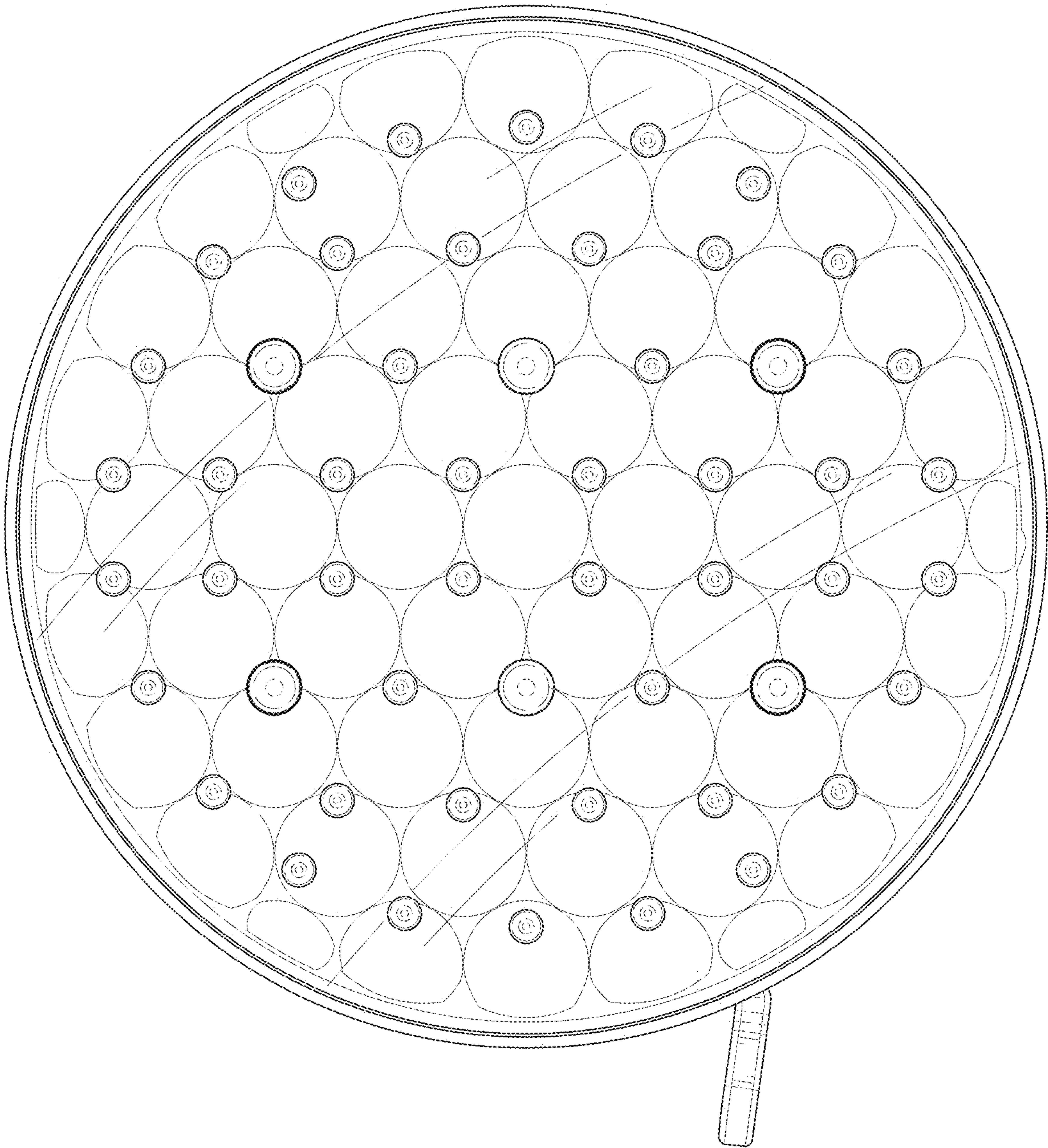

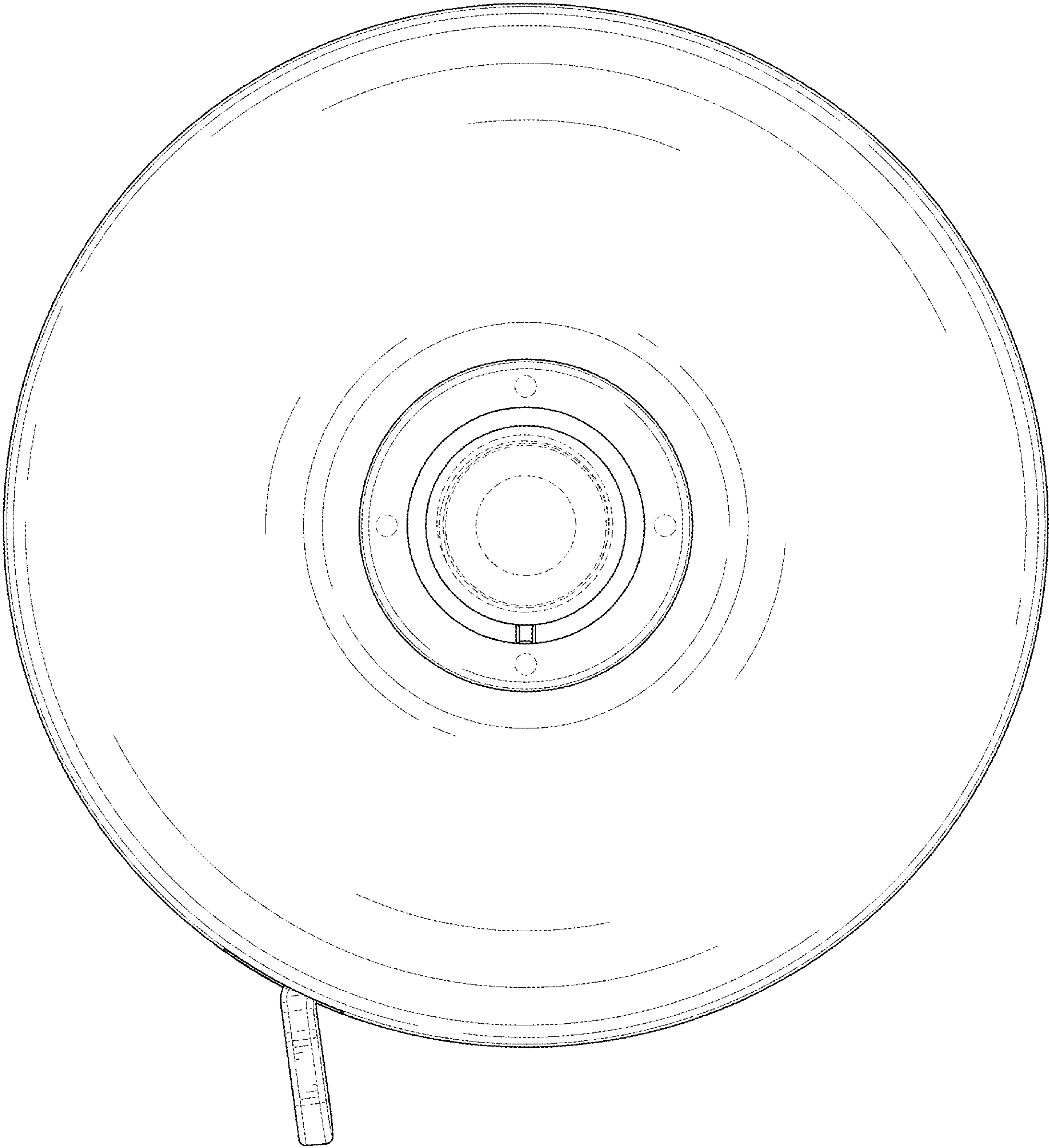

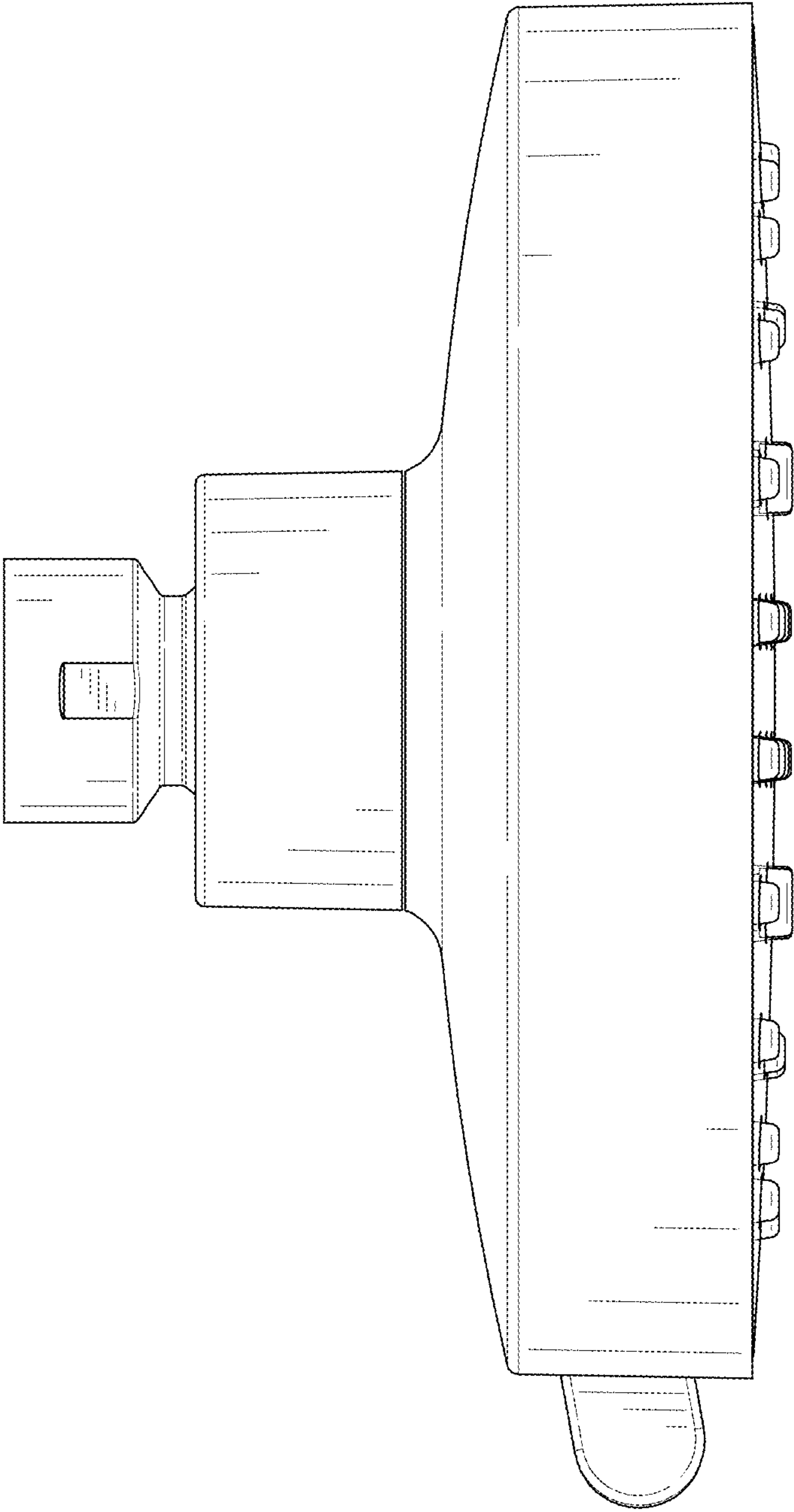

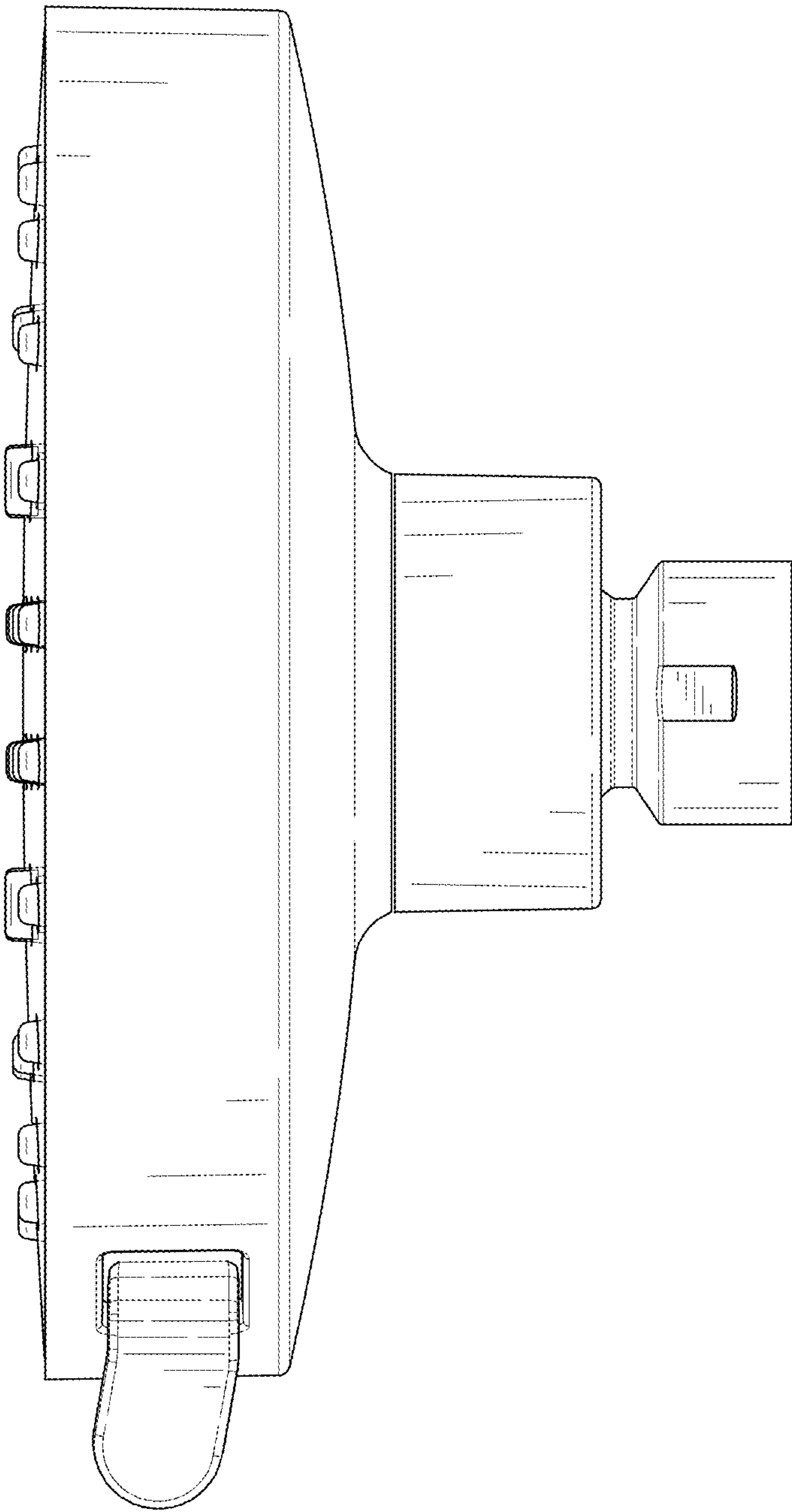

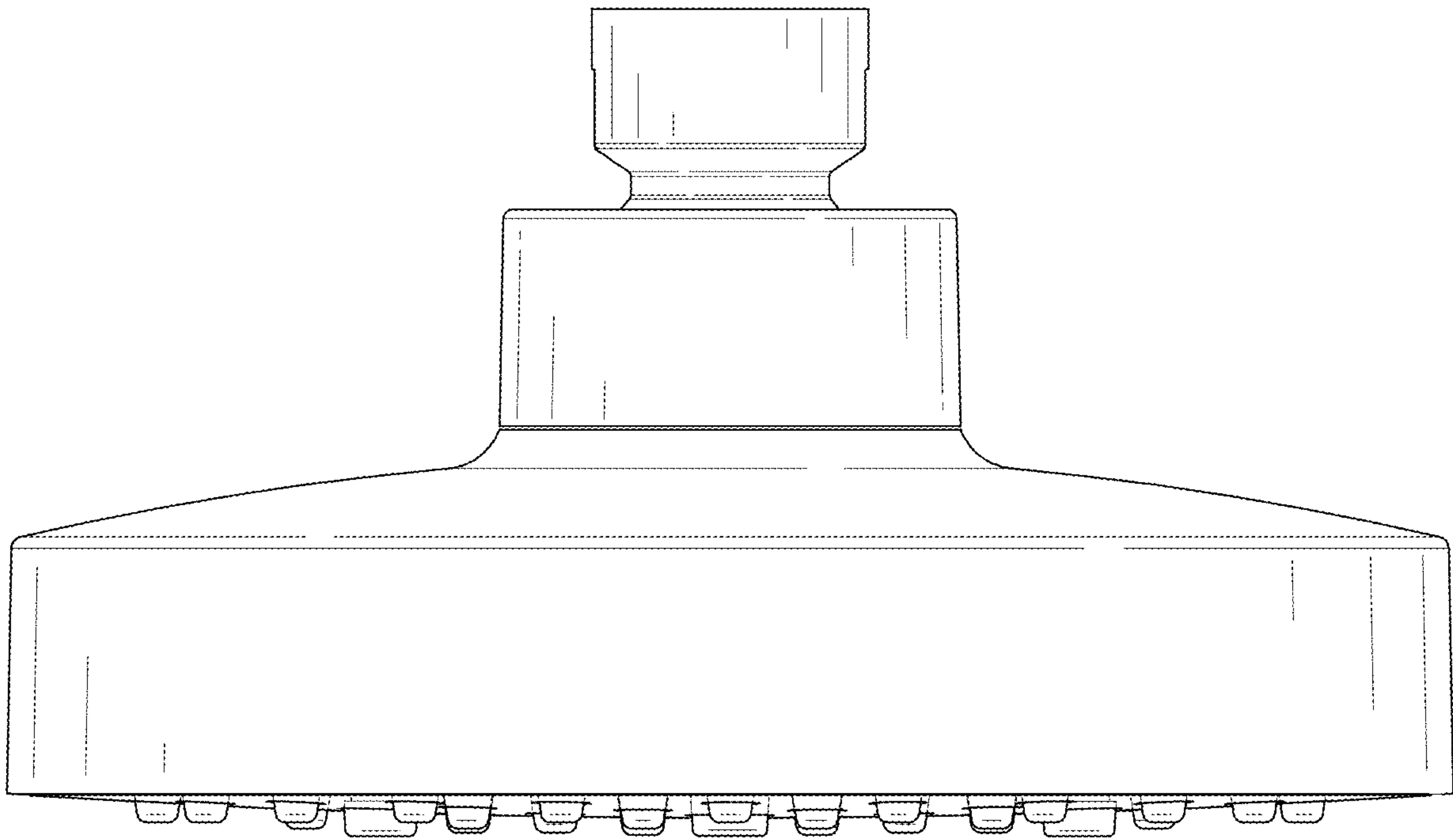

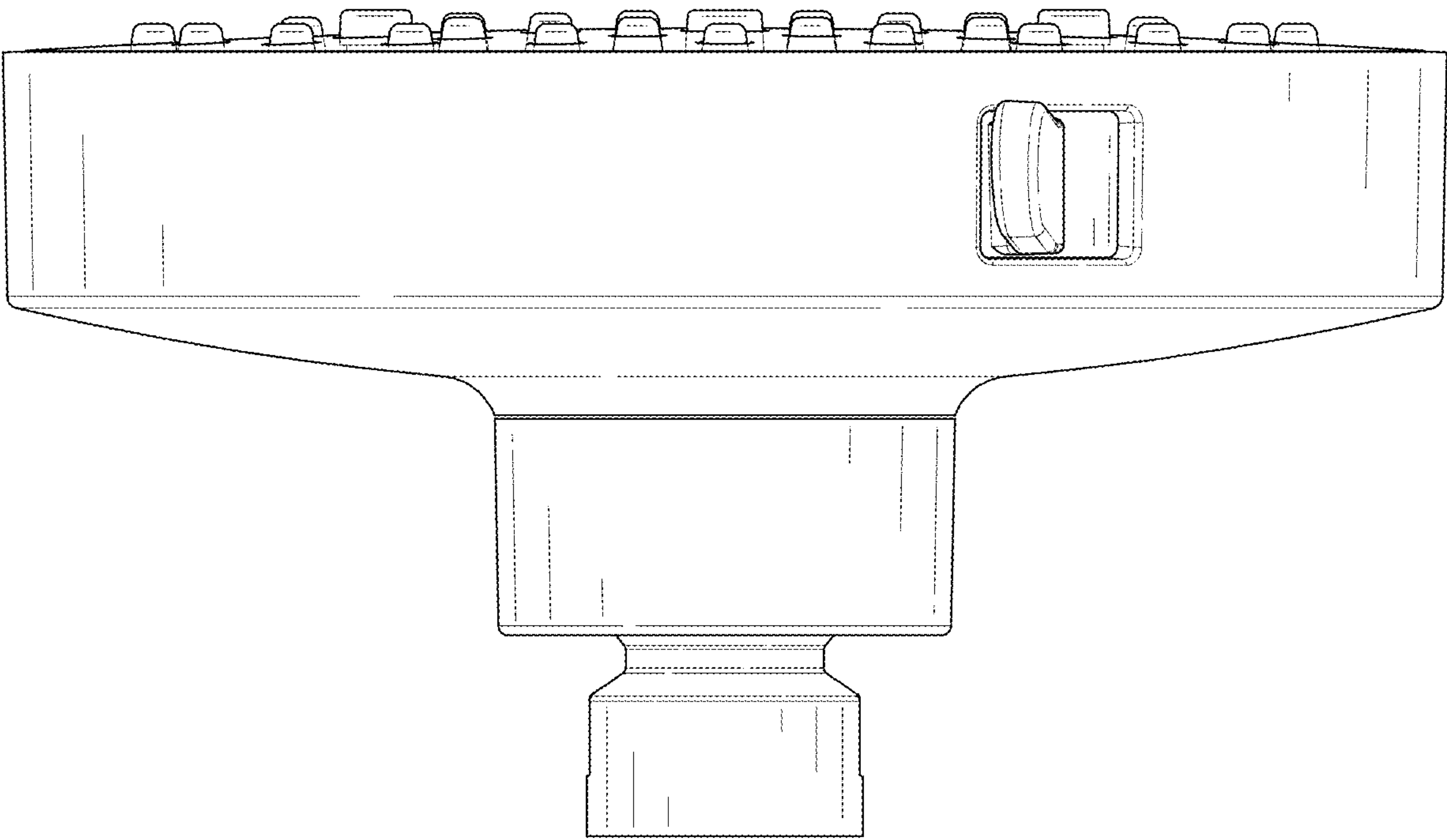

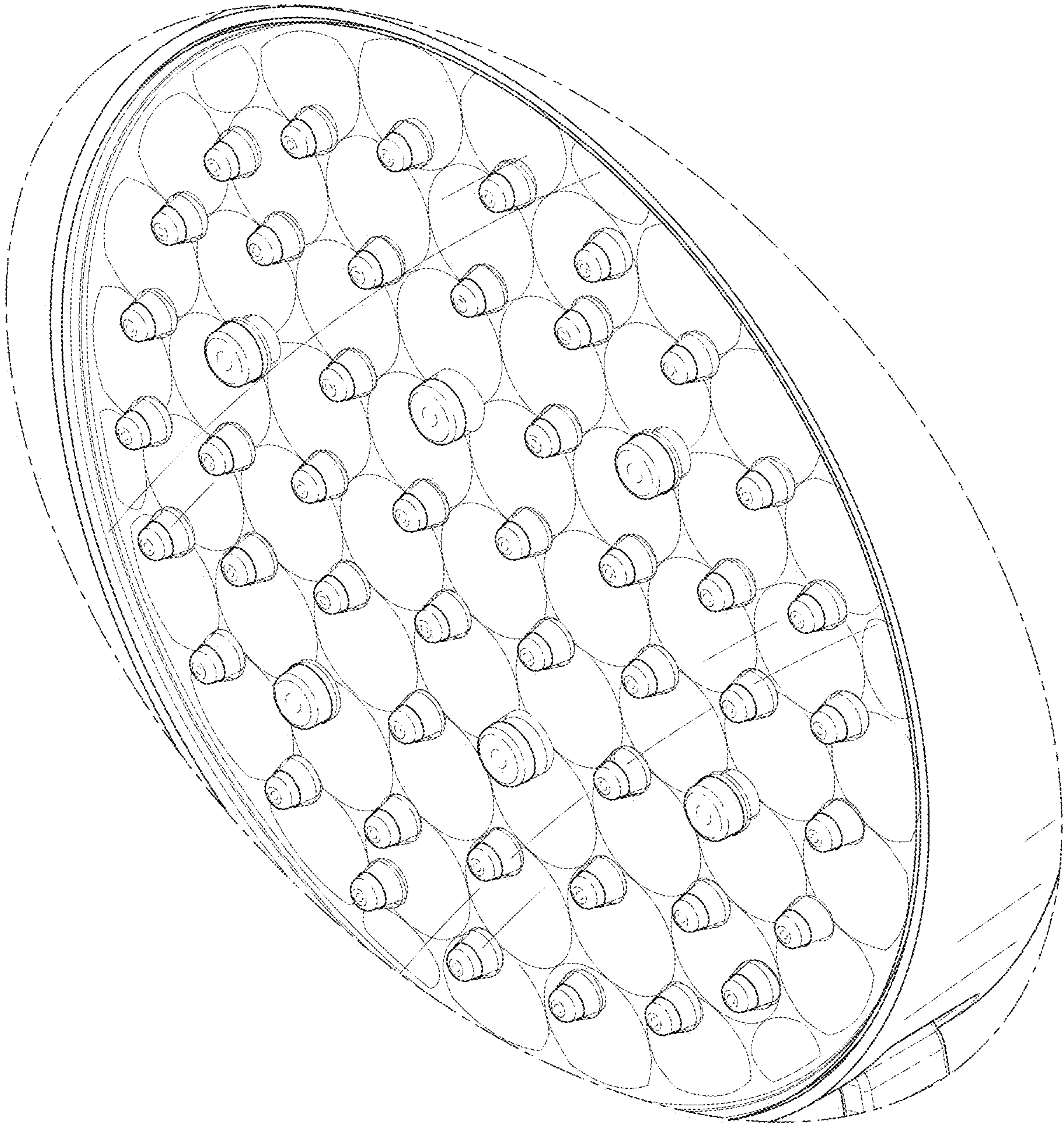
