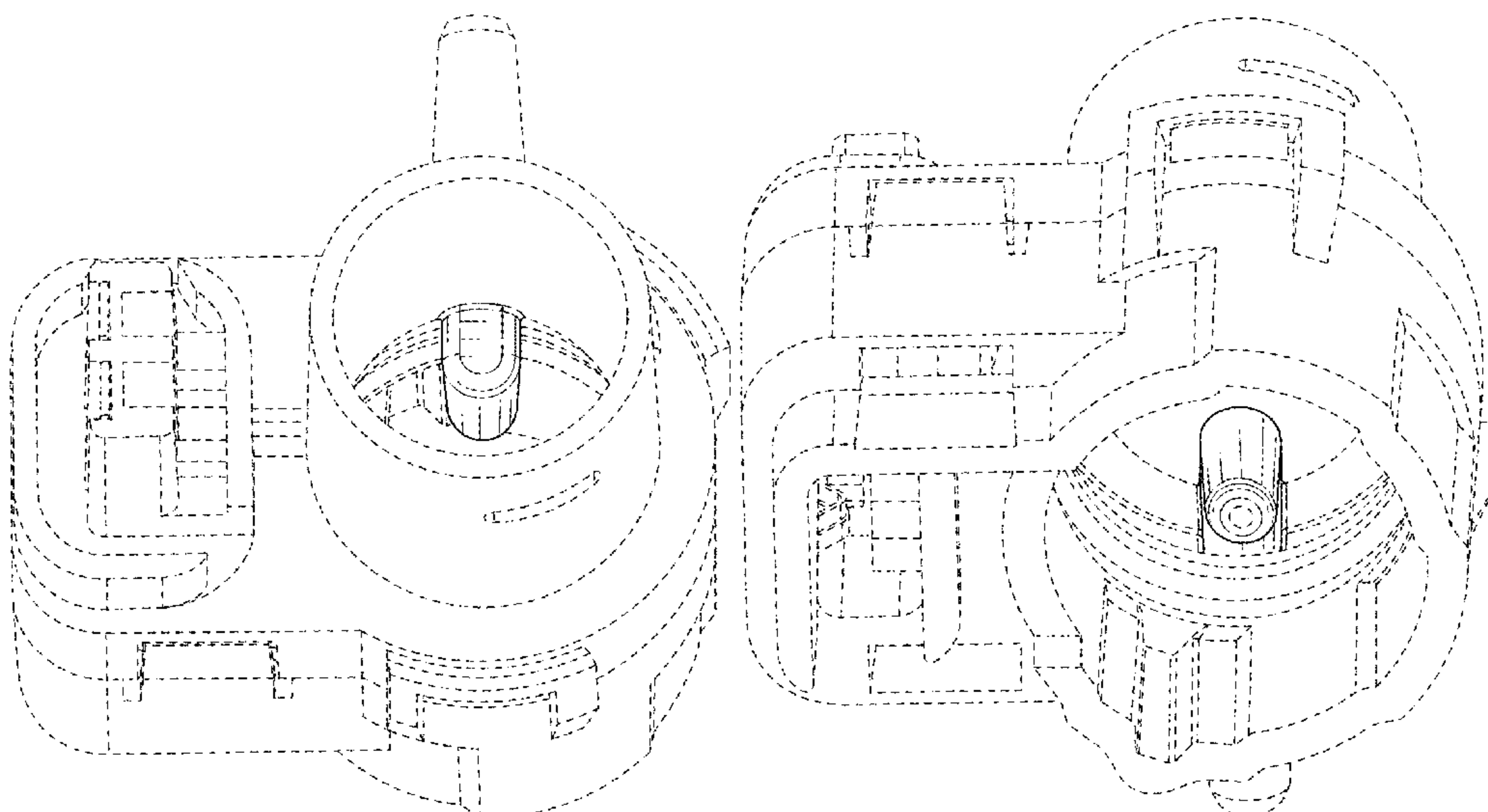
(57) **CLAIM**

The ornamental design for a connector for a sanitizing machine, as shown and described.

DESCRIPTION

FIG. 1 is a bottom view of a connector for a sanitizing machine, showing the new design;
FIG. 2 is a top view thereof;
FIG. 3 is a front top perspective view thereof;
FIG. 4 is a front bottom perspective view thereof;
FIG. 5 is a front left top perspective view thereof;
FIG. 6 is a front right top perspective view thereof;
FIG. 7 is a front right bottom perspective view thereof;
FIG. 8 is a front left bottom perspective view thereof;
FIG. 9 is a right side top perspective view thereof; and,
FIG. 10 is a right side bottom perspective view thereof.

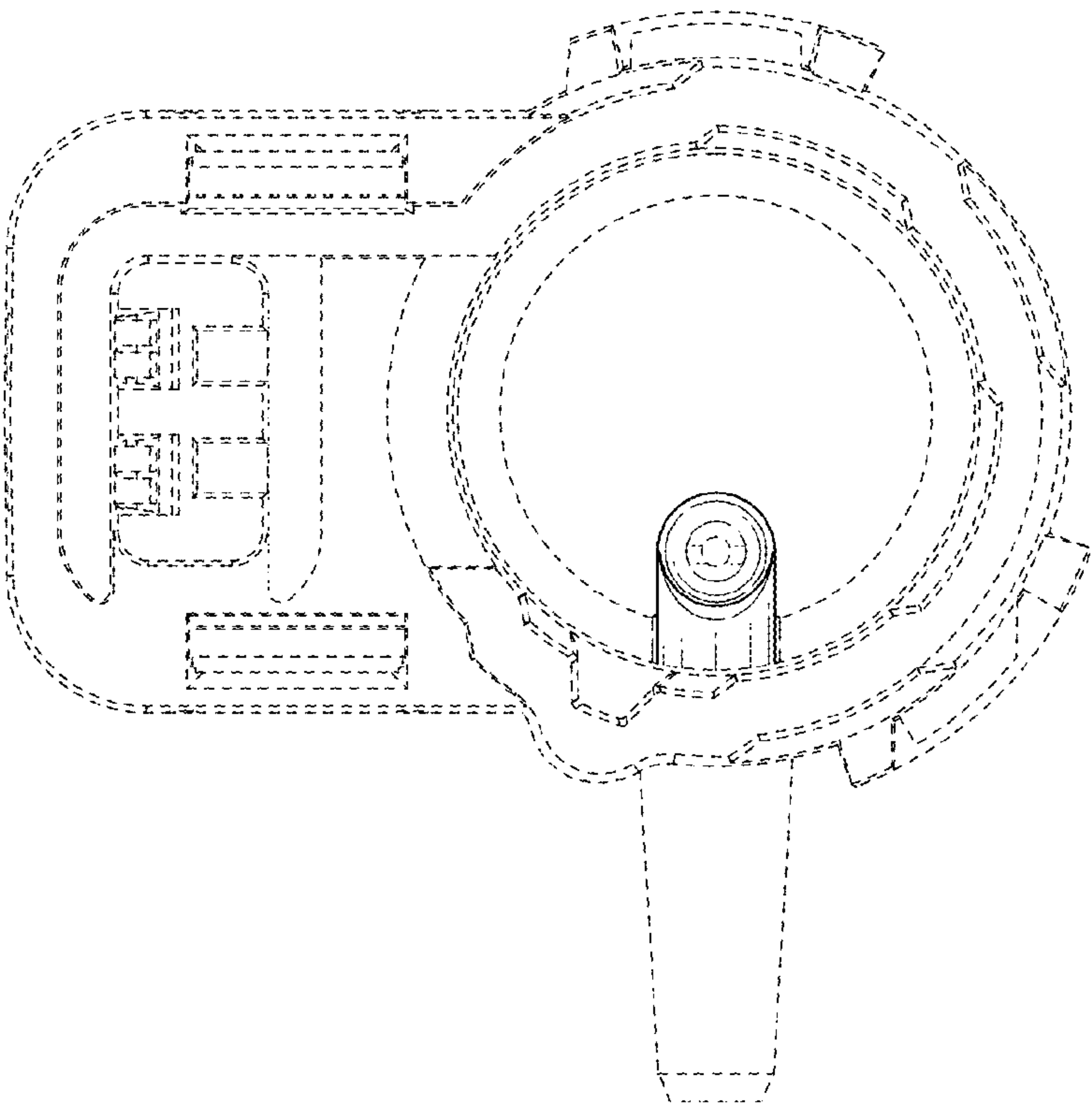

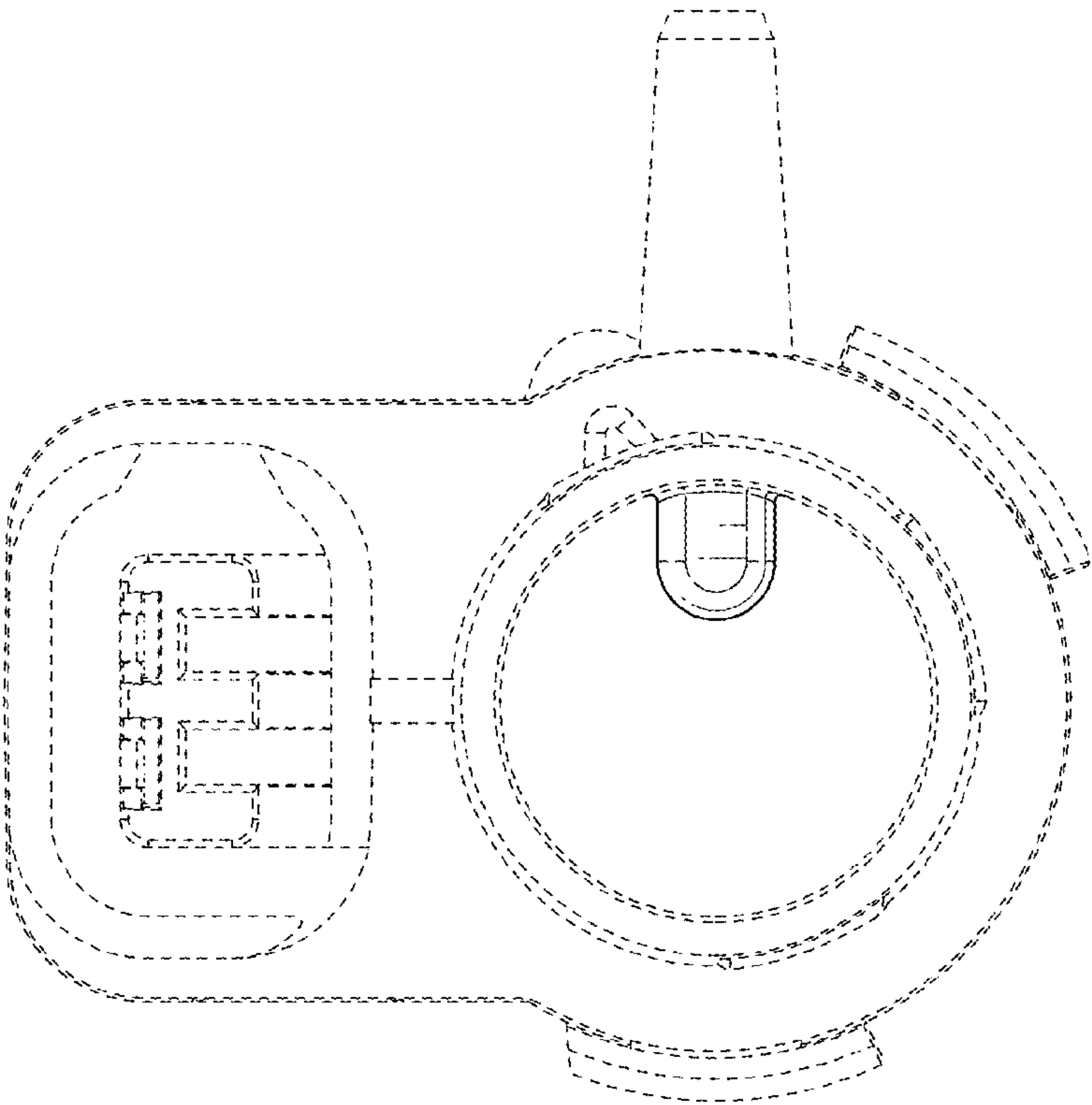

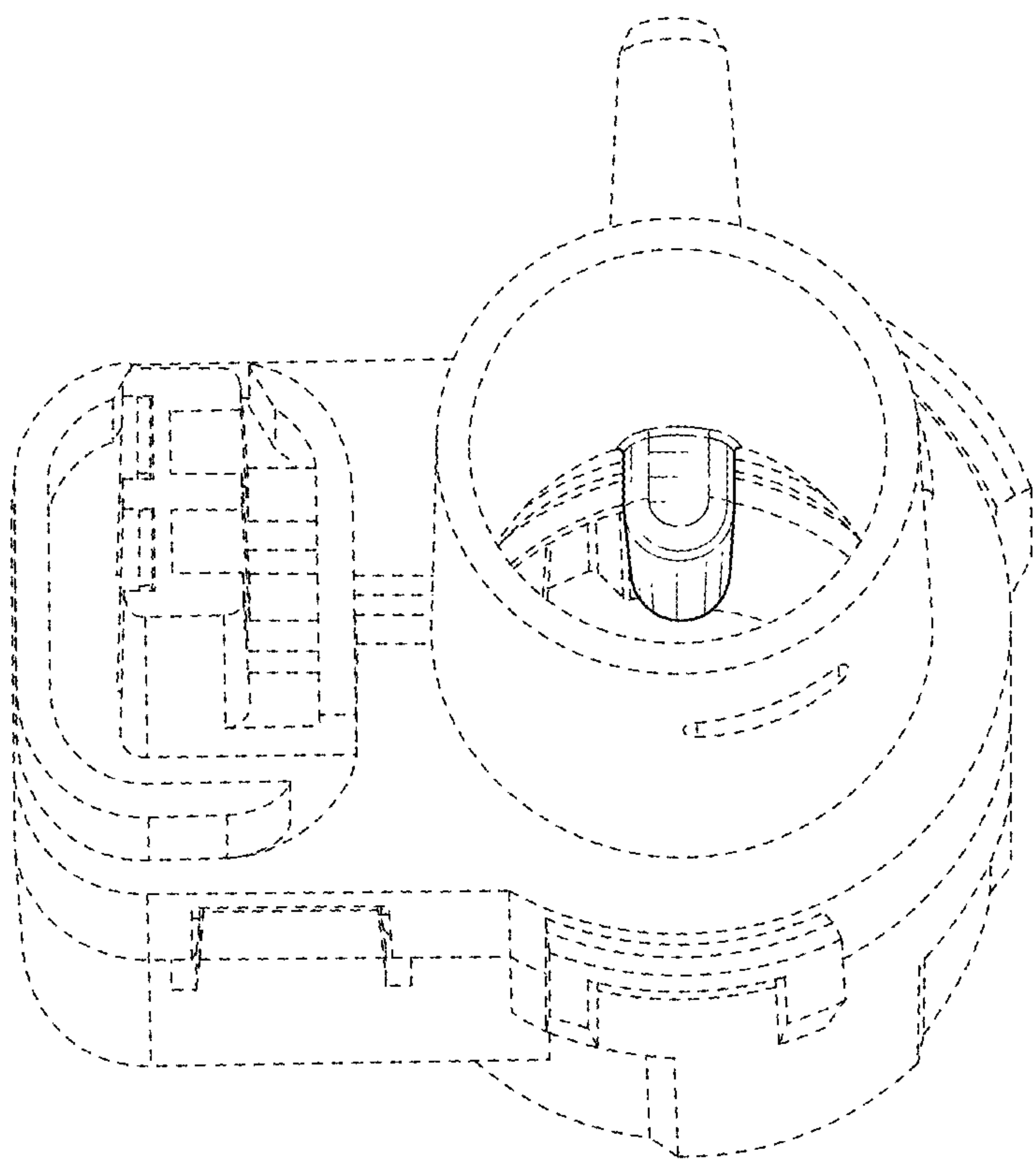

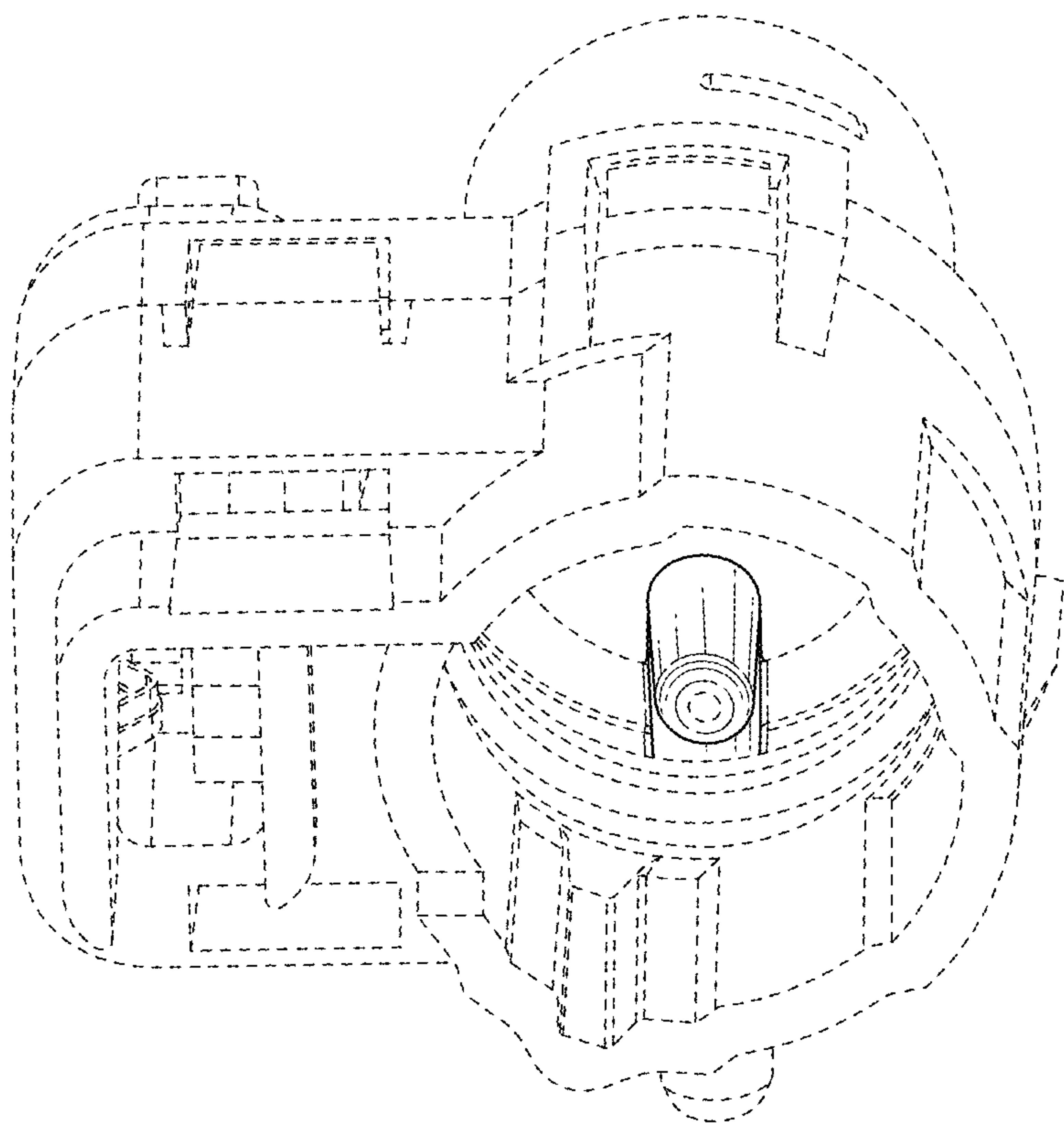

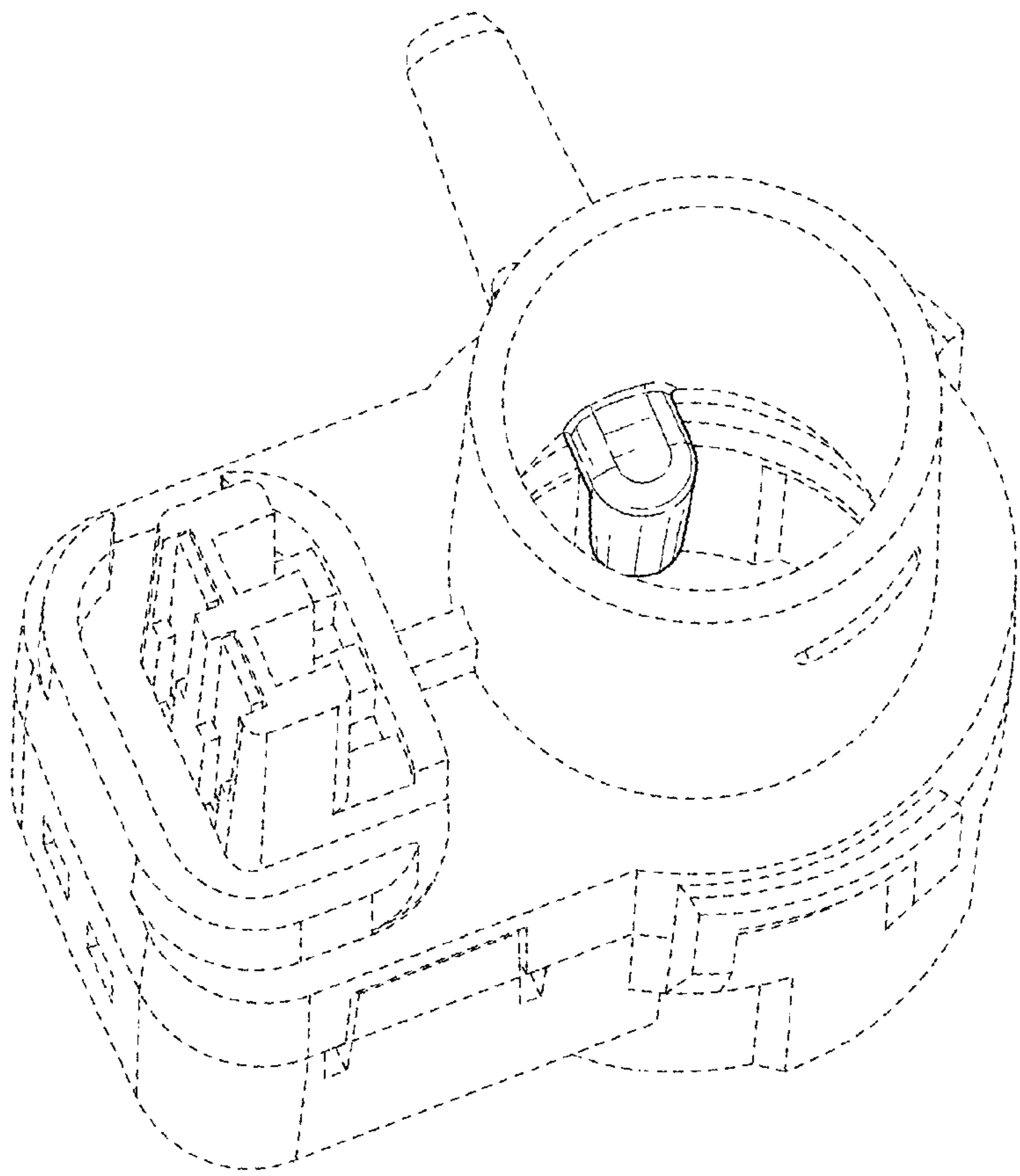

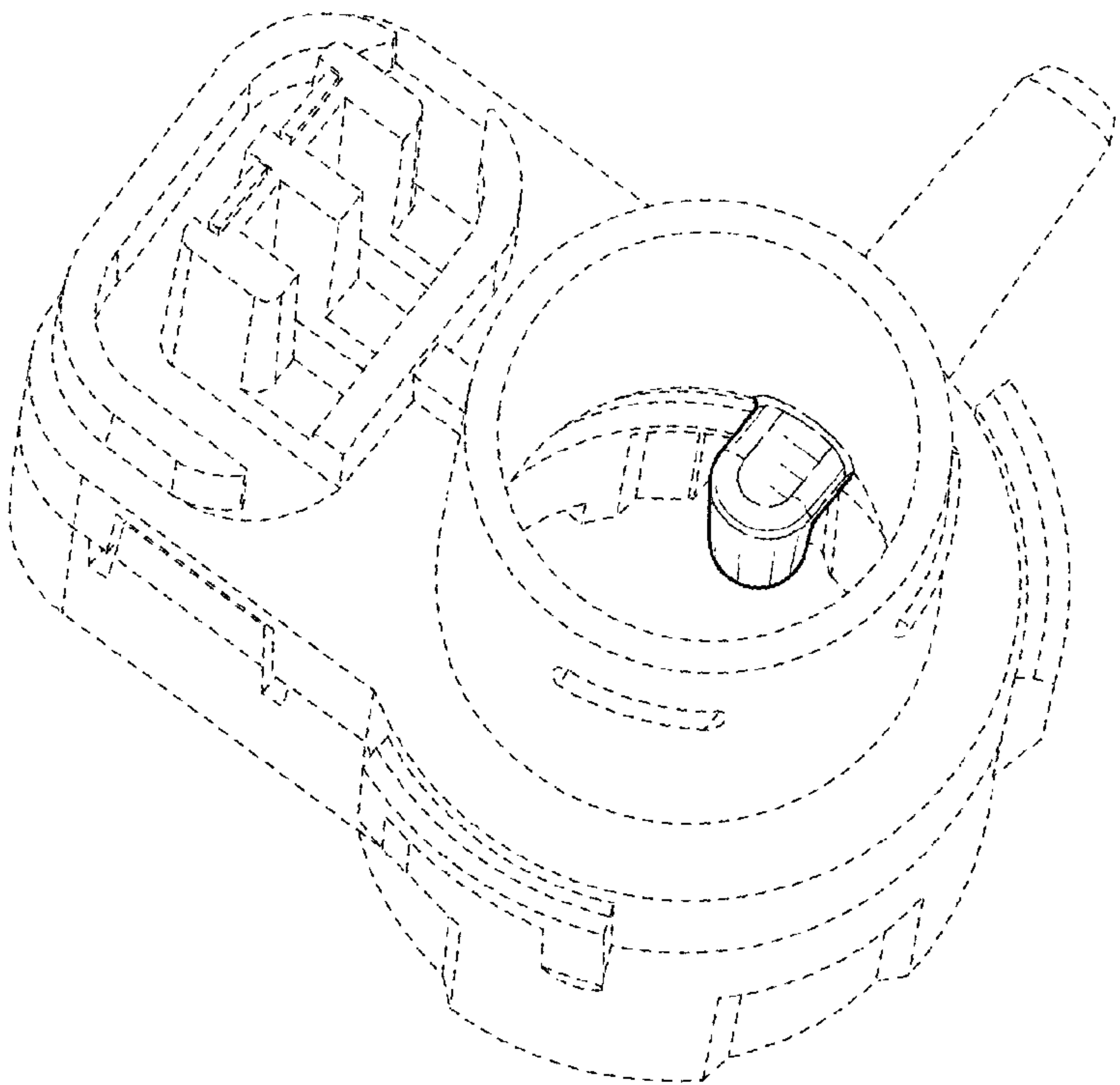

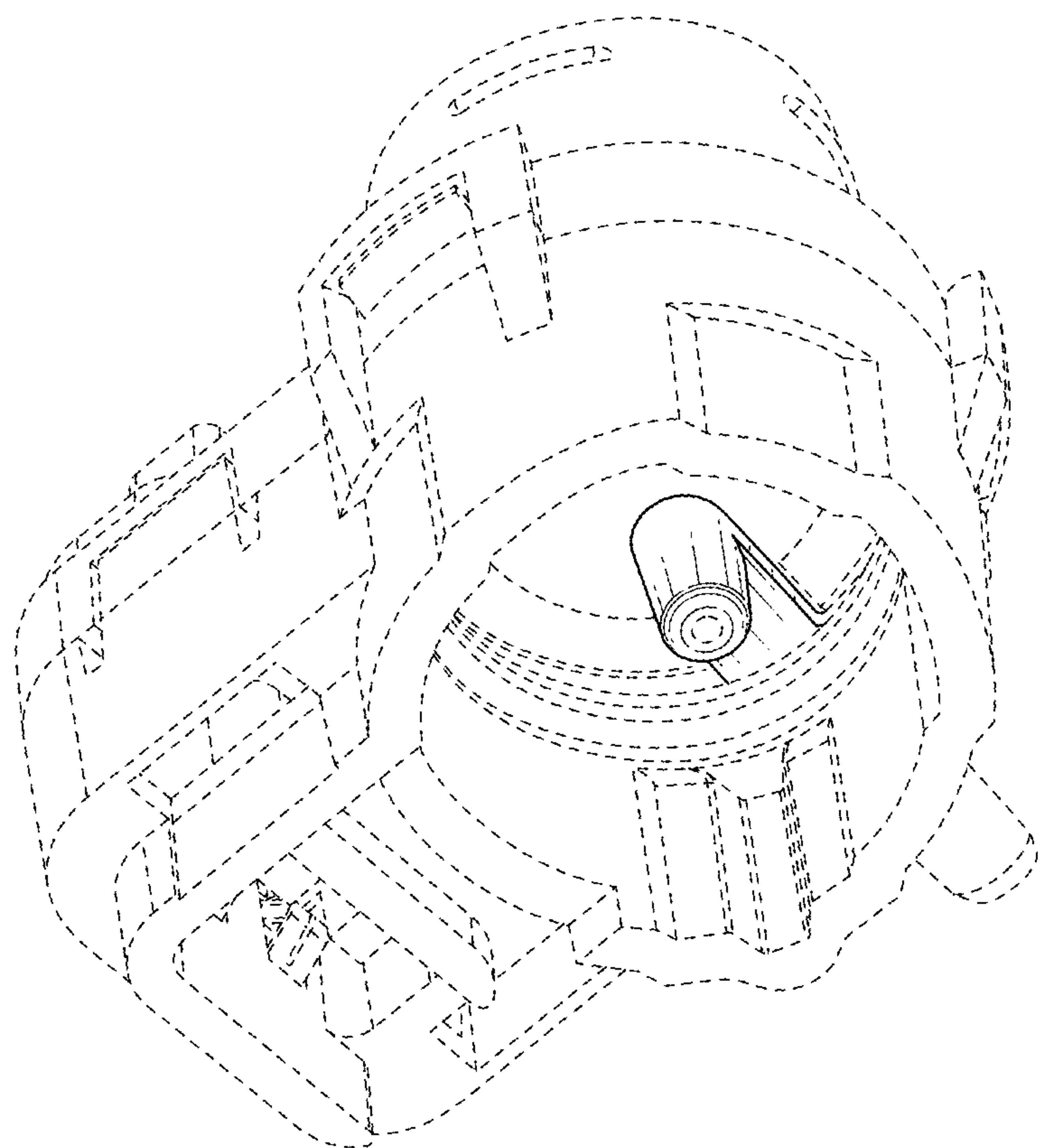

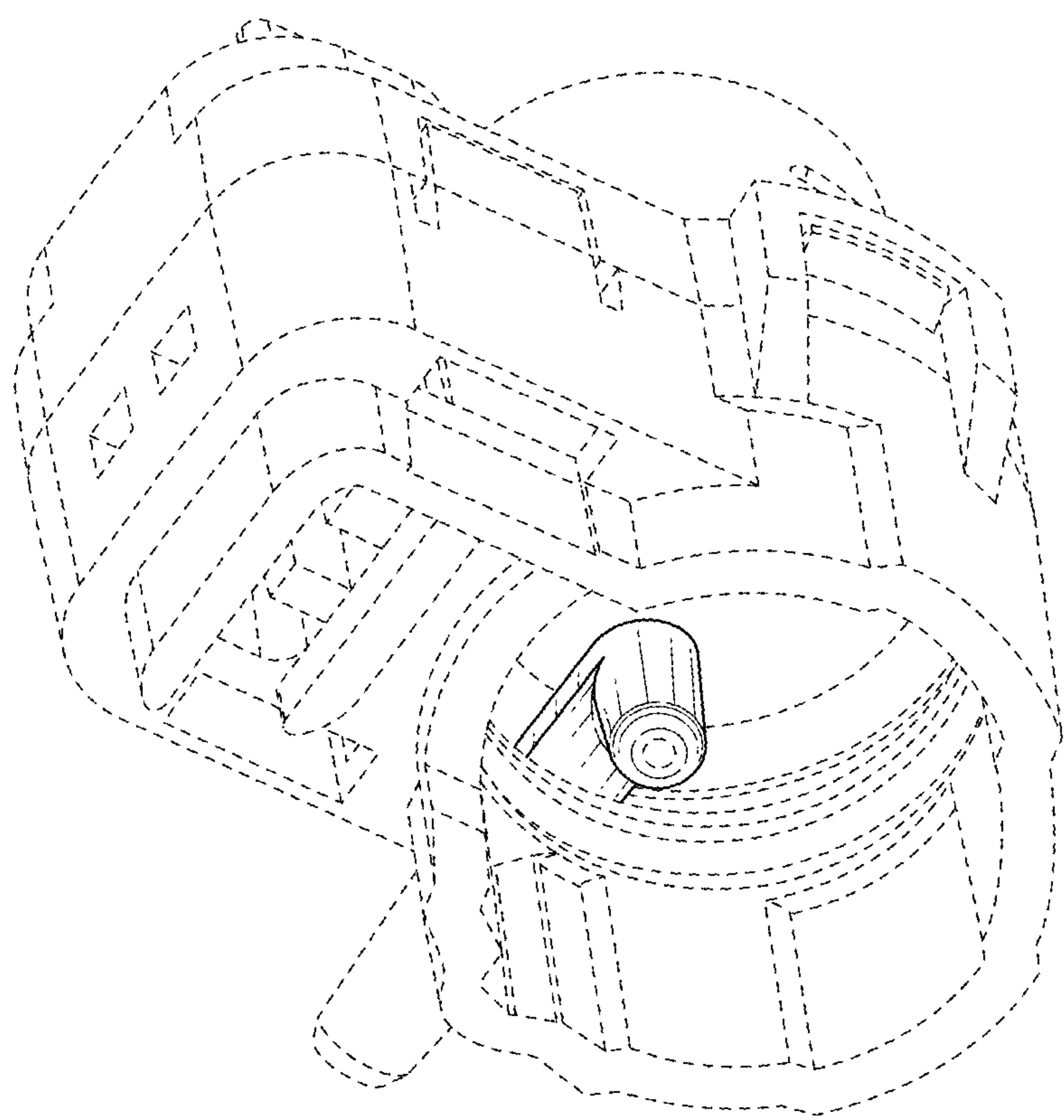

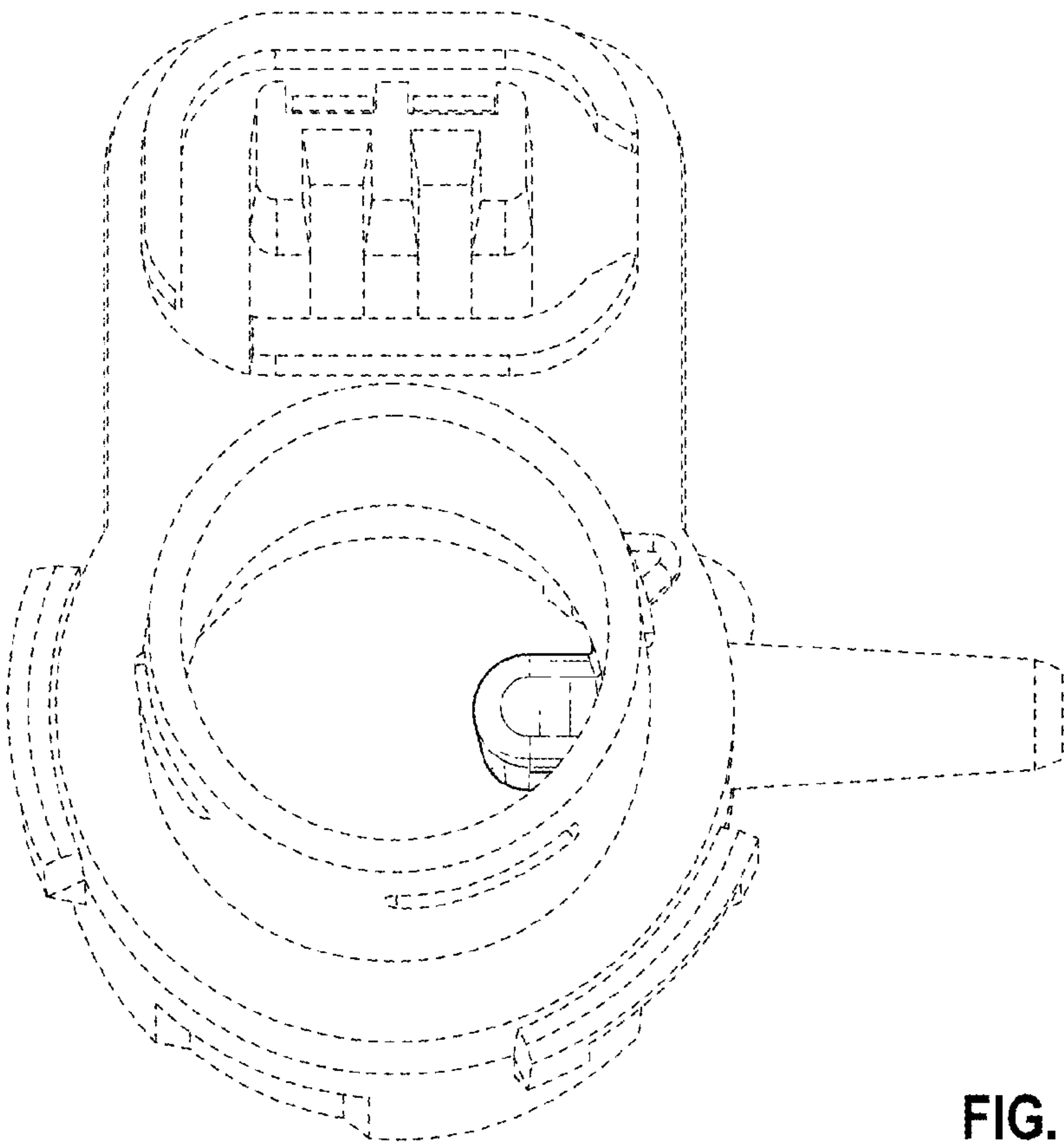

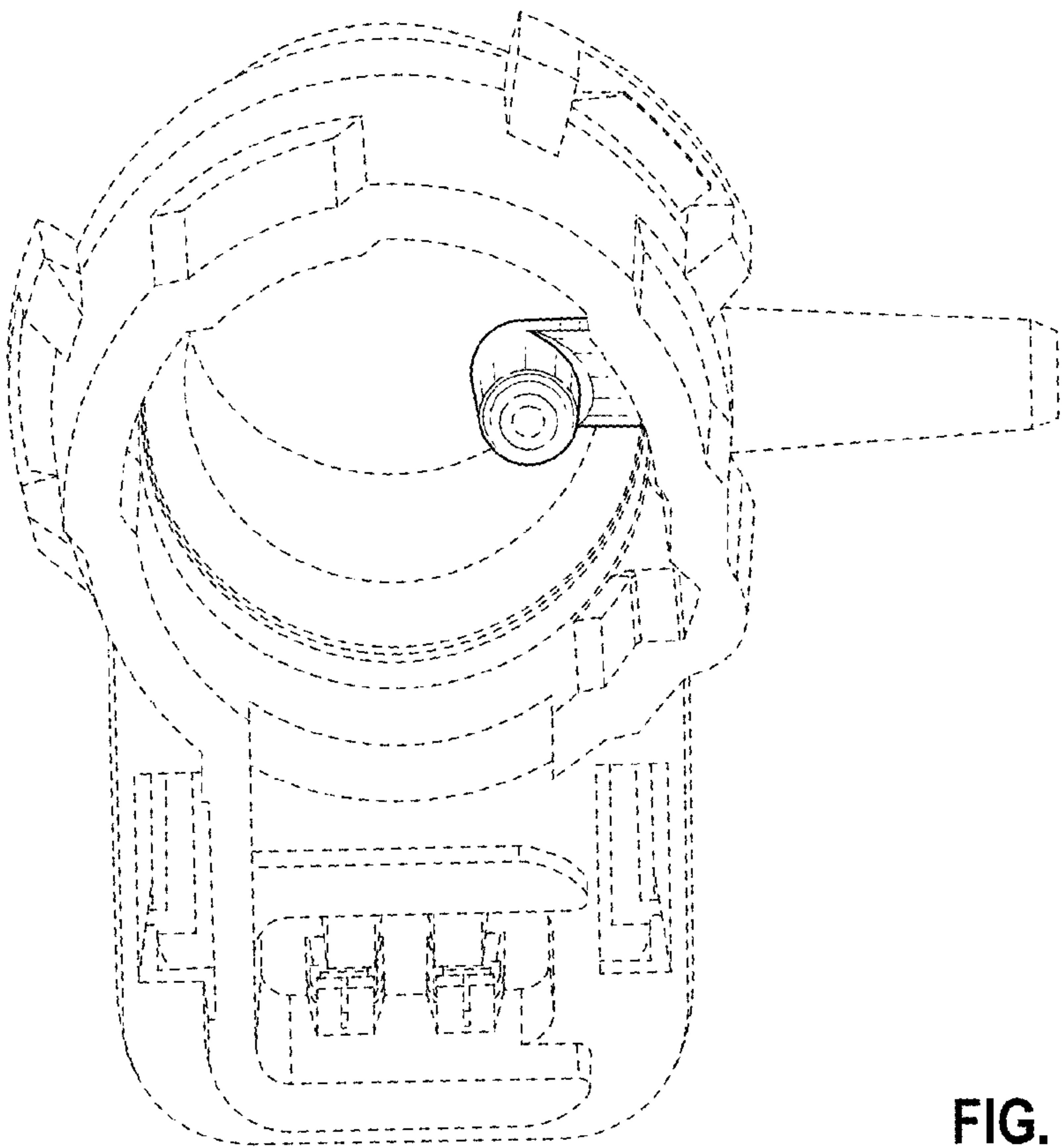
