(57) **CLAIM**

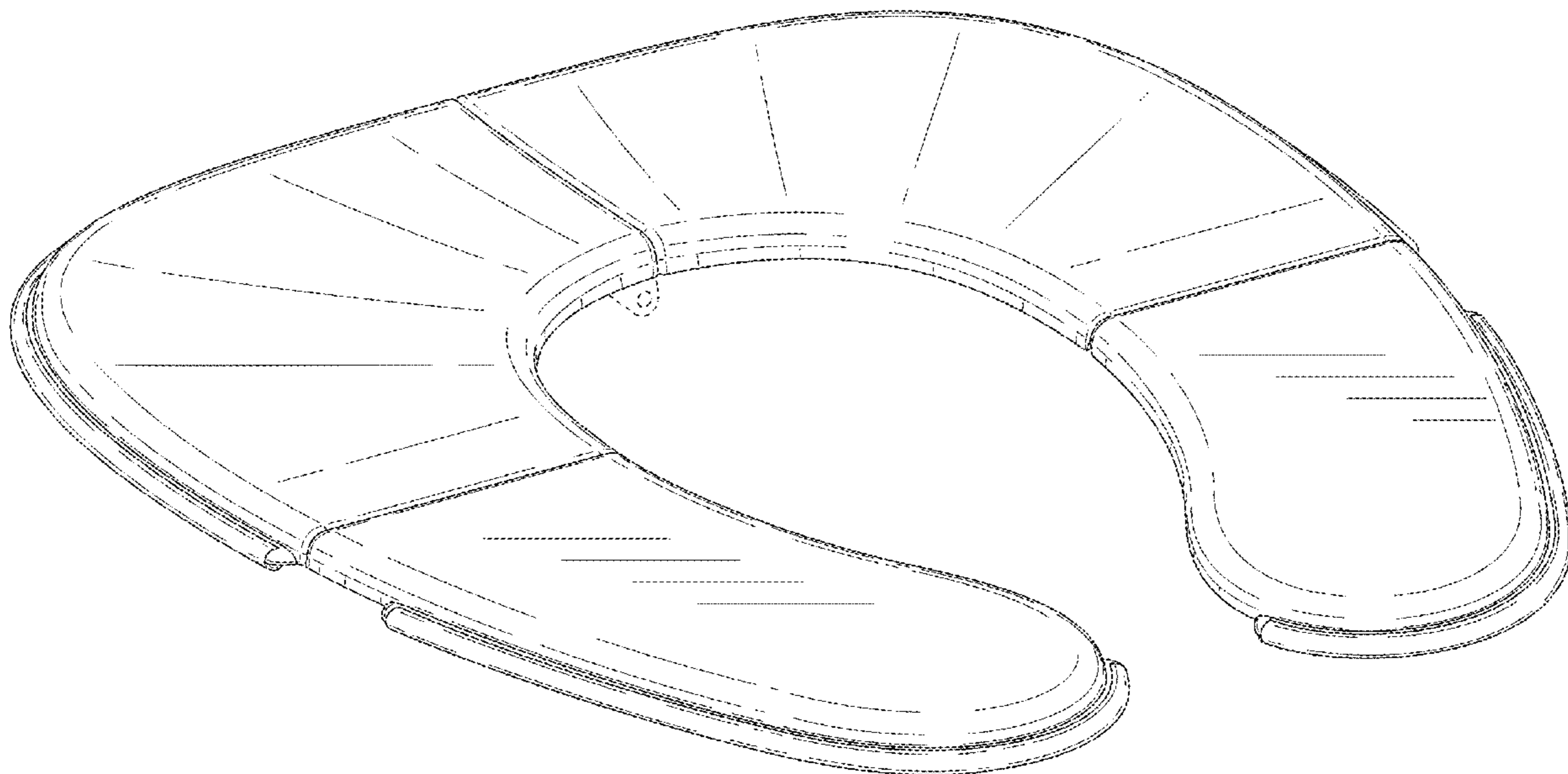
The ornamental design for a collapsible child toilet seat, as shown and described.

**DESCRIPTION**

FIG. 1 is a top front perspective view of a collapsible child toilet seat showing our new design;  
 FIG. 2 is a top rear perspective view thereof;  
 FIG. 3 is a bottom perspective view thereof;  
 FIG. 4 is a top view thereof;  
 FIG. 5 is a bottom view thereof;  
 FIG. 6 is a right side view thereof, the left side being a mirror image of the right side;

 FIG. 8 is a rear view thereof.

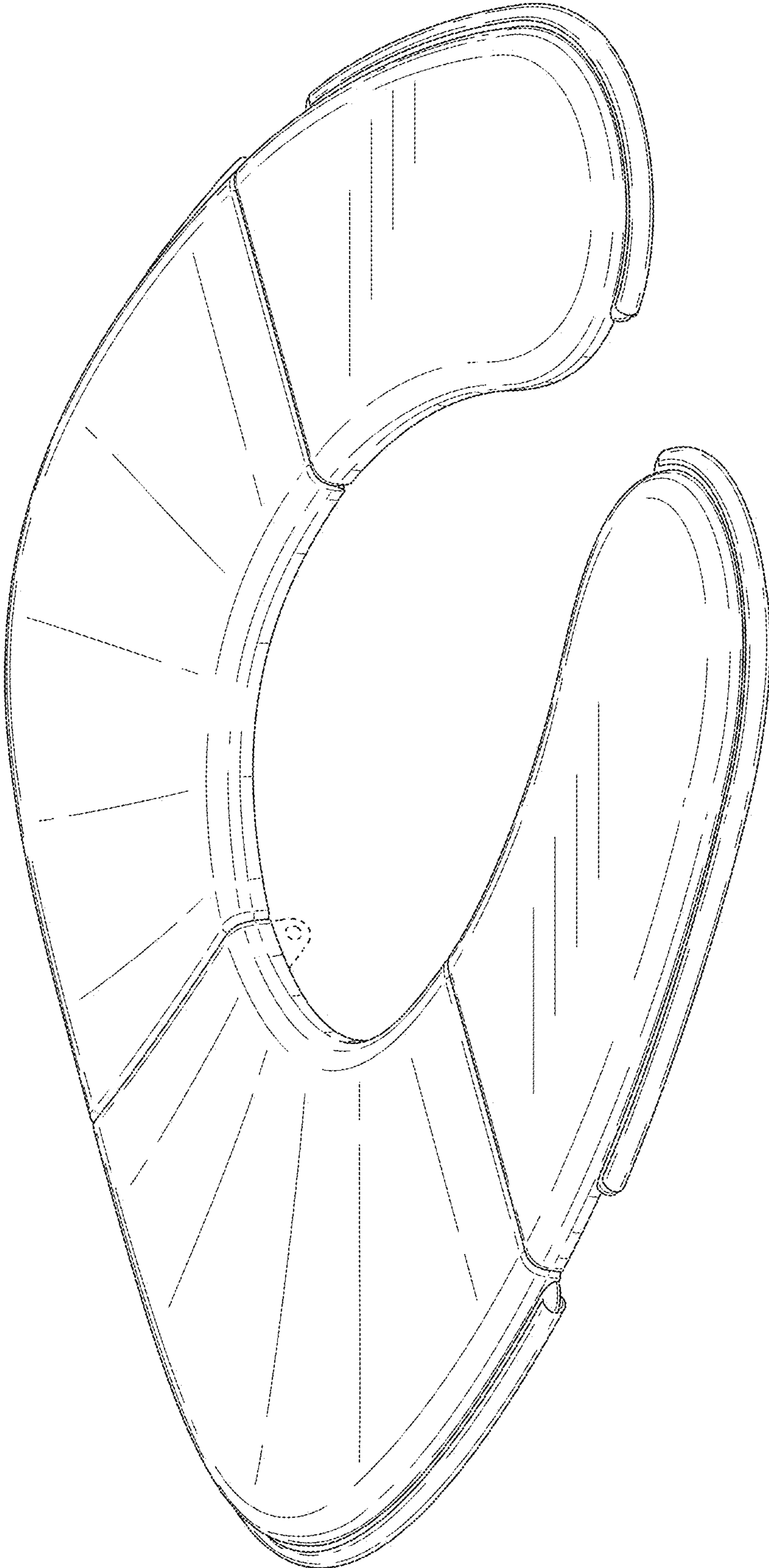

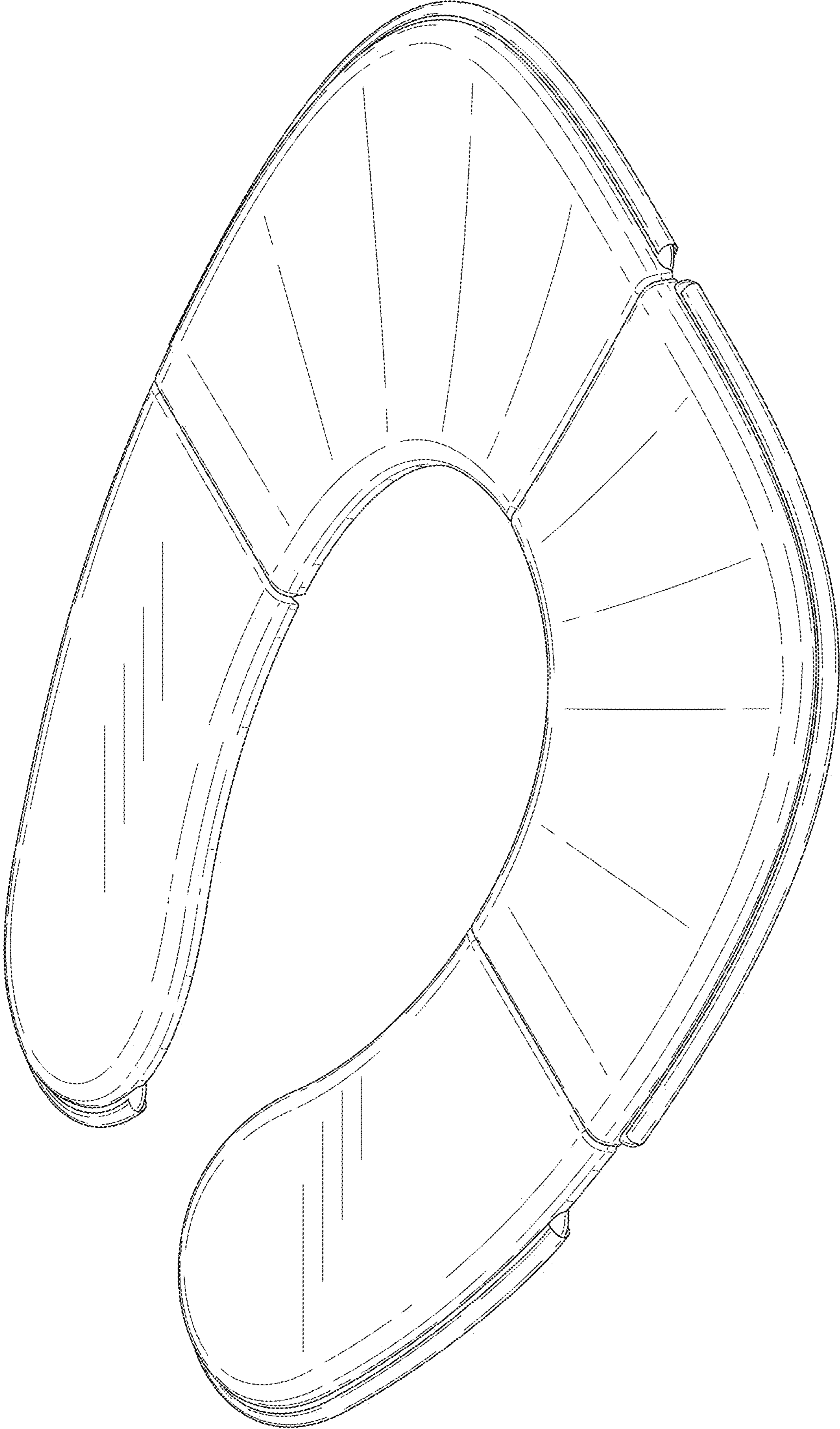

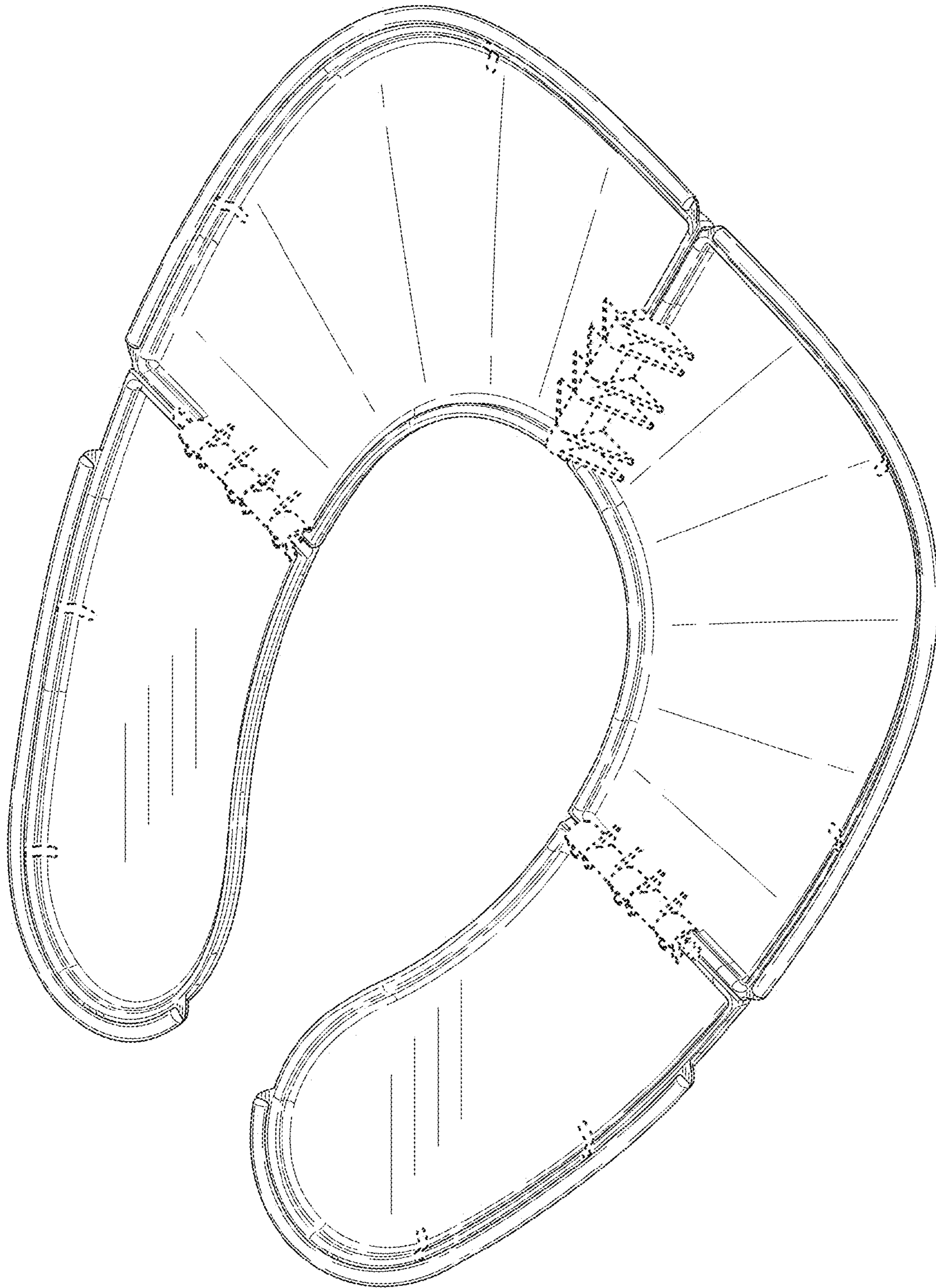

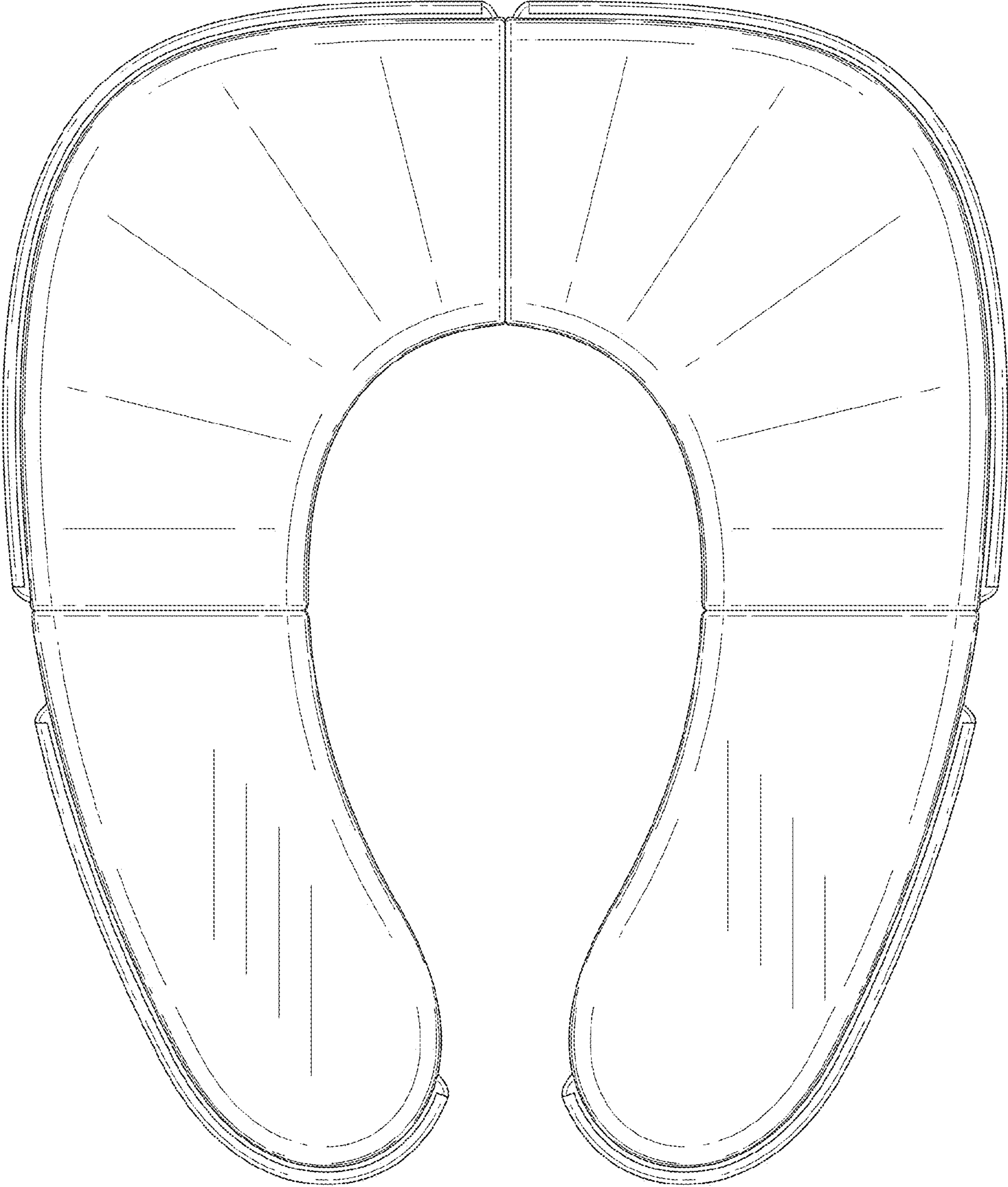

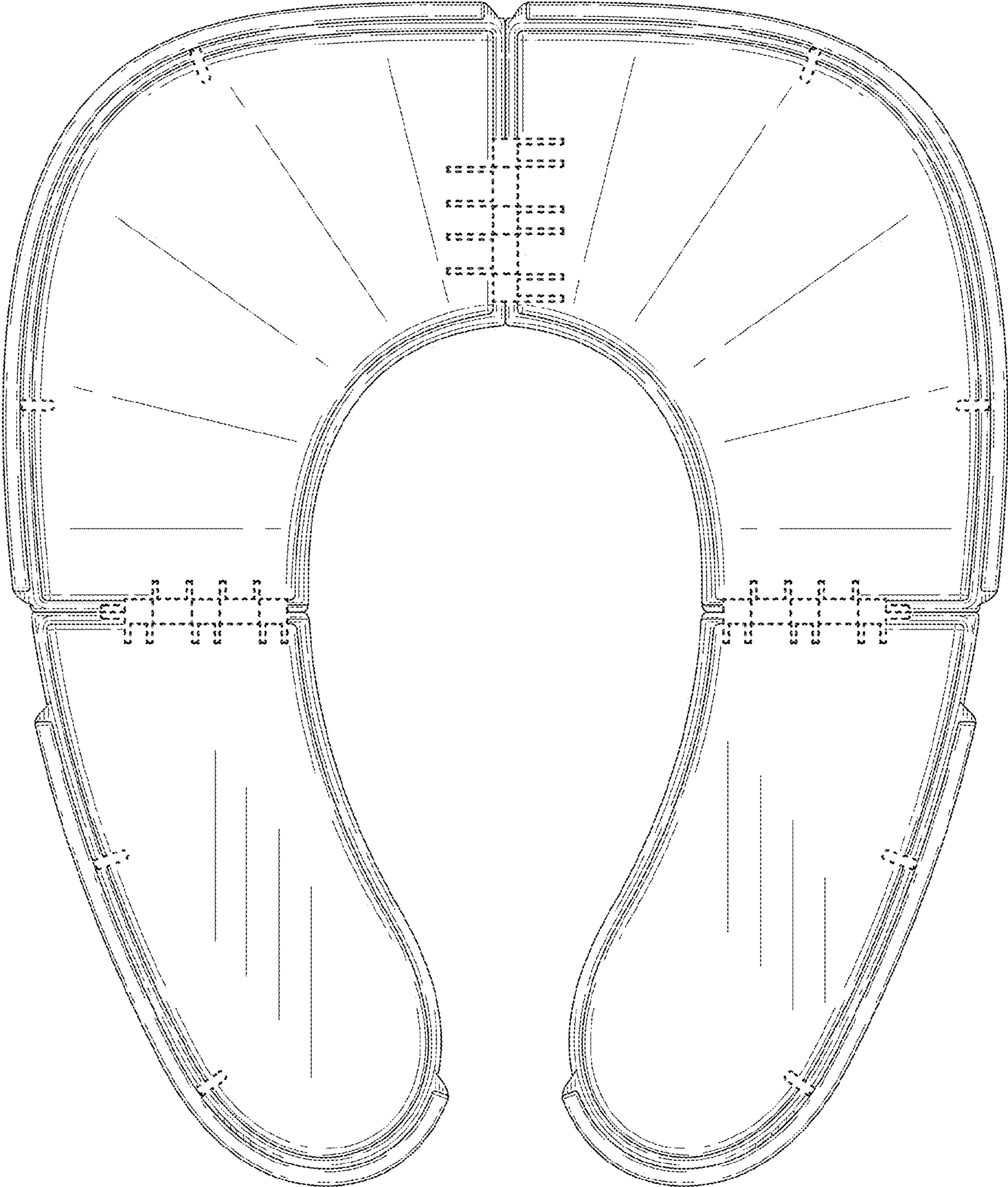

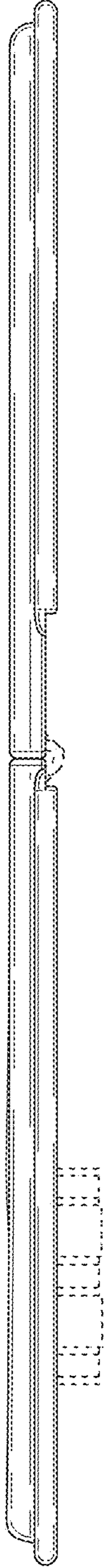

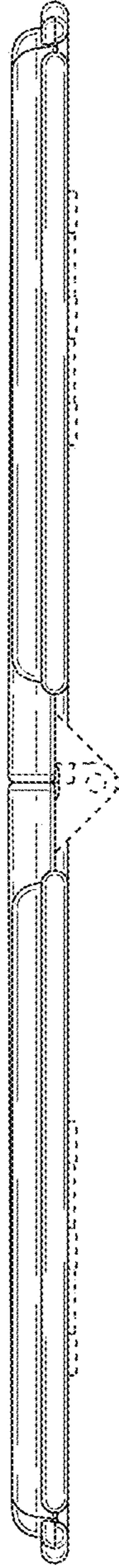

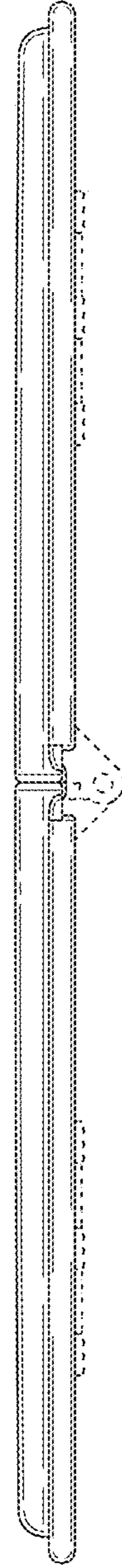
