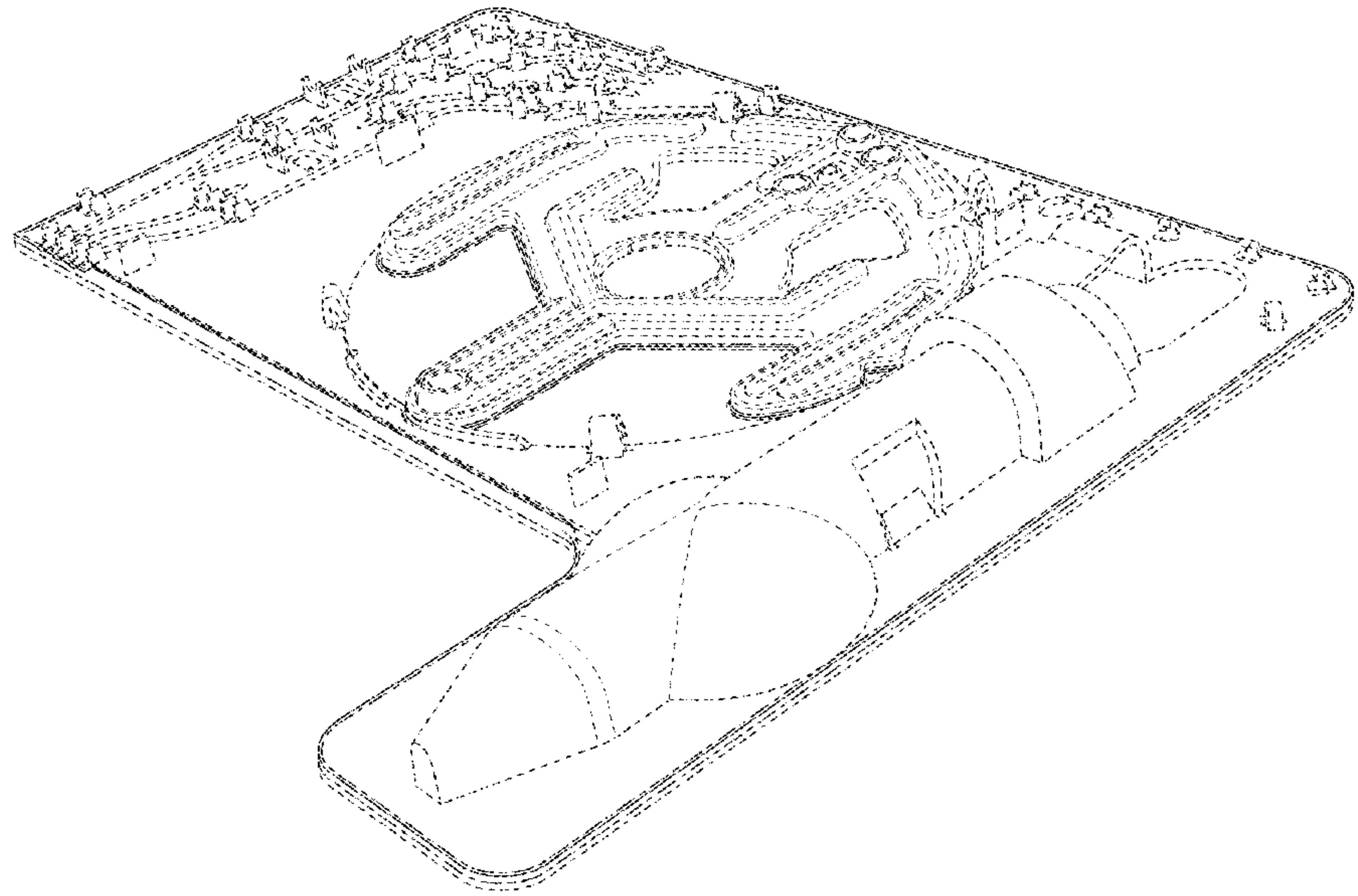

(57) **CLAIM**
The ornamental design for a tubing support plate and
microfluidic disc, as shown and described.

DESCRIPTION
FIG. 1 is a bottom, front, and right side perspective view of
a tubing support plate and microfluidic disc showing our
new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a rear elevation view thereof;
FIG. 4 is a left side elevation view thereof;
FIG. 5 is a right side elevation view thereof;
FIG. 6 is top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.
The dash-dash broken lines represent portions of the tubing
support plate and microfluidic disc that form no part of the
claimed design. The dot-dash broken lines represent bound-
aries of the claimed design, and form no part of the claimed
design.

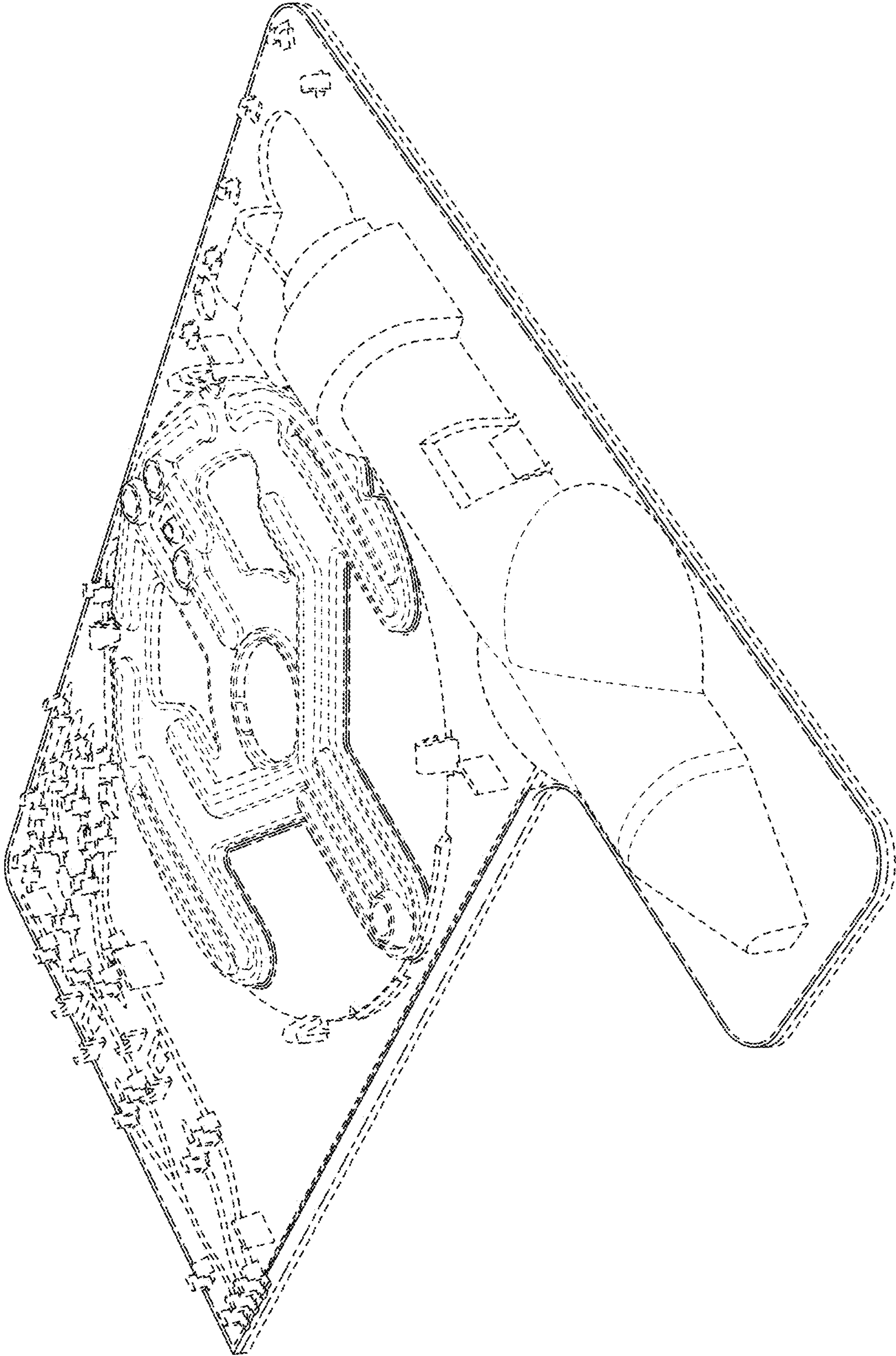

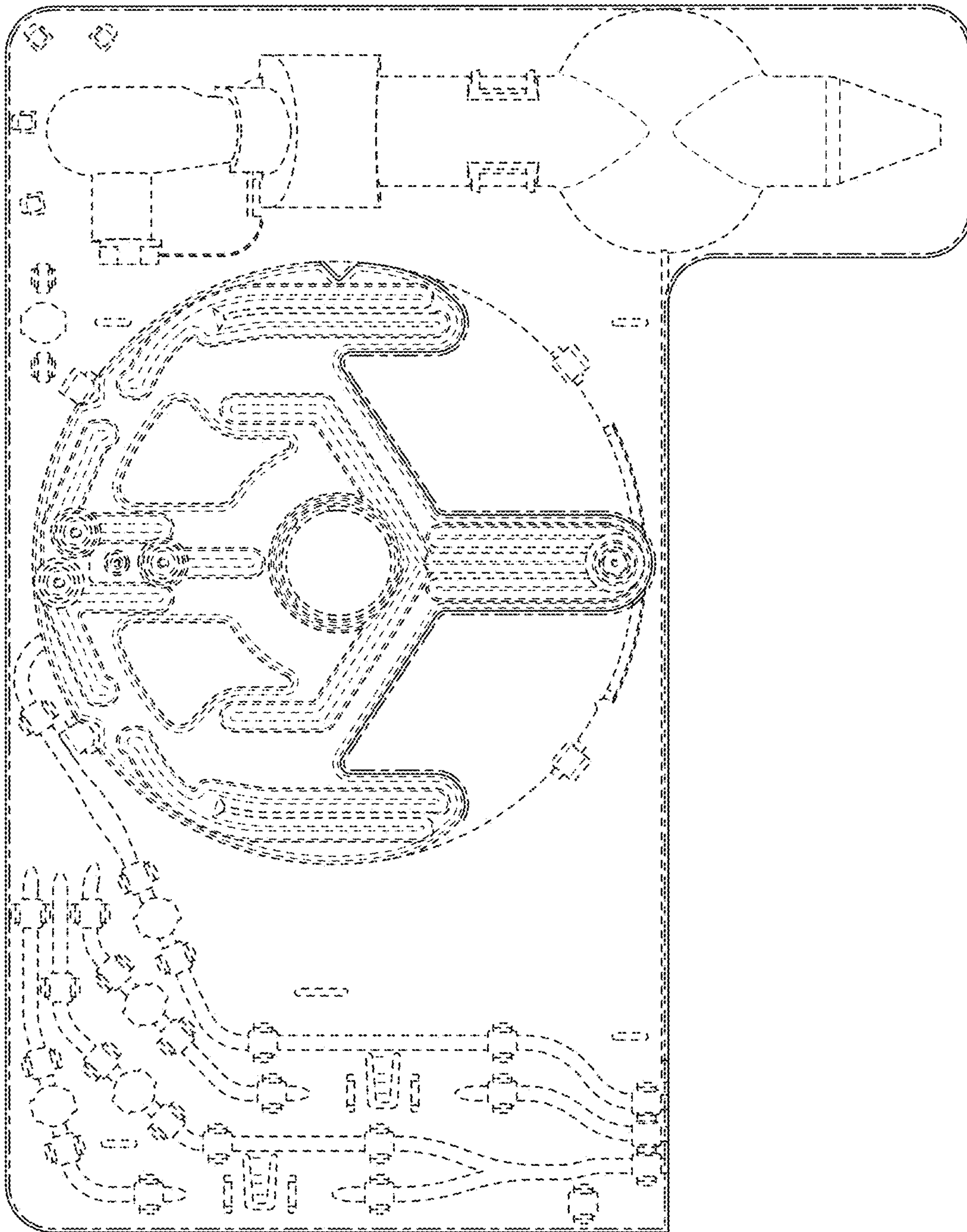

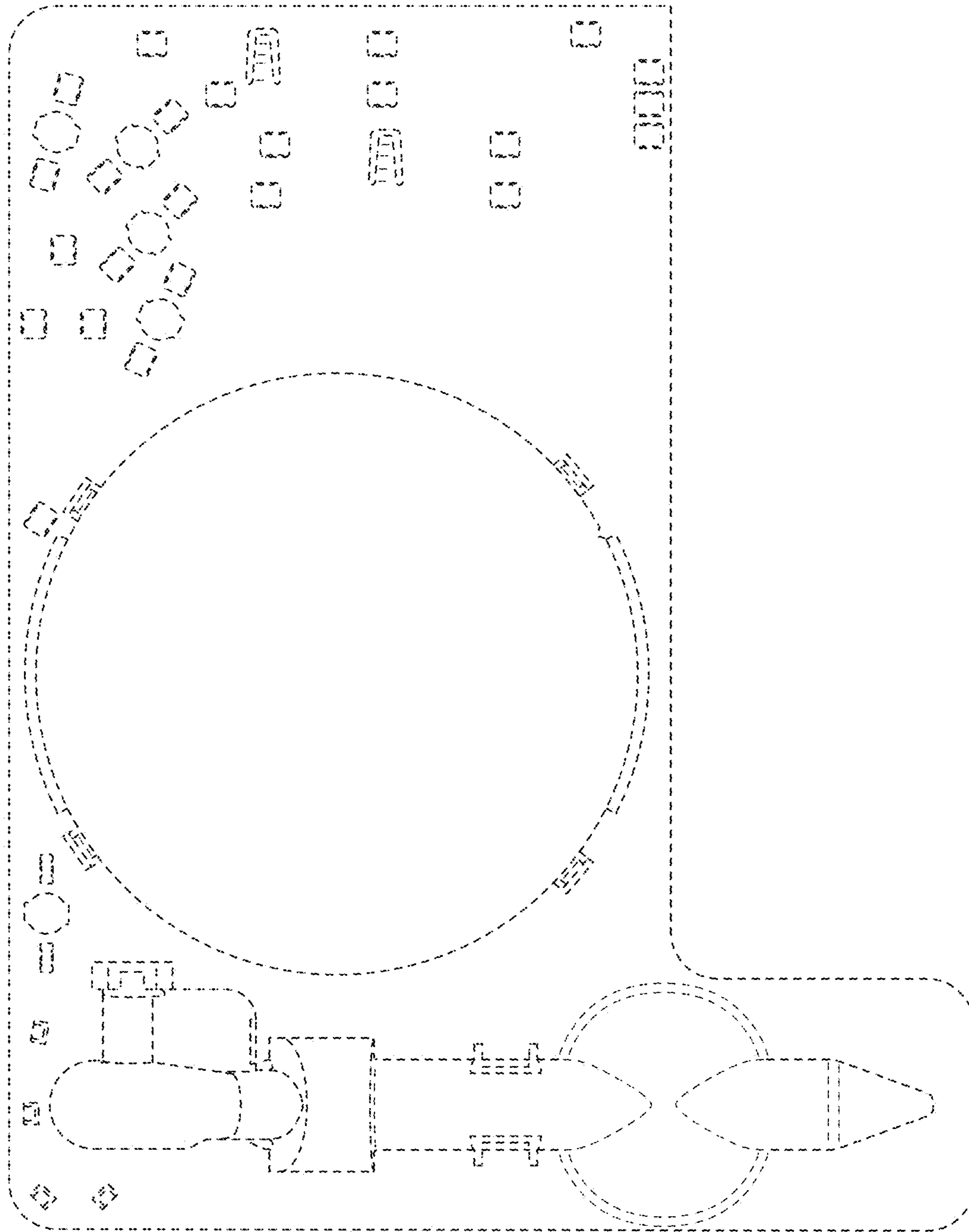

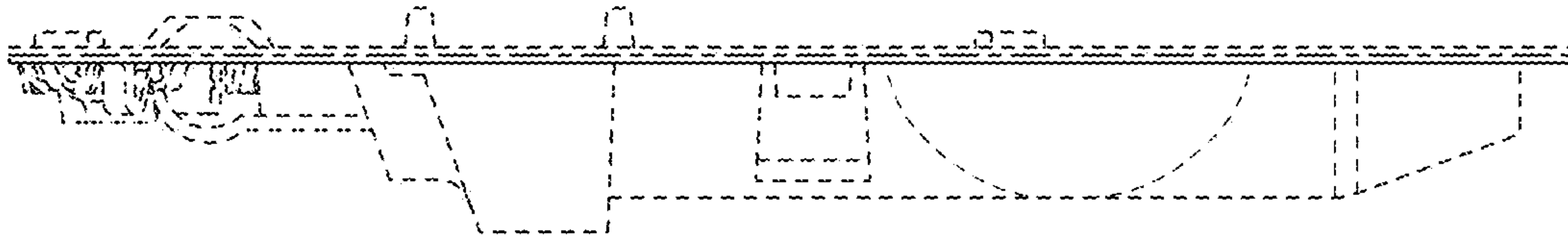

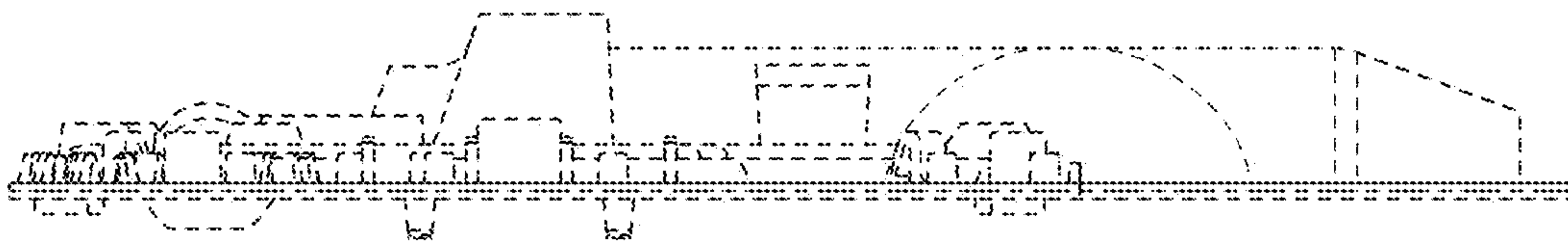

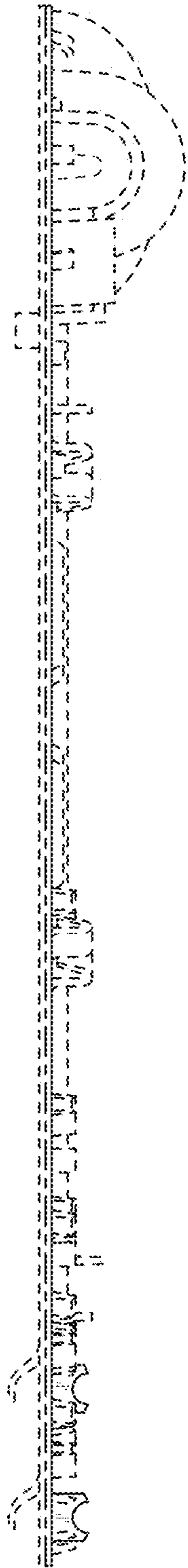

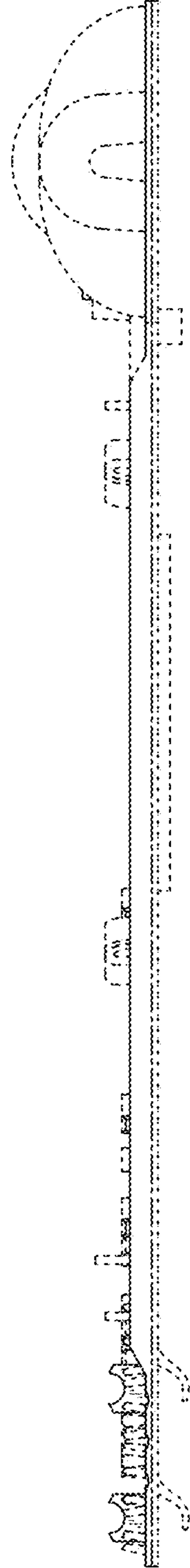
