**DESCRIPTION**

FIG. 1 is a front perspective view of the fence post with rails;

FIG. 2 is a right-side view of the fence post with rails, the

left side being a mirror image thereof;

FIG. 3 is a front view of the fence post with rails;

FIG. 4 is a rear view of fence post with rails;

FIG. 5 is a top view of the fence post with rails;

FIG. 6 is a bottom view of the fence post with rails;

FIG. 7 is a front perspective view of another embodiment of

the fence post with rails; and,

FIG. 8 is an enlarged view of detail 8 of FIG. 1.

The drawings contain a symbolic break; the broken line

showing within the symbolic break depict portions of the

fence post with rails that form no part of the claimed design.

The broken line circle of FIG. 1 depicts the limits of the

enlarged view in FIG. 8. The other broken lines showing of

items in the figures depict portion of the article and its

environment that form no part of the claimed design.

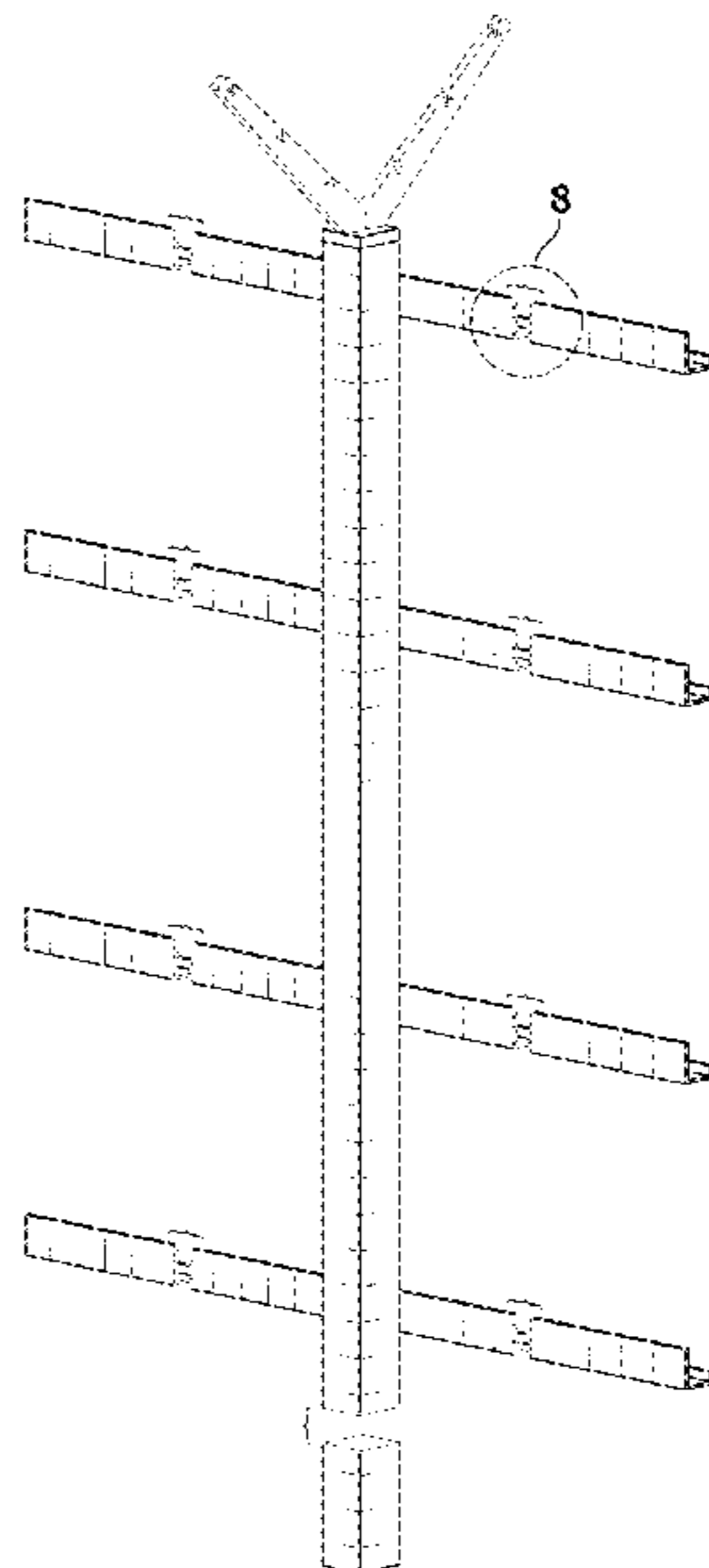

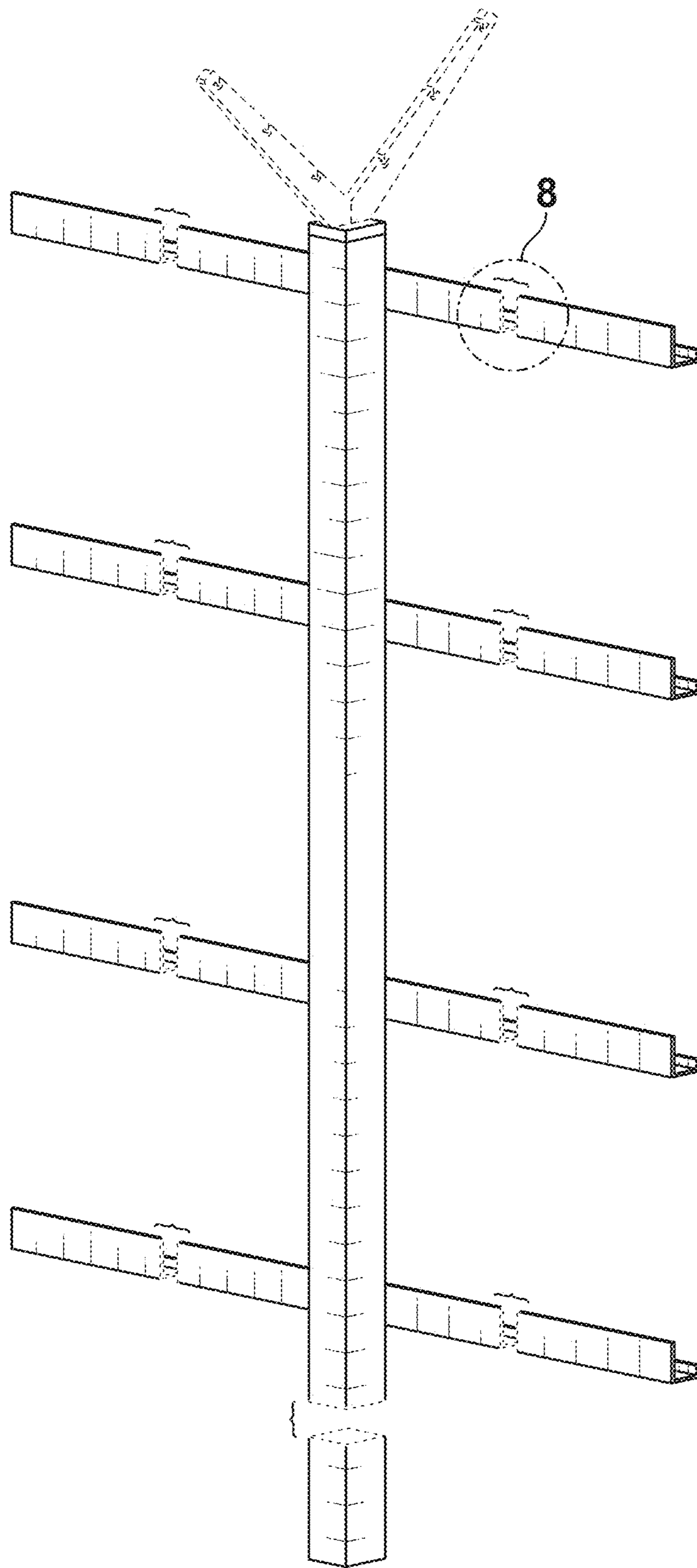

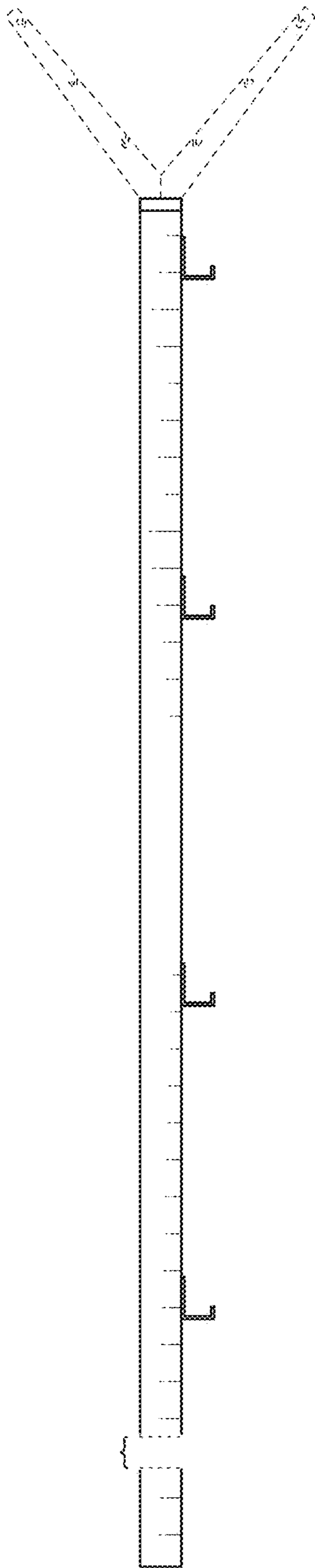

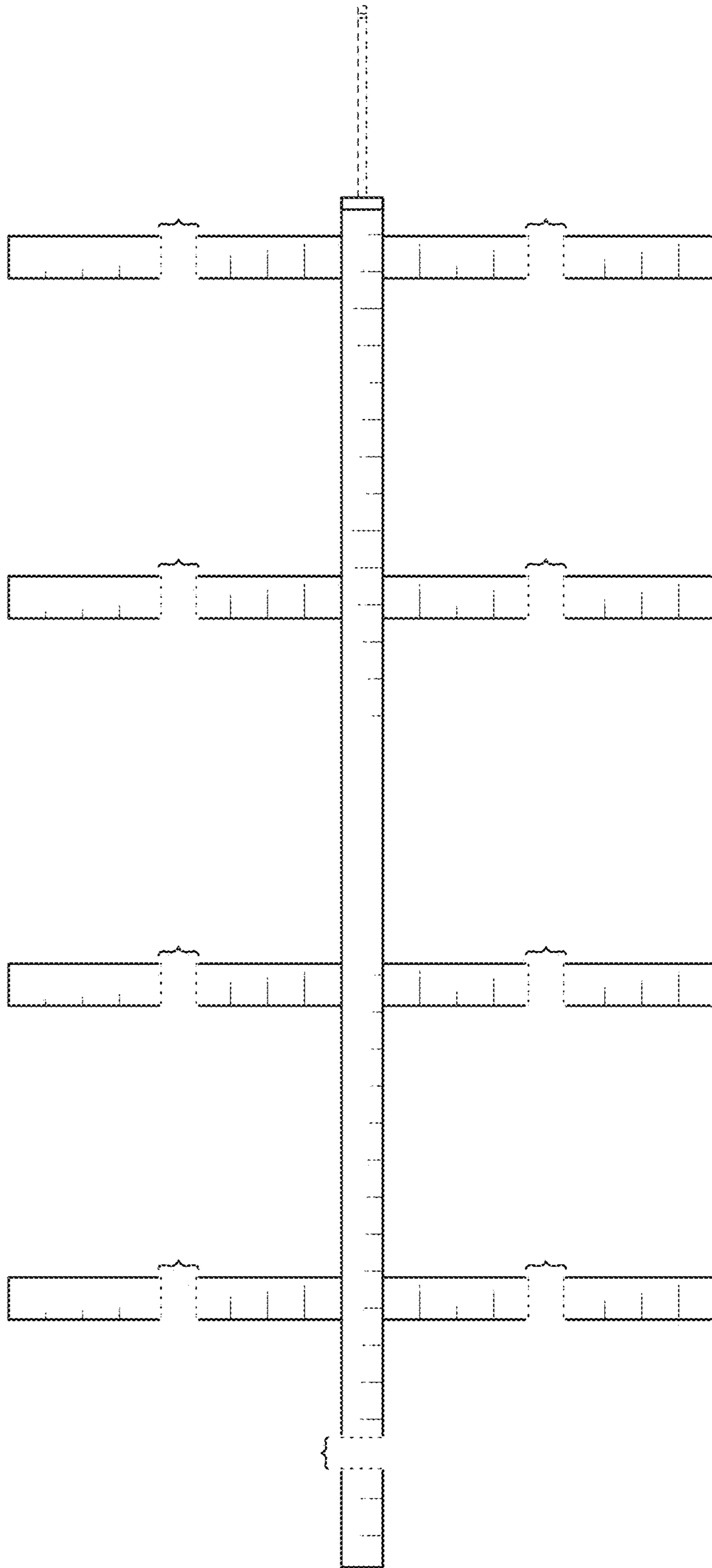

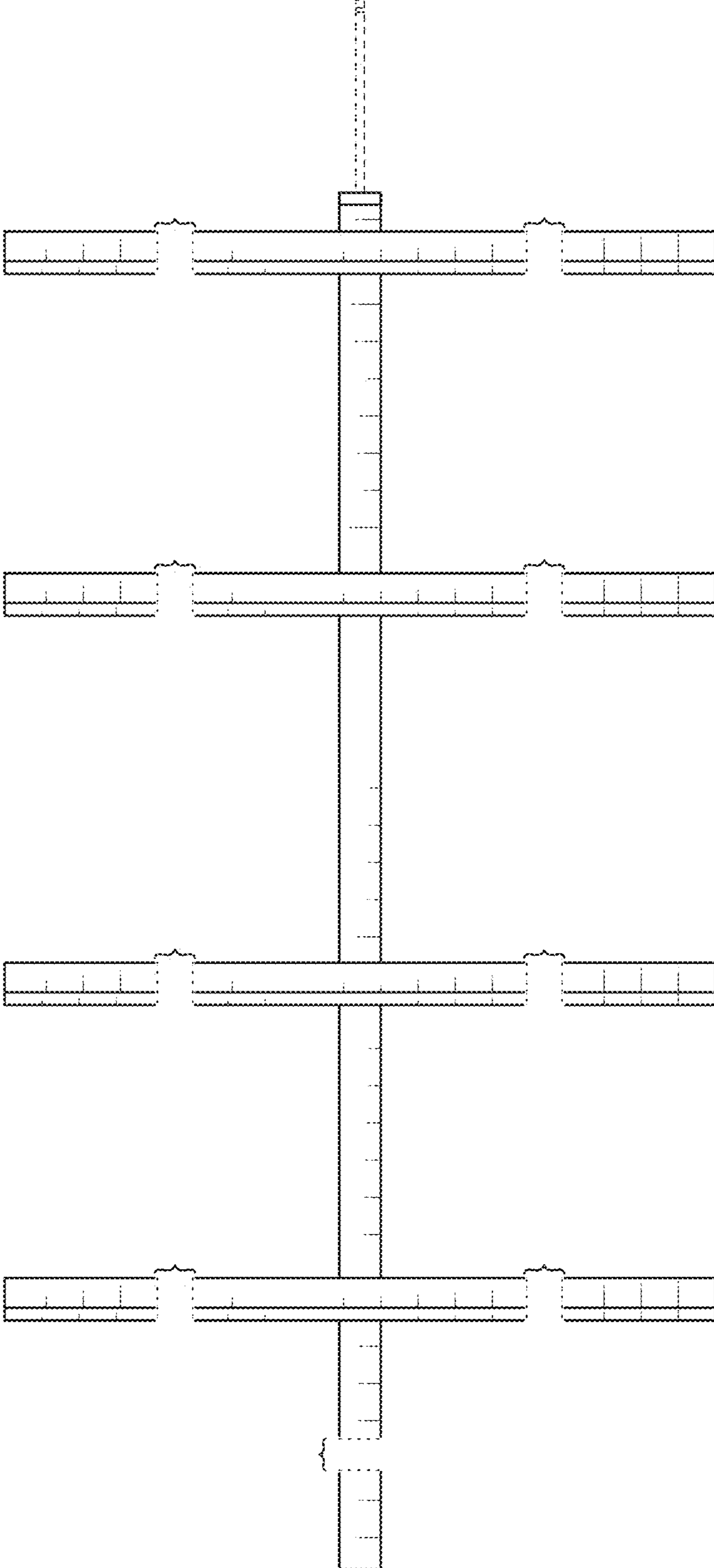

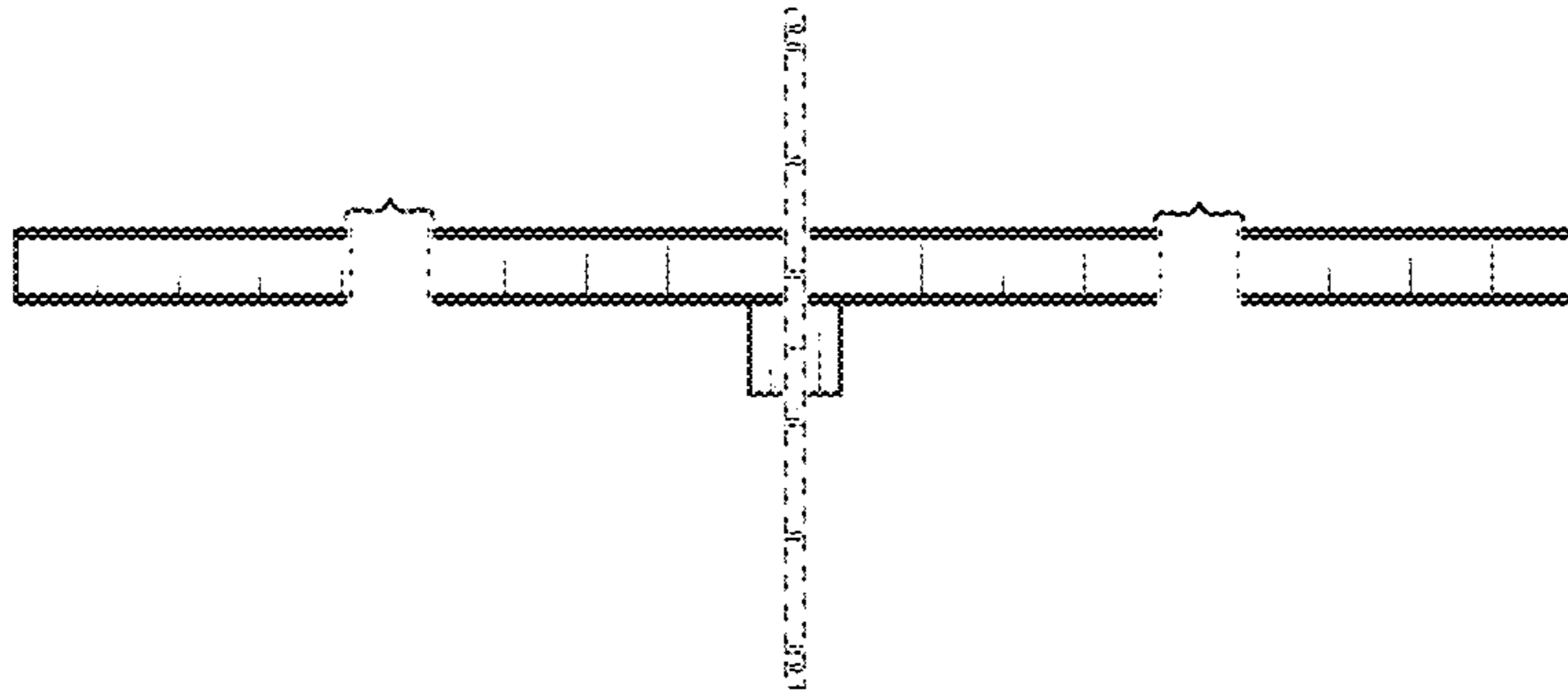

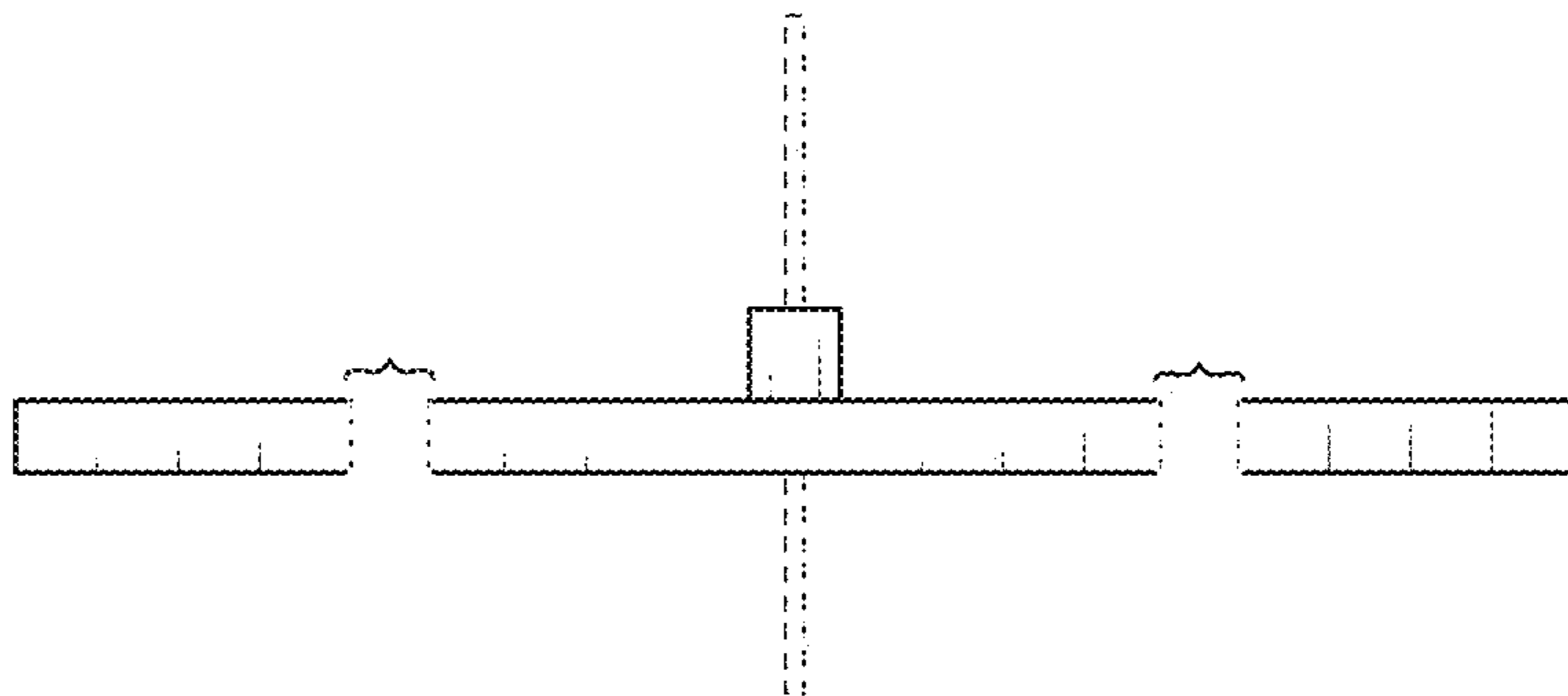

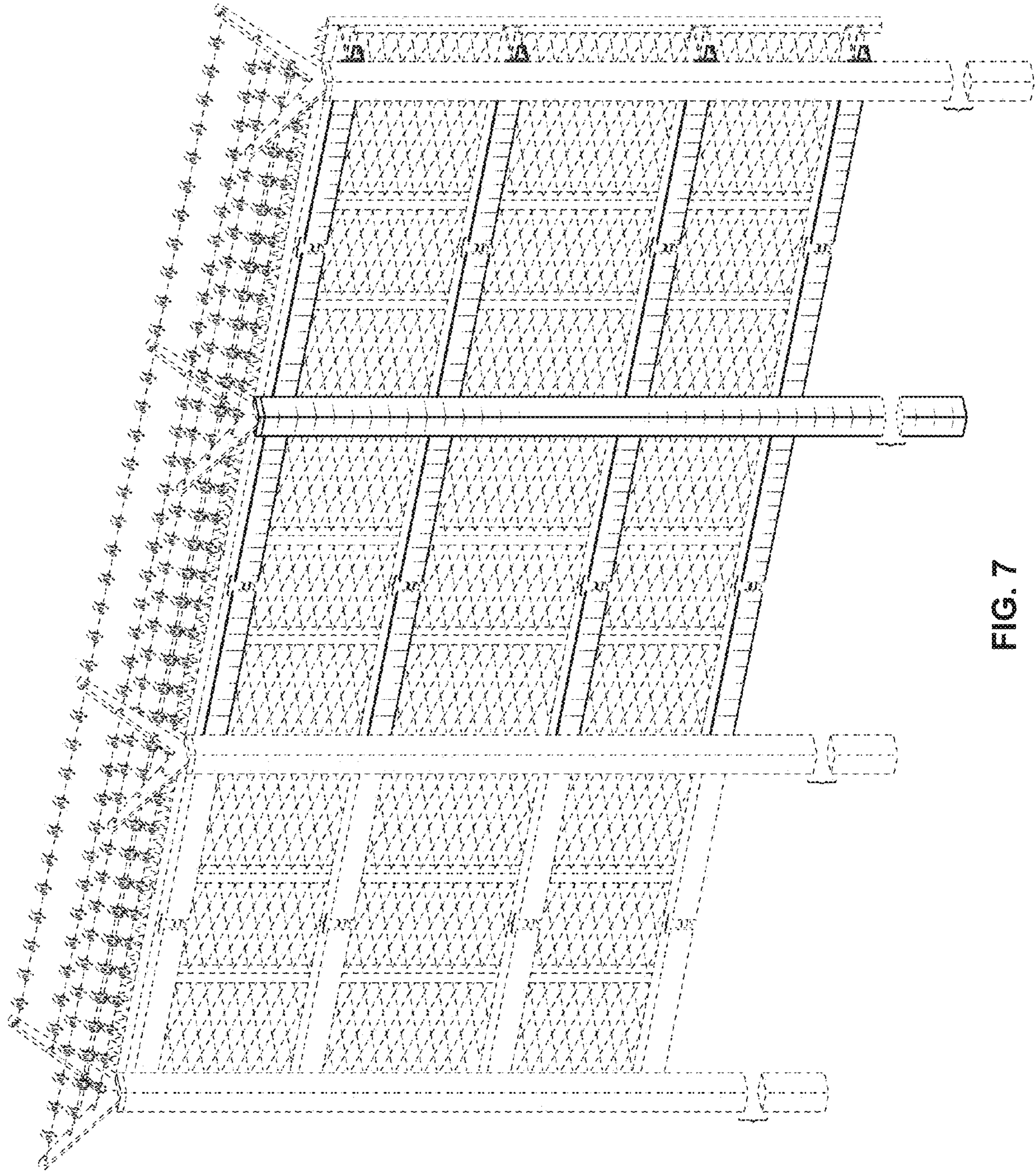

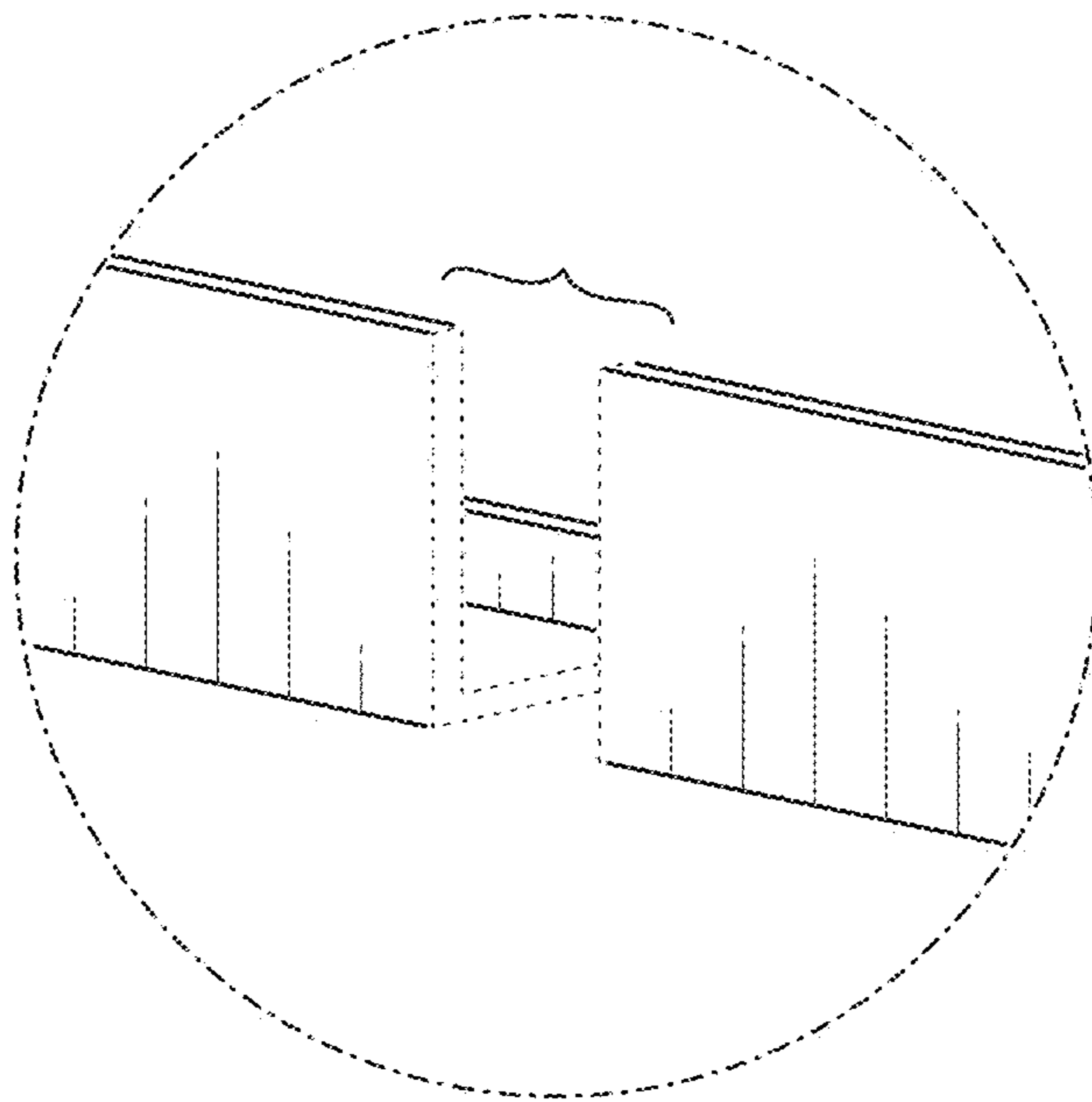
