**DESCRIPTION**

FIG. 1 is a front/top perspective view of my disposable vial with indent;

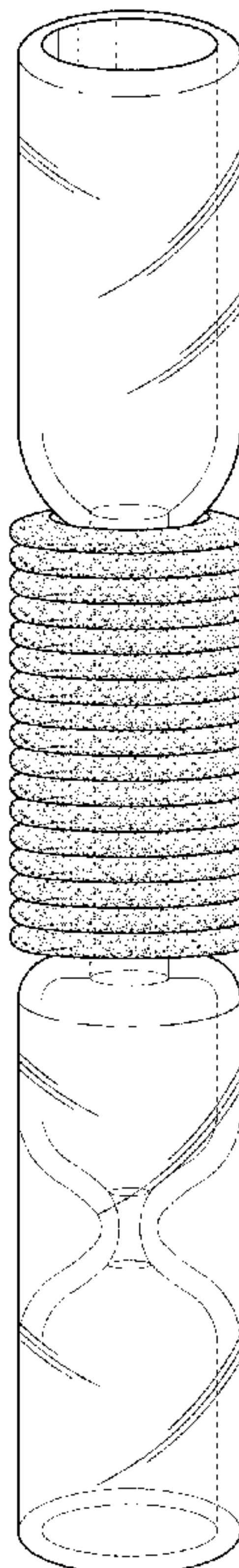
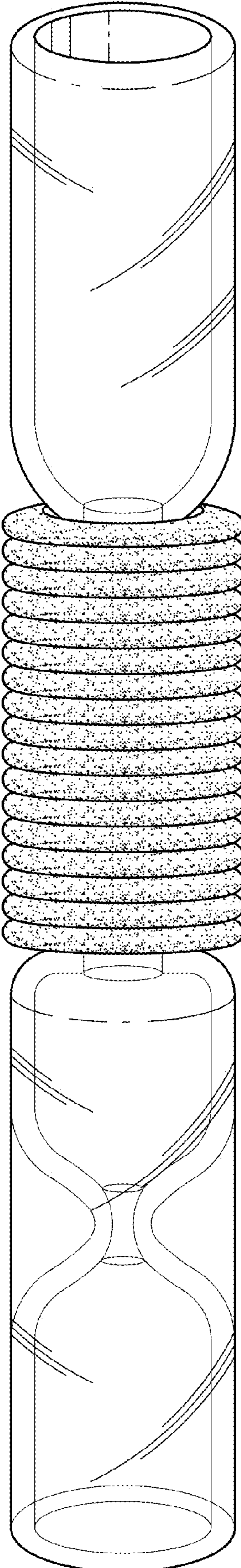

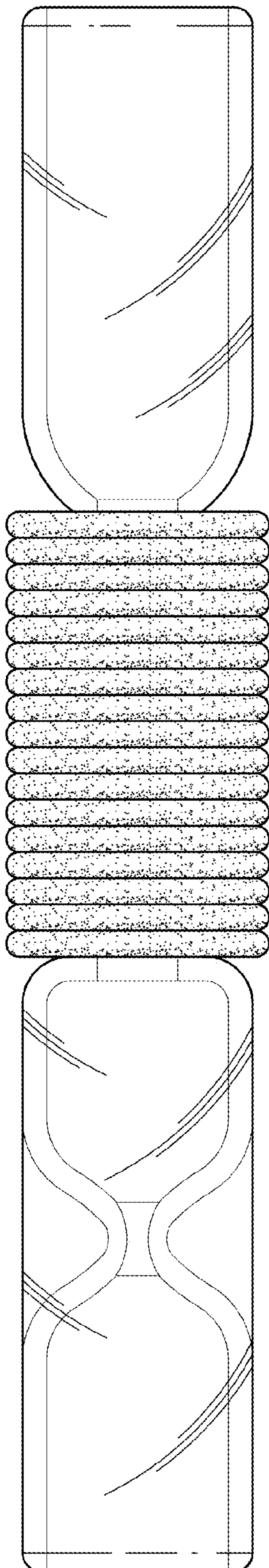
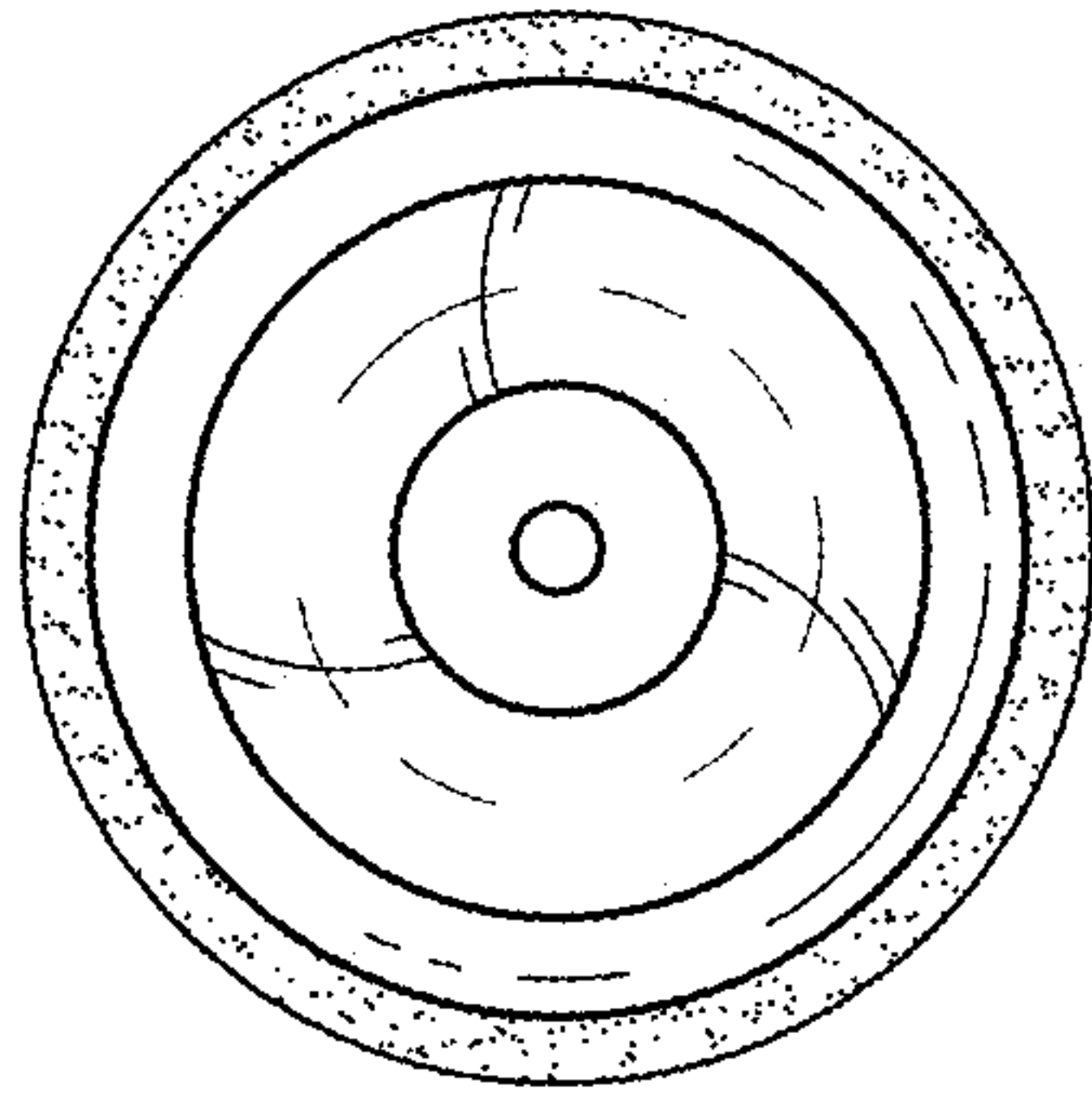


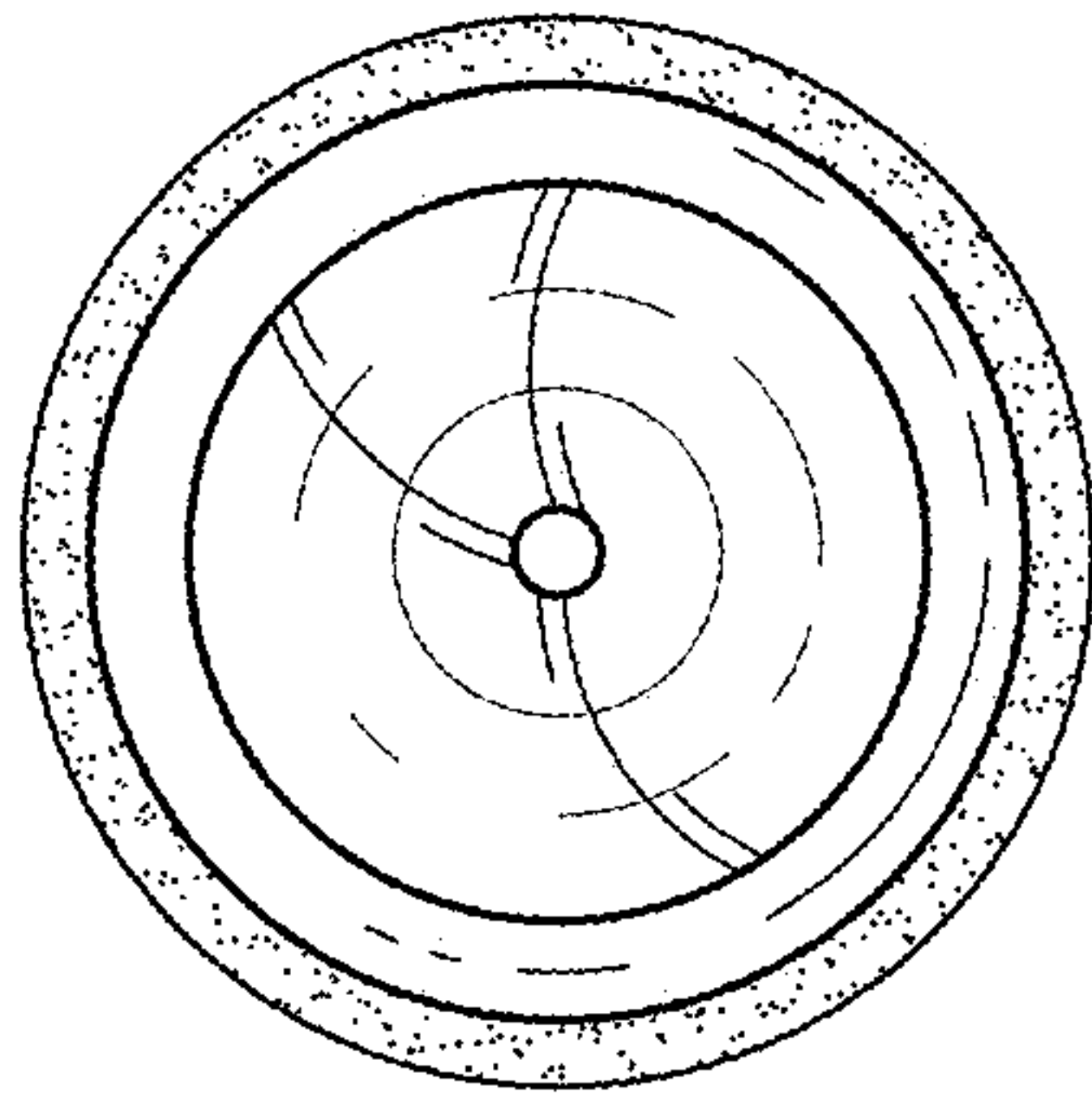
