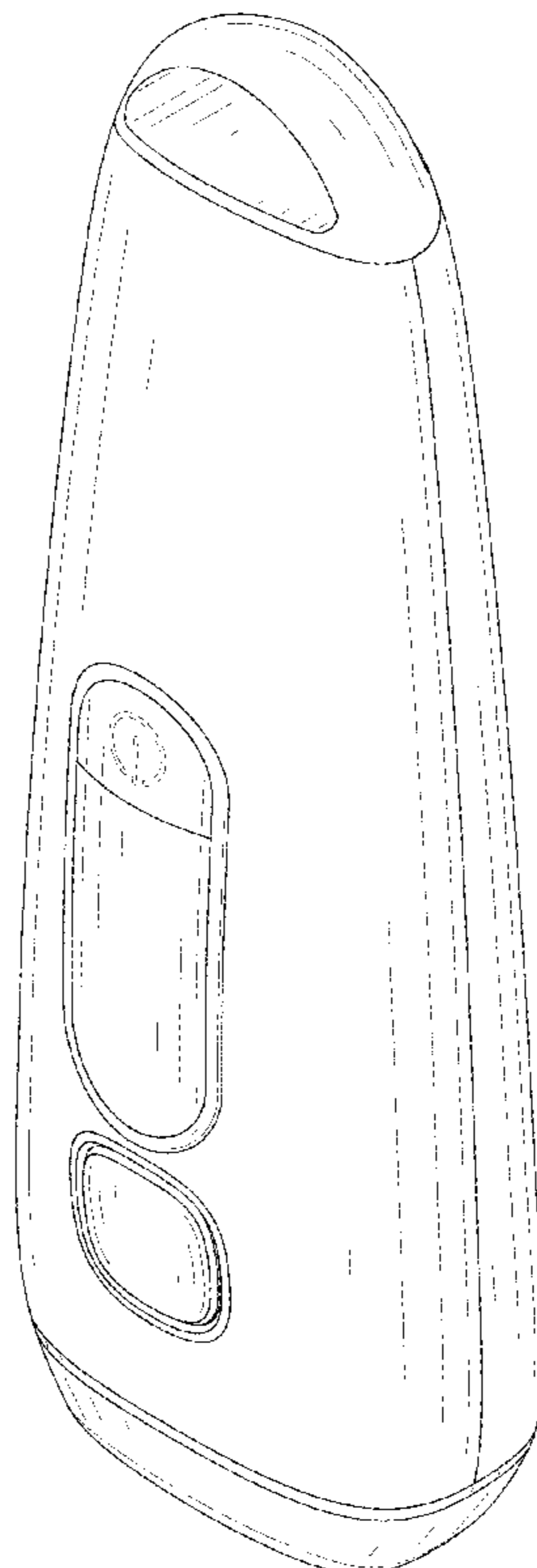
(57) **CLAIM**

The ornamental design for a laser hair removal device, as shown and described.

DESCRIPTION

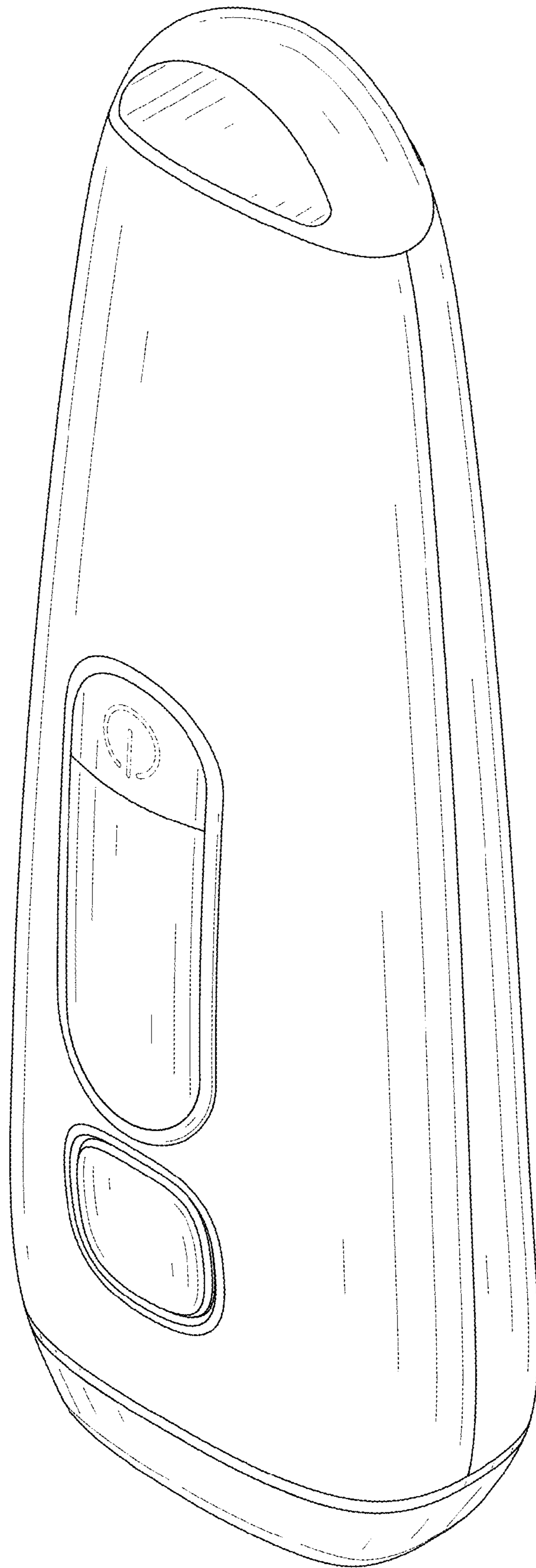

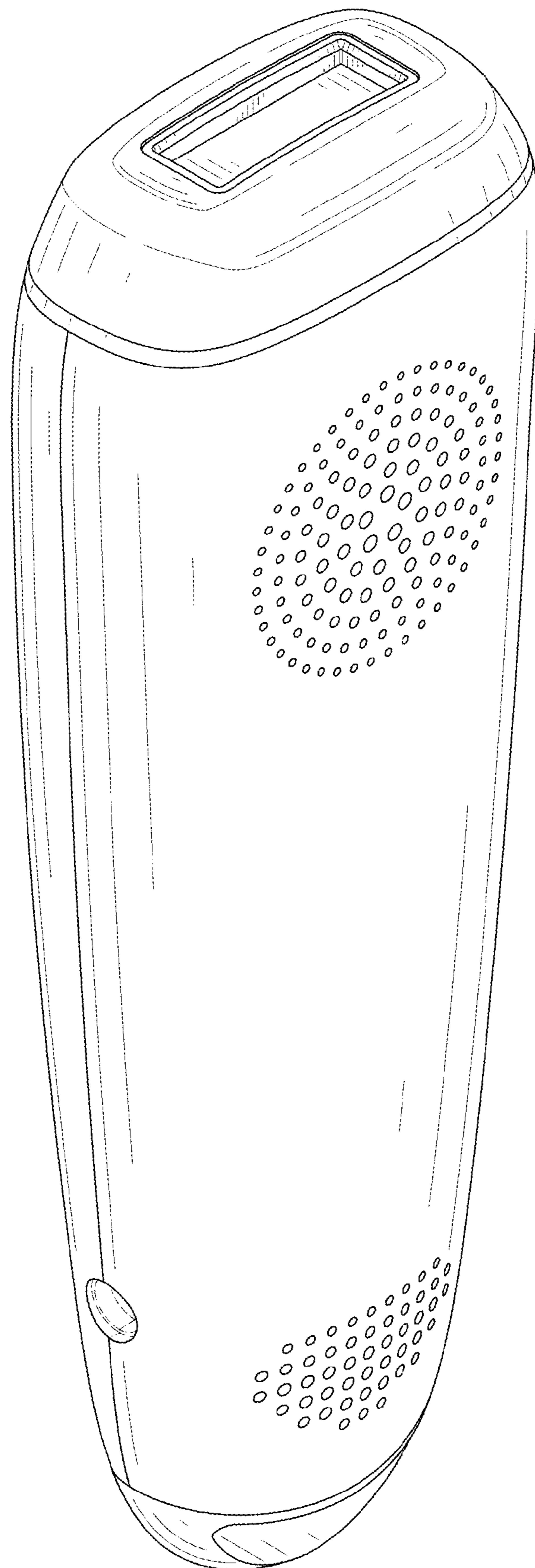

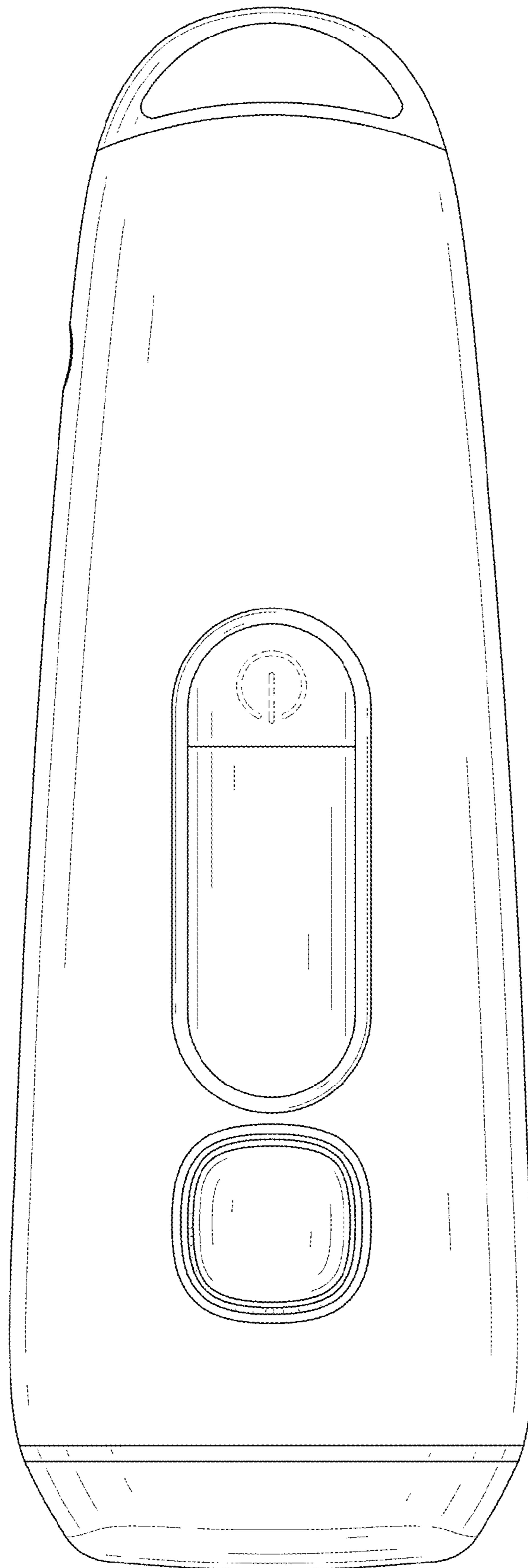

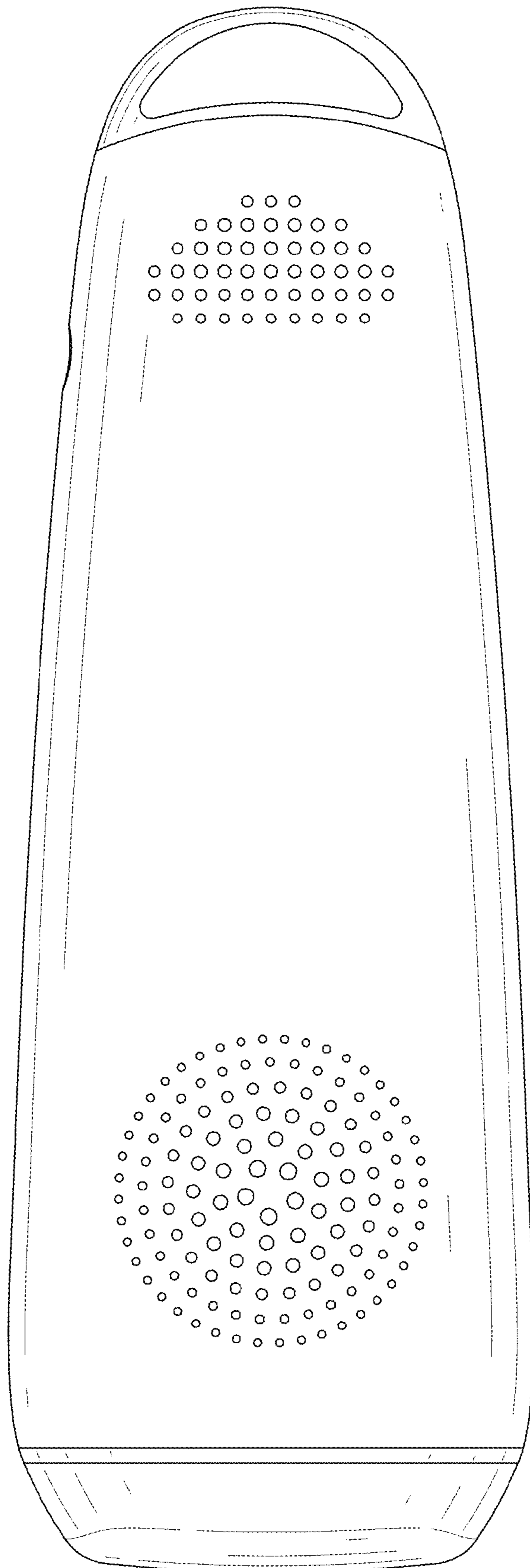

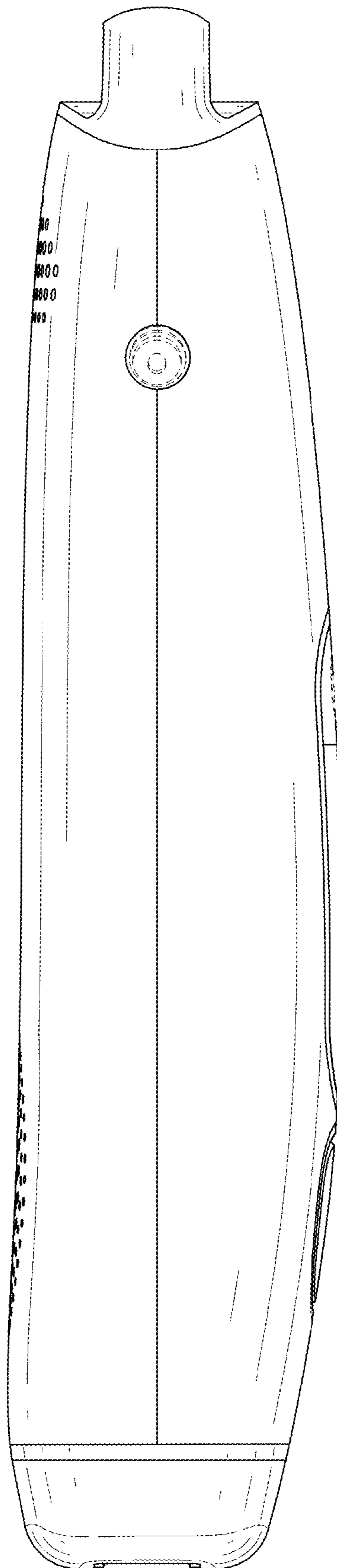

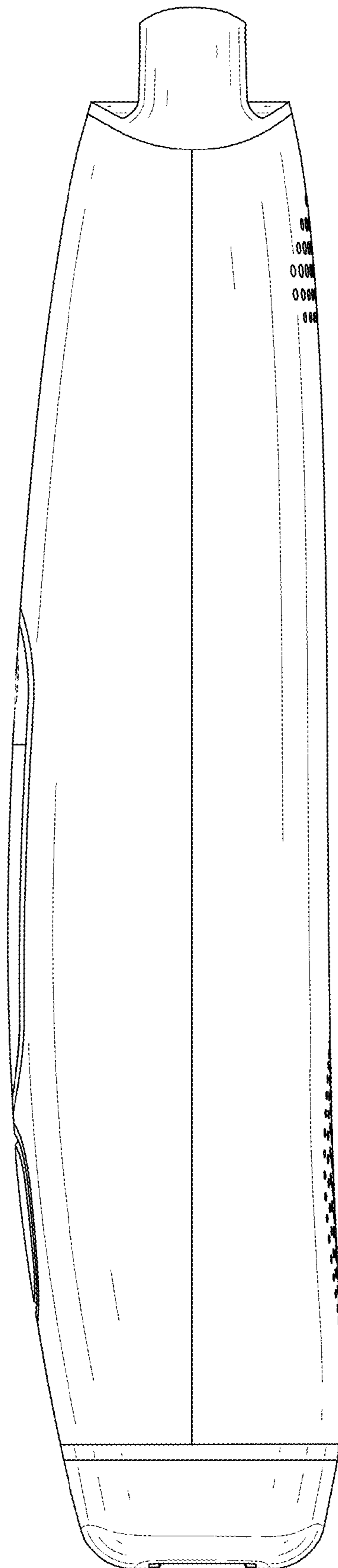

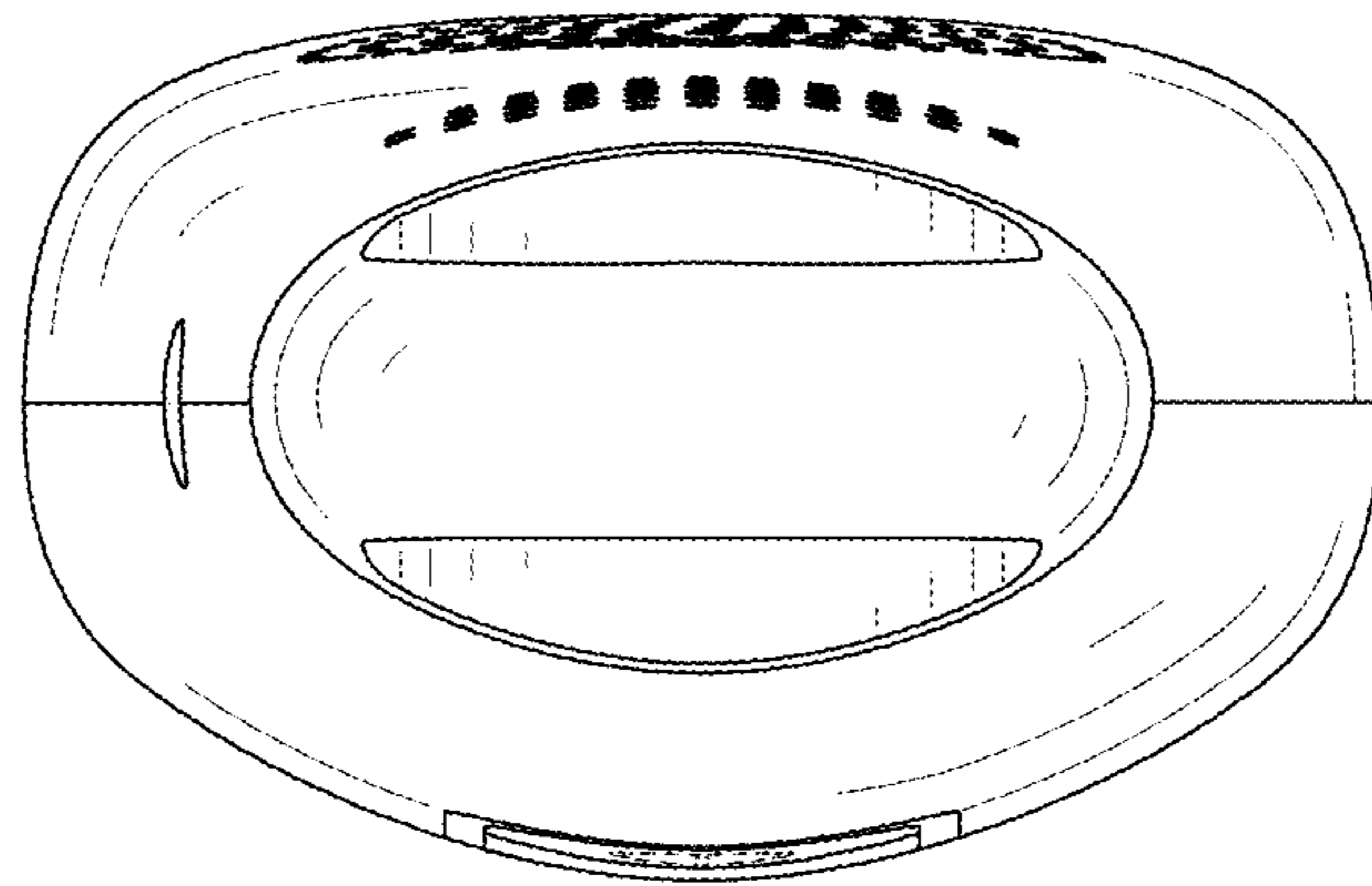

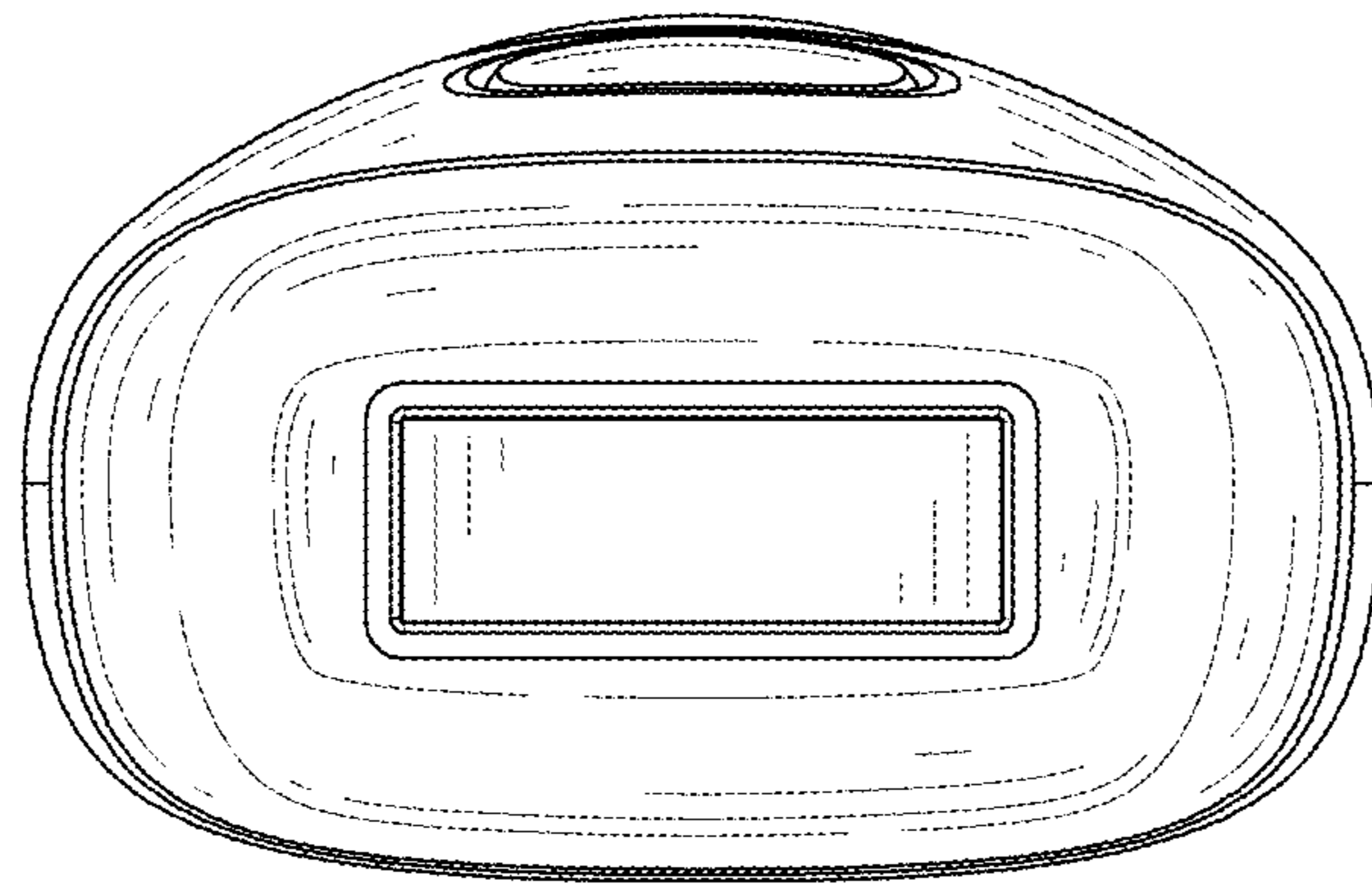
