(57) **CLAIM**

The ornamental design for a razor handle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a razor handle showing the new design;

FIG. 2 is a front view thereof;

FIG. 3 is a rear view thereof;

FIG. 4 is a left side view thereof and a right side view thereof is a mirror image of the left side view;

FIG. 5 is a top view thereof; and,

FIG. 6 is a bottom view thereof.

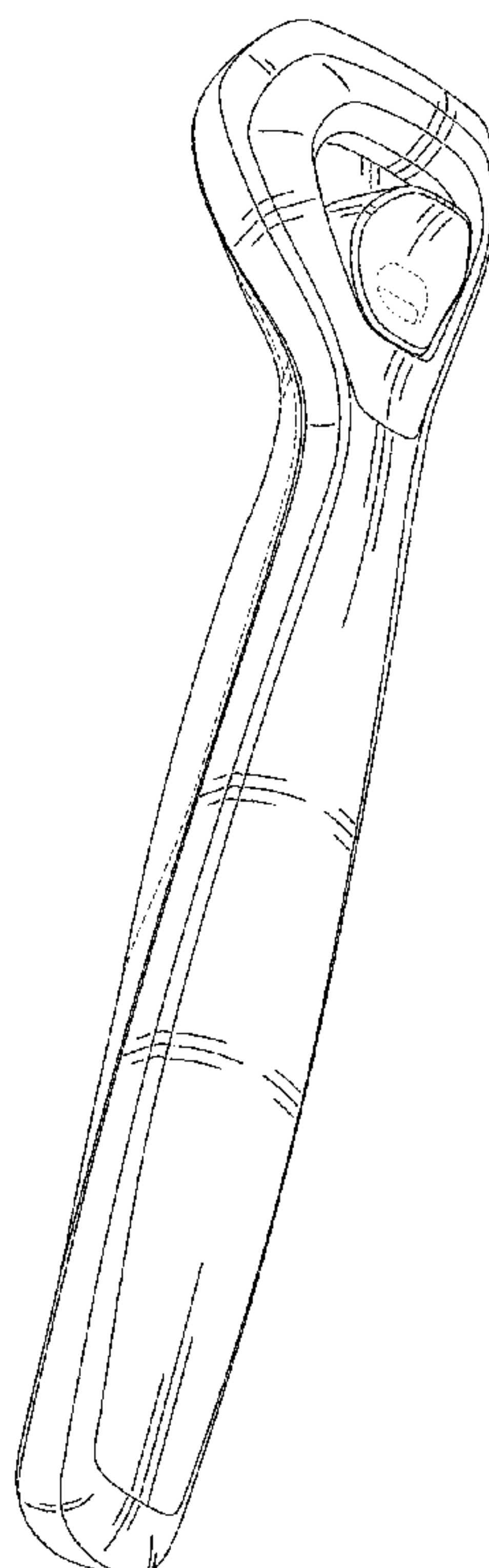

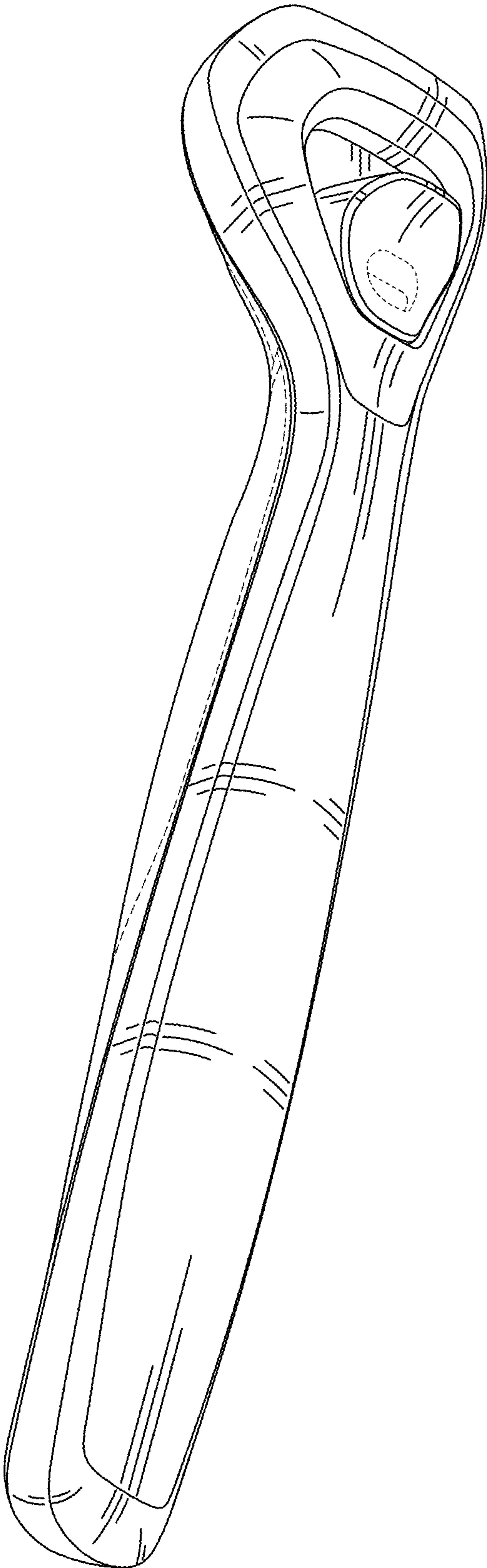

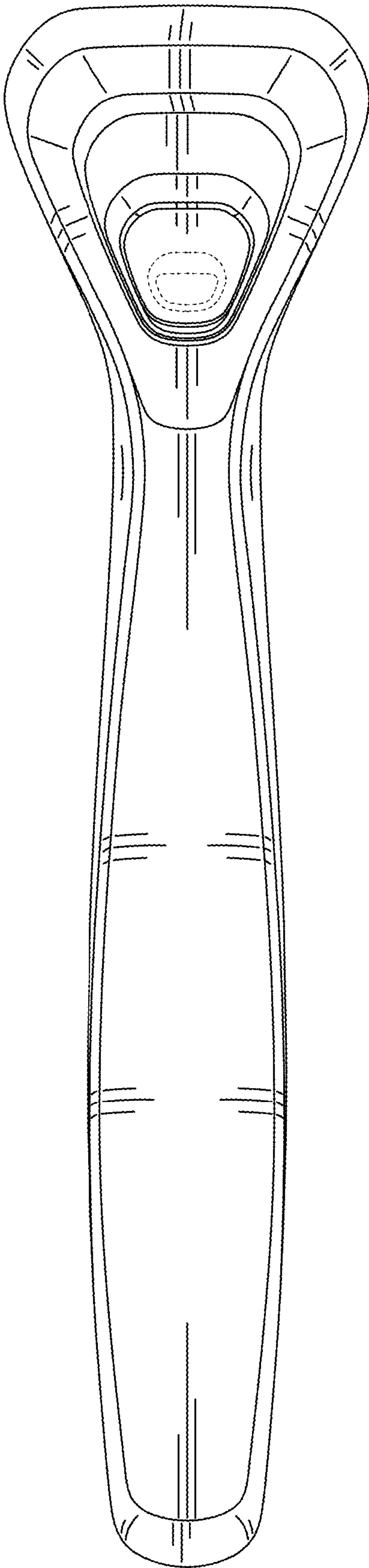

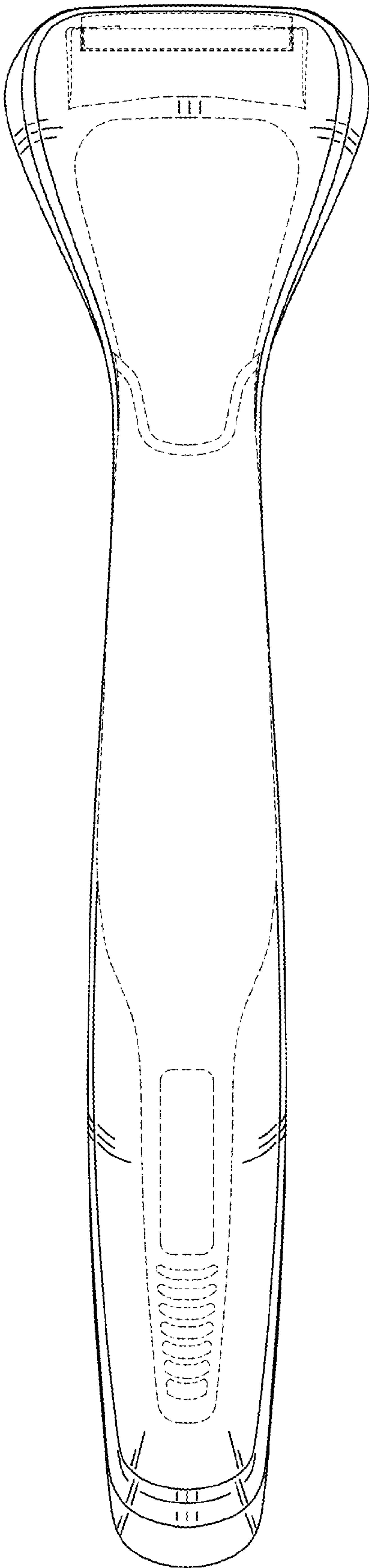

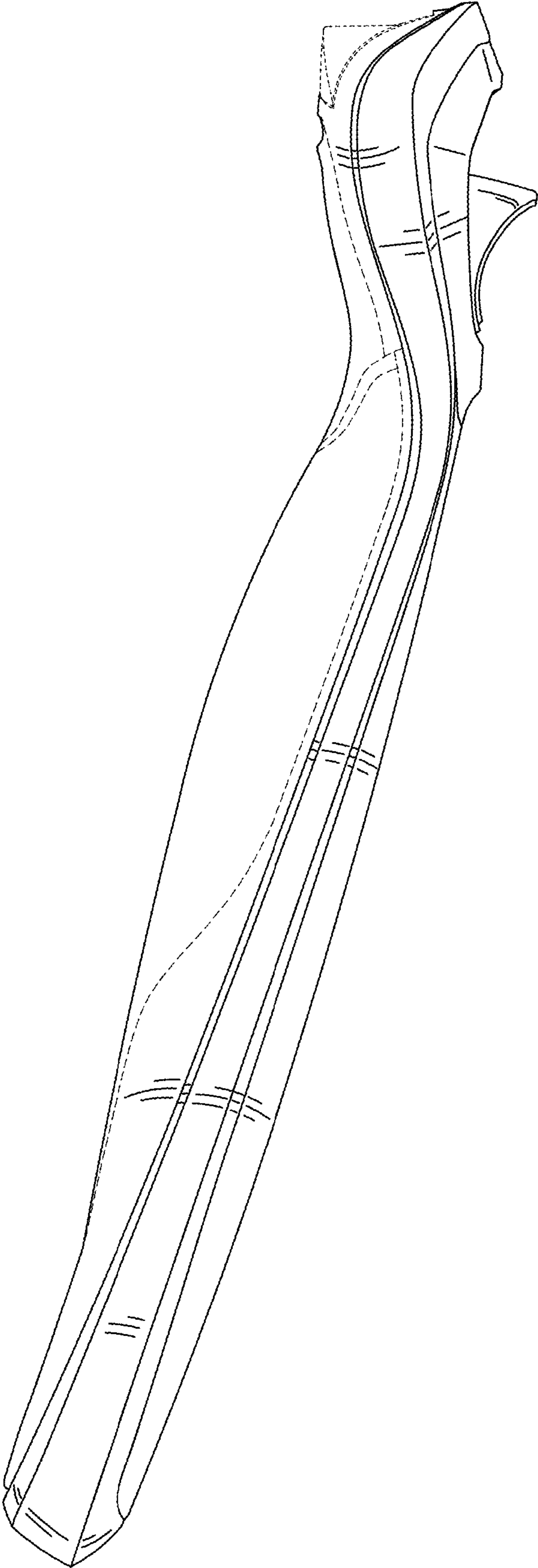

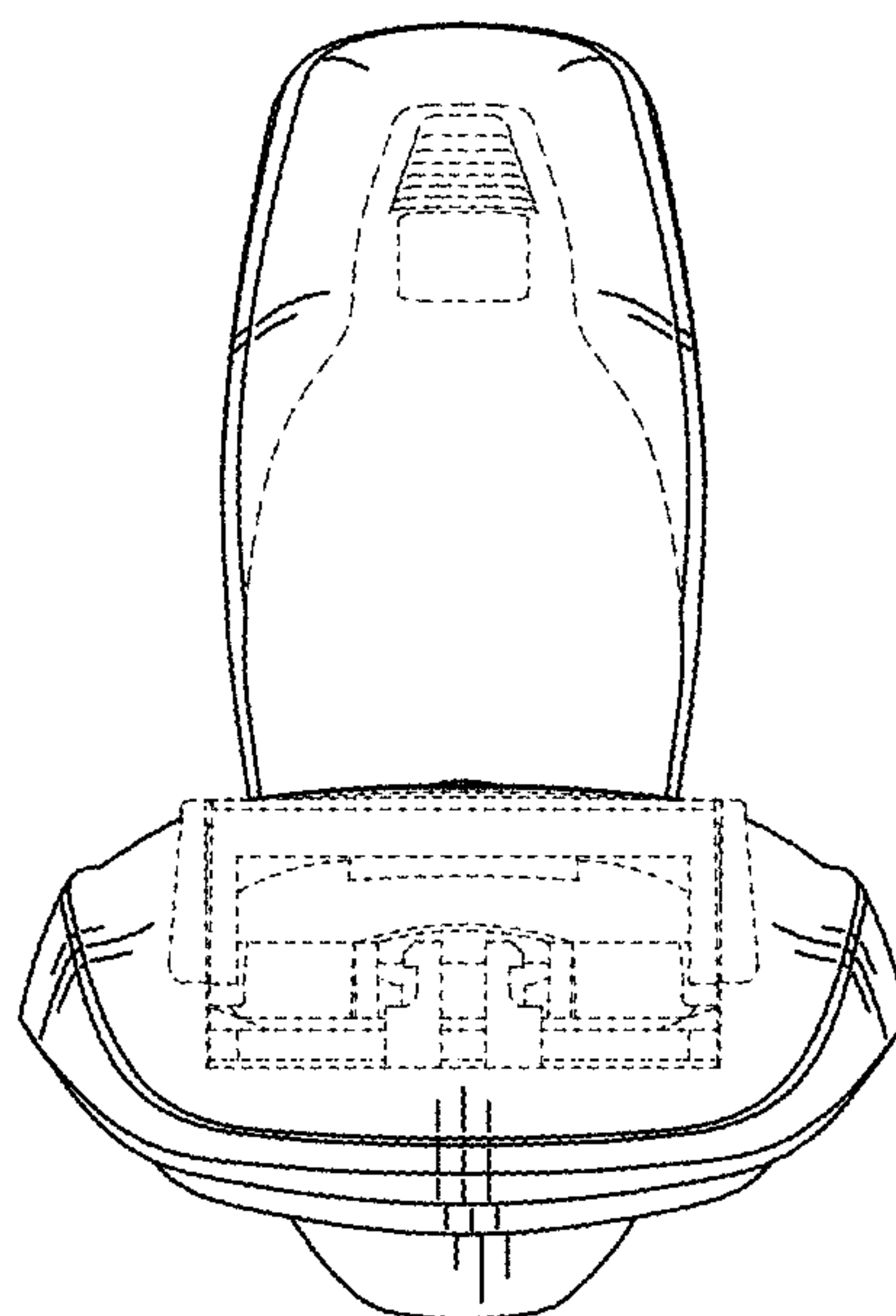
