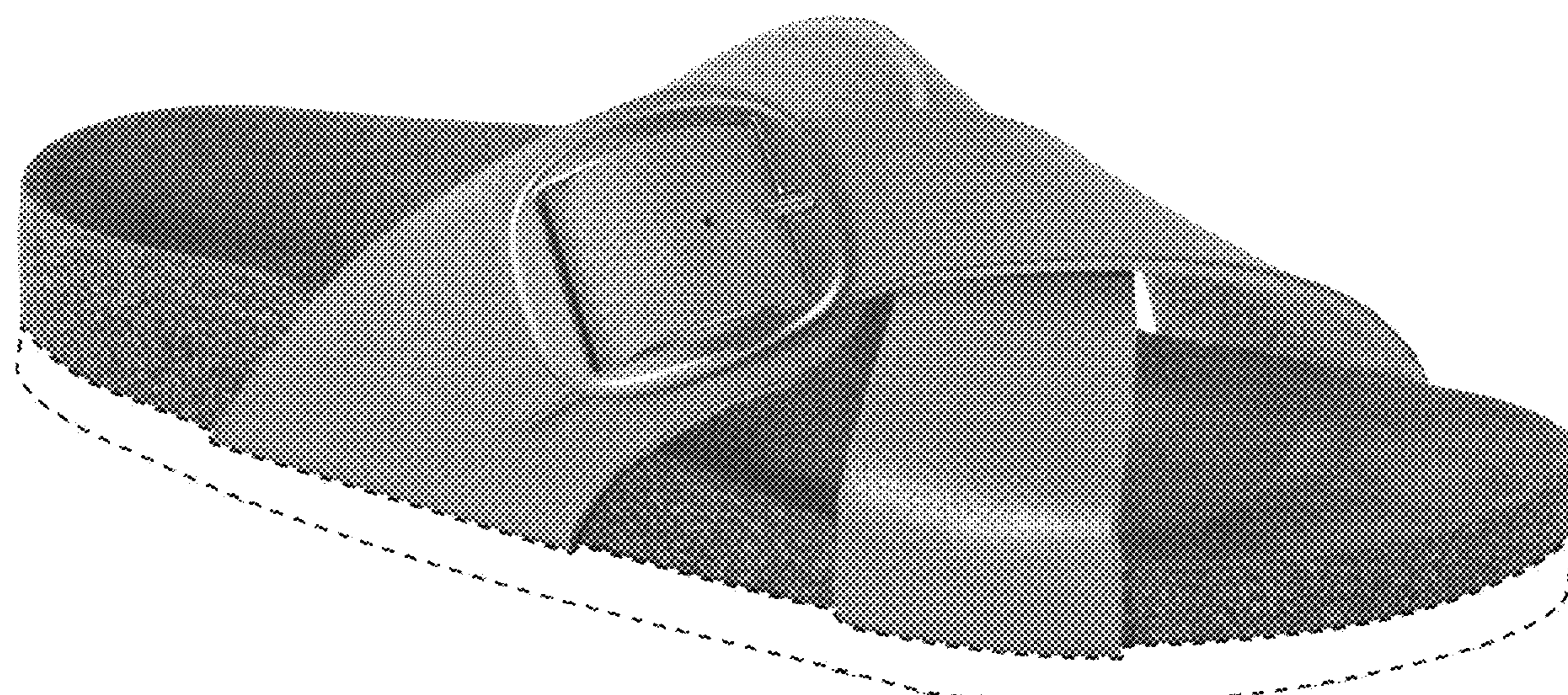
The ornamental design for a sandal, as shown and described.

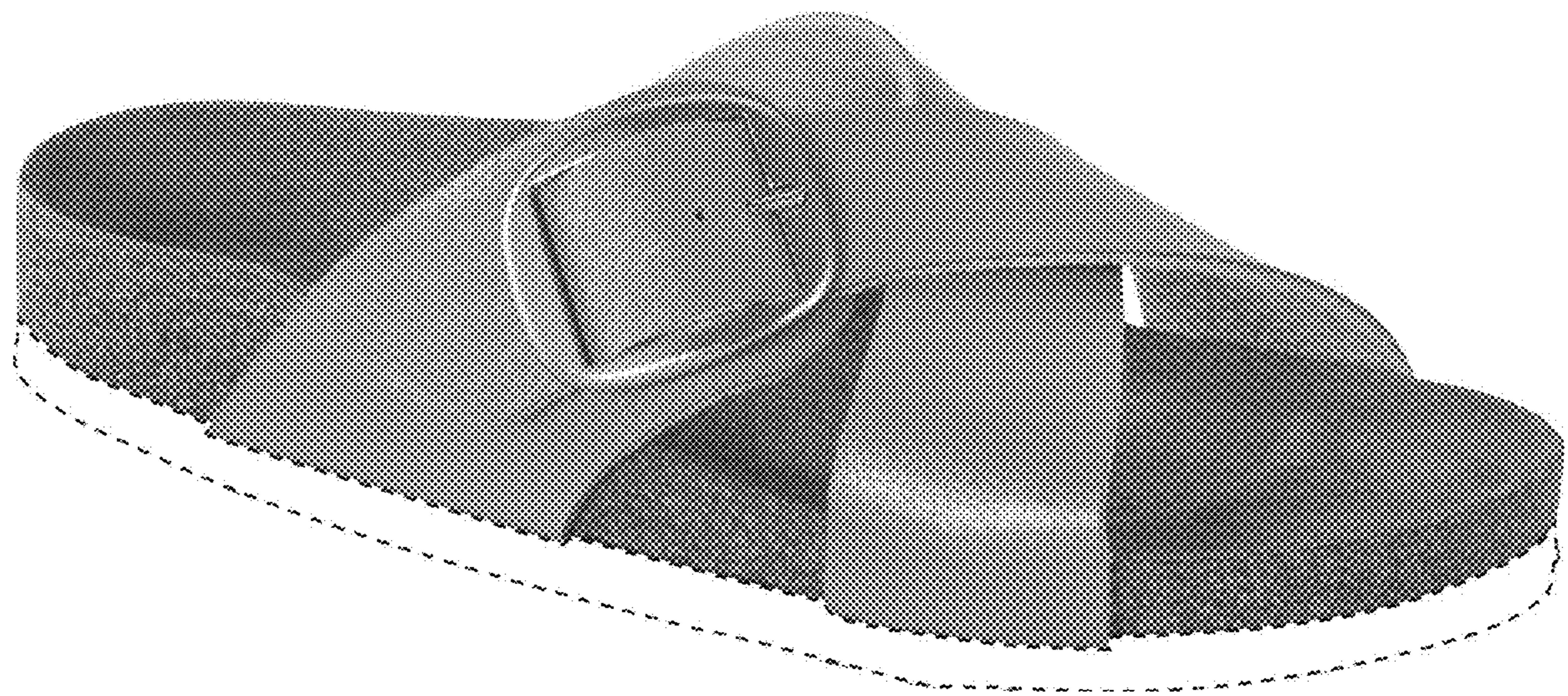
**DESCRIPTION**

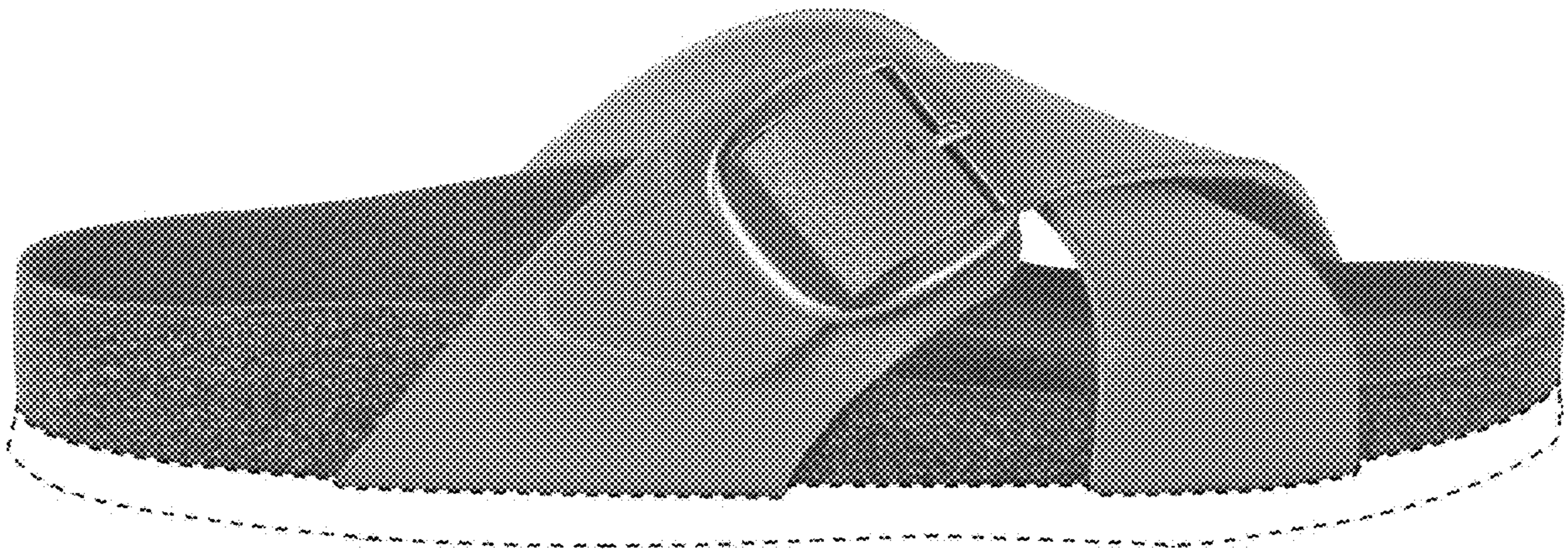

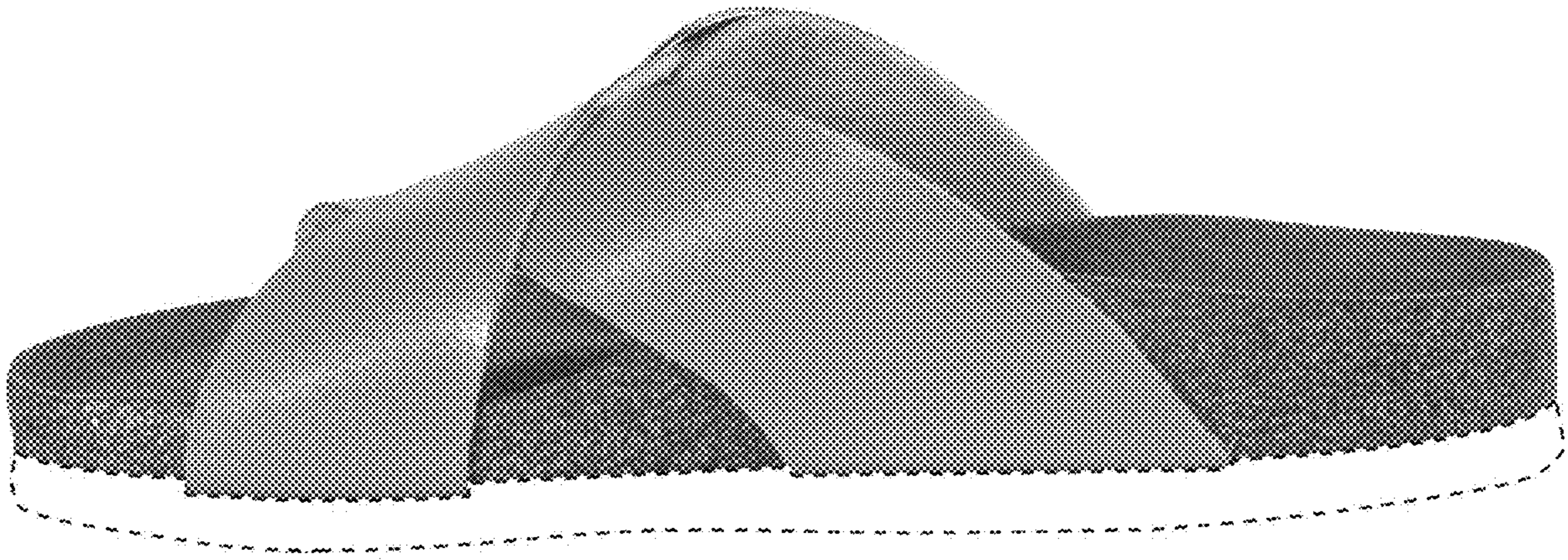

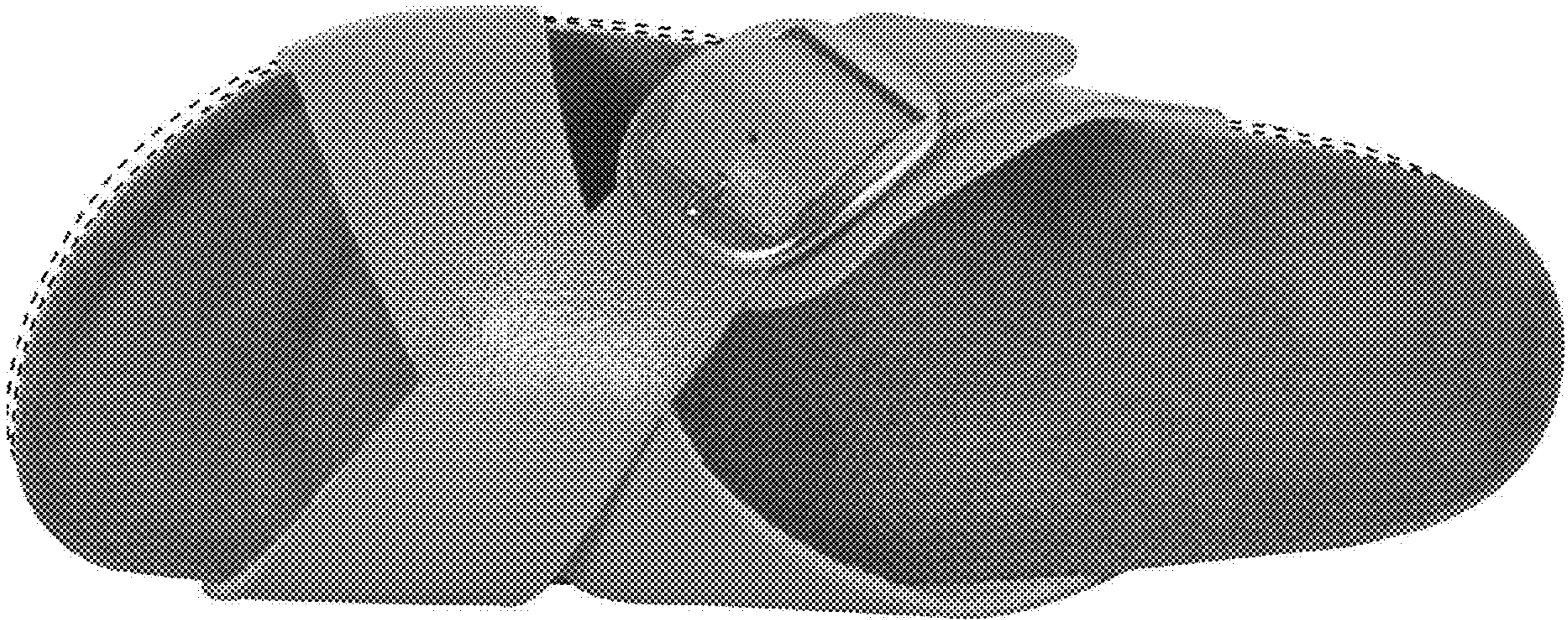
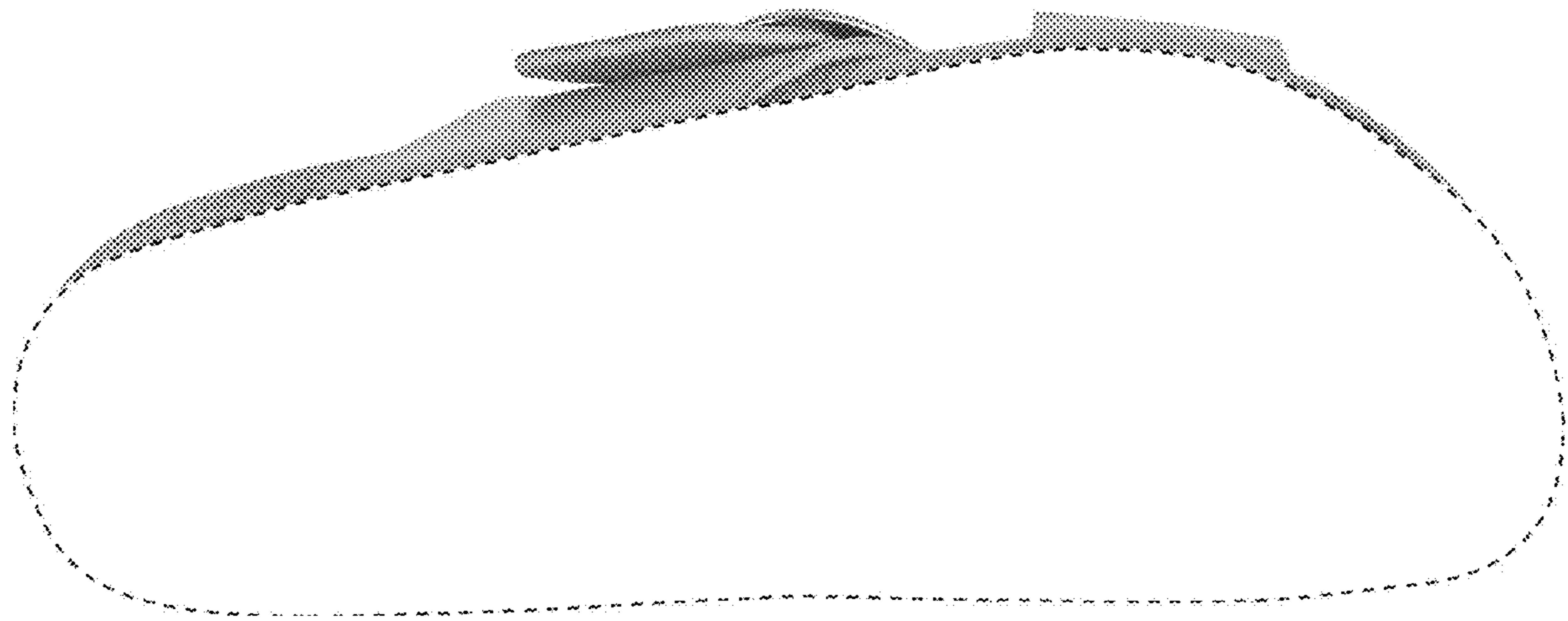
